Report of the Devotional Secretary

The important part of this work does not lie in the things that can be written into a report. The duty of the Devotional Secretary of each parish has been to see that the Woman's Auxiliary realizes that this is a real work, and the one upon which everything we do depends. If there is an awakening interest in the power and use of prayer, it tells the work of the secretaries better than any report that can be written.

The name of the Secretaries in forty-two churches, (fourteen of these having no resident minister), who have given the message of this work to our women deserve special mention, and I am truly sorry that a lack of space forbids my doing it. They have all been wonderful.

For four years we have helped Meta Connell carry on her work, and it was in her last letter that she said, "I know that every prayer offered for me helped me; the Meta Connell of today is a different girl from the one you started praying for four years ago, and it is due in a great part to my prayer partners that I have learned the value of prayer."

We are asked to take Eunice Sen of Grace Church, Anking, China, for a Prayer Partner, so, for the coming year we will have the two, Eunice Sen and Meta Connell.

The Devotional work of the women for the past year as reported through this department has been,

Three Communion Services and five Prayer Groups each week.

A Quiet Day for the women, conducted by Bishop Darst.

Eight Corporate Communions for the Executive Board, and four for the Board of Managers.

Representatives from the parishes attending the service of a Day of Prayer for Missions held by the Woman's Missionary Federation. Distribution of 2000 copies of the "Follow on the Crusade" Folder. Compiling and distributing 2000 copies of "Thoughts for the Octave of Prayer for the World Conference on Faith and Order."

This Leaflet was afterwards printed in the Spirit of Missions and used in other states.

During the week of prayer for Church Unity, a special service to which the women of the other denominations were invited, was held at the Cathedral by Dean Scarlett.

Letters were sent to the pledged Intercessors asking for special prayer during the World Conference on Faith and Order.

Letters have been sent the Intercessors telling them of our new Prayer Partner.

We now have 206 Pledged Intercessors.

St. Andrew's Day was observed as a Day of Intercession.

Four things are asked of us for the coming year:

- 1st. Daily prayers for our Prayer Partners.
- 2nd. Subscribing for and using the Prayer Leaflet.
- 3rd. Telling the children of the Church Schools about our Prayer Partners and asking for their help in this work.
- 4th. Reading at least one book on Prayer; that through study of our subject we may be better fitted for the work that is asked of us.

Report of Educational Secretary

At the end of this, my first year as Educational Secretary, there are several reasons to believe that interest in Religious Education has been stimulated.

The "Institute" held at St. George's Church January tenth and eleventh, 1928, by Miss Laura F. Boyer, Assistant National Educational Secretary, when 190 registered is one evidence of the fact; the use of the Speakers Bureau is another, and the forming of a number of study classes is still another.

The Speakers Bureau was inaugurated in February, 1927, with speakers ready to answer calls to all Branches in St. Louis and St. Louis County. One Branch called a speaker to each of its meetings till every speaker listed had been heard.

A survey of the Branches throughout the State was made by means of a questionnaire, and showed the great need of bringing these isolated groups into closer contact with us in St. Louis.

Mrs. Thos. Q. Dix was able to visit many of these Branches and talk to them on the purpose and scope of the W. A. with very helpful results.

A "Central Education Class" for St. Louis and St. Louis County was formed to meet the 4th Monday of every month for the study of the text book of the year "A Church Awake" by Dr. Sturgis. The Rev. B. J. Moore is the leader of the Class.

Literature and other material for study helps have been sent many Branches, and the outlook for the coming year is very encouraging for religious education.

Constitution

ARTICLE I—NAME.

This organization shall be called "The Missouri Branch of the Woman's Auxiliary to the National Council."

ARTICLE II—OBJECT.

Its object is to increase the interest and unite the efforts of all women in the Diocese in the Church's Mission in the Parish, in the Community, in the Diocese, in the Nation and in the World.

ARTICLE III—MEMBERSHIP.

Its membership shall consist of all baptised women who pray for, work for, or give to the Church in the Five Fields of Service.

ARTICLE IV—AMENDMENTS.

This Constitution may be altered or amended at any annual meeting by a two-thirds vote of the members of the Board of Managers present; due notice having been given to each member.

By-Laws

BY-LAW I—OFFICERS.

Section 1. The Officers shall be a President, First Vice-President, Second Vice-President, Third Vice-President, Fourth Vice-President,

Recording Secretary, Corresponding Secretary, Treasurer, Auditor, Educational Secretary, Supply Secretary and United Thank Offering Treasurer.

Section 2. There shall be an Executive Board composed of the officers, special secretaries and treasurers, and three members at large.

Section 3. The Board of Managers shall consist of the Executive Board and the Parish Representatives; twenty-five members constituting a quorum.

Annual dues of \$1.00 for each member of the Board of Managers shall be paid to the Auxiliary Diocesan Treasurer before the first of February.

Section 4. Honorary offices with the right of vote may be created by a two-thirds vote of the Board of Managers.

BY-LAW II—DUTIES OF OFFICERS.

Section 1. The President shall preside at all meetings; appoint committees; be a member ex-officio of said committees and fulfill all such duties as pertain to her office. By virtue of her office she shall be a Delegate to the Triennial. She shall make a written report of the year's work to the Diocesan Convention, which if so ordered by the convention may be published in the Journal. She shall appoint the Special Secretaries and Treasurers.

Section 2. The First Vice-President shall fulfill the duties of the President in the latter's absence. She shall be responsible for all courtesies to special visitors at meetings.

Section 3. The Second Vice-President shall be responsible for such work as may be assigned her by the President.

Section 4. The Third and Fourth Vice-Presidents shall be responsible for auxiliary work in the Northern and Southern Conventions.

Section 5. The Recording Secretary shall take the minutes of the meetings and shall prepare an annual report of work done by the Missouri Branch. She shall forward said report to the Executive Secretary of the Woman's Auxiliary.

Section 6. The Corresponding Secretary shall send all notices and carry on all necessary correspondence.

Section 7. The Treasurer, under direction of the Board of Managers or the Executive Board, shall receive and disburse all money, presenting a report of same at each quarterly meeting.

Section 8. The Auditor shall examine the accounts of the Treasurers, namely: The Woman's Auxiliary, The United Thank Offering, The Auxiliary "Special" and the Endowment and Memorial Gifts and present vouchers for same.

Section 9. The Educational Secretary shall be responsible for the conducting of Bible and Mission Study Classes, following suggested subjects sent out by the General Educational Secretary. She shall disseminate missionary material and information; and co-operate with all agencies in the Diocese for religious education.

Section 10. The Supply Secretary shall be in charge of the supply work of the Diocese, apportioning the Parish quotas. She shall make her report to the General Secretary of the Supply Department.

Section 11. The United Thank Offering Treasurer shall stimulate interest in this phase of auxiliary work. She shall have charge of all money collected for this purpose and shall make a report at all meetings. She or her alternate shall present the offering at the Triennial.

Section 12. The Executive Board shall have authority necessary to conduct all business between meetings. It shall pass on the report of the Finance Committee and make recommendations to the Board of Managers. It shall direct the policy of the Auxiliary.

BY-LAW III—REPRESENTATIVES.

Section 1. (A) Each Parish is entitled to four representatives, one of whom shall be the President and one the Corresponding Secretary of the Parish Branch.

(B) Any additional Branch in a Parish is entitled to two representatives.

Section 2. The Representatives shall attend the Diocesan Meetings and respond to the General pledges for their branches.

Section 3. The method of choosing representatives shall be left to each Parish Branch.

BY-LAW IV—ELECTION OF OFFICERS.

Section 1. The Officers shall be elected by ballot at the Annual Meeting for a term of three years.

No officer shall be eligible to succeed herself in the same office.

No member shall serve on the Board in any capacity for more than two consecutive terms.

Section 2. A nominating committee consisting of five members shall be chosen by the Executive Board at the December meeting, which committee shall prepare a ticket.

Section 3. The President shall appoint four members to serve as tellers on the day of election, these persons having been previously notified.

Section 4. The Executive Board may fill a vacancy in any elective office by temporary appointment and the person thus appointed shall hold office until the next regular meeting of the Board of Managers, at which meeting the vacancy shall be filled by election and the person thus elected shall hold office until the next Annual Meeting.

Section 5. At each Annual Meeting there shall be elected by ballot one member at large to serve on the Executive Board for a term of three years.

Section 6. Delegates and alternates to the Triennial Convention shall be elected at the annual meeting preceding the General Convention.

BY-LAW V—FINANCE COMMITTEE.

Section 1. There shall be a Finance Committee composed of three members chosen by the Executive Board, two of whom shall be the President and Treasurer.

Section 2. This committee shall prepare the budget for the year's work and shall make plans for financial projects not otherwise assigned.

BY-LAW VI—ENDOWMENT AND MEMORIAL GIFTS.

Section 1. There shall be an Endowment Fund. Only the interest from this Fund may be used for Auxiliary work the principal must remain intact. The Endowment Fund shall be in charge of a Board of Trustees composed of the Endowment and Memorial Gifts Committee. Any individual or branch giving one hundred dollars to the Endowment Fund may name the gift.

Section 2. There shall be an Endowment and Memorial Gifts Committee composed of the Diocesan President, the Treasurer and three other members, which members shall be elected at the Annual Meeting for three years. This committee shall have full charge of receiving, investing and expending the interest of these funds. Anyone wishing to present a Memorial gift shall do so through this committee.

BY-LAW VII—PERMANENT COMMITTEE.

Section 1. A permanent Advisory Committee shall consist of the past presidents of the Woman's Auxiliary. Each member shall serve for one year as Chairman of this Committee in the same order she served the Woman's Auxiliary as Diocesan President. This Committee shall serve in an advisory capacity when called upon by the Executive Board.

BY-LAW VIII—MEETINGS.

Section 1. There shall be four meetings each year, one of which, the Annual Meeting shall be held immediately preceding or immediately following the Diocesan Convention. These meetings are open to all, directed by the Bishop of the Diocese and held in the various parishes by invitation.

Section 2. At the meetings specified in Section 1, members of the Board of Managers only are eligible to cast a vote.

Section 3. Upon the request of four Parishes, the vote on any question may be called for by parishes and in case of a division, the individual roll call may be demanded.

Section 4. Special meetings may be called by the President.

Section 5. The Executive Board shall hold regular meetings from September to June, inclusive.

BY-LAW IX—AMENDMENTS.

These By-Laws may be altered or amended at any regular meeting by a two-thirds vote of the members of the Board of Managers present—due notice having been given each member.

STANDING RULE.

In recognition of the services of a retiring diocesan president a useful gift suitably inscribed as presented by the Woman's Auxiliary may be made to some mission or hospital, church school or similar institution in which the retiring president was interested; subject to the approval of the Bishop of the diocese in which the gift is to be made. The presentation is to be made at the first quarterly meeting following her completed term of office. This gift shall not exceed fifty dollars.
