

FIFTY YEARS!

The Woman's Auxiliary in the Diocese of Missouri seems to have come into being in the year 1881. In the Diocesan Journal for that year, I find, under date of September 30, the following minute:

"The Right Reverend President (Bishop Robertson) appointed Miss Mary W. Triplett, of Christ Church, St. Louis, Diocesan Secretary of the Woman's Auxiliary Society of the Board of Missions of the General Church."

Records which are available indicate that it was not until 1884 that a more complete organization was effected by the election of Mrs. Charles F. Roberston as President; Mrs. E. A. Manny as Vice-President; Mrs. Clement M. Seaman as Treasurer; and Miss Mary W. Triplett as Secretary.

So then, this year marks the Fiftieth Anniversary of the Woman's Auxiliary in the Diocese of Missouri. Always there has been a steady development in its vision, its scope, its influence, and its givings. The Report for 1881 shows that only six Parishes were associated with the work. And the Financial Report for 1881 gives a total of \$866.13, being the value of "the total number of missionary boxes sent." The Report for 1929, (the figures for 1930 are not available as I write), shows that 42 Parish Branches were contributing. And the Financial Report gives a total of \$33,467.79. It is a most gratifying record of accomplishment, isn't it!

The list of Officers and Members of the Auxiliary is bright with the names of consecrated, faithful, praying, forward-looking women, whose compelling desire has been to give joyful and loving service to the Church; in the early days limited in its field, but now auxiliary to every department of the Church's broadening sphere of work. One may never know how far-reaching the efforts of the women have been. One may never know how much theirs has been the inspiration which has kept alive the Missionary Program, without which there can be no real growth. I give them hearty thanks for their splendid achievements in the years that are past. And I pray that you who are now carrying on may continue to travel, with Prayer and Work as partners, into a future filled with great possibilities for making the Name of Christ known above every other name.

In addition to these money pledges we received—several of the churches responded to our special appeal for Christmas gifts, clothing and food, all of which were distributed.

It has been the custom in past years to give two candy parties at the City Infirmary, and an ice-cream party at Koch Hospital. In 1930, however, Mr. George thought that as there were so many people in great distress and without any kind of food, the money should be spent in helping these unfortunates instead. This was done and the money turned over to Mr. George to use as he thought best.

Our Investigating Committee of six is proving of great help in the work as we are able to follow up the appeals that come in under the Social Service Department. We have endeavored to assist the St. Louis Provident Association by providing voluntary workers to aid the trained Social Service workers in various channels.

It was my privilege to attend a meeting addressed by Dr. Lathrop, Social Service head of the Episcopal churches in New York. We are hoping to follow the plan Dr. Lathrop (now deceased) suggested of having the Social Service chairmen of every church meet once a month, at which trained Social Service workers could direct us in some definite work that each church might undertake.

In conclusion, I wish to take this opportunity of thanking the various churches from which our work has received such loyal support in the past.

Report of Educational Secretary

This report covers only the last eight months, the period during which I have held the office of Diocesan Educational Secretary. In order to allow time for preparation for the active season in the fall, a meeting of the branch Educational Secretaries was held in June, at which plans for the ensuing year were adopted.

The prescribed subject for the year was India. An outstanding feature of this part of the educational program was a diocesan study group, most ably led in a series of six lectures by Mrs. Putney, devoted to this subject. These lectures were attended by representatives from the city and county.

Miss Marston, our national Educational Secretary, gave us an inspiring and informing day at the Tuttle Memorial, Nov. 6th. Her subject was "Educational Methods." On Nov. 7th, she gave a program on India at Columbia to sixty women from Macon, Palmyra, Jefferson City, and St. Louis.

Turning to my own activities, I was greatly inspired at the beginning of my work by the Racine Conference for Educational Secretaries held May 1st and 2nd. It has proved most helpful to me during the year. I was also greatly aided by the contacts and conferences later at the meeting of the Synod at Little Rock, Arkansas.

I have talked on Religious Education to the following branches:—St. James, Macon; St. Augstine's, Maplewood (twice); Grace Church, Kirkwood; Calvary, Columbia; Emmanuel, Webster Groves; and in the city of St. Louis, St. John's; St. Paul's; the Cathedral Branch, Cathedral; Ascension; St. Elizabeth's Guild, Cathedral; and to two circles at the Church of the Redeemer. I have also addressed the G. F. S. at St. Peter's and St. Stephen's. Those listed in the Speaker's Bureau have also generously responded to calls by the various branches. Beside these addresses in the regular line of duty, I have talked to a group of young women at the Presbyterian Church in Webster Groves, and also talked on Gandhi to the Women's Missionary Society of the Presbyterian Church.

I have attended two meetings of the Women's Missionary Federation and three meetings of the department of Religious Education of the diocese. I was one of the twelve Auxiliary women who went to Columbia on May 9th, and one of those who went to Monroe City on Oct. 8th, each time to attend the District meeting and to help with the program.

In regard to the present activities, I would say that at least fourteen of the parish branches are making a consecutive study of India. An index, perhaps, will be found, of the interest of the women of the diocese, in the list of titles of books and the number sold. It is as follows: *India Looks to Her Future*, 75; *Leaders's Manuel*, 30; *India on the March*, 50; *The Woman's Auxiliary in the Life of the Church*, 75; *Is Mahatma Gandhi the Greatest Man of the Age?* 40; *Our Expanding Church*, 25.

In closing, I wish to express my deep obligation and gratitude to Mrs. Shepley, the members of the Board and the other members of the Auxiliary, for their unfailing encouragement and cooperation which have made this work such a joy.

Report of the Episcopal Home for Children

The year 1930 which has just closed witnessed a number of changes in our Home which we believe represent real progress. Realizing that our physical equipment and our methods were equally out of date, our Board entered, two years ago, upon a program of reconstruction which is now beginning to show results.

While awaiting a court decision as to our right to sell the present property, we are facing the necessity of deciding upon the future policy of this Institution: shall we continue the same type of Home? If so, should it be in the city or in the country? Are we duplicating the work of other organizations? What is our place in the Child Welfare program of this community? The Executive Board, conscious of the tremendous importance of this step, requested the appointment of a committee to make a study of the community and our relations to the program. This committee consisting of Bishop Scarlett, Dr. Block, Mr. George, Mr. Bloy, Dr. Clopton and Mr. Pangman, with the president and four members of the Board, have begun their investigations and their report will be readily received.

In the meantime, while realizing the handicaps of our present equipment, we have gone steadily on with the program of child care and training which we feel is a worth-while contribution to the community, and which does in some measure compensate for the loss of home and family life which these children have experienced. The moral and spiritual training of the children; the development of good habits; their physical welfare; their school work are all a part of our daily program. We believe that everything possible must be done to prevent illness, and to build up strong bodies, so particular attention is paid to diet, recreation, etc. Complete physical examinations are held at regular intervals and special care given to underweight children. We are most grateful to Dr. Riley for his efficient and generous ministrations to our children and also for the splendid service rendered by the other doctors on the staff.

Our children attend Sunday School at the Cathedral and enjoy many privileges which go with such membership. Our much loved chaplain, Canon Small, comes to us once each week for a service and visit and is welcomed as a member of the family, a relationship which will be of great value to the children in the future.

The order from the fire department, condemning the third floor has limited our intake since 1929, but during the past year all applications have received careful consideration through our department of social service. A full report of Miss Hodgdon's work follows:

There were 100 applications for admission received. Of this number 71 were referred to another agency without investigation; 20 were referred after a partial investigation indicated that they could be better cared for elsewhere. Eleven children of eight families were dismissed, and fourteen children of nine families were accepted.

The family status of the children under our care is interesting and might indicate the diversified problems which we are asked to treat. We have only one child who is a full orphan; 8 of the children have only a father living, and 5 have only a mother living. Fourteen are from homes broken by either divorce or separation of the parents. We have 6 children from homes where there is a step-parent and it has not been possible to return them to the family group. The 34 children under our care represent 17 families, 2 children are being supervised outside the Home; and contact is maintained with about 4 or 5 other children or their families, who were formerly in the Home.

During the year only one application for admission to Brittain Hall was received and accepted. Four boys have left the Hall this year as other plans have been made for them. There are 7 boys in residence as 1930 closes. Three of these boys are full orphans; 2 half orphans and 2 are from homes broken by divorce or separation.

Our children of course attend the public schools but we have found in individual cases where the age limit has been reached before graduation from high school or where for other reasons a child will probably not be able to enter high school, there is an urgent need for vocational training. Our present income does not permit us to extend this kind of aid and we have decided to present to the Church in the near future, a plan for an educational fund to be used exclusively for this purpose.

There are certain children, who after careful study, are found unable to adjust themselves to the group life of an institution and who are recommended by the specialist whom we consult, for foster home placement. Again our limited funds do not provide for this work and we are obliged to surrender the supervision of our children to another agency. This, in the case of children baptised or confirmed in the Church, we feel is a failure to fulfill our obligations and we are planning for a boarding home fund to enable us to care for these children.

Report of the Girl's Friendly Society

January 30, 1931.

The Girl's Friendly Society reports seven branches in the Diocese of Missouri, and three new ones now organizing. The Missions, Social Service, and Parish work has been quite active in these branches; a report of the same is in the Convention Bulletin. A few of the changes in the National organization that are of interest, are the changing of the rules, there being two rules now instead of three, which change took place in Boston three years ago after many years of discussion which greatly hampered the forward work of the society. The adoption of the budget system and new programs and affiliations with kindred organizations.

For the last ten years the Council of the Church has added \$3,000.00 to the Society's income to do its work and advance programs. This money was appropriated during the war, at which time the G. F. S. did some spectacular work in New York, Washington, and Texas. As the quotas of the Nation-Wide Campaign have not been fully met, the Council of the Church is asking its organizations, if possible, to be self-supporting. The Brotherhood of St. Andrew has already accomplished this and the Girl's Friendly Society is planning to do the same.

The program and activities are under the able direction of Mrs. Cording with Dr. Adelaide Case as advisor. Dr. Case is one of the outstanding educators in the Church. The affiliations with such organizations as the Child Health Organization, Camp-Fire Girls, Girl Scouts, Social Hygiene, Religious Education, and Progressive Education is of inestimable value in keeping the society abreast with the questions of the day. Eleven members attended the national convention in Chicago in last October. All were impressed and vastly interested by the presence and sympathy of Miss Lindey of the Woman's Auxiliary, Jane Adams of Hull House, and Shales Mathews of the Chicago University, all of whom made addresses during the meetings.

The outlook and working for the betterment of education and character in the program building left us with the hope of increased strength and growth. So we beg the continued interest and support of the women of the church to help enlarge this work, which is the only work of a national scope in the church for girls.

Constitution

ARTICLE I—NAME.

This organization shall be called "The Missouri Branch of the Woman's Auxiliary to the National Council."

ARTICLE II—OBJECT.

Its object is to increase the interest and unite the efforts of all women in the Diocese in the Church's Mission in the Parish, in the Community, in the Diocese, in the Nation and in the World.

ARTICLE III—MEMBERSHIP.

Its membership shall consist of all baptized women who pray for, work for, or give to the Church in the Five Fields of Service.

ARTICLE IV—AMENDMENTS.

This Constitution may be altered or amended at any annual meeting by a two-thirds vote of the members of the Board of Managers present; due notice having been given to each member.

By-Laws

BY-LAW I—OFFICERS.

SECTION 1. The Officers shall be a President, First Vice-President, Second Vice-President, Third Vice-President, Fourth Vice-President, Recording Secretary, Corresponding Secretary, Treasurer, Auditor, Educational Secretary, Supply Secretary, Social Service Secretary, and United Thank Offering Treasurer.

SECTION 2. There shall be an Executive Board composed of the officers, special secretaries and treasurers, and three members at large.

SECTION 3. The Board of Managers shall consist of the Executive Board and the Parish Representatives; twenty-five members constituting a quorum.

Annual dues of \$1.00 for each member of the Board of Managers shall be paid to the Auxiliary Diocesan Treasurer before the first of February.

SECTION 4. Honorary offices with the right of vote may be created by a two-thirds vote of the Board of Managers.

BY-LAW II—DUTIES OF OFFICERS.

SECTION 1. The President shall preside at all meetings; appoint committees; be a member ex-officio of said committees and fulfill all such duties as pertain to her office. By virtue of her office she shall be a Delegate to the Triennial. She shall make a written report of the year's work to the Diocesan Convention, which if so ordered by the convention may be published in the Journal. She shall appoint the Special Secretaries and Treasurers.

SECTION 2. The Social Service Secretary shall be responsible for all Social Service Work undertaken by the Auxiliary.

SECTION 3. The First Vice-President shall fulfill the duties of the President in the latter's absence. She shall be responsible for all courtesies to special visitors at meetings.

SECTION 4. The Second Vice-President shall be responsible for such work as may be assigned her by the President.

SECTION 5. The Third and Fourth Vice-Presidents shall be responsible for Auxiliary work in the Northern and Southern Convocations.

SECTION 6. The Recording Secretary shall take the minutes of the meetings and shall prepare an annual report of work done by the Missouri Branch. She shall forward said report to the Executive Secretary of the Woman's Auxiliary.

SECTION 7. The Corresponding Secretary shall send all notices and carry on all necessary correspondence.

SECTION 8. The Treasurer, under direction of the Board of Managers or the Executive Board, shall receive and disburse all money, presenting a report of same at each quarterly meeting.

SECTION 9. The Auditor shall examine the accounts of the Treasurers, namely: The Woman's Auxiliary, The United Thank Offering, The Auxiliary "Special" and the Endowment and Memorial Gifts and present vouchers for same.

SECTION 10. The Educational Secretary shall be responsible for the conducting of Bible and Mission Study Classes, following suggested subjects sent out by the General Educational Secretary. She shall disseminate missionary material and information; and co-operate with all agencies in the Diocese for religious education.

SECTION 11. The Supply Secretary shall be in charge of the supply work of the Diocese, apportioning the Parish quotas. She shall make her report to the General Secretary of the Supply Department.

SECTION 12. The United Thank Offering Treasurer shall stimulate interest in this phase of auxiliary work. She shall have charge of all money collected for this purpose and shall make a report at all meetings. She or her alternate shall present the offering at the Triennial.

SECTION 13. The Executive Board shall have authority necessary to conduct all business between meetings. It shall pass on the report of the Finance Committee and make recommendations to the Board of Managers. It shall direct the policy of the Auxiliary.

BY-LAW III—REPRESENTATIVES.

SECTION 1.(A) Each Parish is entitled to four representatives, one of whom shall be the President and one the Corresponding Secretary, or the Treasurer, of the Parish Branch.

(B) Any additional Branch in a Parish is entitled to two representatives.

SECTION 2. The Representatives shall attend the Diocesan Meetings and respond to the General pledges for their branches.

SECTION 3. The method of choosing representatives shall be left to each Parish Branch.

BY-LAW IV—ELECTION OF OFFICERS.

SECTION 1. The Officers shall be elected by ballot at the Annual Meeting for a term of three years.

No elected officer shall be eligible to succeed herself in the same office.

No member shall serve on the Board in any capacity for more than two consecutive terms.

SECTION 2. The Executive Board shall constitute a nominating committee to prepare a ticket to be voted upon at the Annual Meeting.

SECTION 3. The President shall appoint four members to serve as tellers on the day of election, these persons having been previously notified.

SECTION 4. The Executive Board may fill a vacancy in any elective office by temporary appointment and the person thus appointed shall hold office until the next regular meeting of the Board of Managers, at which meeting the vacancy shall be filled by election and the person thus elected shall hold office until the next Annual Meeting.

SECTION 5. At each Annual Meeting there shall be elected by ballot one member at large to serve on the Executive Board for a term of three years.

SECTION 6. Delegates and alternates to the Triennial Convention shall be elected at the annual meeting preceding the General Convention.

BY-LAW V—COMMITTEES.

SECTION 1. There shall be a Finance Committee composed of the President, Treasurer, Supply Secretary, Social Service Secretary and one other member of the Executive Board.

SECTION 2. This committee shall prepare the budget for the year's work and shall make plans for financial projects not otherwise assigned.

SECTION 3. There shall be a Year Book Committee composed of six members of which the Recording Secretary shall be the Chairman. The other members shall be the President, the Corresponding Secretary, the Treasurer, the Auditor, and the Chairman of the Supply Committee. This Committee shall publish a Year Book which shall be distributed and a copy forwarded to the Secretary of the National Board of the Woman's Auxiliary.

BY-LAW VI—ENDOWMENT AND MEMORIAL GIFTS.

SECTION 1. There shall be an Endowment Fund. Only the interest from this Fund may be used for Auxiliary work the principal must remain intact. The Endowment Fund shall be in charge of a Board of Trustees composed of the Endowment and Memorial Gifts Committee. Any individual or branch giving one hundred dollars to the Endowment Fund may name the gift.

SECTION 2. There shall be an Endowment and Memorial Gifts Committee composed of the Diocesan President, the Treasurer and three other members, which members shall be elected at the Annual Meeting for three years. This committee shall have full charge of receiving, investing and expending the interest of these funds. Anyone wishing to present a Memorial gift shall do so through this committee.

BY-LAW VII—PERMANENT COMMITTEE.

SECTION 1. A permanent Advisory Committee shall consist of the past presidents of the Woman's Auxiliary. Each member shall serve for one year as Chairman of this Committee in the same order she served the Woman's Auxiliary as Diocesan President. This Committee shall serve in an advisory capacity when called upon by the Executive Board.

BY-LAW VIII—MEETINGS.

SECTION 1. There shall be three meetings each year, one of which, the Annual Meeting shall be held immediately preceding or immediately following the Diocesan Convention. These meetings, which are held in the Bishop Tuttle Memorial, are open to all. There shall also be one meeting of the Board of Managers during the year.

SECTION 2. At the three meetings specified in Section 1, members of the Board of Managers only are eligible to cast a vote.

SECTION 3. At the Annual Meeting the vote on all measures shall be cast only by representatives who have served during the year.

SECTION 4. Upon the request of four Parishes, the vote on any question may be called for by parishes and in case of a division, the individual roll call may be demanded.

SECTION 5. Special meetings may be called by the President.

SECTION 6. The Executive Board shall hold their meetings from October to June inclusive.

BY-LAW IX—AMENDMENTS.

These By-Laws may be altered or amended at any regular meeting by a two-thirds vote of the members of the Board of Managers present—due notice having been given each member.

STANDING RULE.

In recognition of the services of a retiring diocesan president a useful gift suitably inscribed as presented by the Woman's Auxiliary may be made to some mission or hospital, church school or similar institution in which the retiring president was interested; subject to the approval of the Bishop of the diocese in which the gift is to be made. The presentation is to be made at the first quarterly meeting following her completed term of office. This gift shall not exceed fifty dollars.
