



Report of the President of the Woman's Auxiliary

To the Bishops of Missouri and the Members of the Ninety-Third Diocesan Convention, we present the report of the Woman's Auxiliary of the Diocese of Missouri for the year 1931.

The work of the Auxiliary, during the past year, has gone on quietly and from a financial point of view can be said to have accomplished its task and completed its budget—but the real test is, has it fulfilled its mission as a vital force in the Church's work? Has it realized the vision received as the ultimate aim of its endeavors?

In our last report we quoted from Miss Emery, one of the first Secretaries of the Auxiliary, who stressed "that the things taken into account should be what was best for the work of the whole Church, since before we are members of the Auxiliary we are members of dioceses and parishes," and—to quote again, "she would ask both the Board and the Auxiliary to consider whether a real gain might be made if we would emphasize the Auxiliary less as an organization but rather as a reminder, a co-operator and a vehicle by and through which the missionary interests of the Church might be strengthened in any and every department of parish life."

The program for the Auxiliary, at the General Convention in Denver, went a step farther and by selecting such subjects as Family Life, Economic Conditions, International Relations, Interracial Contacts, and Religious Thinking Today, to be used in the Discussion groups in Denver, and as the foundation upon which the study classes, for the next three years, should be built, carried the women into the realm of world problems and accepted the larger thought of the Auxiliary as representing the Mission of the Church and not just its Missions, believing that the former includes not only the latter but also is concerned with all such questions as Church Unity, World Peace, Universal Disarmament, International Relations, and more Christian ideals in the relation between man and man in both the social and industrial world.

The spirit of the Convention, as far as the women were concerned, was one of deep conviction tempered by a broad tolerance, a courageous willingness to adventure along new lines of thought and action, and an earnest and fearless search for truth as revealed by God in the new discoveries of science and the more recent developments of history.

One hundred dioceses and missionary districts were represented by over 400 delegates, and about 2,000 women were present at the meetings.

For the details of the Missouri work we refer you to the printed reports, but we cannot refrain from an acknowledgement of the faithful, conscientious and efficient service rendered by each member of the Executive Board, and it is our sincere regret that the time of service has expired in the cases of a number of our Board members.

We are especially stressing the Educational features of the Auxiliary, and Mrs. James H. George is developing this program most effectively. We trust that you will read her appended report carefully.

We have missed at our Executive Meetings our Honorary Vice-President, Mrs. Frederick F. Johnson, who by her gentle graciousness and wise counsel has endeared herself to all the members of the Board.

When Mrs. George Tittmann found that she would be away from St. Louis for the winter, she resigned as Devotional Secretary, and we wish to express our deep appreciation of all that she did to emphasize the spiritual and devotional work in the Auxiliary.

Mrs. Rufus D. S. Putney has taken her place and those who heard Mrs. Putney conduct the Meditations and Intercessions for the women, in connection with the Every Member Canvass, realize what a contribution she has to make to the Auxiliary of an inspirational nature.

The work of the Supply Department has been handled so efficiently by our retiring Secretary, Mrs. W. S. Mason, that we have not only been able to meet our requirements from the National Office, but have been able to increase our apportionment and it is with real regret that we see her leave the Board.

The fine report of our United Thank Offering Treasurer has already been printed and we are happy to have had a share in that wonderful offering presented at the Triennial by the women of the Church, \$1,059,575.27.

This offering is, as you know, a freewill thank-offering over and above the regular pledges made by the women. We are truly grateful to Mrs. Herbert M. Edmunds for her untiring and faithful service in helping collect that offering.

Mrs. C. C. Pangman, our Social Service Secretary, has done much to increase the interest in the Social Service Department and we regret that she is unable to help complete and carry out some new plans for that department, which she has worked over and which we believe will greatly increase the efficiency and also the interest in that Department.

For personal reasons and not because her term of office has expired, we are most reluctantly obliged to accept the resignation of our Second Vice-President. She has rendered most valuable service in the planning of our programs and we shall miss Mrs. J. Arthur Corbitt greatly at our Council table.

We feel that we cannot let Mrs. Burritt retire entirely from Auxiliary work and although the By-Laws call for a new Representative in her place, we are happy to say that she has agreed to serve as one of the Trustees of our Endowment and Memorial Gifts Fund.

We are pleased also to announce that Mrs. W. C. Rumsey, our former President, has been made Chairman of this Fund.

The Diocesan Altar Section, with Miss Annie S. Cousland as Chairman, has given valuable service and assisted a number of our Clergy throughout the Diocese, in various ways which have been greatly appreciated.

We acknowledge with gratitude the kind interest and encouragement always given to the Auxiliary by Bishop Johnson and have missed him at our meetings during his absence.

We are happy to report that our budget for 1932 calls for an increased pledge for Bishop Scarlett's work in the Diocese and we very greatly appreciate the assistance and co-operation he is giving the women in his Diocese.

Three women from our Church are members of the Women's Missionary Federation Board and our Auxiliary makes a small donation in money. Our Auxiliary President represents this Board on the St. Louis Council of Organizations for Promoting Peace.

We also have a representative on the Board of the Young Women's Christian Association. And we take part in the World's Day of Prayer, thus showing our desire to co-operate in the work and the services of the other Protestant bodies.

Our various Parish Auxiliaries and Guilds are helping with the work being done by the Citizen's Relief and Unemployment Committee and a number of our Church women have individually volunteered for service with this committee and the Red Cross.

The Second St. Louis Educational Week for the Blind organized by the American Foundation for the Blind, and under the auspices of the Missouri Commission for the Blind, was conducted in October, 1931.

Members from practically all of our St. Louis parish auxiliaries, together with the women from the Presbyterian and Evangelical Churches were in charge one day, and it proved a very successful occasion.

At our January meeting last year, we had the pleasure of hearing Mrs. John C. Tolman, who was then the Provincial Auxiliary President of the Seventh Province, tell about the Helen Dunlop School in Arkansas, to which our Synod pledge is given; and later in the year, Miss Edna B. Beardsley, Assistant Secretary of the Woman's Auxiliary, spent a few days in this Diocese. She gave informal but most helpful talks to a number of groups in St. Louis, and then visited the Auxiliaries in Columbia and Hannibal.

We received great inspiration from a Quiet Morning in the Cathedral, conducted by the Rev. John W. Suter, Jr., Executive Secretary of Education, and he also met and talked with those engaged in Religious Education in both the Church Schools and the Auxiliary.

In June some of the Auxiliary officers and other members, attended a most successful Summer Conference and Training School for Young People and those engaged in Church work, under the auspices of the Diocese of Missouri and the Diocese of Western Missouri, in Columbia, Missouri. The young people were lead by Miss Dorothy Fischer, Executive Secretary of the work for Young People in the Seventh Province, and this fall she spent two months in this Diocese. While this report comes under another department, the Auxiliary feel that Miss Fischer was not only a wonderful leader for the young people but that she gave inspiration and help to the women as well, and we are greatly indebted to her for her splendid achievements in the Diocese.

In reporting what has been accomplished, we feel we should tell of the aims and ambitions of the Auxiliary for the future and we have taken the liberty of quoting from a very fine paper delivered by Dr. Daniel A. McGregor to the women at the General Convention. His subject was "Christianity and International Relations." He says in part:

"The Church has not sufficiently recognized her own high function. She has been content to be the Red Cross, giving relief in the battle of life. She must rise to her true calling as director of the destinies of man. If the Christian Church is to perform the great tasks which lie before her in the coming days, there are two preparations which she must make before those days come. The first is that of achieving unity, and the second is that of realizing her international character. The Christian Church began her life as a solution of the international problem. She claimed that the true and only abiding international unity was that of the family of God in Christ Jesus. Time has justified her claim, for while empires have fallen, she has stood. A distracted world looks for the secret of unity and a divided Church can give no guidance. Christian unity is not a mere economic device, it is the very heart of the Christian life. In this work every one of us is bearing a share. International politics are complicated and confusing, plans and programs, and

leagues and treaties are beyond the understanding of most of us, and many a person who would gladly serve in the cause of world-unity knows not where to begin nor how to serve wisely. But in the work of Missions the humblest and the most obscure can serve. For we are not making mere Episcopalians, we are creating the new family of humanity in Christ Jesus, which alone can stand through the storms of time.

"Centuries hence, when the history of these times comes to be written, when men are able to see in better perspective the world-movements of the nineteenth and twentieth centuries, it will appear that here was being created in those days an international fellowship of humanity, the Christian Church, and that that work was the most important creation which those centuries gave to the future. Silently, quietly, the work goes on. On the surface we see the turmoil of the nations, from their struggles we hear the shouts of hatred and despair. But in the background and the shadow, where humble souls are witnessing for Jesus Christ, they are bringing into His fellowship men and women of every land, and some day this new fellowship shall cover the earth as the waters cover the sea and will bring in the longed-for day, the day of human brotherhood in the Kingdom of God."

Pledges for 1930 amounted to \$1,394.00, and for 1931 to \$998.00—a decrease of \$396.00. Owing to this shortage some of our work had to be curtailed, particularly that of Mr. George, City Missionary, whose budget for \$831.00 could only be granted to the extent of \$513.00.

As you know, commencing with this year 1932, the Social Service Budget is now to be included with the General Budget of the Woman's Auxiliary. This means that the Parishes will not be called upon to make special pledges for this work, as in the past, but you are reminded of the continually increasing needs of the Social Service Department and it is hoped you will provide for them liberally.

At Christmas we sent 125 gifts to the Isolation Hospital, and about 100 gifts to the Training School. All these were donated by the Parishes.

By a private donation of \$25.00 we sent Mrs. Hurlbut sweaters and caps for the children in her care, and also a bolt of flannelette.

In March, April, and May of last year we had a luncheon the first Friday in each month with Prof. Bruno as our speaker. He was most inspiring. In December we had a very interesting luncheon attended by the Social Serv-

ice Secretaries of each Parish and by many of the Clergy. The meeting had the privilege of hearing an address by Mr. Ware, of Cincinnati, who came at Dean Sweet's invitation and spoke on Social Service work. I believe such luncheon meetings prove helpful to us all and I hope that they may be continued as they afford an opportunity to meet and discuss our problems.

I conclude this report with an expression from Dean Sweet who asks that the Parish Social Service Secretaries try and work out a plan of closer co-operation with the Social Service Department of the Diocesan Council. By bettering our team work we will be helping forward the cause of relief which is more than ever needed today.

Report of Educational Secretary

As a result of the North American Home Missions Congress held in Washington, D.C., December, 1930, all communions planned to study the questions which face us in the United States as we attempt to build a Christian Nation. As we had studied Africa, the World Mission of Christianity, and India in these past three years, we were forced to face the fact that if we would build a more Christian world we must be concerned with making Christian every area of life in our own land.

A splendid list of preliminary reading was sent out and reading groups were formed for summer reading that we might better understand the problems that confront us today.

An outstanding feature of the Educational Program has been a Diocesan Study Group, ably led by Mrs. Putney, on the subject for the year, "Building a Christian Nation." Mrs. Putney has talked at Grace, Holy Cross, (twice); Emmanuel, Webster; St. Michael and St. George's; Bethesda Nurses; Business and Professional Women's Club; Cathedral; Holy Apostles; St. Augustine's; Ascension; Redeemer and Grace Church, Kirkwood.

I have talked on some phase of Religious Education at the following places: Cathedral Branch (five times); St. Elizabeth's, Cathedral; St. Margaret's, Cathedral; Holy Apostles; Redeemer; St. Peter's, (twice); St. Michael and St. George's, (twice); Prince of Peace; Holy Communion, (twice); Ascension; St. Paul's; St. Augustine's, (twice); St. Stephen's, Ferguson; Christ Church, Cape Girardeau, (three times); Palmyra (twice); Calvary, Columbia, (twice); St. Luke's, Valley Park, (twice); Trinity, Hannibal; St. James, (twice); Rolla, (twice); St. James, Macon, (twice); Grace Church, Jefferson City; Calvary, Louisiana (district meeting); Emmanuel, Webster Groves; Grace Church, Kirkwood and Poplar Bluff. I have visited and talked with Church people in Fredericktown (three times); Herculaneum and Moberly. On May 9th, I lead a discussion on Young People's programs at the Young People's first Convention; later I spoke to the Young People's group at Holy Communion and at St. Paul's and was asked to be on their list of speakers. Besides these I have talked on Gandhi to a club in Webster; on China to a Church School class in Kirkwood; on Gandhi to the Y.W.C.A. of St. Louis; to the Girls' Friendly at St. Peter's twice, and at St. Stephen's, once.

The monthly meetings of the Department of Religious Education and the Conference for Church workers held in June in Columbia I found most helpful.

Three meetings of the Educational Secretaries have been held where problems were discussed and future plans were made.

I have also attended the World Day of Prayer, three meetings of the Devotional Secretaries, and a Conference for Educational workers conducted by Mr. John W. Suter.

I received much inspiration as well as information at the General Convention and was happy to be able to attend the Class on Religious Education for the Adult led by Miss Marston, our National Educational Secretary. The speeches on International Relations, Interracial Contacts, Property and Economic Conditions, Family Life and Religious Thinking Today, were most helpful as were also the Meditations led by Miss Lindley, conferences with educational leaders and the many personal contacts.

In closing I wish to thank Mrs. Shepley and the members of the Board for their co-operation and for the use of the car which has greatly increased the possibilities of this work.

Report of the Devotional Secretary

If, as an eminent philosopher said, "The condition of the world today is not merely a financial depression, but a failure in the building of moral character," then truly (as our little red book says) we face the need, the great need, to deepen our spiritual life individually and as an organization to the end that Christ's Kingdom may come upon earth.

This report is of the fine work done by my predecessor, Mrs. George Tittman, as I have officially done nothing except to meet once with the parish secretaries and make some plans for the future and make one visit to the Woman's Auxiliary of Valley Park where I talked about Prayer.

Twenty-one parish secretaries are carrying on in their respective parishes in St. Louis and out of town.

Two parishes reported services of Intercession before the Every Member Canvass in addition to the Day of Intercession at Christ Church Cathedral.

Three parishes have regular weekly services of Prayer and Intercession led by the Rectors, and three have Bible Classes taught by the Rectors.

All reported a short Devotional Service at the beginning of each Woman's Auxiliary meeting; and the distribution of devotional literature and prayer leaflets.

One reported a growth in spiritual life keenly felt throughout the Parish due it is thought to an appointed hour being set aside each day for prayer by the women of the parish, each in her own home, but united in spirit with all.

Interesting letters have been received from our prayer partners Deaconess Binns of Nora, Virginia and Miss Clarkson of Sagada, Philippine Islands. Also a very appealing one from Eunice Sun, China, who had not been heard from for two years. She asks prayers for her work, her family and her China.

We are co-operating as much as possible in the World's Day of Prayer, February 12, and may I appeal to you to set aside at least a part of that day to worship in the appointed places. Again I quote our little Red Book, "Our most important work—Intelligent and faithful prayer by all the people of the Church would solve the great problems the Church is facing today."

Report of the Episcopal Home for Children

The year 1931 has not been marked by any outstanding achievement but it has been characterized by a conscientious effort to promote the interest and welfare of the children in every way consistent with our means.

Systematic medical and dental care, daily training in health habits with attention to diet, rest and recreation have brought us to a high standard of physical health. Supervised home study and co-operation with teachers have resulted in better accomplishments in school. An attempt to understand the individual child, with help from Specialists when needed, is bringing about better personality adjustments. Disciplinary problems are very few and a wholesome atmosphere pervades the Home despite the gloom of our physical surroundings.

In January, the Diocesan Council appointed the First Sunday in June as a time for special offerings for the Home and we hope that this work for children will become increasingly the prayerful responsibility of the Church. As a means of presenting our work to the Diocese we will publish at intervals a bulletin known as the "Home News" which will be as widely distributed as possible.

Owing to the reduction in our income and to the small number of applications for boys over 12 years of age, Brittain Hall was closed in June and the boys then in residence placed in private homes. This change involved the loss to us of the faithful services of Miss Julia Upshaw, who has managed Brittain Hall with such loyal devotion for the past 15 years.

In March a court decision gave us the right to sell our Grand Avenue property and to rebuild in a more suitable location but a State law prevents our giving a clear title for three years from that date. We are obliged, therefore, to carry on in the old building, making use of this delay in planning carefully for the future.

Thirty-seven applications for admission involving 62 children were received. The reasons for applying included separation or divorce of parents, death of one parent, illegitimacy, insufficient income, unemployment, illness of parent, behavior, desertion of parent, father in penitentiary. In some cases the children could not be admitted to the Home because they were not of suitable age, but in most cases they were refused because they could be cared for with greater benefit in other ways, as for example in the case of a family of four children whose father had died; help was obtained through another social agency in maintaining the mother with her children in their own home. Each application was investigated; five children were admitted. Six were dismissed. On December 31 there were 26 children—7 boys and 19 girls—in the Home, and 6 boys and 7 girls cared for outside. This included the 5 boys now in foster homes who formerly resided at Arthur Brittain Hall, and makes a total of 45 children cared for during the year, with 39 under care at the present time. Four of the older boys are receiving vocational training, three in farm homes and one at the Rankin Trade School.

The age range of the children under care in the Home and in foster homes is from six to eighteen years. With this somewhat reduced number of children in the Home more thorough study of the development, personality and requirements of each individual is possible.

I wish to express my sincere thanks to our medical staff,—Dr. W. H. Riley, Dr. Carl A. Hobart, Dr. R. H. Davis, Dr. A. H. Hamel, and Dr. Phil Hoffman, who have given such valuable service to the Home; to the Board of Directors of Bethesda for their generosity in admitting our children for hospital and clinic care; to our Advisory Committee for their advice in financial matters; to the Deaconess and her staff for their devotion to the work of the Home; and to the Board of Managers for their loyal co-operation and splendid service throughout the year.

Report of the Girls' Friendly Society

The year 1931 has been a year of growth in the Girls' Friendly Society. Three new branches have been added, one at Trinity, one at St. Augustine's and one at the Church of the Ascension. These branches are all made up of girls in their early teens, the formative stage of their development, and the age when such a character building organization as the Girls' Friendly Society can be of the utmost value.

One of the older members, now married, is the leader of St. Augustine's Branch, which was organized at the instigation of the Woman's Auxiliary as part of their parish project. A member from another branch, won the Art Alliance Scholarship and spent four months traveling abroad, visiting European art galleries.

Another of our older members has gathered together a group of younger girls who are doing altar work. Still others are doing work among the blind, one girl going regularly to read to a blind girl.

A young branch, regretting its inability to accomplish much—due to lack of funds—reported that its six girls have made and packed sixteen baskets for Mrs. Peirce, worked in the Church School and for the Altar, made ten scrap books for colored children at Koch Hospital, made a gift of money to their Rector on his twenty-fifth anniversary, gave a generous Easter offering as well as making a money contribution to Mrs. Peirce for her work. We were moved to ask what more substantial contribution to their parish and community could reasonably be expected of six young girls.

A money gift of \$27.50 went from this diocese to the Girls' Friendly Mission at Hillsboro, Oregon.

For the Mission Box which was sent to San Juan-on-the-Desert at Farmington, New Mexico, six complete layettes were made and returned to the Supply Department. We find that the allotment for The Girls' Friendly Society is quite inadequate and we respectfully suggest that it be increased another year.

Such work as this, we feel, must lead to larger fields of usefulness in the Church and in the community.

Report of the Program Committee

The Spring quarterly meeting was held May 22, 1931 at the Bishop Tuttle Memorial, and marked the Fiftieth Anniversary of the Woman's Auxiliary of the Diocese of Missouri. In order to allow time for the speakers of the day, the reports of the Secretaries of the departments of work were printed in the program.

The history of the Woman's Auxiliary was given most ably by Mrs. C. R. McDonald, followed by Mrs. John F. Shepley, who gave stirring accounts of the present work done by the Auxiliary.

Bishop Scarlett then gave an inspirational talk on what he hoped would be the future work of the women of the Church.

On October 30, 1931 the delegates to the Convention in Denver, gave their impressions of the Convention. Mrs. Walter E. Bryan spoke of the wonderful work of the "United Thank Offering," and what it should mean to every Church woman, and also spoke on "Interracial Contacts." Mrs. D. W. Roberts gave her impressions on the "Economic Conditions" as presented by the speakers. Mrs. Harold C. Littlefield gave the findings on "Family Life." "Religious Thinking of Today" was most interestingly presented by Mrs. James H. George, and the final talk of the day was the "Inspiration of the Convention" by Mrs. John F. Shepley.

On January 28, 1932 the annual meeting was held, and the program consisted of interesting talks on the various projects supported by the budget of the Auxiliary. Rev. Arthur H. Beardsley of Cape Girardeau, Mo.; Rev. O. V. Jackson on the work at Rolla, Mo.; Mrs. C. C. Pangman on Social Service; Rev. Roy S. Rawson on the work at St. Stephen's; Mrs. Carl Reed Taylor told of the many activities at Grace, Holy Cross, and Mrs. James H. George spoke of the work at Valley Park.

After the reports of the Secretaries of the departments of the Auxiliary and the annual election of officers, the meeting was adjourned.

Constitution

ARTICLE I—NAME.

This organization shall be called "The Missouri Branch of the Woman's Auxiliary to the National Council."

ARTICLE II—OBJECT.

Its object is to increase the interest and unite the efforts of all women in the Diocese in the Church's Mission in the Parish, in the Community, in the Diocese, in the Nation and in the World.

ARTICLE III—MEMBERSHIP.

Its membership shall consist of all baptized women who pray for, work for, or give to the Church in the Five Fields of Service.

ARTICLE IV—AMENDMENTS.

This Constitution may be altered or amended at any annual meeting by a two-thirds vote of the members of the Board of Managers present; due notice having been given to each member.

By-Laws

BY-LAW I—OFFICERS.

SECTION 1. The Officers shall be a President, First Vice-President, Second Vice-President, Third Vice-President, Fourth Vice-President, Recording Secretary, Corresponding Secretary, Treasurer, Auditor, Educational Secretary, Supply Secretary, Social Service Secretary, and United Thank Offering Treasurer.

SECTION 2. There shall be an Executive Board composed of the officers, special secretaries and treasurers, and three members at large.

SECTION 3. The Board of Managers shall consist of the Executive Board and the Parish Representatives; twenty-five members constituting a quorum.

Annual dues of \$1.00 for each member of the Board of Managers shall be paid to the Auxiliary Diocesan Treasurer before the first of February.

SECTION 4. Honorary offices with the right of vote may be created by a two-thirds vote of the Board of Managers.

BY-LAW II—DUTIES OF OFFICERS.

SECTION 1. The President shall preside at all meetings; appoint committees; be a member ex-officio of said committees and fulfill all such duties as pertain to her office. By virtue of her office she shall be a Delegate to the Triennial. She shall make a written report of the year's work to the Diocesan Convention, which if so ordered by the convention may be published in the Journal. She shall appoint the Special Secretaries and Treasurers.

SECTION 2. The Social Service Secretary shall be responsible for all Social Service Work undertaken by the Auxiliary.

SECTION 3. The First Vice-President shall fulfill the duties of the President in the latter's absence. She shall be responsible for all courtesies to special visitors at meetings.

SECTION 4. The Second Vice-President shall be responsible for such work as may be assigned her by the President.

SECTION 5. The Third and Fourth Vice-Presidents shall be responsible for Auxiliary work in the Northern and Southern Convocations.

SECTION 6. The Recording Secretary shall take the minutes of the meetings and shall prepare an annual report of work done by the Missouri Branch. She shall forward said report to the Executive Secretary of the Woman's Auxiliary.

SECTION 7. The Corresponding Secretary shall send all notices and carry on all necessary correspondence.

SECTION 8. The Treasurer, under direction of the Board of Managers or the Executive Board, shall receive and disburse all money, presenting a report of same at each quarterly meeting.

SECTION 9. The Auditor shall examine the accounts of the Treasurers, namely: The Woman's Auxiliary, The United Thank Offering, The Auxiliary "Special" and the Endowment and Memorial Gifts and present vouchers for same.

SECTION 10. The Educational Secretary shall be responsible for the conducting of Bible and Mission Study Classes, following suggested subjects sent out by the General Educational Secretary. She shall disseminate missionary material and information; and co-operate with all agencies in the Diocese for religious education.

SECTION 11. The Supply Secretary shall be in charge of the supply work of the Diocese, apportioning the Parish quotas. She shall make her report to the General Secretary of the Supply Department.

SECTION 12. The United Thank Offering Treasurer shall stimulate interest in this phase of auxiliary work. She shall have charge of all money collected for this purpose and shall make a report at all meetings. She or her alternate shall present the offering at the Triennial.

SECTION 13. The Executive Board shall have authority necessary to conduct all business between meetings. It shall pass on the report of the Finance Committee and make recommendations to the Board of Managers. It shall direct the policy of the Auxiliary.

BY-LAW III—REPRESENTATIVES.

SECTION 1.(A) Each Parish is entitled to four representatives, one of whom shall be the President and one the Corresponding Secretary, or the Treasurer, of the Parish Branch.

(B) Any additional Branch in a Parish is entitled to two representatives.

SECTION 2. The Representatives shall attend the Diocesan Meetings and respond to the General pledges for their branches.

SECTION 3. The method of choosing representatives shall be left to each Parish Branch.

BY-LAW IV—ELECTION OF OFFICERS.

SECTION 1. The Officers shall be elected by ballot at the Annual Meeting for a term of three years.

No elected officer shall be eligible to succeed herself in the same office. No member shall serve on the Board in any capacity for more than two consecutive terms.

SECTION 2. The Executive Board shall constitute a nominating committee to prepare a ticket to be voted upon at the Annual Meeting.

SECTION 3. The President shall appoint four members to serve as tellers on the day of election, these persons having been previously notified.

SECTION 4. The Executive Board may fill a vacancy in any elective office by temporary appointment and the person thus appointed shall hold office until the next regular meeting of the Board of Managers, at which meeting the vacancy shall be filled by election and the person thus elected shall hold office until the next Annual Meeting.

SECTION 5. At each Annual Meeting there shall be elected by ballot one member at large to serve on the Executive Board for a term of three years.

SECTION 6. Delegates and alternates to the Triennial Convention shall be elected at the annual meeting preceding the General Convention.

BY-LAW V—COMMITTEES.

SECTION 1. There shall be a Finance Committee composed of the President, Treasurer, Supply Secretary, Social Service Secretary and one other member of the Executive Board.

SECTION 2. This committee shall prepare the budget for the year's work and shall make plans for financial projects not otherwise assigned.

SECTION 3. There shall be a Year Book Committee composed of six members of which the Recording Secretary shall be the Chairman. The other members shall be the President, the Corresponding Secretary, the Treasurer, the Auditor, and the Chairman of the Supply Committee. This Committee shall publish a Year Book which shall be distributed and a copy forwarded to the Secretary of the National Board of the Woman's Auxiliary.

BY-LAW VI—ENDOWMENT AND MEMORIAL GIFTS.

SECTION 1. There shall be an Endowment Fund. Only the interest from this Fund may be used for Auxiliary work the principal must remain intact. The Endowment Fund shall be in charge of a Board of Trustees composed of the Endowment and Memorial Gifts Committee. Any individual or branch giving one hundred dollars to the Endowment Fund may name the gift.

SECTION 2. There shall be an Endowment and Memorial Gifts Committee composed of the Diocesan President, the Treasurer and three other members, which members shall be elected at the Annual Meeting for three years. This committee shall have full charge of receiving, investing and expending the interest of these funds. Anyone wishing to present a Memorial gift shall do so through this committee.

BY-LAW VII—PERMANENT COMMITTEE.

SECTION 1. A permanent Advisory Committee shall consist of the past presidents of the Woman's Auxiliary. Each member shall serve for one year as Chairman of this Committee in the same order she served the Woman's Auxiliary as Diocesan President. This Committee shall serve in an advisory capacity when called upon by the Executive Board.

BY-LAW VIII—MEETINGS.

SECTION 1. There shall be three meetings each year, one of which, the Annual Meeting shall be held immediately preceding or immediately following the Diocesan Convention. These meetings, which are held in the Bishop Tuttle Memorial, are open to all. There shall also be one meeting of the Board of Managers during the year.

SECTION 2. At the three meetings specified in Section 1, members of the Board of Managers only are eligible to cast a vote.

SECTION 3. At the Annual Meeting the vote on all measures shall be cast only by representatives who have served during the year.

SECTION 4. Upon the request of four Parishes, the vote on any question may be called for by parishes and in case of a division, the individual roll call may be demanded.

SECTION 5. Special meetings may be called by the President.

SECTION 6. The Executive Board shall hold their meetings from October to June inclusive.

BY-LAW IX—AMENDMENTS.

These By-Laws may be altered or amended at any regular meeting by a two-thirds vote of the members of the Board of Managers present—due notice having been given each member.

STANDING RULE.

In recognition of the services of a retiring diocesan president a useful gift suitably inscribed as presented by the Woman's Auxiliary may be made to some mission or hospital, church school or similar institution in which the retiring president was interested; subject to the approval of the Bishop of the diocese in which the gift is to be made. The presentation is to be made at the first quarterly meeting following her completed term of office. This gift shall not exceed fifty dollars.
