Report of the President of the Woman's Auxiliary

To the Bishop of Missouri and the Members of the Ninety-fifth Diocesan Convention, we present the report of the Woman's Auxiliary of the Diocese of Missouri for the year 1933.

In the General Church Program 1932-1934, we find the following quotation—"If the Woman's Auxiliary is to arouse the concern of the women of today, especially the young women, and win them to share in working out a Christian answer to the world's need, it must engage in activities of tremendous significance", and it was a prayer for the "growing vision of the Auxiliary" that was used by thousands of women, all over the world on Armistice Day, when the Quiet Day for Prayer was observed in all our Episcopal Churches. Over two thousand in this Diocese alone were praying that prayer.

What significant activities have we engaged in during the year just passed, and have our visions been completed in the fulfillment of our tasks?

Time does not permit detailed reports of work done or money received and expended. These may be found in the Auxiliary Year Book, if not in the Diocesan Journal, or, better still heard at the Annual meeting on Thursday. We invite and urge you to attend that meeting.

Our work is carried on, as you know, in the Five Fields of Service—the World, Nation, Diocese, Community and Parish.

When we join with other groups working for the promotion of Peace and Universal Disarmament and also have united with other religious denominations in the program for the World's Day of Prayer—are we not working towards the accomplishment of what Dr. McGregor has called the greatest task the Christian Church has to perform—that of achieving Church Unity and realizing her International character.

And when we also join with these other denominations in the work they are doing for the Foreign Born in our community, are we not sharing what is best in our Nation with others and thus giving practical evidence of our belief in the Fatherhood of God and the Brotherhood of Man?

It has been our privilege and pleasure to assist the Bishop by our gifts which have helped make it possible for him to carry out some of his plans and we have really enjoyed holding group Auxiliary meetings throughout the Diocese, which we hope have tended to stimulate and encourage deeper interest in the general work of our Church in the Diocese.

In addition to the splendid sewing done, under the direction of the Supply Department, for our Missionary boxes, the women worked diligently in groups and as individuals for the Red Cross in our Community and have helped prepare bandages and at the hospital—have taken part in the Volunteer work which is being organized on a much larger scale, thus trying to lift the burdens of some of our fellow citizens. As individuals we have helped in the United Relief and Community Fund drives—and we are cooperating more and more with the organizations working for the education and relief of the Blind.

There are so many phases of our work in the Parish that we cannot enumerate them all. One definition for the word Auxiliary is "helper" and we have tried to carry out this ideal and our endeavor is always to stand back of our clergy and cooperate with them in any plans they may have—working less as an organization than quietly as assistants—and especially being loyal to our

Church's Program—by keeping posted as to the work of the Church in the three branches of Missions and Church Extension; Religious Education; and Christian Social Service, and spreading this information through an Educational program which includes all phases of the Church's work and thought.

The emphasis that we have especially placed on the United Thank Offering has been to increase interest by urging that every woman have a share in the offering, our goal being a gift from every woman in the Diocese.

Among the important events in which we have taken part we mention the United Foreign Missionary Conference when we cooperated in arranging a special meeting where about two thousand women listened to such Missionaries as Miss Yi-Fang-Wu, of China, Miss Lilian Picken, well known for her work in India—and others.

Outstanding among all that Missionary group, however, was our own Bishop Roots and as we heard his message, it was not difficult to realize why the Chinese Christians appealed to him for leadership in their civic matters as well as those related to their spiritual welfare. He is certainly a wonderful Christian Statesman as well as a great Missionary Bishop.

A Red Letter Day in our calendar was surely the one when Mrs. Harper Sibley addressed our Auxiliary twice and then talked informally to another group of women, delighting all by her charming personality and impressing everyone by her intelligent, tolerant and truly Christian attitude towards the Missionary Problems of the Church at large, today. As she described her personal experience as a delegate at the Jerusalem Conference in 1928 and also gave her impressions as a member of the Laymen's Foreign Missionary Inquiry, one could not but feel that everyone who feels any doubt as to what is being accomplished by the right kind of Missionary work—should hear her presentation of the cause which she has so truly at heart and in which she so earnestly believes—the Mission of the Church.

The only sad note in our Auxiliary is struck when at our Annual meeting we part with some who having served their time go off the Executive Board.

We welcome most heartily the new members who are to be elected and look forward eagerly to all they will bring to the Board.

We are very happy to say that some, who are eligible for reelection will, we hope, continue in one position or another.

We cannot be grateful enough to Mrs. Harold E. Woodward for what she has done for the Auxiliary—not only as Recording Secretary, but in many ways, and we are delighted that a resolution recently adopted, makes it possible for her to be invited to sit in with the Board. She is a representative on both the National and Provincial Boards of the Girls' Friendly Society, by virtue of her office as Vice-President of the Seventh Province.

It is a matter of sincere regret to all that Mrs. James H. George felt she could not continue as Diocesan Educational Secretary and as she had served three years in May, she asked to be relieved at that time. Again her position as Provincial Educational Secretary makes it possible for her to be with us at our Board meetings and we are so very happy that we can still have her help and cooperation along the lines where she has proved herself a most capable and inspiring leader in the Educational work of the Auxiliary.

It is difficult to adequately express the appreciation of the Board of the efficient and tactful manner in which our Treasurer, Mrs. Roy A. Campbell, has handled our finances for the past three years and her splendid report certainly justifies this feeling and the desire of the Nominating Committee that she be requested to remain on the Board in another capacity.

While holding the office of Auditor, Mrs. Irvin Mattick has contributed greatly to the Educational work on the subject of International Relations, and we are to be congratulated that she is to continue her work along Educational lines.

We had hoped very much that Mrs. Sieber, our First Vice-President, would remain on the Board and are disappointed that she felt she could not do so. We shall miss her wise counsel and keen interest in Auxiliary matters and are very grateful to her for what she has done for us.

Mrs. Wood has taken over so much work in her Parish, St. Peter's, that she feels she cannot continue to attend our meetings and should resign. She does this in spite of our protest and very much to the regret of the entire Board. We thank her for the fine contribution she has made to the Auxiliary cause.

Mrs. Sidney Maestre has become so deeply involved in the Volunteer work being organized (and in which the Auxiliary expects to cooperate), and is obliged to give so much time to that, that she thinks she must be excused from her Diocesan position. The work Mrs. Maestre did in organizing and carrying through the Employment Bureau, for the Auxiliary, until the time came when it could be turned over to a department in the Community Social Service plan—is a striking feature in our report for 1933, and many people are grateful to Mrs. Maestre for the personal interest and untiring devotion she gave in trying to relieve them in their difficulties.

We feel that both these women are giving themselves to even larger service and we would like to believe that their experience on the Diocesan Board helped a little to create the interest which takes them into other and possibly broader fields of service.

For personal reasons Mrs. Harold J. Littledale has felt she could not take office again and I am sure she will be sadly missed not only by her fellow Board members but by the large group of women who have worked each week at St. Luke's Hospital, under her able and faithful direction. We are truly grateful to Mrs. Littledale.

Mrs. Charles C. Robertson and Mrs. M. F. Bingham have been added to our Episcopal group on the Woman's Missionary Federation Board and Mrs. George T. Peckham has been made their Chairman of Christian Citizenship.

We wish time might permit mentioning by name, those who are still holding their offices on the Board.

Each and all have made fine contributions to our work and programs. We thank them most gratefully for all they have accomplished in their different departments.

We cannot close our report without a word of regret that our best loved Honorary President, Elizabeth B. Johnson is no longer with us and we have sadly missed her gracious presence at our monthly meetings. We are always most grateful to dear Bishop Johnson for all he did for and was to our Auxiliary.

We have appreciated very much the cooperation of our Bishop and clergy and their attendance at our Diocesan meetings and wish to thank those members of the Press who have given us such kindly consideration and publicity.

We are also grateful for the opportunity to present our report to the Diocesan Convention and we hope that in all our work we shall continue to have a "Growing Vision" and be engaged always in "Significant Activities."

We started last year in the Social Service Department with a small balance, which balance has recently been distributed equally between Mr. George and Sister Miriam, at the decision of the Finance Committee of the Woman's Auxiliary.

Not only in our Church Social Service but throughout the country, Social Service is growing by leaps and bounds, and changing greatly, due to the upset and changing conditions in our communities. The employment bureau which was opened and operated by volunteers from the church groups of the Woman's Auxiliary, was closed in December, because of the organization of the C. W. A. We felt that the people who were registered with us would have much more opportunity to get work through C. W. A., hence we turned our records over to them.

Beginning last Fall, I have stressed the work of the Central Committee for Volunteers very strongly, feeling that that should definitely be our major Social Service work for the year, and hoping that most of the Episcopal women would accept my judgment, for I firmly believe that such service is a true form of Social Service work.

Due to lack of funds the various agencies, not only in St. Louis, but throughout the country have a tremendous need for volunteers to serve in sundry capacities. Where training is needed for specialized work it is being given. There are several divisions of the work, namely:

1. Office work.
2. Case work aides to help trained workers in investigations.
3. Motor corps to drive case workers.
4. Health and hospital work.
5. Recreation and group work.
6. Miscellaneous.

I sincerely hope that any who have spare time to give to Social Service work will get in touch with Miss Bagby, who is the placement secretary of the Central Committee for Volunteers, whose headquarters are at the Community Council, 613 Locust Street. Her telephone number is Garfield 2600.

May I thank all those who have cooperated with me in the Social Service work, and urge them to try to awaken more interest in people in their duty toward their fellow men. I am sure the opportunity for growth in the Social Service department will continue, and that we, as Episcopal women will assume our responsibility according to the demand.

Report of Educational Secretary

1933—January to June, inclusive

In January, 1933, we began our study of China, and an outstanding feature of the meetings of the Educational Secretaries was the interest with which this study was taken up and carried back into the various parish branches. The text book was "Living Issues in China". Some of the books used for collateral reading were, "Twenty Years of the Chinese Republic", "As It Looks to Young China", "Lady Fourth Daughter of China", and "The Young Revolutionist". The last named book was briefly dramatized by Mrs. Frederick F. Johnson and was acted in several of the parish branches.

In our Parish the study of China culminated in "An Evening in China". A dinner cooked and served by a Chinese was followed by a beautiful Chinese pageant written and produced by one of our own women, Mrs. Percy Cobb. Then followed a delightful and instructive talk on his experiences with the Chinese bandits, by Dr. Harry Howard. A large number of men, women and children listened spell-bound to his talk.

Miss Hsi Fau Chao, graduate student of Washington University charmed several groups by her accounts of the women of China.

I talked on Religious Education to the following groups: Calvary, Columbia (twice); Holy Apostles (twice); Ascension; Holy Ghost, Evangelical; Mount Calvary; Holy Communion (twice); Emmanuel (twice); All Saints (twice); Valley Park (twice); St. Augustine's (twice); Trinity; St. Paul's, Overland; Cape Girardeau; St. John's; St. Paul's, Carondelet; St. James, Macon; Church of the Redeemer.

I have talked to the Young People or held discussion groups at Holy Apostles; Redeemer (twice); Emmanuel (twice), and have talked to the Girls' Friendly at St. Paul's, Overland and Grace Church, Kirkwood. I also helped in a Conference for Leaders for the Girls' Friendly.

I have attended six meetings of the Inter-racial Committee of the Community Council and three meetings with the advisors of the Colored branch of the Y. W. C. A.

Some of the books circulated by our department this year have been: "Kagawa", "Open Doors in Religious Education", "On Being Alive", "Managing One's Self", "When Christ Passes By", "Aggrey of Africa", "Out of My Life and Thought", "Re-thinking Missions", "This House of Exile", "God's In This Shadow", "Everybody's Bishop" and "What We Live By".

Report of the Devotional Secretary

The outstanding endeavor of the Devotional Department this past year, was the carrying out in our Diocese of the plans for the Quiet Day for Prayer on Armistice Day.

The response was most amazing. Every single Church and Mission in the city and county was open, most of them all day. All but three of the out of town Parishes and Missions reported their full and splendid cooperation.

Twenty-three hundred (2300) leaflets were distributed—150 at Christ Church Cathedral were not enough for all who came there. A few other Churches requested one hundred—Holy Innocents being one of that number. Here and there a few were left over, but we know there were at least 2,000 women in Missouri, who at some time of the day, in the quiet of some Church, offered up their hearts in prayer. Perhaps that was the most impressive thing about it—it was truly a Quiet Day.

The Lenten Quiet Day was conducted by Dr. Phillips on March 24th and was most helpful and stimulating.

Bishop Scarlett held a Quiet Day at Jefferson City on March 16th. Twenty-two women from Columbia attended and some from St. Louis.

Under the auspices of the Churches of the Holy Communion and Trinity, a Quiet Morning was conducted by Bishop Longley and was attended by women from many other Parishes.

On October 30th, an hour of meditation and prayer was held in the Cathedral preceding a conference of Parish presidents and members of the executive board, led by the Devotional Secretary.

The Woman's Auxiliary has shared in the inspiration and stimulation which have come from the two missions and the many splendid services held in the Diocese, and we are particularly grateful for the visit and most helpful and delightful talks of Mrs. Sibley, and I wonder if we will ever be just the same after the glorious service and stirring sermon of Tuesday night.

Our regular activities have been carried on. Monthly meetings of Parish Secretaries, to which others are welcome, have been held. Our group has increased, now numbering twenty-four, and we have a good attendance. We finished our study of the "School of Jesus" before summer. This fall our study was interrupted by work for the Day of Prayer, but we have discussed two topics: "The Problem of Myself", and "Conscience".

Twenty-three Parishes now have Devotional Secretaries, and we hope this year will see the list complete.

Bible Classes are increasing and the interest in them also.

A group met at Mrs. Sherry's during Lent for meditation and prayer; and Mrs. Franklin had a small class at St. Peter's Church.

A lively interest is shown at St. John's Church, in a library of twenty-five books, which is truly circulating, and there are a few other small Parish libraries which we hope will grow, and the use of them. The circulating of helpful books is practiced by many Parish secretaries, even where there is no library.

The Devotional Secretary has visited all but one Parish and one Mission in City and County, and thanks to Mrs. Shepley, five out-of-town, making a total of twenty-six, not including one when Mrs. Maples kindly took her place.

The Woman's Auxiliary has cooperated with the Woman's Missionary Federation, as Mrs. Shepley has already told you.

We took an active part in the World Day of Prayer on March 3rd—Mrs. Shepley giving a splendid talk on International Relations, followed by a prayer for the same, led by the Devotional Secretary. We also took part in the afternoon service for negroes.

We attended in goodly numbers, the meetings of the United Missionary Conference.

Has the emphasis on the Devotional Life grown during the year? This question was asked on the report form which had to be filled out and sent to New York. I feel it has, and that the response to our Day of Prayer is an indication of the sense of need of God which has been awakened through the hardships, perhaps, of these difficult times.

Report of the Episcopal Home for Children

The year 1933 has been a very significant one in the development of our work in the Children's Home. It brings to an end the two years experiment with foster home care.

To our regret, we have placed very few children with members of our own Church although we have tried to keep our needs constantly before them.

After ninety years of existence we have been brought into an official relationship with the Church through membership in the Diocesan Council.

At the December, 1933 meeting of the Board a new set of By-Laws was presented for consideration, and was unanimously adopted at the January meeting. These new By-Laws provide for an important change in the make-up of the Board, viz.: For the same number of members of the Corporation proper, as heretofore, and for an operating Board consisting of ten women elected, and four men appointed by the Diocesan Council, two of whom are to be ministers and two laymen.

Due to financial losses and continued uncertainty in our income, we have made no effort to increase the number of children under our care. A detailed report of the department of Social Service follows:

During 1933 applications were received for the admission of 50 children into the Home. Of this number 17 were admitted, while plans were made for the remainder to be cared for by relatives or other agencies better equipped to care for their particular problems. During the year 12 children were returned to relatives now able to care for them. Children accepted in the Home were kept for a period of study then placed in foster homes. We are now caring for 37 children; 30 outside, and 7 in the Episcopal Home. One older girl is taking a nurse's training course while the Home furnishes her clothing and incidental expenses; and one boy is employed in the office of a local hos-

pital. Three girls are assisting with housework while attending school, and one boy receives a free home for the work he does on a farm. Twenty-four children are in foster homes where we pay board for them. In several instances, financial assistance was given to relatives capable of training children but unable to manage without this help. Four children were sent to their father in California, as he had established a home and was eager to have them.

After a year and a half of placing children in foster homes, we feel that it has been a very successful experiment. Of 30 children placed in foster homes, only 7 had to be replaced because of lack of adjustment of the child or of unsatisfactory conditions in the home. In other words, 77% of the children remain in their original foster homes and seem happy and contented. They are in excellent health and for the most part are making good progress in school. They are fast becoming real members of the communities in which they live and frequently take part in church or school activities.

We are again holding monthly meetings for our foster mothers. Speakers are secured who give practical talks on modern methods of child training and the foster mothers receive considerable help in this exchange of ideas. Our Board members have rendered valuable assistance by bringing the foster mothers to these meetings. The Board has thus been able to become acquainted with the foster mothers and also to be sure of their presence at the meeting. A monthly news letter is sent out in order to keep the church groups in touch with the work of the Home.

Our Entertainment Committee arranged for luncheon meetings of the Clericus and the Diocesan Board of the Woman's Auxiliary and two afternoon meetings of the Institution and Agencies Committee of the Community Council. The most enjoyable event of the year was a dinner given to fifteen of our old Brittain Hall boys. It was most interesting to hear them talk over old times and to see with what loyalty and affection they remember their association with Miss Upshaw.

We record with deep regret the death of Miss Mary Scudder, who for a number of years served faithfully on our Board as a representative of the Church of the Holy Communion.

Again we wish to record our gratitude to our Medical Staff, especially Dr. W. H. Riley whose faithful attention to our children has much to do with the high standard of health maintained in the Home.

I want to thank the members of the Board of Managers; the Advisory Committee and the Staff of the Home who have so loyally worked with me during these difficult years of transition and to urge their continued interest and support.

Report of the President of the Girls' Friendly Society for 1933

The year 1933 has been one of growth and vitality for the Girls' Friendly Society of Missouri. At St. Paul's, Overland, a group of older members has been admitted and the junior and candidates' groups have secured leaders and are again functioning so that St. Paul's has a complete branch of three groups. At St. Luke's, Valley Park, a branch was formed with a junior group and a candidates' group has also been admitted. Groups of candidates at St. Paul's, Carondelet, and at Holy Innocents inaugurated the branches in those churches. A candidates' group has been formed at St. Peter's and at the Redeemer a junior group has been added. Admission services for new members have also been held at St. John's, St. Peter's, and Prince of Peace. The total number of branches is now fourteen, comprising twenty-two groups of the different ages. The membership shows an increase of fifty-six junior and older girls and forty-six candidates.

The annual quiet day for the older groups was held at Grace Church, March 26th, Dr. Kevin holding a very beautiful service. Tea was served afterward to about one hundred. The candidates' Vesper service was held by Bishop Scarlett, November 25th, and was one of the most impressive meetings of the year. Over one hundred little girls, under twelve, sat spell-bound in the beautiful Cathedral. Some of the children from Valley Park had never been in St. Louis before. Tea and story telling followed the service. The All Saints Day corporate communions were held by most of the branches and the offering sent to the National Endowment Fund. The offering at the older girls' service had been sent to Canon George for his work.

The National Girls' Friendly Society Mission Project was for the house of the Merciful Saviour—Wu Chang, China, and forty dollars was sent by the girls. But of even more importance was the interest and time given to the study of China. One branch, for example, gave all of their Lenten meetings to this study. The whole project culminated in the activities meeting at Overland where Mrs. George spoke on the missionary work in China—showing slides, and a wonderfully colorful Chinese pageant was given by the girls from different branches, directed by Mrs. Seddon, Mrs. Campbell and Miss Betty Campbell. Where it was possible the Girls' Friendly Society branches cooperated with the Woman's Auxiliary in the National Day of Prayer. The girls also took part in the sewing for the Auxiliary Spring box.

Two picnics were given for the girls in June. The candidates numbered over one hundred and the associates in charge found many of the children were seeing the Park and the Zoo for the first time. Through the hospitality of Mrs. Vesper, the junior and older girls had a wonderful time at Fredmar Farm, a swim, much that was beautiful to see and supper together.

Miss Mackmer, from St. Paul's, Carondelet, went as a delegate to the Church Conference at Columbia. Perhaps the two high points of the year were reached at our Leaders' Training Conference, May 20-21 and the two weeks summer camp for the girls, both at St. Stephen's-in-the-Hills. There was a splendid attendance of our council members, associates and branch leaders at the conference. We were able to hear from experts such as Dr. Corey, Miss Blake and Mrs. George, helpful discussions on important subjects having to do with leadership of girls. Together with the hours of conference the more intimate fellowship of the council members gave a real impetus to the Girls' Friendly work.

The Camp which was held by the courtesy of Father Rawson at St. Stephen's-in-the-Hills, was an experiment of great success. With Father Rawson and Mrs. Flint as hosts and seven councillors in residence, about ninety girls, coming for week-ends or a full week, enjoyed an ideal vacation—the mixture of relaxation and stimulus that produces re-creation.

But important and delightful as are all of the corporate and group projects, we believe the essence of the Girls' Friendly life is in the individual branch and one has only to see them at work, alive to the five fields of service, imbued with youth's courage and imagination to believe in the Girls' Friendly Society, as an opportunity for the girls of our church and community, to satisfy the urge for companionship and service which leads to fine Christian living.

Report of the Program Committee

The Spring Meeting of the Woman's Auxiliary of the Diocese of Missouri was held on Friday, May 19th, 1933. There was a report on pledges and reports from the Educational Secretary, the Supply Secretary, and the Secretary on International Relations.

At the meeting held on Monday, October 16th, 1933, the Communion was celebrated by Bishop Scarlett assisted by Dean Sweet, Canon Remick, and Mr. Hines. Mrs. Shepley presided at the business meeting and the noonday address was given by Mrs. Harper Sibley. The pledges were reported and reports were made by the Recording Secretary and the Treasurer. The Annual Meeting was held on Thursday, January 25th, 1934. Bishop Scarlett was assisted in celebrating the Communion by Dean Sweet, Canon Remick, Mr. Hady and Mr. Woodward. Mrs. Shepley opened the business meeting and reports were given by the Recording Secretary, the Treasurer, and all of the Secretaries with the exception of the Secretary of Religious Education, who was out of the city.

The noonday address was given by Dr. Robert O. Kevin, Jr. After luncheon the final report of the pledges was made and the new officers were installed by Bishop Scarlett. The meeting was closed with the benediction by Bishop Scarlett.

Constitution

ARTICLE I—NAME.

This organization shall be called "The Missouri Branch of the Woman's Auxiliary to the National Council."

ARTICLE II—OBJECT.

Its object is to increase the interest and unite the efforts of all women in the Diocese in the Church's Mission in the Parish, in the Community, in the Diocese, in the Nation and in the World.

ARTICLE III—MEMBERSHIP.

Its membership shall consist of all baptized women who pray for, work for, or give to the Church in the Five Fields of Service.

ARTICLE IV—AMENDMENTS.

This Constitution may be altered or amended at any annual meeting by a two-thirds vote of the members of the Board of Managers present; due notice having been given to each member.

By-Laws

BY-LAW I—OFFICERS.

SECTION 1. The Officers shall be a President, First Vice-President, Second Vice-President, Third Vice-President, Fourth Vice-President, Recording Secretary, Corresponding Secretary, Treasurer, Auditor, Educational Secretary, Supply Secretary, Social Service Secretary, and United Thank Offering Treasurer.

SECTION 2. There shall be an Executive Board composed of the officers, special secretaries and treasurers, and three members at large.

SECTION 3. The Board of Managers shall consist of the Executive Board and the Parish Representatives; twenty-five members constituting a quorum.

Annual dues of \$1.00 for each member of the Board of Managers shall be paid to the Auxiliary Diocesan Treasurer before the first of February.

SECTION 4. Honorary offices with the right of vote may be created by a two-thirds vote of the Board of Managers.

BY-LAW II—DUTIES OF OFFICERS.

SECTION 1. The President shall preside at all meetings; appoint committees; be a member ex-officio of said committees and fulfill all such duties as pertain to her office. By virtue of her office she shall be a Delegate to the Triennial. She shall make a written report of the year's work to the Diocesan Convention, which if so ordered by the convention may be published in the Journal. She shall appoint the Special Secretaries and Treasurers.

SECTION 2. The Social Service Secretary shall be responsible for all Social Service Work undertaken by the Auxiliary.

SECTION 3. The First Vice-President shall fulfill the duties of the President in the latter's absence. She shall be responsible for all courtesies to special visitors at meetings.

SECTION 4. The Second Vice-President shall be responsible for such work as may be assigned her by the President.

SECTION 5. The Third and Fourth Vice-Presidents shall be responsible for Auxiliary work in the Northern and Southern Convocations.

SECTION 6. The Recording Secretary shall take the minutes of the meetings and shall prepare an annual report of work done by the Missouri Branch. She shall forward said report to the Executive Secretary of the Woman's Auxiliary.

SECTION 7. The Corresponding Secretary shall send all notices and carry on all necessary correspondence.

SECTION 8. The Treasurer, under direction of the Board of Managers or the Executive Board, shall receive and disburse all money, presenting a report of same at each quarterly meeting.

SECTION 9. The Auditor shall examine the accounts of the Treasurers, namely: The Woman's Auxiliary, The United Thank Offering, The Auxiliary "Special" and the Endowment and Memorial Gifts and present vouchers for same.

SECTION 10. The Educational Secretary shall be responsible for the conducting of Bible and Mission Study Classes, following suggested subjects sent out by the General Educational Secretary. She shall disseminate missionary material and information; and co-operate with all agencies in the Diocese for religious education.

SECTION 11. The Supply Secretary shall be in charge of the supply work of the Diocese, apportioning the Parish quotas. She shall make her report to the General Secretary of the Supply Department.

SECTION 12. The United Thank Offering Treasurer shall stimulate interest in this phase of auxiliary work. She shall have charge of all money collected for this purpose and shall make a report at all meetings. She or her alternate shall present the offering at the Triennial.

SECTION 13. The Executive Board shall have authority necessary to conduct all business between meetings. It shall pass on the report of the Finance Committee and make recommendations to the Board of Managers. It shall direct the policy of the Auxiliary.

BY-LAW III—REPRESENTATIVES.

SECTION 1.(A) Each Parish is entitled to four representatives, one of whom shall be the President and one the Corresponding Secretary, or the Treasurer, of the Parish Branch.

(B) Any additional Branch in a Parish is entitled to two representatives.

SECTION 2. The Representatives shall attend the Diocesan Meetings and respond to the General pledges for their branches.

SECTION 3. The method of choosing representatives shall be left to each Parish Branch.

BY-LAW IV—ELECTION OF OFFICERS.

SECTION 1. The Officers shall be elected by ballot at the Annual Meeting for a term of three years.

No member shall serve on the Board in any capacity for more than two consecutive terms.

SECTION 2. The Executive Board shall constitute a nominating committee to prepare a ticket to be voted upon at the Annual Meeting.

SECTION 3. The President shall appoint four members to serve as tellers on the day of election, these persons having been previously notified.

SECTION 4. The Executive Board may fill a vacancy in any elective office by temporary appointment and the person thus appointed shall hold office until the next regular meeting of the Board of Managers, at which meeting the vacancy shall be filled by election and the person thus elected shall hold office until the next Annual Meeting.

SECTION 5. At each Annual Meeting there shall be elected by ballot one member at large to serve on the Executive Board for a term of three years.

SECTION 6. Delegates and alternates to the Triennial Convention shall be elected at the meeting preceding the General Convention.

BY-LAW V—COMMITTEES.

SECTION 1. There shall be a Finance Committee composed of the President, Treasurer, Supply Secretary, Social Service Secretary and one other member of the Executive Board.

SECTION 2. This committee shall prepare the budget for the year's work and shall make plans for financial projects not otherwise assigned.

SECTION 3. There shall be a Year Book Committee composed of six members of which the Recording Secretary shall be the Chairman. The other members shall be the President, the Corresponding Secretary, the Treasurer, the Auditor, and the Chairman of the Supply Committee. This Committee shall publish a Year Book which shall be distributed and a copy forwarded to the Secretary of the National Board of the Woman's Auxiliary.

BY-LAW VI—ENDOWMENT AND MEMORIAL GIFTS.

SECTION 1. There shall be an Endowment Fund. Only the interest from this Fund may be used for Auxiliary work, the principal must remain intact. The Endowment Fund shall be in charge of a Board of Trustees composed of the Endowment and Memorial Gifts Committee. Any individual or branch giving one hundred dollars to the Endowment Fund may name the gift.

SECTION 2. There shall be an Endowment and Memorial Gifts Committee composed of the Diocesan President, the Treasurer and three other members, which members shall be elected at the Annual Meeting for three years. This committee shall have full charge of receiving, investing and expending the interest of these funds. Anyone wishing to present a Memorial gift shall do so through this committee.

BY-LAW VII—PERMANENT COMMITTEE.

SECTION 1. A permanent Advisory Committee shall consist of the past presidents of the Woman's Auxiliary. Each member shall serve for one year as Chairman of this Committee in the same order she served the Woman's Auxiliary as Diocesan President. This Committee shall serve in an advisory capacity when called upon by the Executive Board.

BY-LAW VIII—MEETINGS.

SECTION 1. There shall be three meetings each year, one of which, the Annual Meeting shall be held immediately preceding or immediately following the Diocesan Convention. These meetings, which are held in the Bishop Tuttle Memorial, are open to all. There shall also be one meeting of the Board of Managers during the year.

SECTION 2. At the three meetings specified in Section 1, members of the Board of Managers only are eligible to cast a vote.

SECTION 3. At the Annual Meeting the vote on all measures shall be cast only by representatives who have served during the year.

SECTION 4. Upon the request of four Parishes, the vote on any question may be called for by parishes and in case of a division, the individual roll call may be demanded.

SECTION 5. Special meetings may be called by the President.

SECTION 6. The Executive Board shall hold their meetings from October to June inclusive.

BY-LAW IX—AMENDMENTS.

These By-Laws may be altered or amended at any regular meeting by a two-thirds vote of the members of the Board of Managers present—due notice having been given each member.

STANDING RULE.

In recognition of the services of a retiring diocesan president a useful gift suitably inscribed as presented by the Woman's Auxiliary may be made to some mission or hospital, church school or similar institution in which the retiring president was interested; subject to the approval of the Bishop of the diocese in which the gift is to be made. The presentation is to be made at the first quarterly meeting following her completed term of office. This gift shall not exceed fifty dollars.
