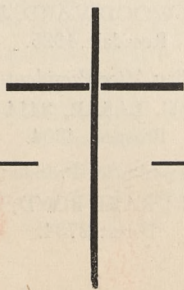

Report of the President of the Woman's Auxiliary

To the Bishop of Missouri and the members of the Ninety-ninth Diocesan Convention, this, the fifty-seventh Annual Report of the Woman's Auxiliary of the Diocese of Missouri for the year 1937, is presented:

As we survey the year 1937 with its hopes and aspirations we realize that the goal which was set was not a one year's program but one which extends into the future and we are still definitely committed to the task of interpreting the interests of the Woman's Auxiliary, to the women, in terms of their every day lives.

The members of the Executive Board have given untiringly of their time and energy and have accepted a measure of responsibility commensurate with the degree to which they have dedicated themselves, in carrying on the work of the Church.

Visiting parish branches and the four districts of the Diocese has been one method which we felt would stimulate interest, and increase activity in parish life. In this I feel, we have been successful.

In accordance with the policy of trying to develop new interest groups, three new evening branches have been organized this year and I look forward to the time when the Auxiliary will have to have, at least one evening meeting, in order that all of its members may participate in it.

The Spring Meeting, which was held in Overland, was an inspiration, and Miss Margaret Marston, National Educational Secretary, having only recently returned from the Orient, gave us a vivid picture of our Missions. The Fall Meeting, which was held in Webster Groves, was equally inspiring. This experiment of holding our meetings in different parishes proved highly successful, not only from the standpoint of taking our meetings to many who would not otherwise attend, but to afford the opportunity for the women to visit these two beautiful Churches. And here may I again express our gratitude and deep appreciation to all who helped make these meetings such happy experiences.

The Conference at Steelville, in September, with representatives from all but two parishes, and two of the districts, was designed to be a real training course and proved to be very helpful. It is the aim of the Auxiliary to reach increasingly more women and to have this conference become a real leadership training course.

Nineteen women from this diocese attended part or all of the sessions of General Convention, in Cincinnati, and we were one of the few dioceses whose delegates stayed through to the end. It is the source of much pleasure to me that so many of our women availed themselves of this opportunity and since have given so gladly of themselves, to carry this message to others, that they might know something of what the Church is doing. Before the end of spring we will endeavor to cover every part of the Diocese with this team.

It was our privilege to have as our guests, a Missionary Team composed of the Right Rev. Winfred H. Ziegler, Canon Charles T. Bridgeman of

Jerusalem and Mrs. Benson Harvey of the Philippines and I would like to thank the clergy and members of the Woman's Auxiliary but more particularly a small committee made up of members of the Executive Board, who made their visit possible.

Financially, the Auxiliary is sound and that is a strong statement. By that I mean that we paid all of our pledges, in full, and carried a small balance forward. The method of collecting our budget was new and for that reason there were some misgivings, but looking back it seems a more dignified way. Enough praise cannot be given the parishes for the way in which they co-operate, for after all they are the Auxiliary.

Our unbounded thanks go to the Cathedral Staff for their untiring efforts. To Mr. Daniel Philippi for his fine contribution and co-operation.

To the newspapers, but especially to Mrs. Julia M. Underwood we wish to express our gratitude for the publicity given us.

To our Bishop and the clergy I would say that words are poor things to try to express our deep feeling for what we feel toward them and we can only pledge ourselves with renewed energy to the tasks which they set us and in some small measure express our thanks.

To the retiring members of the Board I can only say — look back over our years together and realize that a friendship has been formed, a love kindled that cannot be lost by leaving the Board, but that others will be given an opportunity to know what it is to serve the Church. So it must be with all of us. As to the future, our path is clear cut. No one who attended General Convention and heard the message of Bishop Tucker could have one moment's doubt. If we are really to be an Auxiliary to the National Council, working actively in all of its departments, we are committed to thinking and working and giving to Missions first of all, and to this I pledge the whole strength of the Woman's Auxiliary. The other departments are equally important but this is our major emphasis.

Another objective shall be how to work more completely with the Young People. This Diocese has recently re-organized and call themselves "The Young Churchmen of the Diocese of Missouri" and they are looking to us to help them. This is not just a local problem but one that exists all over the church and I sincerely hope that at the end of this year we will have taken at least the first steps toward a closer co-operation.

With this in mind it seems to me that there is a challenge to every woman in the Church to find her place and take it and with a deeper consecration, renewed zeal and a determination to carry the message of Christianity to others, that the Woman's Auxiliary will be living its prayer,—

"Almighty God, our heavenly Father, bless, we pray Thee, our work for the extension of our Kingdom, and make us thankful for the precious gift, of Thy Beloved Son, that we may pray fervently, labour diligently, and give liberally to make Him known to all Nations as their Saviour and their King; through the same Jesus Christ our Lord."

Report of Secretary of the Social Service Department

Year 1937

These Social Service reports are more or less the same each year, but even so, there is a noticeable broadening of the interests and activities of the women who work in this field. Some parishes have inaugurated a Social Service Day—one of the regular weekly meetings being given over to the discussion of Social Service projects, with sometimes a speaker on that day. Which is a very healthful sign, for you know that by knowing more about a subject you are more apt to be interested in it.

The various activities of the Board of Religious Organizations are attracting more and more workers. Mrs. Wayne Lee, our Representative on the Advisory Board of this organization has compiled the following report of what our women did in 1937. Ten scrap books to Children's Hospital, five loads of toys to the Toy Shop, ninety dolls dressed for the Toy Shop, some layettes were made, though for the present, the Layette Guild is inactive as there has been little call for layettes due to the fact that the Government is giving that sort of work to W.P.A. workers. There were three teachers in the Americanization Dept., women who teach English to foreign-born women, not only to aid them in taking out their naturalization papers but also to help them to adjust themselves to ways of American life. At Christmas time fifteen women took charge of the Toy Shop for one afternoon distributing toys. All recipients of these toys are accredited by some agency. I hear one guild is already at work on one hundred toy chairs for next Christmas! All of this work valued by time totals 1,948 hours of service given to the B. R. O. The Community Council bases the amount of help they give the B. R. O. on the number of hours of volunteer service they can report. That is why we ask you to tell us the amount of time you spend on their interests.

We are all always interested in Camp Huldina which is operated and financed by the Church of the Holy Communion. The camp had a seven week season, caring for 504 women and children, 182 of whom were cared for free of charge.

There was an Episcopal Day during the Educational Week for the Blind held in the Municipal Auditorium the week of October 25th. On Wednesday of that week our church women took charge of the lunch room, supplying and serving luncheon. A number of women served in the different booths, these booths were illustrative of the various activities of work by and for the blind. A number of women go regularly to the Blind Girls' Home to read to blind persons. Two church groups and several individuals are marking playing cards for the use of the blind. Year in and year out there are those who transcribe books into Braille, which are put into the Braille Department of our Public Library. It may interest you to know that our Braille Library is second only to the one in Washington, D.C. both in number of volumes and in circulation. All the Braille transcribing is done under the Red Cross. The many bedside bags and sweaters made by our women is Red Cross work too.

Several parishes report sewing for Barnes and Children's Hospitals, and making bandages for them. Every Thursday morning a group of church women meet at St. Luke's Hospital to make surgical dressings. There is an average attendance of thirty—working from four to five hours—which makes a total of about 6,240 hours of service for the year.

All Saints parish sponsors a recreational program for the student nurses and internes at the Homer G. Phillips Hospital.

Thirty women have given active service through the Dept. of Volunteers of the Community Council.

In addition to all these services, there are many reports of giving baskets of food, clothing, sewing lessons, music lessons, workers each Sunday at the Infirmary and the City Jail, motor service for clinics, for Meramec Hills, Deaf Institute and Speech Clinic. Visits to the House of Detention and hours of work at Kingdom House.

From our rural parishes come reports of rummage sales, luncheons, making mince meat, operating a pre-Christmas gift shop, quilting—all to raise money to meet their pledges and all successful. Last spring during the floods in south-east Missouri they worked for days in the Red Cross office and gave practical aid to refugees. One small group (7 or less) has for many years aided young people to complete their educations. Many of those who have received help are now substantial citizens.

Our budget for the year, accepted and approved by the Finance Committee and the Board is: \$100.00 for Grace Holy Cross, \$175.00 for Prince of Peace and \$625.00 for St. Stephen's Mission, total \$900.00.

The \$100.00 for Holy Cross is to help with the vacation school work. The program is not formulated as yet but will be much the same as in former years, and usually there are about three hundred children to reckon with.

The \$175.00 for Prince of Peace pays their fuel bill.

Of the \$625.00 for St. Stephen's Mission, \$600.00 pays the salary of the social worker there, and \$25.00 is used for materials to work with. Miss Albers, the director there, works directly with the children and the year she has been there has seen a definite progress and development in her charges both in education and character building. The Sunday School has an average enrollment of 122 with an average attendance of 110. Miss Albers is there every afternoon supervising classes in sewing, knitting, Girls' Friendly candidates, dramatics, handicraft group of boys and girls from ten to fifteen years of age, is den mother to a cub pack of the Boy Scouts and on Fridays has what she calls "Open House"—a sort of family idea, when all the members of the family are welcome. There are story groups for children, ball and tag for the next age and so on, some interest for all ages.

The recent Diocesan Convention unanimously adopted a resolution urging the formation of social service committees in every parish, such committees to concern themselves with the immediate needs of their parish. Father Bayne presented the resolution and is planning a meeting in the near future to further this movement.

Report of Educational Secretary Year 1937

The theme of this Triennium of the Woman's Auxiliary is "Fellowship in Faith and Work." The major addresses delivered at the Triennial in Cincinnati pertained to that theme. For three years women of our Church in every part of the world will be referring to those addresses as the foundation of their thought in Auxiliary work.

Religious Education is the force which integrates the Faith and Work of our Fellowship. It is the bridge which connects religious experience with human action. Religious Education is more than a specified department of our fellowship to be featured only by occasional programs. It is rather a continued quest for truth and understanding linked with unflagging desire, for an improving world order, and linked moreover with the will to act.

Never before has the urgency for religious education been more marked than at present. The world is desperately in need of men and women of action who are being motivated by a Christian point of view.

The Church in its struggle to bring the world to Christ is today confronted not alone with the non-Christian religions of what we have been wont to call "heathen lands," but as well with the pseudo-religious of what we are pleased to call "Christian lands." The Church's task has been substantially increased by the rise of nationalism, communism and fascism.

The Educational Department records as the outstanding event of the year, the long-awaited visit of Miss Margaret I. Marston, National Secretary of Religious Education for the Woman's Auxiliary. Her splendid account of her trip through the Oriental Mission Field awakened among us a fresh impetus to learn, work and give for Missions.

September brought another two-day conference at Wildwood Springs with many leaders from our parishes in attendance. A well-balanced program which offered opportunity for worship, instruction, discussion and recreation marked a healthful beginning for Autumn activities.

The work for education was strengthened by the vital reports given throughout the diocese by delegates and visitors to General Convention, as well

as by the programs of the visiting missionary team, Bishop Ziegler, Canon Bridgeman and Mrs. Harvey.

The rural district meetings as arranged by the vice-presidents of the Auxiliary Board for their respective territories have proved a most helpful means for presenting the educational project throughout the diocese and have afforded opportunity for the diocesan secretary to meet the parish leaders.

In and about St. Louis she has visited parish branches during the year and wishes to thank the parish secretaries for their good work.

The Educational Secretary has served as chairman of the International Relations Commission of the Woman's Missionary Federation, has spoken on World Peace to many groups in churches, clubs and schools, has also served as secretary of the Committee on Adult Education which is part of the Metropolitan Church Federation Educational Commission.

The Mission Study topics for the year are "The Moslem World" and "The Church in Rural America." "What is this Moslem World" by Chas. R. Watson and "Rebuilding Rural America" by Mark A. Dawber are recommended for study.

Report of the Devotional Secretary for 1937

There has been a definite and earnest effort by the women of the Diocese, towards the cultivation of a deeper and more sensitive spiritual life. It takes courage to accept the responsibilities placed upon us as members of the family of Christ, and we need to strengthen and refresh that courage by prayer and worship. Worship which is not passive, but is active energy directed towards God.

Many Auxiliary members attended the World Day of Prayer last February in St. Peter's Evangelical Church. It was encouraging to see women of many denominations gather together for a day of prayer. It was more evidence of our growing consciousness towards church unity.

Bishop Scarlett conducted our annual Lenten Quiet Day, which began with Holy Communion at ten o'clock. In Bishop Scarlett's meditation on the Parable of the Prodigal Son, there was brought, to the women, a new realization and sweetness of God's love and mercy.

The Devotional Secretary attended a number of Auxiliary meetings in the Diocese in the late spring.

On September twenty-second and twenty-third, the Conference at Steelville gave us renewed inspiration to start our year's work, and gave us better knowledge of the work of the women of the church throughout the diocese.

Those of us who had the great privilege of attending the Triennial Convention in Cincinnati, returned inspired with a better understanding of true Christian fellowship, and a new sense of "humanity, hope and faith." To quote from the report of the Committee on Findings and Plans, we returned with a high resolve to "move out into new fields of more generous living, more disciplined thinking, more adventurous praying."

Through that blessed band of foreign and domestic missionaries we gained stronger sympathy and new insight into the mission field of our church.

At the Quarterly Meeting in October, the Devotional Secretary reported the outstanding work of Bishop Azariah of the Diocese of Doinakal, India.

She made short talks in several parishes in the city, as well as out in the diocese. The district meeting in Cuba was particularly interesting because of the presence of women of at least three other denominations—another evidence of church unity.

On the usual Armistice Day of Prayer our churches were open for prayer and intercession, especially needed now in a world of strife and unrest. One thousand leaflets were distributed, which offered a definite prayer-plan.

We look forward, in the coming year, to continued spiritual growth, as we take upon ourselves the loving duty of being personal witnesses for Christ.

Report of the President OF Board of Managers of the Episcopal Home for Children Year 1937

After nine years as president of the Board of the Episcopal Home for Children, I come before you to give an account of my stewardship and to turn over to my successor the responsibility and opportunity for service which have been mine so long.

These have been eventful years in the history of the Home. Because we have met with discouragements and disappointments and have failed to see some of our dreams come true, it seems best to briefly review the main events in order that we may see just what ground has been gained.

In 1928 we received a report of the study of our institution made by the Child Welfare League of America, calling our attention to certain conditions and practices which were below the standard of the best child caring agencies. A number of suggestions were made for raising the level of our work and it is gratifying to note that we have carried out all of them with the exception of getting into a modern building.

The advent of Deaconess Frances B. Affleck as superintendent of the Home, September, 1929, enabled the Board to realize a growing need for improvement in institutional care. She came to us with a wealth of experience in dealing with under-privileged human beings, and with cultural interests which make her an asset to any group. Her training had been to spare the rod, and to give freely of her understanding and sympathy to the younger generation. She has laboriously and faithfully sought to build up her staff from qualified, intelligent persons, whose vision of children's needs has gradually improved the quality of our work.

With the limitations of psychiatric child guidance service in St. Louis, other child caring organizations, as well as our own, felt keenly the need of a resident diagnostic source, and repeatedly suggested our Home as a suitable center. Preliminary to the initiation of such a program, another study was made by the Child Welfare League of America in 1934.

Because we were physically restricted in immediately meeting the League's recommendations for a cottage type home, we began at once to try to determine the view point and philosophies of fellow workers in the children's field in St. Louis. In addition to verbal inquiries we sent out questionnaires to the various agency executives. The five questions asked concerned their need for resident diagnostic service; their spirit of cooperation with such a program if established by us; and their idea of the social and economic benefits which they might expect from it. Though the responses sounded a note of caution against hasty procedure with the project, and a careful defining of our function, they were for the most part not only encouraging but most enthusiastic.

Due to our success in dealing with the major problems of behavior, we had more and more requests to take children who were unable to adjust in the larger institutions or in private homes. There were still a number of cases, however, which did not respond to the best we could give them in institutional care and foster home supervision, with the customary periodic visits to child guidance clinics. For this reason we were finally persuaded to give our whole

attention to the unadjusted child and to make available, in the Home, the services of workers trained in the fields of clinical and social psychiatry.

In February, 1936, under the leadership of Dr. William Nelson, who was for twelve years the director of the St. Louis Psychiatric Child Guidance Clinic, we launched a program for the study and initial retaining of serious behavior problems. The Board voted to follow this plan long enough to determine our ability to finance the more expensive type of work, and the response of the community in making use of the service. Before the end of the year we were able to announce the establishment of an effectively functioning study home.

Last spring, on the basis of this development, recognized by local agencies as a unique contribution to community resources, we again asked for a critical survey of our work as to eligibility in the Child Welfare League of America. Since their survey was just completed during the month of December we have had no opportunity to act upon it. It is our hope that the members of the incoming Board will have not only our vision and inspiration to see our family properly housed, with the best possible organization to conform to our own ideals and to national standards, but that they may experience it as a reality in the very near future.

In 1936 we invited a group of young women from several parishes to form a committee to give volunteer service in the Home and to become acquainted with our work. In September, 1937 this committee was divided into six groups, with a chairman and five members, who are on duty two months in the year, giving motor service, planning parties and other forms of entertainment for the children. From this group several members have been asked to serve on the case committee and one has become a member of the board.

In spite of our handicaps, reviewed here, we are proud of our accomplishment, and it is with pleasure that we submit the following statistical items from our records for the year 1937:

We began the year with thirty-seven children under direct and cooperative care, eleven of this number being in the institution at that time. Of the 48 new referrals during the year we accepted 42 for full study, giving incidental service in 16 cases. This means that we contacted a total of 85 cases and gave intensive service to 69 children.

Seventeen of the new applicants became residents of the Episcopal Home for Children, as did two children whose admissions were pending at the beginning of the year. With the return of four former residents for periods during the year, we received a total of 23 children. Thus the institution has given resident service to 34 children during the course of the year.

One older boy referred for behavior diagnosis, by the State Crippled Children's Bureau, was considered unsuited to the group here. He was studied for several weeks in Bethesda Hospital, followed by a similar period of study in a foster home, before returning him to his own home where treatment was directed by our psychiatrist by letter to parents and family physician.

We have made eleven foster home placements under direct supervision of the Episcopal Home for Children.

Six children have been placed from the study home by their referring agencies.

Two older girls made independent maintenance arrangements; and seven changed from boarding status to that of self-maintenance. These seven continue to get clothing and incidental allowance from the Home.

Eight well adjusted children were transferred, with their foster homes, to the Board of Children's Guardians.

Eighteen cases have been closed during the year, leaving fifty-one active cases.

With twenty-five children in our own boarding and maintenance homes only one child had to be removed from her foster home. This is an unusual record for any social service department and certainly speaks well for our corrective service and careful placements.

Nineteen sources have referred cases.

In closing this summary of our work during the past nine years, I wish to record my deep appreciation of the loyal support given by my fellow workers on the Board and to acknowledge our debt of gratitude to the staff for their efforts to carry out the policies of the board; to the advisory committee which has safeguarded our financial interests; to the Bishop and Clergy who have encouraged us with their counsel; and especially to Mr. Alt of the Children's Aid Society, Mr. Steger of the Community Council, and Mr. Carstens of the Child Welfare League of America to whom we have turned for advice so frequently during these years of transition.

Report of the President of the Girls' Friendly Society for 1937

The Girls' Friendly Society of the Diocese of Missouri has had its usual success during the past year. The women who are serving as officers, council members and associates have shown a fine Christian loyalty to the organization and in many instances joyous enthusiasm. We have twenty-eight groups of girls meeting in sixteen parishes, which means that we are bringing approximately three hundred girls into a happy mid-week contact with our church life. The real success of our work lies in the personal touch we have with the lives of the girls from week to week. At each meeting there is a service of worship, work on various social service projects and recreation—games, singing, dramatics, etc. Important among the benefits derived from membership in the society is the forming of warm wholesome friendships among the girls.

Our chairman of membership has had a satisfactory year in organizing two groups at the Cathedral under the splendid leadership of Mrs. James Lichliter and Miss Ellen Reil and a group of candidates at Epiphany Mission, Kirkwood with Miss Louise Van Nice. The branches at Cape Girardeau and Grace Holy Cross are carrying on successfully in their second year. Some branches have more members than ever before while others have a decrease in numbers but find they are doing more effective work with fewer girls. And so we must judge our work by results as well as by numbers.

In November we held a two day conference for group leaders with Mrs. Helen Wright Mahon of the National Girls' Friendly staff as the principal speaker. With her broad outlook toward the ultimate good of our efforts, both

leaders and officers felt a renewed enthusiasm. As a result of Mrs. Mahon's panel discussion with the clergy of the diocese, we hope they have a clearer conception of the work and aims of the society. They are always gracious in their appreciation of what we are trying to do and generous in giving constructive advice.

During the year we have carried on an interesting program of activities including a large picnic in Forest Park for younger girls, a supper and boat excursion for older girls, a members' dinner and fashion show, a mission tea, a corporate communion and breakfast on the Sunday nearest All Saints' Day and a worship service and tea at the Cathedral.

One of the major events in the year's program is the summer camp. One hundred and twenty-five girls, under the careful supervision of Mrs. Henry Rohman, spent a happy two weeks vacation in the woods at Camp Sherwood Forest.

The doll dressing project had a fine response from the girls. Ninety dolls were beautifully dressed and displayed at a tea at St. Peter's Church on December 11th. This year the younger girls were invited to join the project and made and filled over a hundred red Christmas stockings. The dolls and stockings were given to the B. R. O. Toy Shop.

Our diocesan publication, Friendly Flashes, continues to come out regularly under the fine management of its editor Miss Benignus. Enough cannot be said in praise of her untiring work and her ability to write news items that catch the eye of even casually interested readers.

The gratifying results from our Girls' Re-Selling Shop at 773 Clara Avenue gives a sense of relief to all who have had a part in raising the budget for the past years. With the continued support of those who have given us financial aid, we plan to use part of the income from the shop in extension work. We are even hoping for the salary for a Girls' Friendly diocesan field secretary.

In summing up the work for the year, I am sure success is expressed in the happy response of the girls and the continued interest of the women working hand-in-hand, in an effort to make the Christian way of life, the desire of every member of the organization.

Constitution

ARTICLE I—NAME.

This organization shall be called "The Missouri Branch of the Woman's Auxiliary to the National Council."

ARTICLE II—OBJECT.

Its object is to increase the interest and unite the efforts of all women in the Diocese in the Church's Mission in the Parish, in the Community, in the Diocese, in the Nation and in the World.

ARTICLE III—MEMBERSHIP.

Its membership shall consist of all baptized women who pray for, work for, or give to the Church in the Five Fields of Service.

ARTICLE IV—AMENDMENTS.

This Constitution may be altered or amended at any meeting of the Board of Managers, by a two-thirds vote of those present; due notice having been given each member.

By-Laws

BY-LAW I—OFFICERS.

SECTION 1. The Officers shall be a President, First Vice-President, Second Vice-President, Third Vice-President, Fourth Vice-President, Fifth Vice-President, and Sixth Vice-President, Recording Secretary, Corresponding Secretary, Treasurer, Devotional Secretary, Educational Secretary, Supply Secretary, Social Service Secretary, United Thank Offering Treasurer, and Church Periodical Club Secretary.

SECTION 2. There shall be an Executive Board composed of the officers, special secretaries and treasurers, and three members at large.

SECTION 3. The Board of Managers shall consist of the Executive Board and the Parish Representatives; twenty-five members constituting a quorum.

Annual dues of \$1.00 for each member of the Board of Managers shall be paid to the Auxiliary Diocesan Treasurer before the first of February.

SECTION 4. Honorary offices with the right of vote may be created by a two-thirds vote of the Board of Managers.

BY-LAW II—DUTIES OF OFFICERS.

SECTION 1. The President shall preside at all meetings; appoint committees; be a member ex-officio of said committees and fulfill all such duties as pertain to her office. By virtue of her office she shall be a Delegate to the Triennial. She shall make a written report of the year's work to the Diocesan Convention, which if so ordered by the convention may be published in the Journal. She shall appoint the Special Secretaries and Treasurers.

SECTION 2. The Social Service Secretary shall be responsible for all Social Service Work undertaken by the Auxiliary.

SECTION 3. The First Vice-President shall fulfill the duties of the President in the latter's absence. She shall be responsible for all courtesies to special visitors at meetings.

SECTION 4. The Second Vice-President shall be responsible for such work as may be assigned her by the President.

SECTION 5. The Third, Fourth, Fifth and Sixth Vice-Presidents shall be responsible for Auxiliary work in their respective districts.

SECTION 6. The Recording Secretary shall take the minutes of the meetings and shall prepare an annual report of work done by the Missouri Branch. She shall forward said report to the Executive Secretary of the Woman's Auxiliary.

SECTION 7. The Corresponding Secretary shall send all notices and carry on all necessary correspondence.

SECTION 8. The Treasurer, under direction of the Board of Managers or the Executive Board, shall receive and disburse all money, presenting a report of same at each quarterly meeting.

SECTION 9. The Devotional Secretary shall promote Bible study and prayer groups. She shall also be responsible for special religious projects for the Diocesan and National Auxiliaries and co-operate with other organizations for similar purposes.

SECTION 10. The Educational Secretary shall be responsible for the conducting of Bible and Mission Study Classes, following suggested subjects sent out by the General Educational Secretary. She shall disseminate missionary material and information; and co-operate with all agencies in the Diocese for religious education.

SECTION 11. The Supply Secretary shall be in charge of the supply work of the Diocese, apportioning the Parish quotas.

SECTION 12. The United Thank Offering Treasurer shall stimulate interest in this phase of auxiliary work. She shall have charge of all money collected for this purpose and shall make a report at all meetings.

SECTION 13. The Executive Board shall have authority necessary to conduct all business between meetings. It shall pass on the report of the Finance Committee and make recommendations to the Board of Managers. It shall direct the policy of the Auxiliary.

BY-LAW III—REPRESENTATIVES.

SECTION 1.(A) Each Parish is entitled to four representatives, one of whom shall be the President and one the Corresponding Secretary, or the Treasurer, of the Parish Branch.

(B) Any additional Branch in a Parish is entitled to four representatives.

SECTION 2. The Representatives shall attend the Diocesan Meetings and respond to the General pledges for their branches.

SECTION 3. The method of choosing representatives shall be left to each Parish Branch.

BY-LAW IV—ELECTION OF OFFICERS.

SECTION 1. The Officers shall be elected by ballot at the Annual Meeting for a term of three years.

No member shall serve on the Board in any capacity for more than two consecutive terms.

SECTION 2. The Executive Board shall constitute a nominating committee to prepare a ticket to be voted upon at the Annual Meeting.

SECTION 3. The President shall appoint four members to serve as tellers on the day of election, these persons having been previously notified.

SECTION 4. The Executive Board may fill a vacancy in any elective office by temporary appointment and the person thus appointed shall hold office until the next annual meeting of the Woman's Auxiliary. At that meeting the vacancy shall be filled by election.

SECTION 5. At each Annual Meeting there shall be elected by ballot one member at large to serve on the Executive Board for a term of three years.

SECTION 6. Delegates and alternates to the Triennial Convention shall be elected at the meeting preceding the General Convention.

BY-LAW V—COMMITTEES.

SECTION 1. There shall be a Finance Committee composed of the President, Treasurer, Supply Secretary, Social Service Secretary and one other member of the Executive Board.

SECTION 2. This committee shall prepare the budget for the year's work and shall make plans for financial projects not otherwise assigned.

SECTION 3. There shall be a Year Book Committee composed of five members of which the Recording Secretary shall be the Chairman. The other members shall be the President, the Corresponding Secretary, the Treasurer, and the Chairman of the Supply Committee. This Committee shall publish a Year Book which shall be distributed and a copy forwarded to the Secretary of the National Board of the Woman's Auxiliary.

BY-LAW VI—ENDOWMENT AND MEMORIAL GIFTS.

SECTION 1. There shall be an Endowment Fund. Only the interest from this Fund may be used for Auxiliary work, the principal must remain intact. The Endowment Fund shall be in charge of a Board of Trustees composed of the Endowment and Memorial Gifts Committee. Any individual or branch giving one hundred dollars to the Endowment Fund may name the gift.

SECTION 2. There shall be an Endowment and Memorial Gifts Committee composed of the Diocesan President, the Treasurer and three other members, which members shall be elected at the Annual Meeting for three years. This committee shall have full charge of receiving, investing and expending the interest of these funds. Anyone wishing to present a Memorial gift shall do so through this committee.

BY-LAW VII—PERMANENT COMMITTEE.

SECTION 1. A permanent Advisory Committee shall consist of the past presidents of the Woman's Auxiliary. Each member shall serve for one year as Chairman of this Committee in the same order she served the Woman's Auxiliary as Diocesan President. This Committee shall serve in an advisory capacity when called upon by the Executive Board.

BY-LAW VIII—MEETINGS.

SECTION 1. There shall be three meetings each year, one of which, the Annual Meeting shall be held immediately preceding or immediately following the Diocesan Convention. These meetings, which are held in the Bishop Tuttle Memorial, are open to all. There shall also be one meeting of the Board of Managers during the year.

SECTION 2. At the three meetings specified in Section 1, members of the Board of Managers only are eligible to cast a vote.

SECTION 3. At the Annual Meeting the vote on all measures shall be cast only by representatives who have served during the year.

SECTION 4. Upon the request of four Parishes, the vote on any question may be called for by parishes and in case of a division, the individual roll call may be demanded.

SECTION 5. Special meetings may be called by the President

SECTION 6. The Executive Board shall hold their meetings from October to June inclusive.

BY-LAW IX—AMENDMENTS.

These By-Laws may be altered or amended at any meeting of the Board of Managers, by a two-thirds vote of those present; due notice having been given each member.

STANDING RULE.

In recognition of the services of a retiring diocesan president a useful gift suitably inscribed as presented by the Woman's Auxiliary may be made to some mission or hospital, church school or similar institution in which the retiring president was interested; subject to the approval of the Bishop of the diocese in which the gift is to be made. The presentation is to be made at the first quarterly meeting following her completed term of office. This gift shall not exceed fifty dollars.

Accept, from grateful hearts, our United Thank Offering of prayer and gifts and joyful service; and bless it to the coming of Thy Kingdom through Jesus Christ our Lord. *Amen.*

O God, ever present with us, to whose wisdom our problems must seem so simple and so easy, help us to stay our minds on Thee, that we may see clearly, think straight and act according to Thy will. Through Jesus Christ our Lord. *Amen.*
