PROCEEDINGS OF THE MONTANA BRANCH OF THE WOMAN'S AUXILIARY

Minutes of the Executive Board

Billings, May 14, 1933.

The Executive Board met in the rectory of St. Luke's Parish, at the close of the Sunday evening service. The President, Mrs. Frank W. Haskins of Butte, presided. Other officers present were: 3rd Vice-President, Mrs. H. H. Harrison, Bridger; Treasurer, Mrs. T. E. Gilbert, Dillon; Educational Secretary, Mrs. E. L. Rolls, Great Falls; Secretary of the Girls' Friendly Society, Mrs. L. D. Smith, Livingston; Recording Secretary, Mrs. G. L. Bryant, Helena.

Letters of regret were received and read from Mrs. A. Kerby, 1st Vice-President and U.T.O. Custodian and Mrs. A. E. Bentley, Supply Secretary. A telegram expressing best wishes for the success of our convention was received from Mrs. Gracia Beard, Secretary of the Daughters of the King.

A letter, which had been received from Miss Lindley, regarding the Quiet Day For Prayer to be held November 11th for the women of the Church was read. Miss Ogden stated in her letter to the women of the Diocese that tentative plans for a program, which may be used for a Quiet Day For Prayer on November 11th, have been made.

Mrs. J. Barlow Reynolds, Chairman of Social Service for the Sixth Province, in a note to Mrs. Kinney suggested that material, such as pieces of silk, embroidery materials, wools, needles etc., be sent to our Diocesan Supply Secretary.

An appeal was received from Ada Loaring Clark for the work of the blind; the appropriation to carry on this work has been reduced, and may be further reduced during the year.

The Executive Board recommended - "That the Little Helpers Fund for which there is no further need in the Diocese at this time, be transferred to the rural work in the diocese."

Mrs. E. L. Rolls presented a bill from the New York Book Store for the amount of \$2.07, covering purchase of leaflets for distribution at the Convention. On motion the bill was allowed.

On motion the meeting was adjourned.

MINUTES OF THE MEETING

The Forty-second Annual Meeting of the Montana Branch of the Woman's Auxiliary was held in the auditorium of the Baptist Church, Billings, on May 15-16th, 1933. The meeting was called to order by the President, Mrs. F. W. Haskins, at 9:30 a.m., and opened with prayer by Mrs. J. L. Craig of Miles City.

Mrs. Craig spoke of two former officers who had passed away in Butte during the previous year; Mrs. Clinton Moore, a former treasurer, who in 1917 celebrated her twenty-fifth anniversary as custodian of the treasury and Mrs. Winchester, who had served as secretary and packer of the Alaska box for many years.

Mrs. H. H. H. Fox of Billings extended a gracious welcome which was responded to most appreciatively by Mrs. H. H. Harrison of Bridger.

Committees were appointed as above.

During the President's address the third Vice-President, Mrs. H.H. Harrison, occupied the chair. Mrs. Haskins stressed in her address the spiritual side of the Church's work, and that our parish members should be better informed regarding the Church and its great work. A rising vote of thanks was extended Mrs. Haskins at the close of her address.

Mrs. H. H. H. Fox was asked to extend an invitation to Dean Brewster of Fargo, North Dakota, to address the meeting sometime during Monday.

Mrs. T. E. Gilbert, Chairman of the Committee on the Revision of the Constitution and By-laws, read the proposed new Constitution and By-laws.

Letters were read from absent officers expressing regret at their inability to attend the meeting this year, and Mrs. Stucky voiced the regrets of Mrs. Whitehouse, who sent words of encouragement in carrying on the work.

A motion was made that a message of sympathy to Mrs. A. E. Maxwell be embodied in our resolutions, and that a copy of the resolutions be sent to Mrs. Maxwell. Motion prevailed. It was also moved and seconded that a telegram be sent to Mrs. Maxwell expressing the sympathy of the women present. Motion carried.

A letter was read from Bishop Faber expressing his deepest appreciation of the words of sympathy conveyed to him during our last Convention.

The report of the Treasurer was accepted as read.

REPORT OF RECORDING SECRETARY

Madame President and Delegates:

This being the second time it has been my privilege to present my report, I wish to express to you my sincere appreciation for the courteous cooperation which has been manifest during the past year. It has been very helpful to me in regard to my records and has enabled me to compile the annual report more accurately. I sincerely hope and trust that this year I shall continue to receive your undivided support.

At this time I also desire to express my thanks to Miss Monica Howell and Miss Imogene Richardson for their unselfish help and assistance during the past year and during my absence from the State this winter.

This year we have sixty-two Women's Guilds and Auxiliaries which have submitted financial reports. Three reported that they had temporarily disbanded due to present conditions, making a total of sixty-five as compared with fifty-nine for the year 1931, showing an increase of six.

During the past year there have been three new organizations reported, St. Paul's Guild of Butte, Junior Guild of Havre and the Episcopal Girls' Guild at Troy, making a total of seventy-five organizations in the Diocese.

REPORT OF UNITED THANK OFFERING CUSTODIAN

At this time, May, 1930, the same period one year from the triennium we had \$941.59, a difference of \$213.27.

We have in this Diocese 13 parishes and 45 missions. Also there are 25 to 30 stations and unorganized missions. Some of these do not function at all, but there are some that are doing a lot of fine work. Some of the missions are really not doing anything. Perhaps we can say then that we have 13 parishes and 50 missions active. Out of that number of 63, we have only 18 on our books this year. Other years there has been a few more, and next year we may have twenty or so, but you can see the field for work we have.

I have been trying to figure out some method to reach all these places, and I wondered if each parish could take the missions in their field and make some organized effort to tell all the Church women about the U.T.O. We can furnish you with plenty of folders and other materials to help in this campaign. I would suggest that you stress "that it is not the amount" that counts, but the carrying the Blue Box idea out. It is the many small parts that make a large whole.

The triennium is only a year away, and if we expect to reach anywhere near our last offering, we will have to work real hard this coming year.

The United Thank Offering takes hold of people if once they listen to its story. Care should be taken to present it properly.

Let all that are here make a special effort to inform the women in their parish and missions about the United Thank Offering

REPORT OF DIOCESAN EDUCATIONAL SECRETARY
May 15, 1933.

I beg to submit the following report of my activities as Educational Secretary during the year since last Convention:

I have written 180 letters, sent in two articles to the "Montana Churchman" and one article for the Provincial Bulletin.

From replies received to my recent letter of inquiry, and from the annual report blanks sent in last January, I have compiled the following report of activities throughout the Diocese this last year which come under the jurisdiction of the Educational Secretary.

There were about 60 services of Corporate Communion held; about 235 copies of the Daily Bible Readings were distributed through the women's organizations; 15 organizations cooperated in the World Day of Prayer, and 27 organizations report educational work of one kind or another at some time during the year. These organizations are as follows: St. Luke's Guild, Billings; St. James' Guild, Bozeman; Altar Guild, Woman's Auxiliary, Butte; St. James' Guild-Auxiliary, Dillon; Daughters of the King, St. Mary's Chapter, Woman's Auxiliary, Girls' Friendly Society, Great Falls; St. Catherine's Guild, Chancel Guild, Woman's Auxiliary, Helena; St. Anne's Guild, Woman's Guild, Kalispell; St. Andrew's Guild, Livingston; Emmanuel Guild, Miles City; St. Anne's Guild, Woman's Guild, Missoula; and the guilds at Augusta, Bridger, Deer Lodge, East Helena, Eureka, Glasgow, Glendive; and the Episcopal Girls' Guild, Troy; and the Daughters of the King, Whitefish.

St. Andrew's Guild, Livingston, again reports having held twelve Quiet Hours and six Quiet Days, the only organization to report such activity.

Three places report District meeting - Bridger, Great Falls, and Miles City.

May I call your attention to the display of pamphlets and other literature sent by the National Woman's Auxiliary for distribution. Please look this over carefully and take some of it home with you, to be read and passed on to other members of your group.

Along with this literature you will notice copies of the attractive programs gotten up by the Guilds at Bridger and Bozeman, by the Woman's Guild at Kalispell and the Woman's Auxiliary at Great Falls. Please look these over, too, and if not already doing so, plan to issue something similar in your organization this coming year.

You will be interested to know that the topic suggested for our study this coming fall and winter is "Christ and the Modern World". The chief source book recommended for our use is "The Never Failing Light" by Dr. James H. Franklin, Foreign Secretary, American Baptist Foreign Missionary Society. This book will be available in June.

May I urge you all to continued and renewed efforts toward building up the inspirational and educational work in your various organizations. We have made some advance this last year, but we can all do more along these lines, and I trust in our report next year we will be able to include a number of those organization we were not able to mention this year. If you will just make the start I am sure you will find you can do it as well as the others, and I know you will be happy in thus sharing more full in the broader program of the Church.

Education was defined as a gas mask to eliminate the poisons coming into our lives. Mrs. Haskins graciously thanked Dean Brewster for his all too brief message to the women. A rising vote of thanks was tendered Dean Brewster.

A report of the Provincial Synod was given by Miss M. Howell. As a bulletin had been edited following the Synod, Miss Howell dealt briefly with the organization of the Sixth Province and its purpose.

The report of the Daughters of the King Secretary, sent by Mrs. Beard, was read and accepted.

THE ANNUAL REPORT OF THE DAUGHTERS OF THE KING.

It is with a feeling of deep regret that I mention the resignation of Mrs. Ada Whitehouse as President of the Bishop's Chapter. From the date of its organization in 1927 Mrs. Whitehouse has proved to be a most loyal and faithful officer, whose kind cooperation at all times your Secretary has most full appreciated.

During the year past our three Chapters of the Daughters of the King have continued their earnest efforts in endeavoring to extend Christ's kingdom among women. Numerous calls have been made upon the sick, the strangers and the shut-ins, active participation in other church activities has been noted, work among the isolated communicants has been stressed, assistance to several needy families has been given during the winter, and the care of vesting the altar, providing flowers and wafers has been assumed by the Daughters.

May I not at this time urge that we make every endeavor to observe the third Sunday in each month as the day of our corporate communion, from which we derive the spiritual strength so greatly needed in carrying on our work.

During the year efforts have been made to establish new chapters which will in time, I hope, meet with success.

Madam President and Members:

For the Personal box for 1932, I sent out fifteen allotments. All the organizations sent the articles or money required of them and our allotment was complete. I received very grateful acknowledgement from Mrs. Smith and from the Reverend Nevill Joyner in behalf of Catechist Oliver Sun Bear.

For St. Elizabeth's Mission in Ketchikan, Alaska, I sent forty-two allotments. Four organizations made no response. St. John's Guild, Three Forks could not fill the requirements. Ascension Guild, Belgrade could not send new articles but did send second-hand things for children. Some organizations sent more than was asked of them, which helped make up for the delinquents. I repeat the messages for the delegates to take to their guilds: First, if the Auxiliary or Guild cannot fill the allotment, please have the secretary write and tell me and please always send the valuation of the boxes, but do not place money value on second-hand clothing.

The noon-day devotions and meditations were conducted by Bishop Fox. Bishop Fox spoke of the "Overtones in the Women's Work". The overtones in our work were compared to the overtones of the musician - they are something added which give the soul and bring out the beauty of the mechanics of technique. The work of Jesus Christ needs a warmth of friendship, something else besides the bald doing of the mechanical thing.

Bishop Fox also spoke of the possibility of a permanent camp being established, to be used as a retreat during the summer for our various Church organizations. Due to an overdraft in the Convention Fund there would be no journals printed this year, but there would be mimeographed copies available. The Bishops' Discretionary Fund had been augmented greatly in the past by gifts from eastern friends, but due to prevailing conditions these gifts have been greatly depleted.

The morning session adjourned for lunch.

The afternoon session was called to order by Mrs. Haskins at 1:45 p. m. Mrs. L. D. Smith conducted the opening prayers.

Roll call followed, showing forty-nine delegates present, there being thirty-two women's organizations represented.

It was moved and seconded that a message of sympathy be sent to Mrs. R. P. Skinner and family. Motion prevailed. Rev. R. P. Skinner had been the missionary in charge at Townsend for several years.

The Constitution and By-laws were again read, and after some discussion, amendments were made to Article II, Sections VII, VIII, and By-laws 2 and 3. It was moved and seconded that the Constitution and By-laws now offered as amended be adopted and substituted for the former Constitution and By-laws, and that all other constitutions and by-laws be repealed. Motion carried.

It was moved and seconded that Miss Monica Howell be made an ex-officio member of the Executive Board, in an advisory capacity with a vote. Motion carried.

Mrs. E. Leslie Rolls now took charge of the Round Table Discussion. Mrs. Rolls opened the Round Table with the singing of the hymn "O Master let me walk with Thee", followed by prayers. The conference was conducted under "the Five Fields of Service" which was subdivided into the four elements of "Worship, Study, Work and Gift

At 4:30 p.m. the Round Table was adjourned until the following morning.
