## Secretary's Report.

---

*Dear Friends of the Woman's Auxiliary:*

We have met once more to see what progress the year just closing has made and to take a backward glance over the work done. We have held our two quarterly meetings, but not quite as usual. Our first meeting was held October 17th instead of in November, so as to give our out of town delegates an opportunity of being present at the services the following day, when the Rev. Arthur L. Williams was consecrated Bishop-Coadjutor of the Diocese of Nebraska, and when we too could avail ourselves of the presence of a number of visiting Bishops to address us. Our meeting was held in the afternoon. After the transaction of business we had the pleasure of being addressed by Bishops Edsall of North Dakota, Millspaugh of Kansas, and Morrison of Iowa. Bishop Edsall spoke entertainingly and hopefully of his work, particularly among the Indians. Bishop Millspaugh spoke in glowing terms of the work being done in Foreign lands, while Bishop Morrison spoke earnestly of the faithful work of our own missionaries in the west.

Our second quarterly meeting, usually held in February, did not take place until March 6th, owing to the inability of Bishop Williams to meet with us in February. This meeting was held in the Chapel of Trinity Cathedral. After the business meeting an address was made by the Bishop, telling of the needs of

our own Diocese and making an appeal to the church women of Nebraska for three hundred dollars to place an additional missionary in the Nebraska field.

An address was also made by Rev. Irving Johnson, asking for more generous giving towards the United Offering. The Auxiliaries throughout the Diocese generally have done excellent work during the past year.

It was the privilege of your Secretary, together with the Diocesan President, and that faithful friend of missions, Mrs. Philip Potter, to visit the Ashland Auxiliary, where we were most hospitably entertained and a delightful day was spent, and an earnest Auxiliary found. Also a part of a day was spent in Papillion, and while they now have no organized Auxiliary, the little mission is almost entirely supported by a few devoted women, and while their need is great at home, we trust another year will find them organized as an Auxiliary, and at least studying the mission work of our dear church. What is true of Papillion is also true of Wymore and many other small places where the church has stations: a few faithful women, earnest in their work for the Master, bear the too heavy burden of its support.

One Auxiliary, that at Wymore, is reported as re-organized. The reports from Lincoln, Central City, Schuyler, Blair, Nebraska City, Plattsmouth, Columbus, South Omaha and Omaha show that good and faithful work has been done in these places.

In Omaha, Trinity Cathedral takes the lead as becomes it, followed by good work in most of the other parishes and missions. For local reasons only the box report does not make as good a showing as usual in some of our parishes, but we hope with home interests in better financial condition the coming year

will show an improvement in this direction. The general box report is better than usual. Owing to St. Martin's, South Omaha, building a new church, the Auxiliary there has not been able to do as much missionary work as usual, though the intelligent knowledge of missionary work and the earnest zeal of that Auxiliary could be emulated by us all. Norfolk has sent in no report, and your Secretary hopes their interest is not dead, but merely sleeping, and can be awakened into new life. Surely there are a number of other places in the Diocese where the Auxiliary should have branches and we trust the new year will find them an established fact. It is hoped the Diocesan Officers can do more visiting in the future and help to make isolated branches feel that they are part of the great missionary work of the church.

In Omaha during the past six months the Omaha and South Omaha branches have held union meetings on the last Friday of each month. These meetings, for the purpose of informing ourselves of the various missionary work of the church, have been most instructive and helpful and have gotten the church people better acquainted and in closer sympathy. Many thoughtful papers were prepared and read.

During the past year we have missed the wise and loving counsel of our Honorary President, Mrs. Worthington, and the inspiration of her presence, but we have known that though far from us, her sympathy and love and prayers were with us here.

Your Secretary wishes to thank each Auxiliary for its kindness to her in replying promptly and fully to her many letters, and to its unfailing courtesy and thoughtfulness, which have made her work a pleasure.

If I may say one word in conclusion, it is this: Never before have the doors been so wide open to

Christian efforts as now. We are at the threshold of a wonderful century, full of golden opportunity. Cuba, Puerto Rico, the Philippines, the Open Door in China, Japan welcoming our missionaries. How can we sit quietly by and say what is this to us? While the needs of our own parish, city, diocese may be great, let us remember that our duty does not end there, and until every soul has heard the blessed gospel, whether it is in the heart of "Darkest Africa," or in the slums of our great cities, our duty is not done, and that we must give our best of love and work and treasure until the Cross of Calvary shall be the beacon light, shining brightest where sin and ignorance now prevail and shining glorious still until it lightens the whole world.

1. Please decide upon the Missionary letters enclosed, and return as soon as possible, those you do not wish to keep to the person from whom you received them.

2. Please write *at once* to the Missionary to whom you have decided to send your box, and tell him that you have undertaken it, how complete you think it likely to be, and how soon you hope to have it ready.

To comply with these requests will very much oblige the Missionary, your own Diocesan Officers, and the Secretary of the Auxiliary.

N. B.—The names of Missionaries to whom boxes are sent should never be printed in reports, parish papers or elsewhere.

The names of Missionaries should be omitted when their letters are read at the meetings of the Auxiliary.

If any clothing that has been worn is offered for a box, write to the Missionary for whom the box is being prepared, and ask if he would like to receive it for distribution in his parish, or for other purposes. Second-hand clothing for the personal use of a clergyman should never be substituted for new. If in excellent condition it may sometimes be sent in addition to new clothing, but its disposition should always be left to the discretion of the Missionary.

It seems unnecessary to add that no article of any kind should be put into a Missionary box that is not *absolutely whole and clean*.

In sending to the families of Missionaries it is desirable to pack in boxes rather than barrels.

Among the smaller Branches, when they have perhaps only five dollars to spend, very acceptable boxes can be prepared for our own Clarkson Hospital.

Hereafter a supply box will be kept at Trinity Parish House, Omaha, from this box smaller boxes can be filled and sent out to different Missionaries as needed. This box will be in charge of Mrs. Chetwood Hamilton, all articles will be assorted by her and sent out in Missionary boxes. Branches not able to supply a whole box can by applying to Mrs. Hamilton get a list of articles needed for their box, and receive credit for any articles sent. Besides wearing apparel, table, linen, bedding etc., table delicacies may be sent, jelly fruit etc. Juniors can make acceptable articles for this box, such as bed slippers, infants' shoes, wash rags, hemming towels and napkins etc. Packages for this box should be addressed to Mrs. Chetwood Hamilton, care Trinity Cathedral Parish House, 18th and Capitol Avenue, Omaha. For any information in regard to this box, or letters giving notice of packages sent, please address Mrs. Chetwood Hamilton, 201 N. 20th St., Omaha.

Should you lose by death one of your members, will you not send the name to the secretary? It is intended hereafter to keep a Memorial Page in each of our Annual Reports for these faithful ones entered into rest.

The President desires to be in close touch with the Branches. At any time she would be glad to know what is being accomplished in each society, to this end she invites frequent communications.

Each parish branch should pay an annual fee of one dollar toward the expense fund. This fund is used to pay the necessary expense of stamps, printing, etc.

Lists of boxes can be procured at any time from the secretary, though enough time should be allowed to get letters from Miss Emery in New York, where the list is kept. The Secretary will be glad at all times to furnish any desired information about the work, to any Branch, as far as it is in her power to give it.

## Constitution.

---

### ARTICLE I.

This society shall be called the NEBRASKA BRANCH OF THE WOMEN'S AUXILIARY TO THE BOARD OF MISSIONS.

### ARTICLE II.

The object of this society is fourfold: 1st. To diffuse missionary intelligence. 2nd. To increase missionary activity among the women of this diocese. 3rd. To unite previously existing societies in a common interest. 4th. To encourage the formation of new societies for missionary work.

### ARTICLE III.

All baptized women of the church in the diocese of Nebraska shall be considered members of this association.

### ARTICLE IV.

The officers of this society shall be a President and four Vice-Presidents, a Secretary and a Treasurer. These officers shall be chosen by ballot at the annual meeting. In case of a vacancy in any office, the same may be filled by appointment of the Bishop, and any person so appointed shall continue in office until the next annual meeting.

### ARTICLE V.

It shall be the duty of the President to preside at all meetings of the association, to call special meetings of the same, and to countersign all drafts on the Treasurer.

## ARTICLE VI.

It shall be the duty of the Vice-Presidents to preside in their several districts in the absence of the President, and it shall be the duty of the three rural Vice-Presidents to superintend the work of the Auxiliary in their respective districts.

## ARTICLE VII.

The Secretary shall give notice of all meetings and conduct the correspondence of the society with missionaries, with the secretaries of the associated branches, and with the general secretary of the Woman's Auxiliary in New York. She shall keep a record of all meetings, prepare and keep a list of the names of all associated branches with their officers, and shall report the same once a year to the Bishop of the diocese and the general secretary in New York.

## ARTICLE VIII.

It shall be the duty of the Treasurer to receive and keep account of all moneys contributed to the work of the association, to pay all drafts on the funds when countersigned by the President and present an annual report of the same.

## ARTICLE IX.

An annual meeting of this association shall be held at the time and place of the Diocesan Council. Quarterly meetings shall be held at such time and place as the president shall direct. The officers or their proxies, of each associated branch, shall constitute a delegation to the general meetings of the association.

## ARTICLE X.

Any parish society becomes a branch of the diocesan auxiliary by paying annually one dollar, which together with the offertories at the general meetings, shall constitute a contingent fund for defraying the necessary expenses of the diocesan branch.
