

## SECRETARY'S REPORT

The Forty-first Annual Meeting of the New Jersey Branch of the Woman's Auxiliary was held at All Saints' Church, Trenton, on Wednesday, May 3, 1916, with an attendance of two hundred and forty-seven members.

The Rector, the Rev. Ralph Urban, celebrated the Holy Communion at 10.30. Bishop Matthews made the principal address of the day, Archdeacon Shepherd spoke for the Missions of the Diocese, and Mr. Paul Shimmon, of the Church of England Mission at Urumiah, Persia, told of the persecutions and sufferings of his people because of the war.

At the business meeting which followed, the President made her Annual Report. The usual meetings have been held in both Divisions of the Diocese. At Pitman Grove, Moorestown, Rumson, and Christ Church, Elizabeth.

Mrs. Carpender reported the amount on hand for the United Offering to be \$5,350.00, as against \$4,470.00 three years ago, and asked every member of the Woman's Auxiliary to make a special and systematic effort to increase this sum, so that before the meeting at the Triennial in October next, the amount will greatly exceed the offering from the New Jersey Branch in 1913, which was \$6,472.00.

Reports were also read by the Educational Secretary, the Chairman of the Devotional Committee, the Diocesan Correspondent of the Church Periodical Club, and of the Committee on Neighborhood Districts.

A combined report of the value of boxes sent, and money given to Missions through the Parish Branches of the Auxiliary, during the past year, was read by the Treasurer, the total amount to date being \$20,207.36.

The Chairman of each department of the work gave an account of special objects for which she asked that pledges be made or renewed, and Mrs. Trowbridge, of the Princeton Branch, moved the adoption of a pledge of \$500.00 to be used for work among women and girls in China.

## ANNUAL REPORT OF THE PRESIDENT OF THE WOMAN'S AUXILIARY

The report which I make to you each year has to be one in which the question of money does not appear at all. From time to time the Chairmen of the different committees tell me in general terms how their work is progressing, but when I come to make this report I really have no idea what our financial report will be. I think in many ways this is an advantage, for the work of the Auxiliary cannot be measured in dollars and cents, but rather in the progress which we women of the Church have made in realizing what is our share in the work of the Kingdom. I have tried this year, as in former years to go about the Diocese and visit the parish branches, to understand their conditions, their problems and their difficulties, and to advise them as best I can about their work. This season I have visited sixteen branches of the Auxiliary. I have helped to organize or reorganize several of them, and I have corresponded with a good many more. As we now have about ninety branches on our list, I am really ashamed to report that I have visited so few of them, but I cannot well go uninvited. Most of the branches I have visited this year have asked me to come nearly every year, and are so well organized and conducted that they seldom need any help or advice. If you again elect me as your President, I beg you to use me. You do not need to get up a special meeting for me, or to give me luncheon or tea, what I want is to know and talk with the two or three women, who in so many branches are trying to interest the women of their parish and keep up the work. The most satisfactory way I have found of getting to know the Auxiliary women of the Diocese is by having Mission Study Classes among them, but, of course, I cannot have these everywhere, much as I should like to. This season I have led classes—all but one of them inter-parochial—at Elizabeth, Cranford, Plainfield, New Brunswick and Bound Brook.

I wish to say frankly that I am not satisfied with the growth or condition of the Auxiliary in our Diocese. There are still a large number of parishes and Missions where there are no branches, and we, as Auxiliary women, are neglecting our duty if we do not use every means in our power to introduce the Auxiliary to every woman in the Church. We, who are on the Executive Board, have tried in every way we know to induce the rectors and women of these parishes to let us come and organize branches for them, but in many, many cases we have failed. It may be that there are ways of doing this work which we have not discovered, and I believe it would be for the good of our Diocesan Auxiliary if we had more rotation in office. I have been your President for six years and I have not declined renomination this

year, but I think it is nearly time for you to be selecting some one else for this office. If to be President of this Auxiliary is an *easy* thing, I ought not selfishly to keep the office, and if it is a *hard* thing, some one else ought to take her turn at it. I propose to bring this whole subject of rotation in all the offices before our Executive Board, and we shall want to discuss some amendments to our constitution with you next fall, at the Division Meetings. In the meantime I hope you will all be thinking about it so that we may find out what we should do.

There have been three executive meetings held during the year, on May 19th, October 20th, and January 19th. Mrs. Matthews, the Chairman of the Committee on Districts, will tell you the results of the plan which was made to divide the Diocese into Districts to be organized and to have meetings at stated times. This plan was suggested by the success of the Monmouth County organization.

At the Synod of the Second Province, at Albany, in January, we were represented by Mrs. Matthews, Mrs. Shepherd and Miss Melville, at the Auxiliary Meeting, when the question of Provincial organization again came up. This year again the decision was against it—Newark alone voting in favor of it. The following resolution was then unanimously adopted:

"That the resolution passed at the meeting last year—in regard to yearly meetings in connection with the Synod be rescinded, and any further meetings of the Woman's Auxiliary in connection with the meetings of the Synod, shall only be called at the express wish of the Diocese holding the Synod that year."

As the Synod is to meet in this Diocese next January, it will be for us to decide whether a meeting of the Auxiliary be held at that time.

We have held our regular meetings during the year; in the fall at Pitman and Rumson, and in the winter at Moorestown, and Christ Church, Elizabeth. Our outside speakers have been the Ven. W. B. Allen, Archdeacon of Asheville; Miss Hopgood, of China; Rev. Roger Walke, of Kyoto, Japan; Rev. A. E. Jensen, of St. Augustine's, Asbury Park; the Ven. W. S. Claibourne, Archdeacon of East Tennessee; Mrs. Biller, of South Dakota; and the Ven. Hudson Stuck, Archdeacon of Alaska. The two Quiet Days were held as usual, both led by Dean Vernon, of St. Luke's Cathedral, Portland, Maine.

I wish more of our Auxiliary women could attend the summer conferences. A few of us were at the Summer School, at Gladstone, two or three were at the Conference of the Second Province, at Geneva, and I hope we were represented at the Cambridge Conference and at Silver Bay, but I am not sure of it. The New Jersey women ought also to try to attend some of the Winter Monthly Conferences, at the Mission House, in New York. I had the privilege of serving on the committee to pre-

pare the Programmes for the Conferences this winter and I was sorry so few of our Auxiliary could enjoy them with me.

All of these meetings and conferences are sure to increase our enthusiasm for the work as well as to suggest to us new and better ways of doing it, and since we have this wonderful privilege of sharing in the great work of hastening the coming of the Kingdom, we should seize every opportunity of increasing our power to help.

The work of the Junior Auxiliary began with the Annual Conference of leaders and older girls, which was held in the Parish rooms of St. James' Church, Atlantic City. About thirty-five attended.

The Conference opened with a business session on Friday afternoon, December 3rd. In the evening the Juniors of St. James' presented a short and interesting play dramatized from "The Conquest of the Continent," and Mr. Gray, the Educational Secretary, gave an illustrated lecture on his trip around the world.

On Saturday, Deaconess Sabine, the devoted and patient worker of many years in Alaska, addressed the children.

Miss Prophet, who has solved so many Junior problems, spoke on Method, giving us many new ways and means of interesting the boys and girls. She urged the formation of branches for boys, claiming that the much-neglected boy was no more difficult to interest or control than the average girl.

The business transacted was as follows:

The adoption of a Constitution.

A new pledge of \$100.00 for a scholarship at Anvik, Alaska.

A resolution to hold a competitive exhibit of Junior work at the Fall Conference. Plans for Neighborhood Meetings of the Junior Auxiliary, to be held throughout the Diocese.

The placing of a sum in the hands of the Board to be used toward the training of a Junior volunteer.

The Conference closed with the noon-day service. A vote of thanks was passed, expressing deep appreciation of the hospitality and kindly thoughtfulness extended to the members by the Rector and the Juniors of St. James' Church.

Two Neighborhood Meetings have been held, one in Lakewood, and the other in Cranford, with Mrs. Biller and Mrs. Burke as speakers.

The attendance was not satisfactory, partly on account of the weather, and also owing to the scarcity of funds. Later we hope that some plan may be arranged so that every branch shall be able to send a delegate to these local meetings.

The chairman made six visits during the winter, and had planned three others but was unable to fill her appointments.

In February we received an invitation from the Juniors of New York, to attend an Inter-Diocesan meeting to be held at Synod Hall to discuss ways and means to help solve our local problems, which we found to be much the same throughout the Province.

These are some of the questions brought up.

How to start branches?

How to get leaders?

How to reach Rectors?

How to apply the associate system of the G. F. S. for the older girls in our Junior work.

Our gains in branches have been: Section I, —; Section II, 3; Section III, —. Two branches have been dropped.

Mrs. Senseman, the Educational Secretary, reports that 34 branches have used some means of missionary instruction, in comparison to 17 of last year.

There have also been on sale four short stories on our pledges, which have proved most interesting.

## REPORT OF THE EDUCATIONAL SECRETARY

It is generally admitted that this is a time of peculiar opportunity for the church in the Mission field, both at home and abroad, but we need to be aroused to our responsibility to deliver the message which has been intrusted to us. There could not be the apathy and indifference which exists among Christian people, if they were aware of this responsibility, which rests on each one of us as members of Christ's Church, to which He gave the unequivocal command, "Go—teach all nations."

At least we have been awakened to the extent of finding out what is one of the great causes of our inertia and apparent inability. Ignorance, that is one malady, and that is what the active leaders of the Church, by a campaign of education, are trying to overcome and to cure.

The Woman's Auxiliary have seized upon this new means of service with enthusiasm, for this is work peculiarly fitting for women to do, and now, almost every Diocese and Missionary District has its Educational Secretary of the Woman's Auxiliary, and Mission Study has become a most important part of our work—not only in itself, but in its effect on the intelligent growth of the other departments.

Everywhere an increasing number of women and girls (and through them some of the men) are informing themselves of the Church's work—what is to be done and how to do it—and from studying the example of those whose ears have been keener than ours to hear the cry for help, whose hearts have been more brave and their spirits more willing to obey the Master's command, they are learning better how to be His faithful followers, whether by giving themselves to work in the mission field, or by better service in the church at home.

In our own diocese of New Jersey we are not doing as much as we should do in educational work. As yet only a small percentage of our Auxiliary members are taking part in Mission Study—but that leaves the more room for growth, which, with honest effort, is bound to be steady and strong.

We need more leaders.

Four Normal Classes, for the purpose of training leaders for the parish classes, were held in November and December in Elizabeth, Red Bank, Trenton and Camden.

Though these Normal Classes had a membership of 37, with an average attendance of 29, only six new leaders were developed by them. I hope that next year there may be larger results from similar classes.

The idea that a Missionary Study Class leader must be a thoroughly equipped Bible student, and well versed in pedagogy, is an erroneous one, and I fear holds back many a woman who, with a little training, might be an excellent leader, and a source of help and inspiration to others.

We have had 16 active leaders this year, who have conducted 26 parish classes, most of them during Lent—one is not yet finished.

The enrolled membership of these classes was 407, with an average attendance of 282.

The total membership of all classes with leaders was 423, with an average attendance of 298.

There are, therefore, about 400 women in the diocese, who know a little more about the Church's work, and realize their own responsibility for it at least a little more than they did a year ago.

Ought we not to have some programme work in our Mission study next year? If we make a *united* effort, the result is assured.

Last summer a number of books were sent from the Missionary Library to Atlantic City, where a member of Miss Hare's Missionary Class placed them in some of the hotels. We hope that some good seed may have been sown in this way.

## REPORT OF COMMITTEE ON NEIGHBORHOOD DISTRICTS

The Committee on Districts and Neighborhood Meetings begs to submit the following report.

Owing to the success of the Neighborhood Meetings in the Rumson District, organized by Mrs. Dale, the Executive Board decided to try the same plan throughout the diocese, and this committee was appointed to divide the diocese into Districts.

The plan has been in operation during the past winter with varying degrees of success, but on the whole, the result has been satisfactory, and the general feeling seems to be that it will be well to continue the plan with some changes.

Two Districts have not organized at all—namely, Atlantic City and Cape May, and two, though organized, have had no further meetings. The Camden District, while it has had good meetings, is too large, and a number of the parishes in the District had not been represented.

The Committee suggests that a new district of Woodbury be formed, taking in some of the Camden District, and that the Vineland District be rearranged, but we feel that this can better be done by representatives of the branches included in these Districts, and the present committee respectfully ask to be discharged.

## NEW JERSEY BRANCH OF THE WOMAN'S AUXILIARY

### Diocesan Constitution

#### ARTICLE I.—*Name.*

The name of this Society shall be, "THE NEW JERSEY BRANCH OF THE WOMAN'S AUXILIARY TO THE BOARD OF MISSIONS."

#### ARTICLE II.—*Object.*

The object of this Society is to interest all women in the general missionary work of the church, to communicate missionary intelligence, and to secure increased contributions and prayers for the spread of the Gospel of Christ.

#### ARTICLE III.—*Officers.*

The officers of this Society shall be a president, two vice-presidents, one for the Upper and one for the Lower Division, a chairman and vice-chairman to represent each branch of the work, a secretary, treasurer, a treasurer of the United Offering, Division corresponding secretaries and a secretary of the "Spirit of Missions," to be elected at the Annual Meeting to serve for one year. The election of officers shall be by ballot, nominations to be made by a nominating committee appointed by the president, and sent to each parish secretary one month before an Annual Meeting. The Diocesan Correspondent of the Church Periodical Club shall be appointed by the Bishop of the Diocese.

#### ARTICLE IV.—*Executive Board.*

The Executive Board shall be composed of the above officers; it shall meet twice or more each year, these meetings to be arranged by the president. Nine members shall constitute a quorum.

The Right Rev. Bishop of the Diocese shall be a member ex-officio of the Executive Board.

#### ARTICLE V.—*Representation.*

Any parish may become a member of this Society by appointing a secretary and notifying the president.

A membership fee of ten cents shall be paid annually by each member toward a general fund. This fund is to be known as the Ten Cent Assessment Fund, to be used for the contingent fund of the Auxiliary and sent to the Diocesan treasurer. Each parish shall send to the annual meeting two or more delegates.

#### ARTICLE VI.—*Meetings and Collections.*

The annual meeting shall be held in the spring before the convention. There shall be meetings in the Upper and Lower Divisions in the autumn and winter, to enable the officers to present their several branches of work. The offerings at the Division meetings shall be used for missionary purposes at the discretion of the president and two other officers.

#### ARTICLE VII.—*Amendments*

The Constitution may be amended by a two-thirds vote at any annual meeting, when such amendments have previously been submitted in writing to, and approved by the Executive Board, and read at an Upper and a Lower Division meeting.

The By-laws may be amended by a two-thirds vote at any meeting of the Executive Board, a copy of the proposed amendment having been sent to each member beforehand.

#### BY-LAWS.

##### I.—*Duties of Officers.*

1. The president shall preside at all meetings, have a general oversight of all branches of the work, and perform such other duties as usually appertain to that office.
2. The vice-presidents shall assist the president in arranging for, and conducting meetings, and in the absence of the president, preside at meetings in their respective divisions.
3. A committee, having a chairman and vice-chairman, shall have charge of each of the several branches of Mission work, respectively,—Domestic, Foreign, Diocesan, Indian and Negro Missions, the Junior Auxiliary, Educational and Devotional,—shall receive and forward all moneys contributed for the same, and make full report to the secretary at the annual meeting.
4. The secretary shall call the roll at the annual meeting, and prepare and read the minutes, performing all duties belonging to the office.
5. The treasurer shall take charge of all moneys appropriated to the incidental expenses of the Society, and the Ten Cent Assessment Fund.
6. The treasurer of the United Offering shall take charge of all moneys contributed for that object.
7. The corresponding secretaries shall send to the Rectors, Diocesan officers and parochial secretaries, notices of each Division meeting, keep the minutes of said meetings, make an annual report of the same, and diffuse among the parishes intelligence concerning the missionary work of the Church.
8. The chairman of the Educational Committee shall have charge of Mission Study, and of the Missionary Lending Library, which is for the use of all members of the Woman's Auxiliary in the Diocese.
9. The chairman of the Devotional Committee shall make arrangements for the days of devotion.

##### II.—*Meetings.*

Days of devotion shall be observed each year, at such time and place as shall be deemed advisable by the committee. Any other meetings which may be desirable can be held at times proposed by the parish or corresponding secretaries and concurred in by the president.
