

## PRESIDENT'S ADDRESS.

My Dear Women of the Auxiliary:

It is not my purpose in this last word to you as your president to go into the details of the work of the Auxiliary; you know it best by the things we have been doing together the longest; in the planning of our work in co-operation with other diocesan organizations; in the standardization of the Supply Department; in the growth of the Educational work through the Summer Conferences and other agencies; in the devotional life through the formation of Prayer Groups, Quiet Days of Intercession, and Corporate Communions; in the wonderful increase in the United Thank Offering; and in the adoption of a Budget plan wherein the parish branches have responded, not only willingly but eagerly. All these denote an increase of personal loyalty and devotion, and are the tangible ways of carrying out the ideals and policies of the National Council to which we are Auxiliary.

In the life of every great movement there comes a time for a re-study of its purpose. Last year the basis of our work was the fulfillment of our re-dedication in the words of THE MESSAGE and to that has been added the BISHOPS' CRUSADE, in which we are allowed the privilege of further service; so, while the year following the Triennial has possibly not been one of great material achievement, it may be considered one of preparation for a deeper consciousness of our individual responsibilities, and a greater and more earnest consecration in the lives of each one of us.

May I pay tribute here to the many faithful workers who have labored with us and have passed to their reward; we thank God for their friendship and blessed example and take courage to go on?

The future of the Auxiliary demands that in a few years we must lay down our work and others will be stepping into our places, for the young women of to-day will be the women of to-morrow. Are we training them or making a conscientious effort to interest them? Are we trying to discover their problems, their needs, their desires, or have we just waved them aside with the thought in mind that their time would come? Conditions in society outside of the Church have forced us to revise our opinions of their ideas and ideals, and many of these changes are inevitable, but do we understand modern psychology well enough to understand their point of view? I doubt it. Just what are we going to do about it, my friends? This requires serious thought and immediate action.

The Auxiliary through the districts has discovered the value of organizing the rural churches into a closer relationship with the larger, nearby parishes; this means practical helpfulness for the country parish where opportunities are limited. I would urge a greater effort on the part of the district officers to bring the isolated women of their neighborhoods into closer contact with the diocesan work through the district meetings.

For several years I have been suggesting, for the sake of uniformity, that the parish branches hold their elections before the Annual Meeting of the Diocese, in order that the names of the new officers, as well as other data of importance, may be reported promptly for tabulation in the Year Book. May I ask again that those who have not already adopted this plan, will do so in order to avoid unnecessary confusion?

Some seventeen years ago, I became a member of the Executive Board of the Auxiliary, first as Chairman of the Little Helpers, then successively as Chairman of the Devotional Committee, Vice-Chairman of the Domestic Committee and Chairman of the Domestic Committee. Then six years ago you did me the honor of electing me your president, an honor that only one who has had the privilege of serving you in that

capacity can appreciate. During my two terms of office I have never missed an Executive Board, Division or Diocesan meeting, and the other meetings I have attended number approximately three hundred.

Seventeen years seems a long period upon which to look back. Numerous changes have taken place; we have lost many tried and true friends; the demands upon our strength and resources have multiplied; but there is sometimes help for the future in looking backward, seeing where mistakes have been made, different methods used, and also finding encouragement in the increase and development of the work in a new and broader way; while through it all has been the sustaining knowledge of the loyalty and devotion of the women throughout the Diocese.

May I thank you all for making possible the fulfilment of the plans of the Executive Board. And to that Board I wish I could express my heartfelt gratitude for all their kindness and loyal trust, but nothing I can say can possibly add to my thankfulness for their untiring patience and co-operation.

Shall we not, as we enter another year, realize that after all we are but creatures called upon to do the will of Our Lord and to help in the extension of His Kingdom on earth. Thus our hearts may be stirred to the needs of the world in such a way that there shall be no turning back. The future of the Auxiliary depends upon what we will put into it. May God bless you all in every way.

**CONSTITUTION AND BY-LAWS OF THE  
NEW JERSEY BRANCH OF THE WOMAN'S AUXILIARY  
TO THE NATIONAL COUNCIL**

---

**Article I—Name.**

The name of this Society shall be "The New Jersey Branch of the Woman's Auxiliary to the Presiding Bishop and Council of the Church."

**Article II—Object.**

The object of this Society is to interest all women in the Missionary, Social and Educational work of the Church, to deepen the spiritual life of its members, and to encourage increased offerings for the spread of the Gospel of Christ.

**Article III—Officers.**

The officers of this Society shall be a President, one Vice-President for each District of the Diocese, a Recording Secretary, a Corresponding Secretary, a Treasurer, a United Thank Offering Treasurer, an Educational Secretary, a Supply Secretary and a Devotional Secretary.

All the above-named officers except the Recording Secretary, shall be elected triennially to serve for a term of three years and shall not be eligible for more than two consecutive terms.

The Recording Secretary shall be appointed by the President for the duration of her term.

The Diocesan Director of the Church Periodical Club shall be appointed by the Bishop.

**Article IV—Executive Board.**

The Executive Board shall consist of the above-named officers. Seven members shall constitute a quorum.

Vacancies on the Board shall be filled by the President for the unexpired term.

No officer shall at any time hold more than one office.

**Article V—Representation.**

Any parish organizing a branch of this Society shall notify both Recording and Corresponding Secretaries of the names and addresses of their officers.

**Article VI—Amendments.**

The Constitution may be amended by a two-thirds vote at any Annual Meeting, when such amendments have previously been submitted in writing and approved by the Executive Board, and read at an Upper, Central and Lower Division meeting.

The By-Laws may be amended by a two-thirds vote at any Annual Meeting or at Upper, Central and Lower Division meetings.

## BY-LAWS.

### I.—Duties of Officers.

1. The President shall preside at all meetings, have a general oversight of all branches of the work and perform such other duties as usually appertain to that office. The President shall appoint a member of the Board to preside at any meeting in case of her enforced absence.
2. The presidents of the Districts shall be nominated as vice presidents of the New Jersey Branch of the Woman's Auxiliary and elected by the Annual Meeting. They shall be responsible for carrying out in their Districts the policies of the Executive Board.
3. The Recording Secretary shall call the roll at all meetings, prepare and read the Minutes, prepare the Annual Report, and perform all duties belonging to the office.
4. The Corresponding Secretary shall send to the Rectors, Diocesan Officers and Parochial Secretaries notices of each Division Meeting and to the Officers notices of Executive Board Meetings. She shall make an Annual Report of the same.
5. The Diocesan Treasurer of the Auxiliary shall take charge of all moneys raised by the Auxiliary, except for the United Thank Offering, for the Church Mission of Help, for the Evergreens and for the Church Periodical Club, which should be sent to their respective Treasurers.
6. The Treasurer of the United Thank Offering shall take charge of all moneys contributed for that object.
7. The Educational Secretary shall have charge of the promotion of Mission Study and other forms of Adult Religious Education among the women of the Diocese.
8. The Chairman of the Devotional Committee shall make arrangements for Corporate Communions and the Days of Devotion for the Auxiliary throughout the Diocese.
9. The Supply Secretary shall have charge of all Missionary Allotments and of the Church Pantry.

### II.—Meetings and Collections.

The Annual Meeting of this Society shall be held in January.

There shall be meetings of the Upper, Central and Lower Divisions of the Diocese in the Autumn and Spring in order to stimulate the various forms of work of the Auxiliary.

The Lower Division shall consist of the Districts of Atlantic City, Woodbury and Camden. The Central Division shall consist of the Districts of Burlington, Trenton and New Brunswick. The Upper Division shall consist of the Districts of Elizabeth, Plainfield and Monmouth.

### III.—Finances.

The finances of this Society shall be administered by a committee, consisting of five members of the Board, to be elected by the Executive Board, the President and Treasurer being members *ex officio*.
