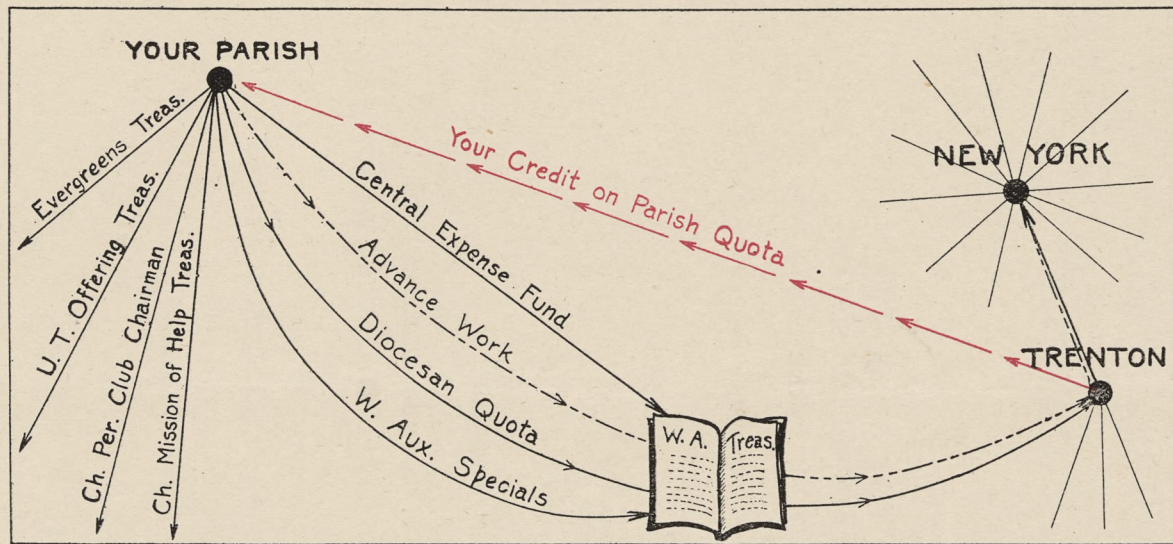
FINANCES

FROM THE ANNUAL REPORT OF THE PRESIDENT.

The Triennial Meeting of the W. A. in Washington was attended by so many New Jersey people that it seems as if its spirit of wide responsibility and privilege should be felt in our work all through this Triennium. The business of the meetings was handled in a new way, each subject presented being referred to a special Committee which reported their findings at a subsequent meeting for discussion, and offered resolutions to be adopted by the meeting. These findings on eight different subjects are incorporated in the Minutes of the Triennial, and every parish president should secure a copy of them. In order to make the best use of these findings a Committee of your Executive Board has selected those which seemed most important for us to follow in this Diocese and has incorporated them into a Diocesan Program. Please call a special meeting of your parish branch, read the Program aloud, consider carefully its various suggestions, decide what ones you could or should follow in your own parish and then make up your own Parish program for the year. Have it printed or multigraphed, give every woman in the parish a copy and see to it that every one finds something to do for the Church. When the copy for this program was submitted to our Bishop he returned it after reading it with the words: "This do and thou shalt live."

Since the last Annual Meeting the whole National Auxiliary has sustained a grievous loss in the death of Miss Emily Tillotson, National Educational Secretary. She was beloved and admired by all who knew her and her splendid work for the Auxiliary was a testimony to her devotion and ability.

On December 9 took place the formal dedication and blessing of Winham House at 326 West 108th St., N. Y., the "House near Headquarters," for which a large part of the Bishop Tuttle Memorial Fund was raised. It is a charming house fitted in every way for its purpose, i. e. to be a home where missionaries on furlough and those preparing for such service can live while pursuing their studies in New York. The library and tiny chapel have been fitted up by devoted friends of Miss Tillotson as a memorial to her. The head of the House, Miss Adele Lathrop, gave up a position as head mistress of a large private school to come and give her life and her great abilities to the service of God at Winham House. There are now eight students in residence preparing for their work in the Church.

Let us be loyal and brave in facing the old and the new tasks. Let us harbor no prejudices against adventures we may be called upon to make. No undertaking is too great or too difficult if it is for the glory of God and the benefit of our fellow men.

Unanimously carried.

Mrs. Morse made her final report for the Triennial, the total U. T. O. being \$30,404.88.

Miss Tappan reported a total of \$1,925.91 for the Corporate Gift and explained the objectives of the new Corporate Gift. The Nominating Committee presented the following ticket: Vice President, Upper Division, Elizabeth District—Mrs. Clarence S. Wood, of Roselle, 1929-1930. Monmouth District—Mrs. Arthur Smith, Long Branch, 1929-1932. Lower Division, Woodbury District—Miss Mary Louisa Whitall, Woodbury, 1929-1932.

Treasurer—Mrs. Franklin S. Chambers, New Lisbon, 1929-1932.

Treasurer of the United Thank-Offering—Mrs. Samuel G. Welles, Trenton, 1929-1932.

There being no other nominations, the Secretary was instructed to cast the ballot and the ticket was declared elected.

Mrs. Stockett, Chairman of the Committee on the G. F. S. Challenge, presented a report and the committee was continued.

THE REPORT OF THE UNITED THANK OFFERING.

Once more we have had a great United Thank Offering Service and presented the Offering of the Women of the Church.

On Oct. 11th, 1928, at the National Cathedral in Washington—the first service ever held in the Cathedral—the Women presented an offering of \$1,101,450.40.

Of that amount the Women of New Jersey gave \$30,404.88. This was an increase of \$5,084.39 over our Offering three years ago.

One hundred and fourteen Parishes and Missions had a share in this Offering, ten more than were reported three years ago, and this increase is a real cause for thanksgiving.

Another cause for thanksgiving is the Offering received from some of the Institutions.

The Masonic Home, Burlington, sent an Easter Offering of \$15.00. The Parker Memorial Home of New Brunswick also sent an Offering of \$12.25.

There was a little "Blue Box" in the living room of the G. F. S. Holiday House at Island Heights last summer, and the Girls made an Offering of \$2.00.

More and more the Girls' Friendly Society is having a share in the Offering and in several Parishes the girls are sending in their regular semi-annual Offering.

Four Parishes gave over one thousand dollars during the Triennial.

Several others came almost up to that amount.

Since the Triennial Service the sum of \$30.00 has been received and this will count on the Spring Offering of 1929.

CONSTITUTION AND BY-LAWS OF THE
NEW JERSEY BRANCH OF THE WOMAN'S AUXILIARY
TO THE NATIONAL COUNCIL

Article I—Name

The name of this Society shall be "The New Jersey Branch of the Woman's Auxiliary to the National Council."

Article II—Object.

The object of this Society is to interest all women in the Missionary, Social and Educational work of the Church, to deepen the spiritual life of its members, and to encourage increased offerings for the spread of the Gospel of Christ.

Article III—Officers.

The officers of this Society shall be a President, one Vice-President for each District of the Diocese, a Recording Secretary, a Corresponding Secretary, a Treasurer, a United Thank-Offering Treasurer, an Educational Secretary, a Supply Secretary and a Devotional Secretary.

All the above-named officers except the Recording Secretary shall be elected triennially to serve for a term of three years and shall not be eligible for more than two consecutive terms.

The Recording Secretary shall be appointed by the President for the duration of her term.

The Diocesan Director of the Church Periodical Club shall be appointed by the Bishop.

Article IV—Executive Board.

The Executive Board shall consist of the above-named officers. Seven members shall constitute a quorum.

Vacancies on the Board shall be filled by the President for the unexpired term.

No officer shall at any time hold more than one office.

Article V—Representation.

Any parish organizing a branch of this Society shall notify both Recording and Corresponding Secretaries of the names and addresses of their officers.

Article VI—Amendments.

The Constitution may be amended by a two-thirds vote at any Annual Meeting, when such amendments have previously been submitted in writing and approved by the Executive Board, and read at an Upper, Central and Lower Division meeting.

The By-laws may be amended by a two-thirds vote at any Annual Meeting or at Upper, Central and Lower Division meetings.

BY-LAWS

I.—Duties of Officers.

1. The President shall preside at all meetings, have a general oversight of all branches of the work and perform such other duties as usually appertain to that office. The President shall appoint a member of the Board to preside at any meeting in case of her enforced absence.

2. The presidents of the Districts shall be nominated as vice presidents of the New Jersey Branch of the Woman's Auxiliary and elected by the Annual Meeting. They shall be responsible for carrying out in their Districts the policies of the Executive Board.

3. The Recording Secretary shall call the roll at all meetings, prepare and read the Minutes, prepare the Annual Report, and perform all duties belonging to the office.

4. The Corresponding Secretary shall send to the Rectors, Diocesan Officers and Parochial Secretaries notices of each Division Meeting and to the Officers notices of Executive Board Meetings. She shall make an Annual Report of the same.

5. The Diocesan Treasurer of the Auxiliary shall take charge of all moneys raised by the Auxiliary, except for the United Thank-Offering, for the Church Mission of Help, for the Evergreens and for the Church Periodical Club, which should be sent to their respective Treasurers.

6. The Treasurer of the United Thank-Offering shall take charge of all moneys contributed for that object.

7. The Educational Secretary shall have charge of the promotion of Mission Study and other forms of Adult Religious Education among the women of the Diocese.

8. The Chairman of the Devotional Committee shall make arrangements for Corporate Communions and the Days of Devotion for the Auxiliary throughout the Diocese.

9. The Supply Secretary shall have charge of all Missionary Allotments and of the Church Pantry.

II.—Meetings and Collections.

The Annual Meeting of this Society shall be held in January.

There shall be meetings of the Upper, Central and Lower Divisions of the Diocese in the Autumn and Spring in order to stimulate the various forms of work of the Auxiliary.

The Lower Division shall consist of the Districts of Atlantic City, Woodbury and Camden. The Central Division shall consist of the Districts of Burlington, Trenton and New Brunswick. The upper Division shall consist of the Districts of Elizabeth, Plainfield and Monmouth.

III.—Finances.

The finances of this Society shall be administered by a committee, consisting of five members of the Board, to be elected by the Executive Board, the President and Treasurer being members ex officio.
