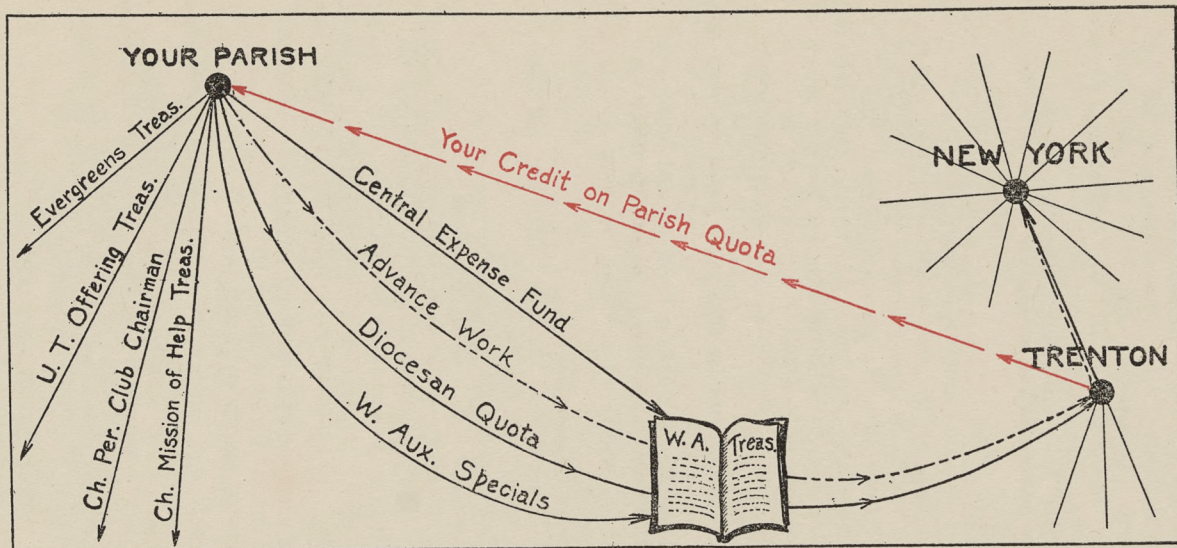

PRESIDENT'S ADDRESS.

The outstanding event of the year 1930 has been Pearl Keller's gift of herself to missionary work, and the fine co-operation of the Auxiliary branches in providing her equipment.

In other work the record of the past year shows spiritual rather than material advancement. A new branch has been organized at St. Alban's, New Brunswick, but to offset this gain Rancocas and Clementon have disbanded. Our gifts are about the same as in 1929. I am much encouraged, however, by the deepening interest in personal religion and by the sympathy shown the problem of enlisting young women.

For this new year an important step was taken at the recent Executive Board meeting. As Auxiliary to the National Council, we are Auxiliary to the Board of Social Service, just as much as we are to the Board of Missions and the Board of Religious Education. We have never officially recognized this fact in our organization, and as the Board felt that it was time to do so, they authorized your President to appoint a Chairman of Social Service for the year 1931. If the experiment is a success the by-laws can be amended to authorize the election of a Social Service Secretary.

I trust that this is the fore-runner of real advancement during 1931. If during the past year we have learned to keep in closer touch with our Master, this year we will have greater power to use in His service. May we sing throughout the year as we sang at the close of the service this morning:

"Through days of preparation
Thy grace has made us strong,
And now, O King Eternal,
We lift our battle song."

I like to think of the Church and the Auxiliary as a great industrial plant. The Church being the power house and the Auxiliary the factory, where, working cooperatively, we turn the power into "deeds of love and mercy."

I pray that this year we keep so closely connected to the power house that our output far exceeds our former records.

"Lead on, O King Eternal,
The day of march has come;
Henceforth in fields of conquest
Thy tents shall be our home."

During the last Triennial, we in New Jersey were praying for the "Gift of Life," that a young woman from our Diocese might offer herself for service in the mission field. It is a cause for thankfulness that Miss Pearl Keller has offered herself, and is now at work in Liberia.

I have tried to interest women in the parishes and missions, which have not given before. In addition to the two which I reported last year, there have been ten other parishes which have taken blue boxes for the first time and most of these have already sent in their first offering. Much literature has been sent out and a great many letters written. I have gone in person and spoken on the subject of the United Thank Offering at thirty-four meetings.

Please note that the report of the money given by each parish for the past year is in the tabulated financial statement at the back of this report. The summary only is given on this page. This money has been given not only by one hundred and four parishes and missions but by the Girls' Friendly Society, by people in our public institutions, and by individuals. Please note the item of Bank interest. This should encourage us to be prompt in sending in our offerings each spring and fall.

There has been an increase in the number of subscriptions to The Spirit of Missions, particularly in the Parishes of Holy Comforter, Rahway; St. Paul's, Camden, and St. Mary's, Burlington.

Forty-six parishes have reported something educational; program meetings, readings, Current Events, Bible classes, pageants, speakers, exhibits and lantern slides.

Discussion classes have been held in 22 parishes on the following subjects: The Mission study book; "Roads to the City of God," The Church's Program, Personal Religion, Social Service, Gospel of St. Mark, Progress of World Wide Missions, The Prayer Book, Missions and The Church's Ways.

**CONSTITUTION AND BY-LAWS OF THE
NEW JERSEY BRANCH OF THE WOMAN'S AUXILIARY
TO THE NATIONAL COUNCIL**

Article I—Name.

The name of this Society shall be "The New Jersey Branch of the Woman's Auxiliary to the National Council."

Article II—Object.

The object of this Society is to interest all women in the Missionary, Social and Educational work of the Church, to deepen the spiritual life of its members, and to encourage increased offerings for the spread of the Gospel of Christ.

Article III—Officers.

The officers of this Society shall be a President, one Vice President for each District of the Diocese, a Recording Secretary, a Corresponding Secretary, a Treasurer, a United Thank-Offering Treasurer, an Educational Secretary, a Supply Secretary and a Devotional Secretary.

All the above-named officers except the Recording Secretary shall be elected triennially to serve for a term of three years and shall not be eligible for more than two consecutive terms.

The Recording Secretary shall be appointed by the President for the duration of her term.

The Diocesan Director of the Church Periodical Club shall be appointed by the Bishop.

Article IV—Executive Board.

The Executive Board shall consist of the above-named officers. Seven members shall constitute a quorum.

Vacancies on the Board shall be filled by the President for the unexpired term.

No officers shall at any time hold more than one office.

Article V—Representation.

Any parish organizing a branch of this Society shall notify both Recording and Corresponding Secretaries of the names and addresses of their officers.

Article VI—Amendments.

The Constitution may be amended by a two-thirds vote at any Annual Meeting, when such amendments have previously been submitted in writing and approved by the Executive Board, and read at an Upper, Central and Lower Division meeting.

The By-laws may be amended by a two-thirds vote at any Annual Meeting or at Upper, Central and Lower Division meetings.

BY-LAWS

I.—Duties of Officers.

1. The President shall preside at all meetings, have a general oversight of all branches of the work and perform such other duties as usually appertain to that office. The President shall appoint a member of the Board to preside at any meeting in case of her enforced absence. In the event of the death or resignation of the President, the Secretary shall call a meeting of the Board to elect a President, preferably from their number, for the unexpired term.

2. The Presidents of the Districts shall be nominated as Vice Presidents of the New Jersey Branch of the Woman's Auxiliary and elected by the Annual Meeting. They shall be responsible for carrying out in their District the policies of the Executive Board. When a Vice President is unable to attend a Board Meeting she may send the Vice President of her District who shall be entitled to vote.

3. The Recording Secretary shall call the roll at all meetings, prepare and read the Minutes, prepare the Annual Report, and perform all duties belonging to the office.

4. The Corresponding Secretary shall send to the Rectors, Diocesan Officers and Parochial Secretaries notices of each Division Meeting and to the Officers notices of Executive Board Meetings. She shall make an Annual Report of the same.

5. The Diocesan Treasurer of the Auxiliary shall take charge of all moneys raised by the Auxiliary, except for the United Thank-Offering, for the Church Mission of Help, for the Evergreens and for the Church Periodical Club, which should be sent to their respective Treasurers.

6. The Treasurer of the United Trank-Offering shall take charge of all moneys contributed for that object.

7. The Educational Secretary shall have charge of the promotion of Mission Study and other forms of Adult Religious Education among the women of the Diocese.

8. The Devotional Secretary shall make arrangements for Corporate Communion and the Days of Devotion for the Auxiliary throughout the Diocese.

9. The Supply Secretary shall have charge of all Missionary Allotments and of the Church Pantry.

II.—Meetings and Collections.

The Annual Meeting of this Society shall be held in January.

There shall be meetings of the Upper, Central and Lower Divisions of the Diocese in the Autumn and Spring in order to simulate the various forms of work of the Auxiliary.

The Lower Division shall consist of the Districts of Atlantic City, Woodbury and Camden. The Central Division shall consist of the Districts of Burlington, Trenton and New Brunswick. The upper Division shall consist of the Districts of Elizabeth, Plainfield and Monmouth.

The following parishes were represented, numbering sixteen: St. John's, Trinity, and Christ Church, Elizabeth; St. Peter's, Perth Amboy; Grace, Plainfield; St. Mary's, Burlington; St. John's, Salem; St. Michael's, Trenton; Christ Church, South Amboy; All Saints', Scotch Plains; Trinity, Princeton; Christ Church, Shrewsbury; Holy Comforter and St. Paul's, Rahway; Christ Church and St. John's, New Brunswick.

The meeting was called to order by the Rev. Erskine M. Rodman, Dean of the Convocation of New Brunswick. After the singing of a hymn, and prayer by the Rev. Mr. Rodman, Miss Emery addressed the ladies, explaining to them the work of the "Woman's Auxiliary to the Board of Missions" with its various branches, and the effort now being

made to systematize and simplify the missionary work in the different States, &c.

The ladies were called upon to report any missionary work in their different parishes, with quite a satisfactory result.

Miss Emery proposed the nomination of some lady to take the head of the work in the Diocese of New Jersey. It was moved and seconded that Mrs. Scarborough be nominated for the position. This being put to the vote Mrs. Scarborough was unanimously elected.

Mrs. Foot, of Elizabeth, Mrs. Conover of Princeton, and Mrs. Tiffany of Plainfield, were nominated as Vice Presidents to assist Mrs. Scarborough.

Miss Emery nominated Miss C. M. Taylor as Secretary, which was seconded, and the election duly made.

Miss Emery requested the ladies to report to their rectors the action of the meeting, and desired if possible that the present delegates should continue to serve, as they had now become familiar with the subjects under consideration.

It was proposed to hold another meeting in January next, to take further steps toward the completion of a Diocesan organization.
