EIGHTH ANNUAL REPORT
OF THE
NIOBRARA LEAGUE.
1879-'80.

THE Annual Meeting of the Niobrara League was held on the 6th of November, 1879, in the Sunday-school room of the Church of the Transfiguration, and the work of the season was begun by the election of officers for the ensuing year.

Forty parishes and three local organizations were represented in the League during the season.

Twenty-five of the Scholarships in the Indian Schools are now entirely supported by Sunday-schools or individuals connected with the League.

The work undertaken during the season, to which all money not otherwise designated was applied, was the support of the ladies working among the Indians in Niobrara. The amount contributed provided for seven of these.

By the contributions of the League a Rectory for the Red Cloud Mission, Pine Ridge Agency, was built and furnished. Some money was given for a log Church and for other work at White Earth Reservation, Minnesota; a contribution was made to the Welsh Memorial Church, and the salary and the support of one of the clergy at Pine Ridge for one year was assumed by a member of the League.

It may be as well to mention here that \$600 will support a clergyman at one of the outposts for a year. \$360 will support a catechist for one year, and \$500 will support a lady for one year.

A full report of boxes sent during the year accompanies this. To the Christmas boxes, children from all parts of the country contributed.

Several of the monthly meetings of the League were rendered particu-

lary interesting and attractive by the presence of the Bishop of Niobrara, and by his reports of the work. At the meeting in January, the Rev. Amos Ross, a Santee deacon, read to those present an English paper written by himself, and afterwards spoke in Dakota, interpreted by a Dakota youth now in Trinity College, Hartford. The paper is published with this report.

A full list of Scholarships is presented, with the dates of their establishment.

The Christmas boxes of this year are also reported.

CONSTITUTION.

ARTICLE I.

This Association shall be called THE NIOBARA LEAGUE.

ARTICLE II.

Its object shall be to work, in connection with the Woman's Auxiliary to the Board of Missions, in aid of the Indian tribes in our land, especially those under the jurisdiction of the Bishop of Niobrara. The methods by which the ends of this organization can be promoted are: the raising of money for the support of Missionaries and teachers, for the education of those who may be preparing for the work, and for other benevolent purposes connected with the Mission; the making, collecting and transfer of clothing and other material aid; and the publication of papers and pamphlets that may serve to stir up a public interest in the welfare of the Indian.

ARTICLE III.

The Association shall consist of all persons who shall contribute to the Treasury thereof, annually, the sum of at least one dollar. Any one may be constituted a Life Member by the payment at one time of the sum of one hundred dollars.

ARTICLE IV.

The Officers of this Association shall be a President, two Vice-Presidents, a Secretary, and a Treasurer; who, with two ladies from each Parish represented in the Association, shall constitute a Board of Managers, whose duty it shall be to regulate the affairs of the Association, and, under the supervision of their Rectors, to further its work in the Parishes to which they respectively belong.

ARTICLE V.

It shall be the duty of the President to preside at all Meetings of the Association and of the Board of Managers; to call Special Meetings of the same when occasion shall arise; and to present to the members of the Association such objects for their interest and contributions as shall have been approved by the Committee in charge of Indian Missions.

ARTICLE VI.

It shall be the duty of the Vice-President to preside in the absence of the President; to make special efforts to interest such Parishes of the

Diocese as are not already represented in the League, in the work of the Association ; to obtain from the Secretary of the Woman's Auxiliary fresh information from our Indian Missions, and to read the same at the Stated Meetings of the Board.

ARTICLE VII.

It shall be the duty of the Secretary to keep the Minutes and conduct the correspondence of the Association and of the Board of Managers ; to send out all notices of the Stated and Special Meetings of the same ; and to prepare an Annual Report.

ARTICLE VIII.

It shall be the duty of the Treasurer to receive and keep account of all money contributed for the work of the Association ; to pay over, after each Meeting, to the Treasurer of the Committee in charge of Indian Missions all funds, excepting such undesignated amounts as shall be needed for printing, postage and other incidentals, with a written explanation of the distinct purposes for which such offerings are destined ; to present a Report at each Stated Meeting ; and to prepare an Annual Report to be printed with the Annual Report of the Secretary.

ARTICLE IX.

This Constitution shall not be altered except at an Annual Meeting of the Association—notice of the proposed change having been given at a Stated Meeting of the Board of Managers.

B Y - L A W S .

I.

There shall be an Annual Meeting of the Association on the first Thursday of November in each year, at such hour and place as the President and Secretary shall agree upon.

II.

The Officers of this Association shall be elected by ballot, at the Annual Meeting, and shall continue in office for one year, or until their successors shall have been elected.

III.

In case of the vacancy of any office, by the death or removal of its occupant, the same may be filled at a Stated Meeting of the Board of Managers ; and any one so elected shall continue in office until the next Annual Meeting of the Association.

IV.

Every Parish in the Diocese is entitled to send two Delegates to the Board of Managers. The Delegates shall be responsible for the representation of their Parish at every Stated Meeting.

V.

The Stated Meetings of the Board of Managers shall be on the first Thursday of each month from November to May inclusive.

VI.

The Order of Business shall be as follows.

Prayers.

Reading of Minutes.

Treasurer's Report.

Roll Call, with Reports from Delegates.

Miscellaneous Business.

Address, or Reading of Letters.

Prayers.

VII.

At a Meeting of the Board of Managers any number present shall constitute a quorum for the transaction of business; and at the Annual Meeting of the Association, a number of members equal to one-half the number of Parishes represented in the League shall constitute a quorum for the election of Officers.

ADDRESS OF AN INDIAN DEACON.

The following is an address prepared by Rev. Amos Ross, an Indian Deacon of the Santee Sioux tribe, and read by him before several societies at the East.

He has been in Deacon's orders for two years, and has done good service, under the Rev. W. W. Fowler, in the Santee Mission.

Bishop Hare was able to send him East at the close of December last, that he might learn English and see something of the white man's life. The Rev. Geo. Walker, of Peabody, Mass., kindly received him into his house, and instructed him; and afterward he enjoyed the kind care of the Rev. T. S. Rumney, D.D., of Germantown, Philadelphia.

He has assiduously improved his opportunities, and is now able to receive and convey ideas in the English tongue, and feasts with avidity on the treasures laid up in English books, from which until recently he was shut off.

My CHRISTIAN FRIENDS :

I am going to say a few words, though I can not speak well in your language.

I am a Sioux Indian, and my tribe is call Santee. I suppose you have heard from us sometimes, and that many of the Santee have become Christians. My friends, that is true; all my people wear the same dress, same as you have, and we have God's House, as you have, and we are working on the farms, as you are working yours; but my friends, you know who is rich, he has everything good; but we are Indian, all are poor, and everything we have, not very good.

I came here to visit my Christian people, and everything makes my heart glad; the people are all glad to see me, and when I see the gifts to the poor Indian, that is what makes my heart glad, and I could not tell how many times I give thanks to God, and to you, for you are a good people at the East. And more than this, I thank you for giving to us God's Word, and we know who is our Saviour now. Jesus, the Son of God, He is our Saviour.

When we have come to Easter day, we have great joy, and we give praise to God; our Saviour is good, and to save us, was given up to suffer death upon the Cross for us.

My friends, I am going to tell you, how I have worked in God's Church, among my own people. Every Sunday I have preached; we have three Chapels, seven and twelve miles distant, and sometimes I go to one and another of these Chapels. I ride on horseback, and come back

the same day, and we have day school ; so I teach every day, and we have young men's meeting every Friday night, and sometimes I go to see the sick people, and pray with them ; whatever I can do for God's Church, I am always glad to do.

When Andrew first found Jesus, he went to tell his brother, Simon Peter, and saith unto him, we have found the Messias, and brought him to Jesus, and Peter saw Jesus ; so, my friends, I want to do as Andrew did. Many of the Sioux Indians have not come to God's Church ; but every year they come in more and more.

Last Summer I went with my Bishop, to the different tribes of Sioux Indians, and always I went to tell God's Word ; not only to God's House, but sometimes I go round to visit the Indian Tipi, and I tell of Jesus' love there too. Some like to hear, and some don't. My friends, that is all I can say.

CONSTITUTION

OF THE

NIOBRA RARA LEAGUE.

ARTICLE I.

THIS Association shall be called "THE NIOBRA RARA LEAGUE."

ARTICLE II.

Its object shall be to work in connection with the Woman's Association Auxiliary to the Board of Missions in aid of the Indian tribes in our land, especially those under the jurisdiction of the Bishop of Niobrara.

ARTICLE III.

The Association shall consist of all persons who shall contribute to the Treasury thereof, annually, at least the sum of one dollar. Any one may be constituted a Life Member by the payment at one time of the sum of one hundred dollars.

ARTICLE IV.

The Officers of this Association shall be a President, Vice-President, Corresponding Secretary, Recording Secretary and Treasurer; the Corresponding Secretary to be always the Secretary of the Woman's Auxiliary, and the Treasurer the Secretary of the Indian Commission. There shall be, moreover, a Board of Managers, consisting of the above-named Officers and of two Ladies from each parish represented in the Association, whose duty it shall be to regulate its affairs, and, under the supervision of their Rectors, to further the work of the Association in the parishes to which they respectively belong. The methods by which the ends of this organization can be promoted are, the raising of money for the support of Missionaries and teachers, for the education of those who may be preparing for the work and for other benevolent purposes connected with the Mission; the making, collecting and transfer of clothing and other material aid; and the publication of papers and pamphlets that may serve to stir up a public interest in the welfare of the Indian.

ARTICLE V.

It shall be the duty of the President to preside at the business meetings of the Association and of the Board of Managers; to call special meetings of the same when occasion shall arise, and to countersign all drafts upon the Treasurer.

ARTICLE VI.

It shall be the duty of the Corresponding Secretary to conduct the correspondence of the Association, especially that with the Christian women employed in the Indian Missions in Niobrara and elsewhere; and to furnish fresh information from such Missions to be read at the stated meetings of the Board.

ARTICLE VII.

It shall be the duty of the Recording Secretary to keep minutes of the proceedings of the Association and of the Board of Managers; to send out all notices of the stated and special meetings of the same; and to prepare an Annual Report.

ARTICLE VIII.

It shall be the duty of the Treasurer to receive and keep account of all moneys and materials contributed for the work of the Association, and to pay all drafts upon the funds when countersigned by the President.

ARTICLE IX.

This Constitution shall not be altered except at an annual meeting of the Association—notice of the proposed change having been given at a stated meeting of the Board of Managers.

BY-LAWS.

I.

There shall be an Annual Meeting of the Association on the second Thursday of November in each year, at such hour and place as the Corresponding Secretary, with the advice of the President, shall indicate.

II.

The election of Officers and of the Board of Managers shall take place at such meeting, and they shall continue in office for one year, or until their successors shall have been appointed.

III.

In case of the vacancy of any office, by the death or removal of its occupant, the same may be filled at a stated meeting of the Board of Managers; and any one so elected shall continue in office until the next annual meeting of the Association.

IV.

The stated meeting of the Board of Managers shall be on the second Thursday of each month.

V.

At a meeting of the Board of Managers any number present shall constitute a quorum for the transaction of business; and at the annual meeting of the Association, a number of members equal to one-half the number of Parishes represented therein, shall constitute a quorum for the transaction of business.

Almighty and most merciful God, the Father of the friendless and the Helper of the helpless, have pity, we beseech Thee, upon the Indian tribes who dwell in this our land. Guide with Thy SPIRIT—guard with Thy power—sustain with Thy love, all those who minister to them in spiritual things, and bear to them the tidings of redemption. Stir up the hearts of all who profess and call themselves Christians, to prayer and deeds of mercy in behalf of this perishing race.
