# Constitution

## OF THE NEW YORK BRANCH OF THE WOMAN'S AUXILIARY TO THE BOARD OF MISSIONS,

AS APPROVED BY THE STANDING COMMITTEES MAY 11th, AND  
ADOPTED ON THE APPROVAL OF THE BISHOP, JUNE 1st, 1900.  
AMENDED APRIL 28th, 1902, AND NOVEMBER 15th, 1905.

---

### ARTICLE I.—NAME.

The name of this Association shall be the New York Branch of the Woman's Auxiliary to the Board of Missions.

### ARTICLE II.—OBJECT.

The object of this Association shall be to carry out within the Diocese of New York the purposes and work of the Woman's Auxiliary as approved by the Board of Missions.

### ARTICLE III.—MEMBERSHIP.

All Churchwomen and children by virtue of their Baptism are considered possible members of the Woman's Auxiliary. All those, who, in this Diocese, by their prayers, work or offerings, aid the missions of the Church, are recognized as actual members of the New York Branch.

### ARTICLE IV.—OFFICERS.

1. The officers of this Association shall be a President, a Vice-President, a Secretary, an Assistant Secretary, a Treasurer, and a Treasurer for the United Offering, who shall be elected by ballot by the Representative Body at their May meeting, and shall hold their offices for one year and until the election of their successors.

2. The President shall preside at all meetings of this Association, of the Representative Body, and of the Executive Board.



3. The Vice-President shall preside in the absence of the President.

4. The Secretary shall keep the minutes of the Association, of the Representative Body, and of the Executive Board; shall have the custody of their records; conduct their correspondence; issue notices of their meetings; prepare and edit the annual report; and shall perform such other duties as shall be assigned to her by the Representative Body or by the Executive Board.

5. The Assistant Secretary shall assist the Secretary in the performance of her duties.

6. The Treasurer shall receive, disburse and keep account of all moneys contributed for central expenses, and all funds not specified as for the Standing Committees. Her accounts, and those of the Treasurer of the United Offering, shall be audited annually by an auditing committee, to be appointed in conformity with the By-Laws, who shall report to the Executive Board.

7. The Treasurer for the United Offering shall receive all contributions for the United Offering of the Woman's Auxiliary; and, under the direction of the Executive Board, endeavor to arouse and increase an interest in the same.

#### ARTICLE V.—REPRESENTATIVE BODY.

1. The officers of the Standing and Archdeaconry Committees and the general officers shall constitute the Representative Body of this Association, which shall meet annually on such day in May as the Executive Board may appoint, and shall then elect the general officers and transact the business of the Association; and may meet at other times on the call of the Executive Board.

2. To constitute a quorum at the annual meeting at least one officer from each Committee must be present.

#### ARTICLE VI.—EXECUTIVE BOARD.

1. There shall be an Executive Board composed of the six general officers of the Association, the chairmen of the five Standing Committees, and a representative elected by each of the Archdeaconry Committees.



The chairmen of the Standing Committees and the representatives of the Archdeaconry Committees may appoint a substitute to attend any meeting of the Board in their absence with power to vote.

2. The Executive Board shall have power to adopt By-Laws; to fill vacancies occurring on the resignation or death of general officers; and, subject to the control of the Representative Body, shall exercise all the powers of the Association not otherwise herein expressly provided for.

ARTICLE VII.—STANDING COMMITTEES.

1. There shall be five Standing Committees of this Association for the furtherance of its work in relation respectively to Foreign Missions, Domestic Missions, Indian Missions, Missions to Colored People, and the Junior Department.

2. Each Committee shall be composed of two or more delegates from each parish or organized chapel in the Diocese. Each parish or chapel shall be entitled to one vote.

3. Each Standing Committee shall annually elect a chairman and such other officers as it may determine, and shall have power to adopt By-Laws not inconsistent with the Constitution or By-Laws of this Association.

4. Each Standing Committee shall annually, on or before June 1st, send to the Executive Board a written report of its proceedings for the year, including a copy of the report of its treasurer.

ARTICLE VIII.—ARCHDEACONRY COMMITTEES.

1. In each Archdeaconry an Archdeaconry Committee may be constituted for the furtherance of the objects of this Association within the Archdeaconry in co-operation with the Standing Committees.

2. Such Committees shall be composed of delegates from the parishes and organized chapels within the Archdeaconry and shall elect a chairman and such other officers as they may determine, and shall have power to adopt By-Laws not inconsistent with the Constitution and By-Laws of this Association.



3. Each Archdeaconry Committee shall annually on, or before June 1st, send to the Executive Board a written report of its proceedings for the year.

#### ARTICLE IX.—AMENDMENT.

This Constitution, having been approved by the Bishop, may be amended with his approval by a two-thirds vote of members of the Representative Body at its annual meeting, notice of the proposed amendment having been given at a previous meeting. This vote must include a majority of representatives of both the Standing and Archdeaconry Committees.

#### ADVENT MEETING.

Advent Meeting, formerly called the "Bishop's Meeting," the first Wednesday in Advent of each year, the Bishop of the Diocese presiding.

## PRAYERS.

### For the Woman's Auxiliary.

O LORD, without whom our labor is but lost, and with whom Thy little ones go forth as the mighty; we humbly beseech Thee to prosper all works in Thy Church undertaken according to Thy holy will (especially the work of the Woman's Auxiliary), and grant to Thy laborers a pure intention, patient faith, sufficient success upon earth, and the blessedness of serving Thee in Heaven; through Jesus Christ our LORD. *Amen.*

ALMIGHTY GOD, of whose only gift it cometh that Thy faithful people do unto Thee true and laudable service, we pray Thee so to dispose the hearts of Thy servants that they may freely give of their substance for the increase of Thy Kingdom, and the salvation of all men; through Jesus Christ our LORD. *Amen.*

### For the Church.

O GOD, who buildest for Thy Majesty an eternal habitation out of living and elect stones; assist Thy suppliant people, that as Thy Church increaseth in outward strength it may also be enlarged by spiritual increase; through Jesus Christ our LORD. *Amen.*

### For Missions.

ALMIGHTY GOD, who, by Thy Son Jesus Christ, didst give commandment to the holy Apostles, that they should go into all the world, and preach the Gospel to every creature; grant to us whom Thou hast called into Thy Church a ready will to obey Thy Word, and fill



us with a hearty desire to make Thy way known upon earth, Thy saving health among all nations. Look with compassion upon the heathen that have not known Thee, and on the multitudes in our own land that are scattered abroad as sheep having no shepherd. O Heavenly Father, LORD of the harvest, have respect, we beseech Thee, to our prayers, and send forth laborers into Thy harvest. Fit and prepare them by Thy grace for the work of their ministry; give them the spirit of power, and of love, and of a sound mind; strengthen them to endure hardness; and grant that both by their life and doctrine they may show forth Thy glory, and set forward the salvation of all men; through Jesus Christ our LORD. *Amen.*

○ GOD, who hast made of one blood all nations of men for to dwell on the face of the whole earth, and didst send Thy blessed Son to preach peace to them that are far off and to them that are nigh; Grant that all men everywhere may seek after Thee and find Thee. Bring the nations into Thy fold, and add the heathen to Thine inheritance. And we pray Thee shortly to accomplish the number of Thine elect, and to hasten Thy Kingdom; through the same Jesus Christ our LORD. *Amen.*

*For Missionaries.*

○ LORD, who didst come to seek and to save the lost, and to whom all power is given in heaven and in earth, hear, we beseech Thee, the prayers of Thy Church for those who, at Thy command, go forth to preach the Gospel to every creature. Preserve them from all dangers to which they may be exposed; from perils by land and perils by water; from the deadly pestilence; from the violence of the persecutor; from doubt and impatience; from discouragement and discord, and from all the devices of the powers of darkness. And while they plant and water, send Thou, O LORD, the increase; gather in the multitude of the heathen, convert in Christian lands such as neglect so great salvation; so that Thy Name may be glorified and Thy Kingdom come, O gracious Saviour of the world; to whom, with the Father and the Holy Ghost, be honor and glory, world without end. *Amen.*

*For Indian Missions.*

○ MOST Merciful GOD, who hast promised that all those who dwell in the wilderness shall kneel before Thy Son, remember, we pray Thee, the Indian tribes of our land and all those who have gone to them in Thy Name. Guide and govern those who are put in civil or military authority over them, that the people may lead a quiet and peaceable life in all godliness and honesty. Set up and strengthen Thy Church among them, that they may all come to know Thee, the only true God,



and Jesus Christ, whom Thou hast sent. Endue its Ministers with Heavenly love and wisdom and make them ensamples to the flock. Sanctify the people. Preserve their marriages in peace and concord; nourish their infants; lead forward their youth; sustain their aged; comfort the weak-hearted; gather together the scattered; settle the roving; and knit them all together, working with their hands the thing that is good, in Thy Holy Church; through Jesus Christ our LORD. *Amen.*

HEAVENLY FATHER, we pray Thee to bless us and all members of the Junior Auxiliary with wisdom, zeal, and constancy, in our work for Thee. Prosper the missions of Thy Holy Church; and strengthen with Thy Holy Spirit all who are engaged in missionary work; through Jesus Christ our LORD. *Amen.*

## Report of the Executive Board.

### SECRETARY'S REPORT FOR 1905-06.

At the annual meeting of the Representative Body of the New York Branch of the Woman's Auxiliary, November 15th, 1905, several changes were made in the Constitution in order that the annual meeting of that body might be held in May instead of November. This change necessitates the closing of the year May 1st. Consequently, this report and that of the Archdeaconry of Westchester will this year cover a period of about six months only.

Last November at the executive meeting preceding the annual meeting of the Representative Body we were surprised and very sorry to learn that our President, Mrs. M. E. Watson, felt obliged to withdraw her name from the ballot already prepared for the election of General Officers. The Nominating Committee were fortunate in being able to obtain, before the election, the consent of Miss Margaret A. Tomes, Chairman of the Foreign Committee, as nominee in place of Mrs. Watson. We are glad that Mrs. Watson is able to continue on the Executive Board as Vice-President. To quote from the resolution passed at a special meeting of that Board: "In tendering to Mrs. Mary E. Watson our affectionate greetings as Vice-President, we, the members of the Executive Board of the New York Branch of the Woman's Auxiliary, desire to express our sincere appreciation of her faithful and loving service and, above all, her spiritual guidance during the past five years as President."

Miss Tomes, our new President, is an old friend, and returns to a work for which she labored so faithfully for six years as Secretary. To Miss Cornelia Delafield we owe our sincere thanks for her valuable work as Treasurer *pro tem.* during the whole year.

Miss Anne D. Duane was elected regular Treasurer.

As Chairman of the Foreign Committee, succeeding Miss



Tomes, we are especially glad to welcome Mrs. E. Walpole Warren.

The Advent meeting, held at St. Michael's Church on December 4th, was another of the enthusiastic and encouraging gatherings we have learned to expect as the first Wednesday in Advent comes around.

The programme was much as it has been for several years past, viz., a celebration of the Holy Communion with sermon at 10:30; mid-day session from 12:15 to 1; luncheon in the Parish House, and the afternoon session, also in the Parish House, at 2:30. The sermon was preached by the Rev. W. T. Manning, and addresses were made by the Rev. H. St. G. Tucker, the Rev. G. A. Strong and the Rt. Rev. David H. Greer. Bishop Greer was also the celebrant and presided throughout the day. The ladies of St. Michael's were most zealous and successful in making everyone welcome at lunch time.

During the afternoon addresses were made by Bishop Greer, the Rev. F. E. Lund, Miss Mahony, Mrs. J. L. Truslow, Jr., Miss Sorabji and Dr. Lloyd.

The attendance was large at all the sessions; the offering, \$409.34, was divided equally among the five Standing Committees. To many the long service, luncheon and afternoon session or, in other words, an "all-day" meeting, is wearisome; therefore, it is thought best to change the plan of the Advent meeting to half a day—or to return to the plan of the Bishop's meeting, as this Advent meeting was first called, and from which it developed. Not wishing, however, to give up our Corporate Communion, it was decided that this service should be held during Lent, the Advent meeting, as usual, on the first Wednesday in Advent, the Bishop of the Diocese presiding, and beginning with a short service at 10:30, followed by hymns and addresses, and finishing by lunch time.

The Corporate Communion was arranged for March 20th, at the Church of the Epiphany, at 10:30. The church was well filled. Everyone must have felt grateful for the spiritual sermon preached by the Rev. Floyd W. Tomkins, D.D., and "strengthen-



ened and refreshed" by the reverent celebration of the Holy Communion which followed. One of our officers well said: "There was nothing more to be desired." It was very encouraging and helpful to know, too, that our members of the Archdeaconry of Dutchess, many of whom were unable to come so far, had arranged for a similar service at the same time in Poughkeepsie.

The United Offering has prospered greatly under Mrs. Truslow's care. She reports 127 treasurers and \$6,391.80 in the bank.

The number of Mission Study Classes has increased very considerably. The Diocesan Class, held on Friday afternoons during Lent, was ably conducted by Miss Pelton, the subjects being "The Negro," "Work in Oklahoma," and "The Mormons." The reports of the other Study Classes are given by the Junior Department.

The annual report, or "Green Book," has become so large and expensive that it is thought necessary to make a decided effort to reduce it. We, therefore, have asked the Secretaries and Treasurers of the Standing and Archdeaconry Committees to shorten their reports as much as possible—the Secretaries' reports to be not over two pages and the Treasurers to omit individual names and unnecessary detail. Even with this reduction in the reports, it will be easy—even easier—to notice what good work has been done.

Aside from these statistics, the Committees report good attendance, and an increasing intelligent interest in, and knowledge of, the work the Church is doing.

OBJECT OF THE UNITED OFFERING OF 1907.

The regular monthly meetings of the Domestic Committee have been held regularly in the Diocesan House on the first Tuesday in the month at 10:45 A.M.

The average attendance has been eighty-seven.

The monthly reports handed in show that 151 boxes, with a total valuation of \$12,741.18, have been sent to various parts of our country.

The Life Insurance for the Bishop of Mexico and Arizona has been sustained and the Reserve Fund has enabled us to answer substantially the appeals of our missionary speakers.

The Pledge of the Committee for the travelling expenses of Bishop Keator, of Olympia, Bishop Gray, of Southern Florida, Bishop Morrison, of Duluth, Bishop Mann, of North Dakota, and Bishop Griswold, of Salina, amounting to \$1,500, was completed at the April meeting.

### THE SECRETARY'S REPORT FOR 1905-1906.

The meetings of the Niobrara League have been held during the past season at the Diocesan House on the first Thursday of each month at eleven o'clock. There are now ninety-two delegates to the League, representing forty-seven churches, and the attendance at the meetings has been satisfactory.

Ten boxes have been sent through the Niobrara League, valued at \$1,082, to missionaries at work among the Indians. Bishop Hare was present at the December meeting and gave an interesting account of the growth of his work. He said there were now 130 congregations to be visited. On November 2d the Rev. Frederick Foote Johnson was consecrated Bishop Coadjutor of South Dakota.

The other meetings of the Niobrara League have been addressed by Bishop Spalding, of Salt Lake City, by Miss Sybil



Carter, by Mrs. Munroe, representing the Indian Missions in the Diocese of New Jersey, and by the Rev. A. B. Clark, of Rosebud, S. Dak. The annual meeting was held in May, when the same officers were re-elected. The special work of the League during the year has been the support of scholarships, collecting money to build catechists' houses, and to assist in educating the sons of the white clergy.

## THE THIRTY-SECOND ANNUAL REPORT OF THE COMMITTEE ON WORK FOR FOREIGN MISSIONS.

"The love of Christ constraineth us."

In giving the annual report of our Foreign Committee we trust that the above motto, which we have for many years chosen as our own, may become more and more a moving spiritual force behind all the efforts we make in the missionary cause.

A change in the officers occurred during the season, owing



to the election of the Chairman, Miss Tomes, to be President of the New York Branch of the Woman's Auxiliary. A vote of thanks was passed to her for the services she had rendered the Committee during the time she had been with us, and we all wished her Godspeed in the sphere of wider influence to which she had been called. The Committee gave a warm welcome to Mrs. E. Walpole Warren, who kindly consented to become Chairman during the remainder of her term of office. We are already indebted to her for the suggestion that one of the clergy of the Diocese should be asked to come and give a short address before the opening of the business part of our meetings. Bishop Courtney, of St. James's Church, Dr. Grosvenor, of the Church of the Incarnation, the Rev. Cornelius B. Smith, and the Rev. J. Freeman, of St. Andrew's Church, Yonkers, have each spoken most helpful words on the spiritual aspect of missionary work, and we are very grateful for the effort they have made to help us.

Our promise to make an earnest endeavor to raise the definite sum of \$4,000 under the title of a Pledge has not been so successful as usual this year. A few hundred dollars were contributed during the first months of the season to finish the sum needed for the Cornelia Jay Ward of St. Luke's Hospital, Tokyo, and toward the Foreign Insurance Fund, both of which were part of last year's Pledge. It is now considered best not to carry our Pledge on from one year to another, but to close our books in April each year, with the understanding that we leave undone that which we have been unable to raise before that date. This united effort of our whole Committee has been a source of great enthusiasm and encouragement in the past, besides being a means of learning more definitely about certain fields of work, and it is hoped that greater interest will be aroused in it next year.

Our special speakers during the year have been Miss Ewart, a member of the Zenana Missionary Society, who has been working for fifteen years at her own expense amongst the Mohammedans in Madras and is at present head of a Training House for

# Treasurer's Report

JANUARY 16, 1906



ALTHOUGH it is now the 16th of January, and two weeks of the year 1906 have already gone, it is not too late to wish you all a Happy New Year, and to pray that the coming months may bring you many blessings. Since the last Roll Call there have been several changes in the list of names. We are sorry to drop the old names, but gladly welcome the new. All Souls parish has ceased to exist, so Miss Duane, Treasurer of that parish is no longer one of us. Miss Phoebe W. Bockee, Treasurer for the Archdeaconry of Dutchess, has entered into the Rest of Paradise. It was my pleasure and privilege to meet her this Autumn at the Archdeaconry meeting held at Christ Church, Red Hook, for the first and only time, though I felt that I knew her through our correspondence. She will be sadly missed in her Archdeaconry, and I shall miss her sympathy and her great interest in the work. Her sister, Miss Mary Bockee, has consented to take up the work for the present.

We are meeting for the third time since we began to gather in the gifts, large and small, for the Offering of 1907. We are well started on our second years' work. What has been accomplished during the first year, and what are we planning to do during the present year? Have we been faithful in the discharge of our duties as Treasurers in our several parishes? Have we taken upon ourselves the duties of Treasurers without any idea of our responsibilities, or have we done our very best to bring the knowledge of our Offering to the women in our parishes, have we given



to it ourselves, and have we interested others and induced them to give?

In a letter that Miss Emery has just sent out to the more than nine hundred Diocesan Officers of the Woman's Auxiliary, she says: "Above all things, remember that, in consenting to become a Diocesan Officer, you have assumed a *personal responsibility*, and that this responsibility cannot be better exercised than by trying in every way that lies in your power, and by every exercise of persuasive Christian skill, to acquaint the unintelligent and uninterested with the inspiring duty and serious privilege of sharing in our common enterprise."

This is exactly the idea that your Treasurer wants to impress upon her fellow Treasurers. Do not be persuaded to undertake the work unless you are willing to assume responsibility, and are ready to give of your best to the work. We must endeavor to be businesslike in our Church work; we must be methodical, energetic, prompt and full of enthusiasm. If we are not interested ourselves, we cannot interest others.

There is much of discouragement in all our work caused by the indifference and unbusinesslike methods of those who are in charge of the various branches of Church work. For months your Diocesan Treasurer has been trying to get a correct list of Parish Treasurers, but has not yet succeeded. Some names that appeared on the list a year ago have never been heard from by the present Treasurer. One name, put down as Parish Treasurer, has not been in the parish for several years. Another resigned over two years ago, but did not notify the Diocesan Treasurer, and her name continued on the list. During all these months and years, notices, leaflets and letters have been sent, necessitating a waste of time, strength and money. It is much worse for the work to have a Treasurer who does nothing, or who is indifferent, than to have no Treasurer at all. Where there is no Treasurer, the Diocesan Treasurer feels at liberty to communicate with the Rector and try to reach the women of the parish. If there is a Treasurer, of course the Diocesan Treasurer hesitates to interfere.



We must not dwell too much on the discouragements, for we have much to encourage us, and fill us with gratitude. Everywhere the interest is growing, and more and more names are being added to the list of women who will have their share in the Offering of 1907.

There are now 57 United Offering Missionaries working in the Domestic Field, 37 in the Foreign Field, 1 Student for the Domestic work in the New York School, and 1 for the Domestic and 2 for the Foreign work in the Philadelphia School, in all, 94 women workers, and 4 who are being trained for their work, supported by the United Offering of 1904.

The amount reported from the parishes, as follows, by no means represents the total amount collected up to date; it represents only the amount actually received by the Diocesan Treasurer. Many parishes prefer to keep their amount in the Savings Bank until the end of the three years, and thus increasing their amount by the interest accumulated. The Archdeaconry of Dutchess, and that of Orange, have Archdeaconry Treasurers who collect the money from their parishes, and hold it until the end.

I would remind you that the New York Banks charge ten cents for out of town checks. In sending out of town checks, please send check for the amount you wish credited to your account, and enclose ten cents in postage stamps. If the check is made out including the ten cents, it necessitates the Treasurer first having the check cashed in one Bank, and then depositing the proper amount in the Savings Bank.

A year ago there were 2 Archdeaconry Treasurers and 98 Parish Treasurers; now there are 2 Archdeaconry and 123 Parish Treasurers; there were 125, but one Church and one Mission have been closed. Unfortunately there were many parishes having Treasurers who gave nothing for 1904, and thus far there are many who have done nothing. For the Offering of 1904 there were many parishes without Treasurers who sent their contributions. We have less than two years, before we shall gather in Richmond with our next Offering; let us see to it that we waste no time. Do

Meem, who paid a warm tribute to the faithful and efficient services of Miss Packard. In January Miss Neely, from Akita, Japan, spoke of her evangelistic work, especially among the upper classes. She was the first missionary sent out under the United Offering Fund. Miss Hayashi, from Japan, said a few words through an interpreter. In February Mr. Lindstrom gave an address upon work in Gankin, China. In March Mr. Littell, from Hankow, China, aroused great interest in the working of our Church there in the power of Christianity to change the whole character of the Chinese. ## SIXTEENTH ANNUAL REPORT.

The St. Augustine League closes its sixteenth year of service with a sense of gratitude to all who have tried to help the work for colored people.

The meetings have been held, as usual, in the Diocesan House, 29 Lafayette Place, on the first Monday of each month at 10:30 A.M.

Although 100 names are enrolled upon the Secretary's books, the average attendance has been only thirty-five. With so large a number representing parishes the attendance should be better. Seven churches sending in the names of delegates have not once been represented at the meetings this year. The burden of work has thus fallen upon a few parishes who have most faithfully and generously responded to the demands made upon them and whose gifts are recorded in the Treasurer's report. The receipts for the year have been \$8,914.05. Sixteen (16) missionary boxes have been sent valued at \$922.96. Five scholarships (\$25 each) and one of \$50 have been given to St. Paul's School, Lawrenceville, Va.; two of \$50 each to St. Augustine's School, Raleigh, N. C.; four of \$150 each to Bishop Payne Divinity-school, Petersburg, Va.; two of \$25 each to the Industrial School of St. Mary the Virgin, Nashville, Tenn.; and two of \$150 each to Hoffman Hall, Nashville, Tenn. Besides these scholarships, \$600 is sent yearly to St. Paul's School, Lawrenceville, Va.; and the same amount to St. Augustine's School, Raleigh, N. C. Four hundred and eight dollars (\$408) have been raised to complete the Children's Ward in St. Agnes's Hospital, Raleigh, N. C., and the sum of \$300 was given toward the Apportionment.

The League desires especially to express its thanks to the clergy of the Diocese who have responded so cordially when invited to address the meetings and whose helpful words have been greatly appreciated. We have heard this winter the Rev. Dr. Huntington, the Rev. James Freeman, the Rev. Nelson P. Dame, the Rev. Mr. Bishop, the Rev. Charles L. Gompf, and



the Rev. Dr. Manning. The mission field has been represented by the Bishop of Florida, the Rev. Mr. Griffith, Archdeacon Russell, the Rev. C. B. Bryan, Archdeacon Hughson, the Rev. J. W. Johnson, and the Rev. P. P. Alston.

The St. Augustine League seems to have accomplished little when confronted by the magnitude of the Race Problem. It needs the constant prayers and earnest support of every parish in the Diocese of New York and the faithful and intelligent co-operation of Delegates. A recent writer has called the negro our "Neighbor." Surely, the service to those nearest to us is that which has been taught us by Him who "took upon Him the form of a servant," and "who humbled Himself unto death, even the death of the cross." In His Spirit and for His Sake let us work with renewed enthusiasm for the uplifting of the colored people.

The meetings of the Junior Department were changed this year. Instead of monthly meetings for delegates, three general meetings were planned when all members of the parish branches were expected to be present, and four when only delegates and



officers need attend. The plan proved very successful. The first general meeting was held February 10th at St. Bartholomew's Parish House with ninety-one members present. Bishop Greer made an address on "Prayer" and Bishop Spalding, of Salt Lake, an address on his work. The second general meeting was held on May 11th at St. Thomas's Church. About 175 members were present. The speakers were Dr. Lloyd and Dr. Stires. Each Branch gave a report of the winter's work.

The meetings for delegates were held as usual on the Friday after the first Monday in November, December, January and March. Miss Emery addressed one of these meetings and the Rev. W. Charles Wilson, of Spring Hill Mines, Nova Scotia, another.

The Angelica Church Hart Scholarship of \$1,500, a fund endowing a scholarship in St. Hilda's School, Wuchang, China, was completed this year. This gift, a memorial to our former Chairman, Mrs. Hart, was offered at a special service held at the Church Missions House on January 25th.

The best work of the Department has been its mission study campaign. Again Miss Delafield, to whom the Juniors owe so much for her guidance in their work, conducted a Normal Study Class on Japan, while Miss Pelton conducted two Normal Classes on Africa. As a result of these Normal Classes there were twenty-four parish classes taught in the Diocese. During Lent there was also a Missionary Bible-class for Junior leaders and others.

There have been a number of changes in the Board of Officers, Mrs. Lorillard, Miss Harris, Miss Cornelia Delafield and Miss Quackenbos resigning. Miss E. R. Delafield was appointed a Vice-Chairman, Miss Verplanck was made Recording Secretary instead of Corresponding Secretary, Miss Alice F. Lindley appointed Corresponding Secretary and Miss Katharine Atterbury, Treasurer of the United Offering. These, with the former officers, were elected at the annual meeting.

### SECRETARY'S REPORT FOR 1905-1906.

The Woman's Auxiliary in the Archdeaconry of Orange held two meetings, as usual, during the year:

The fall meeting, at Grace Church, Middletown, where the speakers were Miss Agnes P. Mahony, of Cape Mount, Africa, and the Rev. Henry Little, of Ocala, Fla.



At this meeting is decided the work to be undertaken during Lent. For a number of years the parishes have united in doing the same work, and have sent all boxes to one hospital, or missionary. Acting on Miss Emery's suggestion, at this meeting, a choice was given the parishes of three letters sent by her. Several promised to send boxes to the Rev. W. J. Cleveland, Pine Ridge, S. Dak., for the Indian catechists, others to send clothing for Indian children to Mrs. Hersey, Randlett, Utah, and a number to sew for the Mission of the Good Shepherd at Lynchburg, Va.

In May, the seventeenth annual meeting was held at the Church of the Holy Innocents, Highland Falls. The reports of the Secretaries were read and the election of officers took place.

The Rev. S. Harrington Littell, of Hankow, China, spoke both morning and afternoon, telling of the marvellous difference in the lives of all the Chinese embracing Christianity, especially the women, thus making a strong plea for workers in this field.

During the year twenty-three boxes of clothing valued at \$1,464.50 have been sent out from the various parishes of the Archdeaconry; \$443.50 in cash donated, and \$379.67 sent to the Treasurer of the United Offering.

## SECRETARY'S REPORT.

October 1st, 1905, to June 1st, 1906.

Although it seems but few months have elapsed since our last report was made, much good work has been accomplished in the school at Cape Mount, Africa, and the Hospital of the Good Shepherd, Arizona—the two objects for which this Committee is working.

Letters from Mr. Matthews or his wife tell us of the life in the school at Cape Mount, of certain boys who are most promising, and of the good dispensary work done by Miss Ridgely. Much of interest could be reported if space allowed, but it does not.

The reports from the Indian Hospital tell of greater work done than ever before. From September 1st to date all beds—twelve—have been constantly occupied. There have been sixteen surgical cases, several very serious ones, and the dispensary has often had as many as seven or eight patients daily. We hear of one Indian wedding, eight baptisms and but two deaths. Miss Thackara has secured the services of a deaconess, of which she has long felt the need, for outside work as well as in the house.

Members of our Executive Committee have attended many parish meetings, reading letters from Cape Mount and from Miss Thackara, thus giving the latest news to those who are helping the two objects.
