THE BUDGET

we mean the sums necessary to maintain the National Council's existing work.

It counts on Parish Quota and on the Woman's Auxiliary Pledge. The Woman's Auxiliary of this Diocese voted at its January meeting as its 1924 Pledge to continue sending \$2,000. monthly (\$24,000 for the year) for the Budget and that each Branch be informed of its proportionate monthly share. This helps our Diocese meet its obligation to the National Council, and since each branch however small has a part in it, the Auxiliary is united in helping our missionaries in all the fields preach the gospel, teach the ignorant, and heal the sick, as well as in the National Council's work for Social Service and Religious Education.

All moneys received by our Treasurer, not otherwise designated, will be used for the Budget.

THE PRIORITIES are sums asked for objects which represent the forward work of the Church.

Our Auxiliary has voted \$24, 000. as our 1924 Priority Pledge and that this pledge be adopted upon the understanding that if any Priority for which money has been given is completed already, the money raised for such Priority shall be used for the next Priority chosen by this Auxiliary.

Sub-Committees of the Domestic and Foreign Committees are working for Priorities.

The recommendation of our Executive Board, adopted by the Auxiliary on January 8, 1924, provides that where a *Priority Plan* is desired, various parts of the field be considered at certain times during the year, as fellows:

- Epiphany: Bishop Carson, Haiti [No. 242 B]
Building Fund for St. Augustine's, Raleigh, (this must be completed before April 1st in order to secure the fund offered by the General Education Board.) [No. 453]
- Lent: Porto Rico Church at Ponce [No. 189]
St. Agnes' School, Kyoto, Japan [No. 455]
- Easter tide; A Domestic Priority
Liberia
- Trinity: An Indian Priority [No. 107]
- Advent: China (this is the subject recommended for study for the winter 1924-25.) [No. 391]

The

SOCIAL SERVICE PLEDGE is \$2,000. for Americanization work at Ellis Island.

This is Diocesan Priority No. 3. The Auxiliary voted that each branch of the Woman's Auxiliary be informed as to the proportionate amount, which if all give, will make up the \$2,000. for the Social Service Pledge.

For the Woman's Auxiliary Special, Bishop Tuttle Memorial Church Houses for Women Workers.

GIFTS FROM INDIVIDUALS (not appropriations from the branch's treasury). One of the Church Houses is to be a Training School for Colored Women in the South. The other a residence near Headquarters (Church Missions House) where missionaries on furlough and volunteers may reside under the Church's influence during a continuance of their training (Post Graduate.) Other Specials must be sent to Mrs. Ewing with careful attention to the following rules.

1. A remittance for a *Special* must not be included in a check or draft for other objects.

It must be sent separately; accompanied by a letter stating it is a *SPECIAL*; and giving the object in full.

2. The sender must realize that: A *Special* is *not* Budget. A *Special* is *not* a Priority. A *Special* does *not* count on the Parish Quota. Nor does a *Special* help the National Council to meet its obligations.

PRESIDENT'S REPORT

The term of office just closing (extended this year to sixteen months by the change of the annual meeting from January to May) has been marked by the successful completion of our 1922 pledge of \$50,000 counting on the N. W. C. quota, and by the reshaping of our 1923 pledge in accordance with the adoption of the Program by the General Convention at Portland.

At the Woman's Auxiliary Triennial in Portland, this Diocese was represented by its full five delegates—Mrs. Macon, Mrs. Miller, Miss Murchison, Miss Waring, and your President—while five faithful alternates who represented the Educational Committee and the Supply Department, as well as the general membership of the Auxiliary, made it possible for our full five votes to be cast at every business session.

In January, 1923, we adopted the Program of the Council to which we are Auxiliary by pledging \$2,000 per month (\$24,000 per annum) toward the General Budget, and also undertaking \$24,000 toward priorities, with a Social Service pledge for Americanization within the Diocese of \$2,000 Diocesan Priorities.

The reports which follow give the work accomplished and show the zeal with which all the Districts have cooperated in the monthly Budget pledge, not a single branch having refused to take part and eleven conferences between Diocesan and Parish officers having discussed the plan.

The New York Auxiliary rejoices in having had a part in the closer drawing together of the Auxiliary of the Second Province to consider the possibility of reaching the Church's college and Normal School girls in the Province and to help Porto Rico by bringing one of her devoted young women teachers to the summer school at Columbia, and also in working for Priority No. 52, the Building Fund of Hooker School, Mexico City. Miss Gertrude Geer, President of the Barnard Class of 19 , represents this Auxiliary on the Provincial Committee.

Our Advent Meeting exceeded all past years in attendance and enthusiasm. Bishop Manning was the Celebrant, Bishop Shipman our preacher, the speakers at the afternoon session Bishop Roots of Hankow, Bishop Tucker of Kyoto, the Rev. W. A. Thompson of Pt. Hope, Alaska, and Mr. Franklin, Vice-President of the National Council.

The Quiet Day in Lent 1922 was conducted by Bishop Lloyd, and that in Lent 1923 by Dr. Wm. H. Milton, both at the Church of the Resurrection, and to both speakers we are deeply indebted.

President's Annual Report.

Important action taken by the Woman's Auxiliary at Portland was the adoption of a Special for two Church houses for women workers training for Church work. The first is for colored women, the second is to be in New York where volunteers and missionaries on furlough can live in touch with the Church Missions House while they receive specialized post-graduate training. This fund is to be raised during the three years, as the Emery Fund was raised during the last triennium. The organization is to be Provincial, Diocesan and Parish representatives. It is a great joy to us that our beloved ex-President, Mrs. R. W. B. Elliott, has consented to act as our Diocesan representative. She asks each parish to name a representative. The object of the Special is twofold: To emphasize the need of the best trained workers; to bring such training within the reach of our women by supplying a place for them to live while receiving it.

The resignation of our Vice-President in charge of Supply Work, Miss Dorothy King, on account of the death of Mr. George Gordon King, was a cause of deep regret. We are grateful that Miss Isabel Peters has taken up the work with devotion and consecration.

The resignation of our Secretary, Mrs. Bangs, is a cause of distress to us all. Her faithfulness has brought a sense of benignity which will always be affectionately remembered. Nomination to succeed her has been accepted by Mrs. Haff, our Educational Vice-President.

The Educational Report, which you have heard, in some slight measure testifies to the valiant work which this devoted officer has performed. What she has wrought has been the foundation on which the whole work in the Auxiliary has progressed, and in closing my report I would bear personal witness to her really toilsome labors, and to the abnegation with which her talents and training have been put always joyfully at the service of the Auxiliary.

DOMESTIC COMMITTEE.

During the period, January 1922 to May 1923, the Domestic Committee has held eleven regular meetings at which interesting addresses were made. The Committee in charge of Colored Work reports having held two parlor meetings, one for Archdeacon Baskerville, at which \$643.75 was given, and the other, for Mrs. Hunt, of the Fort Valley School, Georgia, at which \$511.45 was given. In addition, through the interest and industry of the Chairman, Miss Bowden's School at San Antonio, Texas, has received \$2250.00—\$2000.00 being the generous gift of one person.

The Panama Committee reports a parlor meeting, at which Bishop Morris told of his need for the furnishings of the chancel of St. Luke's Cathedral at Ancon. An enthusiastic and ready response brought gifts amounting to \$2061.35. The Islands Committee reports an organization of eighty-one members, Active, Associate and Contributing. A delightful luncheon was held at the Church League Club, when interesting addresses were made by Mrs. G. F. Mosher and Mrs. John A. Stanton, Jr. The widespread activities of this committee are evident from the splendid report of the Treasurer.

The Southern Mountaineer Committee held a wonderfully interesting "Betsy Ross Circus" at the Hecksher Foundation for Children, sending \$1000.00 to the Helen Dunlop School, Winslow, Arkansas, as well as a scholarship to Mrs. Wetmore at Arden, N. C. and \$100. to Archdeacon Claiborne.

The Indian Committee has sent over \$300.00 for work among the Oneida Indians and contributed for a Ford car; also helped to complete the pledge for the Mary E. Hart Memorial Fund at the San Juan Mission, New Mexico. \$275.00 was raised at a Parlor Meeting, at which Miss Deloria, Miss Debb and a Sister of the Holy Nativity were the speakers.

The Alaska Committee reports that the cause of Alaskan Missions has been much helped this year by the presence in the east of several noted workers. The Rev. Dr. & Mrs. John W. Chapman from Anvik, the Rev. W. A. Thomas from Point Hope, Dr. & Mrs. Grafton Burke from Fort Yukon and Miss Edith Harper. Numerous meetings have been addressed by these experienced missionaries and it is hoped that as a result of their messages not only the Priorities, as scheduled, will be met, but Specials as well. Bishop Rowe has asked that an effort be made to increase the subscription list of the "Alaskan Churchman," as otherwise it must suspend publication. To avoid this, the present chairman has been asked to represent it in this Diocese.

The six Sub-Committees of the Domestic Committee are organized, each under the leadership of a chairman and all are active in furthering the work for their several fields.

FOREIGN COMMITTEE

The opening of this decade has shown a surprising progress in the Foreign Field. Never has it been so well manned; never have so many women workers lived the real Christ-life; never, in contrast to this, has there been such a need of ordained clergy and medical men. Let the cry go out that the urgent want be met!

The last year was the largest in baptisms and confirmations in both China and Japan. Our Sub-Committees for these countries, Miss Florence S. Sullivan, Chairman for China and Mrs. Richard T. Stevens Chairman for Japan have worked hard and accomplished much. Various building funds have been helped, and we rejoice that construction in Shanghai, Wuchang, Nanking, and Nanchang, has been going on satisfactorily. St. Hilda's School Chapel being completed, St. Mary's, Shanghai, will soon receive God's blessing on its new Chapel, for which this Diocese has raised a fifth of the needed amount. Miss Sullivan held, at her home, a most successful meeting to hear Bishop Roots. The Japan Sub-Committee worked for St. Luke's, Tokyo, with all its energies, also contributed largely to the Bazaar in Tokyo, for the Nurses' Home. Great progress in Christian Education has taken place in Japan through the work of the Woman's Auxiliary—St. Paul's in Tokyo having been granted University service. A meeting in the interest of Miss Cornwall-Leigh's Work for Lepers gave a goodly sum for her marvelous and self-sacrificing work.

Our Liberia Sub-Committee, under the able leadership of Mrs. R. Douglas Muir, held a very successful meeting at the residence of Mrs. George Zabriskie, early in April. They report Bishop Overs is much encouraged with the year's progress, and ably assisted by the Suffragan Bishop. The Sarah Conway Ramsaur Memorial, addition to St. Timothy's, is not yet built. The good progress of the Industrial School at Cape Mount is reported in the new "Liberia Churchman" published there by the Douglas Muir Memorial Press.

Bishop Aves, on account of ill health, has presented his resignation in Mexico. Mrs. W. R. Sheffield has worked hard for the Hooker School. We hear three teachers have gone there.

Mrs. Joseph Blanchard has been helping to collect money for Bishop Kinsolving's printing press. The Theological School under Dr. Morris is successfully training ten or twelve fine young Brazilians. Those of us who met Mr. Thomas in October realize what his personality has done for the work of the Southern Cross School which has made such splendid progress.

The Cuba and Haiti Sub-Committee has been divided. Mrs. Hall P. McCullough taking the work for Haiti and Mrs. W. G. Crawford that for Cuba. Bishop Carson has been warmly received by both Americans and Haitians, also by the Naval Government Officials. He is asking for modern typewriters for his work in preparing lectures. We consider the Haiti Committee our new baby, and hope by another year it will be big and strong. We welcome the young girls who are taking charge of this new work.

EDUCATION DEPARTMENT.

This report covers a period of two years. The Educational Committee has met regularly twice each year to report past efforts and plan for the future. Its organization is complete with an educational secretary in each district who takes charge of the local work which has grown accordingly in the most encouraging manner. Members of the committee have devoted part of each summer to writing short essays on the various fields, which essays have been widely used in the more rural parts of the Diocese. Not the least of the labor has been the typing of many copies of these essays, which has been done by volunteers and which we gratefully acknowledge.

The Literature Table has been maintained at each regular meeting. On it has been placed a supply of the latest leaflets and books.

The Executive Board has given each year, a scholarship for the Church Conferences, and two teas for Church Conference members have been held in conjunction with the Girls' Friendly Society. The Vice-President led a Mission Study Class at the Wellesley Conference in 1921 and another at Geneva in 1922.

The chief work of the Committee has been the regular normal and parish discussion classes. Starting in September with the outlying districts and lasting until after Lent they constitute its main endeavor. In 1921-1922, the Social Service Department worked with us, and we can report 70 classes, using "The Survey," "How Can We Know the Way," and "The Social Opportunity of the Churchman." In 1922-1923, we had the opportunity of presenting one of the foremost problems of the day—the race question, as exemplified by the Negro of the United States. We can report to date, 79 classes, the largest number the Diocese has ever had. This number is due to the devotion of the leaders and the members of the Committee, especially Miss Eveleyne Prophet, who herself has led this year 22 successful classes.

The work of the season closed with a meeting where Dr. Patton of the American Church Institute for Negroes was the speaker, and with the Corporate Communion for all class members on April 15th.

I would not like to close this my last report as your Vice-President without a word of appreciation of the letters answered, the books sent, the classes formed by the presidents of the parish branches of the Diocese of New York. Their real co-operation in the educational work has been a source of inspiration and an untold help. I am happy to have this to hand on to my successor as one great asset in her work.

SOCIAL SERVICE DEPARTMENT

In a short report, to tell just what the Auxiliary in the Diocese of New York is doing in the field of Social Service and to put the emphasis in exactly the right place is difficult, since the actual work accomplished must be reported in the departments dealing with finance, education and supplies. However, the making of garments, the giving of money and the attendance at Study Classes is not the final goal of any group really interested in Christian Social Service.

We have been counselled from headquarters that in dioceses such as this it is not the responsibility of the Auxiliary to start social undertakings but that we should work through the Diocesan Commission and that we should co-operate with other organizations already active in this branch of work. The intention of this report is to show how we in the Diocese of New York have been endeavoring to follow this counsel.

The well established Social Service Commission of the Diocese of New York, includes in its membership the Vice-President in charge of Social Service in the Woman's Auxiliary. Through this connection a very definite relationship is being built up between the Woman's Auxiliary and the official body entrusted with the development of a programme for social work in the Diocese. The educational side of our work was closely allied with the Commission by means of classes studying the "Social Opportunity of the Churchman" in the winter and spring of 1922. Another proof of our co-operation with diocesan plans is our pledge for the support of Houston Community House. During 1922, the splendid sum of \$1,400 was raised to help in establishing a community work for the foreign population in one of the most congested districts of this city. Interest in the project was fostered by means of a successful tea held at Houston House in April 1922 when addresses were given and the building was thrown open to visitors who represented a large number of parishes.

That we have planned our work on a basis of co-operation with other organizations is demonstrated in our department of supply work, our financial work and our educational work. The large number of garments sent to the City Mission Society, the Seamen's Church Institute and other Diocesan agencies is proof of much interest and devotion. Our other financial pledge for the work at Ellis Island, under the City Mission Society ties us up with the senior social organization of the diocese and we may feel it a great privilege that we furnish the means to supply a worker particularly charged with welcoming strangers on

their arrival at this port of entry and aiding them in establishing a Church connection in their new homes.

Resolutions adopted at the Triennial meeting last autumn pledged anew the efforts of the Auxiliary in prayer and service toward maintaining a high Christian standard in our homes and in society and urged that our support should be given to such practical movements as Adequate Care for Disabled Veterans, Proper Laws for Women and Children, Prison Reform and Christian International Relations. It is impossible to report the exact ways in which we have followed the general direction of these resolutions but both parish and diocesan meetings have been opened to speakers who have told us of the efforts of Church and secular agencies in building up the Kingdom.

The actual accomplishments enumerated in this department seem very small but its existence in the Auxiliary is we believe helping us to a deeper realization of the great task of the Church to set men everywhere in right relationship with God and with each other.

THE SUPPLY DEPARTMENT.

To start with figures seems dry but though inadequate they do partially depict the work accomplished. The changing of the fiscal year causing the report to cover fifteen months, has made impossible any comparison with the totals of previous years, therefore in order to make a comparison the following figures have been compiled for the twelve month period, from January to January. The valuation for Personal, Institutional, and Social Service Box Work for 1921 was \$37,356.94, for 1922 it was \$38,871.68, a net increase of \$1,514.74. This increase does not denote a uniform gain in all the districts; for in the districts of New York and Dutchess there is a loss of \$2,405.85, whereas the districts of Westchester, Orange, and Staten Island show a fine increase of \$3,920.59. In giving statistics it must be remembered that though they indicate the work being done from year to year they have to be read with the understanding that early or late reporting of figures materially changes the annual total, though it affects the work but slightly.

Outside of this there is the good work done by 67 branches of the Girls Friendly Society.

From these figures let us turn to the ultimate end of our work, the field, to see where our help went. Of the Personal Boxes there were 98 recipients; of the Mission Boxes 42, of which 8 were schools and 9 hospitals. Outside our own country and possessions these Boxes went to Mexico, China, Japan, Liberia, and San Domingo.

In contrast to these distant areas we have our own Diocesan Institutions, for which from January 1922 to April 1923 Social Service work valued at \$5063.27, was accomplished.

The Supply Department workroom was open from the middle of November to April. It is I feel, gradually establishing its usefulness in the Diocese. This winter 1,847 garments, in addition to 31 layettes, were cut.

In reviewing the work it seems of a very materialistic character. But we all know that it is only through knowledge, sympathy and imagination that we can make suitable garments to send to people we have never seen and places we have never visited.

DUTCHESS.

During the sixteen months, January 1922 to May 1923, all the branches of the Auxiliary in Dutchess have been active. There have been readjustments—some branches having combined and others having separated but the number, nineteen, has curiously remained the same. To the country branches Auxiliary work has meant Supply-work or boxes. They have given to the United Thank Offering and to Specials, and our own small District pledge has always been met, but little obligation was felt in regard to the Diocesan pledges. During the last two years, however, a direct result of Mrs. Haff's "intensive days" has been, not only an increase in the number of study classes, but an increase in the money gifts and a willingness to give in the direction indicated by the Executive Board. The response to the pledge for Budget has been especially gratifying, and owing to Miss Moore's untiring efforts to explain the plan of the Supply Department, by visiting personally nearly all the branches our entire allotment was placed.

The annual meeting and corporate communion was held last year in Christ Church, Poughkeepsie, Bishop Lloyd being the preacher and Deaconess Scott of China the principal speaker in the afternoon. The attendance was very large, in spite of thunder storms in the morning, and the ladies of Christ Church gave a wonderful luncheon.

Details of the work done during the year appear in the reports of Mrs. Ewing, Miss Peters and Mrs. Haff, and represent much of devotion and difficulties overcome.

ORANGE.

In the sixteen months since January 1922, Orange has held, (beside the neighborhood study-classes at various centres) nine meetings for the District or specified sections of it. The all-day Annual Meeting was held at the Church of the Good Shepherd, Newburgh, in May 1922. The attendance was one of the largest on record. Bishop Hulse was the speaker and Bishop Shipman made a short impromptu address.

The Quiet Day in October was most devoutly conducted by the Rev. MacVeigh Harrison of the Order of the Holy Cross, at St. John's Church, Kingston. It gave to those, inexperienced in that form of devotion, the desire to participate in the privilege again. Division Neighborhood-Meetings were held at the Church of the Good Shepherd, in Newburgh; at St. James Church, Goshen; Christ Church, Suffern; and the Church of the Holy Communion at Liberty. The last was in connection with an intensive day for Mission Study. Three Officers Conferences were held at St. George's Church, Newburgh, at the Church of the Holy Cross, Kingston, and at Grace Church, Middletown.

In the Supply work, the Educational work, and in the introduction of the new Budget plan the branches have responded not only willingly, but with eagerness, Twenty-six were interviewed concerning the Budget and twenty-three promptly made a favorable response; three are still to be heard from. Six, rather difficult to reach, will be visited later. The branches in several cases have given more than was asked of them, and a disposition to measure up and press forward has been shown throughout. The Educational Leaders have been welcomed and appreciated wherever study-classes have been held. In the Supply Department various branches have gone far beyond their usual measure of work, and through the inspiring influence of the Supply Officer, our unusually large allotment for the institutional work is filled and completed, besides a goodly share of other work.

At the Annual Meeting, a year ago, a motion was passed to form Affiliated Groups from unattached Missions and small parishes willing to take part in the Auxiliary work. Four branches have been organized during the last sixteen months, and one branch, which had suspended work, has re-organized and is now working vigorously. We have at present thirty-two branches and seven groups.

District Reports.

STATEN ISLAND

During the winter of 1922 there were formed three (3) Parish Branches and one Evening branch (formerly a Junior Branch). All parishes took an active part in educational and supply work and we added many new members to the existing branches.

There is now a branch in every parish but one and an Italian Mission.

An active campaign was carried on to inform all members of the mission work of the Church through subscriptions to THE SPIRIT OF MISSIONS and by speakers from the field at the seven District and many Parish Meetings and at our corporate communion service.

We filled many personal and Christmas boxes and had trees and gifts at local hospitals and at the City Farm Colony, sent boxes to the Church Mission of Help, Hope Farm, and the Seamen's Church Institute.

The District has worked together on two large Institutional boxes for Beaufort, N. C., and St. Mary's, Sagada, Philippines.

May 24 our Annual Meeting was held. Mrs. Mosher spoke, the talk being illustrated by lantern slides of the Sagada Mission, for which we have been working this year.

Study Classes have been held in several parishes each Lent. In other branches we have supplied speakers and books.

The Evening Branch sends members to Silver Bay and the work of these young women leads us to hope we may have such a branch in each parish this year and so get in touch with the younger women who are so important if we are to continue a strong organization.

We find sewing is most necessary in our district, we follow up this sewing with educational study of the work in that field for which the sewing is done.

We filled our pledge last year, have promised again and will increase the sum. We are working for Budget with one Special last year and one Priority this year. (198. Archdeacon Russell's Girl's Dormitory, Lawrenceville, Va.).

The meetings have been well attended in spite of the very severe weather; the spirit of helpfulness is shown everywhere. I am greatly encouraged by the work of this district.

District Reports.

WESTCHESTER.

We have made every effort in our Westchester District to create a sense, larger than ever before, of the part we must take in our Church's growth; to express and make articulate that part, by giving to the Quota in new figures, by adding new groups of workers to our Supply Department, and fundamentally to spread knowledge of our Church's present need, and arouse new loyalty and zeal for the Diocese. With this aim ever before us the work has been planned. Six Conferences for the Officers of our forty-eight branches have been held by the Managers of the three Divisions; and two Conferences by our Supply Secretary for Parish Supply Officers. In this way our forces have, from time to time, been brought together to be informed, to face new tasks, and to act upon them.

The annual All-Day Meeting was held May 17th at St. Barnabas, Irvington, the attendance being 452 delegates from forty-three branches. We were entertained with generous hospitality, and the day is memorable for happy experiences. We were fortunate in having Dean Robbins preach at the morning service. At the afternoon session Deaconess Scott, of St. Hilda's School, Wuchang, spoke and Mrs. Ewing. The Summer Pledge, a girl's dormitory at the Hospital of the Good Shepherd, Arizona, was presented by Mrs. Thorne. The appeal met with a quick response, and \$1300. was pledged. The last speaker of the afternoon was Bishop Lloyd, who made the Memorial address to Sarah Conway Ramsaur, whose sudden death had deeply touched the hearts in Westchester. The plans for enlarging the hospital at Cape Mount, to be built in her memory, were presented by the Bishop. We have had seventeen large neighborhood meetings and a District Meeting held in November at Christ Church, Bronxville, to welcome Miss Cady, who filled our hearts with gladness as she pictured what our Summer Pledge had made possible,—the capacity of the Hospital doubled!

The work of our devoted Supply Secretary is a constant joy to us. The valuation of our allotments has increased over \$2600. from January, 1922, to January, 1923. Three chapels have taken allotments for the first time. Many all-day sewing meetings have been a factor in spreading interest and reaching new women. The Gold Cross membership is increasingly used; in one large parish it yielded \$500. and financed for the year the parish allotment. We have over-paid our 15% of the Diocesan Pledge which was suggested to Westchester as its Quota. This means that over and above the payment of the two District Pledges there has been an increase of over \$3000. given by our branches to Diocesan

Pledges. In addition, for Bishop Rowe's new "Pelican" \$400. was sent. For the Sarah Conway Ramsaur Memorial over \$600. was pledged. In response to an appeal from headquarters, the Missions House, twenty-one branches gave to the Near East Relief, and supported ten children for the year. Our Summer Pledge reached \$1500. United Thank Offering boxes have been placed for the first time in four chapels and we have added one new branch, the Chapel of the Redeemer, Lincoln Park, Yonkers. In addition to the three new sewing groups, 137 new members have enlisted.

Our District rejoices in reporting that from St. Barnabas, Irvington, a young woman has recently gone to the Mission field to serve as a nurse at Osaka, Japan. In the ranks of our Westchester committee four Division Managers have been added.

In this review of our work I have not been forgetful for one moment of the influence and work accomplished by my predecessor, who for so long was the Chairman for Westchester, and is now the President of the Diocesan Branch, and it is ever, in fullest recognition of the foundations laid by her, that I present this report.

United Thank Offering.

Although in this Diocese we did not succeed in doubling the offering of 1919, we did take to the Triennial in Portland \$55,592.73, nearly \$10,000 more than was taken to Detroit in 1919. One-tenth of the entire offering collected in all dioceses of the United States is set aside as a permanent trust fund, the income to be applied towards the support of retired Thank-Offering workers. \$15,000 of the 1922 offering will help build the Florence Greeley Memorial Dormitory for Girls at St. Paul's Normal and Industrial School, Lawrenceville, Va., and \$15,000 goes to assist in building the nurses' home at St. Luke's Hospital, Tokyo, Japan.

There are at present 171 women who are working in the mission field supported by our Thank-Offering, and there are 6 in training.

Surely every woman who knew of the offering gave, but for the Thank-Offering of 1925 we want to feel that every woman of every parish has had a share in it. With the splendid Thank-Offering treasurers we have in this diocese, I feel sure we are going at least to double the number of women givers.

United Thank Offering of 1925.

Resolution Adopted in Portland, Oregon.

RESOLVED: That the United Thank Offering of 1925 be given to the Presiding Bishop and Council for the work of women in the mission field whose appointment has been approved by the Executive Board of the Woman's Auxiliary, including the training, sending and support of women workers, and the care of such workers when sick or disabled; Provided, that one-tenth of the Offering be set aside and added to the permanent trust fund to be invested and administered by the Presiding Bishop and Council, the income to be applied to the support of retired United Thank Offering workers; Also Provided, that the sum of not less than \$25,000.00 be devoted to the erection, completion, or renewal of a building or buildings approved by the Presiding Bishop and Council on the recommendation of the Executive Secretary of the Department of Missions and the Executive Board of the Woman's Auxiliary.

RESOLVED: That to our united gifts shall be added our united and earnest prayers that God will put it into the hearts of many faithful women to give themselves or of their substance to the work of the Master in the Mission Field.

The Junior Auxiliary and Church School Service League.

We are glad to report that there has been a growth, even though gradual, in the Church School Service League. Some new branches have been formed and several Church Schools and Junior Auxiliaries have adopted the plan of work proposed by the League, although not calling themselves Church School Service Leagues.

Two members of our executive board had the privilege of attending the meetings of the leaders of the League, from all over the country at the time of the General Convention at Portland. It was evident from the development of the League in over sixty dioceses that it is both a workable and successful plan. Upon our return from the Convention, Bishop Manning appointed Bishop Lloyd to supervise the organization of the League in this Diocese. We are very grateful indeed for this help. It seemed wise after consultation with Bishop Lloyd to omit the annual Cathedral meeting in November and our annual business meeting in January. We held, however, a successful district meeting at St. Luke's Church, Beacon, when over one hundred children were present, representing seven parishes. We held also a New York meeting in February at the Church of the Heavenly Rest, when the Diocesan part of our three-fold pledge was presented by the Rev. Dr. Sunderland. Two meetings for young men and women between the ages of sixteen and twenty-five were arranged. On March 11th the Rev. Dr. Gardiner told of the "Youth Movement" which is sweeping the world, with special emphasis on the development of Young People's Societies in the United States. An outcome of these two meetings is the formation of a Continuation Committee to plan for a week-end Conference in June, with delegates from every parish in the Diocese.

Our branches have contributed missionary boxes to the value of \$949.76, and money gifts totaling \$5,109.44.

NEW YORK BRANCH WOMAN'S AUXILIARY TO THE NATIONAL COUNCIL

ARTICLE I.—NAME.

The Name of this Association shall be THE NEW YORK BRANCH
OF THE WOMAN'S AUXILIARY TO THE PRESIDING BISHOP AND COUNCIL.

ARTICLE II.—OBJECT.

The object of this Association shall be to carry out within the Dio-
cese of New York the purposes and work of the Woman's Auxiliary to
the Presiding Bishop and Council.

ARTICLE III.—MEMBERSHIP.

All Churchwomen and children by virtue of their baptism are con-
sidered possible members of the Woman's Auxiliary. All those who, in
this Diocese, by their prayers, work or offerings, aid the Missions of
the Church may become by enrolment, actual members of the New York
Branch.

ARTICLE IV.—OFFICERS.

The officers of this Association shall be a President and thirteen
Vice-Presidents, five in charge respectively of the districts of Dutchess,
New York, Orange, Staten Island and Westchester, one in charge of the
Junior Auxiliary, and five in charge, respectively, of the work of Domes-
tic Missions, Foreign Missions, Education, Social Service and the Supply
Department, and two Vice-Presidents at Large, a Secretary, an Assistant
Secretary, a Treasurer and a Treasurer for the United Thank Offering;
all of whom shall constitute the Executive Board.

ARTICLE V.—HONORARY OFFICERS.

The Association may appoint Honorary Officers at pleasure.

ARTICLE VI.—AMENDMENT.

This Constitution, having been approved by the Bishop, may be
amended with his approval by the Association at its Annual Meeting,
two-thirds of the Representatives present concurring, notice of the pro-
posed amendments, having been given at a previous meeting.

By-Laws.

ARTICLE I.—DUTIES AND POWERS OF OFFICERS.

SECTION 1. *President.* The President shall preside at all meetings of this Association and of the Executive Board.

SEC. 2. *Vice-Presidents.* A Vice-President at Large shall preside in the absence of the President, and the Vice-Presidents shall perform such other duties as may be assigned to them by the Executive Board, presenting a report of their work at the Annual Meeting.

The Vice-Presidents in charge of the Districts shall endeavor to promote the formation of Parish Branches and to help and strengthen those already existing; shall consult with the Executive Board, and shall present at the Annual Meeting a written report of the work in their respective Districts for the year.

The Vice-Presidents in charge of Domestic Missions, Foreign Missions, Education, Social Service and the Supply Department shall inform the Parish Branches through correspondence, visiting or providing speakers, of the needs and work in their respective departments. They shall present at the Annual Meeting written reports of their work for the year.

Each Vice-President shall appoint such persons as she may deem necessary to assist her in the performance of her duties.

SEC. 3. *Secretary.* The Secretary shall—

- (1) Issue notice of meetings;
- (2) Keep the Minutes of the Association and of the Executive Board;
- (3) Prepare and edit the annual report, and shall perform such other duties as may be assigned to her by the Association or the Executive Board.

SEC. 4. *Assistant Secretary.* The Assistant Secretary shall assist the Secretary in the performance of her duties.

SEC. 5. *Treasurer.* The Treasurer shall receive and disburse and keep account of all moneys received in each department of work and shall attend the meetings of the Association, reporting receipts and disbursements to the same.

SEC. 6. *Treasurer—United Thank Offering.* The Treasurer for the United Thank Offering shall receive all contributions for the United Thank Offering, and under the direction of the Executive Board, endeavor to arouse and increase an interest in the same.

By-Laws.

SEC. 7. *Auditing Committee.* The accounts of the Treasurer of the Association and those of the Treasurer for the United Thank Offering shall be audited annually by an Auditing Committee to be appointed by the President.

SEC. 8. *Executive Board.* The Executive Board shall be entrusted with the general business of the Association; shall fill vacancies occurring on the resignation or death of officers; and shall exercise all powers of the Association not herein expressly provided for. Six members of the Executive Board shall constitute a quorum.

SEC. 9. The officers shall be entitled to vote at all meetings of the Association.

ARTICLE II.—PARISH DUES.

Each Parish Branch shall send annually to the Treasurer, for the current expenses of the Association, a specified sum of money to be known as Parish Dues. The amount of these dues shall be determined by the Association at the November meeting.

ARTICLE III.—FISCAL YEAR.

The fiscal year of the Association shall be from January 1st to December 31st.

ARTICLE IV.—MEETINGS.

SECTION 1. The meetings of this Association shall be held monthly from November to May, inclusive, the May meeting being the annual Meeting.

SEC. 2. These meetings shall be open to all members of the Woman's Auxiliary, but no persons shall be entitled to vote except four duly elected or appointed delegates from each organized Branch of the Woman's Auxiliary and the officers of the Association.

SEC. 3. The Secretary shall call special meetings on request of the President or five members of the Executive Board.

SEC. 4. At all meetings of this Association, except the Annual Meeting, fifty delegates shall constitute a quorum.

SEC. 5. At the Annual Meeting one hundred delegates from the Parish Branches shall constitute a quorum.

SEC. 6. A meeting of the Executive Board shall precede each monthly meeting of the Association.

SEC. 7. The Vice-Presidents in consultation with other officers of the Association may arrange for special meetings in the Districts to arouse keener zeal and effort.

By-Laws.

ARTICLE V.—NOMINATIONS AND ELECTIONS.

SECTION 1. There shall be appointed annually by the President a Nominating Committee of seven members comprising at least one member from each District, which shall nominate at the Annual Meeting one candidate for each office of the Association, the District Vice-Presidents excepted.

The Vice-Presidents in charge of the Districts of Dutchess, New York, Orange, Staten Island, and Westchester shall be nominated at a representative meeting of their respective Districts. At such meeting, which shall take place not less than one month before the Diocesan Annual Meeting, each branch shall have one vote, a branch being a group of women working to help the Presiding Bishop and Council and contributing to the expense fund of the Diocesan Woman's Auxiliary. Unless one-third of the branches are represented by delegates or proxies, there shall be no quorum. Should a District waive the right, the Vice-President shall be selected by the Nominating Committee.

SEC. 2. All the officers except the Treasurer for the United Offering and the Vice-President in charge of the Junior Auxiliary shall be elected by ballot of majority vote at the annual meeting and shall hold their office for one year or until the election of their successor.

SEC. 3. The President of the Junior Auxiliary as elected by that body is *ex-officio* the Vice-President of this Association in charge of that work.

SEC. 4. The Treasurer for the United Offering shall be elected by ballot once every three years, at the May meeting in the same year as the triennial meeting of the Woman's Auxiliary, her election to take effect November 1st of that year. She shall hold office until her successor is elected and installed.

SEC. 2. The order of business may be changed by the vote of the meeting.

- (5) Annual Reports of the Vice-Presidents.

- (10) Election of Officers.
- (11) Prayer.
- (12) Adjournment.

ARTICLE VIII.—AMENDMENT.

By-Laws may be adopted, amended, suspended or repealed at any regular or annual meeting by a two-thirds' majority vote, notice of proposed changes having been given at a previous meeting.

ARTICLE IX.

Roberts' Revised Rules of Order shall govern all meetings.
