In the New York Diocese, the Vice-President in Charge of Supplies allots the work received from headquarters to her District Secretaries, who in turn allot to the Parish Auxiliaries to be filled according to lists.

The Supply Department has been contending with the extraordinary conditions of the day which has been affecting our work adversely since January first. Money for the purchase of supplies could not be given with a generosity equal to previous years, and while we have been able to pay considerably more with our dollars than heretofore, this fact has not offset the falling off of in money gifts, and so it is with no small regret that we come to our annual meeting with the allotments we had accepted for the year, not yet completed by the sum of \$475.00. We sincerely hope, however, that before next fall's allotments are in hand, we shall be able to overcome this deficiency and send to the Institutions which have been our care during the year the full quota of supplies our Diocese has pledged to them thus maintaining our record of previous years for a finished job.

Every year brings its emergency calls to the Supply Department, and this year one came before Christmas when the Emerald Hodgson Hospital at Sewanee, Tennessee, suffered a disastrous fire and lost, among other things, all the supplies it had on hand. Through the prompt response of branches which had been assigned the Emerald Hodgson allotment, augmented by some generous personal gifts, we were able to send forward the needed supplies without delay. There were other emergency calls through the year to which I have always been able to find willing hearts and hands ready to respond, much to the joy of our missionary workers.

The surgical dressing groups merit special attention for they have put through with untiring energy more work than ever, so that the problem of handling our allotments of gauze dressings for the hospitals has been readily met.

At the Supply Cutting Room, the committee of twenty-one regular members has worked with the greatest devotion filling the difficult orders from the Branches for cut garments. The orders for wholesale buying have continued to come in as in other years, and because of reduced prices, we have been able to secure excellent values for our money. The new member of our committee who is serving as buyer has met the constant demands made upon her with marked skill and devotion.

The work done by many of the Altar Guilds in our Diocese in providing new and used altar linens and vestments has been most gratifying. One priest wrote that he had not had a new cassock in twelve years and now he had been given besides his new cassock a new set of stoles; another, that the new altar linens were replacing linens more than fifty years old. The joy thus expressed is a tribute to what the Parish Altar Guilds are doing for the Mission field.

The lack of available used clothing this year has made the problem of our missionaries exceedingly difficult; there is practically no clothing for their people who also are out of employment and with no one but the people of the Church to whom to look for help. The Church people at home have not taken seriously enough their responsibility for those in the mission field. Some splendid supplies have gone forward, and through gifts of special, almost new clothing, some happy friendships have been formed. In one case, a missionary's daughter at college was fitted out. We could give many interesting illustrations were there time.

The Supply work for our Diocesan Institutions has become more general, more Branches are taking part and more supplies distributed to them.

It is with regret that I resign from the leadership in the Supply work of the Diocese. The privilege of service in this most intimate field of work should not be held too long by one person, and it is best that another should take my place. The generous and unfailing support given me not only by the eager and enthusiastic members of my immediate committee, but by Supply Officers and that great number of auxiliary members for whom supply work has a great appeal, has made possible all that we have accomplished.

Constitution.

NEW YORK BRANCH WOMAN'S AUXILIARY TO THE NATIONAL COUNCIL

AS APPROVED BY THE BISHOP AND ADOPTED BY
ITS REPRESENTATIVE BODY, MAY 17TH, 1912
AND AMENDED AT THE ANNUAL MEETINGS.
MAY 8TH, 1913, JANUARY 6TH, 1920, JANU-
ARY 4TH, 1921, JANUARY 3RD, 1922, MAY 6TH,
1924, MAY 5TH, 1925, MAY 1ST, 1928, MAY
6TH, 1929, MAY 6TH, 1930, MAY 3RD, 1931.

ARTICLE I.—NAME.

The Name of this Association shall be THE NEW YORK BRANCH
OF THE WOMAN'S AUXILIARY TO THE NATIONAL COUNCIL.

ARTICLE II.—OBJECT.

The object of this Association shall be to carry out within the
Diocese of New York the purposes and work of the WOMAN'S AUXIL-
IARY TO THE NATIONAL COUNCIL.

ARTICLE III.—MEMBERSHIP.

All Churchwomen and children by virtue of their baptism are con-
sidered possible members of the Woman's Auxiliary. All those who,
in this Diocese, by their prayers, work or offerings, aid the Mission
of the Church through the National Council may become by enrollment,
actual members of the New York Branch.

ARTICLE IV.—OFFICERS.

The officers of this association shall be a President, twelve Vice-
Presidents, of whom three shall be Vice-Presidents at Large, five in
charge respectively of the Districts of Dutchess, Manhattan and the
Bronx, Orange, Staten Island and Westchester, and four in charge,
respectively, of the work of Missions, Education, Christian Social Ser-
vice and the Supply Department; a Secretary, an Assistant Secretary,
a Treasurer, and a Treasurer for the United Thank Offering, all of
whom shall constitute an Executive Board.

ARTICLE V.—HONORARY OFFICERS.

The Executive Board may appoint Honorary Officers, subject to
confirmation by the Association.

ARTICLE VI.—AMENDMENT.

This Constitution, having been approved by the Bishop, may be
amended with his approval by the Association at its Annual Meeting,
two-thirds of the Representatives present concurring, notice of the pro-
posed amendments, having been given at the previous meeting.

By-Laws.

ARTICLE I.—DUTIES AND POWERS OF OFFICERS.

SEC. 1. *President.* The President shall preside at all meetings of this Association and of the Executive Board.

SEC. 2. *Vice-Presidents at Large.* A Vice-President at Large shall preside in the absence of the President. The Vice-Presidents at Large shall perform such other duties as may be assigned to them by the Executive Board, and shall present written reports of their work at the annual meeting.

SEC. 3. *Vice-Presidents.* The Vice-Presidents in charge of the Districts shall endeavor to promote the formation of Parish Branches and to help and strengthen those already existing; shall consult with the Executive Board, and shall present at the annual meeting written reports of their work for the year.

The Vice-Presidents in charge of Missions, Education, Christian Social Service and the Supply Department shall inform the Parish Branches through correspondence, visiting or providing speakers, of the needs and work in their respective departments. They shall present at the Annual Meeting written reports of their work for the year.

Each Vice-President shall appoint such persons as she may deem necessary to assist her in the performance of her duties.

SEC. 4. *Secretary.* The Secretary shall—

- (1) Issue notice of meetings;
- (2) Keep the Minutes of the Association and of the Executive Board;
- (3) Prepare and edit the annual report, and shall perform such other duties as may be assigned to her by the Association or the Executive Board.

SEC. 5. *Assistant Secretary.* The Assistant Secretary shall assist the Secretary in the performance of her duties.

SEC. 6. *Treasurer.* The Treasurer shall receive and disburse all funds of the Association and shall keep accounts thereof, and shall report to each meeting of the Executive Board and of the Association.

SEC. 7. *Treasurer—United Thank Offering.* The Treasurer for the United Thank Offering shall receive all contributions for the United Thank Offering, and under the direction of the Executive Board, endeavor to arouse and increase an interest in the same.

SEC. 8. *Auditing Committee.* The accounts of the Treasurer of the Association and those of the Treasurer for the United Thank Offering shall be audited annually by an Auditing Committee to be appointed by the President.

By-Laws.

SEC. 9. *Executive Board.* The Executive Board shall be entrusted with the general business of the Association and shall exercise all powers of the Association not herein expressly provided for. Six members of the Executive Board shall constitute a quorum.

ARTICLE II.—PARISH BRANCHES.

SEC. 1. A "Parish Branch" is a group of actual members of the New York Branch organized within a Parish.

SEC. 2. Each "Parish Branch" shall be entitled to send representatives to the District Meetings of the District in which it is situated, and shall be entitled at such meetings to one vote. The attendance of one or more representatives, or their proxies, from at least one third of the Parish Branches shall be necessary to constitute a quorum.

SEC. 3. Each "Parish Branch" shall pay annually to the Treasurer for the Expenses of the Association a sum of money to be known as Auxiliary Dues. The amount payable by each Branch shall be determined by the Executive Board—subject to approval by the Association at the November Meeting.

ARTICLE III.—FISCAL YEAR.

The Fiscal Year of this Association shall be the calendar year.

ARTICLE IV.—MEETINGS.

SEC. 1. Meetings of the Association shall be held on the first Tuesdays of every month from November to May inclusive provided that whenever the appointed day shall fall upon a public holiday or a greater festival of the Church, the meeting may be transferred to some other day. The May meeting shall be the annual meeting.

SEC. 2. These meetings shall be open to all members of the Woman's Auxiliary, but no persons shall be entitled to vote except four delegates from each organized Branch of the Woman's Auxiliary and the officers of the Association.

SEC. 3. The Secretary shall call special meetings on request of the President or five members of the Executive Board.

SEC. 4. At all meetings of this Association fifty delegates shall constitute a quorum.

SEC. 5. The Executive Board shall meet before each monthly meeting of the Association.

By-Laws.

ARTICLE V.—ELECTIONS AND NOMINATIONS.

SEC. 1. The term of office of all officers shall terminate at the Annual Meeting of 1932, and at that meeting new officers shall be elected to serve as follows:

The President shall be elected for a term of three years and thereafter for terms of three years each, her election to take place at the Annual Meeting following the Triennial Meeting of the Woman's Auxiliary.

Three Vice-Presidents at Large shall be elected to serve respectively for one, two, and three years, their successors to be elected on the expiration of their respective terms, for terms of three years each, so that annually after 1932 one Vice-President will be elected to serve for a term of three years.

The Vice-President in charge of Missions, the Vice-President in charge of Christian Social Service, the Vice-President in charge of the Supply Department, the Vice-President for the District of Dutchess, the Vice-President for the District of Manhattan and the Bronx, the Secretary and the Treasurer shall be elected for terms of two years each, their successors to be elected at the Annual Meeting in each alternate year thereafter for terms of two years each.

The Vice-President in charge of Education, the Vice-President for the District of Orange, the Vice-President for the District of Staten Island, the Vice-President for the District of Westchester, and the Assistant Secretary shall be elected for terms of one year each, their successors to be elected at the annual meeting of 1933 to hold office for two years and thereafter for terms of two years each.

SEC. 2. The President shall appoint each year a Nominating Committee of at least seven members, including at least one member from each District, to nominate and report to the Annual Meeting one candidate for each office to be filled that year; provided, that the Districts, at meetings of their respective representatives, shall be entitled to nominate their respective Vice-Presidents, and at least one month before the Annual Meeting to report their nominations to the Nominating Committee, and the Nominating Committee shall report to the annual meeting the nominations so received by them.

SEC. 3. All officers shall be elected by ballot at the Annual Meeting, and except those elected for one year in 1932 and those elected at any time to fill unexpired terms, and except the President, Vice-Presidents at large, and the Treasurer of the United Thank Offering, shall hold their offices for two years and until the election of their successors.

SEC. 4. In case an office should become vacant before the expiration of the term, it may be filled for the balance of the year in which the

vacancy occurs by appointment by the President with the advice and consent of the Executive Board, and the remainder, if any, of the unexpired term shall be filled by election at the next Annual Meeting.

SEC. 5. The Treasurer for the United Thank Offering shall be elected by ballot once every three years, at the May meeting in the same year as the triennial meeting of the Woman's Auxiliary, her election to take effect November 1st of that year. She shall hold office until her successor is elected and installed.

ARTICLE VI.—ORDER OF BUSINESS.

ARTICLE VII.—AMENDMENT.

By-Laws may be adopted, amended, suspended or repealed at any regular or annual meeting by a two-thirds' vote of delegates present, notice of proposed changes having been given at the previous meeting.
