Annual Report of the President.

It is a pleasure to present this report as the Woman's Auxiliary has had a successful year.

There are many outstanding matters, but the most important is that two missionaries have gone to the Mission Field, Miss Josephine Budd from St. George's to St. John's University, Shanghai, and Miss Gladys Spafford from Trinity Chapel to Splashdam, Va. Miss Elizabeth Nedwill of All Angels has gone back to Cuba; Miss Frances Carter Wood of the Church of the Ascension and Miss Mary G. MacDonald are doing noteworthy work in Christian Social Service.

The officers and members have cooperated, as they always do, in carrying out the policy presented by the Executive Board, and in addition have done some fine and forward-looking pieces of work. The outstanding example of this is the making of a Survey of part of Sullivan County under the direction of the Vice-President for Orange District, Miss Ramsdell. This was made with reference to possible future work among the unchurched.

During the year 8 new branches and 4 new groups have been organized. The total for the diocese is now 187 branches and 33 groups.

One of the new branches is a Neighborhood Evening Branch with members from five churches, an interesting experiment.

Following the policy of delegating more of the details to the districts, the District of Manhattan and the Bronx was more completely organized and has functioned efficiently.

The devotional life of the Woman's Auxiliary has been strengthened by a greater number of Corporate Communion, Quiet Days, Quiet Hours and periods of Intercession. Miss White has led two Bible classes and Dr. Gavin one Bible class and one class on Modern Religious Thinking.

Our subject for study, "Facing the Future in Indian Missions," roused wide interest, and many successful classes were held, closing with a Service in the Cathedral.

The need for supplies is greater than it has ever been, and Miss Hutton has been successful in placing and filling the allotments promptly.

The meetings of the Missions Committee have been interesting and well attended. The speakers represented six of our mission fields.

The Christian Social Service at Ellis Island touched the lives of 1,995 people, and 12,247 services were rendered to people of 19 nations.

Not many immigrants are coming to this country, but many are being repatriated or deported who need the help of our worker.

A remarkable record. It is less than the year before, but the difference is almost all accounted for by the fact that in 1931 we made a special effort for the United Thank Offering and the Advance Work Program on account of the Triennial Meeting. The U. T. O. is always less during the first year after Convention, but our Custodian is continuing her effort to enlist the interest of every woman of the church.

We have had seven Diocesan Meetings of which the Advent Meeting was most important. The principal speaker was Mrs. Harper Sibley who talked about "Rethinking Missions" in such a stimulating way that our sympathetic interest was stirred and we have studied the book privately, in groups, at parish and diocesan meetings, believing that it points the way to a new era in missions.

At the last meeting of the Synod of the Province of New York and New Jersey the Woman's Auxiliary presented a resolution for representation in the Synod, on the ground that women have much to gain by being granted a part in the deliberations of the Church, and also much to contribute from their practical experience in the Church's organization. The Committee of the Synod on Ordinances and Rules of Order reported to the Synod a proposed amendment to the ordinances which would give representation for women, and action on this report was postponed until the next meeting of the Synod.

There are to be several changes in our list of officers: Mrs. Macon, who has ably filled an unexpired term as Vice-President for Missions, is retiring, and her place will be taken by Mrs. Reilly, a former member of the Board, recently returned from a long visit to our missions in the Orient. Miss Boyer retires after four years of brilliant service in the Department of Education,—service that is recognized far beyond the boundaries of our Diocese. Mrs. Chapman, who succeeds her, has been trained by Miss Boyer, and is therefore fully qualified for her important post. Miss Reese, the Vice-President for the District of Dutchess has resigned. She takes with her the gratitude of the Woman's Auxiliary of her District and the diocese, for her fifteen

years of faithful service. Her place is to be taken by Miss Clarkson, who has been Vice-President at Large. Miss Waring, the Vice-President for Westchester, retires after many years during which she has earned the love and admiration of all her associates and has brought her district to a high state of efficiency. Her place will be taken by Mrs. Haff, a former member of the Board, whose ability makes her valuable in any office. Mrs. Poillon who capably filled an unexpired term as Secretary has declined re-election, to the regret of all her many friends, regret that she is leaving the Diocese, hope for her return at some time. Miss Jones, her successor, comes with experience as a Parish President and will be welcomed by the Board. Mrs. Harding, former Vice-President for Missions, will return to the Board as Vice-President for the District of Manhattan and the Bronx to take the place of Mrs. Jacoby, our new President. Her gracious personality, her efficiency in organization, her evident joy in her work, and the spiritual quality, difficult to describe but which her associates all feel, make her the ideal person to assume the office, an office full of responsibility but also full of unlimited opportunity for Our Father's service. I am deeply grateful for the privilege that has been mine during the past four years, and I retire with regret that my term is over, and with happiness because I know that under Mrs. Jacoby's able leadership our Branch will go forward to a greater accomplishment in the work to which we have dedicated ourselves, the spreading of Christ's Kingdom.

Missions Committee.

Six regular meetings have been held on the 2nd Mondays in each month at 11 o'clock, preceded by the service of Holy Communion at 10:30.

The Parishes of Trinity Chapel, St. Bartholomew, Church of the Ascension, Church of the Incarnation, Church of the Epiphany, and St. Thomas have kindly been the hosts.

The average attendance has been 28, about one-fourth the number of members of the eleven sub-committees.

Reports were made by these groups, of which the Indian and Japan gave an excellent account of having completed their year's work. China, Panama, Mexico-Cuba, and work among the Negroes well all well represented.

Speakers from the Field gave interesting and vivid descriptions of their work, stressing, in every case, the need for active support from the home base, and more workers. Among them were: Dr. Carl Ackley, who gave an illustrated tour of our work among the Southern Mountaineers; Miss Hallie Stevens, of St. Agnes School, Kyoto, Japan; Miss Alice Meacham, of the Julia C. Emery School in Liberia; Mrs. F. W. Creighton, and Miss Martha Boynton, on Mexico and the Hooker School; the Rev. Goodrich Fenner, on The Church and Rural Work; and Mrs. John Reilly, Jr. on "Personal Reminiscences in the Mission Fields in China."

Lack of space prevents giving many important details brought out by these speakers.

The varied and extensive interests of the Missions Committee make this group vital to the growth of the Church. And it is the hope of your present chairman that you all will unite, not only in maintaining the work already established, but also in developing widely new work, so necessary in this period of the world's history.

The American Indian as a subject for study made a wide appeal stimulating new classes and new leaders as well as special programs with speakers on the subject. Mr. Sniffen, Secretary of the Indian Rights Association, spoke in Westchester to a meeting attended by 148 women from 21 parishes. Mrs. David Clark addressed a general meeting on Staten Island. Trips to museums to see Indian exhibits were taken by leaders and district and parish groups. Both G. F. S. and interdenominational classes were conducted by our leaders and definite efforts were made to interest Church Schools.

Gifts from the classes were given toward the salary of Pauline Averill at Flandreau, South Dakota. Close contact has also been made with our own Indian missions.

The Bronx has for the first time provided all of its leaders for its own classes. Manhattan classes provided three new members for the Indian Committee and the new Vice-President. In Dutchess, the son of one of our leaders, spoke in Indian costume at branch meetings.

Your Vice-President led a normal class at the Wellesley Conference as well as speaking and leading training classes in other Dioceses.

Two specially planned services closed the year's work; one conducted by the Rev. Francis Frost, at St. Mary's, Staten Island, and one by Dean Gates at the Cathedral of St. John the Divine.

ANNUAL REPORT—1933

At Ellis Island during the past year the Church has had the opportunity to touch the lives of 1,995 people passing in and out through the Port of New York. Figures for the year ending June 30, 1932, show that 103,295 alien residents have been sent from these shores, while but 35,576 permanent immigrants were admitted.

Paradoxical as it may seem, these changed conditions have created far greater responsibilities for our Worker, Miss Alice Palmer, than in the days when the pendulum was swinging the other way. Services amounting to the number of 12,247 were given. These consisted of telephones, cablegrams, interviews with Government officials, collecting money, redeeming pawned valuables for warrant cases who are unable to get out and do this for themselves, collecting back pay, fixing insurance policies and arranging for weddings, baptisms and often for those who have died.

The number of different nationalities served during the year were 19. The greater number were those of the British Empire—English, Scotch and North of Ireland who are repatriated by this Government. Greek Orthodox Arabs, East Indians, Armenians, Chinese and the natives of the Balkan countries, who are not Jews or Roman Catholics, are under our Worker's supervision.

It is quite necessary for the Christian Social Service pledge of \$5,000 to be met if this vital work on the docks is to be continued. Every parish in the diocese must push its every effort to contribute its share. In order to create an added interest a representative for this work will be appointed in each district. There is great need of clothes, underwear and shoes, no matter how badly worn or out-moded, for these poor people who will otherwise be greeted as abject failures. We are sending the many back with hope in their hearts for the contacts we are able to make on other shores. We are trying to make each and every one feel the hand and heart of friendship and Christian brotherhood in this new country to which, as strangers, they had come. The majority leave with the feeling that America will again beckon them and we want them to feel that way.

All the allotments sent from National Headquarters this year, were filled, but no extra appeals were answered as has usually been the case.

The churches have done a great deal more sewing than usual. The Cutting Room record of 12,000 garments cut and shipped, is higher by 2,000 than any previous record. There has also been a renewed interest in knitting; these hand made sweaters have been specially gratefully acknowledged by the mission schools. The Wholesale Department, Mrs. W. W. Orr, Treasurer, Miss H. V. Lewis, Buyer, has done splendid work buying and billing 19,000 articles not including all the dispensary supplies.

The Monthly Supply Leaflet seems to have helped spread interest in the very personal nature of the supply work, by the letters from the missionaries who are too busy to write every parish working for them. The leaflet has also assisted the Supply Committee giving necessary information to the Parish Supply Officers.

The District has carried on well during the past trying year. Two Branches have lapsed, or died of old age, being in places where, owing to unusual circumstances, there could be no stream of new life to feed them. But to offset this Miss Fitch has gotten supply work done in small missions who are as yet unwilling to become even affiliated Groups. Miss Fitch has done unusually good work and I am sorry that she feels she must resign. We are losing a number of very efficient officers this year, and I cannot speak too highly of the work of Mrs. DeGross, Educational Secretary or of Mrs. Gjobye who has so ably assisted me, and carried my burdens for five years. In tendering my own resignation, I am proud indeed to have contributed my bit to the formative years since May, 1918, to have seen and helped the development of the Educational work from scattered classes to a powerful source of missionary information and inspiration, and to have seen the Supply work grow into the well ordered department with which we are familiar.

Dutchess has had three District Meetings during the past year. The Annual Meeting was held at Grace Church, Millbrook in May, 1932. Bishop Lloyd was Preacher and Celebrant, and after lunch we had the pleasure of receiving messages from members of the Diocesan Board and heard Mr. Collett tell of the work in the Kentucky mountains. An Open Meeting was held at St. Andrew's, Arlington, on November 3rd, when we specialized on the need of enlisting juniors and of contributing to the budget and on January 27, 1933 we held a large Officer's Conference in the Parish House of St. Paul's Church, Poughkeepsie, ending with a most beautiful and inspiring address on the Devotional side of our work by Miss Mary May White.

I have the sad task of recording the death of Miss Ida Hobbs, for thirty-five years an officer of the branch at Christ Church, Red Hook, and whose interest and devotion cannot be measured.

It is with a heart full of gratitude to all my associates, both in my District and on the Diocesan Board, who have so faithfully helped me in my work that I do what I feel sure is a forward step—hand over my cherished District to my successor, Miss Cornelia Livingston Clarkson.

The Annual Meeting was held at St. Paul's Church in Newburgh.

Bishop Burleson spoke of work among the Indians. The preacher was the Rev. E. S. Travers, D.D. of Rhinebeck. The Autumn Meeting was held at Middletown. Bishop Gilbert preached and Dr. Silver spoke on the Budget.

There have been four neighborhood meetings: at Monticello, Saugerties, Liberty, High Falls, Suffern and South Fallsburgh, besides neighborhood meetings at Tuxedo Park.

A Survey of an area of eight square miles in Sullivan County has been made by the Church Army under the auspices of the Auxiliary of Orange. It was with reference to possible future work among the unchurched. The Survey Headquarters was at Liberty. Captain Conder

gave a report of this Survey at the Autumn Meeting in Middletown, and Captain Clarke (who made the Survey), gave the same report at Saugerties.

Two Officer's Conferences have been held; at Chester and at Newburgh.

A Bible Class of six sessions was led by the Rev. Frank Gavin, Ph.D., Th.D. at St. George's in Newburgh. In Lent a Devotional Hour was led by Canon Prichard at St. George's.

We have 34 Branches; 3 adult independent Groups; 4 Parish affiliated Groups; 1 Young People's Independent Group; and 1 Junior Branch. One branch is withdrawing—St. George's Guild. Three of our branches are new; Highland and Liberty having organized as branches, and South Fallsburgh being added to our number.

We wish to add our sincere word of affection and appreciation for our retiring President, Mrs. Pierce, whose serene influence and helpful strength has meant much to us.

Constitution.

NEW YORK BRANCH WOMAN'S AUXILIARY TO THE NATIONAL COUNCIL

AS APPROVED BY THE BISHOP AND ADOPTED BY
ITS REPRESENTATIVE BODY, MAY 17TH, 1912
AND AMENDED AT THE ANNUAL MEETINGS.
MAY 8TH, 1913, JANUARY 6TH, 1920, JANU-
ARY 4TH, 1921, JANUARY 3RD, 1922, MAY 6TH,
1924, MAY 5TH, 1925, MAY 1ST, 1928, MAY
6TH, 1929, MAY 6TH, 1930, MAY 3RD, 1931.

ARTICLE I.—NAME.

The Name of this Association shall be THE NEW YORK BRANCH
OF THE WOMAN'S AUXILIARY TO THE NATIONAL COUNCIL.

ARTICLE II.—OBJECT.

The object of this Association shall be to carry out within the
Diocese of New York the purposes and work of the WOMAN'S AUXIL-
IARY TO THE NATIONAL COUNCIL.

ARTICLE III.—MEMBERSHIP.

All Churchwomen and children by virtue of their baptism are con-
sidered possible members of the Woman's Auxiliary. All those who,
in this Diocese, by their prayers, work or offerings, aid the Mission
of the Church through the National Council may become by enrollment,
actual members of the New York Branch.

ARTICLE IV.—OFFICERS.

The officers of this association shall be a President, twelve Vice-
Presidents, of whom three shall be Vice-Presidents at Large, five in
charge respectively of the Districts of Dutchess, Manhattan and the
Bronx, Orange, Staten Island and Westchester, and four in charge,
respectively, of the work of Missions, Education, Christian Social Serv-
ice and the Supply Department; a Secretary, an Assistant Secretary,
a Treasurer, and a Treasurer for the United Thank Offering, all of
whom shall constitute an Executive Board.

ARTICLE V.—HONORARY OFFICERS.

The Executive Board may appoint Honorary Officers, subject to
confirmation by the Association.

ARTICLE VI.—AMENDMENT.

This Constitution, having been approved by the Bishop, may be
amended with his approval by the Association at its Annual Meeting,
two-thirds of the Representatives present concurring, notice of the pro-
posed amendments, having been given at the previous meeting.

By-Laws.

ARTICLE I.—DUTIES AND POWERS OF OFFICERS.

SEC. 1. *President.* The President shall preside at all meetings of this Association and of the Executive Board.

SEC. 2. *Vice-Presidents at Large.* A Vice-President at Large shall preside in the absence of the President. The Vice-Presidents at Large shall perform such other duties as may be assigned to them by the Executive Board, and shall present written reports of their work at the annual meeting.

SEC. 3. *Vice-Presidents.* The Vice-Presidents in charge of the Districts shall endeavor to promote the formation of Parish Branches and to help and strengthen those already existing; shall consult with the Executive Board, and shall present at the annual meeting written reports of their work for the year.

The Vice-Presidents in charge of Missions, Education, Christian Social Service and the Supply Department shall inform the Parish Branches through correspondence, visiting or providing speakers, of the needs and work in their respective departments. They shall present at the Annual Meeting written reports of their work for the year.

Each Vice-President shall appoint such persons as she may deem necessary to assist her in the performance of her duties.

SEC. 4. *Secretary.* The Secretary shall—

- (1) Issue notice of meetings;
- (2) Keep the Minutes of the Association and of the Executive Board;
- (3) Prepare and edit the annual report, and shall perform such other duties as may be assigned to her by the Association or the Executive Board.

SEC. 5. *Assistant Secretary.* The Assistant Secretary shall assist the Secretary in the performance of her duties.

SEC. 6. *Treasurer.* The Treasurer shall receive and disburse all funds of the Association and shall keep accounts thereof, and shall report to each meeting of the Executive Board and of the Association.

SEC. 7. *Treasurer—United Thank Offering.* The Treasurer for the United Thank Offering shall receive all contributions for the United Thank Offering, and under the direction of the Executive Board, endeavor to arouse and increase an interest in the same.

By-Laws.

SEC. 8. *Auditing Committee.* The accounts of the Treasurer of the Association and those of the Treasurer for the United Thank Offering shall be audited annually by an Auditing Committee to be appointed by the President.

SEC. 9. *Executive Board.* The Executive Board shall be entrusted with the general business of the Association and shall exercise all powers of the Association not herein expressly provided for. Six members of the Executive Board shall constitute a quorum.

ARTICLE II.—PARISH BRANCHES.

SEC. 1. A "Parish Branch" is a group of actual members of the New York Branch organized within a Parish.

SEC. 2. Each "Parish Branch" shall be entitled to send representatives to the District Meetings of the District in which it is situated, and shall be entitled at such meetings to one vote. The attendance of one or more representatives, or their proxies, from at least one third of the Parish Branches shall be necessary to constitute a quorum.

SEC. 3. Each "Parish Branch" shall pay annually to the Treasurer for the Expenses of the Association a sum of money to be known as Auxiliary Dues. The amount payable by each Branch shall be determined by the Executive Board—subject to approval by the Association at the November Meeting.

ARTICLE III.—FISCAL YEAR.

The Fiscal Year of this Association shall be the calendar year.

ARTICLE IV.—MEETINGS.

SEC. 1. Meetings of the Association shall be held on the first Tuesdays of every month from November to May inclusive provided that whenever the appointed day shall fall upon a public holiday or a greater festival of the Church, the meeting may be transferred to some other day. The May meeting shall be the annual meeting.

SEC. 2. These meetings shall be open to all members of the Woman's Auxiliary, but no persons shall be entitled to vote except four delegates from each organized Branch of the Woman's Auxiliary and the officers of the Association.

SEC. 3. The Secretary shall call special meetings on request of the President or five members of the Executive Board.

By-Laws.

SEC. 4. At all meetings of this Association fifty delegates shall constitute a quorum.

SEC. 5. The Executive Board shall meet before each monthly meeting of the Association.

ARTICLE V.—ELECTIONS AND NOMINATIONS.

SEC. 1. The term of office of all officers shall terminate at the Annual Meeting of 1932, and at that meeting new officers shall be elected to serve as follows:

The President shall be elected for a term of three years and thereafter for terms of three years each, her election to take place at the Annual Meeting following the Triennial Meeting of the Woman's Auxiliary.

Three Vice-Presidents at Large shall be elected to serve respectively for one, two, and three years, their successors to be elected on the expiration of their respective terms, for terms of three years each, so that annually after 1932 one Vice-President will be elected to serve for a term of three years.

The Vice-President in charge of Missions, the Vice-President in charge of Christian Social Service, the Vice-President in charge of the Supply Department, the Vice-President for the District of Dutchess, the Vice-President for the District of Manhattan and the Bronx, the Secretary and the Treasurer shall be elected for terms of two years each, their successors to be elected at the Annual Meeting in each alternate year thereafter for terms of two years each.

The Vice-President in charge of Education, the Vice-President for the District of Orange, the Vice-President for the District of Staten Island, the Vice-President for the District of Westchester, and the Assistant Secretary shall be elected for terms of one year each, their successors to be elected at the annual meeting of 1933 to hold office for two years and thereafter for terms of two years each.

SEC. 2. The President shall appoint each year a Nominating Committee of at least seven members, including at least one member from each District, to nominate and report to the Annual Meeting one candidate for each office to be filled that year; provided, that the Districts, at meetings of their respective representatives, shall be entitled to nominate their respective Vice-Presidents, and at least one month before the Annual Meeting to report their nominations to the Nominating

By-Laws.

Committee, and the Nominating Committee shall report to the annual meeting the nominations so received by them.

SEC. 3. All officers shall be elected by ballot at the Annual Meeting, and except those elected for one year in 1932 and those elected at any time to fill unexpired terms, and except the President, Vice-Presidents at Large, and the Treasurer of the United Thank Offering, shall hold their offices for two years and until the election of their successors.

SEC. 4. In case an office should become vacant before the expiration of the term, it may be filled for the balance of the year in which the vacancy occurs by appointment by the President with the advice and consent of the Executive Board, and the remainder, if any, of the unexpired term shall be filled by election at the next Annual Meeting.

SEC. 5. The Treasurer for the United Thank Offering shall be elected by ballot once every three years, at the May meeting in the same year as the triennial meeting of the Woman's Auxiliary, her election to take effect November 1st of that year. She shall hold office until her successor is elected and installed.

ARTICLE VI.—ORDER OF BUSINESS.

SECTION 1. *Monthly Meetings.*

- (4) Report of the Treasurer for United Thank Offering.
- (5) Reports of the Vice-Presidents.

- (8) Prayer.
- (9) Adjournment.

SEC. 2. The order of business may be changed by the vote of the meeting.

ARTICLE VII.—AMENDMENT.

By-Laws may be adopted, amended, suspended or repealed at any regular or annual meeting by a two-thirds' vote of delegates present, notice of proposed changes having been given at the previous meeting.

ARTICLE VIII.
