History of the Woman's Auxiliary.

The Woman's Auxiliary to the Board of Missions came into being October 16, 1871. In January, 1872, headquarters were established in a rented room in the Bible House, New York, with Miss M. A. Emery as the first Secretary. The Mission Board assisted the Auxiliary in every possible way in getting its object known and its work established in the Dioceses all over the country. The Secretary obtained the approval of one bishop after another and one priest after another and they established diocesan and parochial branches, until in 1919, 3,678 parish branches were enrolled in the Woman's Auxiliary, and diocesan branches stretched from Hankow to Texas and Porto Rico to New York. In 1919, at the Detroit General Convention, changes took place in the organization of the Church. The general work of the Church had been carried on by three boards—Board of Missions, Board of Religious Education, and Board of Christian Social Service. At this time, the Presiding Bishop and Council was created; and the work of the Church divided among six departments of which the Department of Missions is one. The Woman's Auxiliary which had been for nearly fifty years Auxiliary to the Board of Missions, became Auxiliary to the Presiding Bishop and Council, now known as The National Council.

The New York Branch was organized in 1896 by the merging of four committees, Foreign, Domestic, The Niobrara League for Indians, St. Augustine's League for Colored People, all of which had been at work since 1874. Mrs. Charles B. Curtis was elected President, Miss Margaret A. Tomes, Secretary, Miss Anne Deas Duane, Treasurer. Upon the resignation of Mrs. Curtis about 1898, Miss Tomes served as Acting President and Secretary, and during this interval the first constitution for the New York Branch of the Woman's Auxiliary to the Board of Missions was framed and adopted. In 1919, under the presidency of Miss Delafield, the constitution was amended and the New York Branch became Auxiliary to the National Council.

Annual Report of the President.

MAY 1st, 1934

"For we commend not ourselves again unto you, but give you occasion to glory on our behalf, that ye may have somewhat to answer them which glory in appearance, and not in heart."

II Cor. v. 12.

In presenting the report of the Woman's Auxiliary, the great organization through which the women of the Diocese express their love for the missionary work of the Church, it is given with a deep sense of gratitude that our efforts have been so successful. The officers and members have worked together with a singleness of purpose and a spirit of dedication that made failure impossible.

The year has been one of many joys, but it has also had its share of sad realities. Last September, within a few days of each other, two of our best friends left this life. Miss Margaret A. Tomes was one of the most remarkable figures in the entire history of the Woman's Auxiliary. At the age of twenty, as a member of the Niobrara League, her active interest in missionary work began. For sixty years her devoted service was an inspiring example to countless women, and until her last moment, her love for the Mission of the Church was the dominant factor in her life. Mrs. George Zabriskie for many years served the Auxiliary with a depth of understanding and an affectionate insight that makes her loss keenly felt. Typical of her life's desire to establish the Kingdom, is a bequest whereby the Woman's Auxiliary will have perpetual aid for its Advance Work. While it is natural for us to miss the lovely influence of personal contact with all our faithful departed, we are happy in the certain knowledge of their great reward.

Much progress has been made in deepening the devotional life of the Auxiliary. The Quiet Day for Prayer was observed throughout the Diocese, and nearly 8,500 women were offering Intercessions on that day. Almost every Branch recognizes the inestimable value of Corporate Communion, and additional Quiet Days, Quiet Hours, Retreats, Hours of Intercession or Prayer Groups were held according to the particular needs. Miss White conducted a class in the development of Prayer, Dr. Gavin a class on Liturgy and Worship, and Dr. Easton a class on the Life of Our Lord.

The outstanding event of the year was the Advent Meeting, when we were privileged to have our Bishop with us all day, as Celebrant at the Corporate Communion in the Cathedral, and as presiding officer at the afternoon Missionary Meeting in the Synod Hall. The Rev. Joseph Fort Newton, D.D., of Philadelphia, preached in the morning with great inspiration, and over a thousand women, the largest number in our history, gained much strength from the Service. In the afternoon we were honored with addresses by the Presiding Bishop, the Right Rev. James De Wolf Perry, D.D., Bishop Larned, and the Rev. Daniel A. McGregor, Ph.D. We also rejoiced greatly in having Bishop Lloyd on the platform.

The six other Diocesan meetings have been very well-attended. We have had such interesting speakers as Bishop Roots of Hankow, Bishop Cook of Delaware, Canon Prichard, the Rev. C. Rankin Barnes, Deaconess Maria Williams and our own Miss Alice Palmer.

The Christian Social Service at Ellis Island, as carried out by Miss Palmer, has helped 1,184 persons, and 4,475 services were rendered to people of 20 nationalities. Our worker has been important as a consultant in the various changes and readjustments of the past year at Ellis Island, and with the recognition of Russia we will have close contact with the immigrants of the Greek Orthodox Church. Mrs. Kerley has stimulated much interest in this work, and has made good progress in building up parish gifts.

The educational work has been built around the subject "Christ and the Modern World," with special emphasis on our Christian Missions in the Orient. Mrs. Chapman has had enthusiastic response and great success, with 153 parishes taking part in the Mission study, a gain of 12 parishes over last year. There has also been a marked increase in attendance, both at the classes and at the closing Service at the Cathedral.

Miss Hutton has done a remarkable piece of work in the Supply Department. Almost every supply allotment was filled, and in these days, that statement calls forth speechless amazement and admiration. Eighty-seven parishes are on the Honor Roll, which means that they did more work than last year. Twelve branches and three groups that had not done supply work before, shared in this year's activities.

The five Districts have functioned smoothly, and the Vice-Presidents in charge report that 5 new branches and 1 new group have been formed, making a total of 192 branches and 31 groups. We find great encouragement in the marked interest of really young women, and the increased attendance at all meetings, whether Branch, District or Diocesan has been very stimulating.

Although the Missions Committee has not had its own Chairman this year, the sub-Committees have been most loyal in their support. The recommendation of the Executive Board, that Budget be considered our first obligation, was adopted. Three large meetings were held and constructive plans were made. Addresses by Bishop Beecher, Miss Dorothy Fischer and Mr. Daniel A. Poling, Jr., aroused much interest.

We are happy that, by concentration of effort, we not only met, but overpaid, our pledge for Budget. We pray, too, that during this summer our hearts may find many reasons for expressing gratitude through the United Thank Offering, so that the Triennial Presentation may show that we are mindful of our blessings.

We deeply regret losing three members from our Executive Board. Miss Ramsdell has served continuously as Vice-President in charge of the District of Orange for the past seventeen years. Her keen vision and wise counsel made her a very valuable member of the Board, and her gentle spirit has endeared her to all her associates. Mrs. Van Bokkelen began her service on the Executive Board eighteen years ago. It was later interrupted, but for the past six years she has been the faithful Custodian of the United Thank Offering. Her untiring efforts and great devotion have been full of the love of our Gift of Thankfulness, and she has accomplished much. Mrs. Harding again leaves the Board after having filled an unexpired term as Vice-President in charge of the District of Manhattan and the Bronx. She is an experienced and able member of the Board in whatever capacity she serves, and her flying Squadron of District Officers was most successful. We shall miss these three at our Board meetings, but we know that they will always work with and for the Woman's Auxiliary.

We are very grateful for the splendid cooperation of the clergy, and for the many friends outside the Auxiliary who have given us aid.

It is impossible to express adequate appreciation of the constant and immediate help given to us by Bishop Manning, whose kindly wisdom has eased our perplexities, and whose great interest has inspired our best efforts.

Annual Reports of Vice-Presidents.

As Vice-President at large I had the privilege of visiting some parishes to speak on general aspects of the work of the Woman's Auxiliary in our Diocese.

From the Church Missions House I learned of the need for workers in the Mission field. China, for one, asks—has long asked—for ten young women trained along definitely religious lines,—“evangelistic workers” as soon as qualified volunteers can be found, and conditions enable the Church to send them. In the immediate present there were openings for two graduate nurses, one in China, and one in Japan,—the latter at St. Luke's Hospital. I put these specific calls before some of the clergy, and a Church guild for nurses. Also, I asked our District Vice-Presidents to give in their various districts such publicity to these openings as was consistent with the requirements, in the hope that fitting candidates might be found in this Diocese.

Devotional Life.

The aim of our devotional life for the past year has been to learn to pray with greater power.

During October a class in the study of prayer was held in the Parish House of the Church of the Heavenly Rest. Mrs. E. Wadsworth Hotchkiss arranged for this class, which was led by Miss Mary May White.

In order that we might be better informed, The Rev. Frank Gavin, Ph.D., Th.D., LL.D. conducted a class on “Our Prayer Book.” The subjects of his discussions were:

- The History and Principles of Worship
- The Ideals of the Book of Common Prayer
- The Offices of Prayer, Praise and Penitance
- The Eucharist as a Sacrament
- The Eucharist as a Sacrifice of Praise and Thanksgiving.

Dr. Gavin's class was held at 26 East 73rd Street during November, and was of great inspiration to those Auxiliary women who availed themselves of this privilege.

Dr. Burton S. Easton, S.T.D. held a class in the study of “The Life of our Lord”, which was open, not only to all members of our Women's Auxiliary, but to their friends as well. This class met in St. Bartholomews Community House during January. We are indebted to Dr. Easton for the helpful instruction he gave us.

It is to be hoped that all of us, as members of our Diocesan Auxiliary, have taken time during the year, and have made true efforts by our own will power, to bring ourselves nearer to God. Only by daily keeping ourselves in close companionship with Him can we hope to live with Christian poise and dignity, so making ourselves of greater service in God's Eternal Kingdom.

The educational work for the season of 1933-1934 centered in the theme *Christ and the Modern World*, with special emphasis on Christ and the Orient and our Christian Missions there.

In Westchester, Miss Edna M. Brigham reached fifty-one branches of a possible fifty-five, an increase of seven over last year's record. In Manhattan forty-six parishes were reached. Under the leadership of Mrs. C. M. Baxter, Jr. the educational program was presented in thirty Day Branches. For the Evening Branches—Mrs. Carleton Montgomery reported work in sixteen parishes. In the Bronx—Mrs. William Trimmer organized study in nine. In the District of Dutchess, Mrs. R. W. Andrews reported eighteen parishes participating in the educational program. In Staten Island, under the leadership of Mrs. R. C. Hanaway—nine branches were reached. In the district of Orange, Mrs. Louis G. Hoffmann reported work in nineteen parishes.

The total number of branches studying Christ and the Modern World was 153, a gain of twelve over last year's report. Attendance has shown a marked increase and we anticipate greater interest, because of the large number of adults, eager to utilize their leisure time with constructive and stimulating study. Even though contributions were not emphasized, generous gifts were made toward the salary of Miss Margaret Hester, a kindergarten supervisor in the District of Kyoto, Nara, Japan.

Recognizing the leadership of the Episcopal Church in Missionary Education, the Presbyterians, Methodists and other denominational groups—both in Westchester and Dutchess—asked to join our classes.

By request of the Clergy, a number of discussion groups were held in the evenings, so that those—both men and women—who were employed during the day might attend. In one such parish in Manhattan six sessions were held in conjunction with the Sunday Evening service, the total attendance being 417.

A special service of Intercession with a Corporate Communion at the Cathedral of St. John the Divine was the culmination of the year's program. In Staten Island a similar service was held.

This significant development and impressive success has been attained only by the steady and persevering devotion of the District Educational Secretaries. It is with profound gratitude that we pay an especial tribute to Miss Laura Boyer who has served as a member-at-large and who has been a constant source of inspiration and strength.

Your Vice-President conducted ten sessions of normal classes for the training of prospective leaders,—has promoted the general educational program in the six districts of this Diocese, and plans to conduct a course in Missionary Education at a Summer Conference for the Junior Woman's Auxiliary of the Province of Washington.

It is gratifying to record the results of the past year's work. The subject studied brought a deeper realization of the obligation of all Christian women, to rethink their own lives in terms of the Purpose of God.

The past year has been a most interesting one for Ellis Island. Three very significant events have taken place, which have a definite bearing upon the Ellis Island work.

First: The merging of the Immigration and Naturalization Services under one Department.

Second: The appointment of a Committee of forty-eight Citizens to investigate conditions at Ellis Island and to recommend changes.

Third: The recognition of Russia. This has made it possible to obtain passports for many who could not obtain them before, and has enlarged our Information Service at the Island, as many of these Russians are of the Greek Orthodox Faith and come to the Worker for advice and assistance.

During the year a total of 1,184 people, involving 20 Nationalities were assisted. The Voluntary Removals as in years past constituted the larger number.

Services to the number of 4,475 were rendered. These services included: Writing and sending of letters, cables, and telegrams; searching for and obtaining baggage; shopping for warrants; investigations

made in behalf of separated families; appeals on worthy cases made to Washington; conferences with Immigration Officials on cases needing special consideration; collecting salary and deposits from banks and distributing literature and clothing.

Also worthy of mention, are our services involved in work with the aliens detained in Ward 23 of the U. S. Public Health Service. This is the Ward where all Immigration Cases are sent, and the work with them is most important, for while in the Hospital those cases which are not bad cases are closely confined and time hangs heavy on their hands. Literature and games and writing materials are given to them and everything done for their comfort. Many of the cases are alien seamen suffering from malaria and several from frozen feet and hands.

The inquiries from other agencies, local and otherwise, constitute an important phase of the work. Working as closely as we do with the Government, we are in a position to be informed of changes in the law, rulings on certain cases, and to get advice as to procedure on appeals and other avenues of help for the alien.

Religious Services are arranged and conducted by the Chaplain. The people look forward eagerly to the Sunday morning Services for the music and the words of encouragement that are given to them at this time. It is interesting to note that while they lounge about all the week in any old clothes and are not particular about shaving, Sunday morning finds them all sleek and shaven, a clean shirt and ready for the services. If they haven't a clean shirt, they borrow one from the more fortunate ones; but their one idea is to look a little different on Sunday than on any other day.

We who work for the Church and its spiritual objectives, know that we cannot be Nationalistic in our attitudes—dealing with many people from many different lands—our point of view is International in scope. Our efforts are turned to strange lands as we try to help in the adjustment of some one who has passed through the portals at Ellis Island; and while Nations may in their dealing recognize International boundaries, *the Church cannot do so*. We realize more and more each day as we work with these people St. Paul's idea that there is neither Greek nor Jew, barbarian, Sythian, bond or free; but *all are one* in Jesus Christ. This is our approach to each individual we meet here—seeing them not in the light of their present difficulties, but as human souls in dire time of need, spiritual need as well as material. After all, it is the fullness of the spiritual life of men that really matters—all else is only means to that end.

At this time when there is an awakening of deeper interest in the welfare of the foreign-born, our task as an agency is to stand by and give our shoulders to the wheel, for we have come to see that our work is not finished when we admit the alien to our shores—we must work for the elimination of *racial prejudice*, for deeper appreciation of what the immigrant has contributed to us from his cultural background.

The Church has a definite part in any such programme, and as in the past will mark time with any plan for bringing the message of the

Church close to its part of the fourteen million foreign-born now in our country. The Woman's Auxiliary Mission at the doorstep of our country, has been a veritable rock in a weary land during the many years of its service and especially during the difficult period of the last few years.

Please note that this report is from January 1933 to January 1934.

The report includes supplies sent through the Altar Department for 31 missions and missionaries, consisting of 12 stoles, 8 sets of altar

linen, 4 cassocks, 6 burses and veils, 2 albs, 1 chasuble, 13 mortar boards, 3 sets of hangings, 1 chalice and paten.

The allotments for New York this year were:

- 57 boxes for missionaries and their families
 - 61 five dollar gift boxes for U.T.O. workers in the field
 - 11 catechists' boxes
 - 24 missions, hospitals and mission schools
- Also parts of allotments for 10 missions and hospitals.

As you see, the total value of the work done in 1933 is \$4997.33 less than that of 1932. This is really entirely unnecessary. There are eighty-seven parishes on our Honour Roll, which means parishes that have excelled their record for the previous year, in their vision of the needs of Christians beyond our own doorsteps. This is really quite wonderful as the parishes are by no means those that are supposed to be the strongest in Church responsibility. The point to take to our hearts is that if these parishes realized and worked for the greater needs of our missions in these days of stress, why cannot the remaining 133 do the same? I feel that I have failed to present the cause, and if I should be elected to carry on the Supply work for the next two years I ask your prayers for a greater vision and ability.

I would like once more to stress the fact that only the work done for the institutions allotted to us can be counted in the Diocesan report. They are the needs for which we as a Diocese have made ourselves responsible. The needs of all the other mission institutions are being cared for by other dioceses, and if we do not fill our own allotments *our* missions will go without, and the others will have a double supply. Please cooperate with our National Board in their effort to deal fairly by *all* our mission institutions, and not have some with empty cupboards and others, with leaders who are more gifted in appealing, but doing no better work, have their closets overflowing. Try to make your members and officers realize this.

Mrs. R. D. Murray and her Cutting Room Committee have cut 11,225 garments against 12,000 last year.

Mrs. John C. Cattus has cut 116,250 surgical dressings which is less than last year, but it was felt at headquarters that this part of our supplies could be cut down with less harm to our missions than the others, so our allotments were nothing like as large as last year.

Miss Helen V. Lewis the buyer for the wholesale work bought 19,000 articles last year, and this year 51,000. She has taken the reduced treasuries of the parishes so much to heart that she has scoured the country and wholesale markets to find the best bargains and has had a very difficult time as the prices have gone up so enormously this year.

The Supply Committee hears with sinking hearts of the retirement from its ranks of Mrs. William Walker Orr. She has had charge of the Orders and Accounts for the past two years since her retirement as Vice-President in charge of the Supply Department. In spite of being handicapped for nine months by her serious accident she has

carried on unflaggingly and her knowledge of the missions and missionaries and the work generally has been a spur and an inspiration to us all.

With God's help let us try to excel, not others but ourselves, this coming year.

Believing that a Parish Branch cannot approximate its full capacity without complete understanding of and compliance with the Diocesan Auxiliary program, the District Committee developed a Team, of two or more members, to visit Parish Branches or Neighborhood Meetings, there to interpret the various aspects of the current missionary program. This team work was on a strictly spiritual and educational basis, the word "money" was taboo. Team members were not money-getters nor "campaigners" nor exhorters; all we aspired to do was to bring a friendly, non-critical, interest along with a definite aim to pass on the information at our disposal. Perhaps one result was what the President of St. Mary's Manhattanville called "humanizing the Auxiliary." We have spoken at twenty meetings, reaching more than 800 women, and some men, and there are four engagements to fill in May; at St. Andrews Church, The Bronx, we were given the sermon time, Team members speaking from the Chancel steps.

Two Branches have been formed:—All Saints Evening Branch
All Angels Junior Branch

One branch dissolved—Church of the Ascension—and a substitute committee to concentrate on a single mission field has been formed.

Officers Institutes were held for The Bronx, Upper and Lower Manhattan and the Evening Branches; each was preceded by a Quiet Time.

THE BRONX. Neighborhood Meetings have been organized and directed by Mrs. Joseph R. Kinney, Chairman for the Bronx, with an average attendance of 113, demonstrating the soundness of this means of creating and maintaining interest. Each offering was designated for some specific department of New York Branch work.

EVENING BRANCHES. The Christian Year was emphasized through bi-monthly meetings in the seasons of Epiphany, Lent and Ascension. Supplies and Education have been speeded up by the appointment of Supply and Educational Secretaries who have concentrated on these two departments. At each meeting, the United Thank Offering and Christian Social Service have been presented by District officers.

At all meetings, Parish Branch, Evening Branch, Neighborhood, there has been personal witness of the power of Jesus Christ and that His way is the only way.

The Annual Meeting was held at the Church of the Good Shepherd, in Newburgh, with an attendance of about 300. The preacher was the Rev. Bernard Iddings Bell, D.D. Bishop Gilbert spoke on the Budget, and the offering was given to the Supplementary Budget Fund. Mrs. Kerley spoke, by special request, on Ellis Island. The Autumn Meeting was held at the Church of the Holy Cross, in Kingston. Bishop Gilbert preached. Mrs. Hollis Smith, of China, was the missionary speaker. Captain George Clarke of the American Church Army reported on work among the unchurched people of our District. 200 people (a very good autumn attendance) were present.

Two Officers' Institutes were held; in Newburgh and in Chester. We feel that an advance has been made in program, interest and attendance.

Neighborhood meetings have been held at Marlborough, Callicoon, South Fallsburgh, West Park, Haverstraw, Cornwall, Nyack, Monticello, and Suffern; nine, in addition to the frequent Parish-neighborhood meetings at Tuxedo Park. Four of the addresses were on the women and girls of China. The meeting at Cornwall was a Representative meeting to vote for a District Vice-President. Our efficient Educational Secretary, Mrs. Hoffmann was unanimously nominated. Dr.

Sherman appropriately spoke on Christ and the Modern World. In Easter week Mrs. John Marshall Chew entertained the District Committees. The retiring and in-coming Vice-presidents were guests of honor.

In Department efforts, the Devotional element of the past few years (including this one) has been very gratifying: Mrs. Carr reports Armistice Quiet Day as giving the best response of the kind in her period of service. High lights in this line (of which I have space to mention but four) are as follows: Dr. Gavin's Quiet Hour at St. George's, Newburgh; a three-hour Prayer session at Montgomery, to begin their working season; the inclusion, at Liberty, of men as well as women in the Armistice prayer-hours; and at Cornwall a whole branch session given to consider the Bishop's Call.

The Educational report shows, curiously, exactly the same number of classes as last year, but not in identical branches: Forty sessions with three Union groups; eight Intensive Days, eleven Classes. Parish interest has spread. Some rectors felt much interest and led the classes. We had three stimulating Normal Intensive Days. I take pleasure in recording that through the inspiration of the past Auxiliary Educational Sessions a desire was aroused to reach the unchurched people of our District. In order to help in this without drawing upon Auxiliary resources a band of Church Army Associates has been formed, largely financed by devout and public-spirited women outside Auxiliary interests. A Survey of ninety square miles has been made by our worker; a mission has been established, with regular services and a Sunday School; contacts with Churches have been made; and many have been brought to baptism.

In Supply Work the branches filled their allotments from January to January, as much in bulk as usual though the valuation is less than usual because of lower prices in clothing. The Lenten allotments met with a good response. We think the branches did very well in a difficult time. On every hand regret is expressed that Mrs. George Smith is obliged to resign through illness.

What especially impresses me in our District is the vitality in the various Divisions; the readiness of officers and members to give their help; and the unity that prevails. We have two new branches; our youngest, nicely started at Arden; a remarkable one, at Nyack, which sprang up full-fledged; and last, but by no means least, a new Junior Auxiliary at Highland. One branch has lapsed; one is in solution; one has not responded for two years; and one has happily re-organized. Our numbers are thirty-five Branches, three Groups, and four Parish-Groups. Practically every Parish and Mission either now belongs to the Auxiliary, in some form, or has belonged to it, within my term of office. The three or four that have gone out, meanwhile, because of parish changes, we are trying to bring back. I must mention a distinct loss to the Auxiliary, more especially to her own branch and in her home town, in the death of Mrs. Lord of Chester, the branch president.

It has been difficult for me to lay down a work which I have loved so much. During the years while I have had the charge of Orange, we have had a line of gifted and gracious women as Diocesan Presidents; Miss Delafield, Mrs. Elliott, Mrs. Thorne, Miss Sullivan; Mrs. Pierce; and now Mrs. Jacoby. It has been a pleasure and a privilege to know them and to work with them, and with the other rare women on the Board and in our District. I thank them all for many kindnesses.

The Westchester Annual All-Day Meeting held at Christ Church, Bronxville on May 17th, 1933 was the largest in the history of the District. 691 members, fourteen visitors, and thirty Rectors responded to the roll-call, representing fifty of our parish branches. The meeting marked the retirement from office of Miss Janet Waring as Chairman of the District after eleven years of devoted, consecrated service. In her honour, a Processional Cross was given to the Mission of the Good Shepherd, Fort Defiance, Arizona. The preacher at the morning service was Canon Prichard and the speakers at the afternoon meeting were Bishop Casady of Oklahoma, Miss Anne Cady of the Mission of the Good Shepherd, Fort Defiance, Arizona, and Miss Anne Park from St. Anne's Preventorium, Mission Home, Virginia. The summer pledge, amounting to \$2445.00 completed first, Westchester's piece of Advance Work for this Triennium, the Connection of the Mission's Lighting System with the proposed plant at the Government Station at Fort Defiance, and then yielded \$1803.00 for Budget in the Missionary District of Oklahoma.

The election at this meeting of nine Managers for nine Units in the District, a change of organization, was the beginning of the plan for

holding nine Officers' Institutes, one in each Unit, in the early fall. Fifty-one out of fifty-four branches were represented at these institutes. The Vice-Chairman of the District, Miss Laura F. Boyer, led the discussion on a five-point program for the new year's work; Worship, Education, Supply, United Thank Offering, and Pledges.

The results of the institutes have been plainly shown in the year's work. Forty-nine parishes took part in the Day for Prayer, November 11th, 1933 and definite plans for Corporate Communion and Quiet Days and Hours were made.

Two Intensive Days for the training of leaders were planned by the Educational Department under the untiring leadership of the District Educational Secretary, Miss Edna Brigham. Fifty-one out of fifty-four parish branches participated in the educational work this year.

Mrs. Eschbach, the indefatigable District Supply Secretary felt in closer touch all through the year with the parish branches because of these nine small meetings with her parish supply officers. The money for the Dispensary Fund became this year a regular item for the parish branch treasuries and so has come in earlier and has been forwarded to meet the great needs of the missions during this hard winter. Second-hand clothing has also been sent forward in a steady stream. The Chairman of the District visited the Mountain Missions of the Blue Ridge Archdeaconry of Virginia in January and was able upon her return to report the arrival of boxes and dispensary money and the real help to the missions which these supplies give.

The United Thank Offering Play, the Blue Box Convention, was widely used and some branches have reported that the Spring offering has again reached pre-depression proportions. The Vice-Chairman of the District, Mrs. C. Helme Strater, has been speaking for the United Thank Offering and by her addresses has stimulated increased giving.

The parish branches faced their obligations also at the Institutes honestly and with great earnestness and the close of the fiscal year, December 31st, 1933 found the two Westchester pledges for the Fanny Schuyler Memorial, Liberia, and for the Mission of the Good Shepherd, Fort Defiance, Arizona, paid in full. Goodly sums were forwarded also for Ellis Island and the Diocesan pledge for Quota; no easy task with the ever increasing pressure of secular needs in each community.

Finally as a result of the nine Institutes for parish officers, the Westchester Committee held a Training Institute for itself in January based on the four letters, C.A.R.E.—a District Officer *Cares* for her work; a District Officer *Arranges* her time; a District Officer *Renews* her inner spirit; a District Officer *Elects* to serve.

Six neighborhood meetings and interesting parish programs have been reported. In addition, members of the Westchester Committee have spoken to thirty-seven individual branches, and met at two Presidents' meetings officers and members from thirteen more, making fifty parish branches seen intimately this winter.

The high point of the year, however, was the work done in co-operation with the Forward Movement in the Archdeaconry of Westchester. At the Bishop's Meeting in November, the District Supply Department arranged an exhibit showing the Supply Work of the year. The Bishop's Call in the month of January found an immediate answer in three Quiet Hours. More than 500 women attended these meetings and were grateful for the spiritual help received from them. An evening meeting for the discussion of the Christian Way of Life was attended by a group of sixty-five business and professional women and so interesting was the discussion that two meetings of the same character are to be planned next year.

In a recent book, "When Half Gods Go" by Frank Kingdon, there is the following quotation: "It would not be far from the truth to say that the most powerful factor in human history is apathy," a sad but true commentary on life. This report with its details of meetings and attendance represents our effort in Westchester to combat the all too easy habit of apathy. A definite plan, with a definite goal, and a definite effort to reach that goal; this is our aim and our endeavor. Last year in May, at our annual meeting, the District of Westchester presented a Cross to a Mission in honour of our Chairman, Miss Waring. This year, at our Annual Division Meetings, May 17th, 18th, and 22nd, the District of Westchester will present this record of the year's achievements, hoping that in it will be seen, a real and intense effort to honour all those leaders whose aspirations for us in the past have made the present possible.

The Treasurer's Report covers the calendar year 1933. Gifts that are to be credited to 1934 should be sent to the Treasurer, Miss Isabel M. Peters, 30 East 71st Street, on or before December 31, 1934.

The pledges this year are:

\$30,000 for Budget

3,000 for Christian Social Service.

The National Council cooperates with the Diocesan Treasurer in the administration of the funds of the Church, in what is known as the "Partnership Principle." In this diocese every dollar that is sent for budget undesignated is divided in the proportion of 46 to 54. 46 cents is sent to the Diocesan Treasurer and is used for the diocesan budget, chiefly missions. 54 cents is sent to domestic and foreign missions, about half and half. Therefore, out of each dollar sent for undesignated budget by a branch, about three-fourths stay in this country and one-fourth is sent abroad.

"Each parish branch shall pay annually to the Treasurer for the expenses of the Association a sum of money to be known as Auxiliary Dues." (By-Laws, Art. II, Sec. 3).

If a branch does not pay its dues it will be listed as a group.

Constitution.

NEW YORK BRANCH WOMAN'S AUXILIARY TO THE NATIONAL COUNCIL

AS APPROVED BY THE BISHOP AND ADOPTED BY
ITS REPRESENTATIVE BODY, MAY 17TH, 1912
AND AMENDED AT THE ANNUAL MEETINGS.
MAY 8TH, 1913, JANUARY 6TH, 1920, JANU-
ARY 4TH, 1921, JANUARY 3RD, 1922, MAY 6TH,
1924, MAY 5TH, 1925, MAY 1ST, 1928, MAY
6TH, 1929, MAY 6TH, 1930, MAY 3RD, 1931.

ARTICLE I.—NAME.

The Name of this Association shall be THE NEW YORK BRANCH
OF THE WOMAN'S AUXILIARY TO THE NATIONAL COUNCIL.

ARTICLE II.—OBJECT.

The object of this Association shall be to carry out within the
Diocese of New York the purposes and work of the WOMAN'S AUXIL-
IARY TO THE NATIONAL COUNCIL.

ARTICLE III.—MEMBERSHIP.

All Churchwomen and children by virtue of their baptism are con-
sidered possible members of the Woman's Auxiliary. All those who,
in this Diocese, by their prayers, work or offerings, aid the Mission
of the Church through the National Council may become by enrollment,
actual members of the New York Branch.

ARTICLE IV.—OFFICERS.

The officers of this association shall be a President, twelve Vice-
Presidents, of whom three shall be Vice-Presidents at Large, five in
charge respectively of the Districts of Dutchess, Manhattan and the
Bronx, Orange, Staten Island and Westchester, and four in charge,
respectively, of the work of Missions, Education, Christian Social Serv-
ice and the Supply Department; a Secretary, an Assistant Secretary,
a Treasurer, and a Treasurer for the United Thank Offering, all of
whom shall constitute an Executive Board.

ARTICLE V.—HONORARY OFFICERS.

The Executive Board may appoint Honorary Officers, subject to
confirmation by the Association.

ARTICLE VI.—AMENDMENT.

This Constitution, having been approved by the Bishop, may be
amended with his approval by the Association at its Annual Meeting,
two-thirds of the Representatives present concurring, notice of the pro-
posed amendments, having been given at the previous meeting.

By-Laws.

ARTICLE I.—DUTIES AND POWERS OF OFFICERS.

SEC. 1. *President.* The President shall preside at all meetings of this Association and of the Executive Board.

SEC. 2. *Vice-Presidents at Large.* A Vice-President at Large shall preside in the absence of the President. The Vice-Presidents at Large shall perform such other duties as may be assigned to them by the Executive Board, and shall present written reports of their work at the annual meeting.

SEC. 3. *Vice-Presidents.* The Vice-Presidents in charge of the Districts shall be Chairmen of their respective Districts and shall endeavor to promote the formation of Parish Branches and to help and strengthen those already existing; shall consult with the Executive Board, and shall present at the Annual Meeting written reports of their work for the year.

The Vice-Presidents in charge of Missions, Education, Christian Social Service and the Supply Department shall be Chairmen of their respective Departments and shall inform the Parish Branches through correspondence, visiting or providing speakers, of the needs and work in their respective departments. They shall present at the Annual Meeting written reports of their work for the year.

Each Vice-President shall appoint such persons as she may deem necessary to assist her in the performance of her duties.

SEC. 4. *Secretary.* The Secretary shall—

- (1) Issue notice of meetings;
- (2) Keep the Minutes of the Association and of the Executive Board;
- (3) Prepare and edit the annual report, and shall perform such other duties as may be assigned to her by the Association or the Executive Board.

SEC. 5. *Assistant Secretary.* The Assistant Secretary shall assist the Secretary in the performance of her duties.

SEC. 6. *Treasurer.* The Treasurer shall receive and disburse all funds of the Association and shall keep accounts thereof, and shall report to each meeting of the Executive Board and of the Association.

SEC. 7. *Treasurer—United Thank Offering.* The Treasurer for the United Thank Offering shall receive all contributions for the United Thank Offering, and under the direction of the Executive Board, endeavor to arouse and increase an interest in the same.

By-Laws.

SEC. 8. *Auditing Committee.* The accounts of the Treasurer of the Association and those of the Treasurer for the United Thank Offering shall be audited annually by an Auditing Committee to be appointed by the President.

SEC. 9. *Executive Board.* The Executive Board shall be entrusted with the general business of the Association and shall exercise all powers of the Association not herein expressly provided for. Six members of the Executive Board shall constitute a quorum.

ARTICLE II.—PARISH BRANCHES.

SEC. 1. A "Parish Branch" is a group of actual members of the New York Branch organized within a Parish.

SEC. 2. Each "Parish Branch" shall be entitled to send representatives to the District Meetings of the District in which it is situated, and shall be entitled at such meetings to one vote. The attendance of one or more representatives, or their proxies, from at least one third of the Parish Branches shall be necessary to constitute a quorum.

SEC. 3. Each "Parish Branch" shall pay annually to the Treasurer for the Expenses of the Association a sum of money to be known as Auxiliary Dues. The amount payable by each Branch shall be determined by the Executive Board—subject to approval by the Association at the November Meeting.

ARTICLE III.—FISCAL YEAR.

The Fiscal Year of this Association shall be the calendar year.

ARTICLE IV.—MEETINGS.

SEC. 1. Meetings of the Association shall be held on the first Tuesdays of every month from November to May inclusive provided that whenever the appointed day shall fall upon a public holiday or a greater festival of the Church, the meeting may be transferred to some other day. The May meeting shall be the annual meeting.

SEC. 2. These meetings shall be open to all members of the Woman's Auxiliary, but no persons shall be entitled to vote except four delegates from each organized Branch of the Woman's Auxiliary and the officers of the Association.

SEC. 3. The Secretary shall call special meetings on request of the President or five members of the Executive Board.

By-Laws.

SEC. 4. At all meetings of this Association fifty delegates shall constitute a quorum.

SEC. 5. The Executive Board shall meet before each monthly meeting of the Association.

ARTICLE V.—ELECTIONS AND NOMINATIONS.

SEC. 1. The term of office of all officers shall terminate at the Annual Meeting of 1932, and at that meeting new officers shall be elected to serve as follows:

The President shall be elected for a term of three years and thereafter for terms of three years each, her election to take place at the Annual Meeting following the Triennial Meeting of the Woman's Auxiliary.

Three Vice-Presidents at Large shall be elected to serve respectively for one, two, and three years, their successors to be elected on the expiration of their respective terms, for terms of three years each, so that annually after 1932 one Vice-President will be elected to serve for a term of three years.

The Vice-President in charge of Missions, the Vice-President in charge of Christian Social Service, the Vice-President in charge of the Supply Department, the Vice-President for the District of Dutchess, the Vice-President for the District of Manhattan and the Bronx, the Secretary and the Treasurer shall be elected for terms of two years each, their successors to be elected at the Annual Meeting in each alternate year thereafter for terms of two years each.

The Vice-President in charge of Education, the Vice-President for the District of Orange, the Vice-President for the District of Staten Island, the Vice-President for the District of Westchester, and the Assistant Secretary shall be elected for terms of one year each, their successors to be elected at the annual meeting of 1933 to hold office for two years and thereafter for terms of two years each.

SEC. 2. The President shall appoint each year a Nominating Committee of at least seven members, including at least one member from each District, to nominate and report to the Annual Meeting one candidate for each office to be filled that year; provided, that the Districts, at meetings of their respective representatives, shall be entitled to nominate their respective Vice-Presidents, and at least one month before the Annual Meeting to report their nominations to the Nominating

Committee, and the Nominating Committee shall report to the annual meeting the nominations so received by them.

SEC. 3. All officers shall be elected by ballot at the Annual Meeting, and except those elected for one year in 1932 and those elected at any time to fill unexpired terms, and except the President, Vice-Presidents at Large, and the Treasurer of the United Thank Offering, shall hold their offices for two years and until the election of their successors.

SEC. 4. In case an office should become vacant before the expiration of the term, it may be filled for the balance of the year in which the vacancy occurs by appointment by the President with the advice and consent of the Executive Board, and the remainder, if any, of the unexpired term shall be filled by election at the next Annual Meeting.

SEC. 5. The Treasurer for the United Thank Offering shall be elected by ballot once every three years, at the May meeting in the same year as the triennial meeting of the Woman's Auxiliary, her election to take effect November 1st of that year. She shall hold office until her successor is elected and installed.

ARTICLE VI.—ORDER OF BUSINESS.

SECTION 1. *Monthly Meetings.*

SEC. 2. The order of business may be changed by the vote of the meeting.

ARTICLE VII.—AMENDMENT.

By-Laws may be adopted, amended, suspended or repealed at any regular or annual meeting by a two-thirds' vote of delegates present, notice of proposed changes having been given at the previous meeting.
