Annual Report of the President

MAY 5, 1936

The Woman's Auxiliary is again able to report a year of advance, in which constructive effort produced definite result. It is almost incredible that so much could have been accomplished. Through the keen interest and intelligent response of individuals, as well as the loyal support of parish branches, the work has gone forward, and it is certain that such cooperation is the first-fruit of a deepened devotion.

There are 233 branches and groups reporting in the Diocese, of which four branches and fourteen groups are new. All District Vice-Presidents emphasize great progress in coordinating the work of the various departments, and a marked increase in interest in the program. Two Districts report amazing response to their Lenten "Pilgrimage of The Christian Life", and Westchester's presentation of Officers' Conferences by the Panel method was so successful that it will be used as the basis for similar work throughout the diocese. An evening repetition of the Annual Meeting for the benefit of those who are occupied during the day is a novelty, and to Orange goes the unique distinction of organizing Auxiliary work in a Mission that four years ago was Miss Ramsdell's vision.

Every obligation has been met, and in addition, special projects were undertaken that have saved the work in certain fields. To have increased our total over that of last year is in itself a remarkable achievement.

Of all our meetings, the Advent Meeting is the greatest, and each year we gain strength and inspiration from our Bishop's encouraging presence. Our Corporate Communion, at which Bishop Cook was the preacher, was the largest we have ever had, and the afternoon Missionary Meeting filled the Synod Hall. Bishop Howden and Bishop Reinheimer addressed the gathering, which included seven bishops, a number of national, provincial and neighboring diocesan officers of the Woman's Auxiliary, and the presidents of our other diocesan organization for women, who had attended the luncheon in the Undercroft.

Attendance has increased and much interest has been aroused by the addresses given at the diocesan meetings by our missionaries. We were privileged to have such outstanding speakers as Bishop Binsted, Bishop Kroll, Miss Tift, Father Souder and Dr. Franklin, and Mrs. Pierce as Provincial Representative on the National Executive Board. The most thrilling event of the year occurred at the January meeting when our Pledges were fully completed. The Missionary Crisis was presented in a way that should not lessen, but rather increase, our regular gifts, and the response has been wholehearted and generous.

The Forward Movement leaflets were widely distributed, and a course of lectures by Bishop Manning on "The Christian in This Modern World" gave strong, clear and definite teaching. Throughout the Diocese the emphasis on the devotional life is noteworthy, and every branch has shown its realization of our aim by ever-increasing participation in services of corporate worship. Miss White led a class on Prayer as Creative Power, and Dr. McGregor conducted a series of talks on "The Meaning and Objectives of Religious Education."

The Missions Committee, under Mrs. Pierce's unsparing and experienced leadership, has had an interesting and profitable year. Four general meetings were held, at which were presented subjects that are gravely affecting the missionary situation in the world today. The sub-committees have aroused much enthusiasm for the work in their special fields, and speakers have been provided for many parish branches. Gifts were more than double those of the previous year, which is cause for great rejoicing when the building is solid.

Mrs. Chapman reports that Latin America was a popular subject, and that all previous records were broken. Special mention is made of the splendid cooperation of the different departments in linking their programs through the Educational work. A Good Will Tour with the United Thank Offering through Latin America, as prepared by Mrs. Haff, proved to be such a successful combination that it has also been used in other dioceses.

We are fortunate in having the work at Ellis Island as our Christian Social Service project. A trained worker is essential there, and the splendid results of Miss Palmer's diligence are made possible through our gifts. Thousands of services were rendered in the course of the year, and much care is taken in referring individuals and families to churches or transferring them through cooperating agencies that will advise and aid. Mrs. Nichols has stimulated so much interest in the work that not only was the Pledge oversubscribed, but the contributions of clothing, books, toys and games established friendly contact with the foreign-born.

The tabulated report of the Supply Department tells its own amazing story of greater achievements. Miss Hutton also records further improvement in organization by the appointment of a special secretary for Diocesan work, and an increase in the popularity of knitting through the adoption of standard directions for sweaters of all sizes.

The United Thank Offering report is encouraging. Plans for the formation of parish committees are gaining impetus, and the conferences for Parish Custodians held in every District have given Mrs. Dickey great hope for wider fields of activity.

With deep regret for Miss Jones' illness, the Executive Board accepted her resignation as Secretary in March, and welcomed with gratitude Mrs. Forrester's gracious acceptance of the appointment.

Four officers are retiring from the Executive Board. Mrs. Pierce has served for fifteen years in different offices,—at Large, for the District of New York, President, Treasurer, and now in charge of Missions; the Provincial Representative on the National Executive Board, and present Chairman of that Board. We need not fear that her interest in the Woman's Auxiliary will wane, no matter what form it takes! Miss Peters' service on the Board goes back thirteen years, in Supply and Educational work and as Treasurer. Mrs. Greene has served as Assistant Secretary and Editor of the Bulletin for the past five years, and Miss Clarkson began three years ago in charge of Dutchess and retires at Large, in charge of Meetings. It is impossible to do justice to the years of devoted service that these officers have given to the Board. Their absence at the Board Meetings will be very marked, but we rejoice in the certain knowledge that their active interest in the work will always continue.

We acknowledge with gratitude the many kindnesses of our Bishops and other clergy, and of the many friends whose helpfulness has been of inestimable value.

We are especially grateful that our work has gone forward, and pray that it may ever advance in the right direction.

That we might grow spiritually during the past year, Hours of Devotion, Quiet Morning, Classes in the study of Prayer, Times of Intercession and Corporate Communions have been held for the Woman's Auxiliary throughout the Diocese. To our Bishops and Rectors, who have made these possible, we express our gratitude.

November 11th was observed as a Quiet Day for Prayer and a larger number of the prayer leaflets were used. On February 28th, we united in the Interdenominational World Day of Prayer, which had its broadening contacts.

The number of Prayer Partners is increasing, for which we are happy, as they make a closer relationship between the workers in the Mission fields and those of us working at home.

The Devotional Secretaries in the various Districts have been faithful in their efforts to deepen our devotional living. In Dutchess, Miss Louise Whitcome; in Manhattan and the Bronx, Mrs. William P. Baird; in Orange, Miss Leila R. Ramsdell; in Staten Island, Mrs. Thomas C. Brown; and in Westchester, Miss Laura F. Boyer, all have helped to direct our work.

Dr. D. A. McGregor conducted a course of lectures on the Wednesday afternoons of November, the topic being "The Meaning

and Objectives of Religious Education". These lectures were illuminating and inspirational.

During October a class in the study of Prayer was held in the Chapel of Christ Church, Pelham, which it was my privilege to lead. I have met with some women in all of the Districts and together we have considered the Power of Prayer.

It has also been our aim to bring the Forward Movement to every woman in the diocese. The seasonal leaflets for Bible readings have been kept constantly before the Auxiliary and several hundred have been distributed at the Diocesan meetings.

In order that we all might be better able to clearly define our Christian beliefs, our Woman's Auxiliary, with The Church Club of New York, sponsored a course of lectures by Bishop Manning on "The Christian in this Modern World", which were delivered in the Community House of St. Bartholomew's Parish from 5:15 to 6 o'clock on the afternoons of January 15th, 22nd, 29th and February 5th. These lectures were very well attended by people of all ages and Bishop Manning gave strong, clear and definite teaching.

As we have made prayer, study, hard work and self-discipline our aim for the past year, let us hope that we have a little more clearly found the purpose for which God placed us here on earth, and day by day become strong Christian characters carrying on into Eternity.

During the year all of the sub-committees have been active. Several of the sub-committees reached the goals that they set for themselves and have selected new projects for which to work.

The Treasurer's report records the gifts. It is interesting to note that the total of the gifts from the sub-committees in 1935 was 121% more than in 1934.

The Alaska Committee has spread the knowledge of the work in Alaska by many addresses, not only to Auxiliary branches but during sermon time in our services and also in the services of churches of other communions.

The Brazil Committee has continued to work for the furnishings of three country churches and has circulated addresses and copies of a radio broadcast by Bishop Thomas.

The China Committee has finished the first unit of the heating and water supply plant for the hospital at Anking which enables Dr. Taylor to bring water to the hospital.

By guaranteeing the salary of a rector at the church at Camaguey the Cuba Committee has made it possible to continue the work there.

The Honolulu Committee completed its gift for the Clergy House for Church Army men at Kamuela and is now making gifts for Archdeacon Walker who is at work there.

The Indian Committee is supporting the work at San Juan Hospital, Farmington, N. M., and is working for an ambulance to carry patients to the hospital.

The Islands Committee has several projects. It is helping with Bishop Carson's budget and making gifts to the Chapel at Savanette, Haiti, the Children's Home at Panama, and much-needed Spanish Hymnals.

Mrs. Sawada, Chairman of the Japan Committee, arranged another Japanese entertainment for the support of its work and by addresses

at parish branches and other meetings has forwarded the work of the Church in Japan.

The Liberia Committee initiated a Free Will Offering for Foreign Missions to commemorate the founding of our first foreign mission one hundred years ago.

The Mexico Committee is working for Spanish Hymnals.

The Committee for Work among the Negroes helped to support the schools of the American Church Institute for Negroes by arranging a recital by Mr. Roland Hayes. An interesting outcome of the concert was the development of Mr. Hayes' interest in the work of the Institute.

The Southern Mountaineers Committee exceeded its objective for the Patterson School in Legerwood, N. C., and is continuing to help in its support.

The Committee for Western Missionary Districts is broadening its study of that great field by correspondence with several missionaries in different parts of the field, by gifts to budget in Spokane and Western Nebraska, and toward a Conference Center in Idaho.

The District Representatives rendered fine service in keeping the work of the Missions Committee before the Districts and in finding new members for the committees. Mrs. Kemmer, who represented the District of Manhattan and the Bronx, is compiling a bibliography of popular books for the use of those who wish to know more about the localities where our Church is at work.

The Diocesan Branch of the Auxiliary accepted the recommendation of the Missions Committee that there should be a great missionary service held in the Cathedral next winter. This service has Bishop Manning's enthusiastic approval.

Our programme for the winter was a study of some of the important issues in the world. We had four general meetings. The subjects of the addresses were The Relation of Missions to Peace, when Bishop Ludlow spoke; The Place of Missions in the Modern World, the speakers being the Rev. Eugene C. Carder and the Rev. John A. Mackay; The Missionary Crisis, and the Responsibility of the National Council for Young People, Miss Eva D. Corey, a member of the National Council, being the speaker; and having built up a background of knowledge, Bishop Barnwell at the last meeting coordinated it and showed us our responsibility in a brilliant address: "If We Be His Disciples".

The church-wide study of Latin America brought a new interest in the countries south of us. Naturally, a subject of this character, so embrasive in its scope, could not be discussed adequately within the confines of a few classes. So we presented the work of our Church in Latin America, a matter of vital concern to us. Our aim was to stimulate thinking and discussion. The viewpoint from both Catholic and Protestant angles was studied. We tried to solve where our responsibility begins and where it ends.

There is no yard stick to use in evaluating education. The results can not be crystallized in definite form, so we shall depart from a statistical report. Bare figures can never tell of the devotion and effort put into the work. In the District of Dutchess, Mrs. Robert W. Andrews maintained her high record and reported an hundred percent participation in the educational program.

In Manhattan and the Bronx, several changes in personnel occurred before the season opened. Mrs. Baxter was kidnapped legitimately, though causing just as much concern as though it had been otherwise, to join the Diocesan Board. Mrs. F. S. Danzoll then became an able member, until illness forced her to resign. Mrs. Baxter, as a Member at Large, stepped into the breach and with the help of our President, Mrs. Jacoby, more parishes were reached than ever before. The evening branches were stimulated by the intense devotion of Miss Cramer, a new officer who took a prominent part in the growth of the work and was one of our most active members. In the Bronx,

Mrs. C. F. Kennedy, with the assistance of Mrs. Kinney, reported a good season.

In Orange, Mrs. Alfred J. Fritz announced considerable interest in the subject, with various methods of study used. In Staten Island Mrs. C. A. McMaster assisted by Miss Hester Snyder, brought wide experience to the work. She had a perfect report of branches and groups, not only in the study but also in the gifts to Deaconess Bechtol. In Westchester, Mrs. H. S. Sheppard had unusual success in the programs and intensive days for every Unit in the Divisions, an innovation, but entirely satisfactory. The committee also records its appreciation of a loyal friend and counsellor in its affairs, Miss Laura F. Boyer, a Member at Large.

The marked feature of the year was the splendid cooperation between the departments and among Diocesan officers. A new relationship is growing; education is not a thing apart, but is fundamental to every phase of the work. An example of this is the Good Will Tour with the United Thank Offering through Latin America, arranged by Mrs. Haff and Miss Boyer. Many friendly contacts were made with Educational officers of neighboring Dioceses. An added feature was the travelogue "Around the Caribbean", given by Mrs. Jacoby, who brought a personal touch to the whole subject. The classes contributed liberally to the objective of the Department, the salary of Deaconess Bechtol of Puerto Rico.

Your committee's proved policy of development of new methods is the principal factor in our position of continued growth. Our purpose is to establish a broader knowledge and a greater understanding of the Missionary Enterprise of our Church, which should result in a firmer foundation for intelligent action. So, once again we bring our record to you. Credit is given to others generously, but also, I give to the members of the committee in equal measure, my appreciation, my admiration, and my affection.

The main work done for Social Service is pledging a designated sum of money to be used for the work with the Foreign Born, specifically that done on Ellis Island. The social service worker placed on the Island by the City Missions Society, is supported morally and materially by the members of the Auxiliary throughout the Diocese. The Pledge for 1935 of \$2,000 was over subscribed, the pledge for 1936 has been raised to \$2,500. An active Committee made up of representatives from each District meets twice a year to discuss problems contingent with the work, and to meet with the Social Service advisers of the Diocese. Dr. Van Keuren, Executive Secretary of the Social Service Commission of the Diocese, and Dr. Barnes, Executive Secretary for Social Service of the National Council keep in touch by sending literature and occasional conferences with the Vice-President for Social Service. During the year at Annual and Fall meetings of each District and the Diocesan Meetings (8), the Vice-President spoke and presented the Ellis Island work and any other special Social Service subject, recommended by Diocesan or National Departments.

The General Committee on Immigration Aid at Ellis Island includes thirty-three agencies, twelve of these agencies have representatives on the Island, at present seven of them giving full time. The twelve are organized into a group known as The Welfare Workers, and Miss Alice G. Palmer, our church worker, is the elected chairman of this group. Problems peculiar to immigration, naturalization and assimilation are met with as a group, though each worker reflects the objects and aims of the organization which he or she represents. All the phases of human welfare work are there, with particular emphasis on this as a missionary work, the personal service. Never any money to speak of is given, an occasional car-fare or lunch, but what a fund of work done, such as writing letters, getting into communication with friends or relatives, locating lost baggage, procuring information, distributing literature, papers, etc. The work on the Island covering the period from January 1st to December 31st, 1935, is as follows:

The aim of the Vice-President is for every Parish in the Diocese to know of the Social Service work being done, to contribute to that work with their prayers, their offerings, and contributions of new and used clothing, toys and games. We feel this is really an accomplished fact as while every Parish has not been able to send material things, every Parish knows of the work, and must remember this Social Service in their Prayers.

Although the total supply report is larger than last year, our giving of new garments to missionaries, missions, mission hospitals and schools was less—the increase was in second hand clothing and work for Diocesan Institutions.

The work showed a little more understanding on the part of the parish supply officers, due to a better attendance at the autumn supply conferences. We hope the Supply Institutes this autumn will be still better attended so that our help for the missions will increase.

About thirty-five parish branches were visited by the District Supply Secretaries during the winter. We want more branches to invite them next winter to explain the need for the supplies. The Supply Chairman will also be glad to speak whenever wanted.

There are eight more branches on the Honour Roll this year than last, which is a good step.

Our wholesale buyer, Miss Helen V. Lewis, purchased 24,000 articles for the parishes, as well as all the dispensary supplies—a fine showing as it had to be done the first of May, when she went abroad.

Mrs. S. M. Fisher reported 11,066 garments cut. We were very comfortably established at Epiphany Parish House and are distressed at having to move.

Mrs. Gerald Groesbeck reported 137,523 gauze dressings cut. Mrs. Groesbeck will have charge of the Cutting Room next year. We have a more experienced staff now, and hope to do much better with the cut garments next year.

We had quite a number of personal Christmas boxes for missionaries who were receiving them for the first time. It is pitiful to think so many more are dependent on the taste of strange women in clothing but gratifying to hear how everything pleased and suited them. This shows the loving care put into our work. We are thankful to be able to help.

On October 24th the Fall Meeting was held at Zion Church, Wappingers Falls, preceded by a luncheon for Diocesan and District officers and the speakers of the day at the Nelson House, Poughkeepsie. The meeting was addressed by the Reverend Eric Tasman, who spoke on the financial situation, and by the Reverend Francis J. M. Cotter, who told of his work in China during his 13 years of residence there. The meeting was followed by a delightful tea.

The Chairman cannot say enough for the work of the District officers during the past year. Miss Kinkead, Vice-Chairman, has always been ready to go to parish branches, furthering the work and inspiring with ready advice and help. Mrs. Madeira has never failed in her efforts to promote interest in her two fields—that of Secretary and as United Thank Offering Custodian. Mrs. Harold Mills has been appointed to the new office of Assistant Secretary. Miss Clarkson has represented the missionary work of the District. Mrs. J. Ross Greer has been indefatigable in visiting branches and speaking on the work at Ellis Island. Mrs. Andrews has done splendid work in the educational field, holding and starting study classes, ably assisted by Miss Wickes. Mrs. W. de Garmo Smith, Supply Secretary, held a meeting in Poughkeepsie in the fall for all Supply Secretaries, and has been zealous in her work of filling required allotments, Mrs. Hoag assisting in every way possible. Miss Tomlins has done all in her power to promote publicity. Mrs. Klein has served on the Diocesan Nominating Committee, representing Dutchess, Miss Florence Titus

A report was made in 1820 in the city of Philadelphia, recommending a General Missionary Society for our Church which, in part, is responsible for our presence here today. It reads:—"By a happy appointment of Divine Providence our lot is cast in a land of Gospel light and Gospel privileges. We are planted in the Garden of the Lord, receive the early and latter rain and are nourished by the

heavenly influence of the Sun of Righteousness". Such have been the auspices under which all work for the extension of the Kingdom has been done and will continue to be done "until time shall be no more."

In the District of Manhattan and the Bronx, where trends of city life are reflected in the Auxiliary, our numerical status remains unchanged—a membership of 3100 women associated with 67 parish branches and 10 parish groups. A new Evening Branch has been formed recently composed of young women at Christ Church (Riverdale). Plans are being formulated for an Auxiliary among the Swedish-speaking congregation at Trinity Chapel.

Two Officers' Conference held in the Fall were conducted by the District Committee who have on several occasions gone out as a group either to present the program of the Auxiliary or to confer with an Executive Committee. Your officer has personally addressed 21 Branch Meetings.

In collaboration with the Department of Education a Lenten Quiet Morning was held at St. Michael's Church conducted by the Reverend Howard Chandler Robbins, D.D., who gave a directed meditation on the Lenten gospels. One hundred and seventy-five women representing 30 parishes were present.

We have endeavored to give the 20 Evening Branches of the District the same type of corporate gathering as is offered at our Diocesan meetings. It is significant that after a day filled with varied and pressing interests our Evening Branch members elect to attend Auxiliary meetings. Outstanding has been the presentation during Lent of a missionary pageant, "The Light of the World" by All Angels' Evening Branch. For the first time, the annual meeting will be repeated for all Evening Branches of the Diocese.

The work in the Bronx has been carried on under the experienced leadership of Mrs. Kinney. Although joining with Manhattan for the Officers' Conference and Quiet Morning, the Bronx has had as its own Intensive Day on Latin America conducted by Mrs. Chapman, and three Neighborhood meetings.

In concluding this record of the year's work acknowledgment must be made for the individual earnest effort on the part of the women of the District, for the conscientious and devoted service rendered by the Vice-Chairman, Mrs. Joseph R. Kinney and by the District Committee to whom belongs the credit for the furtherance and supervision of the work. To Mrs. Jacoby who, in the absence of my predecessor in office, has been an unfailing counsellor and guide I owe a debt of gratitude that is difficult to express or to repay.

In the afternoon Bishop Gilbert spoke to us and we were happy to welcome Miss Lindley on her first visit to Orange District and to hear her tell of her vision for the women of the church.

The devotional life of the District under the guidance of our beloved Miss Ramsdell has grown day by day. We sent out 900

leaflets for the Quiet Day for Prayer and a great many of our churches were open on that day.

A District Quiet Hour led by Canon Prichard, with 200 in attendance, was held in Lent at St. George's, Newburgh. A Neighborhood Quiet Hour at the Church of the Good Shepherd, Newburgh was led by Father Putman of the Church of the Transfiguration, New York City. Miss Mary May White spoke on prayer to a group at St. Paul's Newburgh.

The usual Normal classes were held in the Fall by Mrs. Chapman. Our parishes had many Lenten study groups.

Under Mrs. Henry Powell Ramsdell the United Thank Offering has advanced and most branches report more women asking for little blue boxes. The number of parishes presenting their offerings at a corporate communion is gratifying.

Mrs. Carr is delighted to report the growing number of women joining the different missions sub-committees.

Our Christian Social Service secretary, Mrs. William J. Leghorn, has spread the knowledge of our work on Ellis Island to many groups outside the Auxiliary, and we are sure this will show results in many ways.

All our supplies have been forwarded. Miss Towar is indeed to be congratulated on passing her record of last year.

Our Neighborhood meetings are as popular as ever and we have had our usual number. Tuxedo Park has again been our generous host, as Mrs. Grenville Kane, the President, has arranged monthly neighborhood meetings during the season, with addresses by our missionaries on furlough.

Our annual Garden Party at Christ Church, Marlborough, and the annual all-day meeting at Liberty gave the District officers an opportunity to talk to the branches.

Our District committee has worked faithfully and well. Mrs. Leghorn has done double duty as Miss Towar was out of the country and then ill, so Mrs. Leghorn has carried on for her without in any way neglecting her Christian Social Service Work. Mrs. Fritz has been obliged to resign as educational secretary and Mrs. Harry Keevill has accepted the appointment. Miss Alice Sayer, for many years the manager of our Inland Division, has resigned. We want to record the appreciation of the committee for her years of fellowship with us. Miss Kathleen Grand will be the new manager.

Bishop Gilbert and the clergy of Orange District have at all times been of help and encouragement to us and we thank them.

The past year has been one of joyful service for this Vice-President, and apparently for all the Branches, as the work has gone forward with zeal and enthusiasm.

Our Fall meeting, at which we re-consecrated our lives to the service of our Blessed Lord, was held at St. Mary's Church, West New Brighton. At this time Mrs. Henry D. Waller, Vice-President of the Long Island Diocesan Branch, urged us to re-dedicate our lives as rivers of living waters, bringing life to suffering humanity. The speaker was the Very Rev. F. W. Golden-Howes, former Dean of Christ Cathedral, Mexico City.

One great source of inspiration came to us when at St. John's Church, Rosebank, Miss Mary May White, Diocesan Vice-President, gave a very spiritual meditation on Prayer. Our Branches observed the Quiet Day on November 11th in their parish Churches. During Lent the members found great spiritual refreshment in the Pilgrimage of the Christian Life, held in seven Churches on the Wednesdays in Lent. Let me again pay tribute to the wholehearted support of our clergy in making this Pilgrimage possible.

Many of our parishes contributed summer supply work, garments, linens and so forth to St. Barnabas House, Seaview Hospital and the Mission of the Cross. At Christmas, missionary and gift boxes were sent to the Colored work in the South, and the Lenten boxes to our Indian mission in the West.

In the Department of Missionary Education, an intensive day was led by Mrs. Chapman, Vice-President for Education, and classes were held during Lent in all the parishes, each contributing to the designated fund. One of our leaders, Mrs. Mason Smith, was called upon to lead classes in several Churches besides Staten Island.

Our United Thank Offering officers met with Mrs. Dickey and Mrs. Dawley to plan what proved to be an extension of the work as many more Blue Boxes have been distributed during the year.

The Church Periodical Club has distributed over 9,000 books, magazines, toys and other articles to our Home missions in eight states and to C.C.C. camps. At a request from Bishop Gilbert, 2 boxes of 48 books of light classics, and 200 magazines of a high type were sent to the C.C.C. camp at Middletown, N. Y. From Bishop Shayler, Omaha, Neb., came an appeal for money to provide a Christmas party in a Children's Home. Three Churches in two hours raised the amount needed and it was sent by air mail.

Our Secretary for Christian Social Service, Mrs. O. L. Brodie, who has served so efficiently, speaking at the Branches and creating enthusiasm for our work at Ellis Island, will now have charge of our Educational Department. We are happy to announce that Mrs. Theodore D. Wells has consented to take her place as Christian Social Service Secretary.

We feel that the devotional life of our Branches has been quickened by our daily use of the Forward Movement guides. The few minutes each day spent at our family altars does much to give us poise and calm reassurance of the presence of God in our lives.

Our Evening Branches, few in number, but fervent in spirit, have carried on their work, sending Supply boxes at Christmas and Easter, also personal gift boxes; and gift bags to Seaview Hospital, at Christmas.

To the query, as to the outstanding achievement of the year, such replies as "The Quota paid", "Splendid attendance at meetings", "Loyalty, enthusiasm and willingness to help in every way" show plainly the spirit of all.

Our Annual Meeting was held at St. John's, Rosebank. It was largely attended, and the speaker was Mrs. Lloyd R. Craighill, who, with her husband, is doing a notable work in education in Nanchang, China.

It is with a great deal of regret, and a deep sense of personal loss that we accept the resignation of our dear District Secretary. Mrs. William H. Brinley has served with three District Vice-Presidents over a period of ten years and given of her loyalty and devotion to the service of her Lord, so dear to her heart. At our Annual Meeting Resolutions were presented, to be spread upon the minutes and a copy sent to her. Mrs. Manuel J. Johnson will succeed her in office.

My grateful thanks are due to the Diocesan President and Officers for their helpful cooperation. In both Diocese and District, strong hands and loyal hearts have given me their unfailing support in this my first year as Vice-President, and we unite in praying, Thy Kingdom Come.

"Except the Lord build the house, their labor is but lost that build it;
Except the Lord keep the city, the watchman waketh but in vain."

With these solemn words of warning, the District of Westchester submits a report of a year devoted largely to experiments in new ways of working.

The Annual Meeting, the first of its kind, was held on the afternoon of May 22nd at the hospitable parish house of Christ's Church, Rye, with 455 present from 47 Branches including 30 clergy and 17 visitors. The Summer Pledge amounting to \$2,473.00 was divided between the Emergency Schedule and Budget Undesignated after a stirring address by Dr. Lewis B. Franklin.

In the early Fall, the 3 Officers' Conferences took the new form of Panel Discussions by which the Executive Meeting of a group of parish officers was dramatized. Two hundred and forty parish officers and 31 guests from 49 parishes saw with delight their District Officers act out every phase of parish Branch activity and the District is able as a result to report 327 new Branch members, 239 new contributors to the United Thank Offering, and some new groups comprised entirely of younger women. Two new Branches have been formed, one at St. Stephen's Church, Armonk, and an Evening Branch at Trinity Church, New Rochelle, making 56 Branches in all.

The educational work was grouped around 8 Unit classes. To these new kind of Intensive Days, 43 Branches sent representatives. The plan quite fully carried out was that after attendance, each parish should follow up with a program, an address, or a book review on Latin America.

The new plan for the supply department was the distribution to each parish supply officer, at the Fall supply department conference, of carefully prepared loose leaf blank books in which all information about the details of this work had been typed by the earnest supply secretary of the District. It has been my pleasure to see these books in use at the 37 different parish Branch meetings at which I have spoken this year.

The United Thank Offering was emphasized by special meetings in the parishes with a speaker or the program, a Goodwill Tour through Latin America with the United Thank Offering.

The District pledges for the Mission of the Good Shepherd, Arizona, and the House of Bethany, Liberia, were fully met. Every Branch gave to the Christian Social Service pledge. Budget gifts were increased to meet the increased Diocesan pledge and the District had the added pleasure of raising 2 specials, one for needed school supplies for Miss Meacham in Liberia and one, a twentieth anniversary present, a house trailer, for Miss Cady at the Mission of the Good Shepherd, Fort Defiance, Arizona.

Back of all this, were two efforts to follow the line of the Forward Movement of Our Church; one, a class on Prayer as Creative Energy and the other, The Pilgrimage of the Christian Life held on the Thursday afternoons of Lent in 6 different churches of the District culminating in a Quiet Morning at Christ's Church, Rye, on Monday in Holy Week. Attended by members from 44 of our parishes, the aim of the Pilgrimage was the review of some of the great facts of the Christian experience.

To accomplish all this work, the District Officers have given time and endeavour and the clergy of Westchester County have helped most generously. The Diocesan Officers too have played their part. Neighborhood meetings on the New Haven and Hudson River Divisions, a Garden Party at Bedford, and interparochial meetings in several parishes have built up background.

But it is of the parish Branch presidents that I wish especially to speak—it is they who receive and bear the brunt of all the District plans and work—they must find cars to carry members to meetings and services—they must inspire these same members to go and to work—they must see that money is raised for all gifts—they must watch each department of the work, seeing that each gets its share of endeavour and funds, no more and no less—they are the ones who, as faithful communicants and earnest Christians, must be brave and courageous and eager for every new venture. They, the parish presidents, have made this report possible and their Chairman closes it with a paean of praise and gratitude for them.

It is a certainty that upon the foundation of the parish branch rises the development of the United Thank Offering. Therefore, conferences for Parish Custodians have been held in each District, that through consideration of individual problems, and time for mutually helpful discussion better methods for the furthering of the Offering might be arrived at. Also, at these meetings was presented the value of committees to work with the Custodian of the branch, and to carry to other parish organizations the great ideal that this is an offering for every Churchwoman. This plan is already in effect in a few parishes, and it is hoped that during the coming year it will be extended, and bring to many more women the vision of help to our Missions through the prayer and gift of Thanksgiving.

At the District Annual Meetings, Officers Conferences, and many neighborhood meetings the United Thank Offering has been spoken

for, and in addition to this the District Representatives and the Treasurer have made addresses to fifty-three parish branches.

In Westchester the "Good-Will Tour with the United Thank Offering through Latin America", arranged by Mrs. Haff and Miss Boyer, was given in sixteen parishes, and I cannot warmly enough express my appreciation of this original and stimulating presentation of our great opportunity. I am also deeply grateful to all my co-workers in Parish and District who, with devoted zeal, have striven to show the spiritual meaning and missionary power of our Offering.

A questionnaire sent out through the Diocese to ascertain how many women are sharers in the United Thank Offering brought a response from 171 parishes, which showed a total of 5,254.

The amount of our gifts at this time is not so large as it was at the corresponding time three years ago, but I have faith to believe that when the Offering made today is completed it will so demonstrate our gratitude to our Blessed Lord for His many mercies that we shall be able to sustain our share of the Church's Mission. Beyond that, we look forward to a wider field of helpfulness, and a more perfect expression of our prayer of Thanksgiving in joyful service.

Constitution.

NEW YORK BRANCH WOMAN'S AUXILIARY TO THE NATIONAL COUNCIL

AS APPROVED BY THE BISHOP AND ADOPTED BY
ITS REPRESENTATIVE BODY, MAY 17TH, 1912
AND AMENDED AT THE ANNUAL MEETINGS.
MAY 8TH, 1913, JANUARY 6TH, 1920, JANU-
ARY 4TH, 1921, JANUARY 3RD, 1922, MAY 6TH,
1924, MAY 5TH, 1925, MAY 1ST, 1928, MAY
6TH, 1929, MAY 6TH, 1930, MAY 3RD, 1931.

ARTICLE I.—NAME.

The Name of this Association shall be THE NEW YORK BRANCH
OF THE WOMAN'S AUXILIARY TO THE NATIONAL COUNCIL.

ARTICLE II.—OBJECT.

The object of this Association shall be to carry out within the
Diocese of New York the purposes and work of the WOMAN'S AUXIL-
IARY TO THE NATIONAL COUNCIL.

ARTICLE III.—MEMBERSHIP.

All Churchwomen and children by virtue of their baptism are con-
sidered possible members of the Woman's Auxiliary. All those who,
in this Diocese, by their prayers, work or offerings, aid the Mission
of the Church through the National Council may become by enrollment,
actual members of the New York Branch.

ARTICLE IV.—OFFICERS.

The officers of this association shall be a President, twelve Vice-
Presidents, of whom three shall be Vice-Presidents at Large, five in
charge respectively of the Districts of Dutchess, Manhattan and the
Bronx, Orange, Staten Island and Westchester, and four in charge,
respectively, of the work of Missions, Education, Christian Social Ser-
vice and the Supply Department; a Secretary, an Assistant Secretary,
a Treasurer, and a Treasurer for the United Thank Offering, all of
whom shall constitute an Executive Board.

ARTICLE V.—HONORARY OFFICERS.

The Executive Board may appoint Honorary Officers, subject to
confirmation by the Association.

ARTICLE VI.—AMENDMENT.

This Constitution, having been approved by the Bishop, may be
amended with his approval by the Association at its Annual Meeting,
two-thirds of the Representatives present concurring, notice of the pro-
posed amendments, having been given at the previous meeting.

By-Laws.

ARTICLE I.—DUTIES AND POWERS OF OFFICERS.

SEC. 1. *President.* The President shall preside at all meetings of this Association and of the Executive Board.

SEC. 2. *Vice-Presidents at Large.* A Vice-President at Large shall preside in the absence of the President. The Vice-Presidents at Large shall perform such other duties as may be assigned to them by the Executive Board, and shall present written reports of their work at the annual meeting.

SEC. 3. *Vice-Presidents.* The Vice-Presidents in charge of the Districts shall be Chairmen of their respective Districts and shall endeavor to promote the formation of Parish Branches and to help and strengthen those already existing; shall consult with the Executive Board, and shall present at the Annual Meeting written reports of their work for the year.

The Vice-Presidents in charge of Missions, Education, Christian Social Service and the Supply Department shall be Chairmen of their respective Departments and shall inform the Parish Branches through correspondence, visiting or providing speakers, of the needs and work in their respective departments. They shall present at the Annual Meeting written reports of their work for the year.

Each Vice-President shall appoint such persons as she may deem necessary to assist her in the performance of her duties.

SEC. 4. *Secretary.* The Secretary shall—

- (1) Issue notice of meetings;
- (2) Keep the Minutes of the Association and of the Executive Board;
- (3) Prepare and edit the annual report, and shall perform such other duties as may be assigned to her by the Association or the Executive Board.

SEC. 5. *Assistant Secretary.* The Assistant Secretary shall assist the Secretary in the performance of her duties.

SEC. 6. *Treasurer.* The Treasurer shall receive and disburse all funds of the Association and shall keep accounts thereof, and shall report to each meeting of the Executive Board and of the Association.

SEC. 7. *Treasurer—United Thank Offering.* The Treasurer for the United Thank Offering shall receive all contributions for the United Thank Offering, and under the direction of the Executive Board, endeavor to arouse and increase an interest in the same.

By-Laws.

SEC. 8. *Auditing Committee.* The accounts of the Treasurer of the Association and those of the Treasurer for the United Thank Offering shall be audited annually by an Auditing Committee to be appointed by the President.

SEC. 9. *Executive Board.* The Executive Board shall be entrusted with the general business of the Association and shall exercise all powers of the Association not herein expressly provided for. Six members of the Executive Board shall constitute a quorum.

ARTICLE II.—PARISH BRANCHES.

SEC. 1. A "Parish Branch" is a group of actual members of the New York Branch organized within a Parish.

SEC. 2. Each "Parish Branch" shall be entitled to send representatives to the District Meetings of the District in which it is situated, and shall be entitled at such meetings to one vote. The attendance of one or more representatives, or their proxies, from at least one third of the Parish Branches shall be necessary to constitute a quorum.

SEC. 3. Each "Parish Branch" shall pay annually to the Treasurer for the Expenses of the Association a sum of money to be known as Auxiliary Dues. The amount payable by each Branch shall be determined by the Executive Board—subject to approval by the Association at the November Meeting.

ARTICLE III.—FISCAL YEAR.

The Fiscal Year of this Association shall be the calendar year.

ARTICLE IV.—MEETINGS.

SEC. 1. Meetings of the Association shall be held on the first Tuesdays of every month from November to May inclusive provided that whenever the appointed day shall fall upon a public holiday or a greater festival of the Church, the meeting may be transferred to some other day. The May meeting shall be the annual meeting.

SEC. 2. These meetings shall be open to all members of the Woman's Auxiliary, but no persons shall be entitled to vote except four delegates from each organized Branch of the Woman's Auxiliary and the officers of the Association.

SEC. 3. The Secretary shall call special meetings on request of the President or five members of the Executive Board.

By-Laws.

SEC. 4. At all meetings of this Association fifty delegates shall constitute a quorum.

SEC. 5. The Executive Board shall meet before each monthly meeting of the Association.

ARTICLE V.—ELECTIONS AND NOMINATIONS.

SEC. 1. The term of office of all officers shall terminate at the Annual Meeting of 1932, and at that meeting new officers shall be elected to serve as follows:

The President shall be elected for a term of three years and thereafter for terms of three years each, her election to take place at the Annual Meeting following the Triennial Meeting of the Woman's Auxiliary.

Three Vice-Presidents at Large shall be elected to serve respectively for one, two, and three years, their successors to be elected on the expiration of their respective terms, for terms of three years each, so that annually after 1932 one Vice-President will be elected to serve for a term of three years.

The Vice-President in charge of Missions, the Vice-President in charge of Christian Social Service, the Vice-President in charge of the Supply Department, the Vice-President for the District of Dutchess, the Vice-President for the District of Manhattan and the Bronx, the Secretary and the Treasurer shall be elected for terms of two years each, their successors to be elected at the Annual Meeting in each alternate year thereafter for terms of two years each.

The Vice-President in charge of Education, the Vice-President for the District of Orange, the Vice-President for the District of Staten Island, the Vice-President for the District of Westchester, and the Assistant Secretary shall be elected for terms of one year each, their successors to be elected at the annual meeting of 1933 to hold office for two years and thereafter for terms of two years each.

SEC. 2. The President shall appoint each year a Nominating Committee of at least seven members, including at least one member from each District, to nominate and report to the Annual Meeting one candidate for each office to be filled that year; provided, that the Districts, at meetings of their respective representatives, shall be entitled to nominate their respective Vice-Presidents, and at least one month before the Annual Meeting to report their nominations to the Nominating

Committee, and the Nominating Committee shall report to the annual meeting the nominations so received by them.

SEC. 3. All officers shall be elected by ballot at the Annual Meeting; provided that balloting may be dispensed with by a unanimous vote of the delegates. Except the President, Vice-Presidents at Large, the Treasurer for the United Thank Offering, and those elected at any time to fill unexpired terms, all officers shall hold their offices for two years and until the election of their successors.

SEC. 4. In case an office should become vacant before the expiration of the term, it may be filled for the balance of the year in which the vacancy occurs by appointment by the President with the advice and consent of the Executive Board, and the remainder, if any, of the unexpired term shall be filled by election at the next Annual Meeting.

SEC. 5. The Treasurer for the United Thank Offering shall be elected by ballot in accordance with the provision in *Article V.—Section 3*, at the May meeting, once every three years, in the same year as the Triennial Meeting of the Woman's Auxiliary. The incoming Treasurer shall assume office on November 1st of that year, but she shall be admitted to the Executive Board immediately upon election, with full voting power. The retiring Treasurer shall hold office until her successor is installed, but without vote.

ARTICLE VII.—AMENDMENT.

By-Laws may be adopted, amended, suspended or repealed at any regular or annual meeting by a two-thirds' vote of delegates present, notice of proposed changes having been given at the previous meeting.

Roberts' Revised Rules of Order shall govern all meetings.
