## REPORT OF SECRETARY.

---

The Sixteenth Annual Meeting of the Newark Branch of the Woman's Auxiliary was held in St. Stephens' Church, corner of Clinton and Elizabeth Avenues, on Wednesday, November 5, 1890, at 10.30 A. M.

The Holy Communion was celebrated by the Bishop of the Diocese, assisted by Bishop Gilbert, of Minnesota. Archdeacon Abbott and the Rev. E. F. Small, the Rector of the Parish, were in the chancel. After the service Bishop Gilbert was the first speaker, followed by Rev. F. R. Greaves, Missionary at Hankow, China. Lunch was then served in the Parish rooms adjoining the church, about two hundred availing themselves of it. The afternoon session was called to order by the Bishop at two o'clock. The roll having been called, the minutes of the last meeting were read and approved. Miss Emery, the General Secretary, was then introduced, and made an address in her usual happy manner. Bishop Dudley, of Kentucky, was expected to present the cause of the South—Home Missions to colored people, but was unavoidably detained by other engagements. Rev. F. R. Greaves was then asked to give a more detailed account of his work than he had been able to in the time allotted him in the morning, and greatly interested his hearers in the details of his work. Bishop Gilbert asked that he might make some specifications in his jurisdiction. He asked help in raising the salary of Miss Willis, who is doing admirable work with her brother, a missionary at Rice Lake, Minnesota, which resulted in a number of contributions being made for that purpose. Miss Emery gave a short account of the Pittsburgh Missionary Council. The Bishop, in the name of the Auxiliary, offered thanks to the Parishes contributing to the lunch, and also to St. Stephen's Church for their hospitality. The meeting adjourned after the Collects by the Bishop. The congregation was large and attentive, manifestly interested by the

speakers and their work. The offertory amounted to \$48.50, and had been devoted to the furnishing of the Woman's Auxiliary department in the new Missions house to be built in New York City. One Parish in the Diocese has given an additional \$25.00, making the sum as it stands \$73.50, which we intend to increase to \$100.00.

The Directresses of the six divisions report of their season's work as follows: \$52.37 were given for the Mission at Arlington; \$55.63 for other Diocesan work; total, \$107.00.

For the Domestic Branch Mrs. Sara Wittingham reports one box sent to Enfield, N. C., value, \$120.73; one box to Sioux City, Iowa, value, \$242.17; one box to Albina, Oregon, value, \$423.32; clerical suit to Eutawville, S. C., value, \$22.00; total, \$808.32.

For Foreign Missions Mrs. Nathaniel Niles reports \$150.00 sent to Osaka for the support of three Bible Readers; \$30.00 to Shanghai, China, for the Bishop Odenheimer Scholarship; 15.00 given to Rev. F. R. Greaves, at Hankow, China, for translations; total, \$195.00.

For Mexican Missions Mrs. F. C. Henderson reports \$40.00 sent for the Julia Starkey Scholarship, in Mrs. Hooker's Orphanage, in the City of Mexico; \$25.00 toward the building of an Orphanage as a Memorial to Mrs. Hooker; \$60.00 to Mexican League and Boys' Orphanage; total, \$125.00.

For Home Missions to Colored People Mrs. R. N. Dodd reports one box sent to Kansas City, Mo., value, \$77.70; second box to same, value, \$91.92; one box to Jacksonville, Florida, value \$126.37; toward furnishing Rev. E. N. Joyner with a horse for his missionary journeys in South Carolina, \$44.25; for the Good Samaritan Hospital at Charlotte, N. C., \$31.00; three Scholarships in Rev. E. N. Joyner's school, Columbia, S. C., \$75.00; total, \$446.24.

For the Indian Branch Miss C. L. Boylan reports one Christmas box sent to Indians at St. Paul's Station, Pine Ridge Agency, Shannon County, South Dakota, value, \$43.13; one box for Indian Mission work sent to Santee Mission House, Santee Agency, Knox County, Nebraska, value, \$58.78; for Scholarship in St. Paul's School, Yankton Agency, \$60.00; toward Miss Ives' salary, at Greenwood, South Dakota, \$50.00; for Miss Willis'

salary at Rice Lake, Minnesota, \$25.00; for Memorial Font at Anvik, Alaska, \$75.00; to Rev. J. Roberts for work among Indians, Shoshone Agency, Wyoming, \$5.00; total, \$316.91.

Collection for the Mission House added makes the total of the distinctively Auxiliary work \$2,094.79, against \$1,201.63 of last year.

We turn from our table of statistics to the general summary with a feeling of great joy and thankfulness, for never before since the organization of this Branch of the Auxiliary have we been able to report so large a sum or such varied and extended offerings. Last year we fell below the standard of the two preceding years, but all shortcomings and deficiencies have been made up in the present showing. *Laus Deo* for the will and the power and the strength. The subjoined tables show that the individual Parishes have kept pace with the united body. Seemingly inspired by the spirit ruling, instead of decreasing the home work by what was given in the meetings, it has incited the Parish Societies to greater effort and larger gifts. In addition to what is reported there has been most gratifying work done in many of the Parishes by the Church Periodical Society. Hundreds of valuable books, papers and magazines have been sent West and South, and many have been the grateful responses from the recipients. The work has so increased that the General Secretary in New York (Mrs. Fargo) has been obliged to ask for a salaried assistant, being unable longer to fill the duties of the position on account of the draft upon her time. St. Paul's Church, Hoboken, Grace Church, Rutherford, have been added to the list in the past year, the Parishes represented by their delegates at our monthly meetings numbering twenty-nine.

The average attendance for the past season has been 40. We repeat for the benefit of all, but specially for the Parishes lately connected with the Auxiliary and those contemplating it, that the number of delegates sent is optional with the Parish. The larger the representation the greater the interest we have found. Individuals may become members who do not represent Parishes; we welcome all most cordially, and hope that this year may bring us an increase in the number of both Parishes and members, that the offerings may advance in the same ratio that has marked the

past year. We trust that we may go on from strength to strength, unflagging, never wearying in work or prayers, in the quiet, orderly, systematic way taught by the Church, building without noise or confusion, with pure hearts and single purpose of sending the good tidings of great joy to all people, and to God be the Glory and the Honor and the Praise.

# CONSTITUTION

OF THE

## Newark Branch of the Woman's Auxiliary.

---

**ARTICLE I.** This Society shall be called the NEWARK BRANCH OF THE WOMAN'S AUXILIARY.

**ARTICLE II.** Its object shall be to work in connection with the Woman's Auxiliary to the Board of Missions.

**ARTICLE III.** This Association shall consist of all persons who shall contribute to the treasury thereof annually at least the sum of one dollar, or who shall render, in materials or serving, substantial aid to missions. Any one may be constituted a life-member by the payment, at one time, of the sum of twenty-five dollars (\$25).

**ARTICLE IV.** The officers of this Association shall be a President, Vice-President, Corresponding Secretary, Recording Secretary and Treasurer. There shall be, moreover, a Board of Managers, consisting of the above-named officers and of two or more ladies from each parish represented in the Association, whose duty it shall be to regulate its affairs, and, under the supervision of their rectors, to further the work of the Auxiliary in the parishes to which they respectively belong. The methods by which the ends of this organization can be furthered are the raising of money for the support of missionaries and teachers; for the education of those who may be preparing for the work, and for other benevolent purposes connected with the mission; the making, collecting and transfer of clothing, and other material aid; and the publication of papers and pamphlets that may serve to stir up a public interest in the welfare of the different missions.

**ARTICLE V.** It shall be the duty of the President to preside at the meetings of the Association and of the Board of Managers; to call special meetings of the same when occasion shall require, and to countersign all drafts on the Treasurer.

**ARTICLE VI.** It shall be the duty of the Corresponding Secretary to conduct the correspondence of the Association, especially that with the Secretary of the Woman's Auxiliary, and from her to obtain fresh information of the different missions, to be read at stated meetings of the Board.

**ARTICLE VII.** It shall be the duty of the Recording Secretary to keep minutes of the proceedings of the Association and Board of Managers; to send out all notices of stated and special meetings of the same, and to prepare an annual report.

**ARTICLE VIII.** It shall be the duty of the Treasurer to receive and keep account of all moneys and materials contributed for the work of the Association, and to pay all drafts on the funds when countersigned by the President.

**ARTICLE IX.** This Constitution shall not be altered except at an annual meeting of the Association, notice of the proposed change having been given at a stated meeting of the Board of Managers.

## BY-LAWS.

1. There shall be a Public Anniversary of this Association in the Autumn of each year, with missionary addresses or sermon, at which time a collection shall be made for such mission or missions as shall be designated at the time.
2. There shall be an Annual Meeting of the Auxiliary in the Spring of each year, at such hour and place as the Secretary, with advice of the President, shall designate.
3. The election of Officers and Board of Managers shall take place at such meetings, and they shall continue in office for one year, or until their successors are appointed.
4. In case of vacancy of any office by the death or removal of its occupant, the same may be filled at a stated meeting of the Board of Managers, and any one so elected shall continue in office until the next meeting of the Association.
5. The stated meetings of the Board of Managers shall be on the second Wednesday of each month, in Trinity Chapel, Rector Street, Newark, or any other place designated.
6. At the meetings of the Board of Managers any number present shall constitute a quorum for the transaction of business, and at the Annual Meetings a number of members equal to one-half the number of parishes represented therein shall constitute a quorum for the transaction of business.
7. Each parish shall be considered as represented at the stated meetings of the Association in the absence of their delegates if a report is sent to the Corresponding Secretary.
