REPORT OF SECRETARY.

The Seventeenth Annual Meeting of the Newark Branch of the Woman's Auxiliary was held in Grace Church, Orange, on Wednesday, Nov. 11th, at 10.30 A. M. The Holy Communion was celebrated by Bishop Starkey, assisted by Bishop Leonard, of Utah and Nevada, and Dr. Anthony Schuyler, Rector of the Parish, Archdeacon Abbott and Rev. M. M. Fothergill, of Church of the Atonement, Tenafly, in the Chancel. After the service, Bishop Starkey introduced Bishop Leonard, who gave an account of his work and its needs, asking for help in the Girl's School, established in Salt Lake City. He was succeeded by Archdeacon Walker, of North Carolina. Rev. Alexander Mann, Assistant at Grace Church, then cordially invited the members of the Auxiliary and their friends to lunch in the adjoining Parish Rooms. The afternoon session was called to order by the Bishop. The first address was by Rev. C. B. Wilmer, of Lynchburg, Va., in the interests of the colored people of the South. Miss Mailes, Missionary at Osaka, Japan, succeeded him. She gave an interesting and detailed account of her work among the women of that country, work which only a woman can do. She was listened to with marked attention. Rev. G. W. Christian, of Grace Church, Newark, the Delegate from the Diocese to the late Missionary Convention at Detroit, Mich., gave a very enthusiastic and stirring account of that meeting. Rev. L. L. Kinsolving, Missionary to Brazil, was the last speaker of the day. The meeting was interesting throughout, attended by a large number of people, despite the inclemency of the weather. The Bishop congratulated the Auxiliary on the courage and interest shown in braving the discomforts and inconveniences consequent on the several changes necessary to bring many of them from their homes to the place of meeting. A vote of thanks was offered to the Parishes of Orange for their hospitality, and the meeting adjourned after singing "From Greenland's Icy Mountains" and receiving the Benediction. The Offertory amounted to \$50.00, and was given to Bishop Leonard for his work.

For Mexican Missions, Mrs. F. C. Henderson reports for Julia Starkey Scholarship in Mrs Hooker's Orphanage, City of Mexico, \$40.00; for Mrs. Hooker's Memorial Orphanage, \$52.00; for Mortgage on Cathedral, \$48.60; for Mr. Gordon's work, \$10.00; St. Mary's Orphanage, \$5.00; Church Building Fund, \$5.00; for general work in Mexico, \$5.00; distinctively Auxiliary work, \$135.00; Alfred Biddle Scholarship, \$30.00; Pinckney-Henderson Memorial Scholarship, \$40.00; Mary Lawrence Carter Scholarship, \$50.00.

For the Indian Branch, Miss Boylan reports a Christmas box to Rev. C. S. Cook, at Pine Ridge Agency, S. D., value \$89.24; a box to St. Elizabeth's School, Standing Rock Reserve, S. D., value \$237.57; for Scholarship in St. Paul's School, Yankton Agency, S. D., \$60.00; towards Miss Ives' salary, Rosebud

Agency, S. D., \$50.00; for horse for Rev. S. S. Burleson, Oneida, Wis., \$60.00; to Rev. J. Roberts, for Missionary work at Shoshone Agency, Wyoming, \$5.00; total, \$501.81.

Christ Church, Ridgewood, Holy Communion, Norwood, Church of the Mediator, Edgewater, have been added to our list in the past year. The summary shows the work to have been much the same as last year—a trifle in excess. We would have been glad to record an advance, but are pleased that there has been no falling off from the last report, which was so largely in excess of all preceding. The work done in the Auxiliary meetings is also about the same. The attendance has been good and the interest sustained. The Enrolment Fund is the object to be presented at the general meeting in October, in Baltimore, and it is to be hoped that those having means may make large gifts to so commendable and desirable an object. The Church Periodical Society continues its good work, sending reading matter to all parts of the country where it is most highly prized and needed. The Auxiliary Scholarships are still supported. The pledge to pay half of Miss Wheeler's salary in Rev. E. N. Joyner's Mission, Columbia, S. C., has taken the place of the Scholarships in that division. The work done by the Directress in this branch of the work is more than ever before reported. Certainly the needs are earnest and pressing, emphasized by our Bishops in every address to the people on the subject of Missions.

We have one report from the Junior Auxiliary, of Calvary Church, Summit, another from the young girls in the Baquet Institute, Short Hills, who, with their teachers, have been doing work for the Southern Schools. We shall be glad to give place to any other of the Junior Societies that will send us their report. We would ask that those representing the Parishes in the Auxiliary will make an effort to attend the meetings. There is encouragement and inspiration in full attendance, and an intelligent interest is thereby gained and sustained. The call for help comes to us from North, and West and South. From China and Japan, from Mexico and Brazil, there goes up but one cry: Send us men and money for the field is ripe for the Harvest. And let us not be forced to add, the laborers are few.

CONSTITUTION

OF THE

Newark Branch of the Woman's Auxiliary.

ARTICLE I. This Society shall be called the NEWARK BRANCH OF THE WOMAN'S AUXILIARY.

ARTICLE II. Its object shall be to work in connection with the Woman's Auxiliary to the Board of Missions.

ARTICLE III. This Association shall consist of all persons who shall contribute to the treasury thereof annually at least the sum of one dollar, or who shall render, in materials or serving, substantial aid to missions. Any one may be constituted a life-member by the payment, at one time, of the sum of twenty-five dollars (\$25).

ARTICLE IV. The officers of this Association shall be a President, Vice-President, Corresponding Secretary, Recording Secretary and Treasurer. There shall be, moreover, a Board of Managers, consisting of the above-named officers and of two or more ladies from each parish represented in the Association, whose duty it shall be to regulate its affairs, and, under the supervision of their rectors, to further the work of the Auxiliary in the parishes to which they respectively belong. The methods by which the ends of this organization can be furthered are the raising of money for the support of missionaries and teachers; for the education of those who may be preparing for the work, and for other benevolent purposes connected with the mission; the making, collecting and transfer of clothing, and other material aid; and the publication of papers and pamphlets that may serve to stir up a public interest in the welfare of the different missions.

ARTICLE V. It shall be the duty of the President to preside at the meetings of the Association and of the Board of Managers; to call special meetings of the same when occasion shall require, and to countersign all drafts on the Treasurer.

ARTICLE VI. It shall be the duty of the Corresponding Secretary to conduct the correspondence of the Association, especially that with the Secretary of the Woman's Auxiliary, and from her to obtain fresh information of the different missions, to be read at stated meetings of the Board.

ARTICLE VII. It shall be the duty of the Recording Secretary to keep minutes of the proceedings of the Association and Board of Managers; to send out all notices of stated and special meetings of the same, and to prepare an annual report.

ARTICLE VIII. It shall be the duty of the Treasurer to receive and keep account of all moneys and materials contributed for the work of the Association, and to pay all drafts on the funds when countersigned by the President.

ARTICLE IX. This Constitution shall not be altered except at an annual meeting of the Association, notice of the proposed change having been given at a stated meeting of the Board of Managers.

BY-LAWS.

1. There shall be a Public Anniversary of this Association in the Autumn of each year, with missionary addresses or sermon, at which time a collection shall be made for such mission or missions as shall be designated at the time.
2. There shall be an Annual Meeting of the Auxiliary in the Spring of each year, at such hour and place as the Secretary, with advice of the President, shall designate.
3. The election of Officers and Board of Managers shall take place at such meetings, and they shall continue in office for one year, or until their successors are appointed.
4. In case of vacancy of any office by the death or removal of its occupant, the same may be filled at a stated meeting of the Board of Managers, and any one so elected shall continue in office until the next meeting of the Association.
5. The stated meetings of the Board of Managers shall be on the second Wednesday of each month, in Trinity Chapel, Rector Street, Newark, or any other place designated.
6. At the meetings of the Board of Managers any number present shall constitute a quorum for the transaction of business, and at the Annual Meetings a number of members equal to one-half the number of parishes represented therein shall constitute a quorum for the transaction of business.
7. Each parish shall be considered as represented at the stated meetings of the Association in the absence of their delegates if a report is sent to the Corresponding Secretary.
