In Memoriam

Annie W. B. Howe

Died August 1st, 1924

In the recent death of Mrs. William Read Howe, of St. Mark's Church, West Orange, the Woman's Auxiliary of the Diocese of Newark has suffered a great loss. Mrs. Howe will long be remembered as an active member of the Woman's Auxiliary and a member of the Executive Board, having served as Director of Indian Missions in 1912, Director of Diocesan Activities, 1914, and Director in charge of the Bishop's Fund, 1919. This latter office she held at the time of her death, and under the Bishop's direction was able to render assistance to the Missionary clergy in many ways. Mrs. Howe was most faithful in attendance at all meetings until her health prevented. Always helpful with advice and counsel, her presence will be greatly missed by her associates.

At the September meeting of the Executive Board, the President asked that this expression of appreciation of Mrs. Howe, and the deep sense of personal loss through her death, be presented at the Auxiliary meeting, that Mrs. Howe's name be inscribed in the Book of Remembrance, also, that this tribute be spread upon the records of the Woman's Auxiliary of the Diocese of Newark.

A Message

MY DEAR FRIENDS :

As this is my last message to you as your President, it may not be amiss to review, in part, the four years we have worked together.

The District divisions, with which we are so familiar, were in their infancy, and the only District officer was the Director. Immediately after the adoption of our present Constitution their organization was completed and they became what they are today—the medium through which each Diocesan officer can reach the interested women in each parish and share with them the plans she wants carried out.

Three years ago the Diocesan officers began their regular semi-annual visits to the District meetings. From these has developed a knowledge of the natural beauties of our Diocese, the dignity and attractiveness of even our smallest churches, the cordial co-operation of our clergy, and the devotion of the women who give so generously of their time and strength.

Our financial system with its division into ten classes has won its way, and this last year 84 Auxiliary Branches, or guilds, have had a share in each object listed in our Budget Slip. Of course we are not satisfied with our progress, and we would not want to be, but we have reason for feeling much encouraged.

At the meeting of the Synod of the Second Province certain "Objectives" in Work and Prayer were adopted for 1925. These you will find printed in the Year Book, and I hope you will study them and, as far as possible, put them into practice.

At the same meeting a "Standard of Excellence," now being followed in the Diocese of Albany, was presented. This too, slightly modified, is printed in the Year Book. It is heartily recommended to Parish Branches.

With gratitude for the privilege of having had these years of work with you, and with sure confidence of greater things to come, I am, though no longer your President, ever your friend,

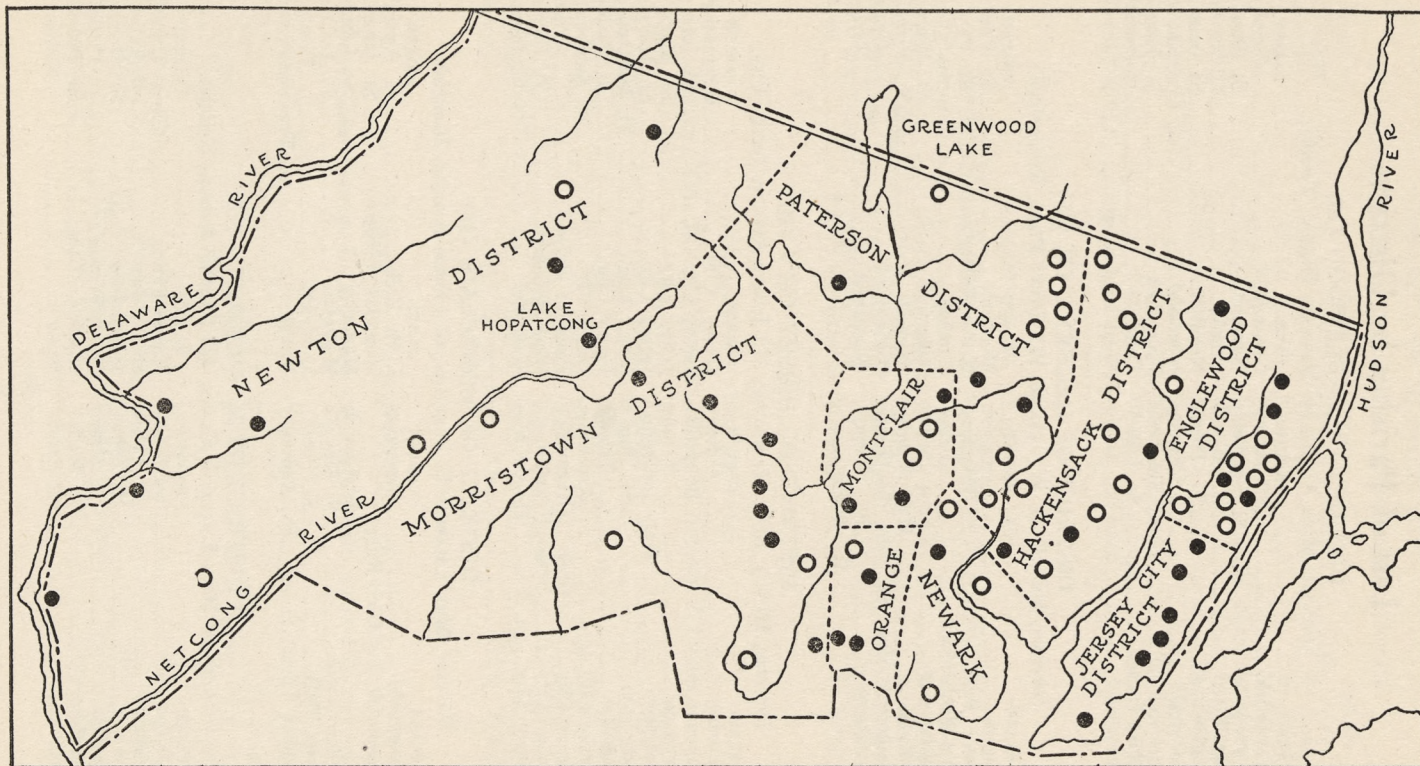

Objectives in Work and Prayer

WOMAN'S AUXILIARY OF THE SECOND PROVINCE, 1925.

The following Objectives were adopted by the Dioceses of the Second Province at the meeting of the Synod, in November, 1924. Through this united effort the Province will become more conscious of itself and of its place in the Church at large.

A. OBJECTIVES IN PRAYER

Let us pray for

1. The deepening of our own spiritual life and that of the Woman's Auxiliary members in this Province.
2. The realization of the Forward Program of the Church.
3. The coming Triennial of the Woman's Auxiliary.
 - a. For adequate plans and preparation.
 - b. For a large offering of life and money.
 - c. For significant results.
4. Our mission fields, especially for Porto Rico and the Virgin Islands and for leadership in Mexico.
5. The promotion of such a spirit of good will among the nations as will tend to bring peace upon earth.

NOTE—It is suggested that these topics of prayer be used at Diocesan Executive and Annual Meetings, at least one regular branch meeting, and by the members in their private devotions.

B. OBJECTIVES IN WORK

Let us

1. Support the Synod in its plans that the 2nd Province provide the priorities for the Missionary District of Porto Rico, and in other ways support the work there.
2. Support the work in the Province of Miss Martha Bullitt with the students in women's colleges.
(By informing ourselves and our branches, and by co-operating in new plans and carrying out as best we can any suggestions she makes to us during the year.)
3. Further the Forward Program of the Church.
(By keeping our branches informed about the Forward Program in the Province, in the Diocese, and what our particular parish is doing, or how it stands.)

By the co-operation on the part of the Diocesan Woman's Auxiliary boards with other Diocesan plans.

By the co-operation of each parish branch with parish plans.

PROVINCIAL OBJECTIVES

4. Foster the spirit of fellowship and good will in the Province.

By giving delegates to Synod a chance to speak of the Provincial Meeting.

By Diocesan officers attending meetings in other Dioceses.

By knowing each other's work, through the Year Books, correspondence, etc.

By attending Provincial Summer Schools.

By joining in our fellowship of prayer and work as outlined above.

Standard of Excellence

SUGGESTED FOR PARISH BRANCHES OF THE WOMAN'S AUXILIARY OF THE DIOCESE OF NEWARK.

The accompanying Standard was adopted by the Executive Committee at its meeting in December, 1924, and is recommended to the Parish Branches.

It is in no way obligatory, but it is hoped that it will be found helpful in measuring their growth and activity. It has been drawn with care, so that the smallest as well as the largest Branch alike may have a chance to register 100%.

For this Standard the Diocese of Newark is indebted to the Diocese of Albany, where it is already in operation.

NOTE—The basis of the Standard is 100, each section counting 20. Active membership includes all women who, through systematic prayer, study or work, participate in the life of the Branch.

The year upon which the Standard is reckoned is from January 1st, to December 31st.

1. MEMBERSHIP

- A. Net increase in membership—10 points.
- B. An average attendance at regular meetings equal to at least one-half of the active membership—10 points.

2. PRAYER

- A. The use of the Prayer Leaflet by at least one-half of the active membership—10 points.
- B. Parish observance of a Corporate Communion of the Auxiliary during the year—10 points. (It is suggested that for 1925, May 1st be the day selected.)

3. OFFERINGS

- A. Adoption of some one Class in the Budget—10 points.
- B. Contributing to the United Thank Offering by at least one-half of the women of the parish—10 points.

4. INFORMATION

- A. One Mission Study Class, Intensive Day, or series of Program Meetings—10 points.
- B. Subscriptions to, or regular use of, THE SPIRIT OF MISSIONS by at least one-half of the active membership—10 points.

5. SUPPLY DEPARTMENT

- The preparation of one box, or part of a box, in co-operation with the Supply Department—20 points.

Suggestions to Parish Officers

Use the Church Service League Prayer Leaflet in order that all may be thinking along the same lines.

[The Leaflet may be secured from the Vice-Chairman of the Department of the Devotional Life, price, 25 cents.]

Parish Presidents should plan to attend all District Meetings and keep in close touch with Diocesan Officers.

Supply Work should be secured through the District Supply Secretary, Educational Work through the District Educational Secretary, Social Service Work through the District Social Service Secretary, and all information connected with the United Thank Offering should be secured through the District Custodian.

Attendance at the Summer Schools at Geneva and Princeton should be secured, if possible. Parish Officers would find them of great value.

Include in every personal box a copy of some good book.

Parish Presidents should see that all notices of Diocesan and District matters are distributed to the members, and that changes in Parish Officers, or their addresses, are reported to the Diocesan Corresponding Secretary.

Suggestions to Parish Treasurers

Realize the importance of your office, as it is in your power to increase the desire to give on the part of your members.

Study carefully the "Budget Sheet" (page 31) and know how the money is used.

Know what is meant by a "Special," a "Priority," and the "Parish Quota."

If you pay to a Scholarship, know whether it is a Special or is to count on your Parish Quota, and so notify the Diocesan Treasurer when you send her the money.

Simple but systematic accounts should be kept, and a financial statement rendered at each business meeting. Have bank books balanced once a month, all vouchers filed, and accounts audited once a year.

Date all letters, give the name of your Parish Guild or Auxiliary, state which class in the Budget you have selected and which class in the Specials. Sign your name, adding married name and address, or, if unmarried, write (Miss) in parenthesis.

If you resign, notify the Diocesan Treasurer and send the name of your successor. Be sure to give to your successor all the information that you possess in regard to the work.

Remember that the Fiscal Year begins January 1st and ends December 31st. December money should be sent as early in the month as possible in order that the Diocesan Treasurer may have time to write her report and have her books audited.

Keep your Rector informed of all payments that apply on your Parish Quota.

Make your monthly reports so interesting as to inspire your members to give, and show what has been paid and what remains to be paid.

In Missions and weak Parishes contributions of five or ten cents a month to the Budget and Specials will be found an easy way to share in the work, and those who are unable to attend the meetings should be given this opportunity as well.

Report of the Recording Secretary

During the year, the Woman's Auxiliary of the Diocese of Newark has held regular meetings on January 2nd, March 12th, May 7th and October 1st. The largest attendance was at the October meeting when there were 119 present, representing 44 parishes.

At the Annual Meeting in January, reports of the work accomplished during the year were read by the officers and a summary of the work of the Districts was presented by the Recording Secretary.

The following officers were elected to serve for three years:

First Vice-President—Mrs. Reginald H. Williams.

Second Vice-President—Mrs. William S. Rodie.

Third Vice-President—Mrs. Ellwood W. Porter.

The speaker for the day was Mrs. G. B. K. Wade, the Supply Secretary for the National Work. A luncheon followed for the officers and guests.

The speakers at the other regular meetings were: Mr. G. Warfield Hobbs, Editor of *THE SPIRIT OF MISSIONS*; The Rev. George M. Plaskett, who spoke for the National Training School for Colored Workers; Miss Helen A. Burkhardt, of the New York School for Social Work; Mrs. Charles H. Boynton, who told of her visit to Mexico as a representative of the Woman's Auxiliary, and Bishop Lines, who spoke at the May meeting and urged us to help pay the debt of the Diocese (for buildings in the Missions) and also in October when he told us of the plan for the Pilgrimage through the Diocese in commemoration of the Fiftieth Anniversary of its formation.

On account of ill health, Mrs. Rodie was obliged to resign, in June, as Second Vice-President and Mrs. Stewart A. Trench was appointed to serve for the balance of the year.

Mrs. Chester L. Colton was also appointed to take charge of the Comfort Club.

Seven meetings of the Executive Board were held at which the regular business was transacted and some changes made in the By-Laws.

Report of the First Vice-President

(DEPARTMENT OF EDUCATION)

During the first half of the year 1924, until May, the Educational work was still under the able direction of Mrs. Stephen S. Johnson, the new Vice-President assuming control, as the season's work was closing, making her first official visits at the Spring District Meetings.

Mrs. Johnson reports, for the first of the year:

In January, two Normal classes were held in Newark, with an attendance of ten, to prepare leaders for the Lenten discussion groups on "Creative Forces in Japan," the book studied by all denominations at that time. The Lenten classes are recorded below by Districts.

On September 18th, an Educational Rally was held at St. John's Church, Montclair, and more than eighty women came from all parts of the Diocese, including many Auxiliary Presidents and Educational officers. Plans for the year were outlined, and an inspiring address was given by the Rev'd George P. Dougherty of Christ Church, Bloomfield and Glen Ridge. An Executive Committee, consisting of the Educational Secretaries of 9 Districts, together with Mrs. C. E. Hutchison; Mrs. E. W. Fortiner, the Executive Vice-President, and the Vice-President, was formed to meet at regular intervals and plan for the work.

An outline for a Conference of Parish Officers to be held in each District in the early Fall was prepared by this Department, and it was used at many committee meetings and at several District Meetings in October.

Much interest and enthusiasm was shown in the sale of the Church Missionary Calendars, during October, November and December, the District of Paterson doubling last year's sales and Englewood jumping from 3 to 59. It was also the first District to turn in a full paid account.

In December, a two-day training class on "China's Real Revolution," led by Mrs. C. E. Hutchison, was held, to prepare leaders for Epiphany Institutes and classes.

A call has just come from Bishop Lines to double the list of subscribers to THE SPIRIT OF MISSIONS, so this has been apportioned to each District as the calendars were, and January will see every one intent on filling the quotas.

This year, in place of the Educational Programs, messages have been sent regularly to all District Educational Secretaries with plans and suggestions for each month, and three times during the year, letters will go to all Presidents.

Besides many copies of "Creative Forces in Japan" and the Japanese Hand Book sold, the first part of the year, the last few months have seen large numbers of "My Father's Business" go into different Parishes, and requests are just coming in for "China's Real Revolution," and the China Hand Book.

The Educational Department has assisted Churches to prepare programs and Church current events, has furnished speakers, and members of the Department have also spoken.

One member of the Department was on the Faculty at Geneva Summer Conference, and one at Princeton, and delegates to Princeton were sent from three Districts and from four Auxiliaries, and many others attended also.

Telephone calls, conferences, visits, books loaned, pamphlets sent, letters written, have been some of the ways in which the Department has been of help.

The increasing number of parishes taking part in Diocesan work, and looking to the Diocesan officers for suggestions and guidance, means a larger amount of work, and the Educational Department, like the Supply Department, must turn to the District representatives to bear more of the responsibility for the work in each District, if progress is to be made.

With a keen realization that during the coming year the Educational Department must stress the informing of every woman in the knowledge of our Church's Program, the failure of our Diocese to meet its quota and the responsibility of each one to find out what her own parish is doing in the matter, and how she can help, the Department is looking forward to a year of earnest work. Bishop Stearly has said "Prayerful education is what we need, and we must all of us, in every way we can, be working along these lines."

"We beseech Thee, O Lord, to give Thy grace to those who are striving to present the world-wide call of the Gospel to the Church at home: that they may rightly understand the hearts and minds of those to whom they speak, and may be able to awaken in them a new desire to see all the dark places of the earth illumined by the spreading light of Christ; Who with Thee and the Holy Spirit liveth and reigneth ever one God world without end. Amen."

Report of the Second Vice-President

(SUPPLY DEPARTMENT)

While the Supply Department suffered a very real loss in the resignation of Mrs. William Rodie just after she had assumed the office, yet Mrs. Colton had so thoroughly organized the Department during her four years of service that the work was able to go on without a serious break.

From January 1 to July 1, 1924, five personal boxes valued at \$575.00 were sent, and the boxes sent to missions, schools and institutions were valued at \$10,513.00.

The allotment for 1924 and 1925 consists of 26 personal boxes, 4 boxes for Indian Catechists, 28 Christmas Joy Boxes to women missionaries, 2 hospitals, 6 schools and 6 missions. Special appeals have come from four other missions.

Since September 1st, 25 personal boxes for the missionary clergy, 4 for the Catechists, the 28 Joy Boxes and 19 bundles for the missions have been sent; the rest will go by April 1st.

The Girls' Friendly Society is working with us as usual, and the Altar Guild stands ready to help if needed.

More of the parishes are taking an interest in the Department than ever before and we can truly say that our watchword is progress.

Again I would like to remind the parish branches that all information about the work for the institutions (hospitals, schools, missions) should be secured from the District Supply Secretaries. The Diocesan Director is ready to help whenever it is desired, but the source of information nearer home adds much to the interest.

My thanks are given to Mrs. Colton, the District Directors and the District Supply Secretaries for their assistance.

Report of the Third Vice-President

(DEPARTMENT OF SOCIAL SERVICE)

In presenting the second annual report of the Vice-President in charge of Social Service, the report must be divided into two departments—"Recreation" and "Education for Volunteer Workers."

At the Spring Meeting of the Woman's Auxiliary Miss Burkhart, of the School of Social Work, spoke on "Recreation."

During the summer months nearly two hundred children were given a day's outing, the city providing the children and the suburban parishes the lunch and play.

In November and December a class for Volunteer Workers was held at the Diocesan House, under the direction of Miss Mary Dyckman. This course included lectures on health and delinquency, Round Table discussion, and Field Work. The enrollment was nineteen and the average attendance twelve. Five of the members of this class have continued the regular field work with the church and community organizations to which they were assigned.

In Newark, a Social Service Exchange has been established at the Diocesan House.

It is impossible to tabulate the "case work," but I know of many families who have been re-established, problem children helped, and the sick visited and cheered.

Your Vice-President has attended the National Conference of "Social Service Workers of the Episcopal Church," followed by the "National Conference of Social Workers," at Toronto; the District meetings; and has spoken at four parishes.

My report cannot close without a word of thanks to the Executive Board, to the District Directors, for their co-operation and confidence, and to the loyal and interested women who have carried on the work in the various fields of service.

Department of the Devotional Life

REPORT OF THE ACTING CHAIRMAN

It was a great loss to this Department when Mrs. Williams, who had given so much time and thought to its development, felt she must resign as Chairman as the duties of First Vice-President demanded most of her time. After much, and unsuccessful, effort to find some one to take her place the President assumed charge herself.

Before resigning, Mrs. Williams sent out a letter calling attention to the Day of Prayer for Missions and suggesting some books for Lenten reading, and in June a letter was sent to all the members asking them if they would speak to others about the Devotional Life of the Auxiliary. As a result several new Intercessors were added and they now number forty with six Prayer Groups.

There have been no other communications since June, and it is not strange that the question has been asked whether the Department is the power it should be.

Recently Mrs. August Ahrens has been secured as Vice-Chairman and with her able assistance and that of a small committee, the acting Chairman will continue to serve until May.

In the Litany of Intercession prepared for the Pilgrimage, which marked the fiftieth anniversary of the Diocese, there were two petitions I wish could be used regularly. The first is for the Parish, the second for the whole Church.

The Emery Fund

The Book of Remembrance

"There shall be created an Emery Fund for Missionaries Home on Furlough, to be given over to the Board of Missions or their successors, to be for all time a Trust Fund, the interest of which shall be used for women missionaries on furlough in such way as the Executive Committee of the Woman's Auxiliary or its successors shall approve." [From the Minutes of the Triennial Meeting of the Woman's Auxiliary, held in Detroit, Michigan, October, 1919.]

In connection with this Fund the Woman's Auxiliary of the Diocese of Newark established a Book of Remembrance.

In it may be recorded the names of former diocesan officers, and those women no longer living, who in parish branches have served the Auxiliary and Church in their day and generation. The sum of five dollars, which accompanies the name, is sent to the Emery Fund at the Church Missions House.

The Book of Remembrance was presented with the Emery Fund on October 5, 1921.

The following four names have been placed in the Book of Remembrance during the year of 1924:

In loving memory of Mrs. William Read Howe, a faithful Officer of the Woman's Auxiliary for a number of years, by the Officers of the Auxiliary.

United Thank Offering of 1925

Resolution adopted in Portland, Oregon.

Resolved, That the United Thank Offering of 1925 be given to the Presiding Bishop and Council for the work of women in the mission field whose appointment has been approved by the Executive Board of the Woman's Auxiliary, including the training, sending and support of women workers, and the care of such workers when sick or disabled; *provided*, that one-tenth of the Offering be set aside and added to the permanent trust fund to be invested and administered by the Presiding Bishop and Council, the income to be applied to the support of retired United Thank Offering workers; also, *provided*, that the sum of not less than \$25,000.00 be devoted to the erection, completion, or renewal of a building or buildings approved by the Presiding Bishop and Council on the recommendation of the Executive Secretary of the Department of Missions and the Executive Board of the Woman's Auxiliary.

Resolved, That to our united gifts shall be added our united and earnest prayers that God will put it into the hearts of many faithful women to give themselves or of their substance to the work of the Master in the Mission field.

The Comfort Club

This Club was established about 1892 by Mrs. Thomas A. Starkey, the wife of the second Bishop of the Diocese, herself the President of the Woman's Auxiliary at that time. Its object is to assist the Bishops' Missionary Fund and the Supply Department in the work of providing boxes for families, schools, missions and hospitals. Much of the work is emergency, and a stock on hand means comfort; a supply sent at once is of untold value; hence the name "Comfort Club."

There are many in every parish who would be glad to supplement their work by individual gifts to the Comfort Club.

The gift of two articles and thirty-five cents, annually, makes one a member.

All *moneys* go to the Diocesan Treasurer, plainly marked "Comfort Club." Address, Mrs. F. H. Brown, Dana Place, Englewood, N. J.

All *articles* must be sent to the Diocesan House, 21 Washington Street, Newark, N. J., marked plainly, "For Comfort Club."

DIOCESAN INSTITUTIONAL SUPPLY DEPARTMENT.

Owing to the illness and death of our beloved friend, Mrs. William R. Howe, a detailed report of the work of the Comfort Club for the year 1924 is not available. It is evident that more parishes are showing an interest in outside work, and that more members have been added to the roster. It is likewise evident to the thinking person that a club established in 1892 to meet specific needs would find, after thirty years of continuous labor, that the original cause for its being had merged into a larger, more definite field; that its reason for existence was even greater, and its sphere of usefulness vastly increased. In lieu of a report, therefore, I am appending the following letter:

"As it is my earnest desire to have the Comfort Club become a really practical source of supply for the institutions of our Diocese, I should be very glad to know that each member of every parish group is thoroughly informed as to the needs which must be met.

"The obligations of a member are summed up in the phrase, 'Thirty-five cents and two *new* articles.' Very often there is a wide divergence of opinion as to the 'two new articles.' Some are purchased with utmost care, but occasionally it is borne in upon the observer that *haste* has been the prime element when the purchase was made.

"The needs to be met have changed somewhat in the past few years. At its inception, the Comfort Club was meant, primarily, to assist the clergy in the rural sections to fill the many calls upon them. Changing conditions have lessened that need, while the needs of the institutions have increased. The present plan must be founded upon a true knowledge of the requests we must answer, so that we, each, can send 'two articles' that will be of real value—not just useful because they are on hand, but useful because they fill a need.

"Every year the needs must be much the same, for institutional requirements, in the main, cannot vary greatly. Although *quantities* may change, we can figure quite comfortably on *certain standard things in certain standard numbers*, every year. Of course, there may be *special requests* which cannot be classed exactly as *needs*, and those will vary with conditions. But for the most part we can all be acquainted with the general needs of each institution by simply realizing its work in the community.

"The hospitals must have linens in huge quantities. And that does not mean *towels* and *pillow-cases* only. While towels, pillow-cases and wash-cloths are absolutely indispensable, they do not fill the place of *sheets*, *spreads* and *blankets*. Hospitals also require some surgical dressings and hospital garments—such as pajamas, bed-gowns, bed socks, etc. Some of these things are better when bought, others are suited to group work and fit in nicely with parish plans. Some baby garments are also needed, so the range is wide. So much for St. Barnabas' and Christ Hospitals.

"The needs of St. Katharine's Home are largely for young women and the quantity is not great. Some household linen is also required. For the Church Mission of Help, little children's and babies' garments are needed in

ample amounts, and some young women's clothing. The House of the Holy Comforter requires household linens and bedding. Bonnie Brae, being the home of about *thirty* boys, needs boys' garments, blouses, overalls, etc., and household articles.

"This is but a rough outline of our work, and if we arrange a part of our time to care for Diocesan Institutions the usefulness of the Comfort Club will be doubled. Send packages to the Diocesan House at 21 Washington Street, Newark, N. J., marked plainly, 'For Comfort Club,' between the dates of November 15 and May 15—not later, please. And send all moneys to Mrs. F. H. Brown, Dana Place, Englewood, N. J."

If I can be of any service in making this a gradual change, not a drastic nor radical one, I shall be most happy to be called upon.

Reports of the District Directors

THE DISTRICT OF ENGLEWOOD

The District of Englewood, which was separated from the District of Hackensack in October, 1923, comprises one large church, three small churches, three churches so small that each is only part of its rector's charge, and nine missions.

The Spring and Fall Meetings are called "Conferences for Church Women" and every guild in the District is invited to report its activities, whether missionary or parochial. These are all day meetings, beginning with the Holy Communion. At the Spring Meeting held in Christ Church, West Englewood, the principal speaker was Mrs. Ross, of East Orange, who described her observations of Church Missions and Schools in Japan on a recent trip around the world. At the Fall Meeting in St. John's, Nordhoff, we had the privilege of listening to Mrs. Paul Maslin, who with her husband is home on furlough from Hankow, China, and Mrs. Williams, of the Educational Department, led a stimulating discussion of parish guild problems.

In addition to these Conferences the larger parishes have inaugurated the neighborly custom of inviting all the District to particularly interesting local

meetings. St. Paul's, Englewood, extended such invitations to hear Bishop Remington, of Eastern Oregon, in February; and Mrs. Ballington Booth, in November; and the Church of the Atonement, Tenaflly, in January, to hear Mrs. Estelle Royce, U. T. O. worker from Panama and Haiti; and in April, Mrs. Pitman, Diocesan U. T. O. Custodian

Two committee meetings of District and Parish officers were held in January, at the Church of the Atonement, Tenaflly, and in October at St. Paul's, both with small attendance.

EDUCATIONAL DEPARTMENT—No discussion classes were held, but during Lent the text book on Japan was read aloud in the guild meetings at St. Paul's, Englewood. The new Educational Secretary reports a great gain in the number of missionary calendars sold this Fall. The District paid the expenses of a delegate to the Princeton Summer School, Mrs. Reid, the new Social Service Secretary.

SUPPLY DEPARTMENT—Four guilds sewed for the allotment, furnishing their own materials; three others offered to sew on materials furnished by the Supply Department; three gave money for supplies in addition to their contributions to the budget. This Fall four personal boxes were taken in the District, only one a year having been sent in the past. Many boxes of used clothing were shipped to the DuBose Memorial Training School, in Mont-eagle, Tennessee. This Autumn two young girls' organizations have applied to the District Supply Secretary for missionary sewing.

SOCIAL SERVICE DEPARTMENT—All Saints', Leonia, gave a day's outing in July to children from a Jersey City Institution, co-operating with the Diocesan Social Service Department.

UNITED THANK OFFERING—The District Custodian has placed blue boxes in four guilds where they were not in use.

The Auxiliary organization in this District is still very loose. The full quota of officers was secured only in May. The Bishop's visitation in the Autumn afforded opportunity for increased neighborliness and mutual acquaintance, and during October the Director, always in the company of another officer, attended services in every church and mission of her District.

THE DISTRICT OF HACKENSACK

There are fifteen parishes in Hackensack District, and all are gradually coming into diocesan work.

Two District Meetings were held during the year. The Spring Meeting, in May, at Oradell, and the Fall Meeting in Montvale. Both were all-day meetings followed by a business session and conference. The District sent a delegate to Princeton Summer School.

Supply work was accomplished by many of the guilds and second-hand clothing sent.

We have now an Educational Secretary, Social Service Secretary, and United Thank-offering Custodian, and hope to have active work in all these departments this year.

A Lenten Study Class was held in one parish and we hope to see this work spread.

Monthly meetings are held for Guild Presidents and Officers of the District in Hackensack on the second Wednesday in each month, and it is expected that this will increase interest.

The past year showed improvement in knowledge, and interest in the Church Work and we are much encouraged.

THE DISTRICT OF JERSEY CITY

The Jersey City District consists of twenty churches, seventeen having active branches of the Woman's Auxiliary.

Three District meetings were held during the year—the Mid-winter one at Trinity, Bayonne, with Canon Prichard of the Cathedral of St. John the Divine as the speaker; the Spring meeting at Grace Church, Town of Union, with the Rev. George Plaskett as the speaker; and the Fall meeting at Trinity, Hoboken, where three members of that Auxiliary presented the play, "Home on Furlough."

There were three Executive meetings held.

EDUCATIONAL DEPARTMENT—A delegate was sent to the Summer School at Princeton. Her report was most inspiring. Ninety-five calendars were sold this year. Institutes are being planned for January to be held in Jersey City, Hoboken and Bayonne.

SUPPLY DEPARTMENT—Seventeen churches responded, with two others promising to work this Lent. The response was most cordial and the quota assigned the District will be met. The sewing was sent to Bishop Manuel Ferrando, Ponce, Porto Rico. We also sent seven Christmas Gift Boxes and two Personal Boxes. Much second-hand clothing was sent as directed by the Auxiliary.

SOCIAL SERVICE DEPARTMENT—The city authorities of both Hoboken and Jersey City have recognized the Social Service work of the Episcopal Church and have co-operated with it and asked its assistance. *Recreation*—Last summer 105 children were entertained by the churches of Leonia, Little Falls and Montclair. Each month candy, books and toys were taken to the County Institutions, and parties have been given at the Home for Aged Women, S. P. C. C., etc.

UNITED THANK OFFERING—Fourteen parishes are contributors through the Blue Box with a healthy increase in numbers and amount given. St. John's, Jersey City, was fortunate in having the presentation service of the United Thank Offering, in May.

Each year shows an increase of interest and work accomplished and the same splendid spirit prevails.

THE DISTRICT OF MONTCLAIR

The Montclair District consists of three large churches, four small churches, and four missions.

Every month an Executive Committee meeting is held. This consists of the six District Officers, the President and one or two delegates of the Woman's Auxiliary from each of the Churches.

At this time the Director passes on information received at the Diocesan Executive Committee Meetings, gives notices, etc., and the District Officers and Auxiliary Presidents give a report of their work. Some branch of the general work, such as the U. T. O., Comfort Club, Educational, Supply, or Social Service Department, is made a "Special" at each meeting, and the head of that work in each church is asked to be present and report. In this way we are kept in touch with one another, and get new ideas. At the close of the business hour tea is served, and we meet socially and become better acquainted.

The All Day Spring Meeting was held at St. Peter's, Essex Fells, on April 30th, and for size and spirit was a record breaker. The District Officers told of what each Department had accomplished as a whole during the year, and the Presidents of every Auxiliary and Guild reported on their work.

Mrs. Albinson, from Pompton, told of her visit to Princeton Summer School, and the Rev'd Carol M. Davis spoke on Japanese Reconstruction.

In June the Churches sent a donation of fancy and useful articles, valued at \$174, to Bazaars held in two of our missions for their building funds.

On October 3rd and 16th, the District Officers made the Pilgrimage with the Bishops to their Churches and Missions, some parishioners joining with them.

The Fall All Day Meeting was held at St. John's, Montclair. The Diocesan Officers made brief addresses, and at the informal luncheon each one presided at a table, gathering about them the women especially interested in their branch of the general work. After luncheon Mrs. Boynton gave an interesting account of her recent visit to Mexico.

THE EDUCATIONAL DEPARTMENT reports an interesting and well attended Study Class during Lent. "Creative Forces in Japan" read and enjoyed in several Auxiliaries. The sale of Calendars is smaller by fifteen copies than last year, partly accounted for by the fact that it was not ready at the Fall Meeting. Thirty copies of "China's Real Revolution" sold, and ten of "My Father's Business."

THE SUPPLY DEPARTMENT reports 10 boxes of used clothing shipped—3 "Personal boxes," 8 "Joy boxes," and 16 "Institutional boxes," making a total value of \$1,806.19 for the year's work; 11,000 surgical dressings were made and shipped to China.

SOCIAL SERVICE DEPARTMENT—In July St. Agnes' Guild gave a day's outing to 39 children from Jersey City. During the same month, the afternoon Guild of Christ Church entertained 40 children. In August, St. James' entertained 30 children from the Tuberculosis Clinic at Kearny. Bountiful luncheons of sandwiches, milk, ice cream and cake were served on each of these days.

An urgent call from Essex Mountain Sanatorium for men's clothing and shoes met with a prompt response from the churches.

One needy family has received aid in coal, warm clothing, and Thanksgiving and Christmas dinners.

Our Social Service Secretary attended the course of classes under Miss Dykeman at the Diocesan House, also giving one-half day each week to field work with appointed Social Service agencies, and one-half day to visiting hospitals, courts, juvenile and adult; special classes in day schools, also asylums and nurseries.

THE WOMEN'S UNITED THANK OFFERING is now 100%, every church and mission having a Custodian—about 800 contributors.

THE DISTRICT OF MORRISTOWN

Of the twelve parishes in the Morristown District all are doing some kind of Auxiliary work with one exception, a parish which has thus far taken no interest in forming a branch of the Woman's Auxiliary. The mission in Mt. Arlington is practically closed during the winter, but our Educational Secretary reports a beginning of interest. The other branches are active in all departments.

Besides personal boxes sent by the larger parishes, all branches were interested in working for Simmon's Gap Mission, Va., and a goodly number of garments for men, women, and children were supplied. Joy boxes were sent to women missionaries and a generous response made to the Japanese Emergency Fund.

Our new Supply Secretary is planning for the work apportioned to the District this year, St. Mary's in the Mountains, Sewanee, Tenn.

The Educational Department reported four study groups on Japan during Lent and a large class on Prayer conducted by the Rector in Calvary Church, Summit. Plans are being made for greater work this year. The District is glad to report having sent one young woman to the Summer School at Princeton besides several who went from individual parishes.

There is need for more active interest in the Social Service Department of the District and we hope to accomplish greater work next year.

The Annual Spring meeting was held in St. Peter's Church, Morristown,

May 6. Reports of parish branches were presented and officers elected for the year, the only new officer being Mrs. F. W. Keasbey, Supply Secretary, to succeed Mrs. Hoffman, who because of ill-health was obliged to give up the work. Mrs. Boynton spoke in reference to the work in Hooker School, Mexico, and Mr. Leidt, of the Educational Department of the Church Missions House, told of the need for re-building in Japan and our responsibility.

The Fall meeting was held in Grace Church, Madison, October 6, when Mrs. Boynton gave an interesting account of her recent visit to Mexico and Hooker School. The other Diocesan officers told of plans for the year and at the close of the meeting Rev. Mr. Mori gave a pleasing account of the pilgrimage of the Bishops and clergy through this section of the Diocese.

Meetings of the District Officers and Parish Presidents are held from time to time as needed for discussion of plans.

THE DISTRICT OF NEWARK

There are twenty-one parishes in the District of Newark, all doing excellent work, but there is not complete co-operation between them and the Woman's Auxiliary. An effort is being made to co-ordinate the work of diocese, district and parish, and to this end, each parish is urged to appoint delegates to attend the District Meetings which are being held at Trinity House, from two to three-thirty o'clock on the third Monday of every month.

EDUCATIONAL DEPARTMENT—We have to report four requests for speakers at parish meetings, two parishes with mission study classes, several candidates for normal class for leaders, and four delegates to the Princeton conference; with Miss Russell, of Grace Church, one of the faculty.

Missionary Calendars were sold in excess of our allotment, and the additional fifty subscriptions for THE SPIRIT OF MISSIONS are in a fair way of being disposed of.

SUPPLY DEPARTMENT—Mrs. Hobbie reports satisfactory response in the District for the work of her Department, but as much of the sewing is done during the Lenten season, a definite report at this time is not available.

SOCIAL SERVICE DEPARTMENT—This Department has opened a "Service Exchange," with a temporary office in the Diocesan House. It is hoped that the Exchange may help women of inadequate means, whose needs are not met by the usual employment agency, and also those people requiring service which can best be supplied through a church organization.

Applicants need not be members of an Episcopal parish, but all applications must be made through a member of an Episcopal organization. We expect to co-operate in this work with the Church Mission of Help, and with the Social Service Bureau of Newark.

Miss Van Ingen, who took the course of training in Social Service work, given at the Diocesan House in October and November, will be a volunteer worker in St. Barnabas' Hospital.

UNITED THANK OFFERING—Mrs. Kelsall reports eighteen parishes using Blue Boxes, an increase of three over last year, and five hundred and seventy-three women contributing.

The District held its Spring meeting at St. James' Church, at which time new District officers were elected, and much stress laid upon the work of the various Departments.

The Fall meeting was held at Trinity House in October. Dr. Pott of Changshu, China, gave a very interesting talk on China, with special reference to his hospital work.

THE DISTRICT OF NEWTON

There are ten parishes in the District of Newton, with branches of the Woman's Auxiliary in five of these. The parishes doing Auxiliary work have taken much interest in the work, sewing and contributing clothing for the Good Shepherd Mission, Abingdon, Va. There has been an increase in the number of Missionary calendars sold over last year.

The United Thank Offering is growing, and plans are being made to bring the Little Blue Box to all women.

The Spring meeting was held at Washington in June with a good representation from many of the parishes. Speakers included Mrs. Boynton, Mrs. Pitman, Miss Shaw and the Rev. George Plaskett who spoke of the National Training School for Colored Workers at Raleigh, N. C. The offering was given to this Special.

The October meeting was held at Newton with an attendance of 45. The Diocesan Officers were present and explained the work being planned for the Fall and Winter. This meeting was of much interest to us all and is showing results by increases in giving to the Budget and Specials by some of the parishes.

I wish to take this opportunity to thank the parishes for their ready co-operation in all of the work.

THE DISTRICT OF ORANGE

The District of Orange consists of sixteen Churches and one Mission.

The women in these Parishes have shown great interest and marked results in carrying out plans in the four lines of Service, namely, Departments of Education, Supply, Social Service and the United Thank Offering.

Two District Meetings were held, the Annual Meeting in April at St. Stephen's Church, Millburn, and the October Meeting at St. Paul's Church, East Orange.

Mr. Balcon, from St. Michael's Mission, Project, Wyoming, was the speaker.

Personal and Christmas boxes were sent from many of the Parishes, and all, except three, are co-operating in the special work assigned to the District.

The Department of Social Service is progressing, three women attended the class for workers at the Diocesan House during November and two will continue to work with the Orange Bureau of Charities.

The District is proud that it is 100% U. T. O. (all Parishes responding).

A Secretary for the Educational Department is needed; in fact, it is impossible for the work to grow without a suitable head. Will one woman in the District offer her services?

Appreciating all the help given me by the District Officers and Women of the Parishes, I hereby submit this report.

THE DISTRICT OF PATERSON

The District of Paterson consists of twenty-two parishes, seven are missions. In each Church the women are doing some form of Auxiliary work, although not always under that name, some parishes preferring to call the societies through which they work a Guild, Parish Aid or Ladies' Aid. Many supply their own work. However, our District Supply Secretary reports for 1924, 2 personal boxes, 19 churches made 949 garments, 7 churches gave materials amounting to \$552.22. For 1925, so far, 9 churches are making garments,

4 churches are giving materials amounting to \$208.50, 4 personal boxes have been shipped. Not all of the parishes have reported. St. Paul's of Paterson sent a box to one of our missionaries, Miss Helen Sparkman of New Mexico.

The Educational Secretary reports: A Guild is being formed at the Church of the Good Shepherd at Ringwood Manor for the first time. One member of the Paterson District attended the Social Service course arranged by Mrs. Porter and given by Miss Dykeman at the Diocesan House, and as a result social service work has been added to the programs of three Guilds in this District. Fifty-two Church Missionary Calendars have been sold to date, this being an increase of 100% over last year. Subscriptions for THE SPIRIT OF MISSIONS are coming in very slowly. During Epiphany and Lent various parishes, including St. Paul's, Paterson, and Christ Church, Ridgewood, are planning to hold Study Classes, using as text-books "China's Real Revolution" and "My Father's Business." The Parish Educational Secretary at St. Paul's, Paterson, held a fine meeting with her group, speaking on the "History of the Diocese," this being the 50th anniversary of the Diocese.

On October 22nd the Fall District Meeting was held at St. John's, Passaic, where our Diocesan officers addressed us and Dean Dumper gave a most inspiring talk on the "Woman's Auxiliary."

On October 28th an Auxiliary Day was held at Christ Church, Ridgewood, at which some of the Diocesan Officers spoke.

The Spring District Meeting is to be held at the Church of the Epiphany, Allendale. Holy Communion at ten A. M. followed by an all day meeting.

About 15 Churches are using the U. T. O. blue boxes. Mrs. Probert, the U. T. O. Secretary for this District, attended a meeting at St. Peter's, Clifton, on Friday, December 12th, with the result that another parish has been added to the U. T. O. list.

Constitution

NEWARK BRANCH OF THE WOMAN'S AUXILIARY TO THE NATIONAL COUNCIL

ARTICLE I.—NAME

This Society shall be called the Newark Branch of the Woman's Auxiliary to the National Council.

ARTICLE II.—OBJECT

The object of this Society shall be to carry out within the Diocese of Newark the purposes and work of the Woman's Auxiliary to the National Council.

ARTICLE III.—MEMBERSHIP

The membership of this Society shall be composed of all women, and parish organizations of women, actively engaged in carrying out its object.

ARTICLE IV.—EXECUTIVE BOARD

The officers of this Society shall be a President, three Vice-Presidents, a Recording Secretary, a Corresponding Secretary, a Treasurer and a Custodian of the United Thank Offering, who, together with the District Directors and Chairmen of Committees, shall constitute the Executive Board.

ARTICLE V.—AMENDMENTS

This Constitution may be amended by a two-thirds vote of the whole number of delegates present at any regular meeting, *provided, however*, that notice of such amendment has been given, in writing, to the organization in each parish, at least one month previously.

By-Laws

ARTICLE I.—MEETINGS

Section 1. There shall be four regular meetings of the Auxiliary during the year, to be held on the first Wednesday of the months January, March, May and October.

Sec. 2. The meeting in January shall be the Annual Meeting.

Sec. 3. The President shall call at least four regular meetings of the Executive Board each year, which shall be held on the first Wednesday of the month.

Sec. 4. Eight shall constitute a quorum at all meetings of the Executive Board.

ARTICLE II.—DUTIES OF THE OFFICERS

Section 1. It shall be the duty of the President to preside at all meetings of the Auxiliary and of the Executive Board; to call special meetings; and to have a general supervision of the work.

Sec. 2. The first Vice-President shall represent the Department of Education.

Sec. 3. The second Vice-President shall represent the Supply Department.

Sec. 4. The third Vice-President shall represent the Department of Social Service.

Sec. 5. It shall be the duty of the Corresponding Secretary to conduct all correspondence of the Auxiliary and to send out all notices. She shall also be the Custodian of the Emery Fund, and the Book of Remembrance.

Sec. 6. It shall be the duty of the Recording Secretary to keep the Minutes of all meetings of the Auxiliary, and of the Executive Board, and present a report at the Annual Meeting.

Sec. 7. It shall be the duty of the Treasurer to receive and keep all moneys contributed, and to disburse the same; exclusive of the Emery Fund and the United Thank Offering.

ARTICLE III.—COMMITTEES

Section 1. There shall be the following committees: Publicity, Finance, Auditing.

Sec. 2. The President, with the approval of the Executive Board, shall appoint the Chairmen of Committees.

ARTICLE IV.—ELECTIONS

Section 1. Elections shall be by ballot.

Sec. 2. At the Annual Meeting in January, 1922, and each third year thereafter, there shall be elected a President, and a Corresponding Secretary, to serve for three years or until their successors shall have been chosen. There shall also be elected a first, second and third Vice-President, to serve for two years; a Recording Secretary, a Treasurer, and a United Thank Offering Custodian, to serve for one year.

At the Annual Meeting in January, 1923, and each third year thereafter, there shall be elected a Recording Secretary, a Treasurer, and a United Thank Offering Custodian, to serve for three years or until their successors shall have been chosen.

At the Annual Meeting in January, 1924, and each third year thereafter, there shall be elected a first, second and third Vice-President, to serve for three years or until their successors shall have been chosen.

All officers shall take office the May following their election, except the Treasurer, who shall take office immediately upon election.

ARTICLE V.—DELEGATES

There shall be five delegates to the Triennial Convention, nominated by the Executive Board, and elected by the Auxiliary, with the approval of the Bishop.

Delegates to all other meetings shall be elected by the Executive Board.

ARTICLE VI.—AMENDMENTS

Amendments to these By-Laws may be made at any regular meeting, provided previous notice has been given in writing to members.

SUGGESTIONS FOR DISTRICTS

Districts shall elect their own officers.

District Directors shall be elected for three years, and are members of the Executive Board.
