A Message to the Women of the Church

We, the members of the Woman's Auxiliary, in Triennial Meeting assembled at New Orleans, in October, 1925, being deeply concerned over the grave financial situation which still faces the National Council and even more alarmed by the apathy and lukewarmness of many of us, Churchmen and women, have pledged ourselves to co-operate in every way possible with and in any plans of the National Council for the carrying out of the Church's program.

We go back to our diocesan and parish branches dedicated and committed to :

- (1) The payment in full of all general Church quotas.
- (2) The overcoming of lukewarmness by deeper spiritual understanding and greater consecration through prayer and the sacraments.
- (3) The awakening of the women of the Church to more effective service for Christ.
- (4) United parish effort.
- (5) The strengthening of our rural and foreign-born work.
- (6) Closer relationships with the missionaries in the field.
- (7) Furthering in every way the spirit of united Christian effort.
- (8) The carrying out of a constructive program of education for peace, and the use of our best efforts and strongest influence toward the promotion of international and inter-racial good-will.

THE RE-DEDICATION

Used by the Women of the Church gathered in New Orleans, Thursday,
October 22, 1925.

Realizing that only through personal dedication to Jesus Christ, our Lord, can we hope to bring to fruition our human endeavours, we re-dedicate ourselves to the service of our Lord Jesus Christ, to making the strength of our deeds the measure of our Faith; to a sincere and simple effort in our daily living to follow with humility the example of our Saviour.

"I would make this Message my own—

"I would know the Father as did Jesus Christ when on earth, opening my eyes daily to behold Him in other people, in the beauty of earth, in the written word, in the Sacraments and through daily communication with Him.

"I would know my Church as He knows it and dare to face where we have been untrue to her calling, joyfully accepting the service she asks of me.

"I would know myself as my Lord Jesus Christ does, and be made conscious of those things which have prevented me from being a true follower.

"I would offer myself daily to Him, my body, my mind, my spirit, in full consecration, trusting Him with my whole life and learning to be wholly His.

"I would follow Jesus Christ and Him only, giving proof through all contacts of my life of my conviction that He is the only way of life striving to help those about me to understand and to use His power and through it to accomplish His purpose in the world.

"I would be a messenger of His grace, an ambassador of God among men, a doorway through which Christ may enter into the world."

A Letter

South Orange, New Jersey,
January, 1926.

My Dear Fellow Workers:

This, my first greeting to you in the "Blue Book," is both "Hail and Farewell," since, with this issue, we inaugurate our new plan of a Triennial blue book instead of an annual one.

We have adopted this policy as an economy and also as a practical evidence of our wish to conform with the national plan of the Church.

It is our hope that district and parish officers may ultimately serve for three years as do your diocesan, provincial and national officers, and that in district and parish your program of gifts, work and service may also be for the Triennium.

In accord with this plan the Financial Budget adopted at our annual meeting was an annual budget for each of the three years of this Triennium (1926-1928).

On the preceding page you will find the spiritual pledge made by the women (representing each of you) assembled in Triennial Meeting in New Orleans, which we hope may be the inspiration to re-dedication for every woman of our Church.

We are also pledged to a very definite program of service, financial, educational and social.

First, to a concentrated effort to carry out the Program of the National Council by seeing that the full quota for Budget and Advance Work is raised in Parish and Diocese; second, to a constructive plan not only to inform ourselves and other church-women as to all the work of the Church, at home and abroad, but one that will tend to the building up of a public understanding of and demand for Peace and United Christian Effort, and third, an effort toward friendliness and understanding in rural communities and among the foreign-born and toward acquaintance with and service to our missionaries and their children.

To this national program we add our diocesan one of devotion and service, ever remembering that it is only by "the strength of our deeds" that we prove the faith that is ours.

Will you study your "Blue Book," know your diocesan and district officers, use them and let them know you?

Yours for such co-operation and service that this Triennium may be our best.

Objectives in Work and Prayer

WOMAN'S AUXILIARY OF THE DIOCESE OF NEWARK,
1925-1928.

A. OBJECTIVES IN PRAYER. (It is suggested that these topics of Prayer be used at Diocesan, District and Parish meetings and private devotions.)

Let us pray for

1. The deepening of our own spiritual life and that of the Woman's Auxiliary in this Diocese.
2. The fulfillment of the Program of the Church in Budget and Advance Work.
3. The coming Triennial of the Woman's Auxiliary.
 - a. For adequate plans and preparation.
 - b. For a large offering of life and money.
 - c. For significant results.
4. Our mission fields, especially Porto Rico, Haiti and the Virgin Islands and our missionaries throughout the World.
5. The promotion of such a spirit of good will among the nations as will tend to bring peace upon earth.
6. A united front of all Christians against the forces of materialism; and a united Christian effort.

B. OBJECTIVES IN WORK

Let us

1. Support the Synod in its plans for the Province.
2. Support the Woman's Auxiliary in its plan for a Scholarship in the Province.
3. Further the Program of the Church.
(By keeping our branches informed about the Program in the Nation, Diocese and what our particular parish is doing, or how it stands.)
By co-operation on the part of the Woman's Auxiliary with all other Diocesan plans.
4. Support the Program for increased information among Churchpeople, by using the Spirit of Missions, the Study Class, the Summer Schools, Program Meetings, etc.

C. PROVINCIAL OBJECTIVES

1. Foster the spirit of fellowship and good will in the Province,
By giving delegates to the Synod a chance to speak of the Provincial Meeting.
By Diocesan officers attending meetings in other Dioceses.
By knowing each other's work, through the Year Book, Diocesan Papers, correspondence, etc.
By attending Provincial Summer Schools.
By joining in a fellowship of prayer and work.

Standard of Excellence

SUGGESTED FOR PARISH BRANCHES OF THE WOMAN'S AUXILIARY OF THE DIOCESE OF NEWARK.

The accompanying Standard was adopted by the Executive Committee at its meeting in December, 1924, and is recommended to the Parish Branches.

It is in no way obligatory, but it is hoped that it will be found helpful in measuring their growth and activity. It has been drawn with care, so that the smallest as well as the largest Branch alike may have a chance to register 100%.

For this Standard the Diocese of Newark is indebted to the Diocese of Albany, where it is already in operation.

NOTE—The basis of the Standard is 100, each section counting 20. Active membership includes all women who, through systematic prayer, study or work, participate in the life of the Branch.

The year upon which the Standard is reckoned is from January 1st to December 31st.

1. MEMBERSHIP

- A. Net increase in membership—10 points.
- B. An average attendance at regular meetings equal to at least one-half of the active membership—10 points.

2. PRAYER

- A. The use of the Prayer Leaflet by at least one-half of the active membership—10 points.
- B. Parish observance of a Corporate Communion of the Auxiliary during the year—10 points.

3. OFFERINGS

- A. Adoption of some one Class in the Budget—10 points.
- B. Contributing to the United Thank Offering by at least one-half of the women of the parish—10 points.

4. INFORMATION

- A. One Mission Study Class, Intensive Day, or series of Program Meetings—10 points.
- B. Subscriptions to, or regular use of, THE SPIRIT OF MISSIONS by at least one-half of the active membership—10 points.

5. SUPPLY DEPARTMENT

The preparation of one box, or part of a box, in co-operation with the Supply Department—20 points.

Suggestions to Parish Officers

Use the Prayer Leaflet in order that all may be thinking along the same lines.

[The Leaflet may be secured from the Chairman of the Department of Devotional Life, price, 25 cents.]

Parish Officers should plan to attend all District Meetings and keep in close touch with Diocesan Officers.

Supply Work should be secured through the District Supply Secretary, Educational Work through the District Educational Secretary, Social Service Work through the District Social Service Seeretary, and all information connected with the United Thank Offering should be secured through the District Custodian.

Attendance at the Summer Schools at Geneva, Burlington or Annandale should be secured, if possible. Parish Officers would find them of great value.

Include in every personal box a copy of some good book.

Parish Presidents should see that all notices of Diocesan and District matters are distributed to the members, and that changes in Parish Officers, or their addresses, are reported to the Diocesan Corresponding Secretary.

Suggestions to Parish Treasurers

Realize the importance of your office, as it is in your power to increase the desire to give on the part of your members.

Study carefully the "Budget" Sheet (page 37) and know how the money is used.

Know what is meant by "Advance Work" and the "Parish Quota."

If you pay to a Scholarship, know whether it is a Special or is to count on your Parish Quota, and so notify the Diocesan Treasurer when you send her the money.

Simple but systematic accounts should be kept, and a financial statement rendered at each business meeting. Have bank books balanced once a month, all vouchers filed, and accounts audited once a year.

Date all letters, give the name of your Parish Guild or Auxiliary, state which class in the Budget you have selected and which class in the Specials. Sign your name, adding married name and address, or, if unmarried, write (Miss) in parenthesis.

If you resign, notify the Diocesan Treasurer and send the name of your successor. Be sure to give to your successor all the information that you possess in regard to the work.

Remember that the Fiscal Year begins January 1st and ends December 31st. December money should be sent as early in the month as possible in order that the Diocesan Treasurer may have time to write her report and have her books audited.

Keep your Rector informed of all payments that apply on your Parish Quota.

Make your monthly reports so interesting as to inspire your members to give, and show what has been paid and what remains to be paid.

In Missions and weak Parishes contributions of five or ten cents a month to the Budget and Specials will be found an easy way to share in the work, and those who are unable to attend the meetings should be given this opportunity as well.

In every District, except Hackensack, there was a regular study class, or one-day Institute, and the sale of Mission Calendars, which exceed last year, is being well distributed, every Parish and Mission in some Districts having taken one or more. 232 copies of "China's Real Revolution," 77 of "My Father's Business," 109 of other related books and magazines, charts and maps were distributed, besides many others which were ordered directly from Church Missions House. The classes were conducted by ten leaders, four of whom were working in Diocese for first time. Several leaders had charge of more than one class. Speakers were furnished and material for programs arranged, for many Parishes.

At Bishop Lines' urgent request, a definite effort was made, in each District, to secure new subscriptions to the "Spirit of Missions," but only about 200 were reported. This January many are working at it again. Who will help in this important work?

In various centers of the Morristown District, on Sunday afternoons of December, a series of talks and discussions on Peace, from different angles, have been given, in some instances making of it a community affair. Later the same thing is to be attempted in some of the Young Peoples' Fellowships.

Two large meetings have been held under the auspices of this department. One was in April, at St. James' Church, Newark, where about 100 people, representing the study classes that had just finished their work, heard a fine résumé of the educational work, by Dr. Sturgis. The other was in September, at Grace Church, Orange, when 125 people, from many Parishes of the Diocese, heard Dr. Walkley speak on religious education, and had a chance to talk over plans for this year.

An executive committee, composed of the District Educational Secretaries and two of the leaders, meets four times a year to plan the work.

The year's record must not be closed without mention of the privilege and joy of being a delegate to the Church Triennium at New Orleans. Grateful recognition is here made of \$100 of the apportionment for Education, given to help pay the expenses of the trip.

This department is keenly aware of how little progress has been made. It offers a wonderful thing to Parish Presidents—assistance in lining up the members of their groups, on the side of helping to build the Kingdom of God. Basil Matthews, in his book "The Clash of Color," quotes H. G. Wells as saying: "The world situation is a race between education and catastrophe." We offer, for this season, a magazine which Mr. Hobbs calls a Geographic with a mission; a calendar, with a page a week telling about, and praying for, some part of the Church's work; and such books on topics of current thought as "The Search for Peace"—"That Freedom," a fine exposition of an unfamiliar side of the Monroe Doctrine—and "The World and I."

Two good reasons for arranging for study classes in every Parish come from headquarters. The first, the record of attendance at the classes at New Orleans, in spite of heat, mosquitoes, the early morning hour, and crowded program, showing that the people are anxious for such classes. The other reason:—a returned missionary from China reported, that in speaking in cities, from the Atlantic to the Pacific, "he found women able to ask intelligent questions about China, and fit the answers into a proper frame-work," and he sent congratulations for the good work done in the past year's classes on China. Are the Presidents arranging, this year, to offer classes to their groups, so that women may know about Latin America, when returned missionaries from there visit us?

The Diocese embraces so many active Parishes that this work can only be properly accomplished by having, in each District, Educational Secretaries, of consecration and vision. Our workers are so few, and the opportunities of presenting this work to all women are so limited. Somehow, we must break down the wall, raised everywhere, that to be acquainted with the work of extending Christ's Kingdom belongs only to Auxiliary women, and put, in its place, a conviction, that to know why one is on the side of peace, rather than war; to know about the pitiful condition of our nearest neighbors, the Latin-American countries, and how the Monroe Doctrine applies to them; and to know what relations each one of us has to the whole world, is the duty of every American woman of our church.

The work of the Supply Department during the past year has gone on with its customary vigor, there never being any lack of enthusiasm for this branch of the Auxiliary work.

Besides these many special appeals came to us from The Church Missions House, which were met promptly.

The last months of the year have been devoted chiefly to the Personal Boxes for the missionary clergy and the Christmas Gift Boxes for the women missionaries. These are on the allotment for 1925-1926.

There are 22 of the Personal Boxes with one special call for a surplice alone, and 33 Gift Boxes.

There are also three Catechists whose wants are supplied by the Comfort Club.

The needs of the Missions could never be met as completely as they are without the help from the Comfort Club which its Director, Mrs. Chester Lee Colton, gives so freely.

Thanks are due to the G. F. S., who always undertake a large part of the missionary appeal, and to the District Directors and Supply Secretaries, without whose co-operation so much could not be accomplished.

The complete reports for the year show that the value of the work done amounts to \$15,434.00.

Report of the Third Vice-President

During the Spring, Case Work was continued by members of the class for Volunteer Training, and one member of the class has gone definitely into the Work of the Church Mission of Help.

During the Summer months, under the able direction of Mrs. McKibben and Mrs. Bouton, the recreation work was continued. Nearly five hundred children and a few mothers were given a day's outing, twelve churches and one of the members acting as host.

Four children have been placed for convalescent care in private homes in our Diocese.

During the Christmas vacation St. James' Church, Upper Montclair, gave a party for fifty children from Jersey City. Another parish gave a party for a smaller group. Two children were entertained for Christmas vacation in private homes. Food, clothing and money, also, were distributed.

It is impossible to give a report of the Case Work, but the members of the Department are constantly being called on to help adjust family relationships, obtain institutional care and visit the sick.

The Training Class has been postponed until March on account of the late dates of the District meetings. The Class will be held in March in Trinity House, Newark, under the direction of Dr. James S. Plant of the Essex County Juvenile Clinic.

My thanks are due to the Executive Board, the District Directors, and to the women who so loyally carried on the work during my long absence.

The Emery Fund The Book of Remembrance

"There shall be created an Emery Fund for Missionaries home on Furlough, to be given over to the Board of Missions or their successors, to be for all time a Trust Fund, the interest of which shall be used for women missionaries on furlough in such way as the Executive Committee of the Woman's Auxiliary or its successors shall approve." (From the Minutes of the Triennial Meeting of the Woman's Auxiliary, held in Detroit, Michigan, October, 1919.)

In connection with this Fund the Woman's Auxiliary of the Diocese of Newark established a Book of Remembrance.

In it may be recorded the names of former diocesan officers and those women no longer living, who in parish branches have served the Auxiliary and Church in their day and generation. The sum of five dollars, which accompanies the name, is sent to the Emery Fund at the Church Missions House.

The Book of Remembrance was presented on May 6, 1925, and at each of the spring district meetings.

Two names have been placed in The Book of Remembrance during the year 1925, that of Miss Marie Harbach, of All Saints' Church, Orange, who served as Parish Librarian for seventeen years, and that of Miss Anne D. Gilbert, Correspondent for the C. P. C. for twelve years, which was entered by the C. P. C. of the Diocese. Any names recorded are presented each spring at the district meetings at the Communion Service, by the President of the Woman's Auxiliary and the District Director. So grows the Emery Fund.

United Thank Offering of 1928

Resolutions Adopted at New Orleans, Louisiana.

Resolved, That the United Thank Offering of 1928 be given to the National Council for the work of women in the mission field, whose appointment has been approved by the Executive Board of the Woman's Auxiliary, including the training, sending and support of these women workers, and care of such workers, when sick or disabled; provided that not more than one-tenth of the offering be set aside and added to the permanent trust fund to be invested and administered by the National Council, the income to be applied to the support of retired United Thank Offering workers; also provided that the sum of not less than \$30,000.00 be devoted to the erection, completion or renewal of a building or buildings, approved by the National Council, on the recommendation of the Executive Secretary of the Department of Missions, and the Executive Board of the Woman's Auxiliary.

Be it further Resolved, That to our United gifts shall be added our united and earnest prayers, that God will put it into the hearts of many faithful women to give themselves, or of their substance, to the work of the Master in the Mission Field.

(As it was decided to be impractical to fix a uniform date for the whole Church, for presenting the United Thank Offering in dioceses, it was recommended that each diocese fix its own date in the spring and fall.)

UNITED THANK OFFERING POLICY

Resolved, That the women of the Church should not aim to provide the support of all women workers in the Mission Field, through the United Thank Offering.

In closing the books at the end of another Triennium, it is with a deep sense of gratitude to all the custodians in the one hundred and twenty-one parishes who have worked quietly and faithfully in placing the Little Blue Box,

to say nothing of those whose unbounded love and enthusiasm in the United Thank Offering would not admit of too much quiet! To all I say thank you for working with me so happily, making my task never a burden but a privilege.

Let us all help to spread the good tidings to the remaining twenty-nine parishes, until the goal is reached—every woman united in prayer, gifts and joyful service, that we may hasten the coming of our Lord's kingdom.

Report of the Department of Devotional Life

We sincerely hope that in this Diocese it may be possible to carry out the suggestions of the Commission on Faith and Order—namely, for a period of corporate prayer.

The Comfort Club

DIOCESAN INSTITUTIONAL SUPPLY DEPARTMENT.

This Club was established about 1892 by Mrs. T. A. Starkey, the wife of the second Bishop of the Diocese, herself the President of the Woman's Auxiliary at that time. Its present object is to assist the institutions of our Diocese and also to help out the Supply Department in the work of providing for schools, missions and hospitals. The gift of two small (new) or one large article and 35 cents annually makes one a member.

Every year the needs of our institutions must be much the same, for such requirements cannot vary greatly. The hospitals—Christ and St. Barnabas—need linens and hospital garments, and baby things. St. Katherine's Home, Holy Comforter and Bonnie Brae are also in need of linens, and each has a few individual requirements, according to the groups they serve. The Church Mission of Help needs baby things and young women's wear. The House of Good Shepherd and the Laura Augusta Home are really not in any present need. I would commend to your attention the schools at Ralston. Although they have asked for nothing, I am sure the Sisters in charge would welcome your interest.

The monetary value of the work of the Comfort Club during 1925 was about \$4,000—\$2,000 going to help our home institutions and \$2,000 to assist the Supply Department in its work in the National field.

The following letter sent out in November, 1925, to every Comfort Club Secretary or Woman's Auxiliary head explains our present plan and the working of this branch of our Woman's Auxiliary should by now have been thoroughly digested.

"As per the plan outlined last year, we expect to look out for the needs of the Diocesan Institutions through the medium of the Comfort Club. May I ask that no articles be mailed to 21 Washington Street, but that *lists* of these articles be sent to us, so that proper mailing directions can be returned to you and shipment be made as then directed. Owing to the fact that so very much duplication existed in the past, it is essential that we endeavor to carry out these new rules and thus expedite help to the Institutions, save your Diocesan officers unnecessary labor and lessen the money outlay incidental to re-mailing.

The method of procedure in the future will be:

1. Collect your Comfort Club articles, having in mind the work of the Institutions in the Diocese.
2. Make a list of the collection and mail to Mrs. Hobbie.
3. When the lists are returned with the directions for your shipping, pack as suggested and mail to the addresses given.
4. Then make revised list, giving articles sent to each address and their value, and mail to the Comfort Club Secretary.
5. Send all moneys to Diocesan Treasurer, Mrs. W. R. Baker, 43 Crescent Road, Madison, N. J.

THE DISTRICT OF JERSEY CITY

The Jersey City District consists of 20 churches located in Woodcliff, Union City, West Hoboken, Hoboken, Jersey City and Bayonne. Seventeen are engaged in the work of the Woman's Auxiliary.

During the year 1925 there were held three executive meetings and two District meetings: The Spring one at St. John's, West Hoboken and the Fall meeting at St. Paul's, Jersey City.

EDUCATIONAL DEPARTMENT—The Educational Department showed very marked activity under a very able Secretary. 181 Calendars were sold. The District sent a delegate to the Princeton Summer School and four additional students, sent by their respective churches, also attended. As a result of this work one church (St. Stephen's of Jersey City) presented a beautiful Christmas pageant. Three all-day institutes were held and the coming year there are four scheduled to take place.

SUPPLY DEPARTMENT—The Supply Department worked faithfully, as usual. Seventeen churches more than filled their quota. Two Personal boxes were filled and two Christmas boxes were sent.

SOCIAL SERVICE DEPARTMENT—This Department continues its good work. Monthly donations of candy were sent to the County Institutions and summer outings for poor children were most successfully held.

UNITED THANK OFFERING—The filling of the Blue Boxes shows a slow but steady increase with a spiritual awakening among the women.

The present year is starting with a renewed interest and a marvellous spirit of co-operation and loyalty among all the members of the Auxiliary.

THE DISTRICT OF MONTCLAIR

The Montclair District consists of three large churches, four small churches and four missions.

Every month an Executive Committee meeting is held. This consists of the six District Officers, the President and one or two delegates of the Woman's Auxiliary from each of the churches.

At this time the Director passes on information received at the Diocesan Executive Committee meetings, gives notices, etc., and the District Officers and Auxiliary Presidents give a report of their work. Some branch of the general work, such as the W. U. T. O., Comfort Club, Educational, Supply or Social Service Department, is made a "Special" at each meeting, and the head of that work in each church is asked to be present and report. In this way we are kept in touch with one another, and get new ideas. At the close of the business hour tea is served, and we meet socially and become better acquainted.

The All-Day Spring meeting was held at St. Agnes', Little Falls, in May. Every Parish and one Mission represented.

The Book of Remembrance was presented, and the Rector read the names of the women of this District which were inscribed in it. The Offering, which was for the Holiday House Building Fund, was \$163.82, the largest ever taken at a District Meeting.

The District Officers told of their work, and a report was given by the President of every Auxiliary and Guild.

Mrs. Colton, the speaker, outlined the work of the Comfort Club, illustrating her talk with dolls in costume to represent the different Diocesan Institutions.

In June the churches sent fancy articles valued at \$207.48 to bazaars held in two of the District Missions.

The Fall All-Day Meeting was held at Christ Church in October. All Parishes and one Mission represented. Diocesan delegates gave reports on the Triennial in New Orleans, and outlined the work they wished the Auxiliaries to accomplish during the year, and at luncheon each one presided at a table, gathering about them the women especially interested in their branch of the general work. Mr. M. L. A. Houghwart of Porto Rico was the speaker.

EDUCATIONAL DEPARTMENT reports 110 Calendars sold, 72 China's Real Revolution, 29 That Freedom. Five Mission Study Classes held during Lent. Program Meetings in every Parish.

SUPPLY DEPARTMENT reports 24 boxes used clothing, 3 Personal boxes, 8 Joy boxes, 1 Fort Valley (sheets, etc.), 9 boxes to China (new garments and surgical dressings), 6 boxes to South Carolina (new garments and dispensary articles), making a total of 51 boxes valued at \$1,811.90.

SOCIAL SERVICE DEPARTMENT reports coal sent to a family in January, also a check of \$7 in February, March and May for the same family. Check to Church Mission of Help in May. 224 children and 4 mothers entertained at six picnics. Two little girls from Jersey City have been taken into the homes of our Church women, nourished and cared for, one for several months, the other several weeks, to return at Christmas for another visit. Six children were

given a party on Christmas Day, and on December 28th fifty children were given a Christmas tree, gifts and goodies. Two families were remembered at Christmas with clothing, dinners and money.

THE WOMEN'S UNITED THANK OFFERING is 100%, every Church and Mission having a Custodian. Our aim is every woman with a Blue Box. 88 of our women attended the Presentation Service at Englewood in May.

THE DISTRICT OF MORRISTOWN

With the exception of one parish and a mission in the District of Morristown, much work has been accomplished by the parish branches and the reports show greater activity.

Personal boxes, sent by the larger branches, have been well filled with new clothing, household supplies and Christmas gifts. The "joy boxes" continue to be a pleasure to send to individual missionaries. The fall work in many of the branches was given mostly to parish needs but with the beginning of Lent all were busy working for the District allotment, St. Mary's-in-the-Mountain, Sewanee, Tennessee, and many and varied garments were made to fill the quota.

The District was greatly interested in the Old Gold, Silver and Jewelry offering for Japan and sent many articles.

Our District Supply Secretary reports that the work for the coming year, St. Mary the Virgin, Philippines, has been distributed among the parish branches.

The Educational Secretary reported that while there were few study classes, the book on China was read at regular meetings and followed by an intensive day with a leader.

The District sent a boy to the Princeton Summer School. He was anxious for one more year to complete his course and is now ready to meet and talk with groups of young people.

The Social Service Department is organizing for more intensive work and we have also a District Secretary for the Comfort Club.

The United Thank Offering is growing but our District Custodian is anxious to dispose of many more "Blue Boxes."

The Annual meeting was held at All Saints' Church in Millington on Tuesday, May 26. It was an all-day meeting, beginning with a celebration of the Holy Communion, followed by an address by Canon Leslie, whose subject was "The Foreign Born." After a box luncheon on the lawn, we held our afternoon meeting. The Diocesan officers spoke of their plans for the year and reports were given of work accomplished by the parish branches. The following new officers were then elected for three years: Supply Secretary, Mrs. G. F. Wilcoxson, Calvary Church, Summit; Educational Secretary, Mrs. Paul B. Klugh, Grace Church, Madison; Social Service Secretary, Mrs. J. E. Estler, St. John's Church, Boonton; Comfort Club Director, Mrs. O. B. Jacobs, Church of the Redeemer, Morristown.

THE DISTRICT OF NEWARK

The District of Newark consists of twenty-one parishes. Eight meetings of the District Officers and representatives of the parishes are held each year. The Spring meeting and the Fall meeting have special programs.

At the Spring meeting, held at St. Paul's, Newark, a short sketch was given by the women of St. Mark's Church, depicting social service work. Mrs. Chester Lee Colton showed her dolls, dressed to represent the work of the different institutions of the Diocese.

At the Fall meeting, at St. Stephen's, there were reports from the Diocesan Officers, and a talk by Miss Lovett, a missionary from Porto Rico, who told of the splendid work being done there by our church.

EDUCATIONAL DEPARTMENT—There has been a slight increase this year in the number of requests for speakers by the parishes. Four parishes studied

"China's Real Revolution" during the Lenten season of 1925. Fifty-six Missionary Calendars were sold during the Fall of 1925. A few new subscriptions to the "Spirit of Missions" have been reported.

SOCIAL SERVICE DEPARTMENT—We regret to state that the Service Exchange, started by this department last year, has been discontinued. As the work advanced it was found very difficult, with only volunteer workers, to bring together those who needed occasional help and those who wished to give part-time service. This exchange may, at some future time, be established with a regular office and secretary, but for the present it seemed wiser to discontinue the undertaking.

SUPPLY DEPARTMENT—The response in this department has been very encouraging this year. Three personal boxes have been taken by the churches, and three Christmas gift boxes were sent. There have been many gifts of second-hand clothing in answer to an appeal.

The Director wishes to express her gratitude and that of the District to Trinity Cathedral, which, by allowing the District to hold its meetings in Trinity House, has made possible the organization of the District. She also wishes to voice her unbounded gratification for the faithful co-operation of the nineteen parishes whose representatives have attended the monthly meetings, and to her executive officers who have so faithfully and efficiently carried on the work of their various departments.

DISTRICT OF NEWTON

EDUCATIONAL DEPARTMENT—Miss Anne Beavers was sent to the Summer School at Princeton. Her report was most inspiring.

Thirty calendars were sold this year. A large increase in subscriptions to the Spirit of Missions is reported for the district.

An Institute was held at Phillipsburg on "China's Real Revolution," led by Mrs. Williams, and one at Washington on "My Father's Business," also led by Mrs. Williams. At Newton, the Rev. George R. Hewlett read "My Father's Business" to the Auxiliary during the sewing meetings.

SUPPLY DEPARTMENT—Five Churches responded to the call to sew for Rutherford Associate Missions, Rutherford, N. C. Used clothing was sent by one Church.

During the Fall two boxes of used clothing have been sent to St. Andrew's, Harper's Ferry, West Virginia. One Christmas Gift Box was sent. Contributions have also been made to Bonnie Brae Farm.

UNITED THANK OFFERING—The new District Custodian, Miss Virginia T. Morford, reports six parishes contributing with an increase of Blue Boxes given out in some parishes. A new branch of the Woman's Auxiliary has been organized at Belvidere. Each year shows an increase of interest, this being the second parish to form a branch within three years.

THE EDUCATIONAL DEPARTMENT reports 95 Missionary Calendars sold, 3 Study Classes, 2 Institutes (one day), 2 Churches having program meetings and many speakers supplied for other meetings.

THE SOCIAL SERVICE DEPARTMENT will have representatives attending the class for workers in the Diocesan House in February, and reports a sending of flowers to hospitals as usual and plans being made for recreational work among the children of the crowded tenements.

New subscriptions to the Spirit of Missions included St. Paul's, East Orange, 25; Christ Church, East Orange, 24; Grace Church, Orange, 20.

Two District Meetings were held, one in the Spring in St. George's Church, Maplewood, and one in the Fall in Christ Church, East Orange.

DISTRICT OF PATERSON

An earnest group of Auxiliary workers has been organized by the consolidation of the Church societies at the Church of the Holy Communion, Paterson.

The U. T. O. Custodian for the District has placed "the little Blue Box" in fourteen parishes and hopes to make its mission ever more widely known.

The Educational Secretary for the District would be glad to dispose of some more Missionary calendars and have some more subscriptions for the "Spirit of Missions."

The work of the Comfort Club is increasing.

The Social Service activities of this District center in the work done by the "Church Mission of Help," branch headquarters for which have been established in Paterson. Our Social Service Secretary would be very glad to have cases reported to her for investigation.

Constitution

NEWARK BRANCH OF THE WOMAN'S AUXILIARY TO THE NATIONAL COUNCIL

ARTICLE I.—NAME

This Society shall be called the Newark Branch of the Woman's Auxiliary to the National Council.

ARTICLE II.—OBJECT

The object of this Society shall be to carry out within the Diocese of Newark the purposes and work of the Woman's Auxiliary to the National Council.

ARTICLE III.—MEMBERSHIP

The membership of this Society shall be composed of all women, and parish organizations of women actively engaged in carrying out its object.

ARTICLE IV.—EXECUTIVE BOARD

The officers of this Society shall be a President, three Vice-Presidents, a Recording Secretary, a Corresponding Secretary, a Treasurer and a Custodian of the United Thank Offering, who, together with the District Directors and Chairmen of Committees, shall constitute the Executive Board.

ARTICLE V.—AMENDMENTS

This Constitution may be amended by a two-thirds vote of the whole number of delegates present at any regular meeting, *provided, however,* that notice of such amendment has been given, in writing, to the organization in each parish, at least one month previously.

By-Laws

ARTICLE I.—MEETINGS

Section 1. There shall be four regular meetings of the Auxiliary during the year, to be held on the first Wednesday of the months January, March, May and October.

Sec. 2. The meeting in January shall be the Annual Meeting.

Sec. 3. The President shall call at least four regular meetings of the Executive Board each year, which shall be held on the first Wednesday of the month.

Sec. 4. Eight shall constitute a quorum at all meetings of the Executive Board.

ARTICLE II.—DUTIES OF THE OFFICERS

Section 1. It shall be the duty of the President to preside at all meetings of the Auxiliary and of the Executive Board; to call special meetings; and to have a general supervision of the work.

Sec. 2. The first Vice-President shall represent the Department of Education.

Sec. 3. The second Vice-President shall represent the Supply Department.

Sec. 4. The third Vice-President shall represent the Department of Social Service.

Sec. 5. It shall be the duty of the Corresponding Secretary to conduct all correspondence of the Auxiliary and to send out all notices. She shall also be the Custodian of the Emery Fund, and the Book of Remembrance.

Sec. 6. It shall be the duty of the Recording Secretary to keep the Minutes of all meetings of the Auxiliary, and of the Executive Board, and present a report at the Annual Meeting.

Sec. 7. It shall be the duty of the Treasurer to receive and keep all moneys contributed, and to disburse the same; exclusive of the Emery Fund and the United Thank Offering.

ARTICLE III.—COMMITTEES

Section 1. There shall be the following committees: Publicity, Finance, Auditing.

Sec. 2. The President, with the approval of the Executive Board, shall appoint the Chairmen of Committees.

ARTICLE IV.—ELECTIONS

Section 1. Elections shall be by ballot.

Sec. 2. At the Annual Meeting in January, 1922, and each third year thereafter, there shall be elected a President, and a Corresponding Secretary, to serve for three years or until their successors shall have been chosen. There shall also be elected a first, second and third Vice-President, to serve for two years; a Recording Secretary, a Treasurer, and a United Thank Offering Custodian, to serve for one year.

At the Annual Meeting in January, 1923, and each third year thereafter, there shall be elected a Recording Secretary, a Treasurer, and a United Thank Offering Custodian, to serve for three years or until their successors shall have been chosen.

At the Annual Meeting in January, 1924, and each third year thereafter, there shall be elected a first, second and third Vice-President, to serve for three years or until their successors shall have been chosen.

All officers shall take office the May following their election, except the Treasurer, who shall take office immediately upon election.

ARTICLE V.—DELEGATES

There shall be five delegates to the Triennial Convention, nominated by the Executive Board, and elected by the Auxiliary, with the approval of the Bishop.

Delegates to all other meetings shall be elected by the Executive Board.

ARTICLE VI.—AMENDMENTS

Amendments to these By-Laws may be made at any regular meeting, provided previous notice has been given in writing to members.

SUGGESTIONS FOR DISTRICTS

Districts shall elect their own officers.

District Directors shall be elected for three years, and are members of the Executive Board.
