President's Annual Message

For the second time it is my privilege to count upon your loyalty and devotion, your energy and ability to make the work of the women of the Diocese of Newark during this triennium a splendid and worthy achievement.

For three years we have prayed and worked together, perhaps not always reaching the goal we would attain but certainly growing in grace and faith and love.

We know that more, not only of the churches but of the women, are interested in our work, though we are still far from our ideal—"every churchwoman an interested, informed and working Christian."

There must be some 25,000 women communicants in this Diocese and we have perhaps 3,000 at work in the Auxiliary. Shall we not each of us try this new year to interest some of these others?

We mothers might show our daughters how real a joy and privilege we count our work for the Master.

We have very large and grave material responsibilities ahead of us. We can easily accomplish all our tasks if we but recognize our spiritual heritage and, walking "humbly with our Lord," be lifted up in His strength.

We bring to you from the Triennial Meeting of the Woman's Auxiliary new responsibilities, recognizing that the work of the Woman's Auxiliary includes Prayer, Information, Service, Gifts; and may be in all fields, the Parish, the Community, the Diocese, the Nation and the World.

Will you use the theme of our monthly meditations, the possibility of our planning our lives as Christ would have us, and Hymn 493 as part of your personal devotions this year?

On the following pages you will read some suggestions based on the findings of the Triennial Meeting. Please study them as they are the basis of our program for the next three years.

I hope to be at the Diocesan House on Wednesday mornings. Will you come in and see me there?

May we have God's help in all our duties, His counsel in all our perplexities, His protection in all dangers and in all our sorrows His peace.

Suggestions Based on the Findings of the Triennial Meetings of the Woman's Auxiliary in Washington, D. C., October, 1928

1. Personal Religion and Evangelism.

- a. That we deepen our own personal religious lives.
- b. That we help others in their quest for a more complete life, through the process of friendship.
- c. That we pray that all hesitation in witnessing for Christ be taken from our hearts, and that we fervently desire to share Him with others.

2. (a) Domestic Missions.

- a. Since every year hundreds of Churchwomen visit as tourists our Domestic Missionary field, both in this country and in our extra-continental possessions, that such persons should receive instructions and letters of introduction to the Bishops and workers in the field, and that they should be used as speakers on their return to the Diocese.
- b. That we inform ourselves concerning the work which is being done in all parts of the Domestic field.
- c. That in cooperation with all women's organizations of the Church we make the development of village and rural work a definite objective for the Triennium.
- d. That we recognize that to bring Jesus Christ into the lives of all is the surest way of wiping out the ever-present race problem.

2. (b) Foreign Missions.

- a. That we keep ourselves informed concerning the Missionaries who have gone out from this Diocese to the Foreign Field, and of their return on furlough. That we inform them of all publications and items of interest concerning the Church

in the Diocese. That a closer relationship with them be established through the observance of the Noon-Day Prayer for Missions, and that intercessions each for the other be offered at this time.

- b. That we ascertain whether there are any children of Missionaries in the schools or colleges of this Diocese and take definite steps to bring them in touch with the young people here at home especially during week-ends and holidays.
- c. That we also ascertain whether there are any foreign students in this Diocese and formulate plans to bring them into contact with our Christian home life, doing for them what we would like others to do for our own boys and girls.
- d. That since it has been found that a great encouragement to the missionary in the field would be the knowledge that every woman in the Church is backing the Maintenance Budget of the Church, we use our influence to see that all Parish Quotas are paid in full.

3. Social Service.

That we charge ourselves with the responsibility for inspiring the women of the Church:

- a. To acquire an intelligent understanding of the problems of the Community.
- b. To help educate public opinion as to these problems.
- c. To take our part in cooperating with Diocesan and civic social service agencies and with other communions, when possible, in such opportunities for service as may be presented.
- d. To recognize that such cooperation with other communions is one way of promoting Christian Unity.
- e. To realize that responsibility in the field of human relations is laid upon us by our Lord Himself, and that service to Him must include service to our fellow-men.

4. Gifts.

- a. That we cooperate at once with the Diocesan plans for sharing in the gift of \$1,000,000 for St. Luke's Hospital, Tokyo.

5. Religious Education.

- a. That we cooperate in every way with the National and Diocesan Departments of Religious Education, and assist in their purpose of having Missionary education represented on the program of every Church School, Conference or Institute.
- b. That we promote subscriptions to "Findings in Religious Education" through the same channels as are used for the Spirit of Missions.*
- c. That we offer assistance and encouragement to the Church's work in the various colleges and universities.
- d. That we urge the constant use of Daily Bible Readings, the Missionary Calendar and the reading and lending of inspirational books.*

6. Publicity and Promotion.

- a. That we make more intelligent use of the great mass of available material relating to subjects upon which the Woman's Auxiliary should be informed.*
- b. That we familiarize ourselves with the methods of preparation for the Every-Member Canvass and give it our loyal cooperation during the intensive period of the work.
- c. That we make greater use of The Church at Work.*
- d. That we secure and renew subscriptions to the Spirit of Missions, placing a subscription in every Public Library, and finding suitable women to act as parish representatives for the work.*
- e. That we promote the wider use of Mission Study Books and supplementary material for the same.*
- f. That we increase the number of subscriptions to the national Church papers.
- g. That we give wide publicity to appeals for volunteers for the Mission field and circulate information about places where training for Missionaries and other Church workers may be had.
- h. That we make more use of Lantern slides and motion pictures of the Mission field.*
- i. That we use simple dramatic plays and sketches to teach about various phases of our work.
- j. That we promote the sale of Mission goods at Parish and Diocesan meetings.

7. Training.

- a. That in order to meet the increasing demand and need for consecrated and trained workers for every department of the Church's work, especially for the Mission field, Rural work and in colleges, we seek to find and encourage possible candidates for such work, referring them to the Diocesan President of the Woman's Auxiliary.
- b. That we keep in touch with the training centres under the National Council in order to disseminate information and create interest in the securing and training of women workers for service in the Church.

8. Enlisting Others.

- a. That we discover and report all isolated Church women in order that they may be brought in touch with the fellowship and activities of Church life.
- b. That evening branches be formed providing programs for business women.
- c. That branches be formed for younger women offering a variety of forms of service for the Church.
- d. That the Woman's Auxiliary stand ready to assist the Young People's Fellowships.

- e. That the Woman's Auxiliary cooperate very definitely with the Girls' Friendly Society.
- f. That we endeavor to keep in touch with young women in college, inviting them after graduation to lead classes in Mission Study, Social Service, Parliamentary Law, etc., in connection with the Church.
- g. That we develop practical spiritual contact with the young mothers through the Little Helpers' Department.

Notes

Parish Branches are urged to select from the above Findings whatever might be effectively used in their respective parishes, and to incorporate them into a definite program to be presented to the women of the parish for their adoption.

The Manual is the official hand-book of the Woman's Auxiliary and should be consulted in the organization and carrying on of all Branches.*

The Diocesan officers of the Auxiliary stand ready to assist branches in any way regarding the planning and carrying on of their work.

Some form of Church work should be found for every woman in our parishes.

It should be noted that the field of responsibility of the Woman's Auxiliary extends from the parish and community to the Diocese and the world at large.

By co-operation on the part of the Woman's Auxiliary with all other Diocesan plans.

Suggestions to Parish Officers

Use the Prayer Leaflet in order that all may be thinking along the same lines.

[The Leaflet may be secured from the Chairman of the Department of Devotional Life, price, 25 cents.]

Parish Officers should plan to attend all District Meetings and keep in close touch with Diocesan Officers.

Supply Work should be secured through the District Supply Secretary, Educational Work through the District Educational Secretary, Social Service Work through the District Social Service Secretary, and all information connected with the United Thank Offering should be secured through the District Custodian.

Include in every personal box a copy of some good book.

Parish Presidents should see that all notices of Diocesan and District matters are distributed to the members, and that changes in Parish Officers, or their addresses, are reported to the Diocesan Corresponding Secretary.

Suggestions to Parish Treasurers

Realize the importance of your office, as it is in your power to increase the desire to give on the part of your members.

Study carefully the "Budget" Sheet (page) and know how the money is used.

Know what is meant by "Advance Work" and the "Parish Quota."

If you pay to a scholarship, know whether it is a Special or is to count on your Parish Quota, and so notify the Diocesan Treasurer when you send her the money.

Simple but systematic accounts should be kept, and a financial statement rendered at each business meeting. Have bank books balanced once a month, all vouchers filed, and accounts audited once a year.

Date all letters, give the name of your Parish Guild or Auxiliary, state which class in the Budget you have selected. Sign your name, adding married name and address, or, if unmarried, write (Miss) in parenthesis.

If you resign, notify the Diocesan Treasurer and send the name of your successor. Be sure to give to your successor all the information that you possess in regard to the work.

Remember that the Fiscal Year begins January 1st and ends December 31st. December money should be sent as early in the month as possible in order that the Diocesan Treasurer may have time to write her report and have her books audited.

Keep your Rector informed of all payments that apply on your Parish Quota.

Make your monthly reports so interesting as to inspire your members to give, and show what has been paid and what remains to be paid.

In Missions and weak Parishes contributions of five or ten cents a month to the Budget, will be found an easy way to share in the work, and those who are unable to attend the meetings should be given this opportunity as well.

Annual Reports

Report of the First Vice-President

(DEPARTMENT OF EDUCATION)

In reporting on the work done by the Educational Department of the Woman's Auxiliary for the year from January, 1928, to January, 1929, I can say that we have not, at least, lost ground, though I am not sure that the advance is as great as I would like to see it.

"In *my* country," said Alice to the Red Queen, "when you run very fast you usually get to some other place." "A slow sort of country," said the Queen. "*Here* it takes all the running you can do to stay in the same place." Is that to be a description of our educational work?

To report our most important work first. We have had 17 study classes during the year. These were, as usual, concentrated in the districts of Newark, Orange and Montclair. Several districts had none.

There were 13 Intensive Days conducted, several parishes often combining in these. A rough estimate shows that about 200 people were reached through the classes and about 300 by the Intensive Days.

At the Educational Rally last spring, which was held at Christ Church, East Orange, we had as our speakers the Rev. Theodore Ludlow, head of the Church Department of Adult Religious Education, and the Rev. Canon McAllister. The collection was given to the Scholarship Fund of the Department.

Six members of the Department attended the Summer Conferences at Burlington and Wellesley, and the training classes held in connection with the General Convention at Washington to get further preparation for their work. One hundred and sixty-five dollars was spent from the Scholarship Fund in various ways to make this more possible.

Four hundred Missionary Calendars have been sold this year. A new policy was decided on by the Department, of trying to make the Calendar answer a need, rather than trying to force a large number of sales. The result has been a smaller number of sales, but perhaps just as healthy a condition.

Perhaps the greatest gain that we have made is in the large number of books and pamphlets which have been circulated, and, we hope, read and studied. It is impossible to give the total number, but the value in money is \$598.96. The largest part of this amount was for text books. Of "A Church Awake," last year's book, we circulated 335 copies. Of "The New Africa," this year's book, we have sold 160 copies so far. The biggest sales on this are still to come in connection with Lenten Classes. A number of "The General Program of Church" have also been sold.

Another line of work which has kept the Vice-President very busy, was suggesting and making arrangements for speakers for parish and district meetings. No record of the number furnished was kept, though I wish it had been. I was very glad to furnish that service, but can not tell just how successful it proved.

In looking forward to the future of our work, I want to call your attention to the fact that, in all educational work, religious or secular, there is a tremendous emphasis being placed, at the present time on *adult* education. Rev. Leslie Glenn tells us of the need for work in the colleges and points out that the lack of thoughtful, well-based religion in the homes from which students come is a large factor in the problem. Leaders in both Church and Day School education say the same thing. Professor Adelaide Case of Columbia spoke of this in her address to the Diocesan Church School Teachers. If you try to get people to teach in our Sunday Schools they tell you they do not know enough—and they are quite right, too! There is no reason why we should stop learning and studying when we leave school.

Now we have the mothers of children and future college students in our parishes. Can we help them at all in this important matter? A study class is

not just an effort to gather a certain amount of knowledge on a mission field in which the Church is at work. It is an opportunity for a group of women to get together and co-operate in an effort to think out some problems which concern, not only our Church work, but our own relation to Our Master and to the world in which we live.

There should be no parish or mission in this diocese in which the Guild or Auxiliary does not plan carefully for some kind of educational work,—meetings with speakers on various phases of the Church work, or classes, or reading. The aim is that we may become more intelligent Christians and Church-women and there is no church which can afford to be left out of that aim.

A recent writer on education says: "Knowledge quickens love, love brings obedience, obedience and love dedicate the mind and will to a fuller and deeper knowledge and thought. In that fullness of obedience is the end of Missionary Education."

The allotment, consisting of hospitals, schools and missions, given us in the fall of 1927, was very well filled. This outfitting of institutions is the work done in the early part of the year. It is owing to the good work of the District Supply Secretaries that their needs are so well met. Their help and that of the District Directors is of the greatest assistance.

Our quota for 1928-1929 is the outfitting of:

St. Elizabeth's Hospital, Shanghai, China.

St. John's Hospital, Jackson, Wyo.

Valle Crucis School and Holy Cross Mission, Valle Crucis, N. C.

Taylor Hall, Racine, Wis.

Thompson Orphanage, Charlotte, N. C.

Calvary and Associated Missions (colored), Charleston, S. C.

St. Mattia's Mission (colored), Atlanta, Ga.

To these has been added an emergency allotment for St. Luke's Hospital, Ponce, Porto Rico; the furnishing of linen for St. Luke's School and Iolani School, both in the Hawaiian Islands; as well as certain items for Epiphany Mission, Spartanburg, S. C.; 26 Christmas Gift Boxes, 3 Catechists' Boxes, 26 Personal Boxes.

Every Parish has been so eager to take the personal and Christmas Gift Boxes this year that they are all provided for, and most of them already sent. The work of filling these Christmas and Personal Boxes is done during the fall and early winter.

The Comfort Club has sent the Catechists' outfits. We must also thank Mrs. Colton for so promptly and efficiently purchasing all supplies sent directly by this department.

The Girls' Friendly Society, as usual, has given valuable help.

My deep thanks go to Mrs. Stewart A. Trench, former Second Vice-President, for carrying on the supply work for three of the busiest months of the year.

Report of the Third Vice-President

(SOCIAL SERVICE DEPARTMENT)

In January and February, 1928, the Diocesan Department of Social Service, together with the Department of Social Service of the Woman's Auxiliary, held their first Social Service Institutes. The Morristown Institute, which was held in the afternoons, had an average attendance of thirty.

Commencing Wednesday afternoon, February 8th, at Trinity House, Newark, Dr. James S. Plant of the Essex County Juvenile Clinic, came to us for a series of five lectures on "Child Psychology."

In April, another Recreational Institute was held at the Y. W. C. A.

On the third Saturday in June, the Summer recreational work began with a picnic at St. James' Parish House, Upper Montclair, for the children from the Social Service Bureau in Newark. There were twenty-four picnics covering the period up to September 15th, with 1,106 children and tired mothers given a day in the country. This year we were delighted with the spirit of co-operation which we found in all quarters. One of the branches of the Order of Eastern Star joined with us, and took care of one hundred children from Jersey City, giving them a hot vegetable luncheon, their afternoon's amusement, and something for each child to take home. The women who gave this party so enjoyed it that they planned a Christmas party for fifty children, which was given at Park Ridge on Thursday, December 27th. It was a delightful party, and a great deal of kindly thought went into it.

Every District in the Diocese was represented in the Summer work, providing money for buses and picnics for the children. Especially fine Social Service work was done by the Districts of Montclair, Jersey City and Newark. This has been an excellent piece of co-operative work, church and community working together for the good of others.

The year's work was concluded with the Christmas Party on December 27th.

The Emery Fund

The Book of Remembrance

"There shall be created an Emery Fund for Missionaries home on Furlough, to be given over to the Board of Missions or their successors, to be for all time a Trust Fund, the interest of which shall be used for women missionaries on furlough in such way as the Executive Committee of the Woman's Auxiliary or its successors shall approve." (From the Minutes of the Triennial Meeting of the Woman's Auxiliary, held in Detroit, Michigan, October, 1919.)

In connection with this Fund the Woman's Auxiliary of the Diocese of Newark established a Book of Remembrance.

In it may be recorded the names of former diocesan officers and those women no longer living, who in parish branches have served the Auxiliary and Church in their day and generation. The money, which accompanies the name, is sent to the Emery Fund at the Church Mission House.

The Book of Remembrance is presented at the Service of Remembrance, held at Trinity Cathedral on the first Wednesday in May. It is also presented at the spring district meetings in those districts from which names have been recorded in the Book of Remembrance during the year. In 1928 twenty-three names were sent in, accompanied by \$119 in gifts for the Emery Fund.

United Thank Offering, 1928-1931

Be it Resolved, That the United Thank Offering of 1931 be given to the Domestic and Foreign Missionary Society of the Protestant Episcopal Church in the United States of America, to be used as follows:

One-tenth of the Offering to be added to the permanent trust fund, the income from which is to be used for retiring allowances of United Thank Offering workers, and

At least \$75,000 to be held in reserve for training of United Thank Offering workers, and surplus to revert to the general fund, and

The sum of not less than \$200,000 to be appropriated for buildings to be erected in the mission field.

The balance of the Offering, together with all interest earned thereon, to be used by the Missionary Society as directed by the National Council, for the work of women in the missionary enterprises of the Church, including their training, equipping, sending and support, and for their care when sick and disabled, the appointment of said women having been approved by the Executive Board.

Be it further Resolved, That to our United Gifts shall be added our united and earnest prayers, that God will put it into the hearts of many faithful women to give themselves and their substance to the work of the Master in the Mission Field.

Be it Resolved, (a) That the Executive Board be requested to outline the policy for the use of the United Thank Offering, including provision for the financing of the Triennial Mass Meeting.

Report of the Comfort Club

The last report of this department—The Department of Diocesan Institutional Supply—was compiled from data furnished by 42 parishes. For the year 1928, the number of churches sending data has increased to 98. This increase is due to two causes—first, to a sizable advance in the total of working groups, and, second, to a better realization of the need of a systematic tabulation of all help given to our diocesan institutions. There are still groups of workers who do not report—except to their own parishes—hence the list, as made up from Comfort Club records, can not be a complete one.

Supplies were furnished this year to: Christ Hospital, St. Barnabas' Hospital, House of the Holy Comforter, St. Katherine's Home, Church Mission of Help, Bonnie Brae Farm, Western Counties Mission, Foreign-Born Work, City Missions, and Porto Rico.

From January 1, 1928, to January 1, 1929, the value of clothing and household articles sent by the churches in nine districts to the various institutions amounted to \$3,280. The moneys reported as sent to the Diocesan Treasurer totaled \$1,600.

In disbursing this last sum we have provided material for women to work upon, bought needed garments or household articles, furnished special equipment and given money for routine requirements. To Porto Rico, after the hurricane, we sent hospital supplies and linens. This explains the following figures, which refer only to expenditures from the Diocesan Comfort Club account:

Christ Hospital, metal furniture, \$150; House of Holy Comforter, screens, \$50; St. Barnabas' Hospital, curtain goods, \$150; Canon Leslie, \$100; Canon Cooder, \$50; Church Mission of Help, \$100; Western Counties Mission, building fund, \$200; St. Katherine's Home, \$100, and an added \$200 to their endowment effort for a bed in Christ Hospital. For materials and wearing apparel during the year, \$290. Porto Rico, \$150.

This is over and above the supplies sent by the individual parishes through their working groups.

We can therefore report the disbursement of \$4,820—\$3,280 by individual parishes and \$1,540 through the Treasurer, and a comfortable balance in the bank.

Reports of Districts Directors

DISTRICT OF ENGLEWOOD

We have added two new parish guilds to the Woman's Auxiliary during the last two years, and now have seventeen parishes associated with us.

Every parish, except two, has been visited by the Director, the Supply Secretary and the United Thank Offering Custodian. At all visits the necessity for co-operation between the branches and of loyalty towards the diocesan branch has been stressed.

We had a very successful tea, given by the District Officers to the parishes, with thirteen parishes represented, our aim being to allow the women from the entire district to meet one another.

We have had our regular spring and fall meetings each year, with from eleven to thirteen parishes represented. Eight parishes contribute to the Budget and Specials. Prayer partnership has been very successfully established in one parish, and we are hoping to introduce it into more parishes this spring.

THE UNITED THANK OFFERING—We have 287 blue boxes distributed, against 247 in 1926.

THE EDUCATIONAL DEPARTMENT—One hundred and forty-six calendars were sold, and twenty-three new subscriptions to the *Spirit of Missions* were secured.

Bergenfield had a one-day institute at which eight parishes were represented.

Two mission study classes were held during Lent.

THE SUPPLY DEPARTMENT—The Supply Department has taken care of one personal box, five allotments and one gift box. Two barrels of second-hand clothing were also sent.

The Supply Secretary reports that the parishes are more than willing to do their share.

COMFORT CLUB—This is only the second year that we have had a Secretary for the Comfort Club in this district and we are therefore very proud that more parishes contributed to the work and that every diocesan institution received something from this district in 1928.

DISTRICT OF MONTCLAIR

In 1926 the Montclair District had the largest number of Mission Study Class Leaders in the Diocese and each year the Religious Education Department has arranged for several Mission Study Classes, as well as Intensive Days, plays and pageants; and notable speakers for the parishes. In 1927 the District sent a representative to the Burlington Summer School and at Wellesley Conference St. Luke's, Montclair, had eight representatives.

In the Supply Department for the three years the value of personal and joy boxes, layettes, dispensary articles and thousands of surgical dressings, approximates \$5,000, not counting the many boxes of used clothing.

The Comfort Club has more than met its quota and contributed several thousand dollars in garments and money.

The amount accomplished under the leadership of our energetic Social Service Secretary is beyond computing in dollars and cents. The District leads in the number of picnics for poor children held last summer and countless benefactions have helped to cheer the poor and suffering.

The District is always very proud of our little Mission at Towaco and glad to record that this past year twelve of its members gave to the Bishop Lines Memorial Fund; also earned \$200 for their chapel.

The District U. T. O. for the Triennium was \$6,587.90.

DISTRICT OF MORRISTOWN

The District of Morristown comprises twelve parishes and missions. In 1927 two new Auxiliaries were formed and there are now twelve organizations doing Auxiliary work.

EDUCATIONAL DEPARTMENT—Some kind of educational work has been done in all but one or two of the smaller missions. There have been some study classes and intensive days. One parish has had a Bible class every Lent. Another Auxiliary read a book entitled "The Episcopal Church—Its Message to the Men of To-day." Still another church had stereopticon talks on Missions and Church History. Most of the organizations have had speakers at their meetings. We have also sent a delegate every year to one of the Summer Conferences.

SUPPLY DEPARTMENT—We have filled our allotment of supply work for the District each year, and in 1927 asked for extra work. In the three years, we have supplied the needs of three missions. The larger parishes have also sent personal boxes. Supplies and clothing have been sent to fill numerous calls.

SOCIAL SERVICE DEPARTMENT—The Social Service work has been carried on in many ways. In 1927, one picnic was given for the poor children from Newark, and in 1928, two were given. Three children were taken into private homes for much-needed vacations. Mending was done in local institutions. Supplies and clothing have been sent to the Parsippany Home, Summit Home, etc. Packages of worn clothing were sent to the Western Counties Mission.

In addition to the two regular District meetings each year, we had a series of United Thank Offering meetings, at which workers from the Mission Fields spoke, and in the spring of 1927 a beautiful and inspiring United Thank Offering pageant was given on the lawn of the Laura Augusta Home in Madison. Each fall we begin the work for the season with a luncheon for the district officers and parish presidents, followed by a conference at which the plans for the year's work are formulated. Thus we started with enthusiasm and a spirit of co-operation throughout the District.

DISTRICT OF NEWARK

The Newark District is comprised of twenty parishes; fifteen in Newark, and one each in Nutley, Irvington, Arlington, Harrison and Belleville.

Two District meetings are held each year; one in the spring and one in the fall, in different parts of the District.

Our Supply Secretary, Mrs. A. C. Babbitt, reports splendid results in her department. Personal and gift boxes have been sent, and our allotment of sewing finished and sent to the different institutions.

The U. T. O., under the direction of Mrs. A. S. Harden, reports steady progress. Literature, as well as many Blue Boxes, have been distributed. Six hundred and forty-eight contributors of record; four parishes not having given the number of people contributing; nineteen parishes have contributed, and the growth in some has been outstanding. In 1928 the amount of the offering was \$1,460.25—the total for three years being \$3,898.25.

Mrs. C. B. Johnes, District Social Service Secretary, reports five picnics held during the season with an attendance of 197 children and six adults; the money being given by several parishes for the expenses.

The Educational and the Comfort Club work have been functioning, although without special secretaries.

There has been a regular District meeting held on the third Monday of each month, during the season, at Trinity Parish House, with an average attendance of twenty-five representatives from the parishes. At that time each department has an opportunity to present its work, thereby keeping the parishes in touch with the different activities.

DISTRICT OF NEWTON

This District, composed of ten parishes and missions, is the only distinctly rural district in the Diocese. Because of this fact, growth and development must of necessity be slow. One new branch has been organized at Hopewell House, Western Counties Mission, and is doing splendid work. One parish guild, at St. James' Church, Hackettstown, is doing auxiliary work.

Spiritual growth is shown in the number of Corporate Communion made, and in the fact that one Quiet Day was held at St. Mary's Chapel, Western Counties Mission.

Two District meetings are held each year and the increase in attendance at these meetings is very encouraging. From these meetings there can always be seen a growing consciousness of responsibility to the Diocese and to the General Church.

An educational program of some sort is carried out in most of the parishes. Intensive Days have been held in three parishes and three delegates have been sent from the District to summer conferences.

The Missionary Calendars have been sold and used in most of the parishes.

All but three parishes have taken part in the work of the Supply Department. Boxes have been sent to St. Anna's Mission, Columbia, South Carolina, and work is now being done for Calvary and Associate Missions at Charleston, South Carolina.

Supply work has also been done for the Diocesan Institutions and Church Mission of Help.

The U. T. O. Custodian reports an increase in the number of women using the Blue Boxes. Our goal for the next three years is every woman in the District using a Blue Box.

Mrs. C. E. Rice reports for the Supply work that twelve auxiliaries and guilds are taking part in this work. Several Christmas boxes and personal boxes were taken.

The Comfort Club, under Mrs. W. W. Archbold, reports that seventeen parishes are interested, and that all of the Diocesan Institutions have been helped. In addition, the local institutions have been assisted.

The U. T. O., under Mrs. Marsh, shows that the Blue Boxes have been placed in seventeen parishes.

The Church Periodical Club is a new undertaking in the District. Mrs. B. M. Mitchell reports that seven C. P. C. Librarians have been instrumental in sending magazines and Christmas cards, and collecting magazines for the Seamen's Church Institute.

The Educational work, Mrs. J. H. Glover, Secretary, reports that seven delegates went to Summer Schools, the *Spirit of Missions* subscriptions have been increased, and three study classes held.

The Social Service Department has been handicapped by lack of a secretary. However, Christmas parties, picnics and money have been given.

The work of the District has been encouraging, and we look to the future for greater co-operation.

Constitution

NEWARK BRANCH OF THE WOMAN'S AUXILIARY TO THE NATIONAL COUNCIL

ARTICLE I.—NAME

This Society shall be called the Newark Branch of the Woman's Auxiliary to the National Council.

ARTICLE II.—OBJECT

The object of this Society shall be to carry out within the Diocese of Newark the purposes and work of the Woman's Auxiliary to the National Council.

ARTICLE III.—MEMBERSHIP

The membership of this Society shall be composed of all women, and parish organizations of women actively engaged in carrying out its object.

ARTICLE IV.—EXECUTIVE BOARD

The officers of this Society shall be a President, three Vice-Presidents, a Recording Secretary, a Corresponding Secretary, a Treasurer, and a Custodian of the United Thank Offering, who, together with the District Directors and Chairman of Committees, shall constitute the Executive Board.

ARTICLE V.—AMENDMENTS

This Constitution may be amended by a two-thirds vote of the whole number of delegates present at any regular meeting, *provided, however*, that notice of such amendment has been given, in writing, to the organization in each parish, at least one month previously.

By-Laws

ARTICLE I.—MEETINGS

Section 1. There shall be a regular meeting of the Auxiliary during the year, on the first Wednesday of each month from October to May, inclusive, except December.

Sec. 2. The meeting in January shall be the Annual Meeting.

Sec. 3. The President shall call at least four regular meetings of the Executive Board each year, which shall be held on the first Wednesday of the month.

Sec. 4. Eight shall constitute a quorum at all meetings of the Executive Board.

ARTICLE II.—DUTIES OF THE OFFICERS

Section 1. It shall be the duty of the President to preside at all meetings of the Auxiliary and of the Executive Board; to call special meetings; and to have a general supervision of the work.

Sec. 2. The first Vice-President shall represent the Department of Education.

Sec. 3. The second Vice-President shall represent the Supply Department.

Sec. 4. The third Vice-President shall represent the Department of Social Service.

Sec. 5. It shall be the duty of the Corresponding Secretary to conduct all correspondence of the Auxiliary and to send out all notices. She shall also be the Custodian of the Emery Fund, and the Book of Remembrance.

Sec. 6. It shall be the duty of the Recording Secretary to keep the Minutes of all meetings of the Auxiliary, and of the Executive Board, and present a report at the Annual Meeting.

Sec. 7. It shall be the duty of the Treasurer to receive and keep all moneys contributed, and to disburse the same; exclusive of the United Thank Offering.

ARTICLE III.—COMMITTEES

Section 1. There shall be the following committees: Publicity, Finance, Auditing.

Sec. 2. The President, with the approval of the Executive Board, shall appoint the Chairmen of Committees.

ARTICLE IV.—ELECTIONS

Section 1. Elections shall be by ballot.

Sec. 2. At the Annual Meeting in January, 1922, and each third year thereafter, there shall be elected a President, and a Corresponding Secretary, to serve for three years or until their successors shall have been chosen. There shall also be elected a first, second and third Vice-President, to serve for two years; a Recording Secretary, a Treasurer, and a United Thank Offering Custodian, to serve for one year.

At the Annual Meeting in January, 1923, and each third year thereafter, there shall be elected a Recording Secretary, a Treasurer, and a United Thank Offering Custodian, to serve for three years.

At the Annual Meeting in January, 1924, and each third year thereafter, there shall be elected a first, second and third Vice-President, to serve for three years.

"No officer shall serve for more than two consecutive terms." (A term is understood to be the major portion of three years.)

All officers shall take office the May following their election, except the Treasurer, who shall take office immediately upon election.

ARTICLE V.—DELEGATES

There shall be five delegates to the Triennial Convention, nominated by the Executive Board, and elected by the Auxiliary, with the approval of the Bishop.

Delegates to all other meetings shall be elected by the Executive Board.

ARTICLE VI.—AMENDMENTS

Amendments to these By-Laws may be made at any regular meeting, provided previous notice has been given in writing to members.

SUGGESTIONS FOR DISTRICTS

Districts shall elect their own officers.

District Directors shall be elected for three years, and are members of the Executive Board.
