## IMPORTANT NOTES

1. See Constitution and By-Laws on pages 43-47.
2. See pages 5 and 6 for names and addresses of new officers and chairmen of committees.
3. The Feast of the Purification is the annual Corporate Communion day; and the eves of the Feasts of St. Andrew, the Epiphany, the Annunciation and the Transfiguration are the special intercessory days for the diocese.
4. The special prayer for use before and at the time of the election of officers may be found on page 4.
5. The Emery Fund must be completed before October 16. On that day every Auxiliary branch is asked to arrange for a Corporate Communion and every member of the Auxiliary to rededicate herself at this service.
6. A leaflet on the Emery Fund, which will be presented in New York at the celebration of the Golden Jubilee of the Auxiliary (October 16, 1921), may be secured from the Church Missions House, 281 Fourth Ave., N. Y. Every member of the Auxiliary is asked to contribute at least fifty cents to this fund. This would make North Carolina's share at least \$808.00. Shall we give \$1,000.00?
7. The North Carolina branch has set \$11,000.00 as its United Thank Offering goal this triennium. \$3,544.13 is in hand. \$7,455.87 must be raised by September, 1922.
8. Read the report of the United Thank Offering Custodian and learn how to get a place on the U. T. O. Honor Roll.
9. Article VII. of the Constitution reads in part, "A branch to have voting privileges must have paid the Central Fund."



10. Article VIII., Section 3, reads in part, "From the amount contributed according to this scale, the Treasurer shall turn over one-half to the Nation-wide Campaign Fund." Inasmuch as this organization is Auxiliary to the Presiding Bishop and Council this money will go to the general fund, therefore any amount a branch may wish to go for diocesan objects should be designated from the remaining half of the branch's contribution.

11. Send all money, except the United Thank Offering, to Mrs. W. D. Burwell, Treasurer. Books close for the year December 31, 1921.

#### FORM OF BEQUEST

I give, devise, and bequeath to The Domestic and Foreign Missionary Society of the Protestant Episcopal Church in the United States of America, for the use of the Society \$\_\_\_\_\_. ## REPORT OF THE RECRUITING COMMITTEE

The efforts of the Recruiting Committee the past year have been:

1. A letter to every branch asking that a recruiting secretary be appointed.
2. An appeal for volunteers made at five institutes, at St. Mary's School, at Chapel Hill to Episcopal students, at the North Carolina College for Women to a group of Episcopal students, at the Governor's mansion to a special meeting of young men and women and at four other special meetings in parishes.
3. Daily prayer for those already in the field and that many others from the diocese may offer themselves for this service.

The appeals were made by Miss Catharine Miller of Henderson, N. C. and Richmond, Va., and by Rev. J. M. B. Gill of Nanking, China.

There are at present twelve missionaries and three



volunteers and they have gone, and are preparing to go, from the following parishes:

Let us pray daily for our representatives already in the field; for those preparing to go, it is a sacred and difficult time for them and their families; and let us pray that many others may offer themselves. We have never sent a missionary to Japan. We have never sent out a missionary doctor. Let us pray that both may be accomplished this year and then let us in some way, a wise way, bring the needs definitely before the young men and women of the parish. The Church needs, and needs *now*, for her missionary work: clergymen, doctors, business men, teachers, nurses and business women.

At the officers' meeting in September at the home of the President, Mrs. Hoke, the following matters were decided:

*United Thank Offering:* The aim for this triennial offering: \$11,000.00. The United Thank Offering parish officer shall be termed custodian instead of treasurer.

*Educational Work:* Eight one-day institutes to be arranged, four in each convocation. Miss Hall to arrange program.



*Constitution and By-Laws:* The committee to draft a Constitution and By-Laws and present them to the annual meeting to consist of Miss Hunter, Mrs. Hoke and Mrs. Burwell.

*Pledge List:* The Pledge List to be revised by Mrs. Van Landingham for the Social Service Department, Miss Hall for the Educational Department and Miss Hunter and Mrs. Burwell for the Department of Missions.

Relationships between the Woman's Auxiliary and the Church Service League and between the Woman's Auxiliary and the Church Periodical Club were discussed.

#### EXTRACTS FROM MINUTES

The second annual meeting of the Woman's Auxiliary to the Presiding Bishop and Council was called to order by the Vice-President, Mrs. W. L. Wall, in St. Paul's Church, Winston-Salem, at 3:45 o'clock on April 19, 1921, after an opening service by the rector, Rev. Phillips S. Gilman.

Mrs. Thomas Shore for herself, and Mrs. Whitaker the President of St. Paul's branch who at present lies ill in a Winston hospital, gave a most gracious greeting to Winston. Mrs. Thomas W. Bickett responded. Mrs. Wall appointed Miss Cheshire, Miss Gregory and Mrs. Holmes to send a word of appreciation and sympathy to Mrs. Whitaker. The minutes of the Executive Committee meeting held in September were read by the Secretary and accepted. Diocesan officers' reports followed. Mrs. Wall in her report as President began with a tribute to Mrs. Hoke and a reference to the Mary McBee Hoke Memorial in Liberia then summed up the officers' reports, ending with an appeal for a more general observance of the Intercessory Days and Corporate Communions. Miss Mary H. Hinton was extended the privi-



lege of the floor for five minutes at the conclusion of her report in order to lay the work of the C. P. C. more definitely before the women assembled at this annual meeting. The chair appointed as the Courtesy Committee, Mrs. W. W. Way, Mrs. J. H. Holt and Mrs. Cheshire Webb. The meeting adjourned to a tea at the home of Mrs. Fletcher.

The evening meeting consisted of the Missionary Litany, hymns and other music by the splendid choir of St. Paul's, and two addresses by Rev. W. E. Cox, of Richmond, Va., and by Miss Grace Lindley. Miss Lindley gave the Auxiliary just what it needed as preparation for the days ahead. Among the qualifications she felt those who work now should have are:

1. A world outlook.
2. An aim.
3. A desire to enlist the uninterested.
4. Intelligence.
5. Careful avoidance of discouragements.

The two special temptations to leaders, she felt, are:

1. Conceit.
2. Discouragement.

The address closed with these thoughts: "Let us do our work in the spirit of worship. We should keep our soul on its knees before the Christ. It is not what past generations think of us or what those yet unborn are going to think but what the *expectant* Christ thinks."

The second day's session was opened with prayer by the Vice-President. The minutes of the preceding day were read by the Secretary. Miss Hunter told of her resignation as Secretary and after the Auxiliary had expressed its regrets presented the Constitution and By-Laws, which were discussed, some changes made, then adopted, section by section, and as a whole. The chair appointed as the nominating committee, Miss Kate Cheshire, Mrs. P. H. Thomas and Mrs. Renwick Wilkes. Mrs. G. W. Alston moved that a committee be appointed



to draft a resolution on the death of the late President, Mrs. Hoke. Mrs. Alston, Mrs. Henry Cooper and Miss Hall were named as the committee. The President urged the women to carry back into their parishes the leaflet on Moral Standards and the leaflet on the Emery Fund, and to *carry out* the suggestions made in these leaflets. Mrs. P. H. Thomas moved the endorsement of the movement to raise moral standards. Carried. Mrs. J. R. Ross, Charlotte, Chairman; Mrs. W. H. S. Burgwyn, Raleigh, Honorary Chairman; Mrs. W. W. Way, Raleigh; Mrs. Clement Manly, Winston; Mrs. Henry Perry, Henderson, and Mrs. R. S. Travis, Weldon, were appointed the Diocesan Committee on Moral Standards. The Rev. Mr. Gilman came before the meeting and extended an invitation to luncheon at the home of Mrs. Whitaker and, in the name of Mrs. Thomas Shore, to a tea at the Country Club at 5 o'clock. Miss Cheshire read the message prepared by her committee to send Mrs. Whitaker. Noonday prayers followed. Then Miss Lindley addressed the meeting on the Auxiliary and its relations to the other organizations of women in the Church. Miss Lindley reminded us that whatever else we do, we must stand true to missions—the revealing of the Christ to the world. In this address she quoted from George McDonald, “God is as easy to please as He is hard to satisfy.” Mrs. Pittenger reported \$998.00 in hand and pledged toward the Hoke Memorial Fund. Mrs. Spruill was added to this committee by Mrs. Wall and at her suggestion the roll was called and \$150 more was pledged. After a wonderful luncheon served to 160 women at Mrs. Whitaker’s home the conference on How to Get Recruits was held, Miss Hunter presiding. Miss Catharine Miller, Dr. John Wood and Miss Lindley spoke during the conference and, with others from the floor, gave some valuable suggestions which are to be turned over to the parish recruiting secretaries. Mrs. Alston showed the communion service



which had been blessed by Mr. Gilman at the early celebration. The Bishop accepted it showing great appreciation and stating it would be turned over to the Archdeacon for use in the Convocation of Charlotte and that the next one would be used for the Colored Convocation. A collection to go towards paying for the manufacture of this service was taken, amounting to \$52.38. Mrs. Blair reported on the Nation-Wide Campaign and the One-Day's Income Fund and Mrs. Wilkes on the Emery Fund, urging the North Carolina branch not to be satisfied with giving \$600.00. Miss Gregory reported on the Hoke Ramsaur Fund—the \$500.00 having been over-subscribed. Mrs. W. A. Whitaker, Winston, was named as chairman of the Bishop Cheshire Fund. The resolution on Mrs. Hoke's death was read by Mrs. Alston, Mrs. Bickett moving that the resolution be published in the Annual Report and a copy each be sent to Judge Hoke and Miss Mary Hoke:

"The North Carolina branch of the Woman's Auxiliary wishes to record its sorrow for the death, its love and thanksgiving for the life of Mary McBee Hoke, our beloved diocesan President, who was called from service here into the joy of Paradise on October 30, 1920. Kindness, courtesy, gentleness and strength radiated from her presence and all who came in contact with her were uplifted by her influence. God bless and comfort her husband and her daughter and give us grace to serve as she served, to love as she loved, to pray as she prayed and some day to share with her the blessedness of serving Thee in Paradise."

After the adoption of this resolution the Bishop of the diocese entered the chancel and held an impressive service in memory of the late President.

At the evening meeting addresses were made by the Bishop and Dr. John W. Wood of New York. The Bishop reviewed the history of the Auxiliary in this diocese, saying that the separation from the diocesan convention



four years ago had more than justified itself. The Bishop spoke with feeling of the late President, Mrs. Hoke, saying that no President of this diocese has exerted a greater influence. Dr. Wood's address was on the missionary work of the Church as a whole and contained many references to the missionaries from this diocese and their work.

The third day's session was opened with the reading of the minutes which, after two corrections, were accepted. Miss Bertha Richards of St. Augustine's School, was introduced and spoke of the work there. The Nominating Committee reported the following names: Miss Emma Hall, Mrs. T. W. Bickett, Miss Claudia Hunter. Miss Hunter asked that her name be withdrawn because it would be impossible for her to hold any office on account of needing a rest; Miss Hall also requested that her name be withdrawn. It was voted to drop no name. From the floor, the following nominations were made: Mrs. J. S. Holmes, Mrs. H. M. Bonner, Mrs. W. L. Wall and Mrs. H. G. Cooper. After the Bible reading (St. John 15:16 to the end), the special prayer for guidance five minutes of silence and the closing prayer, balloting began—resulting in the election of Mrs. Thomas W. Bickett. The Auxiliary has never listened to such an acceptance; every woman who heard it must feel that not only the Auxiliary but the Auxiliary's Divine Head made the choice. Upon request, Miss Lindley spoke on the Shepard-Towner Bill asking, in the name of Dean Lathrop of the Social Service Department, that we urge our representatives in Congress to vote for this bill—and more important still, to urge the state authorities to carry it out if passed. Mrs. Pittenger reported that the Memorial Fund now amounted to \$1,178.49. Mrs. Bonner introduced the following resolution:

*“Resolved:* That this body of women of the Diocese of North Carolina in council assembled endorse The



Shepard-Towner Bill. A copy of the resolutions to be sent to our congressmen."

It was moved that this resolution be adopted and that a copy be sent Miss Lindley as well as to each North Carolina representative in Congress. The following figures had been placed on the blackboard: United Thank Offering for the year, \$2,550.00; total gifts of the Auxiliary this year, \$10,658.43. Reports from parish branches followed, then a discussion of summer conferences. Rev. Mr. Gilman was the chaplain at the noonday service. The Secretary reported 42 branches represented and 74 delegates and speakers, not including a large number of women from near-by towns for a day. Mr. John S. Cunningham introduced the following resolution which had been endorsed by the Bishop:

"WHEREAS, Many churches and much property are burned annually in North Carolina, and

"WHEREAS, This is largely the result of carelessness and neglect,

*"Be it Resolved,* That the Woman's Auxiliary of the Diocese of North Carolina go on record as urging greater care of churches and church property and beg every parish to appoint a Safety Committee, consisting of two or more members, to co-operate with the church wardens in the care and safety of the church property of that respective parish." Adopted. The conference on mission study led by Miss Hall was full of enthusiastic reports on mission study. Miss Hall offered herself to every branch who would like to have her come to it at sometime during the year. After a discussion as to whether the Mary McBee Hoke Memorial take the form of a school or a hospital, Miss Cheshire moved that \$2,000.00 be raised at once and be turned over to Bishop Overs for a school in Liberia. Carried. Mrs. J. S. Holmes, having been chosen by the Executive Committee as Chairman of the Department of Social Service before the adoption of the Constitution, was presented by Mrs. Wall. Mrs. Holmes urged



that every Auxiliary branch report every student from its parish to the State University to the Rev. Mr. Lawrence, Rector; and also asked that all who sing be reported to her. Miss Jeannette Gregory was appointed to write at once to every branch asking for a contribution to send students to summer conferences—and that the branch itself designate whether this money shall be used to send delegates to Blue Ridge or to Sewanee, or be divided between the two. Mrs. Way for the Courtesy Committee in a very lovely way told the Auxiliary of St. Paul's how their most remarkable hospitality had helped the work along and given comfort and pleasure to their guests. And to Mrs. Wall she said, what all were feeling, that she had proved to be a splendid presiding officer. And for steering the meeting through so much and such difficult business she deserved and had our appreciation.

REPORT OF THE ACTING PRESIDENT OF THE  
WOMAN'S AUXILIARY, DIOCESE OF  
NORTH CAROLINA

MY DEAR CO-WORKERS:

We meet once more to pray together, and confer about matters near our hearts as Auxiliary women; to take inventory of the past year's work, and to plan for the new. We all feel a profound sense of loss in the death of our President, Mrs. Hoke, who went to her reward in the midst of a glorious inspirational program of work and study. The One-day Institutes she planned for and carried out, under the inspiration of her character, led us to a wider vision. The last one she held was in Durham, October 29th. It was a privilege to have been there. The next day she fell asleep and her beautiful Christian life was left us as an example. We pray God to guide us in the choice of a successor, who shall be worthy to take her place. The women of the diocese



have undertaken a memorial of love and you have heard the committee make their report.

You have heard the reports of the diocesan officers and appreciate the efforts they have made toward the goal set in the different departments: Mrs. Burwell, Treasurer, with her roll call of parish branches and their gifts amounting to, with expense of distributing, \$6,442.16. Miss Hunter, our Secretary, with a report of 72 branches, 1,615 members, is called on for many letters and much planning. I sincerely thank her for her unfailing response to all my appeals for advice and help. The Box Work has been very satisfactory owing to the fact that we have done more along the lines of the new plan, taking all our apportioned work as sent from headquarters in New York. The amount is less than last year, but Sections 2 and 3 are not included in our report this year. The United Thank Offering Custodian, Mrs. H. G. Cooper, has certainly touched the key-notes in all her letters to the custodians, thanksgiving and increase of gifts for the next Triennial. The Educational Secretary has done a big work in conducting normal study classes and creating an interest in the study of the Survey. She reports 1,000 members, 6 normal classes and 78 study classes. The work has gone forward as Mrs. Hoke and Miss Hall planned and hoped it should.

This is a resume of the past. We must now look to the future at a time when every one admits faith, prayer, righteousness and stability are more needed than at any time since the organization of this Auxiliary. Social Service is part of our work and the Christian womanhood of the Church will respond to the appeal to help raise the present day moral standards. The United Thank Offering demands our gifts if we are to raise one million dollars by the Triennial in Portland; the time is half gone. The Emery Fund gives us the privilege of showing our gratitude for 50 years of Woman's Auxiliary service and of caring for our own returned mission-



aries at home on leave. Our educational work is the way to remove ignorance regarding our missions and missionaries. We love, and are more interested, in what we really know about. The Church Service League, our federation of church organizations, calls for our earnest co-operation. Miss Lindley has asked us to consider these several things. Let us do so prayerfully and let next year's work show the result.

In our own diocesan work, let me urge that we meet our obligations according to the new scale and thus give the Treasurer less bookkeeping. I also urge the paying of the only dues that the Auxiliary has, the Central Fund. Let the Box Work in its effort to be efficient and organized as planned by the Supply Department meet with hearty co-operation. The use of the Auxiliary Column of *The Carolina Churchman* is requested to impart useful or interesting suggestion from the parish branches; I also suggest its use as a source of information to be read at meetings and thus it will become a medium for reaching all members of the Auxiliary. Send articles for this column to your President.

The Constitution and By-Laws reported by the committee and approved by the Bishop will be our working rule when and as passed by this meeting.

In closing let me call to your mind how few Corporate Communion and Intercessory Days were kept and beg that our Spiritual Life be renewed.

## REPORT OF BOX WORK

The work in the Box or Supply Department, as it is called at headquarters, has been better organized, and is nearer in line with the new plan this year. We have been inclined to do for our own Diocese, lacking the broad vision of the needs of distant lands and other fields. Mrs. Wade, head of the Supply Department in New York, held a conference with me in Raleigh the 9th of this month. We talked of the work and plan. This is the plan as she gave it to me: A diocesan head of this work, one chairman for each of our Convocations, and a secretary for Box Work in each branch. Part of this plan is in operation. Besides the diocesan head we have Mrs. E. C. Marshall as chairman of the Charlotte Convocation and Mrs. L. A. Tomlinson appointed chairman of the Raleigh Convocation. They will be in communication with your branch box secretaries. The wish now is for the branches to make such things as are standard for a Supply Department for each Convocation; the chairmen to have charge of them. If an emergency arises they can be used or can fill in the allotment for the Convocation in which they are.



Our allotment for 1921 will reach us about July and consists of:

Two Personal Boxes, One Mission Box, including men, women, and children's clothes, new and old, and household supplies.

One catechist's suit, to be sent out of the money contributed.

Last year's total of box value was \$1,666.20, somewhat less than 1919. Sections 1 and 2 were transferred to the Church School Service League and are not included in the report.

Thank you all who generously made this work so worthwhile.

### REPORT OF EDUCATIONAL SECRETARY

"Time's scythe has swept another year and bound it in its sheaf," and we come again with grateful hearts to report our year's work. The Diocese of North Carolina, through the Survey, has lifted up her eyes and looked on the fields white unto the harvest; she has studied these fields with an enthusiasm and joy that she has never known before, and through them she has heard a call to world service. Seven Institutes and 6 Normal Classes have been held, and we report 78 classes on the Survey, with an attendance of 1,000; 40 Bible Classes; 41 subscriptions to the Spirit of Missions have been secured and 15 delegates promised for the Blue Ridge Conference. The result of the year's study has been, more leaders developed, definite work begun, increased interest, religious education emphasized, and such a vision of the world's needs has been gained that many branches have changed their missionary policy and the budget system has been adopted by some as a marked step forward in extending Christ's Kingdom. Every branch has had an opportunity to attend an Institute, and the recommendations of last year have almost been realized. Through the Survey the needs and opportunities have



made their appeal, and some are going, many are giving and many are praying that the blessed story may be known in all the earth! "The morning light is breaking," the darkness is disappearing, nations are in commotion, Zion's war is on and the command is, "Go forward Christian soldiers."

#### THE THIRTY-FIRST ANNUAL REPORT OF THE CHURCH PERIODICAL CLUB, DIOCESE OF NORTH CAROLINA

During the past year greater interest has been manifested in the Church Periodical Club. It has been presented to more members, many of whom expressed their interest in words, while not a few became active in this far-reaching branch of the Master's work. It requires so little effort, just a few pennies and the results simply cannot be estimated. I believe that if this very useful phase of the Church's work could be presented to the members in general a hearty response would follow. Many know nothing of the existence of such a Club.

In 1920 at six One-Day Institutes large gatherings heard of what is being accomplished at home and abroad through the C. P. C. and literature was distributed. Three new branches have been established with librarians.

It is not easy to obtain a full report as some librarians do not furnish detailed accounts and some fail to reply.

Since the Nation-Wide Campaign has aided the C. P. C. notice has been given that no dues will be required from the branches (each branch pays annual dues of two dollars), but they are to be placed at the disposal of the correspondents. Your Diocesan Correspondent this past year turned the amount, \$16.50, over to St. Paul's College library for the purchase of books.

The Johnsonian Book Club, of Raleigh, has presented all of the club books of the year, in number twenty (20), to the C. P. C. to be equally divided between Boone University, Shanghai; St. Paul's College Library and Alaska. Miss Thomas, our Executive Secretary, expresses a wish that other book clubs may do likewise.

Let us one and all work until August, 1922, to raise funds for the purchase of books for St. Paul's College Library. This is the most ambitious plan ever assumed by the C. P. C. A more worthy one could not be found. Let each one of us go through our collection of books, select one, wrap it in strong paper, and send to Boone University, thereby answering the recent appeal for volumes to fill the empty shelves of this institution of learning, which recently appeared in the *Spirit of Mis-*



sions. Pass on your newspapers, your magazines to those less fortunate. Save your old cards and calendars to be turned over to the librarians and used again.

Lastly, use the C. P. C. Prayer, for without prayer there can not be success.

#### REPORT OF ORGANIZING SECRETARY OF THE CHURCH SCHOOL SERVICE LEAGUE

At the Convention of the Woman's Auxiliary held in Oxford, 1920, among the resolutions passed was the following: "That the Junior Auxiliary as an organization cease to exist and that it be the purpose of the Junior Auxiliary to merge, as soon as possible, into the Church School Service League." The former Junior Auxiliary officers, except President of Little Helpers, having resigned, an Organizing Secretary was appointed by the Bishop and accepted by the Woman's Auxiliary. Inasmuch as the Junior Auxiliary and the C. S. S. L. were placed by the Presiding Bishop and Council in the Department of Religious Education in February, 1920, the Organizing Secretary requested the Bishop to place our Junior Auxiliary and C. S. S. L. under the Board of Religious Education. In June, during the St. Mary's Conference, the Board of Religious Education recognized the Junior Auxiliary as a nucleus of the C. S. S. L. Accordingly the Board appointed a nominating committee to nominate the officers of said League. The following were nominated and unanimously elected by the Board and approved by the Bishop:

Mrs. H. M. Bonner, President; Mrs. W. W. Way, Vice-President; Miss Sarah Cheshire, Secretary; Mr. H. C. Jones, Treasurer; Mrs. Gilbert Hay, Box Secretary; Mr. H. M. Weathers, Treasurer Birthday Thank



Offering; Mrs. F. S. Spruill, Secretary Little Helpers. These officers were elected to serve one year and the duty of said officers is to advance the work of the C. S. S. L. and to perfect the merger between it and the Junior Auxiliary.

The function of the Junior Auxiliary having been taken over by the Church Schools as a fundamental part of Religious Education to be shared in by all boys and girls, the Junior Auxiliary has officially ceased to exist, but the Board will have under its care every Junior Auxiliary in the diocese up to the time that it is ready to pass into the C. S. S. L. The Junior Auxiliary in the past has made a splendid contribution to the Church. This great force must be conserved and the officers, leaders and members of the Junior Auxiliary should feel that they are needed in the work of the League. The Little Helpers Department of the Junior Auxiliary was started in 1891 with the suggestion that children from the day of their baptism could be little helpers in forwarding the mission of the Church. In the new step forward in religious education the Little Helpers and the Font Roll have combined. Together they form "The Little Helpers' Department of the Church School."

The work of the C. S. S. L. is divided into five fields of service, the Parish, the Community, the Diocese, the Nation, the World, with the five-fold objects of Prayer, Study, Work, Gifts and Fellowship. The year's work is divided into five periods or blocks. The 1st block is to be devoted to Box Work. The 3rd block is to be devoted to Graded Mission Study Work. The work of these two blocks is received from the Assis-King." At a meeting of the officers, October 1, 1920, the work was planned and a copy of that plan was sent to every rector and supervisor of C. S. S. L. and the former Junior leaders in whose parish no League had been organized. Articles have been printed in *The Carolina*



*Churchman* relative to our work; many letters have been written by both President and Secretary and Box Secretary. In addition to the regular plan mapped out for the work in the five fields of service through the five blocks, there is the Birthday Thank Offering of the boys and girls in the Church. This is made on Whitsunday, the birthday of the Church. I wish to call attention to the League Prayer, the collect of the former Junior Auxiliary; a pin has been adopted, too, for the C. S. S. L.

I wish to present to you not only the purpose of the League but a report of work accomplished during the year beginning January 1, 1920, ending December 31, 1920:

Number of Leagues organized -----	10

Cycles, 44; leaders, 47; members, 600. Reports of activities in the five fields are as follows: Contributions for parish, \$116.69; community, \$169.36; diocese, \$347.20; nation, \$106.00; world, \$1,264.30; boxes valued \$248.00. Total \$2,251.55. Of this amount the Little Helpers gave \$305.50; number of persons provided for by Christmas boxes, 403.

This report of work done is not as large as we would like to have it; yet, I feel encouraged because I know as one of our leaders said recently, that this organization is the beginning of a tremendous work and I also believe that the Woman's Auxiliary will co-operate with us and give the same loyal support and loving consideration that it has always given to its own beloved child, the Junior Auxiliary. And since the C. S. S. L. is under the Board of Religious Education we request the Woman's Auxiliary's earnest prayers and co-operation for its furtherance in every parish and mission and that the



Woman's Auxiliary give the C. S. S. L. an opportunity to share in their plans for Diocesan Missions and Social Service.

## CONSTITUTION

## ARTICLE I

## NAME

The name of this organization shall be "The North Carolina Branch of the Woman's Auxiliary to the Presiding Bishop and Council of the Protestant Episcopal Church."

## ARTICLE II

## OBJECT

The object of this organization shall be to enlist the women of the diocese in active service for making the Christ known throughout the world. This object shall be carried out through Missions, Religious Education and Christian Social Service; and by means of faithful and definite prayer, study, systematic giving of means and service, and by finding recruits for the mission fields.

## ARTICLE III

## MEMBERSHIP

The membership of this organization shall be composed of all parish and mission branches within the diocese.

## ARTICLE IV.

## OFFICERS

SECTION 1. The officers of this organization shall be: a President, a Vice-President, a Secretary, a Treasurer, a Secretary of the Department of Education, a Secretary of the Department of Social Service, and a Custodian of the United Thank Offering.

SEC. 2. These officers shall constitute the Executive Committee and shall meet in September and March of each year.



## ARTICLE V.

## DUTIES OF OFFICERS

SECTION 1. The President shall have general oversight of all work and shall appoint all committees unless otherwise provided for. She shall preside at all meetings and at every annual meeting shall address the Auxiliary—outlining the work for the year ahead.

SEC. 2. The Vice-President shall act in the absence of the President and shall have charge of the Box Work.

SEC. 3. The Secretary shall record the proceedings of the diocesan branch, carry on all necessary correspondence, prepare and have printed the Annual Report and at each annual meeting shall make report of the past year's work of the branch.

SEC. 4. The Treasurer shall receive and disburse all money except the United Thank Offering and shall make report of same at the annual meeting. She shall, at the end of every fiscal year, turn over accounts to a public auditor for verification and shall publish his statement along with her report in the Annual Report. The Treasurer shall act as chairman of the Committee on Credentials.

SEC. 5. The Secretary of the Department of Education shall have charge of the educational program of the branch.

SEC. 6. The Secretary of the Department of Social Service shall have charge of the social service work of the branch.

SEC. 7. The United Thank Offering Custodian shall receive the United Thank Offering in September and at the annual meeting and shall deposit same in a savings bank or immediately remit to the Treasurer of the Presiding Bishop and Council for investment. The Custodian shall make every effort to secure the interest and a contribution from every woman in the diocese.



## ARTICLE VI.

## TERM OF OFFICE

SECTION 1. The President, Vice-President, Treasurer, Secretary of the Department of Education, Secretary of the Department of Social Service and United Thank Offering Custodian shall be elected for a term of three years; the President to be elected at the second annual meeting after the Triennial; the Treasurer, Secretary of the Department of Education and Secretary of the Department of Social Service the third meeting after the Triennial; and the Vice-President and United Thank Offering Custodian the first meeting after the Triennial. No officer shall be eligible for two consecutive full terms. Vacancies occurring during the year shall be filled by the Executive Committee.

SEC. 2. The Secretary shall be appointed by the President for one year.

## ARTICLE VII.

## ELECTIONS

SECTION 1. For the election of the President: The President shall appoint, at the annual meeting, a committee of three to receive nominations. Nominations must be in writing—except any that may be made from the floor at the time of election—and from these written nominations the committee shall present three names. If there is no majority on the first ballot all names shall be dropped but the two having the largest number of votes.

SEC. 2. Any delegate may nominate, but a branch may cast but one vote; a branch to have voting privileges must have paid the Central Fund; no vote shall be cast by proxy; all elections shall be by ballot.

SEC. 3. All other elective officers shall be chosen according to the manner prescribed for the election of the President.



## ARTICLE VIII.

## FINANCE

SECTION 1. The Treasurer shall send to every branch two months before the annual meeting the following sliding scale: Class A \$600; Class B \$500; Class C \$400; Class D \$300; Class E \$200; Class F \$100; Class G \$50; Class H \$25; Class I \$10; Class J \$5 and at the annual meeting each branch shall designate the class which it decides to enter.

SEC. 2. The United Thank Offering, Box Work and Central Fund shall be in addition to the contributions made according to this sliding scale.

SEC. 3. From the amount contributed according to this scale, the Treasurer shall turn over one-half to the Nation-wide Campaign Fund—not to be counted on the parish pledge unless so requested—and one-half to such specials as the parish branch may designate.

## ARTICLE IX.

## AMENDMENTS

This Constitution may be amended at the annual meeting of the diocesan branch by a two-thirds vote of the duly appointed representatives, due notice of the proposed amendment having been given to every branch at least one month before the annual meeting.

## BY-LAWS

The time and place for the annual meeting of two and a half days shall be approved by the Bishop and the Executive Committee.

Unfinished Business

For the meeting next before the Triennial the Executive Committee shall arrange a different order of business in order that the Celebration, presentation of the United Thank Offering and a special sermon may come the first day at 10:30 in the morning.

2. Each branch shall be assessed twenty-five cents per member to provide for Provincial expenses, printing, postage, stationery and traveling expenses of speakers. \$50 shall be set aside from this fund for the President's traveling expenses. All offerings at district meetings and institutes, except when given for some special object, shall be added to this fund, which shall be known as the Central Fund.

3. The annual report of the Church Periodical Club may be printed in the Annual Report.

4. One-fourth of the branches having the right to vote shall constitute a quorum at the annual meeting. Three members shall constitute a quorum at the Executive Committee meetings.

5. These By-Laws may be altered or amended by a majority of the delegates to any annual meeting.
