**IMPORTANT NOTES**

1. See Constitution and By-Laws on pages 56-62.
2. The Feast of the Purification is the annual Corporate Communion day for the Woman's Auxiliary of the National Church; and the Feasts of St. Andrew, the Epiphany, the Annunciation and the Transfiguration are the special Intercalary Days for the Diocese. Please observe these days.
3. The special prayer for use before and at the time of the election of officers may be found on page 4.
4. Note carefully Article IX of Constitution.
5. Article VII of the Constitution reads in part, "A branch to have voting privileges must have paid the Central Fund."
6. Article VIII, Section 3, reads in part, "From the amount contributed, according to this scale, the Treasurer shall turn over one-half to the Forward Movement," this amount to be distributed according to the needs as seen by the Presiding Bishop and Council. Inasmuch as this organization is Auxiliary to the Presiding Bishop and Council, this money will go to the general fund, therefore any amount a branch may wish to go for diocesan objects should be designated from the remaining half of the branch's contribution.
7. Send all money, except the United Thank Offering and money for Supply Department, to Mrs. R. B. Davis, 425 Tarboro Street, Rocky Mount, Treasurer. Books close for the year December 31, 1926.
8. Article VIII of the Constitution explains the letter placed by most branches in the list of parish branches and their officers. Where there is no letter the branch either did not enter the scale, which every branch should feel free to do or not do as seems best to its members (a surprisingly large number, however, did follow the new plan), or it did not divide its gifts in a way to approach anywhere near the place in the scale the amount given entitled it. (At least half must go to the Forward Movement.) It seems fairer to place no letter by a branch in a case where \$600, for instance, had been given, less than

\$250, however, going undesignated, because if a letter had been used it would have been C. Whereas if \$300 or more of this \$600 had been left undesignated—given to the Forward Movement—the branch's letter would have been A.

#### FORM OF BEQUEST

## MINUTES OF THE ANNUAL MEETING

The thirty-seventh annual meeting of the Woman's Auxiliary to the Board of Missions and the seventh annual meeting of the Woman's Auxiliary to the Presiding Bishop and Council in the Diocese of North Carolina was opened on the afternoon of Tuesday, April 20th, 1926, in St. Philip's Church, Durham, with a Quiet Hour, conducted by the Rev. Bertram E. Brown.

At 8:00 p. m. Evening Prayer was said in St. Philip's Church, followed by words of welcome spoken by Bishop Cheshire and greetings from the parish by Rev. Sidney S. Bost. Bishop Cheshire introduced two of our returned Missionaries, now on furlough in this country, Dr. A. W. Tucker, in charge of St. Luke's Hospital, Shanghai, who spoke on "A Medical Missionary in China," and Archdeacon Fred B. Drane, whose subject was "Along the Yukon."

On Wednesday, April 21, at 7:30, Holy Communion was celebrated by Bishop Cheshire, assisted by Bishop Penick and Rev. Sidney S. Bost. At this service the U. T. O. was presented, and there was a commemoration of the Departed of the Auxiliary.

At 8:30 a. m. breakfast was served at the Washington Duke Hotel. The subject for this Group Conference was "Problems of the Mission Study Class," led by Mrs. Mazyck.

The business session opened at 9:45 in the Parish House of St. Philip's, the President, Mrs. W. W. Way, presiding. A hymn was sung, and prayer was offered by Bishop Penick.

Rules of Order were read by the President, who introduced Deaconess Peet for the Dispatch of Business, whose duty was to keep time. Mrs. Way announced there would be an election of two officers, the Vice-President and United Thank Offering Custodian. Mrs. Bonner called the roll of delegates for the Secretary.

The following Committees were appointed:

Mrs. J. M. M. Gregory, President of the District of Orange, welcomed the Auxiliary to the parish. Miss Lillie H. Hill, responded.

The President delivered her address.

The Secretary's report was read and accepted.

The Treasurer's report was read and accepted.

The Church Periodical Club report sent by Miss Mary Hoke, who was unable to attend, was read.

Mrs. Way introduced two Saint Mary's girls, Miss Sylbert Pendleton and Miss Bullitt, who had attended summer conference in 1925. They spoke briefly and very interestingly.

Rev. John L. Jackson spoke on the Nation-Wide Campaign and Thompson Orphanage.

Mrs. James H. Cordon read the report from the Girl's Friendly Society.

Invitations to hold the annual meeting of 1927, in the Church of the Good Shepherd, Raleigh, Tarboro, Burlington, Henderson and Salisbury were extended. The vote was cast to accept the invitation from Salisbury.

Reports from the Prayer Partnership and the Treasure and Trinket Fund were read by Mrs. Bickett in the absence of the Chairman, Mrs. G. W. Alston.

The report on the Offering of Life was sent by Miss Sophronia Cooper, and read by her mother, Mrs. H. G. Cooper.

At 12:00 Noon Prayer and meditation were held by Mrs. Bickett.

After this service Mrs. Spruill gave the report for the United Thank Offering, and Bishop Penick delivered the address. The March, 1926, Offering was announced to have been \$3,206.79.

Luncheon was served at the Washington Duke Hotel at 1:00 p. m., by the Auxiliaries of Durham.

Business session began at 2:24 p. m. in St. Philip's Church, the Parish House being inadequate for the large attendance.

Report of the Auxiliary of the Colored Convocation was read by Mrs. H. B. Delaney, the President.

Mrs. Collier Cobb extended a cordial invitation to the Auxiliary to visit Chapel Hill in the afternoon.

Mrs. Bulluck read the report of her department—Social Service. It was announced that Dr. Branson was unable to attend and address the Auxiliary.

Mrs. Mazyck gave report on Religious Education. Miss Tiltonson spoke impressively on this phase of work.

Mrs. Devin gave report of the Supply Department, but regretted that neither Mr. Bost nor Mr. Jackson could deliver an address.

At 4:00 p. m. an automobile ride was given to Chapel Hill, where the delegates and visitors enjoyed an organ recital by Miss Henrietta Smedes in the Chapel of the Cross. Supper was served in the Parish House by the Auxiliary of Chapel Hill.

At 8 o'clock Evening Prayer was said. Rev. Roney C. Fortune delivered an address in sign language, interpreted by Rev. Sidney S. Bost. Bishop Penick announced as "Advanced Work," a Chapel for deaf mutes, to be erected in Durham, a tribute to our beloved Bishop Cheshire. Miss Bessie Blacknall told of her work at St. Mark's, Nenana, Alaska.

#### THURSDAY, APRIL 22

Holy Communion was celebrated by Bishop Penick at 7:30 a. m.

At 8:30, in the Washington Duke Hotel, the Breakfast Conference was held, when Mrs. Frank S. Challen talked of "Our Young People."

The business session was held in St. Philip's Church. After prayer and a hymn, Mrs. Way called the meeting to order.

Miss Emma Hall was called upon to report for the Districts, as Chairman of Districts.

Reports were read by the following Chairmen: Mrs. Burwell for Granville; Mrs. Blair for Guilford; Mrs. Gregory for Orange; Mrs. Garibaldi for Mecklenburg; Mrs. Massey for

Rowan; Mrs. Baker for Richmond. Reports from Forsyth and Edgecombe were read.

Mrs. G. N. Cooke was asked to speak about the Church at Albemarle. Miss Hall asked all to pray for this most worthy work.

Report from the Nominating Committee was presented by the Chairman, Mrs. Quintard.

A question arose as to the privilege of voting. It was asked could officers vote. It was moved and carried that we abide by the Constitution.

At noon prayer and meditation were conducted by Mrs. Bickett.

Archdeacon Bethea spoke of work in the Convocation of Raleigh. Archdeacon Hardin spoke of his labor in the Convocation of Charlotte.

Luncheon was served at the parish house of the Methodist Church.

The business session opened at 2:15 p. m. A hymn was sung and prayer offered.

An address on "Our Young People's Work" was given by Mrs. Frank S. Challen.

After ballots were cast and counted it was announced that Mrs. R. H. Lewis, of Oxford, was elected Vice-President and Chairman of Supply (Box) Work, and Mrs. W. D. Burwell of Henderson, United Thank Offering Custodian.

Mrs. Cheshire Webb, Chairman of Resolutions Committee, read the resolutions that had been presented to the Committee.

It was moved and carried that a change be made in the representation of the Branches at the Annual Meeting. (See page 61.)

A resolution was discussed that a memorial be given by the Woman's Auxiliary for Miss Horner and Miss Katherine Bourne.

The Secretary was instructed to write a letter of love and sympathy to Mrs. W. A. Erwin in her illness, telling her how much we missed her during the Annual Meeting.

All business having been transacted, the President offered the closing words, then prayer, and the Meeting of 1926 was declared adjourned.

At 8:00 p. m. Evening Prayer was said. Rev. Francis A. Cox, spoke on "China," Miss Tillotson on "This Triennium." Bishop Penick read the following Resolution from the Courtesy Committee.

#### **Resolution of Courtesy**

*Unanimously passed at the last session of the Woman's  
Auxiliary Convention*

*Resolved:* That the delegates to the Woman's Auxiliary Convention of the Diocese of North Carolina, assembled in St. Philip's Church, Durham, N. C., unanimously record their sincere appreciation for all the courtesies and kindnesses extended to them by this hospitable parish, by the rector, the choir and organist, the local Branches of the Woman's Auxiliary, by the friends of St. Philip's congregation and other citizens of Durham who have opened their homes and contributed to the comfort of the delegates in manifold ways, the press of the city, the neighboring parish of the Chapel of the Cross, Chapel Hill. For these special evidences of warm-hearted hospitality and for unnumbered acts of kindness, we record our grateful appreciation.

#### **THE PRESIDENT'S ADDRESS**

This, our first meeting after the Triennial, must be a very important one. At this time we start out on another three years' work with new vigor, interest and responsibility.

"The Message" sent by our Executive Board to the National Council was adopted by your representatives of the Woman's Auxiliary in New Orleans as "our own" Message.

"We have dedicated ourselves anew to our Saviour" and must strive "to give proof in our own lives" our belief in His power to strengthen us. And further, we have pledged "to try to awaken the women of the Church."

Let us carry this message to every woman in this diocese. Throughout several of the districts "The Message" was carried by "The Pilgrimage of Prayer." Prayerful preparation was made and every branch was visited and devotional meetings were held. More than that, isolated Church women were visited who joyfully received the "Message," and now (though unable to attend meetings and, sometimes, even the Church service), have the "Little Blue Box" and a real part in the work of the

Auxiliary. I hope some such plan will be carried out through every district in our diocese.

I remind you that a resolution was passed by you a year ago pledging, as members of the Auxiliary, to keep yourselves informed as to whether our parishes, or missions, are meeting their budget quotas, and offering ourselves to the clergy and vestries to do all we can towards that end.

By resolution in New Orleans "we are dedicated to the payment in full of all general Church quotas."

Please study carefully "The Church's Program" and the Minutes of the Triennial. Then we shall all know just what "Budget Quota" and "Advanced Work" mean, and what is asked of our diocese.

A church building for deaf mutes, here in Durham, has been chosen as our Diocesan Advanced Work for this triennium. Of the \$15,000 necessary for the building the Executive Council asks that the members of our Auxiliary raise \$3,000 during the next three years. Our own Executive Committee recommends to you that we assume \$3,000 for this "Advanced Work" and \$1,000 for the "Corporate Gift." Miss Emma Hall is the chairman for these funds. The Executive Council also asks us to give \$100 a year towards the expenses of the CAROLINA CHURCHMAN. Please first *read* the CAROLINA CHURCHMAN each month, and second, send in to me articles of interest for the Woman's Auxiliary page.

I commend again to your use "The Calendar of Daily Bible Readings" and also "The Prayer Leaflet." Let us read and pray each day, together, the same words and gain the strength that comes from such concerted effort.

It is reported that only four or five branches have kept the Intercessory Days during the past year, sending in their offerings.

These four days are set apart for a Corporate Communion of the Auxiliary, with special intercessions. I need not remind you what an earnest observance of these days might mean to us. And on these days the offerings are designated for special objects, all near to our hearts. Let us try in each branch to keep these days this year.

I hope, through Mrs. Delaney's report and the committee on "Work with Colored Women," you will be especially interested in doing what you can to strengthen the Auxiliary among the colored parishes and missions throughout our diocese.

Because of the great help that has come to some of our branches through the use of printed programs for the year's work, a committee has been formed to prepare an outline of such a program. This will be printed in The Annual Report and is offered as a helpful suggestion.

#### SECRETARY'S REPORT

The Annual Report was published and mailed individually to members of the Executive Committee and the Branch officers in June so as to avoid delay of delivery.

Notices were sent to the members of the Executive Committee for the September and March Meetings, and minutes of those recorded.

At the September Committee Meeting it was voted to purchase a mimeograph, the Auxiliary purchasing one-half interest, the Secretary the other half. This affords opportunity for the President to send copies of Miss Lindley's quarterly letter to each branch, as well as other important communications. Miss Lindley's January letter was mimeographed and mailed to every branch president. The President's letter concerning the Annual Meeting was mailed to each branch in March.

The program for the Educational Institute, which Mrs. Mazyck held at Christ Church, Raleigh, February 12th, was done by your Secretary.

Early in January 81 report blanks were sent to the branch presidents. In April 10 more were mailed to those who had not answered. Seven branches have never replied. The membership reported is 2,005, and the following information was requested by the Church Missions House:

Included in the total of \$4,128.27 reported for Box Work for the year was \$798.25 in cash contributions received by the Chairman from fifty-three branches for Supply Room, Durham, N. C., together with Personal Boxes valued at \$309.85 sent by six branches.

The cash received for Mission Boxes to be sent from Supply Room was disbursed as follows:

A box of second-hand clothing was sent from Supply Room, valued at \$119.15 but this is included in reports from branches.

The work of the past three years has been marked by a continued growth in the volume of things accomplished, and increased interest in this Department among the branches. A large percentage of the branches contribute the average of fifty cents or one dollar per member for carrying on Box Work in the Diocese.

A Supply Room has been furnished in Durham, N. C., and the work in connection with it is all organized, and bears fruit in greater service by this Department. The members of nearby branches come to this Supply Room, and cut the garments, and they are then sent to other branches to be made. Thus the cutting and sewing have given a personal contact and an individual touch to the many members who have given their personal service in love to the filling of Mission Boxes and this has brought an added interest.

Personal boxes are filled by branches which do not assist with the Mission Boxes, and these branches get the personal touch by corresponding with the Missionaries to whom the boxes are sent.

This year our personal boxes were sent to Rev. and Mrs. Stallknecht, Del Rio, Texas. Their family consists of a girl and two boys. On Easter Monday a letter was received from Mrs. Stallknecht from which I quote in part as follows:

"Having three children in school requires many things we are not able to buy. We are all so pleased when the Missionary boxes arrive, and I want to thank you all for the money you have sent me. It is needless to tell you that it came in answer to prayer."

Our Missionary Boxes for 1926 were for Advent Mission, Columbia, Tenn., and were sent to Mrs. Mary B. Hine. In acknowledging receipt of them she writes:

"I have never in all my past experience seen such wonderful boxes. They combine just what I am sure these people need. The contents of these boxes seem almost an answer to prayer. The children from the factory town will all come to me in the morning and I will have an Easter dress for each little girl and a shirt for each boy, and they will be so happy. I am so happy to have all these things to give them for I know their necessities, and they look to me to help them."

The work of the Supply Room is in its infancy. We have laid the foundation for larger things yet to be accomplished.

As I retire from the Chairmanship of this Department, I desire to express my appreciation of the sympathetic cooperation of those who have given their aid in this service—a real service to those who are in need. May God continue to bless you in this work. And as I pass on my duties to my successor it is with the earnest hope that she may receive during her term of office as rich a blessing and as hearty cooperation of the branches as has been accorded to me.

The best known and best loved work in the Church today is that of the United Thank Offering.

What is the purpose of this offering?

It is a woman's work for women. Every woman and young girl in the Church is given a little blue box, and asked to place in it an offering when she is thankful. The funds thus obtained supply the needs of our own women who so bravely face the trials and dangers of the Mission Field.

As Bishop Tuttle said: "The United Thank Offering is an outward and visible sign of an inward and spiritual grace," the little blue box representing the material side of this holy work.

In this day of multiple organizations, it is a comfort to feel that there is one phase of the Church work which is conducted by each individual, with responsibility to no one but God Himself. The stimulus comes not from public meetings, but from daily contact with our dear Lord. May we reverently call this a little society of two, the individual giver, and the blessed Master? In the ordinary society, there are assessments and dues, but here we have the joyful exhilaration that comes from the voluntary thank offering.

The isolated woman and the invalid are no longer helpless. Through fervent prayers and secret gifts, the wonderful privilege is given them, quietly and alone in their own homes, to aid in the advancement of the Kingdom of Almighty God.

Whether the loving offering is made systematically, or is given spontaneously and ecstatically—

"All service ranks the same with God—  
With God whose children, best and worst,  
Are we: there is no last nor first."

Somehow there is a sense of inadequacy in the merely spoken word of thanks. The language of love is giving, and the individual secret gift is anointed with the oil of gladness above its fellows. I believe that the woman who takes her part in the United Thank Offering is helped in her own soul, and will find a truer happiness in her religion, and a deeper reality in the sacramental life of the Church.

Let us dedicate ourselves afresh to this work. We are thankful for our daily blessings, beautiful sunshine, showers, health, friends, food, raiment, escape from accidents, relief from pain. Do our little blue boxes daily receive our expression of this thankfulness?

Let our slogan be: To serve those who serve.

Our aim: A thank offering when we are thankful.

There is an honor roll for the Parishes whose offerings are increased each year, but the ideal honor roll is the one in which every woman and girl understands the purpose of the United Thank Offering, and has a share in it.

I pray God's blessing on our effort.

#### REPORT OF COMMITTEE ON THE OFFERING OF LIFE

The two phases of work of this committee are:

First—To endeavor to keep the names and addresses of all workers from the North Carolina Diocese and, in particular, to try to keep in touch with the volunteers.

Second—To secure funds for Diocesan Delegates to Summer Conferences, and to keep a list of the delegates sent.

I have sent my list of the workers from this diocese to the Missions House to be verified and will have it in time to be printed in our Annual Report.

We have with us at this meeting such splendid representatives from the Mission Field, Dr. Tucker, Mr. Cox, Miss Blacknall and Archdeacon Drane, that I feel that they are a report from the Offering of Life.

The opportunity of hearing and knowing these faithful workers should certainly draw us into closer contact with the Missionary work of the Church.

In response to cards sent to the different parishes, concerning Summer Conferences, we find that the sum of about \$100 has been given for this purpose. Since you give this money you should have a voice in where and who should be sent from this Diocese. You will have an opportunity in a few minutes to hear from the delegates you sent last year, where they went, what they did, and the result. Surely we are going to send girls from St. Mary's!

But are there not many workers in our home diocese who would also be worthy and helpful delegates to one of our conferences?

Should we not, now, decide to send a delegate to the Conference at Valle Crucis? The Valle Crucis Conference, being under the guidance of the Church exclusively, claims our loyalty, and is in the mountain section where many of our missions are situated.

I need not tell you of the St. Mary's girls who are present, for they will speak for themselves, but I would like to say that we have never sent St. Mary's girls to Conferences as delegates that have not proven great assets to the Church, even tho' not going as missionaries. They have proven good witnesses in colleges, business and homes.

We especially wish you to know that the Auxiliary does not pay all of the expenses of these delegates. The Blue Ridge delegate is given \$25.00; the remainder of the expenses, which is between \$25.00 and \$30.00, is paid by the delegate herself. To the Sewanee delegate \$50.00 is given, and she herself pays the remainder, about \$30.00.

The St. Mary's delegates are elected by the student body. Our last year's delegates, who are present, are:

Miss Mela Royall, Goldsboro;  
Miss Margaret Bullitt, Chapel Hill;  
Miss Sylbert Pendleton, Fort Benning, Ga.

Is there any work more beautiful and helpful for our Committee to undertake than sending delegates from our own, dear Church School, St. Mary's, and seeing the results each year as they influence their comrades and go into our different parishes!

I now earnestly request an open discussion on two questions:

A delegate from the Diocese at large, and  
The Conference at Valle Crucis.

## REPORT OF CHRISTIAN SOCIAL SERVICE

In many ways my report is very gratifying, and in many ways, disappointing. The Branches, as a whole, have failed to send in written reports, yet by hearsay, by verbal reports and by personal observation your Secretary is aware of the good work that has been done by the women of our Diocese in the line of Christian Social Service.

Last October a letter was sent to each branch, outlining a program and containing many requests. Most of these requests, your Secretary is confident have been complied with, but the very urgent request of sending reports promptly has been ignored.

Many letters have been received, asking suggestions, and much work has been done by most of the Branches. Winston-Salem, Greensboro and Rocky Mount have done very constructive and tangible work in community uplift and public welfare. Religious services have increased in county homes and prison camps, and before our next Convention we hope that regular services will be held in every institution, county home and prison in the Diocese. Let us pray fervently that the right spirit may prevail in the hearts of the men who direct these institutions—when once the Christian spirit prevails all the ills and problems of social welfare will be solved.

Many branches, in addition to their personal work, have expended sums of money for hospital and sanatorium treatment. It is the desire of your Secretary that more of this will be done in the future.

The most excellent work last year of Miss Lilly Haines Hill in Rockingham County shows us the crying need and the wonderful opportunity for our rural work. This year we hope to make the country mission our main objective, and with this thought in mind we have invited Dr. Branson to talk to us today about our country neighbors, and the Church's relation to them.

There is a feeling of fear on the part of some of our women, that perhaps our Auxiliary, by becoming a member of the organization asking for remedial legislation, is slipping too much into politics. We pray God that His women may never become

a political machine. But we must remember that Jesus taught us to attack the forces of evil in His name. In the prayer written for our daily use, we ask "that we make no peace with oppression, that we reverently use our freedom, help us to employ it in the maintenance of justice among men and nations to the glory of Thy Holy name."

We would have you bear in mind that the economic, social, and industrial world have become so organized that public welfare cannot function without law and order. The only way of obtaining this, however unfortunate it may be, is through the men who make our laws.

Our women are doing splendid Christian social service work, even if they don't report it. Your Secretary has great faith in them and asks God's blessings upon them.

#### REPORT OF EDUCATIONAL DEPARTMENT

Just one year ago this month I was chosen by the women of the Auxiliary to lead in our Educational Department. It is a tremendous responsibility. One is so poignantly conscious of one's limitations; and of the inability of any individual to properly, adequately, lead in this still unplowed field of Religious Education. We seem to *know* so little, and (here's the rub) to *wish* to know so little! How to stimulate and arouse an ardent, enthusiastic, *desire* for knowledge, seems to me our all absorbing task in a nutshell.

In offering me the position of Educational Secretary for the Diocese of North Carolina the women of the Church have thrust upon me the grim, but exhilarating necessity to *think*. I know of no position in the Auxiliary where there is greater need for thought, constructive thought; and I now extend to every individual woman in the Diocese, a most cordial invitation to join me in this noble exercise! Let us think together—Alone I can do nothing but the power of our *united, concentrated*, thought will work the miracle we so greatly need.—An aroused intelligence

alive to the glory and joy of making the world a brotherhood, each and every individual in that brotherhood worshiping and obeying our Lord Jesus Christ! Ah! is it not a consummation which would inspire the heart of the dullest, and most phlegmatic? And it is no idle dream, no fantastic vision of impossible things. It was the reason for Our Lord's coming. "Christ for the World we sing, Christ to the world we *bring*." Yes, but we do *not* "bring," we simply *sing*. Our part in this divine undertaking is that ancient command, two thousand years unheeded, "Go, *teach*:" and when we awake to our responsibilities, the "Earth *shall* be covered with the knowledge of the Glory of God as the waters cover the sea."

Now a word as to specific things accomplished in this past year. We held one Educational Institute in Raleigh, which we hope and believe was most successful. Individuals here and there all over the Diocese are awakening to the necessity of serious study—we intend that at least one such Institute shall be held every fall, preferably before Advent, so that Educational Secretaries all over the Diocese may get together to discuss plans and methods for the year's work. This we feel is a step in the right direction. An organized effort to arouse Educational Secretaries to an appreciation of their duties and privileges. From the 78 report blanks sent out, I received 39 replies; and mark this, the best reports were by no means those from the largest, best equipped, parishes. I was amazed and delighted to find isolated, small, groups here and there reading more broadly, reading because they were vitally interested, and not from a strict sense of duty; study groups being formed, where none existed before, discussion groups (the ideal method) being tried for the first time in many rural places. It makes one take heart, for we can *see* the dawn of a brighter, better, day in Educational work.

Finally I am rejoiced, after carefully studying this great question of leadership, to find that a really good leader puts the responsibility on *others*! If, therefore we succeed in these three years, the success shall be *yours*; If we fail—but there is no such word in the vocabulary, nor in the annals, of the women of North Carolina. Let me close with a quotation from one of

our great Educational leaders, "If Christ is the 'Light of the World, then Christian Religious Education is the World's hope."

#### REPORT OF THE CHURCH PERIODICAL CLUB

The Church Periodical Club of the Diocese of North Carolina is made up of thirty-four branches, about half of which are now active. The report for the year 1925, is necessarily incomplete, due to the fact that only nine of these branches sent in statements of their year's work. The work reported is as follows:

Current periodicals sent regularly.....	75
Donors of above current periodicals.....	63
Odd magazines sent.....	1,228
Books, theological and secular.....	20
Tracts and catechisms.....	8
Money spent.....	\$4.00

Among the institutions in this Diocese aided by the Church Periodical Club are Watts Hospital, Durham; Old Ladies' Home, Durham; County Home, and other institutions, Burlington; Penitentiary, Raleigh.

At the meetings of the Church Periodical Club held in New Orleans at the time of the General Convention, it was particularly urged that the various branches of the Church Periodical Club direct their attention to local work, since the present postal rates make it impractical and often impossible to send away all our magazines; and so we are asked to find out the needs for magazines and books in our own communities and in neighboring localities, and supply these needs to the best of our ability. In a number of places in this Diocese, I am sure, a great deal of this local work is being done, but not reported through the C. P. C., and I particularly want to ask that in such places a C. P. C. Secretary be appointed to keep track of the amount of work done so that we may have an accurate report each year.

Another point stressed at New Orleans was that, while the C. P. C. functions, in many cases, through the Woman's Auxiliary, there is work for every member of each parish. The aid of the children of the Sunday School and Service Leagues may be enlisted in collecting and distributing magazines and in making scrap books for hospitals and children's homes; and all the men and women of the parish may be asked to give their magazines or books, and to seek out those to whom these gifts would bring enlightenment and pleasure.

Of course, where it is possible, we are still urged to forward our magazines to distant lands, where the need for them is ever growing, and to contribute money for libraries in our mission fields. Letters of appreciation and encouragement come from all parts of the world to let us know that our work is indeed worth while, and to urge us on to renewed activity in this important field of service.

#### REPORT OF PRAYER PARTNERSHIP PLAN

I have received reports for this meeting from the districts of Edgecombe, Granville, Guilford, Mecklenburg, Orange, and Wake. Forsyth has no chairman.

The report from Edgecombe is an account of the Prayer Pilgrimage last November, which Mrs. Green, our Chairman, helped to make a success. The value of this to the Prayer-Partnership is easily recognized. She had written to all her branches, asking them to appoint Prayer Partnership Secretaries, but had not received replies to her letters. ("That we may realize the duty of answering letters" would be a good clause to put in our Auxiliary litany.)

Mrs. Cooper, of Granville, reports occasional letters and cards sent Miss Whitley and prayers offered.

Mrs. C. W. Banner, of Guilford, has only recently been appointed. She has responded to every suggestion about the work and attended promptly to her correspondence. She reports one branch, Leaksville, as having a Branch Prayer-Partnership Secretary, and she is trying to arouse an interest in this plan in all her branches.

Mrs. E. K. Powe, of Orange, reports a Prayer Partnership Secretary in every branch in her district, letters and cards sent Miss Whitcomb and prayers offered.

Mrs. J. S. Gaul, of Mecklenburg, reports that her six branches "are cooperating very nicely" and to their prayers are added gifts and cards and letters for Mrs. Coffin, especially was she remembered by lovely gifts at Christmas.

Miss Ellen Bowen was appointed Chairman of Wake in November. She assigned the special Prayer Partnership work to St. Anne's Branch, Good Shepherd Church, Raleigh, for December. They responded cordially with personal prayers and personal gifts and cards of greeting. She wrote to every branch in her district, asking them to appoint Branch Prayer Partnership Secretaries, and also to Deaconess Smith. This closed her report for 1925.

I have received no reply to my requests for reports from the districts of Richmond and Rowan.

With this report closes my term of office. I have not succeeded in what I wanted to do, but I bespeak for my successor your earnest cooperation and prayers.

We women of the Church must realize our responsibility and opportunity to serve the girls of our Church and all girls, for girls of all denominations are welcomed into the Friendly.

Is there any girl that would not be benefited by the cardinal principles of the Friendly—Purity of Life, Dutifulness to Parents, Faithfulness in Work, and Thrift?

In our Diocese there are five branches and several Candidates' classes which are doing splendid work in the five fields of service—the parish, the community, the diocese, the nation and the world. Our Lenten work came under the world field for it was making layettes for the missions. These layettes, by the way, were sent out by the Woman's Auxiliary.

Our Diocese has an unique accomplishment of which we are very proud—our Girls' Friendly Lodge in Raleigh. If at any time any of you know of a girl coming to Raleigh who wants a home, send her to the Lodge, where she will be well taken care of and chaperoned and can get board and lodging for only \$7.00 a week. We are most fortunate in having a housemother, Mrs. Portia McClenaghan, who has the happy faculty of understanding girls, and they love her.

Good work as we have done, it is not as much as we could do if you women took a more active interest in the Girls' Friendly. Our cry is for leaders. It is the Church's opportunity—will you women answer the call?

## TREASURER'S REPORT

### REPORT OF AUDIT

**From January 1, 1925, to December 31, 1925**

*To President and Executive Committee of the Woman's Auxiliary to the  
Presiding Bishop and Council, Diocese of North Carolina.*

Pursuant to request of your Treasurer I have audited your records of Receipts and Disbursements for the period beginning January 1, 1925, and ending December 31, 1925. During this period the account was handled by two Treasurers. From January 1st to May 5th by Mrs. C. M. Parks and from May 5th to December 31st by Mrs. R. B. Davis.

On May 5th Mrs. Parks turned over to Mrs. Davis the sum of \$500.00 and later Mrs. Davis paid for Mrs. Parks outstanding checks amounting to \$60.00, which were included in Mrs. Parks' disbursements, but paid by Mrs. Davis after Mrs. Parks' account had been closed. Mrs. Davis also paid to Mrs. Parks \$53.62 for overdraft, after Mrs. Parks' account had been closed. It appears, therefore, that the amount turned over to Mrs. Davis by Mrs. Parks should have been \$386.38 instead of \$500.00.

The item of \$500.00 is shown as received by both Mrs. Parks and Mrs. Davis due to two Treasurer's accounts. The item as appearing in Mrs. Davis' account is simply a journal entry or transfer from collections already made by Mrs. Parks.

*Resolved*, That the delegates to the annual meeting of the Woman's Auxiliary of the diocese of North Carolina, assembled in St. Philip's Church, Durham, desire to reaffirm the resolution adopted by the Woman's Auxiliary at their Triennial meeting in New Orleans:

*Resolved*, That the delegates to the Triennial of the Woman's Auxiliary of 1925, assembled in New Orleans, place on record our conviction that war as an institution for the settlement of international disputes by brute force allied to skill and cunning and lying, is incompatible with the mind of His Church, and that the causes of war are ignorance, prejudice, selfishness and greed, especially in the national economic and other corporate aspects of life, which must be uprooted from the hearts of men;

*We, Therefore*, Pledge ourselves to carry out a constructive program of education for peace, and to use our best efforts and our strongest influence toward the promotion of international and inter-racial good will.

"Lord, lift us out of private mindedness and give us public souls to work for Thy Kingdom by daily creating that atmosphere of a happy temper and generous heart which alone can bring the Great Peace."

**CONSTITUTION****ARTICLE I****NAME**

The name of this organization shall be "The North Carolina Branch of the Woman's Auxiliary to the Presiding Bishop and Council of the Protestant Episcopal Church."

**ARTICLE II****OBJECT**

The object of this organization shall be to enlist the women of the diocese in active service for making the Christ known throughout the world. This object shall be carried out through Missions, Religious Education, and Christian Social Service; and by means of faithful and definite prayer, study, systematic giving of means and service, and by finding recruits for the mission fields.

**ARTICLE III****MEMBERSHIP**

The membership of this organization shall be composed of all parish and mission branches within the diocese.

**ARTICLE IV****OFFICERS**

SECTION 1. The officers of this organization shall be: a President, a Vice-President, a Secretary, a Treasurer, a Secretary of the Department of Education, a Secretary of the Department of Social Service, and a Custodian of the United Thank Offering.

SEC. 2. These officers, with the District Chairmen, shall constitute the Executive Committee, and shall meet in September and March of each year.

## ARTICLE V

## DUTIES OF OFFICERS

SECTION 1. The President shall have general oversight of all work and shall appoint all committees unless otherwise provided for. She shall preside at all meetings and at every annual meeting shall address the Auxiliary—outlining the work for the year ahead.

SEC. 2. The Vice-President shall act in the absence of the President and shall have charge of the Supply Department.

SEC. 3. The Secretary shall record the proceedings of the Diocesan branch, carry on all necessary correspondence, prepare and have printed the Annual Report, and at each annual meeting shall make report of the past year's work of the branch.

SEC. 4. The Treasurer shall receive and disburse all money except the United Thank Offering, and shall make report of same at the annual meeting. She shall, at the end of every fiscal year, turn over accounts to a public auditor for verification, and shall publish his statement along with her report in the Annual Report. The Treasurer shall act as chairman of the Committee on Credentials.

SEC. 5. The Secretary of the Department of Education shall have charge of the educational program of the branch.

SEC. 6. The Secretary of the Department of Social Service shall have charge of the social service work of the branch.

SEC. 7. The United Thank Offering Custodian shall receive the United Thank Offering in March and September and shall deposit same in a savings bank or immediately remit to the Treasurer of the Presiding Bishop and Council for investment. The Custodian shall make every effort to secure the interest and a contribution from every woman in the Diocese.

## ARTICLE VI

## TERM OF OFFICE

SECTION 1. The President, Vice-President, Treasurer, Secretary of the Department of Education, Secretary of the Department of Social Service, and United Thank Offering Custodian

shall be elected for a term of three years; the President to be elected at the second annual meeting after the Triennial; the Treasurer, Secretary of the Department of Education and Secretary of the Department of Social Service the third meeting after the Triennial; and the Vice-President and United Thank Offering Custodian the first meeting after the Triennial. No officer shall be eligible for two consecutive full terms. Vacancies occurring during the year shall be filled by the Executive Committee.

SEC. 2. The Secretary shall be appointed by the President for one year.

## ARTICLE VII

### ELECTIONS

SECTION 1. For the election of the President: The President shall appoint, at the annual meeting, a committee of three to receive nominations. Nominations must be in writing, except any that may be made from the floor at the time of election, and from these written nominations the committee shall present three names. If there is no majority on the first ballot, all names shall be dropped but the two having the largest number of votes.

SEC. 2. Any delegate may nominate, but a branch may cast but one vote. A branch to have voting privilege must have paid the Central Fund. No vote shall be cast by proxy. All elections shall be by ballot.

SEC. 3. All other elective officers shall be chosen according to the manner prescribed for the election of the President.

## ARTICLE VIII

### FINANCE

SECTION 1. The Treasurer shall send to every branch, two months before the annual meeting, the following sliding scale: Class A, \$600; Class B, \$500; Class C, \$400; Class D, \$300; Class E, \$200; Class F, \$100; Class G, \$50; Class H, \$25;

Class I, \$10; Class J, \$5; and at the annual meeting each branch shall designate the class which it decides to enter.

SEC. 2. The United Thank Offering, money for Supply Department and Central Fund shall be in addition to the contributions made according to this sliding scale.

SEC. 3. From the amount contributed according to this scale the Treasurer shall turn over one-half to the Nation-wide Campaign Fund—not to be counted on the parish pledge unless so requested—and one-half to such specials as the parish branch may designate.

## ARTICLE IX

### AMENDMENTS

This Constitution may be amended at the annual meeting of the Diocesan branch by a two-thirds vote of the duly appointed representatives, due notice of the proposed amendments having been given to every branch at least one month before the annual meeting.

### BY-LAWS

The time and place for the annual meeting of two and a half days shall be approved by the Bishop and the Executive Committee.

1. The Order of Business for the annual meeting shall be arranged by the Executive Committee.

2. Each Parish Branch shall be represented by the President of the Branch and one delegate, (appointed by the President, or elected by the Branch) for 25 members or under. Each additional 25 members shall be entitled to an additional delegate.

3. Each branch shall be assessed twenty-five cents per member to provide for Provincial expenses, printing, postage, stationery, and traveling expenses of speakers; \$50 shall be set aside from this fund for the President's traveling expenses. All offerings at district meetings and institutes, except when given for some special object, shall be added to this fund, which shall be known as the Central Fund.

4. The annual report of the Church Periodical Club may be printed in the Annual Report.

5. One-fourth of the branches having the right to vote shall constitute a quorum at the annual meeting. Three members shall constitute a quorum at the Executive Committee meetings.

6. These By-Laws may be altered or amended by a majority of the delegates to any annual meeting.
