



FOREWORD

IN ANTICIPATION OF THE TRIENNIAL CONVENTION, TO BE HELD IN WASHINGTON, OCTOBER, 1928

To the Woman's Auxiliary:

I am anxious that all the members of the Woman's Auxiliary should be advised of the great importance of preparing for the General Convention which is to meet in Washington in October, 1928. If we are to make it an occasion of great spiritual power, we cannot begin too soon to prepare for it. I feel very strongly that the officers and members of the Auxiliary will contribute a large part towards making this Convention all that it should be.

The Woman's Auxiliary is one of the most vital and important elements in a great General Convention, and I am hoping and praying that in the approaching Convention we may register a higher mark of spiritual attainment, and thereby give a freshened impulse to the great work which the Auxiliary is doing.

It is anticipated that this Convention will bring together upwards of about twenty thousand people. One feature that will prove most interesting and practical in entertaining the hosts of people who will be with us is the rapid development and completion of the extensive Bishop's Garden. The All Hallow's Guild supported by the Bishop's Guild and interested individuals, are carrying to consummation plans that will make this garden the most perfect place that could be desired for great outdoor social gatherings. Two objectives that are worthy of our most serious consideration have to do with the spiritual and fraternal aspects of the Convention and its allied bodies.

I am asking every officer and member of the Auxiliary, indeed, every interested member of our Church to pray and work, to the end that the Convention of 1928 may prove to be the greatest in the history of the Church.

RESOLUTIONS ADOPTED AT THE ANNUAL MEETING, 1928

Resolved, That the Woman's Auxiliary of the Diocese of North Carolina hereby record its sense of loss in the death of the Rt. Rev. Henry Beard Delany, D.D., Suffragan Bishop of the Diocese. In his life, work, and character Bishop Delany has left to his own race and to all Christian people, a noble example of devotion to his Master, fidelity to his Church, usefulness to society, integrity in service, and the memory of a name of singular spiritual beauty.

Resolved, That the Woman's Auxiliary of the Diocese of North Carolina, realizing the importance of completing the Bishop Rowe Foundation, requests each Parish to send before July 1st, 1928, contributions of \$2.00 or more to this fund.

Resolved, That a minimum of \$200.00 be sent during the year 1928, to Miss Mary Wood McKenzie, N. C. Missionary to Liberia, to be used at her discretion, as a token of love and appreciation.

Resolved, That a Special for the Fall of 1928, shall be the procuring of funds for the Hodgson-Emerald Hospital at Sewanee, Tenn. This is a Provincial Objective.

RECOMMENDATIONS

That parishes and individuals respond liberally to the appeal from Sanford for help in building a church.

That the Appalachian Training School at Penland, deserves the interest and aid of the Woman's Auxiliary, and that funds be procured for this purpose.

All money except that for Box Work and the United Thank Offering must be sent to Miss Nan G. Clark, Tarboro, N. C. Where an exception to this is contemplated, specific instructions will be sent to the Parish Presidents.

MINUTES OF THE ANNUAL MEETING

The forty-sixth annual meeting of the Woman's Auxiliary to the National Council of the Diocese of North Carolina was opened with the presentation of a pageant "Corporate Gift," in the parish house of Calvary Church, Tarboro, April 17th, 1928, at 7:30 P. M.

At 8:30 Evening Prayer was said in Calvary Church, when Bishop Penick extended greetings from the Diocese and Rev. Bertram E. Brown welcomed the Auxiliary to Calvary Parish. Mr. Brown presented Miss Grace Lindley, Executive Secretary of the National Council, who made the address of the evening.

WEDNESDAY, APRIL 18

On Wednesday, April 18th, at 7:30, early Communion was celebrated by Bishop Penick. The United Thank Offering was presented at this service, followed with the commemoration service for the departed.

At 9:45, the Convention was called to order by the President, Mrs. F. S. Spruill. Devotional exercises were conducted by Rev. C. E. B. Robinson of Tarboro. Following this Miss Rena H. Clark, of Tarboro, delivered the address of welcome, to which Mrs. T. W. Bickett responded. Miss Kate Cheshire thanked Mrs. Bickett for her beautiful tribute to Bishop Cheshire, and to his father, the Rev. Joseph Blount Cheshire, D.D., long a rector of Calvary Church.

The Convention then heard the address of the President, Mrs. F. S. Spruill.

The reports of the Secretary, Mrs. E. S. Boice, the Treasurer, Mrs. R. B. Davis and the U. T. O. Custodian, Mrs. W. D. Burwell were then presented, following which Miss Margaret G. Weed, Diocesan representative for the Fourth Province spoke on the U. T. O.

The report of the Supply Department was then presented by Mrs. R. H. Lewis, the report on Christian Social Service by Mrs. R. D. Bulluck, and the report on Religious Education by Mrs. H. DeC. Mazyck.

Rising votes of thanks and appreciation were extended the Diocesan officers for their reports and good work done.

An invitation to meet in Raleigh next year was extended through the Lucy Pittenger Branch of the Church of the Good Shepherd. This invitation was accepted.

Miss Emma Hall reported for "Advance Work and Corporate Gift."

The Auxiliary was delighted to have as its guests, Mrs. Whichard, Diocesan President of Southern Virginia, and Mrs. Staten, former President of the Diocese of East Carolina, both of whom brought greetings to the Auxiliary.

Miss Emma Hall and Mrs. E. S. Boice were appointed to send a loving message to Bishop Cheshire regretting his inability to be with us during Convention, and a telegram of sympathy to Mrs. Henry B. Delany.

At 12 noon, Noonday Prayer and Meditation were held by Bishop Penick.

A short time before the lunch hour group conferences were held.

A delightful luncheon was served in the parish house of the Presbyterian Church at 1:10 P. M.

At two o'clock the business meeting was called to order by the President. Fifty branches responded to roll call. The Credentials Committee reported that all of these were entitled to vote.

In the absence of Mrs. Gilbert Hay, Mrs. Bonner brought greetings from the Girl's Friendly Society. Miss Emma Hall

brought greetings from the Order of the Daughters of the King, and Bishop Penick explained the work of this organization.

The Diocesan Objectives were then taken up:

Mrs. Purcell in behalf of the Thompson Orphanage asked that each Branch clothe one orphan.

Mrs. Henry G. Cooper in behalf of the N. C. C. W., asked that \$1,000 be given for the chapel there. \$519 has already been raised.

The Rev. Warren W. Way made a plea for more students at Saint Mary's.

In the absence of Mrs. Frank Challen, who was to have talked of the work of the Y. P. S. L., Bishop Penick spoke in behalf of the two church camps, asking that we encourage the young people to attend these camps.

Miss Mary Hinton spoke on Offering of Life.

Miss Reba Shields read the report of the Treasure and Trinket Fund, in the absence of Mrs. Alston.

Mrs. Reginald Mallett read report on Prayer Partnership Plan, in the absence of Mrs. Gaul.

Mrs. Henry presented a report of the Church Periodical Club, in the absence of Miss Mary Hoke.

Mrs. W. W. Way gave a report on Inter-racial Work, which was followed by a message from the Diocesan Colored Auxiliary, delivered by Mrs. M. M. Weston.

This completed the business for the afternoon, the meeting adjourned.

Between the hours of 5 and 6 Miss Kate Cheshire was at home to all delegates and friends.

Eight P. M. Evening Prayer was held, the Rt. Rev. Philip Cook, D.D., Bishop of Delaware, delivering a forceful and inspiring address.

Evening session convened at 9 P. M. Recommendations for revision of the Constitution were presented by the Committee chosen by the Executive Council, consisting of Mrs. Mazyck, Mrs. Burwell and Mrs. Garibaldi, and on motion of Mrs. Platt were approved unchanged.

Mrs. Rawlings moved that the Diocesan Officers be allowed to vote. Unanimously carried. Mrs. J. S. Holmes moved that this go into effect immediately. Carried.

The following Diocesan officers were elected: Miss Nan G. Clark for Treasurer, Mrs. G. B. Lewis as Social Service Secretary and Mrs. W. W. Way as Educational Secretary.

Mrs. Ralph Coit of Greensboro was nominated for Woman Representative on Diocesan Council.

Delegates to the Triennial are as follows: Mrs. F. S. Spruill, Miss Rena Clark, Mrs. W. D. Burwell, Miss Emma Hall, Mrs. W. W. Way. Alternates: Miss Sally Dortch, Mrs. Joseph Garibaldi, Mrs. H. G. Cooper, Mrs. Herriot Clarkson, Mrs. I. W. Hughes.

The newly elected officers were installed with appropriate prayers by Rt. Rev. Edwin A. Penick.

The meeting adjourned at 11:45 P. M.

THURSDAY, APRIL 19

Thursday morning 7:30, Holy Communion was celebrated by Bishop Darst.

Nine-thirty A. M. Devotional exercises were conducted by Rev. C. E. B. Robinson of Tarboro. Following this came reports of District Chairmen: Mrs. E. F. Guilford for Forsyth-Rowan; Mrs. Wm. J. Gordon for Guilford; Mrs. Joseph Garibaldi for Mecklenburg; Miss Easdale Shaw for Richmond; Miss Rena Clark for Edgecombe; Mrs. I. W. Hughes for Granville; Mrs. Collier Cobb for Orange; Mrs. J. S. Holmes for Wake.

Miss Mary A. Hill, a returned missionary from China, gave a most interesting and enjoyable talk on her work there.

Mrs. Gordon, Mrs. McNair, Mrs. Bulluck, Mrs. Davis, Mrs. W. W. Simms, Mrs. Mazyck, each reported favorably concerning the Group Conferences.

The Chairman of the Resolutions Committee read the resolutions that had been presented, and moved that these resolutions be adopted. Carried.

At Mrs. Spruill's request one Provincial matter was presented by Mrs. Bickett. Help for the Hodgson-Emerald Hospital at Sewanee. Mrs. Bickett made a plea for the Appalachian Training School at Penland. A request for a nurse was made.

Mrs. M. S. Clifton, Chairman of the Courtesy Committee offered this resolution:

Madam President and Ladies of the Convention:

What shall we say for all the blessings which we have received during these wonderful days in Tarboro? How shall we adequately express our appreciation for all the good things that have come to us in this fortunate Parish? Truly we have had with us sainted spirits of the past and present during our deliberations. Was ever the Woman's Auxiliary so blessed? Three Bishops, five Priests, three past presidents of the Auxiliary. We have had the comfortable and the uncomfortable Gospel preached.

Spring brought us to you with sunshine and flowers and as we walk around this ancient churchyard we are more impressed with the beautiful resurrection of our Lord.

We have enjoyed your homes, your hospitality, your beautiful Parish House, erected as a memorial to our dear Bishop's father, who served so faithfully as Rector of this parish for fifty years. Your choir, but most of all your beautiful services in your Church, warm with the sainted spirits whose loving hands framed it all.

Our evening together at the home of Miss Kate Cheshire, will live in our memories always.

We have felt the spiritual blessing of the constant oversight of Bishop Penick as well as the indispensable help and guide he has been. The only note of regret we have had is that our dear Bishop Cheshire could not be with us in person.

We want to acknowledge with true appreciation the full and active accounts of this Convention as reported in the local press.

We extend our thanks to the ladies of the Presbyterian Church for the delightful luncheons served.

We must all return home and put a thank offering into our little Blue Box for all the blessings we have received. May God bless us every one.

The Committee from the Woman's Auxiliary on the Legislative Council, Miss Sallie Dortch of Raleigh, Chairman, is standing for the things that are uplifting—For the School for delinquent girls at Efland; for the Farm Colony for Women; for adequate provision for the feeble-minded of both races.

After the most inspiring closing message by the Rt. Rev. Thos. C. Darst, Bishop of East Carolina, there was a re-dedication of the women of the Church as follows:

THE RE-DEDICATION

Realizing that only through personal dedication to Jesus Christ, our Lord, can we hope to bring to fruition our human endeavors, we re-dedicate ourselves to the service of our Lord Jesus Christ, to making the strength of our deeds the measure of our Faith; to a sincere and simple effort in our daily living to follow with humility the example of our Saviour.

The meeting adjourned to convene April 9, 1929, at the Church of the Good Shepherd, Raleigh, N. C.

ADDRESS OF PRESIDENT

Friends:

This is my first opportunity to express my appreciation to you for giving me the privilege of serving the Auxiliary as President. Especially do I thank you for your sympathetic coöperation.

The work has not been borne upon the shoulders of merely a few. The duties of the President have been greatly lightened, and the efficiency of the office increased, by the cordial support and cheerful participation in the work of the members of the Auxiliary.

It is unnecessary to review the work of 1927 in detail, as this will be done by the chairmen of the various departments. This has been a year of progress. More funds have been disbursed. Women are more eager to serve. Wider interest is manifested in study classes. Replies to letters are more prompt. Greater efficiency along general lines is evident. *One* thing yet is desired—a greater willingness to accept parish offices and responsibilities. Every woman has qualifications for some constructive work. Not the talents we have *not*, but those that we *have*, should be the measure of our fitness for leadership.

In a letter from Bishop Freeman, we are urged to realize the great importance of preparing for the General Convention to meet in Washington in October.

The message of the little Blue Box must be taken everywhere, culminating in that triumphant service of the United Thank Offering on October 11th at the great Triennial.

Dr. Franklin reports a serious decrease in the pledges of the Dioceses to the Church for 1928. As an Auxiliary we are "dedicated to the payment in full of all General Church Quotas." This means individual sustained work, and the burden of this deficit should rest on our hearts, until it is paid.

The work of the young people must receive our sympathetic and loving help.

In 1919 a fund was started, but not completed, to commemorate the twenty-fifth Anniversary of the Consecration of Bishop Rowe of Alaska. This fund is known as the Bishop Rowe Foundation. An effort is being made to complete this fund by October, 1928, and we are asked to make this a Summer Special. Bishop Rowe has refused to tread the soft paths of life, and for thirty years or more has traveled by water and sky, and with his dog trains through ice and snow. The details of this activity will be brought out at this meeting.

The value of Summer Conferences cannot be over emphasized. One or more women should attend some Conference from each parish.

Our Church Periodicals should receive more generous support. I venture the assertion that there is not a home in the Diocese without a secular paper, but how few feel the need of the literature of the Church.

Rural work must be stressed.

May each of us assume a personal responsibility for this great work, and show the eagerness and enthusiasm for serving our Blessed Master, that is justified by the magnitude of the task.

The Auxiliary is well organized—but there is a danger that we, to whom is committed the responsibility of leadership, become so engrossed in *making plans*, that the *machinery* of our work may too greatly absorb us. I pray that there may be removed from our lives every hindrance to the manifestation of God's redeeming love and power.

May this annual meeting be one of great joy and inspiration, and while we meet for conference and legislation, may we also meet for renewed consecration and instruction, knowing that if we are doing God's bidding, He will give us power to perform the same.

The Secretary has endeavored to carry out all requests from the President and to perform promptly all duties required of her.

I cannot close my report without thanking you for your coöperation, and without expressing the pleasure that has been mine in serving you this year.

This is my third and last report as your Secretary of Christian Social Service, and it is a pleasure to present an encouraging outlook. We have stumbled many times but generally upward and with progress.

Seven Districts have sent full and comprehensive reports, and a partial report has come from the Eighth District.

Around \$1,200.00 has been expended by the Diocesan Treasurer, an increase of \$300.00 over last year.

The Thompson Orphanage, our Diocesan Institution, is listed by the State Board of Charities and Public Welfare as one of the best child caring institutions in the State. May our acquaintanceship and interest in the Orphanage continue to grow from year to year.

A detailed report of each branch is in my hands, but expense and shortness of time prevent report of same here.

The work has consisted chiefly of poor relief, religious services in county homes, jails and prison camps, public welfare, community uplift and education, carried on by varied programs suited to individual needs of each branch.

I wish to thank you all for your patient and helpful service and to assure you of my abiding interest always.

REPORT OF RELIGIOUS EDUCATION

For the past three years I have led the department of Religious Education; and it has been my great privilege to see the work grow from small, listless beginnings to great, enthusiastic proportions. The women of the Diocese are alive at last to the fact that "Knowledge is Power."

They are eager to see that every woman in the Diocese of North Carolina shall know right things, in the right way.

Seventy-one parishes and missions, out of a possible 82, have done some type of active educational work; 37 of these holding actual discussion groups. Five Districts, out of a possible 8, have reported 100 per cent in religious education—that is every parish or mission in the five Districts doing active educational work.

I held 1 Diocesan Institute, and 9 normal classes.

Fifteen years ago the Woman's Auxiliary held its annual meeting in Calvary Church, Tarboro. This sum was the gift of forty-six of the sixty-six branches then in existence. Compare these figures with those in the above report. In 1927 eighty-five branches gave \$6,786.68. Thus we realize how wonderfully the offering has grown, and surely this increase in givers and gifts must mean a growth in interest and sympathy for the work.

This record is an incentive for us to go forward, laboring more diligently to reach the goal towards which the Woman's

Auxiliary is striving, namely that the United Thank Offering shall represent the prayers and gifts of *every* woman and girl in the church, for work by women among women.

Most of the women know the purpose of the offering and all are aware of the needs in the mission field.

What has been our share, through the work of the United Thank Offering, in meeting these needs? Representing us in the field are more than two hundred United Thank Offering missionaries whom we are pledged to support, pledged to stand behind with our prayers and gifts. And these gifts and prayers are the measure of our gratitude for God's blessings.

The little Blue Box is the approved method by which the women take part in the work of the United Thank Offering, and some one has said that every box which is used conscientiously stands for a gain in the spiritual life of the Church, greater and more precious out of all proportion in the sight of God, than anything the box itself may contain.

During these few months before the Triennial meeting, let us give this work a more serious consideration, a more prayerful and thankful recognition of God's mercies; and let our Blue Boxes receive the expression of this thankfulness. Gathered in such a spirit, our Triennial gifts will be truly

CONVOCATION OF RALEIGH**Reports of District Chairmen****DISTRICT OF EDGECOMBE**

In this "District" there are five counties—Northampton, Halifax, Edgecombe, Nash and Wilson, 17 branches of the Auxiliary, 579 members.

The year 1927 has been one of stupendous activity, due to the spiritual impetus gained in preparation for the Bishops' Crusade. The outward and visible signs of this are clearly shown by the following: The reorganization of the branch at Spring Hope; the increasing number that observed Intercessory Days and made Corporate Communions; \$1,273.99 for the United Thank Offering; fifty per cent increase in the Supply Department; Christian Social Service and Religious Education are now vital factors; our Prayer Partner, Miss Helen Disbrow of Kyoto, Japan, is constantly brought before our hearts and minds, and a fund for a piano for her has been started; a wonderful response to the Pledge Cards and to special appeals, the complete furnishing of a room at Patterson School.

The two District meetings, Roanoke Rapids in May, and Enfield in October, are the outstanding features. They are the most convincing evidence of the spiritual and material development of the Auxiliary in the District of Edgecombe.

DISTRICT OF GRANVILLE

The District comprises the following towns: Oxford, Franklinton, Louisburg, Ridgeway, Townsville, Middleburg, Warrenton, Littleton and Henderson.

Two District meetings have been held—one in Louisburg and one in Townsville—delightful socially and very helpful spiritually.

DISTRICT OF ORANGE

The District of Orange has 10 branches with some 240 women interested. The Supply Department reports over \$450 in pledges and boxes valued, about 400 garments cut and one dozen garments made. Social Service shows fine coöperation with organizations already at work—Welfare Department, King's Daughters, Parent-Teacher Associations, Red Cross (for flood sufferers), Near East (clothing)—in addition to Christmas Cheer, bags for soldiers, visits to county homes and jails, two Christmas trees, assistance for needy families, aid to Valle Crucis and the Thompson Orphanage. There was a good response to special appeals—Miss Gordon's salary, Patterson School, Woodleaf, blankets for Penland School. Several branches tell of flowers and cards for the sick, parties for the Y. P. S. L., choir supper, Parish entertainments. Our Secretary of Religious Education reports this District as 100 per cent active, showing that each branch is following suggested courses of study or reading. The U. T. O. is over \$500. All money handled in the District is well over \$3,000.00. Building funds for three churches have received contributions. Repairs on one rectory were \$500. Prayer Books and Hymnals were bought. A number of Intercessory Days were observed, also Corporate Communions and one branch joined in the World Day Prayer for Missions. A splendid meeting was held at St. Phillip's Church, Durham, on October 25th, 1927.

DISTRICT OF WAKE

Number of branches, 9; members, 396 (a gain of 18); cash realized for all purposes, \$5,858 (a gain of \$158). Boxes valued at \$991.44.

The reports reveal a better grasp on the part of individual members of what the Auxiliary stands for. Leaders have emerged; others are in the making. Work in the "Five fields" is becoming the ideal of branch after branch. While maintaining or even raising the standard of pledges to the Auxiliary, an aroused social conscience is expressing itself in many worth-while ways. Christ Church Service League is notable for her work in behalf of St. Saviour's Mission

and Thompson Orphanage (\$1,590). The two Good Shepherd branches have each gone a step higher in the Ascending Scale. St. Saviour's is deriving inspiration from a carefully planned Year Book; she is ranked highest in attendance at the spring meeting at Erwin, and was a charming hostess to the fall meeting. Wake Forest has made her best showing this year. Smithfield and Erwin excel in their local Social work, but respond generously, as does St. Mary's also, to the Diocesan obligations and special calls. There's need for some of us to move to Selma to live, lest the two or three faithful and lonely ones there grow fainthearted.

Reports of District Chairmen

DISTRICT OF FORSYTH-ROWAN

The Woman's Auxiliary of Forsyth-Rowan during 1927, has gone forward in the work with its customary zeal. This District was honored in having the Annual Diocesan meeting of the Woman's Auxiliary held at St. Luke's, Salisbury. Two splendid District meetings were held at Advance and Cooleemee. At Cooleemee, a Blue Box Pageant was successfully given by women of Salisbury branches. Each department has moved forward in its respective lines, and the secretaries have done fine work. Of especial note is that of the Prayer Partnership Correspondent, whose efforts have produced splendid results.

The United Thank Offering was good.

The Supply (Box) Department work valuation amounts to nearly \$1,300.00. Generous contributions were made to the Christmas Cheer and other emergency funds.

Work was excellently done for the Chapel at N. C. C. W.

Our principal Christian Social Service work is again the Valle Crucis scholarship, but outstanding activities of certain branches, both small and large, merit special comment, particularly that of St. Paul's, Winston-Salem; Grace, Lexington; and St. Paul's, Salisbury. The efforts and sacrifices of each branch brought a broader conception of the privileges and opportunities of this work and we shall strive for greater achievements. About seven thousand dollars was contributed to all causes.

Branches either sent a delegate to one of the Summer Conferences or helped to do so, and all branches held study classes during Lent, subject being, "The Church Awake."

The United Thank Offering amounted to over \$530.00.

REPORT OF DISTRICT OF RICHMOND

CONSTITUTION**ARTICLE I****NAME**

The name of this organization shall be "The North Carolina Branch of the Woman's Auxiliary to the National Council."

ARTICLE II**OBJECT**

The object of this organization shall be to carry out in the Diocese of North Carolina the three great aims of the Church: Extension of the Kingdom, Religious Education, and Christian Social Service.

ARTICLE III**MEMBERSHIP**

All women of the Diocese, by virtue of their Baptism, are eligible for membership in the Woman's Auxiliary.

ARTICLE IV**OFFICERS**

SECTION 1. The officers of this organization shall be: a President, a Vice-President, who is also Secretary of the Supply Department, a Secretary, a Treasurer, a Secretary of the Department of Religious Education, a Secretary of the Department of Christian Social Service, and a Treasurer of the United Thank Offering.

SEC. 2. These officers, with the District Chairmen, shall constitute the Executive Committee and shall meet twice a year, at the call of the President.

ARTICLE V**DUTIES OF OFFICERS**

SECTION 1. The President shall have general oversight of all work, and shall appoint all committees not otherwise provided for. She shall preside at all meetings, and at every annual meeting shall address the Auxiliary.

SEC. 2. The Vice-President shall act in the absence of the President, and shall have charge of the Supply Department.

SEC. 3. The Secretary shall record the proceedings of the Diocesan Branch, carry on all necessary correspondence, prepare and have printed the annual report, and at each annual meeting shall make a report.

SEC. 4. The Treasurer shall receive and disburse all money except the United Thank Offering and Box Work money, and shall make report of same at the annual meeting. At the end of every fiscal year the Treasurer's accounts shall be verified by a public auditor. The Treasurer's report as audited shall be published in the Annual Report. The Treasurer shall act as Chairman of the Committee on Credentials.

SEC. 5. The Secretary of the Department of Religious Education shall arrange two Institutes each year before Advent, one to be held in the Convocation of Raleigh and one in the Convocation of Charlotte, and shall carry out the Educational program provided by the National Council.

SEC. 6. The Secretary of the Department of Christian Social Service shall carry out as nearly as possible the suggested program of the National Council.

SEC. 7. The Treasurer of the United Thank Offering shall receive the United Thank Offering in March and September; and shall deposit same in a Savings Bank, or immediately remit to the Treasurer of the National Council for Investment.

ARTICLE VI

TERM OF OFFICE

SECTION 1. All Diocesan Officers shall be elected for a term of three years; the President to be elected at the second annual meeting after the Triennial; the Treasurer, Secretary of the Department of Religious Education and Secretary of the Department of Christian Social Service the third meeting after the Triennial; and the Vice-President, and United Thank Offering Treasurer the first meeting after the Triennial. No officer shall be eligible for two consecutive terms. Vacancies occurring during the year shall be filled by the Executive Committee.

SEC. 2. The Secretary shall be appointed by the President for one year.

ARTICLE VII

DISTRICTS

(a) For effective service the Diocese shall be divided into Districts.

(b) Each District shall meet twice a year.

(c) A District shall be under the direct supervision of a Chairman, duly elected by her District for a term of three years.

ARTICLE VIII

ELECTION OF DIOCESAN OFFICERS

SECTION 1. The President shall appoint a committee of three at the annual Convention to receive nominations. Nominations may be in writing or from the floor. All names shall be presented to the Convention. If there is no majority on the first ballot, all names shall be dropped but the three having the largest number of votes.

SEC. 2. Any delegate may nominate, but a branch may cast but one vote. A branch to have voting privileges must have paid the Central Fund. No vote shall be cast by proxy. All elections shall be by ballot.

SEC. 3. All members of the Executive Committee may vote independently of their branches.

ARTICLE IX

FINANCE

SECTION 1. In the fall the Treasurer shall send to every branch the following *ascending scale*, and each branch shall designate the class which it desires to enter: \$5 class, \$10 class, \$15 class, \$20 class, \$25 class, \$35 class, \$50 class, \$75 class, \$100 class, \$150 class, \$200 class, \$250 class, \$300 class, \$350 class, \$400 class, \$450 class, \$500 class, \$550 class, \$600 class.

SEC. 2. The United Thank Offering, money for the Supply Department, and the Central Fund, shall be in addition to the contributions made according to the ascending scale.

SEC. 3. From the amount contributed according to this scale the Treasurer shall turn over *one-half* to the *Forward Movement Fund*, and one-half to such specials as the parish branch may designate.

ARTICLE X**AMENDMENTS**

This Constitution may be amended at the annual meeting of the Diocesan Branch by a two-thirds vote of the delegates, due notice of the proposed amendments having been given to every branch at least one month before the annual meeting.

BY-LAWS

The time and place for the annual meeting shall be approved by the Bishop and the Executive Committee.

1. The Order of Business for the annual meeting shall be arranged by the President and the Executive Committee.
2. Each Parish Branch shall be represented by the President of the branch and one delegate (appointed by the President, or elected by the branch) for 25 members or under. Each additional 25 members shall be entitled to an additional delegate.
3. Each branch shall be assessed twenty-five cents per member, to provide for Provincial expenses, printing, postage, stationery, and traveling expenses of speakers; \$50 shall be set aside from this fund for the President's traveling expenses. All offerings at district meetings and institutes, except when given for some special object, shall be added to this fund, which shall be known as the Central Fund.
4. One-fourth of the branches having the right to vote shall constitute a quorum at the Annual Meeting. Five members shall constitute a quorum at the Executive Committee meetings.
5. These By-Laws may be altered or amended by a majority of the delegates at any Annual Meeting.
