## PRESIDENT'S ADDRESS

---

Quietly but surely there has been an advance this past year along the lines of Missionary work done by the women of North Dakota. Considering that our Parish and Mission Guilds are obliged to contribute so largely to the support of their own home services, and that the Guild members must necessarily also be the Auxiliary members, it seems to me best, for the present at any rate, not to increase the number of branches of the Auxiliaries, but for each Guild to do its share in the work imposed upon us.

The summary of the year's work will be found in the reports. They show a decided increase in giving and representation. More than the gain in money has been the growing sense of responsibility, a willingness to share in our obligations to the Board of Missions.

Last fall our President visited eight Missions: Langdon, Park River, Larimore, Rugby, Towner, Minot, Lakota and Grand Forks; introduced seven birthday boxes, and obtained new subscriptions for forty-four copies of the Spirit of Missions. Of this number seventeen were introduced into as many Guilds, and therefore within the possible reach of two hundred and eighty-three members.

I am pleased to report that in several of these guilds some portion of the meetings has been given to the reading of this magazine. I trust that in every Parish and Mission this will form a feature of its work. In this way it is hoped more interest will be taken in Missions, and that each woman reading it will have a clearer understanding as to what the term "General Missions" really means.

The United Offering from North Dakota has never been what it should be. It is now on a more systematic basis, and where it is not possible to introduce the individual boxes, the birthday box will be found convenient. Each custodian of a box is expected to send the contents each year, September 1st, to the Treasurer in Fargo. This offering is not counted on the apportionment, nor is it made in

payment of any pledge. It goes as a free will contribution to the Thank Offering of the Women of the Church and is presented at the meeting of the General Convention.

There has evidently been some misunderstanding in certain quarters as to the "Annual Dues." These, which are one dollar for each Guild or Auxiliary, are levied for the purpose of paying for necessary printing, such as circulars, notices and reports, and for defraying, in whole or in part, the expenses of delegates to the General Missionary Meetings of the Sixth Department, such as the one to be held in Minneapolis next October. I would suggest that a report of the past year's work be printed and copies sent generally to the women of the Church in North Dakota. It is hoped that during the coming year much interest will be awakened in the Junior Branch.

The opportunity of a new year is before us. Let us all strive, not as Auxiliaries alone, or Guilds alone, but as co-workers in a great cause, to accomplish more than has ever been done before for the Missions of the Church.

#### OBJECT OF THE UNITED OFFERING OF 1907

Resolved: That the United Offering of 1907 be given to the Board of Missions, for woman's work in the Domestic and Foreign fields; including the training, sending and support of woman workers, also the care of such workers when sick and disabled; this to be interpreted to include Brazil, Haiti, Cuba and Mexico; but that a sum not exceeding \$10,000 be devoted to some building, or extension of the same, preferably connected with woman's work, to mark the United Offering of 1907 and to be begun in that fiscal year, such building to be approved by the Board of Missions on the recommendation of the General Secretary and the Secretary of the Woman's Auxiliary.

## REPORT ON CHURCH HALL AT VALLEY CITY

The Episcopal Hall at Valley City, an institution started as a home for young women students attending the State Normal School, went into operation June 8, 1905. The use of the building was secured for a rental of \$35.00 per month, and those responsible for the venture were given an option on the same for one year.

From the first it was hoped that the undertaking might prove such a success as to warrant the purchasing of the building for permanent use in this way. This hope has, we believe, been realized, for during these first eleven months the Hall has earned a little over \$500 above all expenses.

Those accommodated at the Hall have been regular students and teachers at the Normal School. The number has averaged over twenty, and many more have applied for admission than could be received.

The needs of the Hall are many, but simple. At present the most pressing ones are dining room chairs, comforters, bed linen, towels, a piano, and dishes of all kinds. But most of all we ask for the co-operation and prayers of all who are interested in helping young people.

CONSTITUTION  
OF THE  
NORTH DAKOTA BRANCH OF THE WOMAN'S AUXILIARY TO THE  
BOARD OF MISSIONS

ARTICLE I

The name of this Association shall be the North Dakota Branch of the Woman's Auxiliary to the Board of Missions.

ARTICLE II—Object

The object of this association is fourfold: 1st—To diffuse Missionary intelligence; 2nd—To increase Missionary activity among the women of the District; 3rd—To unite previously existing societies in a common interest; 4th—To the formation of new societies for Missionary work and study.

ARTICLE III—Membership

All baptized women belonging to the District of North Dakota shall be considered members of this Association, and may be so enrolled by sending their names to the District Secretary and pledging themselves to the payment of twenty-five cents each year as dues. When, however, any woman is a member of a parochial branch of this Auxiliary it shall not be necessary for her to send her individual dues to the Treasurer of the North Dakota Branch; but it shall suffice that such parochial branch send one dollar per year to cover the dues of all individual members of such parochial branch.

ARTICLE IV—Officers

Sec. 1—The officers of this Association shall be a President, three Vice Presidents, Recording Secretary, Corresponding Secretary and Treasurer.

Sec. 2—The duty of the Presidents shall be to preside at all meetings, to arrange for the organization of parochial branches, and to have general charge of the work.

Sec. 3—The duty of the Vice Presidents shall be to preside in their order in the absence of the President, and to organize and superintend the Auxiliary work in the districts which may be assigned to them by the Bishop of the District.

Sec. 4—The duty of the Recording Secretary shall be to keep a correct record of all meetings, to send out notices under the direction of the President.

Sec. 5—The duty of the Corresponding Secretary shall be to conduct all correspondence and to prepare the annual report.

Sec. 6—The duty of the Treasurer shall be to receive, and under the direction of the President, disburse all funds, and to render an account of the same at each annual meeting.

#### ARTICLE V—Parochial Branches

A parochial branch of the District Auxiliary may be organized in any parish or mission in North Dakota by the consent of the rector or missionary (if there be one in charge of such parish or mission) and by consent of the District President. Each parochial branch shall pay one dollar as annual dues to the District Auxiliary. Any existing Guild or other Woman's Society connected with any parish or mission in North Dakota may become a branch of the District Auxiliary by passing a vote to that effect, and complying with the foregoing conditions including the payment of \$1.00 annual dues. It should be understood that when any existing guild or aid society becomes a parochial branch of the District Auxiliary it will thereafter endeavor to devote some portion, however small, of its funds to Missionary causes outside such local mission or branch.

#### ARTICLE VI—Reports

Each parochial branch shall make an annual report to the District President at least one month before the time of the meeting of the District Convocation.

#### ARTICLE VII—Meetings

There shall be one general meeting of this Association each year, at the meeting of the District Convocation. At all meetings each parochial branch shall have the right of representation by not more than three delegates, but only members of branches which have paid their dues, shall have the right to vote.

#### ARTICLE VIII—Rules of Parochial Branches

Each parochial branch shall adopt such rules as to duties of officers, times and places of meetings, and other necessary regulations, as it may see fit.

#### ARTICLE IX—Constitution

This Constitution may be altered at any annual meeting by a vote of two-thirds of the members present, subject to the approval of the Bishop.

## BY-LAWS

### I.

The election of officers at the annual meeting shall be by ballot.

### II.

Special meetings may be called by the President at such time and place as she may designate, for the purpose of stimulating interest in the work.

### III.

The regular order of business for the annual meeting shall be as follows:—

1. Prayer by the Bishop or presiding officer.
2. Calling the Roll.
3. Reading the minutes of the last meeting.
4. Report of the President.
5. Report of Corresponding Secretary.
6. Report of Treasurer.
7. Report of parochial branches, etc.
8. Discussion of work for the ensuing year.
9. Miscellaneous business.

### IV.

These By-Laws may be amended at any meeting, by a vote of a majority present.
