Report of Annual Meeting.

REPRESENTATIVES of the Woman's Auxiliaries and Guilds of the District of North Dakota assembled in the Parish Hall, Grand Forks, at 1:30, Monday afternoon, June 5th, 1911, for their Annual Meeting, the President, Mrs. Mann, in the chair.

The singing of Hymn 252 and prayers by the Bishop opened the meeting.

The Committee on Credentials, previously appointed by the President, and consisting of Mrs. S. Currie of Park River, Mrs. G. W. Wilson of Stanley, and Miss Gibbs of Fargo, presented its report.

After roll call, the Treasurer's report was read by Mrs. J. B. Wineman, the report of the Junior Auxiliary by Mrs. Maglone and the report of the United Offering by Mrs. Gowran, all of which were approved and accepted.

A motion was made and carried that the Treasurer send five dollars to Duluth for Department expenses at the Missionary Conference to be held in that city in September.

It was also moved, seconded and carried that the President appoint a delegate to this Conference.

Delegates from twenty-nine Guilds and Auxiliaries read the reports of their societies, seventeen Guilds not represented sending written reports to the Secretary.

A motion was made and carried that \$25.50 contributed by the Junior Auxiliaries be devoted to the endowment of a scholarship for one year in St. Mary's in the Mountains, Sewanee, Tenn.

It was moved by Mrs. Wilson and seconded by Mrs. Partridge that the surplus amount contributed for the apportionment be divided between Deaconess Routledge of Manila and Dr. Mary Glenton of Wu Chang, China, for the missionary work under their direction.

An amendment was offered by Mrs. Buxton, seconded by Mrs. Dowling that this money be given to Bishop Mann for the Indian Chapel at Dunseith.

A second amendment was proposed by Mrs. Gowran, seconded by Mrs. Burleson and Mrs. Fairchild, that the money be sent undesignated to the Church Missions House.

Upon taking a vote the first amendment carried.

The following Nominating Committee was appointed by the President: Mrs. Fairchild of Grand Forks, Mrs. Perkins of Fargo, Mrs. Wiig of Kenmare, and Mrs. Brayfield of Dickinson.

Missionary study books used by some of the Auxiliaries during the past year were offered to any Guild wishing to carry on the study of missions. Kenmare, Pembina and Dickinson accepted the offer.

A motion was made and carried that the offering of the day, amounting to \$15.10, be given to the United Offering.

After the singing of Hymn 253 Mrs. Passmore of Minneapolis gave a most inspiring talk on "Missions in the Far East," it being an account of what she saw of actual missionary work during months spent in Honolulu, Japan, China and India, and an earnest plea for more enthusiastic support for the faithful workers who are bringing about such wonderful results in the mission field. She told of the educational work, the medical work and the evangelistic work, laying particular emphasis upon the condition of women in the East and what it means to them to realize that great truth of Christianity—the value of the Individual Soul.

She urged her hearers not to be content with a narrow outlook upon life, but to live on a height, to be women of large views, women of vision eager to learn more of the great work of missions and to lend it the support of their sympathy and aid.

The report of the Nominating Committee was presented and approved, the following officers being declared elected:

It was moved and carried that Mrs. Passmore's expenses be paid. In accepting this amount Mrs. Passmore made a generous donation to the Auxiliary funds.

After a rising vote of thanks tendered to the ladies of Grand Forks for their cordial hospitality the meeting adjourned.

PRESIDENT'S ADDRESS

Dear Friends of the Auxiliaries and Guilds:

THIS meeting, to which I most heartily welcome you all, is the first to be held in Grand Forks. I am glad so many have been able to attend, and I hope you may make it the most earnest one we have ever had.

Last year your President visited Jamestown, Bismarck, Mandan, Dickinson, Beach, Oakes and Lidgerwood, covering 1045 miles.

There is one matter in particular to which I would call attention. That is the importance of sending *all* money through the General Treasurer. I find very often a local branch sends money direct to a Missionary. This is wrong; it should go first to the Treasurer, and she will forward it to the proper destination.

In spite of financial depression, there has been an increase in giving. As I said in my circular letter, I feel we should give more than has been asked of us by the Board of Missions. You know what your Auxiliary or Guild gave the preceding year, and that, if possible, it will be expected to do the same again. The increase may vary. When a Guild has a little extra money, or, when some members are interested in some special work or Missionary, it could send, through the Treasurer, any extra sum, and so help on the missionary work.

There is danger of becoming so absorbed in the needs of a Parish, that we forget we have a duty to others. We receive help freely in this District, and we should freely give to others needing help. Last year twenty-five missions paid on the Apportionment, thirty-one contributed to the United Offering, and forty-eight paid annual dues.

On the Feast of St. Michael and All Angels, September 29th, services were held in nine of our missions. This annual Consecration service at the beginning of our fall work has a tendency to unite us in greater personal efforts and to inspire us with more zeal.

In regard to the Junior Auxiliary, I want to impress upon you all the importance of teaching the young girls of the Church about missionary work. Even if the membership is small,—two or three to start with, and a Church woman to guide them,—it means preparing them for better and greater work later in the Auxiliary. For, as has been said, Junior work of today is Woman's Auxiliary work of to-

morrow. I know you will all listen with pleasure to the first report of the Juniors, and will find the advance made cause for rejoicing.

On October 8th, in Christ Church, Cincinnati, the Thank Offering of the Woman's Auxiliary was presented, the sum amounting to \$242,110.83. North Dakota contributed \$515.96. This offering is given by the women and girls of the American Church.

The Birthday Plan is the one carried on in North Dakota. It does not mean a large gift from any one person, but it should mean, a continual, increasing, giving every year, a reaching out by the privileged ones to those who do not give, an effort to interest every woman, even though living in the country or away from usual Parish life. And we hope our members will grow yearly, until all join in our working band. Our fund arises from small gifts. So do not let the fact that you cannot contribute largely, prevent your contributing at all.

Mission study work has been carried on last year in several Auxiliaries and Guilds, with the result of increasing interest. There are several courses of study which Guilds might profitably exchange, if application is made to the Secretary.

With better knowledge of missionary work comes a realization of responsibility. I want to ask if each of you is doing all she can to help on the Auxiliary or Guild, the Junior work and the United Offering? If not I trust that your presence here will result in your taking a deeper interest and devoting more of your time, thought and attention.

In conclusion I thank you for your co-operation and your willingness to follow up suggestions I have offered. Your responses have been most gratifying. I end by quoting words from the Ontario Churchman, which have also been used by the Diocesan Presidents of Minnesota and Iowa:

"There is in your Church a young lady who will join the Auxiliary or Guild if you ask her; a woman who will send her children to Sunday School if you ask her; a woman waiting to join; and still another, tender in sorrow, who will make a special offering if you ask her; a man who will become an honorary helper if you ask him; there is a man and a woman who will subscribe for a Church paper if you ask them, also for missionary papers for the children; another who will ask a friend to subscribe for them also if you ask them; a woman who will pray for mission work if you ask her; perhaps there is another who will give herself to the work if you ask her. The Master is waiting for you, and you, and you to do His work."

THE UNITED OFFERING OF 1913

RESOLVED—That the United Thank Offering of 1913 be given to the Board of Missions for woman's work in the mission field, including the training, testing, sending and support of woman workers; also the care of such workers when sick or disabled; but that a sum not exceeding \$20,000 be devoted to buildings for the use of woman workers, approved by the Board of Missions on the recommendation of the General Secretary and the Secretary of the Woman's Auxiliary.

Also that to our united gifts there shall be added our united and earnest prayers that God will put it into the hearts of many faithful women to give themselves to the work of the Master in the Mission field, or, if they cannot go themselves, to give of their substance gladly, as the Lord hath prospered them.

REPORT OF THE JUNIOR AUXILIARY

FOR THE YEAR 1910-11

CORRESPONDENCE has been had with all of the Parishes and Missions of the District wherein could be procured the name of a person to whom to write, with the result that we have active branches at Bathgate, Casselton, Devils Lake, Fargo, Grand Forks, Jamestown, Larimore and Park River. Each of these branches contributed liberally and most cheerfully toward the making up of a box of clothing and other useful articles sent to St. Mary's on the Mountain, a girls' school at Sewanee, Tenn. The contents of this box were new, the work of our young people themselves, with a little assistance from the Junior leader at each point. The box was valued at \$70.00, and we have an appreciative letter of thanks from the Sister Superior of the school. The above named branches, together with the young people of Valley City and Dickinson (which two places have as yet, we believe, no organization as an Auxiliary) have contributed toward the Junior United Offering as follows:

CONSTITUTION
OF THE
NORTH DAKOTA BRANCH OF THE WOMAN'S AUXILIARY TO THE
BOARD OF MISSIONS

ARTICLE I

The name of this Association shall be the North Dakota Branch of the Woman's Auxiliary to the Board of Missions.

ARTICLE II—Object

The object of this Association is fourfold: 1st—To diffuse Missionary intelligence; 2nd—To increase Missionary activity among the women of the District; 3rd—To unite previously existing societies in a common interest; 4th—To the formation of new societies for Missionary work and study.

ARTICLE III—Membership

All baptized women belonging to the District of North Dakota shall be considered members of this Association, and may be so enrolled by sending their names to the District Secretary and pledging themselves to the payment of twenty-five cents each year as dues. When, however, any woman is a member of a parochial branch of this Auxiliary it shall not be necessary for her to send her individual dues to the Treasurer of the North Dakota Branch; but it shall suffice that such parochial branch send one dollar per year to cover the dues of all individual members of such parochial branch.

ARTICLE IV—Officers

Sec. 1—The officers of this Association shall be a President, three Vice Presidents, Recording Secretary, Corresponding Secretary and Treasurer.

Sec. 2—The duty of the President shall be to preside at all meetings, to arrange for the organization of parochial branches, and to have general charge of the work.

Sec. 3—The duty of the Vice Presidents shall be to preside in their order in the absence of the President, and to organize and superintend the Auxiliary work in the districts which may be assigned to them by the Bishop of the District.

Sec. 4—The duty of the Recording Secretary shall be to keep a correct record of all meetings, to send out notices under the direction of the President.

Sec. 5—The duty of the Corresponding Secretary shall be to conduct all correspondence and to prepare the annual report.

Sec. 6—The duty of the Treasurer shall be to receive, and under the direction of the President, disburse all funds, and to render an account of the same at each annual meeting.

ARTICLE V—Parochial Branches

A parochial branch of the District Auxiliary may be organized in any parish or mission in North Dakota by the consent of the Rector or Missionary (if there be one in charge of such parish or mission) and by consent of the District President. Each parochial branch shall pay one dollar as annual dues to the District Auxiliary. Any existing

Guild or other Woman's Society connected with any parish or mission in North Dakota may become a branch of the District Auxiliary by passing a vote to that effect, and complying with the foregoing conditions including the payment of \$1.00 annual dues. It should be understood that when any existing Guild or Aid Society becomes a parochial branch of the District Auxiliary it will thereafter endeavor to devote some portion, however small, of its funds to Missionary causes outside such local mission or branch.

ARTICLE VI—Reports

Each parochial branch shall make an annual report to the District President at least one month before the time of the meeting of the District Convocation.

ARTICLE VII—Meetings

There shall be one general meeting of this Association each year at the meeting of the District Convocation. At all meetings each parochial branch shall have the right of representation by not more than three delegates, but only members of branches which have paid their dues, shall have the right to vote.

ARTICLE VIII—Rules of Parochial Branches

Each parochial branch shall adopt such rules as to duties of officers, times and places of meetings, and other necessary regulations, as it may see fit.

ARTICLE IX—Constitution

This constitution may be altered at any annual meeting by a vote of two-thirds of the members present, subject to the approval of the Bishop.

BY-LAWS

I.

The election of officers at the annual meeting shall be by ballot.

II.

Special meetings may be called by the President at such time and place as she may designate for the purpose of stimulating interest in the work.

III.

The regular order of business for the annual meeting shall be as follows:

1. Prayer by the Bishop or presiding officer.
2. Calling the Roll.
3. Reading the minutes of the last meeting.
4. Report of the President.
5. Report of Corresponding Secretary.
6. Report of Treasurer.
7. Report of parochial branches, etc.
8. Discussion of work for the ensuing year.
9. Miscellaneous business.

IV.

These By-Laws may be amended at any meeting, by a vote of a majority present.
