REPORT OF ANNUAL MEETING

ON MONDAY AFTERNOON, June 3rd, 1912, representatives of the Woman's Auxiliaries and Guilds of North Dakota convened at 1:30 in Gethsemane Cathedral, Fargo, for their Annual Meeting, Mrs. Cameron Mann presiding.

The meeting was opened by the singing of hymn 261 and prayers by Bishop Mann.

The Secretary then read the minutes of the meeting held in Grand Forks last June.

Mrs. Currie of Park River and Mrs. Weinrebe of Minot, having been previously appointed a Committee on Credentials, presented their report.

It was moved and seconded that all women present from the various Guilds and Auxiliaries be counted as representatives for this meeting. Carried.

The President read her Annual Address and this was followed by the report of the Treasurer, which was approved and accepted.

A Nominating Committee was appointed consisting of Mrs. Pitts, Grand Forks; Mrs. Childs, Casselton; Miss Ashbrook, Larimore; Mrs. Aldrich, Fargo; Mrs. Williamson, Lisbon.

The report of the Junior Auxiliary presented by the President, Mrs. Maglone, and the Report of the United Offering given by Mrs. Gowran were both approved and accepted.

A letter from Miss Emery was read by the President.

Miss Webster, Matron of the Church Hall at Valley City, presented the report of this institution, after which Mrs. Mann asked if any of the delegates would be willing to pledge from their Guilds the sending of a box of fruit or supplies to the Hall during the coming year. The following fifteen promised to do so: Casselton, Devils Lake, Fargo Guild, Fargo Auxiliary, Fargo St. Cecelia, Grand Forks Auxiliary, Jamestown, Larimore, Lisbon, Minnewaukan, Minot, Park River, Walhalla, Wahpeton, Williston.

The President appointed a Committee to consider the most suitable appropriation of the funds at the disposal of the meeting. North Dakota's Apportionment having been fully met the money usually set apart for this purpose was available for other uses. Mrs. Holt, Fargo; Mrs. Payne, Grand Forks; and Mrs. Stuart, Minnewaukan, comprised the Committee.

It was moved by Mrs. Gowran, seconded by Mrs. Turner that \$5.00 be sent towards expenses of the Department Conference to be held this fall at Grand Junction, Western Colorado.

The report of the Nominating Committee was then presented recommending the election of the following officers:

President—Mrs. Cameron Mann, Fargo.

First Vice President—Mrs. Currie, Park River.

Second Vice President—Mrs. Biller, Minnewaukan.

Third Vice President—Mrs. Turner, Larimore.

Secretary—Mrs. George Hancock, Fargo.

Treasurer—Mrs. J. B. Wineman, Grand Forks.

President Junior Auxiliary—Mrs. Maglone, Larimore.

Treasurer United Offering—Mrs. C. C. Gowran, Grand Forks.

When the report was given, Mrs. Mann repeated what she had already said in her Address and asked for further nominations. The names of Mrs. George Hancock and Mrs. R. J. Haxby were presented in turn, but as neither of these felt it possible to accept the honor, the office of President was not filled, the recommendations of the Committee for all other officers being approved and accepted.

Reports of the Junior Auxiliaries were read by the delegates, after which it was moved by Mrs. Currie, seconded by Mrs. Wineman that further reading of reports from the individual Guilds be postponed until after Miss Lindley's address. Carried.

The Committee on Appropriations presented its report recommending first, that \$50.00 be given to the Valley City Hall; second, that \$50.00 be given to the fund for aged and infirm Clergy; and third, that the balance, \$68.50, be sent to Alaska.

The first two recommendations were passed and the third amount was designated for use in the hospital in Alaska, where Miss Langdon is giving her services.

During the singing of a hymn a collection of \$9.47 was taken up for the United Offering.

Miss Lindley of the Church Missions House, New York City, then gave an interesting and stirring address characterizing the splendid age in which we live as one especially marked by the abundance of opportunities presented for missionary work. It is no longer needful to ask that the door of Opportunity be opened more fully but rather that the Church may be enabled to possess the field already open for her labors and to do more intensive work. Possibilities for, and need of, mission work lie at our very doors as well as in distant lands. There really should be no distinction between Domestic and Foreign Missions, as the field is one and the call as urgent in one case as in the other. Present conditions in China, Japan and India were touched upon and in closing the speaker urged a fuller realization of the spirit of consecration so beautifully expressed in the Communion Service—a spirit which will surely manifest itself in affectionate concern for those who know nothing of the blessings of the Gospel, and the helpful and uplifting ministrations of the Church.

At the conclusion of the address, announcement was made of Normal Study Classes to be conducted by Miss Lindley the following day, to which all were invited.

Mr. Two Bear, an Indian delegate to the Convocation, spoke briefly, delivering a message to the assembled women from their Indian sisters at Red Hail, in the southern part of the state.

A motion was made and carried that the Woman's Auxiliary of North Dakota send greeting to the women of Red Hail.

It was moved by Mrs. Wineman, seconded by Mrs. Rawson and Mrs. Pitts, that a vote of thanks be extended to the ladies of Fargo for their hospitality, after which the meeting adjourned.

PRESIDENT'S ADDRESS

Dear Friends and Co-Workers:

AGAIN we meet to listen to reports of what has been accomplished during the past year, and to gain courage and fervor to continue the work. There seems to be encouragement in all departments, and we must labor together to insure a constant, even though slow growth.

The past year is the first one your President has not visited some Mission in the District. This has been partly because there are no funds to defray travelling expenses. It was, however, my privilege to speak to several Auxiliaries during my stay in New Mexico, and to describe some of our methods in this District.

The annual service of intercession and preparation on St. Michael and All Angels' Day was observed in every Parish and Mission where there was a resident Priest. I hope that this service will be held each year. The total contribution, \$33.00, was given to the United Offering.

Our United Offering needs no explanation. You are all now fully aware of its idea and object. The money comes from many women not largely endowed with this world's goods, and from those who also conscientiously give towards parochial needs. To the question "What is giving"? the answer is, "It is a reaching forward of one human life to uplift another".

In regard to Mission Study and Class Work, I wish more might be accomplished. Every Guild should have one monthly reading from *The Spirit of Missions*. These readings need not be long, but many helpful suggestions can be found, and much information gained. Missionary spirit is awakening everywhere. It is not possible, I know, for all Guilds to have a class, but there might be reading circles. Our method of passing on our used Text Books to some other Auxiliary or Guild is a very good one.

The Junior Auxiliary, as you know, has been revived, and the President will report to you its present condition.

I wish it were possible for some one to offer her services as Secretary for the Babies' Branch. This department is being totally neglected. Several years ago it was flourishing. It is our duty to train children in missionary spirit, that they may pass into the older societies and carry on the Church's work. I firmly believe a woman who volunteers her services will be more effective than one who is appointed. Cannot somebody offer her services today?

The response made to the Special Fund was most gratifying, the amount, \$58.50, being in excess of my most sanguine expectations.

It has seemed to me that there should be in print and accessible, some condensed history of the early days of the Woman's Auxiliary in

North Dakota. Unfortunately there is not much material for it;—at least I have not discovered much. But I am able to give the following resume:

In the various District Journals, under the head of officers, the Auxiliary is noted as having been organized in June, 1890. *The North Dakota Churchman*, a paper once published in Fargo, states that a branch of the Woman's Auxiliary to the Board of Missions was organized at the Annual Convocation held in Mayville, June, 1890. No records can be found, nor does anyone I have consulted remember any meeting held until that in Fargo at the Convocation in November, 1897, when Bishop Morrison was in charge of the District. At this meeting Mrs. Gilfillan of White Earth, Minn., gave a talk. The point emphasized was "that it is, generally speaking, lack of knowledge about missions which explains the indifference and spasmodic efforts of many Christian people. They need to be informed as to the difficulties, growth and extent of the missions of the Church, before they can become interested".

The first printed report in connection with the District Auxiliary was in 1899, when the Convocation was held in Grand Forks. Then the Auxiliary was re-organized, and a Constitution adopted. A separate report was printed and at this time began the printing of the reports at the end of the District Convocation Journals. Bishop Edsall greatly favored Auxiliary work, and regular annual meetings have been held ever since.

The Parish Auxiliary in Fargo was organized by Bishop Walker at the Webster Hotel, between January, 1893, and October, 1895. The Parish Auxiliary in Grand Forks was organized in 1896 by Rev. A. T. Gesner.

In Bishop Edsall's Annual Address of 1900, he records the fact that Miss Seward, the Diocesan Secretary, and Mrs. Gesner had paid visits to several Guilds and organized them into local branches of the Auxiliary. At one time we were credited with fifteen branches; and I well remember how awkward it was to answer the question, "With so many branches of the Auxiliary, why is not more accomplished"?

The Babies' Branch from 1895 to 1905 gave \$127.38 to missions. Mrs. Charles Turner was President from 1895 to 1901, when Mrs. Hugh L. Burleson was appointed.

At the Triennial Meeting in Minneapolis in 1895, the Auxiliary was represented by Mrs. J. A. Chesley and Mrs. Rumney. In San Francisco, 1901, Miss Seward, Mrs. R. B. Blakemore, Mrs. H. L. Burleson and Mrs. Walter Hancock were the delegates. In Boston in 1904, Mrs. W. H. Standish and Mrs. Cameron Mann were the delegates.

The Presidents of the Auxiliary have been: Mrs. R. J. Mooney, 1897-98-99; Miss Seward, 1900-01; Mrs. J. B. Wineman, 1902-03-04; Mrs. Cameron Mann, 1905 to 1912.

The Missions House in New York reports the following con-

tributions from the District Auxiliary towards the Apportionment: 1894, 89 cents; 1895, nothing; 1896, \$1.74; 1897, \$1.69; 1898, \$18.30; 1899, \$11.26; 1900, \$12.50; 1901, \$9.39; 1902, \$30.58; 1903, \$112.10; 1904, \$156.94; 1905, \$128.00.

For the foregoing information I am indebted to Rev. A. T. Gesner, Rev. R. J. Mooney, Mrs. W. H. Standish, Mrs. W. C. Nash, and the Missions House.

I have tried to present a record of the Auxiliary since its organization in 1890, to the time of its first separate printed Annual Report in 1906.

In closing I now ask that you elect some one in my place as your President. My aim has been to help and extend the Auxiliary work in all its branches. My only regret is that results are far short of my ambitions. It has been said that "an essential virtue of an officer of the Auxiliary, is an enthusiastic patience". I thank you all for your courtesy to me, especially when visiting in the different Missions, and the readiness with which you have responded to my requests. The friendships formed during my term as President, seven years, will always be a source of pleasure to me.



REPORT OF CHURCH HALL AT VALLEY CITY

WE HAVE struggled through the past year in spite of many difficulties. A period of two years of poor crops in North Dakota has had its effect upon us, as upon every other enterprise in the state. Retrenchment has been the cry everywhere. But our *expenses* go on whether the crops are good or bad; and our *receipts* dwindle. Consequently we have to report a deficit of some \$300.00 at the close of the Convocation year (April 30th, 1912), for the first time since the institution started. And that not owing to any fault of ours, but to the financial conditions which we have had to face, and certain extraordinary expenses which we have had to meet. Had it not been that under the present management we have been able to reduce the running expenses of the institution quite materially, we should have been forced to show a still larger deficit. We are confident that with the practice of the same rigid economy, and the co-operation of the women of the Church in North Dakota, we shall be able next year to show a balance on the right side of the ledger.

During the year the Hall has been well filled with the exception of the past three months, when we have had two rooms vacant. If these had been filled, we should have had no deficit to report; but a

large number of students did not return in the spring owing, as I said before, to lack of funds, and we with all others had to bear our share of the loss.

As far as the Auxiliaries and Guilds in North Dakota are concerned, we have not received help in the way of canned fruit, linen, etc., from nearly as many as heretofore. Only three Guilds have assisted us, and they are our regular stand-bys,—the ones we always count on. These, beside Valley City, are Grand Forks, Larimore and Jamestown. We certainly are very grateful to them. But could not more do something if they only would? Our work ought to appeal especially to the women of the Church, as it is caring for the young women from your own and your neighbor's families while away at school, generally for the first time in their lives. Can we be too particular in this matter? Don't you want to be sure that they will be in proper surroundings and environment? Is there any place where they will be better cared for than in an institution conducted by your own Church, and under the direction of the Bishop of that Church? Is there any work outside of your own Parish which is more deserving of your support, or which at the present time needs that support as much as the Church's only institution in the District?

If the Hall were twice as large as it is, our work would then be more effective, and the cost would be a good deal less in proportion. The staff would be the same; the cost of administration per capita a good deal less; and the influence and work of the Church among the students just so much more effective. At the present time, besides linen, fruit, etc., we need two things especially, but we have no funds to provide them: a large room which could be used for a Chapel and Assembly Hall, and a laundry. But above all else we need the co-operation and hearty support of the women of the Church in our work; their financial aid, when they can give it; and their united prayers daily to the Throne of God that this work may increasingly prosper, and that many may be helped by the refining influences and practical lessons in daily living which we endeavor to instil in all who sojourn within our walls.

REPORT OF THE JUNIOR AUXILIARY FOR THE YEAR 1911-12

WE HAVE tried this year not only to hold the branches already formed, but to add new ones, and with this end in view a good deal of correspondence has ensued. The result has not been as satisfactory as we could wish. Nevertheless we have advanced a little, and though only a little, it is something. We have kept all the old branches save one, and have gained two new ones. Replies to my letters over the District have shown that in some places there is really no material for a branch, while in others there is a lack of a suitable person willing to lead and superintend the work. In a few instances I received no reply of any kind.

We now have nine active branches with an average membership of seventeen. These nine branches during the winter prepared and sent to me clothing and other useful articles to make up a box for St. Mary's-on-the-Mountain, a girls' school at Sewanee, Tenn., the same place to which we sent last year. This box was shipped in March, and we have a good letter of thanks and appreciation from the Sister Superior, saying they have never received a nicer box.

Our girls in North Dakota have told me that they would like to continue this work another year. In addition to this, one or two of the branches have sent individual gifts to other places. Each of the nine branches has contributed to the United Offering in the following amounts:
