REPORT OF THE SECRETARY.

The Eighth Annual Meeting of the Woman's Missionary League of the Diocese of Northern New Jersey was held in Trinity Church, Newark, on Wednesday, Oct. 11th, 1882. In compliance with the decision at the last meeting of the previous season, the meeting was public, the first public meeting the League has ever held.

There were present in the chancel the Bishop, the Rev. Dr. Eccleston, Rev. Dr. Boggs and the Rev. G. F. Fliehner of Newark; also Rev. W. E. Jacobs, of Blair, Nebraska, and Rev. B. B. Babbitt, of Columbia, S. C., Missionaries in their respective Dioceses.

After a service the Bishop made a short address, introducing the strangers, commending them and their work to those present.

Mr. Jacobs first gave an account of his field of labor and the church which he was building, which was his special object of appeal. Mr. Babbitt followed with a like address, presenting as his peculiar need help in the education of a young colored man at his school in Columbia. Dr. Boggs made a short, earnest speech upon Missions in general, which was followed by a hymn and the usual collects and benediction. The ladies of Trinity Church having provided a lunch at Trinity Rectory, invited thereto the members of the League and the clergy present. An hour was spent in refreshment and social intercourse, for which the thanks of the League are due to those who so kindly and generously entertained them.

At 1 o'clock the League again assembled for the ordinary business meeting. The election of officers had been held at the closing meeting of the last season, resulting in making Mrs. T. A. Starkey President, Mrs. C. G. Craig Vice President, Miss Phoebe Carter Corresponding Secretary, Miss S. J. Schoch Recording Secretary, Mrs. E. M. Upham Treasurer. Directresses—Mrs. G. L. Heckscher, Diocesan Missions; Mrs. W. C. Hicks, Domestic Missions; Mrs. J. S. Cox, Foreign Missions; Mrs. F. C. Henderson, Mexican Missions; Mrs. C. M. Sanderson, Home Missions to Colored People; Mrs. J. W. Russell, Indian Missions.

The Directresses of the six departments report as follows:

Mrs. G. L. Heckscher reports one box sent to Diocesan Missionary, value \$69.00; cash, \$36.00; Associate Mission, Washington, \$11.00. Total, \$116.00.

Mrs. W. C. Hicks, of Domestic Missions, reports one box sent to Denver, Col., value \$37.00; one box to Kansas, value \$100.00; one box to Mississippi, value \$113.10; one box to North Carolina, value \$30.00; one box to Kansas, value \$18.00—\$298.10. Cash to Rev. W. E. Jacobs, for building church in Nebraska, \$51.00; to Point Coupée, La., towards building Rectory, \$20.00; for support of "Sister Eliza," Denver, Col., \$45.00; Missionary in Florence, Ala., \$10.00; Missionary in Maine, \$10.00, making a total of \$146.00 in money; added to the value of boxes, \$444.10.

Mrs. J. S. Cox reports for Foreign Missions \$27.00 for Bishop Odenheimer Scholarship at Jaffa, Syria; \$150.00 for the outfit of Miss Helen M. Thompson as Medical Missionary in the Memorial Hospital at Wuchang, China. Total, \$177.00.

On Mexican Missions Mrs. Henderson reports: For Julia Starkey Scholarship in Mrs. Hooker's Orphanage in City of Mexico, \$40.00; for Bishop Riley, \$86.00; for Grace Church Scholarship in Mrs. Hooker's Orphanage, \$50.00. Total, \$176.00.

On Home Missions to Colored People Mrs. C. M. Sanderson reports one box sent to Rev. Mr. Babbitt for his school at Columbia, S. C., value \$110.75; one box to Rev. Henry Dunlop, Savannah, Ga., value \$34.00; toward the education of young colored student in Mr. Babbitt's school, \$50.00, making a total of \$194.75.

On Indian Missions Mrs. J. W. Russell reports six barrels sent to Yankton Agency, value \$179.00; for Northern New Jersey Scholarship in St. Paul's School, Yankton Agency, \$60.00; for Sisseton Mission, \$25.00; for White Earth, \$25.00; for hospital supplies, Emmanuel House, \$38.50; for wire screens for the same, \$5.00; surgical instruments from Dr. Albert H. Smith, Philadelphia, \$3.00, making a total of \$330.50.

Three Scholarships are supported by the League, the W. H. Odenheimer, Jaffa, Syria; the Julia Starkey, in the City of Mexico; the N. N. J. in St. Paul's School, Yankton Agency; \$50.00 toward the support of student in Rev. Mr. Babbitt's school, Columbia, S. C.

Four Scholarships are reported through the League, one at Salt

Lake City, supported by the women of Trinity Church, Bergen Point; two in Duane Hall, Shanghai, and one in City of Mexico, by the women of Grace Church, Orange.

The League numbers 68 members, representing 20 parishes, with an average attendance of 33, which may be accounted a fair one in consideration of the weather of the past Winter. Two parishes have been added to our list, Grace Church, Jersey City, and St. Luke's, Montclair. We trust others of the neighboring parishes may follow their example. Church of the Redeemer, Morristown, though not sending representatives, reports through the League, as will be seen by the tabular account on another page.

In reviewing the three years which have elapsed since the last general meeting of the Woman's Auxiliary during the session of the General Convention in 1880, it is with pleasure we report a steady increase in numbers, in contributions, and in interest, contributions and interest far exceeding numbers, the increase to be attributed to the information gained at the League meetings, whereby the zeal of the parish societies has been aroused and quickened, in some instances doubling the work done in former years. The simple recital of the efforts of our self-sacrificing Missionaries among Indians and Freedmen, as well as at the Domestic stations of the border States and Territories within the limits of our Government, is in itself an appeal to the hearts and sympathies of those who hear and believe it their duty to do good to all men, but especially unto them of the household of faith.

Our method is direct and simple. The appeals are made by those desiring help to the Secretary of the Woman's Auxiliary, at the Bible House in New York, who transmits them to the heads of the different departments under which they are classified, who presents them at the League meeting to the delegates from the several parishes. These assume the whole or a part of the expense and labor, as they may feel ability or inclination. If the whole, it is reported a parish box; if a part only is promised, and several parishes unite, it is packed by the head of the department, Domestic, Freedmen or Indian, and called a League box. It is sent directly to the address given, without expense or delay, from the hand of the donor to that of the recipient and owner. Then

comes the letter of grateful acknowledgment, written with full heart, showing plainly how great has been the need and how great the relief. Sisters of the faith! what can we say to induce you to come and help us, that the work of the coming season may be doubled, yes, trebled? Will you not give us one morning in each month, that you may at least hear and know and decide for yourselves?

The following is taken from the minutes of the meeting held October 13th, 1882:

"Inasmuch as it has pleased God in His infinite wisdom to remove from our midst His faithful servant, Dr. A. T. Twing, the members of the Woman's Missionary League of Northern New Jersey wish to place on record their great sorrow at the loss which the cause of Missions has sustained, and their high estimate of his ability, untiring energy and perseverance, his benevolence and loving kindness to all men, and his unflagging devotion to the cause which he held dearer than life. They recognize in him, under God's blessing, the source and motive power of the great impetus given to the General Missions of the Church in the past ten years. Specially have the women of the Church cause for gratitude to him, for by his efforts have they been roused to interest in Missions. To his exertions are due the organization of the work now carried on throughout the country. With their sorrow and regret, they would express the hope that the spirit which animated him, and which he was so successful in imparting to others, may not be lost or grow inert, though he rests from his labors in the Church Militant. His most fitting memorial will be found in the continuance of the work thus begun, the perpetuation of the qualities he possessed, leavening the hearts, guiding the hands, shaping the lives of those whom he influenced while here, until they who minister unto the needs of others as well them who are ministered unto be reunited with him at the last in the great Church Triumphant."

CONSTITUTION
OF THE
WOMAN'S MISSIONARY LEAGUE.

ARTICLE I. This Society shall be called the Woman's Missionary League of Northern New Jersey.

ARTICLE II. Its object shall be to work in connection with the Woman's Auxiliary to the Board of Missions.

ARTICLE III. This Association shall consist of all persons who shall contribute to the treasury thereof annually at least the sum of one dollar, or who shall render, in materials or serving, substantial aid to missions. Any one may be constituted a life-member by the payment, at one time, of the sum of twenty-five dollars (\$25).

ARTICLE IV. The officers of this Association shall be a President, Vice President, Corresponding Secretary, Recording Secretary, and Treasurer. There shall be, moreover, a Board of Managers, consisting of the above-named officers and of two or more ladies from each parish represented in the Association, whose duty it shall be to regulate its affairs, and, under the supervision of their rectors, to further the work of the League in the parishes to which they respectively belong. The methods by which the ends of this organization can be furthered are the raising of money for the support of missionaries and teachers; for the education of those who may be preparing for the work, and for other benevolent purposes connected with the mission; the making, collecting and transfer of clothing, and other material aid; and the publication of papers and pamphlets that may serve to stir up a public interest in the welfare of the different missions.

ARTICLE V. It shall be the duty of the President to preside at the meetings of the Association and of the Board of Managers; to call special meetings of the same when occasion shall require, and to countersign all drafts on the Treasurer.

ARTICLE VI. It shall be the duty of the Corresponding Secretary to conduct the correspondence of the Association, especially that with the Secretary of the Woman's Auxiliary, and from her to obtain fresh information of the different missions, to be read at stated meetings of the Board.

ARTICLE VII. It shall be the duty of the Recording Secretary to keep minutes of the proceedings of the Association and Board of Managers; to send out all notices of stated and special meetings of the same, and to prepare an annual report.

ARTICLE VIII. It shall be the duty of the Treasurer to receive and keep account of all moneys and materials contributed for the work of the Association, and to pay all drafts on the funds when countersigned by the President.

ARTICLE IX. This Constitution shall not be altered except at an annual meeting of the Association, notice of the proposed change having been given at a stated meeting of the Board of Managers.

BY-LAWS.

1. There shall be a Public Anniversary of this Association in the Autumn of each year, with missionary addresses or sermon, at which time a collection shall be made for such mission or missions as shall be designated at the time.
2. There shall be an Annual Meeting of the League in the Spring of each year, at such hour and place as the Secretary, with advice of the President, shall designate.
3. The election of Officers and Board of Managers shall take place at such meetings, and they shall continue in office for one year, or until their successors are appointed.
4. In case of vacancy of any office by the death or removal of its occupant, the same may be filled at a stated meeting of the Board of Managers, and any one so elected shall continue in office until the next meeting of the Association.
5. The Stated Meetings of the Board of Managers shall be on the second Wednesday of each month, in Trinity Chapel, Rector street, Newark, or any other place designated.
6. At the meetings of the Board of Managers any number present shall constitute a quorum for the transaction of business, and at the Annual Meetings a number of members equal to one-half the number of parishes represented therein shall constitute a quorum for the transaction of business.
7. Each parish shall be considered as represented at the Stated Meetings of this Association in the absence of their delegates if a report is sent to the Corresponding Secretary.
