## The Annual Meeting at Cleveland

### May 22nd, 1913

The Annual Meeting of the Ohio Branch of Woman's Auxiliary took place at St. John's Church, Cleveland, on May 22nd.

The Convention began its day with the service of Holy Communion, Canon Cooke being celebrant, assisted by the Archdeacon, the Rev. J. R. Stalker and the Rev. W. A. Thompson.

At the business meeting immediately succeeding, Mrs. H. P. Knapp occupied the chair. At roll call, delegations answered to their names from Akron, Ashtabula, from all the parishes of Cleveland, from Cuyahoga Falls, East Cleveland, Lakewood, Elyria, Findlay, Fremont, Gambier, Geneva, Hudson, Huron, Kent, Lorain, Massillon, Medina, Monroeville, Norwalk, Painesville, Perry, Sandusky, Steubenville, Toledo, Warren and Youngstown.

Upon motion, the reading of the minutes of the last meeting was omitted, the same having been printed and distributed.

Canon Cooke gave a cordial word of welcome from St. John's Church. He then read a letter of greeting to the Auxiliary from Bishop Leonard.

A Nominating Committee was elected, as follows: Chairman, Mrs. L. Lascelles, of St. John's, Cleveland; Mrs. Thos. M. Sloane, of Grace, Sandusky; Mrs. George Gunnell, of Trinity, Toledo; Mrs. L. E. Lyman, of Emmanuel, Cleveland, and Mrs. A. A. Franzheim, of St. Paul's, Steubenville.

The Amendments to Article IV of the Constitution, of which notice had been given to each Branch, were passed without dissenting voice. This made possible the election of Mrs. Leonard as Honorary President, for which there was universal desire, and also the division of the Junior Department so that it may have the leadership of two officers instead of one.

Reports covering the work of the year were made as follows: Mrs. Savage gave her report as Secretary, and also read the Bishop's report concerning the "Bishop Leonard Fund," and that of Mrs. White for the Babies' Branch. Mrs. Knapp gave her report of the Junior Department, and Mrs. Collacott that of the Educational Secretary. Report of the United Offering was given by Mrs. Hatch. Miss Spencer gave, verbally, her report concerning the Sandusky Convocation, and Mrs. Hart read the report of the Church Periodical Club which had been prepared by Mrs. Dawson, its Correspondent.

Noonday prayer for Missions was said by Canon Cooke.

At the luncheon hour, all repaired to the dining room where delicious refreshments were served by the ladies of the West Side Auxiliary societies.

Reassembling in the church, the pledges for the coming year were considered. It was announced that the Treasurer should understand that all the old pledges would remain as last year unless she was notified to the contrary. It was decided to undertake a new pledge for the support and education of a child in the Rev. Mr. Betticher's School in Alaska—the fund to be called the "Sarah L. Leonard Scholarship." In order that as many as possible be privileged to participate, no society was allowed to subscribe more than \$5.00. The requisite \$100.00 was raised immediately.

A letter was read by the Secretary from the Rev. Mr. Joyner, of the Mission in the Blue Ridge, supported by the Ohio Branch.

The Missionary address of the day was then made by the Rev. Robert Wood, of China. Pledges for his work were made amounting to \$300.00.

A rising vote of the entire Convention was taken expressing to St. John's and all the West Side Parishes most hearty thanks and sincere appreciation of the day's delightful hospitality.

An invitation was extended by the women of Emmanuel Church for the next Annual Meeting and was thankfully accepted.

The new Board of Officers chosen is as follows: Honorary President, Mrs. W. A. Leonard; President, Mrs. H. P. Knapp; Vice Presidents, Miss K. L. Mather, Miss F. G. Spencer, Mrs. T. H. Walbridge, Mrs. H. E. Cooke; Secretary, Mrs. J. B. Savage; Treasurer, Mrs. C. S. Bates; Directors of Junior Department, Miss J. Truesdell and Miss M. E. Atwood; Director of Babies' Branch, Mrs. F. R. White; Director of United Offering, Mrs. C. D. Hatch; Educational Secretary, Miss Martha Kimball; Correspondent Church Periodical Club, Mrs. H. H. Hart.

By unanimous vote, the Secretary was directed to send a telegram to Mrs. Leonard informing her of her election as Honorary President and wishing her a safe journey and speedy recovery. The Secretary was also directed to write to Mrs. Bates, the Treasurer, expressing deep regret at her absence and hope that she may be present another year.

The meeting was then closed with a short service of prayer and benediction.

## Letter by Bishop Leonard

(Read by Canon Cooke at the Annual Meeting.)

My dear fellow-workers in the Woman's Auxiliary of the Diocese of Ohio:

I believe that it is the first time in my entire experience as Bishop of this Diocese, covering now nearly a quarter of a century, when I have been absent from your important meetings. So that I am constrained to send you a letter of greeting, because, providentially, I am compelled to be absent this year. I shall probably be in New York at the time of your Convention, as Mrs. Leonard and I are to sail for Europe on the 24th inst. The doctor has ordered her to take added medical treatment and benefit in Europe and therefore we are compelled to leave our home. This prevents us both from being present today.

You know how deep is Mrs. Leonard's interest in your work and welfare; you know how she has expended herself and her energies and heart in the development of your great organization; and I am simply voicing for her, as for myself, our profound regrets that we cannot share with you the joy of this council, and the blessing of unity that comes from Communion with our dear Lord at His holy altar.

From all that I hear, the Auxiliary has done an unusual work this year. I understand that the reports coming in of the United Offering show a larger growth of that fund than ever before. What a joy it will give to Mrs. Leonard and to me, to know that you are overpassing and outstepping the former records. Your Auxiliary is a blessed institution, it has stimulated me in my work throughout the Diocese; it has been a benediction through its services and offices to very many souls, far away and nearby.

I do not know that I have any special injunction or instruction to proffer at this time; my word is one simply of congratulation and thankfulness. It was my pleasure and privilege to secure the assistance of Mrs. Homer Knapp, of St. James' Parish, Painesville, when Mrs. Leonard felt compelled to resign the presidency of your Auxiliary. Miss Mather, at the time, was about to leave the country for a long stay in Europe, so that it was necessary that you should have a head for the directing of affairs. I am confident that Mrs. Knapp has won your love and appreciation by her skilled methods and her earnest efforts, and I beg to thank her in your presence now for the comfort and satisfaction she has given to me. My prayer will go up for you today that the blessing of the Spirit of God may be upon you, and that your hearts may be filled with love, and determination and an earnest desire to accomplish more and more for Him as the months and years pass on.

I am proud of the development of the Junior work, and now the elders may be conscious of the fact that a goodly group of loving daughters is being trained to take up a more extended service and labor of love when it becomes their duty so to do.

Today we are called to be present at the thirty-sixth Annual Meeting of the Woman's Auxiliary of the Diocese of Ohio. Most of us have heard, if we have not been privileged to see for ourselves, the growth that has been made through these years.

Of necessity, the progress has been slow, but from some gain each year, we have now reached the point where a beginning has been made along all lines of Auxiliary work. The great regret is that so many of the weaker Parishes, who need help and encouragement, are so far removed from our center of activity that only once a year are we able to come together, and that for so short a time, to receive the stimulus which exchange of ideas and social intercourse can give.

There are too many of our smaller Parishes that find the problem of self-support so great, that they have not yet started an Auxiliary Society or Junior Branch. If they could only see that an advanced step in their own Church progress could be more easily made by an effort to help some Parish or Mission Station less favorably placed than their own, the problem of self-support would be more readily solved, and our Diocese would grow more rapidly in strength and usefulness. There is nothing that gives us a broader view of life, in its varied conditions, than a willingness to look beyond the limits of our own horizon into the broader perspective which the whole world offers, and contrasting it with our own privileges and opportunities. Some of us have already learned this, and are acting upon the belief that doing for others brings its own reward in increased opportunities for our own success in any endeavor.

The year's activities opened, when, on the 11th of October, was held, in Trinity Cathedral, the Fourth Annual Meeting of the Woman's Auxiliary in the Fifth Missionary Department. This is composed of eight Dioceses of the Middle West, each Diocese being represented by five delegates from the Woman's Auxiliary and the Junior Department.

The meeting opened with the Holy Communion, followed by a sermon by the Rt. Rev. R. H. Weller, Bishop of Fond du Lac, after which, adjourning to Cathedral House, the day's program began with an address of welcome from Bishop Leonard, followed by a paper from Mrs. W. I. Pratt, of Indianapolis, on "The Use of Church Papers." An informal talk was given by Mrs. F. B. Stevens, of Detroit, on "Methods and Plans in Michigan," also an address from Mrs. C. P. Lampman, of Chicago, telling of the project and arrangement of plans for the "World in Chicago," which is to be held there this summer. Miss Lindley, the Junior Auxiliary leader, gave a most interesting exposition of the Gospel of St. Matthew, followed by noon-day prayer, and a short business meeting. After this, adjournment was taken for luncheon, which was delicious and well served by the ladies of the Cathedral.

Returning to the Hall, a Question-Box Conference was conducted by Miss Lindley,—interesting from the variety of subjects which were brought to our notice. Later, the visiting delegates and Auxiliary women of Cleveland were driven in automobiles to Miss Mather's beautiful home on the lake shore, and there enjoyed a delightful social hour, a most happy close to a day so full of interest and profit.

We of Ohio were glad to be attentive listeners at this meeting, receiving from our sister Dioceses some valuable suggestions to aid us in growth and efficiency. Our great regret was that all our societies could not have been represented, to carry back with them some of the spirit and enthusiasm which pervaded this assembly of earnest women.

A Missionary Rally was held in Emmanuel Church on Wednesday, January 29th, to which the entire Cleveland Convocation was invited. The distance which separates

most of the towns in the Convocation from Cleveland makes it next to impossible to have a representation from outside Parishes other than those in the nearby suburbs. This is a source of regret to those who enjoy the privilege, appreciating the benefit such opportunities afford. At this meeting, in particular, the Auxiliaries lost the rare chance of hearing and meeting in a social way the Presiding Bishop of the Church, the Rt. Rev. Daniel Sylvester Tuttle, a most forceful speaker, who has a personality entirely his own, and who, once heard, cannot be forgotten. His talk upon the Woman's Auxiliary, from its beginnings to the present time, and what it had meant to him as a pioneer Bishop (as well as to all others in the Missionary field), could not fail to gratify those who listened to him, though within us may have lurked the feeling of our unworthiness to receive such praise, knowing what might have been accomplished had we really done our best.

The Annual "Quiet Day" for women, was held in Grace Church, on Thursday, March 6th. The Rev. W. O. Waters, D. D., Rector of Grace Church, Chicago, conducted the service. Unfortunately it chanced to be about the most blustering and snowy day of the winter; but earnest, interested women are not easily kept away, when duty and privilege are considered, consequently a goodly number were present, who, under the spell of the devotional spirit with which they were surrounded, could not fail to be benefited by the peace and restfulness of this quiet day.

It is with a feeling of satisfaction that we speak of the five Missionary Conferences that have been held, each month, beginning with December. The attendance has not been large at any meeting, still when we consider the distances to be overcome, and often cold or inclement weather, there appears to have been a steady increase in interest, if not always in numbers. Three of the meetings were held in Parishes removed from the center of town—the Church of the Incarnation, St. Luke's, and St. Paul's, East Cleveland, while the others were in Grace Church and St. Andrew's. One meeting was given to the "United Offering," with

papers stimulating us to renewed effort, as we near the close of our last year for giving our Woman's Thank Offering for women, before the triennial in October of this year.

"Financing Missions" was another interesting subject. The important question is—How can the Woman's Auxiliary further the efforts of the Board of Missions to establish a uniform system of giving, for the General Missions of the Church? The answer is plainly this: By contributing liberally to General Missions (thus helping your Parish to meet its "apportionment.") The Diocesan apportionment has not been usually met; nor can the money be raised unless the members of the Woman's Auxiliary do their full part. Let us remember much depends upon the interest and co-operation of each individual. We must feel our responsibility, and bear in mind that it is the small sums which, given by many, will aggregate the large amount.

At the same time, "specials" are by no means to be overlooked in our zeal to help the Parish, for our Missionary Bishops and other workers in the Mission field depend much upon the money they receive directly from a society or friend, to carry out many of their plans.

By the same token — let us not overlook our own Diocesan institutions which should always claim our attention, as they afford care and support for the aged, the orphan and the crippled child.

The topic of the fourth meeting was "Auxiliary Problems and Difficulties." "The Devotional Side of the Woman's Auxiliary," the topic of the fifth conference, was a most fitting subject for the close of these meetings. We were brought to realize that, above all else, the spiritual side of our own natures should be intensified, in order that we may realize as we should the wonderful things that can be accomplished in our work for the advancement of Christ's kingdom, through faith and earnest prayer.

The membership in our Auxiliary must of necessity undergo changes each year. Some go from us into the higher life, while others no longer take an active part, and

so drop away, feeling, perhaps, that they have done their share and are ready to pass on the good work to others. How helpful it would be if such women would become Honorary Members of the Auxiliary, and, by a contribution of five dollars a year, still continue to fill a most necessary place by helping to supply the frequent and unexpected calls made upon the Auxiliary, which otherwise cannot be met except by personal solicitation. Again, what more fitting than an Honorary Membership, given in remembrance of some mother, sister, or friend, whose name and loyalty to the Auxiliary it is a pleasure to recall, and whose good work, by money given in this way, is still carried forward.

It is encouraging to feel that the Junior Department is being so well fitted by study and early training to take our places as Auxiliary workers. We believe that many of the failures made by us, through lack of knowledge and experience, will not occur, as the years go forward.

As in previous years, much interest has been shown in what may be called the Diocese of Ohio's own Mission at Glen Alpine, N. C., where so much has been accomplished through Mrs. Joyner's efforts for the betterment and education of these shut-in mountain people. By our continued interest, it has been proved that we felt our efforts in their behalf were well appreciated. Now we are assured: for since hearing that many in our Diocese have suffered from the recent flood disaster that has swept our State, these poor people of St. Paul's Mission, to whom a dollar is a great deal of money, wishing to show their interest and sympathy, sent twice that sum as their donation towards our Diocesan Relief Fund. A touching tribute this! It bespoke their appreciation and gratitude towards their Ohio friends, far more than could have been expressed by them in any other way.

It is with feelings of inexpressible regret that we must note the resignation of our beloved President whose continued ill health has made it necessary that she give up active service. Through all these years she has shown the same unfailing interest and enthusiasm for the advancement and

welfare of the Woman's Auxiliary, both spiritual and temporal. Her unusual personality and earnest Christian character have made her a rare leader, upon whose advice and decisions we had grown to depend. It is our heartfelt wish and prayer that a quiet summer may do much to bring back her former health and vigor.

In summing up the work of the year it is most natural that we contrast it with that of the previous ones. A feeling of disappointment is ours, if the comparison does not indicate some increase. What we really need and what would help us is a more apparent interest shown in the work by our less active members. Think what it would mean to the leaders in each society, if all Auxiliary women really worked with a will. With what ease we should meet our pledges, do the other work expected of us, and much more besides. We should have a keen sense of our privileges and be ever ready to benefit those whose environment is one of ignorance or superstition, and so help them to a knowledge of Christ and His love.

## The Junior Auxiliary

Back of all the annual meetings and the annual reports are twelve months of hard and faithful work, and it is of this work we would speak first today. If it were not for the earnestness and steadfastness of the Directors of the Junior branches we should have no report to make. To give of one's thought and time for the training of children and the directing of young people is no easy task, and we cannot but be thankful for the band of forty-five Directors who are leading the young people of the Church in the Diocese of Ohio.

Some of these branches do not make a large report in money gifts or box values but we know of other things accomplished. The training is the important part of our work and in so far as the Director has taught her branch to carry responsibility, to know why they work and give, to pray earnestly and to serve faithfully and conscientiously,—that is her measure of success. A clergyman once wrote to his Bishop, "God wants a better man here." The reply was, "Yes, He does, but He wants you to be the better man." If our Directors ever feel they are not fitted for their work, will they not see if they cannot become better fitted? That is wiser than to become discouraged or to give up their office. There are opportunities for this training in the various summer conferences, and at the General Convention in October there will be a rare chance to learn from experienced leaders. And God gives no better place for working for the extension of His kingdom than that of training the young people who are to be the Church of the future and the leaders in the missionary campaign.

The Junior Directors of Cleveland began their winter's work with a corporate communion at Emmanuel Church. The branches in Cleveland and the Sandusky Convocation again sent united barrels to various mission stations, and

those of Toledo have adopted the same plan. It brings the Juniors together in a way that is almost impossible otherwise.

We have to report \$1,061.97 in money gifts and \$1,274.25 in box values. Of the money, \$605.55 applied on the apportionment and \$180.92 goes to the United Offering.

Our Junior at the Philadelphia Training School will graduate this month. By advice of the Deaconess in charge, she will have two years of parochial work before going into the mission field. This experience will be an added equipment.

In urging the branches to study this year, they were asked to make scrap books which would illustrate "The Honorable Little Miss Love," the Junior text-book on Japan. First and second prizes were offered. Mrs. W. H. Cowell was invited to act as chairman of the committee of awards and she selected the Misses Ludlow and Kimball to serve with her. The books were judged by the skill shown in illustrating the story and for neatness of workmanship. The committee announced that St. James', Painesville, won the first prize and St. Paul's, Steubenville, the second. They also commended Grace, Ravenna, as sending the most artistic book, and that from Ascension, Lakewood, as showing great originality. The rewards offered were: for the first, the expenses of two delegates to this Annual Meeting, and the expenses of one, for the second. As these are critical days in school, the winners of the first decided to take their prize money and send it as their gift to Japan. We are proud to welcome the delegate from Steubenville here today.

The winning books are to be sent to the Junior Exhibit at the General Convention. As a result of the study at St. Paul's, Steubenville, two little visitors to the class became candidates for baptism.

We have added seven branches this year and regret the lapse of one.

For two or three years each Diocese has been asked to appoint an officer whose special duty should be to interest the older girls and younger women in Missionary work. We

now have a plan for this in Ohio. If you pass the amendment of which notice has been given, it is proposed to divide the Junior Department, putting the girls of eighteen and older into a department to be called "Auxiliary Daughters," the younger ones being still known as Juniors.

The Auxiliary Daughters for the present will be part of the Junior Department, but after a year or two will report through the Senior Department. We trust this will be the bridge between the Woman's Auxiliary and the Junior Auxiliary, and in time the yawning chasm now existing may be quite forgotten. It is also our hope that the Auxiliary Daughters will act as "Big Sisters" to the Juniors. Will not the members of the Woman's Auxiliary give cordial support to the Daughters? It is to them we must soon look to fill our places.

We will close with an extract from the letter which Miss Lindley has sent to all the Juniors. "And now one word about the summer. Most of you won't have meetings to go to, but all of you are needed for some special help. All the summer, while your Junior work stops, the work of the Church will go on, for the people who do not know it need the message of God's love *now*. Will you help to send it to them? You can do this in these ways: First, make or save something this summer. Second, pray for the world which needs the message. Third, pray that before October some one from your Diocese will offer to take this message. Fourth, pray that God will bless the Convention which will meet in October and remember to ask that He will teach the Junior leaders who will be there and help them in all their work."

### REPORT OF THE TOLEDO CONVOCATION.

We feel that we may look forward to the coming year with great encouragement as a result of the missionary work accomplished in the Toledo Convocation during the past year. Many of the branches had mission study classes during the winter, and that is always a potent factor in arousing interest.

In November our annual all-day meeting was held at Trinity Church, the Rev. George Gunnell being celebrant and preacher at the service of Holy Communion in the morning. At noon, luncheon was served in the Parish House; one hundred and fifty delegates were present. At the Missionary meeting in the afternoon, Miss Frances Sibley, in a delightfully enthusiastic way, told us of her experience in mission work in Manila under Bishop Brent. The offering was \$31.00—\$18.00 being sent to Bishop Brent and \$13.00 to General Missions.

The mid-winter meeting was held at St. Mark's, where it was our privilege to hear Bishop Van Buren tell of the work being done in Porto Rico. The offering was \$10.00 for Bishop Van Buren and \$6.00 for General Missions.

The third general meeting was held at Grace Church, where Rev. H. E. Somerville, our City Missionary, brought home to us the needs of the many isolated and unfortunate human beings here in our very midst, most of them living in public institutions. It opened the eyes of many who had

hitherto had no conception of the needs of this, our Home Mission. The offering was \$19.00.

It is always a keen happiness to report the organization of a new branch, and this year the new one is a Junior Auxiliary at St. Paul's, East Toledo. God speed the day when all women of the Church will realize their personal responsibility to the cause of Missions and will gladly and gratefully give their time, service and money to the great cause and thus to His service.

## The Mission Study Classes

We have been trying this year both "extensive and intensive" methods. That is, we have been working to give many people at least a little knowledge of the work the Church is doing outside our own Diocese, and to give a few people enough knowledge for them to become teachers of others.

Two things stand out as marking real progress in our educational work. Last summer one of our young women went to the Silver Bay Conference and there took the training to fit herself as a leader of Mission Study classes. During Lent she held classes in Toledo, Cleveland and Lakewood, and we are exceedingly appreciative of this help. One Rector wrote, "I am grateful for having had the class to enlarge the Parish horizon."

You all know of the inspiration which the Council of the Fifth Department brought us. Seventy registered for the classes taught by Miss Lindley and Miss Tillotson. We believe that those classes and the conference and addresses on our "Woman's Day" gave an impetus to the work which has lasted through the year. Various study classes, led by those who were in these normal classes, have been held in several Parishes.

The Suggested Programs for Lenten use were based this year on the text-book, "Japan Advancing,—Whither?" The reports seem to show an increased interest. One secretary's comment was illuminating, "There are no prospective recruits for the missionary field in this class, as we are mostly too old, but the personal benefit we have received and the interest aroused has made the class worth while." She recognized the need for recruits and we may hope that influence in that direction may be brought upon the Juniors in that Parish.

We did not look for immediate results from the classes but are grateful that, following the work in one, we were able to secure Miss Martha Kimball as our Diocesan Secretary for the "Spirit of Missions." We feel this is a part of the Educational Department if we interpret that to mean the spreading of missionary intelligence throughout the Diocese. Nothing can so arouse our interest as the faithful and regular reading of our own magazine, and we cannot hope for a steady increase in gifts till we have a firm foundation of knowledge and the right spirit back of all.

This year we have inaugurated a series of conferences in Cleveland, five having been held. We were entertained by the Parishes in different parts of the city and the varying phases of Auxiliary work were the subjects for discussion. These conferences, started as an experiment, have proven so successful that we feel they have come to stay. We plan to take them out of the Educational Department next year and place them under a special committee. We ask the help of each woman here in making the Educational Department a real power in our work. We can be Auxiliary to the Board in no truer way than by developing a body of women who are intelligent as well as active, and above all, filled with the spirit of Christ.

## The Annual Pledges

The largest one of our pledges is made to the Board of Missions for the annual salary of a lady missionary in China. The amount is \$750. Miss Elwin, who is thus "our own missionary," is in charge of St. Mary's Orphanage, Shanghai, a post of much responsibility and importance.

Since the founding of St. Paul's Mission at Glen Alpine in the Blue Ridge Mountains, we have had the honor of paying the salary of our very successful missionary there, Mrs. Eva. F. Dixon Joyner. Her husband, the Rev. James Joyner, who has mission work in the vicinity, makes his headquarters at Glen Alpine, and in consideration of the occasional services which he can render, we contribute a small amount toward his salary also. The sum for which we pledge ourselves to Glen Alpine is \$500.

A new pledge was determined upon at the recent Annual Meeting, to be called the "Sarah L. Leonard Scholarship." It requires the payment of \$100.00 annually and is given to the Rev. Charles Betticher's School in Alaska.

The "Bishop Leonard Fund" is for use among the missions of Ohio, when and where the Bishop thinks it best. We have pledged to him \$550; he will pay \$300 of this amount to the support of the Colored Mission in Cleveland, \$200 to the salary of the Archdeacon, and the rest as need may require.

The "Expense Fund" covers the cost of publishing the annual report, and occasional circulars or leaflets, the stamps and stationery of the Secretary, traveling expenses in starting new Branches, and that of missionaries whom we invite to address us. It is hoped that each society will contribute \$1 at least, during the year, and that the stronger societies will contribute considerably more.

The "Contingent Fund" is available for all sorts of emergencies and is of great service. Most often it has been expended for overcoats needed without delay, or for clerical suits not otherwise obtainable. The Honorary Membership fees are allotted to this fund. Our list of Honorary Members has recently been sadly depleted by death. It is much to be desired that other women may take the places of those who, so long as life lasted, took pleasure in aiding this fund.

Varying sums are pledged each year to Bishop Rowe's work in Alaska, to General Missions, to the Districts of Oklahoma, Sacramento, Asheville, the Philippines and others.

The Bishop Bedell Scholarship and the Julia Bedell Scholarship pay for the education of native pupils in St. John's University, Shanghai, China. They require \$70 each per annum. The "Ohio Scholarship" in St. Elizabeth's—one of the Bishop Hare Schools in South Dakota—pays for the education of an Indian pupil; it requires \$60 per year. Several other scholarships are maintained by individual Parishes, and by the Juniors. The "Foreign Insurance Fund" provides insurance upon the lives of foreign missionaries for the benefit of their families. We of the Ohio Branch have for thirty years paid \$50 each year into this fund; we greatly desire now to increase the amount to \$100 or \$150, or more. It is a fund which should particularly appeal to us.

Those of our pledges which help the Board of Missions to meet its appropriations (and which therefore count toward the "apportionment" of our Parishes), have been this year as follows: Salary of our missionary in China, General Missions (that is to say, Foreign and Domestic Missions); Missions in the Districts of Alaska, Cuba, Kearney, Oklahoma, Sacramento, Lexington, East Oregon, the Philippines and Wyoming; Juniors' fund for Day School in China; Japan; School at Cape Palmas, Africa; Julia and Bishop Bedell Scholarships, China; Sandusky Scholarship, China; Julia McGrew Scholarship, St. Hilda's, China; and "Ohio Scholarship" in St. Elizabeth's, South Dakota.

## Notes

All contributions for the United Offering are to be sent to the Director and Treasurer of that fund, Mrs. C. D. Hatch; other sums are to be sent to the General Treasurer, Mrs. C. S. Bates. All "pledges" are to be paid to Mrs. Bates. If you send money direct to Church Missions House, New York, do not fail to say that it is to be credited to the Woman's Auxiliary, and also state whether it is to be a "special" or may be assigned to the appropriations of the Board.

\* \* \* \* \*

PLEASE NOTE that packages sent to Mrs. Savage for distribution in missionary boxes should be addressed, *not* to her residence, but to *St. Paul's Parish House, 4108 Euclid Ave., Cleveland*. It is there that the packing is done. The janitor resides in the house and packages are always cared for. All articles received will be assorted by the Secretary, or the Junior Director, and sent out again according to need and the particular sizes desired. But if you have enough to fill a barrel or over fifty-pound box there is no economy in sending to Mrs. Savage at all; in that case please send direct to the Mission for which it is intended. Before sending a box or barrel be very sure that you have the correct address. Write the name of the State in full. Put your own address, also, on the outside. This is often important for purposes of identification, and it will enable the receiver to acknowledge the gift at once. It is always best, also, to mail the freight receipt to your missionary; he will then be able to secure the box without trouble.

## **The Convocations**

A list is here given of all the Parish and Mission Stations of each Convocation in which we have either Auxiliary or Junior Branches, or both, and also a list of those where we have none. Please study your own Convocation. Note especially the places that are yet to be gained; if you have friends at any of these points, or can in any way aid us, may we not count upon your assistance?

### **Cleveland Convocation**

We have two Branches in Akron, one each in Ashtabula, Boardman, Canton, in 18 Parishes in Cleveland and suburbs, Cuyahoga Falls, Geneva, Hudson, Kent, Massillon, Medina New Philadelphia, Niles, Painesville, Peninsula, Perry, Ravenna, two in Steubenville, in Warren, Wellsville, Wooster, two in Youngstown, Unionville.

We have none in the Parishes of St. Alban's and St. James', Cleveland, and of St. Stephen's, East Liverpool, nor in the Missions of Alliance, Barberton, Berea, Collinwood, Conneaut, Cross Creek, the Atonement in Cleveland, Dennison, E. Plymouth, Harbor, Jefferson, Kinsman, Lisbon, Salem, Willoughby, Windsor Mills.

### **Sandusky Convocation**

We have branches in Bellevue, Bucyrus, Cardington, Catawba Island, Coshocton, Elyria, Fremont, Galion, two in Gambier, Huron, two in Lorain, Mansfield, Marion, Marysville, Milan, Monroeville, Mt. Vernon, Norwalk, Oberlin, Port Clinton, three in Sandusky, Shelby, Tiffin, Upper Sandusky.

We have none in the Missions of Clyde, Fostoria, Lyme, Mill Creek, Mt. Gilead, Venice.

### **Toledo Convocation**

We have Branches in Bellefontaine, Defiance, Findlay, Kenton, Maumee, and in seven Parishes in Toledo.

We have none in the Missions of Bryan, Hicksville, Lima, Napoleon and Sidney.

## **Diocesan Constitution**

### **ARTICLE I—Name.**

The name of this association shall be The Ohio Branch of the Woman's Auxiliary to the Board of Missions.

### **ARTICLE II—Object.**

Its object shall be to work in connection with the Woman's Auxiliary to the Board of Missions, the field being co-extensive with the Church, diocesan and general. The methods by which the ends of this organization can be promoted are: the raising of money for the support of Missionaries and Teachers, for the education of those who may be preparing for the work, and for other benevolent purposes connected with Missions; the making, collecting and transfer of clothing, and other material aid, and the circulation of papers and leaflets that may serve to stir up a public interest in the Missions of the Church.

### **ARTICLE III—Membership.**

Section 1.—Any Parish Auxiliary (Senior or Junior) may become a member of this association by a written announcement of its organization to the Diocesan Secretary.

Sec. 2.—The officers of Parish branches shall send to the Diocesan Treasurer all pledges and money given for other than local purposes, and shall report to the Diocesan Secretary by May 1st each year all work done, with value of boxes and money given. Each Parish branch shall be entitled to but one vote in the annual Diocesan meetings, but may send any number of delegates, one of whom shall be authorized to cast the vote and assume pledges for specific work undertaken by the Diocesan branch.

### **ARTICLE IV—Officers.**

The officers of this association shall be a President, four Vice Presidents, a Secretary, a Treasurer, and Directors of Junior Auxiliary, of Babies' Branch and of United

Offering, an Educational Secretary, and a Correspondent of the Church Periodical Club, to be appointed by the Bishop from names presented by a committee of five (each Convocation to be represented thereupon) elected annually in convention.

One Vice President shall be chosen from each of the three Convocations of the Diocese, as follows: First, Cleveland; second, Sandusky; third, Toledo; the fourth shall be a Vice President at large; and these with the other officers shall constitute a Board of Managers and trustees of the association. But it shall be competent for the same person to hold two or more offices if in the judgment of the Board of Managers the best interests of the work require it.

The Board of Managers shall also have power to divide the work of any department when they deem it expedient, and the proper officers thereto shall be elected as herein-before provided. If desired, an Honorary President may be elected.

#### ARTICLE V—Duties of Officers.

Section 1.—The President shall preside, and in her absence one of the Vice Presidents, in Convocation order. She shall call meetings and perform such duties as pertain to her office; and shall make every effort, through the Vice Presidents and otherwise, to direct the work of the Parish branches in raising money for the support of some one or more of the departments of missionary work, and shall form new Parish auxiliaries wherever practicable.

Sec. 2.—It shall be the duty of the first, second and third Vice President in addition to the customary assistance to the President, to take general charge of the missionary work in her own Convocation and she may arrange for one meeting of representatives from the Parishes in the Convocation, held annually in the Autumn, and shall in every way strive to arouse and maintain active interest in all departments of the work. The especial duty of the fourth Vice President shall be to assist the President, and she may also be assigned to duty in any part of the Diocese where such assistance is desired.

Sec. 3.—The Secretary shall correspond with the General Secretary and the missionaries and find out where help is needed, and of what kind; shall inform the Parish secretaries and arrange about their work, so that a general oversight may be kept by one person. She shall keep a correct list of all Diocesan officers, Parish secretaries and clergymen in the Diocese, with addresses of the same. She shall take the minutes of all meetings and prepare an annual report for circulation in the Diocese. The Treasurer shall receive and forward all money offerings, and shall pay out money only as voted by the Diocesan branch or Board of Managers, except money received for a definite purpose may be paid for that purpose without a formal vote; shall keep an account of all money contributed for missionary and other purposes by the Parish branches, or individuals; and shall, after the accounts and vouchers are audited, embody a full account in the annual report.

Sec. 4.—An Auditing Committee of two persons, to be appointed by the President, shall examine the accounts and vouchers of the Diocesan Treasurer, and report result.

#### ARTICLE VI—Amendments.

The Constitution may be amended by a vote of two-thirds of the members present at any annual meeting of the association; provided, that notice of the proposed change has been given with the call for a meeting.

## By-Laws

### I.

The Annual Meeting of this Association shall be held on Tuesday of the week following the Diocesan Convention; but, for good reason, the Board of Officers may appoint the meeting upon some other date.

The place of meeting may be determined upon by vote at an annual meeting, or, failing this, shall be arranged by the Board of Officers.

### II.

In case of vacancy in any office the same may be filled at a stated or called meeting of the Board of Managers, and any one appointed by them shall continue in office until the next annual meeting.

### III.

Special meetings may be called by the President at such time and place as she may designate, for the purpose of stimulating interest in the work.

### IV.

The stated meetings of the Board of Managers, with the President as Chairman, shall be held in May at any place designated, and at these meetings any number present may constitute a quorum.

### V.

It is expected that each parish Branch shall contribute not less than one dollar (\$1.00) to the expense fund.

### VI.

These by-laws may be amended at any annual meeting by vote of majority present.

VII.

The order of services and of business at the annual meeting shall be as follows:

- Holy Communion.
- Bishop's Address.
- Roll Call.
- Reading of Minutes of Last Meeting.
- Reports of Officers and Committees.
- Statement of Future Work—Receiving Pledges.
- Unfinished Business.
- Miscellaneous.
- Addresses or Papers.
- Adjournment.
