The Annual Meeting at Cleveland

May 12, 1927



The Fiftieth Annual Meeting of the Woman's Auxiliary to the National Council, Diocese of Ohio, convened in Trinity Cathedral, Cleveland, on Thursday, May 12, 1927. The Holy Communion was celebrated at ten o'clock with the Bishop of the Diocese, the Rt. Rev. William A. Leonard, assisted by Bishop Rogers, Dean White and Canon Mallett.

Bishop Leonard began his address of welcome with a prayer for China and our missionaries there. Speaking of the past achievements of the Woman's Auxiliary the Bishop said in part, "You have been a splendid band of laborers in His Name. Your Bishops are proud of you. There is one single note I want to strike and that is 'Hopefulness.' I want you to be full of hope. As Christians I want you to realize that hope should be a slogan. Interest women with faith. Hope for great results. In China we have not lost faith. God stands behind the Church and will never allow the Church to be overcome. The missionaries will be going back. You women have a special interest in China. There is the Memorial Chapel to Mrs. Leonard. They pray for us at the altar there. There is also the Nurses' House in memory of Mrs. Leonard. Dr. Mary James, an Ohio woman, is consecrating her life to that work. Dr. Yen, who was a student at Gambier, and other men from Ohio bring us in closer touch with China. Don't be discouraged. May you go out in the new half century with hope and courage and may our Lord accompany you in His great affection."

Bishop Leonard then appointed the Diocesan officers for the coming year and read his annual report, thanking the women of the Auxiliary for all they had done.

Following this, Mrs. E. J. Backus, President, called the meeting to order for business. The minutes of the last meeting were omitted, as they are printed in the Year Book.

Miss Lettie Brenneman, Diocesan Secretary, read her annual report, the greater part of which was devoted to the compiling of the Year Book, a task which takes months of preparation. Next year she hopes every branch will be one hundred per cent in sending reports in early.

The roll-call, which is always a time for excitement, was answered by more than 450, representing nearly every branch. Another roll-call was made of all those faithful women who had served 45 years or more, and the list was a long one.

This being the fiftieth anniversary of the Woman's Auxiliary in the Diocese of Ohio, a special program was prepared to commemorate the event. Printed programs with letters in gold were presented to the delegates as souvenirs. A hymn, written and dedicated to the Woman's Auxiliary, by Mrs. Collacott, was sung to the tune of St. Andrew's hymn.

The report of the President, Mrs. E. J. Backus, came next. The new Year Book, the Book of Remembrance, the Gold and Silver Offering, the Message and her appreciation of all that has been done by the women of the Diocese, were touched upon in this splendid account of a year's work.

Mrs. E. S. Grauel, who was Chairman of the Gold and Silver Offering, reported that \$5,960 was realized from the sale and that friends raised it to \$6,000. Every one was thrilled at the news. "Pray that these gifts be transformed into life, beauty and service" said Mrs. Grauel in closing.

Preceding the noon-day prayers, which were offered by Bishop Rogers, the Gold and Silver Offering was carried to the altar by Miss Elise Backus and Mrs. Grasselli.

As an innovation, Mrs. Backus introduced her staff of officers to the delegates and as each one was presented, she was given time to say a few words in regard to the particular work in which she was engaged.

After all the officers had been presented, Mrs. Collacott paid a beautiful tribute to Mrs. Backus as being one who gives of her strength, time, love, and spirituality and one who has the ability of creating and preserving everywhere a spirit of harmony. Here Mrs. Collacott asked all to stand for a moment in silent assent. Mrs. Backus replied in her customary cheery way and thanked all for the way they have responded.

As a representative of the Diocesan Convention, Archdeacon Patterson was delegated to read two resolutions, passed by that body, to the Woman's Auxiliary in convention assembled.

The following resolutions were adopted by the Diocesan Convention, in session May 11th:

RESOLVED: That this Convention of the Diocese of Ohio go on record as giving its hearty indorsement and moral support to the American Institute for Negroes in its educational work for the negro race.

RESOLVED: That a Special Committee composed of representatives of this Convention and of the Woman's Auxiliary be appointed as a sponsoring committee to study and, when possible, carry through the project of an Ohio Building at the Fort Valley Industrial School for Negroes, Georgia.

The Diocese of Ohio in Convention assembled puts on record its sense of deep gratitude to Almighty God for the completion of fifty consecutive years of devoted service which the Woman's Auxiliary has rendered the Church at large, and more especially the Diocese of Ohio, since its organization in 1877.

The Convention extends to the present organization its sincere congratulations on the remarkable achievements of this past year, and

expresses the hope and belief that the next fifty years will witness a duplication, both in leaders and membership, of the piety, self-sacrifice and devotion to the Mission Cause, which is the Cause of the Church; which same virtues the leaders and the members of the first fifty years have so beautifully manifested in thought, word and deed.

It was deeply regretted by all present that Mrs. Conrey was detained in New York on account of the serious accident which happened to her daughter Dorothy. Mention was made of the chain of book readers, conducted by the C. P. C., in connection with the Bishop's Crusade and the follow-up work.

The last report to be read was that of the Diocesan Treasurer, Mrs. Collacott. She asked that pledge cards be filled out and sent to her as soon as possible. She also thanked the Branches for their courtesy and generosity.

Pledges for work among colored people and the Contingent Fund were asked and the response by the Branches represented was most generous for both askings.

Luncheon was served at one o'clock by the ladies of Trinity. Miss Belle Sherwin, National President of the League of Women Voters, gave a short talk on the aims and work of the League during the hour.

The afternoon session began promptly at two o'clock. Pledges for the Contingent Fund were finished and the remainder of the afternoon was given over to hearing addresses by Bishop Rogers and Bishop A. A. Gilman of Hankow, China.

Bishop Rogers began with his annual report in which he expressed his gratitude for the \$400 given to him by the Auxiliary to be used as a Discretionary Fund. "I am grateful on the occasion of your fiftieth anniversary. I am proud of your work and leadership and thank you for your generosity," said the Bishop. In his foreword, the Bishop began by saying, "The past sustains the future. We do the same things year after year until they become habits. You have a lot of habits in the Auxiliary. You know you are going to have certain things—talking money most of the time. For fifty years you have been doing it. Keeping in the rut. That is my message. The first task that we have in the future is that some things be continued and not let them slip. The past sustains the future and the present encourages the future." Here the Bishop mentioned the four annual Diocesan meetings taking place during the week, particularly of the corporate communion of the Diocesan Convention. He said he hoped the spirit of that most important service would permeate all our gatherings. "We have done the same today. It was a wonderful service. Over three hundred made their communions and dedicated themselves to God's service for the coming year. The Woman's Auxiliary is the largest meeting of this week in connection with the work of the

Diocese." After these introductory remarks the Bishop gave a little time to the subjects pertaining to the work of the Auxiliary, namely: Leadership, Regional Meetings, the Educational Program and the House of Churchwomen. The Bishop concluded by saying that some of the things of the past must go on—responsiveness, loyalty, devotion and enthusiasm. "What you have accomplished in the past gives great joy to me and great promise for the future."

The Rt. Rev. A. A. Gilman, Bishop Suffragan of Hankow, was next introduced by Mrs. Backus. The Bishop, who was President of Boone University for twelve years and who is now head of the Central China University, began his talk with a short history of Boone from its beginning when the Chinese were afraid to enter its doors, up to the present day when Boone is commemorated in the hearts of China. The success attained by our great institutions in China has been achieved by their leaders' strong belief that in order to have a preaching mission we must have a teaching mission. While here in America the Bishop said he hoped to raise \$7,000 for a Girls' School at Boone. The first subscription was a ten-dollar gold piece given by a woman who had received it as a gift. Other women followed her example and now the Bishop has no difficulty getting gold pieces wherever he tells this story. A number of the delegates helped to swell the fund by their generous offerings. "The Chinese have a great desire to develop a National system of education and to do that they must simplify their language. The students must have freedom to attend religious services. I ask the Church to back us. Our Church has accomplished a great work but compared to what must be accomplished is as a mustard seed."

Mrs. Evans, Chairman of nominating committee, reported the following names to go as delegates to the Conference at Racine next October: Mrs. Ireland, St. Barnabas Guild; Mrs. Ginn, Girls' Friendly Society; Miss Kimball, Daughters of the King; Mrs. Conrey, Church Periodical Club and Mrs. Backus, Woman's Auxiliary.

A rising vote of thanks was extended to all members of the Cathedral for their gracious hospitality to the visiting delegates.

The meeting came to a close with the reciting of the Dedication and the benediction by Bishop Gilman.

Report of the President



It is not of results that my report will tell you, for we have been dealing with beginnings through this past year—beginnings in which your cooperation and interest have been most helpful and encouraging.

After our Annual Meeting in May a letter was sent to the clergy of the Diocese, asking them to appoint a representative in their parishes, to spread the knowledge of and gain new subscribers to the Spirit of Missions, if one had not already been appointed by the Church Periodical Club. The one appointed was to write to Mrs. H. L. Wallau, 3051 East Derbyshire Road, Cleveland Heights. A few wrote to Mrs. Wallau, but not as many as we could wish.

I sent a letter to the Presidents of the Branches, asking their interest and prayers in behalf of the Lausanne Conference, to be held in August, 1927. Inclosed with my letter were prayers and leaflets explaining the hopes and objects of the Conference. If these were used, the lectures given this fall by Bishop Rogers on this Conference must have been of more than usual interest through the knowledge you thus gained.

As the Woman's Auxiliary Message has been given to you many times, recalling to you the spiritual motives of our organization and calling to you for reconsecration and dedication to the work of the Master; so I also wrote to the Presidents of the Follow-up-Work of the Bishops' Crusade. I suggested to you that you consult with your rectors, and with their aid plan for Quiet Hours or Days, for Prayer Groups, Bible Classes and more frequent Communions; all of the things most helpful to the growth of the spiritual life, hoping that some of my suggestions might be carried out in your parishes.

To draw us closer together as an organization, a letter was sent, with a program carefully prepared by our Educational Secretary and myself, suggesting that the Woman's Auxiliary of our Diocese might be united in "Prayer! Study! Service!" We gave the dates and plans of the meetings at headquarters, that you could follow if you wished. A list of speakers for your meetings was also given.

These letters were sent to the Presidents of the Branches of the Auxiliary with the hope that they would be read to the members, and taken to their rectors for help and advice. I beg that my letters may not be thrown into the waste basket or put aside and forgotten. They take time and strength, and are sent out after thought and prayer.

We have on the Board of Officers a new member, representing work for friendliness and interest in our Foreign-Born neighbors, Mrs. Eleanor Ledbetter is well known for her helpfulness in making happier the citizens of our city who have come from foreign lands. Through her initiative and suggestion we have given three teas: one at St. Mary's for the women of St. Michael's Church; one for the women of St. Mary's Roumanian Church at St. Mark's, and one at St. John's for the Greek and Russian Churches near that Church. Mrs. Ledbetter and I have been very grateful for the interest and cooperation given by the women of the Cleveland Region, especially the Secretary, Mrs. J. J. Greenway, who has been most helpful in sending notices and arranging the details of the meetings.

The Automobile Corps has been enlarged and the members of this Corps have been most gracious in answering the calls to carry the women to and from these meetings.

A Chairman has been appointed to take an interest in any isolated churchwomen in this Diocese. Mrs. O. P. Stafford, of Boardman, has given her time to write to those whose names have been sent us through the courtesy of the Rev. Mr. Bilkey of Defiance, and the Rev. Mr. McIlwaine of Cuyahoga Falls. Mrs. Stafford's letters are not

always answered, but she is not discouraged, and it is hoped that some one is made a little happier through the interest shown.

In the interest of Christian Social Service, our organization was asked to help educationally by telling of the work of this department of the National Council. Miss Florence Sanford, Field Secretary of the National Church Mission of Help, was invited to come into the Diocese and explain the methods and work of this organization. She came to the Diocesan Institute in October, and afterwards went to many parishes as planned for her. Her visits gave great satisfaction; and much interest has been aroused in her work.

Canon Mallett has given generously of his time and knowledge of Christian Social Service. We are very grateful to him. We have a committee within our organization, with Mrs. Frederick C. Trussell, Secretary, to advance further our work in this line. We have but made a beginning.

Again I ask your interest in the Diocesan Altar Guild, with Mrs. Charles Lang and her small corps of workers. Read her report in the new Year Book, and learn what can be done by constant and unflinching attention by devoted Christian women.

All reports of meetings in the Regions and Branches, and any items of interest in women's work throughout the Diocese, should be sent to our Faithful correspondent of "Church Life," Mrs. Frank H. Jewitt, 3668 Riedham Road, Shaker Heights, Cleveland.

We have ninety-five branches of our organization in the Diocese; two new ones added this year: North Madison under the Rev. Mr. Colby and Gates Mill, under the Rev. Dr. Jackson. Some of our branches are very weak, often made so by the departure of a strong woman's Auxiliary woman from the town or a change of rector, or a lack of vision in those who should be interested.

It seemed to your President a helpful thing this year to visit some of the branches, to meet with women who are not able to attend the Regional Meetings. So, with one or another of the officers of the Board, I have visited St. Alban's, Cleveland; Trinity, Cleveland; St. Andrew's, Akron; St. Peter's, Cleveland; St. Paul's Cleveland; St. Philip's, Akron; St. Martin's, Cleveland; St. John's, Cleveland; Church of the Advent, Cleveland; St. James', Boardman; St. Paul's, Mt. Vernon; St. Margaret's Guild of St. John's Church, Cuyahoga Falls; Christ Church, Geneva; Church of the Redeemer, Lorain; Christ Church, Oberlin; St. Timothy's, Massillon; Trinity, Alliance; and St. Christopher's, Gates Mill. I have attended all the meetings of the Cleveland Region and the annual meetings of the Church Periodical Club; the Daughters of the King; the Girls' Friendly; the meetings of the Bishops' Crusade when held in this city, and the Fellowship Teas for the women of the foreign churches.

It is not necessary to give the number of letters written, or the conferences, committee meetings and board meetings held. These are all a part of the work of a president; and, as your President, I am happy to do the work to the best of my ability.

Without my splendid Board of Officers I could not carry on this work. Each one not only carries on with great ability her own department, but is ever ready to help loyally in any undertaking of the President. The machinery of our organization, through their work, moves quietly, but effectively.

Thanking each and every member of our Diocesan Woman's Auxiliary for the appreciation and affection which have been shown in many and beautiful ways, I pray that the same spirit of loyalty to God and the organization may ever be with us.

Report of the Fourth Vice-President



Two meetings of the Akron Region were held during the year.

The spring meeting was held at St. Paul's Church, Canton, on May 23rd, eighty-two women being present. The celebrant was the Rev. Mr. McCowatt, the rector, assisted by Rev. Mr. Keeler, of St. Paul's, Akron. The speakers of the day were the Rev. Dr. Patton and Mr. H. A. Hunt, Principal of the Fort Valley School, Georgia. A group of colored men under the direction of Mr. Hunt, sang several negro spirituals, which were greatly enjoyed. A plea was made for the Ohio Building, a Boys' Dormitory, at the Fort Valley School.

The fall meeting was held on October 29th, at St. John's Church, Cuyahoga Falls, one hundred and twelve women attending. The educational work of the Diocese was informally discussed and the Rt. Rev. John C. White, D. D., Bishop of Springfield, was the speaker of the day. He told of the pressing need in his Diocese and aroused much interest in his hearers with the result that \$230 was pledged to help him in his work.

The Youngstown Region held two all-day meetings during the year, each one proving most inspiring and helpful to those who attended.

On May 24th, at St. James', Boardman, the day began with a celebration of the Holy Communion, the celebrant being the rector, Rev. Mr. Vaughn, the music rendered by the choir adding greatly to the beauty of the service. At the business meeting which followed, officers for the ensuing year were elected. Fifteen dollars was given toward the expenses of a woman delegate to the Gambier Summer Conference.

Mrs. Backus and Mrs. Anderson gave very interesting addresses, the former stressing the fact that only the best trained women should be sent as missionaries to the foreign field. Mrs. Anderson emphasized the need of an educational leader in every parish and a definite program.

After luncheon the meeting was addressed by Canon Mallett, of Trinity Cathedral, on the subject of Christian Social Service. His presentation of the subject was very illuminating and instructive.

The second meeting was held at Christ Church, Warren, on October 20th, eighty women in attendance. Following the service of Holy Communion, Rev. Mr. Schultz, celebrant, Mrs. Edgar Tricker, our representative at the Gambier Conference, gave a most interesting account of her experience while there.

Miss Florence E. Sanford, Field Secretary of the Church Mission of Help, held the interest of the women in her able discussion of the problems pertaining to her work.

All of these meetings have proven most helpful in bringing together our women, uniting and inspiring them to greater efforts for the furtherance of Christ's Mission in the world.

Report of the Secretary



This has been an unusually active and interesting year for the Woman's Auxiliary in this Diocese, and a very profitable year. From the brief reports read today, and the reports and activities of all the Branches recorded in our new Year Book, one cannot but feel that the year has been one for which we can be thankful, and rejoice in the thought that we have had a part in its achievements. In reviewing the progress of the past year we know that one of the factors to bring such satisfactory results has been the Educational Program.

Our energetic and loyal President, Mrs. E. J. Backus, has visited most of the parishes, giving helpful talks on the Woman's Auxiliary, the "Message" and the Devotional Life. And the leaders of the different departments on the Diocesan Board have held conferences in many parishes, particularly the smaller and more isolated ones, explaining their special work — Religious Education, United Thank Offering, Church Periodical Club, and the Supply Work. Also two National officers spent two weeks in the Diocese giving helpful talks in many parishes. And the Regional Meetings, held in different parts of the Diocese to give opportunity to every Branch to send delegates to hear the fine speakers and get the enthusiasm that comes with large gatherings.

Another outstanding event to give educational and inspirational help was the splendid Conference for Church Workers at Gambier. More and more the church people are taking advantage of this opportunity for enlightenment. Then the Quiet Days of meditation and prayer, which gave spiritual impetus which was the real power back of all our undertakings.

The result of all these privileges has been co-operation and intelligent service on the part of our Auxiliary women.

Your Secretary has had, as usual, a busy but interesting year. The task is rather strenuous, and at times, monotonous. Writing the many letters, sending out literature, blanks, Year Books and notices of Board meetings and keeping the records of these sessions. But, if your Secretary did not choose the office, she accepted it, and her desire is to do the task acceptably, and this can best be accomplished by the co-operation of the Branch officers. I want to thank the secretaries who sent in promptly their reports and other information for the Year Book. Your personal notes are always appreciated. I waited a month for reports from fourteen Branches, then sent a second letter to which most of the secretaries responded. Let us again emphasize promptness, also carefulness and legibility in making out our reports—care in placing the money and boxes in the right fields. If given for the Diocese, put it in the Diocesan; anywhere under the American flag, in the Domestic. If to a foreign nation, put it in the space marked "Foreign." As these reports represent our missionary activities—what we do for others—we cannot, therefore, report what we do for our own parishes. This co-operation is a great help in compiling the Year Book.

The books are now ready and four will be given free to each Branch after the luncheon. If extra copies are wanted there will be a charge of twenty-five cents per copy. Please read it from cover to cover. You will find an answer to any question regarding the work of the Ohio Branch of the Woman's Auxiliary. May I again suggest that you make your first meeting after this gathering a Year Book meeting, reading and discussing the contents. In other words, "Read, mark, and inwardly digest" the contents. I would call attention to the reports of your Diocesan Officers, as they are messages to you. Our Memorial page this year contains the names of so many of our co-workers who have entered into the Paradise life. In memory of their lives and work, may we stand in silence a moment.

With gratitude for our privileges and blessings for the year that is past, which resulted in earnest work for Christ and His Kingdom, let us go forward full of hope for the future.

The Pledge Cards have proved helpful as memoranda, but have resulted in a continued renewal of old pledges with no increase. There are many causes which need help. The "Spirit of Missions" will suggest some of these to you and there are always our Mission Fields and Missionary Dioceses like Alaska, the Philippines, South Dakota, Liberia, etc., gifts to which apply on your quota and to which we make no definite Diocesan Pledges.

Report of Educational Secretary



How many of us realize as we study throughout the year just what is our relation to the task of education?

Of what help to us are the use of Church papers, Book Reviews, Discussion Groups and the many other avenues open to us through which we acquaint ourselves with the Church and her mission?

Do we see any definite results from this knowledge of conditions outside of our own Parishes?

Yes, we see results in increased praying, giving and serving.

The Woman's Auxiliary, including education in her program through many years has stressed study of the Church and her work in the world. A leaflet of Suggestions, sent out early in the fall, containing a reading list and information as to text-books and materials for study during the entire year, is widely used throughout the Diocese.

The Seasons of Advent, Epiphany and Lent are considered the most profitable times for study.

The books used during 1926-27 were many and varied as to subjects.

The World Call to the Church, Beyond City Limits, A Church Awake, The Episcopal Church, Some Elements in the making of a Christian, Talking with God, The Christ of the Indian Road, Our Templed Hills, Whither Bound in Missions, Wild Geese, So Big, John Frederick Oberlin, The General Church program, Mother India, Church Symbolism, Religion Versus Science, The Modern Use of the Bible, The Ministry of Laymen, Christianity and the Race Problem, the Cost of a New World, The Bible.

Mrs. E. S. Grauel, Painesville, Educational Secretary of the Lake Region, made a fine contribution to the educational program in leading the class on A Church Awake, at the Gambier Summer Conference and conducted a Normal Class for the Lake Region on the same book in connection with a School for Church Workers. Again

presenting A Church Awake at a Diocesan Institute held in Cleveland on October 13, 14. We are most grateful to her for this outstanding work for the training of Leaders.

This Institute had a registration of ninety-two with all Regions represented by one or more.

From the study of the Rural Problem, came a response of interest in terms of money contributed by some study classes and a few Auxiliary branches; this money enabled us to send two men from Ohio to a Conference for Rural Workers held in Madison, Wisconsin.

The Rev. C. L. Bilkey of Defiance and Rev. J. R. Colby of Geneva, were the men chosen because their work is in Rural Ohio.

We were thankful for this fund and believe the work will be strengthened where these men are now serving.

Forty-five Parishes report as follows:

Program meetings 249. Reading Circles 4. Prayer Groups 14. Prepared Papers 64. Bible Classes 14. Stereopticans in Province and Dioceses 195. Plays 8. Pageants 3. Book Reviews 23. Study Classes 31. Delegates to Summer Conferences 23. Church Papers used in Parishes 32. Pieces of Mail 875.

May I call to your attention the Lantern Slide Bureau in Cleveland, at Emmanuel Parish House in charge of Miss Ada Crary who will be glad to confer with you as to its use in your Parish programs.

Perhaps you will notice the absence of Regional Institutes from this year's report. There is a reason! Because of importance of the Bishops' Crusade and the many missions conducted and the meetings held for its furtherance, it was deemed best to give way to that, during the time when we usually have our institutes.

For 1927-28 we are asked to study and discuss earnestly A Church Awake, (Sturgis). The title indicates an indifference to our obligation as Christians that must be overcome.

The book presents vital elements of the Gospel, and is intended to be a follow-up of the Message and the Bishops' Crusade for Personal Evangelism.

Such searching questions as: Why the Church? What is the Church? What is her Mission? To whom is her Mission addressed, should be given careful thought. They are questions that should be taken to heart by all who believe in Christ and His Gospel.

The value of such a method of study with free discussion is untold and should prove to be a force in molding Christian thought on all matters concerning the Church's Mission, beginning with the individual, from the parish, and into the whole wide world.

The Annual Report of the Church Periodical Club

In the Diocese of Ohio, from January 1, 1927 to January 1, 1928



The work of the Church Periodical Club during 1927 has been carried on along the usual lines. This does not mean however that the work can ever become monotonous, since each year brings us new friends and forms closer ties with our old ones.

The Church Periodical Club offers opportunity of helping our Church workers all over the world. We have a real live interest in the missionary's wife in Mosul, Arabia, as we respond to her call for a book of designs, for fancy work, or in the men at U. S. Naval Station in Island of Guam when we send to the Chaplain a package of pictures from New York Times.

One foreign worker writes, "Our friends at home have no idea of the terrific isolation and loneliness in a missionary's life." He needs diversion and relaxation after the daily grind of duty and the Church Periodical Club is the one department in our church whose duty it is to respond to just such needs. Every bit of help we give a man increases his efficiency. We can send good magazines, inspiring books of travel, biography, fiction and religion, and without such help he becomes unfitted for his work. The personal interest that plays so big a part in our Church Periodical Club is a help to both giver and recipient.

During 1927 our money gifts for libraries amounted to nearly \$550. This was sent to Headquarters to buy books for Boone University, Wuchang, China, and for St. Philip's School for Girls at San Antonio, Texas. This coming year our Special includes three libraries for which we ask money: One for the Girl's School at Valle Crucis, N. C., for mountaineer girls, one at Ethete, Wyoming, for Indian Boys and Girls, and the third for Japanese boys at St. Paul's, Tokio, where Bishop Reifsnider is President. These three schools are of varied interest and should engage our best efforts. We hope to give a substantial sum of money to each of these school libraries. The books asked for are not to be found in our private libraries.

In some parishes we have had the active help of the young people. The Kappa Beta Kappas have pledged their support to the work and we hope to enlist the interest of all young peoples' societies in the diocese. There is much in the recreational part of the Church Periodical Club that is attractive to young people and the doing of which means a tremendous help to the work. Every parish house should be supplied with posters setting forth the needs of the Church Periodical Club, that our church friends may know we will welcome gifts of reading and recreational material 366 days of the year.

We have had two conferences for the Librarians of the Diocese, both of which were well attended and both of which proved to be most helpful in the exchange of ideas and plans. Your Director has presented the Church Periodical Club work in twenty-two parishes and

she will welcome an invitation to any parish at any time, where there is no Branch or where the work needs fresh interest.

With heartfelt thanks to all the Librarians and to the many friends for their gifts of money and material, we again bespeak your interest and support for their splendid work for the year 1928.

Information



The Ohio Branch of the Woman's Auxiliary has as its representative in China, the principal of St. Mary's Hall, Shanghai. Her salary has been increased to nine hundred dollars a year on account of living costs. Please send generous gifts to Mrs. H. R. Collacott, Treasurer.

Since the founding of St. Paul's Mission at Glen Alpine in the Blue Ridge Mountains we have had the honor of supporting it. Our very successful missionary there is Mrs. Eva Joyner Barrett. The work has grown so much that we have now provided Mrs. Barrett with an assistant. The sum for which we pledge ourselves to Glen Alpine is seven hundred dollars.

The "Bishop Leonard Fund" is for use among the missions of Ohio, when and where the Bishop thinks it best. We have pledged to him five hundred dollars.

The "Bishop Rogers Fund" will place in the hands of the Bishop Coadjutor, a sum for use at his discretion among missions in the Diocese.

The "Expense Fund" covers the cost of publishing the annual report, occasional circulars or leaflets and notices, postage in several departments, traveling expenses in starting new Branches, and that of missionaries whom we invite to address us. With the enlarged scope of the Supply Department, there are expenses for freight, express and postage. To meet the demands on this fund it must be materially increased.

The "Contingent Fund" is available for all sorts of emergencies. It is the large feature in the work of the Supply Director. We ask the women of the Branches to give special thought to this work. An increase of pledges is earnestly solicited and will be carefully expended. All money and checks for this fund should be sent to the Diocesan Treasurer, Mrs. H. R. Collacott, 246 South State Street, Painesville, Ohio.

The Bishop Bedell Scholarship and the Julia Bedell Scholarship pay for the education of native pupils in St. John's University, Shanghai, China. They require \$70 each per annum. The "Ohio Scholarship" in St. Elizabeth's—one of the Bishop Hare Schools in South Dakota—pays for the education of an Indian pupil; it requires sixty dollars per year.

The Sarah L. Leonard Scholarship—St. Mark's School, Nenana, Alaska, \$200 per annum.

Kuling School China, is a school for the education of the children of Missionaries and pledges are asked for its support.

The "Foreign Insurance Fund" provides insurance upon the lives of foreign missionaries for the benefit of their families. We, of the Ohio Branch, have for more than forty years contributed annually to this fund. Our pledge is one hundred dollars a year.

All pledges are payable to Mrs. H. R. Collacott, 246 S. State Street, Painesville, Ohio. In the case of a "special" when a custodian

is named, all money may be sent direct to the collector, who later reports to Mrs. Collacott.
