The Annual Meeting at Cleveland

May 16, 1929



The Fifty-second Annual Meeting of the Woman's Auxiliary to the National Council, in the Diocese of Ohio, convened in Emmanuel Church, Cleveland, on Thursday, May 16, 1929. The Holy Communion was celebrated at ten-thirty o'clock with the Bishop of the Diocese, the Rt. Rev. William A. Leonard, assisted by the Rt. Rev. Warren L. Rogers, Bishop Coadjutor, the Rev. Kirk B. O'Ferrall, Rector of the parish, and his assistant, the Rev. William Munds.

As always, Bishop Leonard extended a hearty welcome to the delegates and expressed his grateful appreciation of their helpfulness to him. Referring to the celebration in honor of his fortieth anniversary in the episcopate, the Bishop paid a splendid tribute to the clergy and laity because of their faithfulness and loyalty to him and the work of the Church. "We are fellow laborers with Christ," he said, "and I want you to exalt your privilege of being in fellowship with God."

The annual pledge of \$500, which is known as the Bishop Leonard Fund, was used for the purpose of augmenting the salaries of three colored clergymen, one deaf-mute missionary, and our Italian missionary. This amount was graciously acknowledged with thanks by the Bishop.

The appointment of Diocesan officers for the coming year was then made by Bishop Leonard, who named Mrs. Eliza J. Backus, President; Mrs. John G. Anderson, first Vice-President; Mrs. Rupert Holland, second Vice-President; Mrs. Charles C. Bubb, third Vice-President; Mrs. L. W. S. Stryker, fourth Vice-President; Mrs. James B. Ireland, Vice-President-at-large, Miss Lettie Brenneman, Secretary, Mrs. H. R. Collacott, Treasurer until October 1st; Mrs. W. H. Bingham, Supply Director; Mrs. Samuel E. Strong, United Thank Offering Director; Mrs. John G. Anderson, Educational Secretary; Mrs. Ralph M. Evans, Assistant Educational Secretary; Mrs. D. W. Conrey, Diocesan Correspondent of Church Periodical Club; and Mrs. Eleanor E. Ledbetter, Director of Foreign-Born Work.

The young folks and their problems is a subject which is enlisting the interest of both young and old these days. The Woman's Auxiliary was fortunate in being able to have Miss Clarice Lambright talk to them on this important topic at their morning session. Miss Lambright, who is Advisor of the National Federation of Young People, began her address by calling attention to the great tie which exists between the young people and their elders. "They are trying to follow our example," she said, "and they need our sympathy and understanding." The purpose of the Federation, as explained by Miss Lambright, is study and extension of the work of the whole Church through the young people. Being a Christian is their major interest and giving of themselves in work, study and gifts in each of the five fields of service. Many times boys and girls lose their faith and they

look to others for strength. This is an opportunity for us to help them face the real issues of life.

Before calling the meeting to order for further business, Mrs. Backus, Diocesan President, extended her greetings to all present. "In the eight years I have been with you," she said, "I have grown in knowledge of your friendship and I know it is reciprocated." She then asked Bishop Rogers to offer the noon-day prayers. Following this, the Bishop thanked the women of the Auxiliary for the \$300 which they had given him, and reported that he had used this amount among the clergy during sickness and death.

Before roll-call, Mrs. Backus asked that a motion be made to omit the reading of the Secretary's report, as it is printed in the Year Book. The motion was duly made and carried. Four hundred and seventy-one responded to the roll-call, but the number was greatly increased later in the day.

Miss Brenneman, Diocesan Secretary, announced that the new Year Books were ready for distribution and requested the delegates to procure them after luncheon. In memory of all our co-workers who have gone into that other life during the past year, Miss Brenneman asked all to stand in silence for a moment.

The following notices were then given by Mrs. Backus: that Miss Mather invited the delegates to an afternoon reception at her home where they could meet Dr. Elliott; that anyone wishing to confer with Mrs. Lang, Diocesan President of the Altar Guild, could meet with her in the church parlor; that anyone desiring to do so could look at the Book of Remembrance. Any sum, as low as \$5.00, may be given in remembrance of a church worker. The amount raised thus far for the Endowment Fund is now \$14,646. Mrs. Backus said she hoped the Mid-day prayers, which she sent throughout the Diocese, would be used as a bond of union among us.

After the singing of the Auxiliary hymn, Mrs. Backus presented her annual report in which she touched upon the General Convention in Washington, the Corporate Gift, Christian Social Service, Isolated Churchwomen, and a plea for greater interest in the Spirit of Missions. She also mentioned the many speaking engagements she has filled throughout the year, as well as attending a large number of meetings and conferences. In closing, she expressed her regret in the retirement of Miss Katherine Mather, United Thank Offering Treasurer, Mrs. E. S. Grauel, first Vice-President and Mrs. H. R. Collacott, Treasurer.

At one o'clock the delegates recessed for luncheon.

The afternoon session began with the report of the Diocesan Treasurer, Mrs. Collacott who thanked the Branches for their promptness in the payment of pledges. In regard to the Corporate Gift, \$1,000, which was pledged as our share toward the building of the Church in Santo Domingo, Mrs. Collacott announced with pleasure that the amount had been overpaid, and that the next pledge would be applied on a building in the Canal Zone. She requested that all money be sent to the Treasurer, otherwise no credit will be given.

The Contingent Fund is important and must be kept up. The sum of \$93, balance of a three-year pledge made to Boone Library, was promised by six of the Branches.

The speaker of the afternoon, Dr. Mabel Elliott, was next introduced by Mrs. Backus. Before beginning her talk on St. Luke's Hospital, Dr. Elliott paused to express her sympathy to the people of Cleveland, in their great distress over the terrible disaster of the Clinic Hospital.

In the words of the Master, "Suffer the little children to come unto me," she heard the call of service among the children of Japan. She has established clinics, not only for sick babies, but a well-baby clinic, where the mothers come to learn how to care for their little ones that they may become strong and healthy. In speaking of the new St. Luke's, which is to cost \$2,500,000, Dr. Elliott said she had been asked why the Japanese do not build and pay for the hospital themselves. "The answer to that question," she said, "is three-fold: first, that we do not want to be left out of it; second, it is a missionary project; and third, the people of Japan are too poor, having no national resources as we have. The emperor has already given \$25,000, and his people have donated \$400,000, a large sum according to their wealth."

Dr. Elliott described Dr. Teusler as being a man of unusual personality, who by his patience and persistence has developed the institution to what it is today.

"St. Luke's is not only a hospital but a hospital center. Among the 10,000 school children in one ward, there are from 110 to 150 who come to the clinic every day. This work is important, as we get in touch with the parents. We now have district nurses who visit the mothers in their own homes, a thing unheard of before western civilization came to Japan. The death rate among babies there is very high. St. Luke's has set about to correct this. The Japanese hospitals are better than St. Luke's as far as research work and fine laboratories are concerned, but the Japanese people are not practical. We are tearing down the old institutions, founded on fear and superstition, and are endeavoring to show them the Christian way."

The delegates pledged nearly \$2,000 toward the new St. Luke's.

With appropriate and pleasing remarks on the splendid achievements of Dr. Elliott, not only in Japan, but in other lands, Bishop Rogers brought the meeting to a close with the benediction.

Report of the President



Greetings to my Fellow Workers in the Woman's Auxiliary:

I have served with you in the Diocese ten years: three as Acting President during Mrs. Knapp's illness, and until she was called to higher service; and six as your President.

Your co-operation has made these years happy ones. I see here today many familiar faces. They have become dear to me, as the years have passed. I appreciate the effort you have made to come. I pray you may go back to your parishes with renewed faith in the work that you are doing; with the inspiration that comes from being with others who are interested in the same things; and with consecrated courage to press on, notwithstanding many handicaps and many other calls that must be heeded.

Last winter an enthusiastic Woman's Auxiliary member in Akron, remarked, "I want all my Branch to be at the next Annual Meeting; it is wonderful to see and talk with others interested in the same work we are doing. I have never felt, since our last meeting, that we were a small, isolated branch. I feel we belong to a valiant company, pressing on to do God's work, in Christ's name." I hope you will all go home with the feeling that you are not working alone; that in the great fabric of the Church's work you are helping to fill out the design, so that not one stitch of the great pattern may be left out.

Each year brings added interests, and what we like to call greater adventures.

I have attended a Conference of Officers at Racine; the Provincial Synod at Indianapolis; and the Summer Conference at Gambier.

We are happy to send Mrs. J. G. Anderson to the Rural Conference at Madison, Wisconsin, by the aid of interest from the Endowment Fund. That fund is gradually increasing; and, with the gifts, names long connected with the Auxiliary work of the Diocese are written in the Book of Remembrance. They are a splendid company who have joined the Church Triumphant; and we, who believe in the Communion of Saints, know that they rejoice in all the efforts we are making to spread Christ's Kingdom on the earth. I wish I might speak of each one of the members who have been called away, some of whom were dear and intimate friends.

I reported our activities in January of last year in my report for 1928. We are still working toward some plan for Christian Social Service in our Auxiliaries. You will remember that I reported last year the pleasure and interest given to the Cleveland Region by the Rev. Dr. Nelson, whose services were given to us through the generosity of the Social Service Commission of the Diocese. The Diocesan Board of Officers made an effort to show friendliness towards the Social Workers in the city, by giving a tea with the help of the always gracious assistance of the Emmanuel Auxiliary.

In our Foreign Work a tea was given by the Cathedral Auxiliary to the Greek Bishop from Chicago, and to his friends who came with

him, and to the members and friends of the Greek Church where Father Zagrofes, whom we all like and respect, is priest. The service, splendidly arranged by Dean White, for the Greek Bishop, was well attended. We, as an Auxiliary, were happy to have a part in it. We were invited to attend, on the following evening, the services at the Greek Church. I was happy to see many of our women there. I hope that some of this same friendliness may be shown in other parts of our Diocese to foreign-language neighbors.

With Mrs. Ledbetter I attended a service in the Roumanian Church on the West Side, at the celebration of the Twenty-fifth Anniversary of the founding of their Church. I gave a short address, at the request of their priest, expressing the wish of our women for increased friendliness and neighborliness. As I was leaving the city, I asked Mrs. Anderson to go with Mrs. Ledbetter to their banquet, given later. She also spoke of our hope for future pleasant relations.

Our pledge, given at the Washington Triennial, for the Church at Santo Domingo, was met, as pledged, by Easter of 1929. Next year our gifts will be for the Advance Work of the Church. The Budget prepared by the National Council can pay only for the necessary expenses of the Church's work. Through our Corporate Gifts and the United Thank Offering, the Advance work, for the most part, has been carried on by the Woman's Auxiliary. During the next year, the whole Church, men and women, will work for the better equipment of the Church's work in the missionary fields everywhere. Ohio has never failed; and we will, with greater zeal than ever before, do our part for this Advance Work.

We were asked by the Publicity Department at headquarters to send the names of the Presidents of our Branches, that letters might be written through that department in interest of the Spirit of Missions. I hope answers were given promptly, with the offer of help in increasing subscriptions. Mrs. Gordon Rieley, 3344 Dorchester Road, Cleveland, has been appointed to receive your reports of the number of subscriptions you are able to obtain in your parish; also renewed subscriptions. I would like each President, on her return to her parish, to find out who is the representative in her parish, and send the name to Mrs. Rieley.

I have asked the Regional Chairmen to have a publicity chairman in each region, to report to "Church Life," through our Correspondent, Mrs. Frank H. Jewitt, and to the President, activities in that region.

Mrs. O. H. Stafford, of Boardman, and I have been made very happy by the interest shown in the letters written to "shut-ins" and to isolated Church women. Huron, Youngstown and Mt. Vernon have sent us names of women who have responded to letters sent them. A form has been sent to each clergyman in the Diocese, asking for the name of anyone in his parish, or vicinity who would enjoy such letters. The Church Periodical Club is sending magazines when asked for; and Christmas cards were sent to our correspondents.

I have been happy to report to headquarters more Corporate Communions, Quiet Days and Prayer Groups than in the past.

My calendar has been full this year. I have met the presidents of the Cleveland, Akron, Mansfield, Fremont and Toledo Regions; also the Regional Chairmen, for conference and mutual helpfulness. I have attended the Board meetings; all the Cleveland Regional meetings and Quiet Days. I was happy to represent the women of the Diocese at the anniversary of Bishop Leonard's forty years of service in the Diocese. I was glad to have an opportunity to speak to the Kappas and Sunday-school teachers at St. Paul's on the Heights. I have visited in Cleveland: St. Paul's, East Cleveland; St. Paul's on the Heights; Ascencion; Church of the Incarnation and Grace Church. Through the Diocese: Church of Our Saviour, Akron; St. Andrew's, Akron; Mansfield; Fremont; Toledo; Sheffield Lake; St. David's, South Lorain; Youngstown; Medina; Dennison; Port Clinton; and Epiphany, Euclid.

Mrs. Collacott's resignation was a real sorrow, although we have been blessed in the acceptance by Mrs. Clifford Cowin of the appointment to be our Treasurer; and she is ably doing the work. Mrs. Conrey's resignation, after her ten years of inspiring service, has been another sorrow. She is greatly loved throughout the Diocese. With her usual care she has been training those who will, with consecrated service, take up the threads of her work, that her going has loosened; namely, Miss Ann Brown of Emmanuel, and Mrs. G. L. McCracken of Akron. Mrs. Grauel is remaining on the Board, helping your President in sending out letters you receive from time to time. She also looks after the names to be written in the Book of Remembrance, so that all the names are found there in her beautiful handwriting. I have been gratified this year by receiving some most appreciative replies to my letters, affording the comforting assurance that at least not all my letters have been thrown, with other burdensome mail, into the waste paper basket.

You will be happy to know we have been able to send the \$10,000 promised for St. Luke's Hospital, Tokyo.

We have received letters from our missionaries whose salaries we are paying: Miss Fullerton of St. Mary's Hall, Shanghai, and Mrs. Joyner Barrett of Glen Alpine, North Carolina.

Before closing this report, I wish to ask certain questions for your thoughtful and prayerful consideration: Are you putting emphasis on the devotional life of your Branch? Have you frequent Corporate Communions; at least two a year? I quote from an address to the Woman's Auxiliary by the late Bishop Brown of Virginia: "Get into closer touch with the Master. Live with Him more. He is the Life that is really Life. Love is the great solvent of all difficulties. Money is necessary in our work; but the great power is intercessory prayer." Other questions I want to bring home to you. What are you doing to bring young women into your Branches? Our Bishops think and say that the Women's Auxiliary is a power in the parish. Try having a Membership Committee in your Branch to see that every woman in your parish is invited to join you in some part of your work. Do you study the Church's Program, to know what Budget-Quota and

Advance Work mean? Do you take any interest in your parish "Nation-Wide" Campaign? Do you pray for your Presiding Bishop and for the Treasurer of the National Council, weighed down and discouraged by the heart-breaking requests of our missionaries at the front, that cannot be granted through the Budget? Are you interested in the needs of the institutions in your community, and in those they are helping? Are you encouraging your rector in all his efforts with your sympathy and co-operation, and attending the services he plans for the bringing of Christ's Kingdom on earth?

The year of 1929 we leave in His hands, Who knows the frailties of our natures, and Who can forgive all our mistakes and failures.

May I leave this prayer with you?

"Give us, O God, the power to go on;
To carry our share of service to the end;
To live all the years of our lives
Faithful to the highest we have seen.

Give us the power to give ourselves;
To break the bread of our lives
To starving humanity;
In humble subjection to serve others,
As Thou, O Lord, dost serve Thy world."

Report of the Secretary



December 31, 1929, brings to a close another year of joyful service for the members of the Woman's Auxiliary in the Ohio Diocese. It has been a year of progress along many lines. We cannot measure the spiritual value of our work, but the fine things that have been accomplished show effort and sacrifice, and a splendid co-operation.

As you read the reports of all the Branches in the new Year Book, and compare them with the reports of last year, you will note an increase in some of our gifts, but a decrease in many others, which is unfortunate. Our United Thank Offering, which means so much to our women missionaries, has also fallen short. Realizing our failures, we can make a fresh start and do greater things than ever before.

As your Diocesan Secretary, you doubtless expect me to render an account of my stewardship. But we are all familiar with the duties of a secretary; therefore it seems a waste of time to tell in detail of the many letters, notices, reports and Year Books sent all over the Diocese. Of the Year Book, I could write pages, being "fed up" on it for three months while making the copy, corresponding with the printers, reading the proof, and finally, placing the finished product

in the envelopes for each Branch; but I have explained this task in detail in former reports, until, as the children say, "You know it by heart."

This report will be a sort of heart-to-heart message to the Branch Secretaries. First, however, I want to express my deep appreciation to the secretaries who sent in their reports so promptly, and the work carefully done. The typewritten reports are a joy to your secretary, and your personal notes are always appreciated.

More reports came in on time than in any previous year, but too large a number were remiss. In some cases it took two, and often three, letters before the desired information was received. The following are some of the reasons given for the delay: The Branch was not functioning; the secretary had lost the report blank; the new secretary had not received a blank. In this last case, the Diocesan Secretary had not been notified of the change in officers, consequently, the mail was sent to the wrong address. In the meantime, work on the Year Book was delayed, causing the Secretary some annoyance, to put it mildly.

I think I can help the secretaries, who are new in the work, by giving suggestions for making out these reports. When the secretaries receive the annual report blanks, which are always sent out during the last week in November, or the first week in December, please do not lay them aside for a more convenient time, but carefully read and note that your report is to be sent in not later than January twentieth. This gives ample time before and after the holiday season for the election of officers for the coming year, and the making out of the reports. This is not a difficult task, if the officers have made a study of the Year Book, particularly the Information Page. Another aid to the work is the reading, each month, of that splendid Church magazine, "The Spirit of Missions," telling of our missions at home and abroad; also where our gifts for the Advance Work of the Church are expended. In making out these reports, we must record only what we do for missions and not what we expend for our own parish.

Three copies of the Year Book will be given to each Branch; more can be had, if desired, for twenty-five cents per copy.

The Diocesan Secretary begs the Branch officers to read the book from cover to cover. Read the book at your meetings and discuss the contents; then pass it on to the other members of your Branch, until all are in touch with the Diocesan and Branch officers and the work being done in the Diocese.

At the Annual Meetings there is not time for the officers to read their reports, nor the minutes of the previous meeting; but it is all in the Year Book.

I would advise the preservation of all your Year Books, as they will be found convenient for reference. Every ten years, since the organization of the Ohio Branch of the Woman's Auxiliary, these books have been bound. It was my privilege, this year, to do this work. These bound volumes are in the library at Trinity Cathedral.

We give a cordial welcome to our new Branches. When these

Branches need assistance in planning their program, the President, Mrs. Backus, and other officers, will be glad to come to them.

It is again the sad duty of your Secretary to record the names of so many of our friends and fellow-workers whom God has called to the higher life. In memory of their lives and work, let us stand in silence a moment.

As we enter upon the duties and privileges of another year, let us go forward as faithful servants, sharing with others these blessings and so extend the Kingdom for which we pray.

Report of the Akron Region



The Akron Region of the Woman's Auxiliary held two meetings in 1929, both being in Akron.

The first one was held at St. Peter's, Firestone Park, April 26th, with 112 women present. After the usual service of Holy Communion at 10 A. M., there was a short business meeting with roll-call. Every Branch present responded with a brief report of its six months' work, especially during the Lenten season.

Mrs. Frease of Canton, our Regional Educational Secretary, offered her resignation, which was accepted with regret.

Mrs. Durr of St. Peter's, gave a brief but interesting talk about St. Luke's, Tokyo. A letter of invitation from Mrs. Harvey Firestone was read asking all the Auxiliaries in the Region to be present at a Silver Missionary Tea in June at her home, the proceeds to be sent to Liberia for Medical Missionaries.

After luncheon, which was served in St. Peter's new Parish House, the afternoon meeting opened with a talk by Bishop Hulse of Cuba. His description of the work in the island, the difficulties and hardships owing to lack of money, was most appealing. His description of the missionary work in Cuba, gave one a definite idea of the tremendous sacrifices involved, and of the infinite values gained.

Meeting adjourned at 3 P. M. to meet on October 26th at Church of Our Saviour, Akron.

The Fall Regional was held October 26th, and had an attendance of 135 women. The Holy Communion was administered at 10:30 A. M., after which came the usual business meeting with roll-call.

There were some brief talks about the International Hospital of St. Luke's, Tokyo, and the fear of the amount needed to complete the building not being raised. Many auxiliaries increased their pledges to St. Luke's.

Mrs. Anderson, our Diocesan Educational Secretary, gave a most inspiring talk about the Rural Conference she had attended in Madi-

son, Wisconsin. She stressed the need of a more enlightened interest in everything pertaining to the Rural Problems.

Luncheon was served at 12:30 A. M. at which a real spirit of co-operation and fellowship was felt.

At the afternoon meeting, Mr. Clephan of Put-in-Bay, was the speaker. His subject was the Rural work of which he is a most devoted and inspired leader and worker. It is not often that the "Regional" is blessed with such a wonderful opportunity of hearing a message fired with vision and its practical application.

Meeting adjourned at 3 P. M. to meet April 25, 1930, at St. Andrew's, Akron.

Report of the Second Vice-President



It is my privilege to again report on the work accomplished by the Woman's Auxiliary in Toledo region.

Mrs. John G. Anderson, Educational Director of the Diocese, came to Toledo the first week of January and conducted the Conference for church workers, which Conference was well attended by the women and led to greater activity and interest in the Lenten study classes.

On January 16th, the annual Regional meeting was held in Grace Church, the Rev. A. J. J. Gruetter, Rector, was the Celebrant at the service of the Holy Communion. After this service the Rev. Louis M. Hirshon delivered a very inspiring address. At the afternoon session Father Hawkins, who had spent some time in Liberia, described the people of that country and told of conditions there, also the work the church is doing among the people, describing their loyalty to him and their appreciation of all who work among them.

During February, Bishop Rogers was in Toledo and gave a very interesting talk to the women of the region, in St. Mark's Parish House. The women are always happy to have the Bishop come to them for an informal talk.

On February 22d, Bishop Barnwell was the guest speaker in Trinity Parish House. He gave a very delightful address on conditions in his diocese and at the close of his address everyone felt more interested and sympathetic towards the diocese of Idaho and the Nation-Wide Campaign.

Miss Grace Lindley, the Executive Secretary of the Woman's Auxiliary, came to Toledo on March 6th. The Rev. Cedric C. Bentley was the Celebrant at the service of Holy Communion, after which Miss Lindley spoke of many things near the hearts of all women present. The few hours spent together proved a very helpful and inspiring time to all those who were privileged to attend this meeting.

On October 24th, a Quiet Day was held at Trinity Church, with Rev. Father Harrison in charge, beginning with a celebration of the Holy Communion at 10:00 A. M. Father Harrison told when and

where the first Woman's Auxiliary was held and said that Jesus never rebuked women. He spoke feelingly of Mary, saying that her sins were many but she loved much. She spent her all for ointment to anoint the Saviour's feet and performed this loving act three different times; once at a feast when she washed His feet with her tears, wiped them with her hair and then anointed them. Again, she bought an alabaster box, very precious, filled with costly ointment, and broke it over the head and feet of her Master; and the third time was at the tomb.

The closing meeting of the year was held at St. Alban's Church on November 21st, with the Rev. A. E. Clephan, of Put-in-Bay, as our speaker. His subject was: "The Problem of the Rural Church." In the early nineties, he said, so great was the stress to settle and populate the Dakotas, that large numbers went out knowing little or nothing of how to get a living from the soil. They planted bran and split peas for their crops. There was neither church nor school house. Finally sixty young clergymen were persuaded to volunteer to go and at last the beginnings of the church was established. The hardships were many, the people being compelled to walk two miles and pay ten cents for a small pail of drinking water. As scientific, twentieth-century methods are rapidly bringing the rural people to the standards of city intellects and mental processes, so the Church must keep up with the times and expend more time, patience and efficiency to keep rural ideals at a higher standard.

These various meetings and speakers have been much enjoyed, and a closer feeling of friendliness and co-operation has been established between the various parishes, which compose Toledo region. There is a growing interest shown in the work of the whole Church and an earnest desire to help in every possible way through Gifts, Service and Prayer.

Mrs. C. H. Lang told of the work of the Diocesan Altar Guild in furnishing linens and altar hangings to small parishes and missions unable to procure them otherwise.

Mrs. Miller of Warren, gave a fine report of the annual meeting of the Woman's Auxiliary, held in Cleveland the week previous, stressing the earnest plea made by Dr. Mabel Elliott for St. Luke's Hospital, Japan.

The fall meeting was held in St. Luke's Church, Niles. The celebrant at the service was the Rev. Mr. Woodward, assisted by Rev. R. E. Schulz of Warren.

Mrs. Webb of Niles reported the sum of \$465.89 for the U. T. O. from the women of the Region for the year.

Mrs. Geiger of Warren gave helpful suggestions gained from her attendance at the Diocesan Institute for leaders held in Cleveland.

Mrs. Robert Scott of St. Andrew's, Youngstown, and Mrs. Woodward of Niles gave interesting reports of the work and study accomplished at the Gambier conference. The splendid opportunity for the training of young people was stressed, and parishes urged to send delegates another year.

Archdeacon Patterson, at the luncheon hour, spoke briefly on the Nation-Wide Campaign.

At the afternoon session, Mrs. Conrey, always a welcome guest, gave her splendid talk on the work of the C. P. C.

The Rev. James R. Colby, Geneva, Chairman of the Diocesan Commission on Rural Work, in a thoughtful address, gave many reasons why the problems of the rural parishes and missions should have the interest and attention of the women of the Church.

The meetings have each brought over a hundred women of our Region together, and have been the means of information and inspiration, as they have planned to go forward to do a larger work and render greater service in His Kingdom.

Suggestion: Plan your work for the fall at your last meeting in the spring, sending in your request for work before the new allotments arrive the 1st of August.

Supply Department Needs: Contingent Fund—used clothing for the Missions, and new clothing for the Supply Room. This is very important, as we have many calls of this kind.

Report of Educational Secretary



The following report indicates the growing interest of women in general education as they serve God and man for His sake.

From 57 parishes have come reports of 215 Program Meetings with 50 visiting speakers. The subjects presented at these meetings were: Africa, Rural Work, Evangelism, The General Church Program, The Corporate Gift, Christian Social Service, The Spirit of Missions, and Reports of the General Convention.

Books reviewed: Our Changing Life, Ludwig's Goethe, The New Africa, The Green Walls of Mystery, In Darkest Africa, Porgy, Mamba's Daughters, Nigger Heaven, The House Behind the Cedars, and books of the Africa Library.

There were 75 Prepared Papers given; 78 Stereoptican Lectures, throughout the Diocese and Province, 2 Plays, 9 Bible Classes, 9 Pageants, 6 Prayer Groups, and 35 Discussion Groups. Of these Discussion Groups, 20 met in Lent, 8 in Epiphany, and 7 in Advent. The books used were: The New Africa, The General Church Program, which was studied in 22 groups; The Spirit of Missions and other Church papers, in 32 parishes.

The attendance at Summer Conferences was lower than it should have been. Our women need this training, and a greater effort should be made to find those who are ready and willing to fit themselves for this work.

Reports of Regional Educational Secretaries

Mrs. Harry Frease, Chairman of the Akron Region, addressed the Akron Regional at Cuyahoga Falls; the Lutheran women of Canton, on the New Africa; directed an Institute in Massillon; held conference for leaders in Akron; sent out notices and materials to leaders during the year; and planned an African Tea, at which four hundred people from the Akron Region and guests from Cleveland were present. The lovely home of Mr. and Mrs. Harvey Firestone was opened for the occasion. The silver offering, a generous one, was given for work in hospitals of our Church in Liberia.

I regret having to report the resignation of Mrs. Frease on account of ill health. Mrs. H. A. Hoffman of Kent, was appointed to this office, and the good work will continue under her capable leadership. Mrs. Hoffman reports having given a talk on Adult Education; one on The Church's Work in Brazil and Mexico; and an address on Education at Cuyahoga Falls.

Miss Maude Gorham, Chairman of the Mansfield Region, arranged meetings in Marion; in Wooster, where a Branch of the Woman's Auxiliary was revived; visited Gambier, Bucyrus, Wooster, and Mansfield; sent

out notices and materials, and was in contact with her leaders regarding educational plans.

Mrs. E. C. Loofbourrow, Regional Educational Secretary, sent out notices and materials to leaders. As the Ohio and Lima Regions are unorganized, reports come to me direct from parishes that are carrying on any kind of educational program.

The resignation of Mrs. B. H. Leavenworth leaves Toledo without a Regional Educational Secretary.

Mrs. F. L. Geiger, Educational Secretary of the Youngstown Region, sent out notices and materials to leaders and for Regional meetings; attended all meetings and the Diocesan Institute, and gave a good report of same at Regional meeting; reviewed The New Africa for the group at St. Augustine's.

Mrs. Ralph Evans, Cleveland Region, conducted two classes; one in St. Paul's, Cleveland Heights, and the other in Emmanuel Parish on The New Africa. No parish leaders have been developed in either church. Mrs. Evans was appointed Assistant Diocesan Educational Secretary at the annual meeting of the Woman's Auxiliary in May, 1929. Mrs. Evans is well known throughout the Diocese for the splendid record made in the Church School Department, and we are glad to have her efforts turned to furthering Adult Education among women.

My report follows: Regional Institute in Toledo, January 8th; in Marion on January 15th. Attended Foreign Affairs Institute on January 25th and 26th; annual conference for Regional Chairmen, February 5th; Mansfield Regional, March 21st; Sandusky Regional on May 3d; and Cleveland Regional, October 11th. Addressed the Diocesan Assembly of the Daughters of the King, on October 12th, on the subject of Rural Work; a Diocesan meeting of the Church Periodical Club, October 22d, on Rural Work; Regional at Akron on October 25th, on Our Church's Rural Work. Directed a Diocesan Institute, October 17th-18th at Trinity Cathedral, at which Miss Margaret Marsten of New York, presented The World Mission of Christianity, using the subject book, Roads to the City of God, by Basil Mathews. All communions are studying the world problems that were discussed at the Jerusalem Conference in 1928. Addressed the Cleveland Clericus on Education in the Woman's Auxiliary, and the World Mission of Christianity, November 4th. Attended the Federated Churches Institute, September 23d-25th; 52 miscellaneous meetings, such as Board, Departmental, Conferences and the like; visited 36 parishes and missions in every Region, except the Lima and Lake Regions; spent five days at a Conference for Woman's Auxiliary Diocesan officers at Taylor Hall, Racine, Wisconsin; was sent as a delegate from the Woman's Auxiliary to the Madison, Wisconsin Conference for Rural Church Workers, June 30th to July 12th. Both conferences were interesting and stimulating.

Arranged for the Rev. A. E. Clephan of Put-in-Bay, Ohio, who represented the Ohio clergy at the Madison Conference, to speak at

four Woman's Auxiliary Regional meetings on our Church's Rural Work.

During the year prepared and sent out Suggested Programs for Study and Reading; also programs for using Roads to the City of God. Sent out many copies of The General Church Program; reading list; many letters, many copies of The New Africa, and Roads to the City of God; and kept a number of books and leaflets on the go throughout the year.

So this interesting work of education goes on, and we find ourselves coming to the place where we are loving God with minds as well as hearts and hands; slowly developing intelligence about our Church and her work through education as an attitude toward life lived as members of Christ.

The Annual Report of the Church Periodical Club

January, 1929 to January, 1930



The needs of the Church Periodical Club cover all kinds of good reading matter, not only Church magazines, religious books and Sunday School material, but all good literature. Among the special needs always in demand, are the books and magazines of current thought, pictures of current events, and all kinds of good reading for children.

Our rural and missionary clergy are apt to be far from libraries and there are many isolated church people who are starving for reading matter. One missionary writes: "We have almost nothing to read, anything in the way of books and magazines are prized, every little picture for the wall is precious, a Sunday picture supplement or anything that appeals to the eye, is a help." It is to provide for these needs that the Church Periodical Club carries on.

During 1929, the regular work in the Diocese has increased in volume and in value, and besides this a number of special needs have been filled. At Easter and Christmas there were sent to the Veterans' Hospital at Chillicothe, several hundred individual boxes to soldiers, by name. We hear that they call the Church Periodical Club their best friend.

During the year we were asked to help equip three libraries. The first was at the Armenian Seminary in Jerusalem, where our Educational Secretary, Rev. Thorley Bridgman, is a teacher. A special offering of books was made on Good Friday, and at the same time the Church people were making a money offering for the Near East work. Mr. Bridgman acknowledged these gifts in many nice notes to individual donors.

The second library was given to a large colored community where there were no books, and no library privileges. To Rev. W. H. Brown, missionary at Sumter, S. C., in charge of the community, Southern Ohio and Ohio united in sending 3,000 books. The third library given is at Gainesville, Georgia. In this flourishing town of 10,000, there is no library of any kind. Our Church there is small and weak. It was thought that a good library would benefit both the Church and the community. The members were enthusiastic, the Woman's Auxiliary gave the lumber, the Clergymen built the book shelves and the senior warden painted them. And once more Southern Ohio and Ohio joined in sending 1,000 books. To these three libraries books were given, but for the fourth library, we asked for money to buy books. This is at St. John's University, Shanghai, China, one of the oldest and finest Christian schools in China. Ohio sent for this cause \$513.80 with which to buy the expensive technical and reference books necessary in such a library.

There were three conferences of Librarians in the Diocese, one in February, one in May and one in October—all of which were well attended, always enjoyable and always helpful. Special speakers, with exchange of ideas and ways of working, make interesting features of these conferences. Turning to the coming year, we are assigned as our Special for 1930, the Library Training School at Boone University, Wuchang, China. This is our old friend, for which we have given money in former years—a library started about thirty years ago by Miss M. E. Wood. It is the only Training School for Librarians in all of China. Its graduates are now directing most of the important Libraries in the great cities of China. It is an inspiring cause for which we are happy to work.

The Church Periodical Club offers many opportunities where the young people may help. The Kappa Beta Kappas in some parishes devote part of their time to this work. They collect and send out magazines, books, pictures and games. They make scrap books and puzzle pictures and writing pads, they have talks given on Church Periodical Club work and they give the Church Periodical Club plays. We ask for the continued help and interest of all our friends, young and old, in this fine work. The figures are as follows:

Information



The Ohio Branch of the Woman's Auxiliary has as its representative in China, Miss Caroline Fullerton, "Our Own Missionary." She is principal of St. Mary's Hall, a school for girls in Shanghai, and we are responsible for her salary of nine hundred dollars a year. Please send gifts to Mrs. Clifford C. Cowin, Treasurer, 5007 Mayfield Road, South Euclid, Ohio.

Since the founding of St. Paul's Mission at Glen Alpine in the Blue Ridge Mountains we have had the honor of supporting it. Our successful missionary there is Mrs. Eva Joyner Barrett. The work has grown so much that we have now provided Mrs. Barrett with an assistant. The sum for which we pledge ourselves to Glen Alpine is seven hundred dollars.

The "Bishop Leonard Fund" is for use among the missions of Ohio, when and where the Bishop thinks best. We have pledged to him five hundred dollars.

The "Bishop Rogers Fund" will place in the hands of the Bishop Coadjutor, a sum for use at his discretion among missions in the Diocese.

The "Expense Fund" covers the cost of publishing the annual report, occasional circulars or leaflets and notices and postage in several departments. With the enlarged scope of the Supply Department, there are expenses for freight, express and postage. Each Branch is asked to contribute to this fund.

The "Contingent Fund" is available for all sorts of emergencies. It is the large feature in the work of the Supply Director. We ask the women of the Branches to give special thought to this work. An increase of pledges is earnestly solicited and will be carefully expended. All money and checks for this fund should be sent to the Diocesan Treasurer, Mrs. Clifford C. Cowin, 5007 Mayfield Road, South Euclid, Ohio.

The Bishop Bedell Scholarship and the Julia Bedell Scholarship pay for the education of native pupils in St. John's University, Shanghai, China. They require \$70 each per annum.

The Bishop Hare Scholarship in St. Elizabeth's School, South Dakota, pays for the education of an Indian pupil; it requires sixty dollars per year.

The Sarah L. Leonard Scholarship—St. Mark's School, Nenana, Alaska, \$200 per annum.

Kuling School China, is a school for the education of the children of Missionaries and pledges are asked for its support.

The "Foreign Insurance Fund" provides insurance upon the lives of foreign missionaries for the benefit of their families. We, of the

Ohio Branch, have for more than forty years contributed annually to this fund. Our pledge is one hundred dollars a year.

All pledges are payable to Mrs. Clifford C. Cowin, 5007 Mayfield Rd., South Euclid, Ohio. In the case of a "special" when a custodian is named, all money may be sent direct to the Collector, who later reports to Mrs. Cowin.
