## THE WOMAN'S AUXILIARY—1898.

---

The Sixth Annual Meeting of the Olympia Branch of the Woman's Auxiliary was held in Trinity Church, Seattle, Wednesday, June 21, 1898. The Holy Communion was celebrated at 11:30 by the Bishop, and a Sermon was preached by the Rev. Dr. Nevius, on the words "In His Name." This Service was followed by a beautiful luncheon served by the ladies of Trinity Parish in the rectory.

The business meeting was called to order by the Bishop in the "choristry" of Trinity at 2:00 p. m. After the opening Service, the election of officers took place, resulting in the choice of the following persons to serve for the ensuing year: President, Miss E. H. Maynard; Vice-President, Mrs. W. M. Snyder; Secretary, Miss Anna M. Barker; Treasurer, Mrs. Winfield R. Smith; Secretary Junior Auxiliary, Mrs. Reich. In the absence of the newly elected President, Mrs. Sackman was chosen Chairman *pro tem.*

The minutes of the previous Annual and Semi-Annual Meetings were read and approved. The Secretary's report of work done during the year showed that boxes were sent valued at \$163.25. Cash donations to other funds amounted to \$125.89.

Reports were read of work done by the following Branches: Centralia, Chehalis, Everett, Hamilton, New Whatcom, Olympia, Junior Auxiliary St. Paul's, Seattle, and the Tacoma Branch.

Most interesting ten minute addresses were made by the following Clergy: Rev. P. E. Hyland, "The Early Days of Missions;" Rev. F. H. Church, "The Motive of Missionary Work;" Rev. Dr. Baker, "Results of Missionary Work."

After a few words of suggestion by the Bishop, a resolution was passed, at his request, "That the Offerings at the Quarterly Meetings continue to be devoted to the Bishop's Fund, with the understanding that the sum received is to be used for the support of a Missionary in the field." Twenty-eight delegates responded at the roll call from four different Branches, and several visitors were present. The meeting adjourned with a hymn and benediction.

The Seventh Annual Meeting of the Diocesan Branch of the Woman's Auxiliary was held at St. Luke's Church, Tacoma, on Thursday, October 12th. At 10:00 a. m. there was a Celebration of the Holy Communion, the Bishop being the Celebrant, and the preacher, Rev. I. M. Barr, of New Whatcom.

The ladies of the Tacoma branch of the Auxiliary served lunch in St. Luke's Parish House, and at 2:00 p. m. the business meeting was called to order.

Addresses were made by invited speakers as follows:

"How can we make the Woman's Auxiliary more effective as a Missionary power?" Rev. J. P. D. Llwyd, Rev. I. M. Barr, and the Bishop.

"Ten minutes in the Mission field." Rev. P. Edward Hyland, Rev. Charles MacLean.

The usual routine business was transacted, including the reading

of the reports of the Secretary and Treasurer. The reports gave the following interesting facts:

Twenty-two Parishes and Missions have shared in some way in the mission work that has been done (eight of these working together as the Tacoma Branch), so that we have fifteen branches of the Woman's Auxiliary, and one of the Juniors.

The first work of the year was the sending of boxes to Alaska, in response to the pathetic appeal from Bishop Rowe, for help for the hospital at Skagway. Three beautiful boxes were sent from Tacoma, valued at \$150.

At Christmas time ten boxes were sent to our Mission Sunday Schools, valued at \$84.07. Two hundred and seventy-three children received gifts, and the boxes were much appreciated.

During the year six boxes were sent by the different branches to our Church hospitals, valued at \$147.46. A box was also sent to Boise City, Idaho, valued at \$5.

The Juniors at St. Paul's, Seattle, sent three boxes, valued at \$6.50, making in all a grand total of twenty-three boxes, valued at \$393.03.

Of money we have not so much to report. One hundred and six dollars and eighty-two cents was contributed for objects outside the Jurisdiction. Twenty-seven dollars and fourteen cents was given for work in our own District. Besides all this, \$22.61 has been raised for running expenses of the branch, making in all a total of \$156.57. Add to this the money contributed for the United Offering, in 1898, \$84.84, and we have a total of \$241.41 money raised, and a grand total of \$634.44 money and boxes, which is the largest amount raised for several years.

At the Annual Meeting in 1898, a Treasurer and Secretary Junior Auxiliary were elected and both were obliged to resign. Since then the Executive Committee has elected two women to fill the place of Treasurer, both of whom were unable to serve, so the present Secretary was requested by the Executive Committee to act as Treasurer.

The Eighth Annual Meeting of the Diocesan Branch of the Woman's Auxiliary was held at St. Mark's Church, Seattle, on Thursday, October 11, 1900. At 11:30 there was a Celebration of the Holy Communion, the Bishop being the Celebrant, assisted by the Rector of the Parish. The Sermon was preached by the Rev. Mr. Badger of St. John's Church, Olympia.

Next came a bountiful lunch prepared and served by the ladies of St. Mark's. At 2 p. m. came the business meeting, with all officers present.

The meeting was opened by the Bishop with the Creed and Missionary Collects. It was called to order by the President, and the roll call showed eleven Branches represented by fifty-seven members.

The minutes of the last Annual Meeting, the annual reports of the Secretary and Treasurer, and reports of different branches were read and accepted, including the report of a special meeting of all Seattle Branches held on October 5th.

Following the reports was the Bishop's address, in which he suggested special lines of work, the most important being the support of a Missionary, to be furnished by the Woman's Auxiliary; supplies for the hospitals; the United Offering; study of the Missionary field and inc and encouragement to Juniors. At the close of his address the Bishop and other clergy present withdrew, and the President took up the business of the meeting. In her remarks she emphasized that part of the Bishop's address which referred to the United Offering and the Juniors, and suggested the taking of the spirit of Missions by Branches as well as individuals as the best way to become acquainted with Missionary work at home and abroad. It was voted to repay the Bishop for printing the report of the last two years' work and order this year's report printed.

The Committee on Nomination submitted the following: "The Nominating committee appointed by the Chair respectfully submit that in their judgment and on consultation with branch officers, rotation in office is deemed advisable on general principles, as making for deeper interest in a greater number, and while gratefully acknowledging the very efficient work of the officers the past years, we respectfully submit the following ticket as officers for the coming year: President, Mrs. Winfield R. Smith of St. Mark's; Vice-President, Mrs. N. B. Coffman, Chehalis; Secretary, Miss E. H. Maynard, Tacoma; Treasurer, Mrs. Bernard Pelley, Trinity, Seattle; Secretary Junior Auxiliary, Mrs. Samuel Sutton, St. Paul's, Seattle.

No other nominations being suggested, these officers were elected unanimously. The advisability of working unitedly for some special offering was discussed and it was decided best to try letting separate branches or groups decide on the disposition of the money or work.

The President of the Tacoma Branch (which includes delegates from all the Parishes and Missions of that city), told of the plan of work adopted for the coming year, by which it was hoped to reach many more women than could come regularly to the monthly meetings.

Letters were read from Miss Emery, and Miss Edmund, in charge of the work at Ketchikan, also one from Dr. Gates, telling of the value of hospital work among the women, and of the needs of the Woman's Hospital in Shanghai.

Looking back over the past eighteen months we see that fourteen branches of the Woman's Auxiliary and three of the Juniors (St. Mark's and St. Paul's, Seattle and Tacoma) have been working, resulting in the following list of boxes:
