PRESIDENT'S ADDRESS

To the Woman's Auxiliary in the Diocese of Olympia,

Greeting:

It is with much pleasure, my dear friends, that I welcome the representatives of the various branches of the Woman's Auxiliary, in this my home parish, with the hope that this gathering will be one of great profit to all, and that we may carry back to our home branches renewed inspiration that will result in greater work for the Master.

It can hardly be necessary to explain to anyone here what we mean by the Woman's Auxiliary, or to tell of the great work it is accomplishing for Missions by three definite means: prayer, study and gifts. It has always seemed to me that each one of these means is of equal importance, altho we frequently hear emphasis laid upon one or the other. They are so interwoven that they cannot be separated with impunity. How many have begun by giving only of their prayers because they had no time to study Missions and nothing to give, and have ended by offering the highest gift of all, even themselves and all of their time! Has anyone ever begun first by studying Missions without feeling a growing need to help in some way, either in gifts or prayers? And as our material gifts are speeded on their way, do they not carry with them the mute prayers of all the loving hearts that have sacrificed to make the gifts possible, and do not these generous ones long for and seek definite knowledge of the work which they are so ably assisting? Therefore, shall we not see to it that no one of these means is neglected in the particular Branch for which we are responsible, inasmuch as each in its way makes for the enlargement of the Master's Kingdom?

The reports of the officers will cover the work accomplished by our Diocesan Branch this year, and we may all note with thankful hearts the many visible signs of progress.

Each year we bespeak your continued interest in the United Offering, which will be made in New York, in October, 1913, to be devoted to woman's work in the mission field, the training, testing and sending of new workers, and their support; and the care of those sick and disabled; a sum not exceeding \$20,000 to be set aside for buildings for the use of women workers. This, let me remind you, is a thank offering which we give over and above what is our bounden duty to give. On this account, it is always a satisfaction to see an increase in gifts every year, for to a certain extent it is the measure of our spiritual growth, the expression of a burning zeal. Our offering of 1910 amounted to over seven hundred dollars, and it is our hope and expectation that the year 1913 will see us pass the thousand dollar mark. Every indication points that way. The

first year after the General Convention is always a lean one for the United Offering. We seem to make our most substantial gains as the time grows short. Nevertheless, for the first year, ending September, 1911, the amount of our offering was more than one-third of the entire 1910 offering by a generous margin. So many parishes have so far exceeded what they ever did before, that, with a little effort, particularly on the part of those who are lagging behind, we can easily surpass any previous record.

At our semi-annual meeting in September, there was handed in for the last time the well-worn and well-filled mite box of Mrs. C. J. Petersen, of Orillia, a loyal and devoted Auxiliary worker, who had but a few weeks before been called to her last rest. Mrs. Petersen served one year as a vice president for the Auxiliary, and rarely missed an annual or semi-annual meeting. We are also called to mourn the loss of two other valued members, Mrs. Leontine T. Newcombe, of St Paul's Church, Seattle, and Mrs. Lavinia N. de Wolf, of Trinity Church, Tacoma. Mrs. Newcombe was for many years an active Auxiliary worker, and upon her coming to this Diocese transferred all her allegiance to it. Mrs. de Wolf lived many years in Tacoma, and the value of her work and example can never be measured. We who knew and loved her humbly thank God for the enrichment of our own lives which has come to us through contact with this gracious, Christian woman.

As these valued workers are taken from us, we wonder how we can spare them and who will take up the tasks laid down by their faithful hands. Surely, the responsibility devolves upon us to see that the work shall in no wise lose. Shall we not pray that the mantle of their devotion and self-sacrifice may fall upon us to help us do our share in advancing the coming of Christ's Kingdom? God grant that such prayers be answered.

We have had distributed today printed copies of Miss Emery's annual letter, which hitherto has been read at this meeting. It is of such length and contains such important matter that it seemed best to put it in such form that you might take it away with you to consider at your leisure and discuss in your home branches. Then when we meet in the fall, we can take up these various matters and act upon them intelligently.

MINUTES

The 19th Semi-annual Meeting of the Woman's Auxiliary in the Diocese of Olympia was held in Trinity Church, Tacoma, September 19, 1911. Holy Communion was celebrated at eleven o'clock by the Bishop, assisted by the Rev. C. Y. Grimes. The sermon was preached by the Rev. E. V. Shayler, rector of St. Mark's Church, Seattle. Luncheon was served in the Parish House by the ladies of Trinity Church.

The President called the meeting to order at two o'clock, and the Bishop led in the opening prayers.

In the absence of the Secretary, Mrs. George H. Plummer was appointed Secretary pro tem. The minutes of the last meeting were read and approved. The Roll Call showed 127 present, from 19 parishes and missions.

The reports of the Treasurer, Treasurer of the United Offering and the Secretary of the Junior Auxiliary were read and accepted.

After discussion, it was voted that we continue to work another year for the mission at Fort Yukon, Alaska.

It was also moved and carried that the Constitution be changed so as to make provision for the office of Corresponding Secretary. A unanimous vote was cast for Miss E. H. Maynard, Corresponding Secretary, and Mrs. George H. Plummer, Recording Secretary.

The Bishop then spoke at some length on the apportionment and matters of interest to the Diocese. A general discussion followed.

MINUTES

The 20th Annual Meeting of the Woman's Auxiliary in the Diocese of Olympia was held in St. Luke's Church, Tacoma, May 27, 1912. Holy Communion was celebrated at 11 o'clock by the Bishop of the Diocese, assisted by the Rev. F. T. Webb. The sermon was preached by the Rt. Rev. Robert L. Paddock, Bishop of Eastern Oregon.

At the close of the service, the ladies of St. Luke's Church served a buffet lunch in the Parish House.

The President called the meeting to order at two o'clock, and the Bishop led in the usual prayers.

The Roll Call showed an attendance of about 200 members from 18 parishes and missions.

The minutes of the semi-annual meeting were read and approved.

The President then read her annual address, which was followed by the reports of the Corresponding Secretary, the Treasurer, Secretary of Junior Department and Treasurer of the United Offering, which were duly accepted.

By resolution, the chair was requested to appoint a committee of three to consider the advisability of electing more Diocesan officers to have charge of the Junior work.

Reports of Parochial Branches were read and placed on file.

The following officers were unanimously elected:

Mrs. Frederic W. Keator, President; Mrs. J. O. Cooper, First Vice President; Mrs. A. J. Eikens, Second Vice President; Mrs. M. E. Somerville, Third Vice President; Mrs. G. H. Plummer, Recording Secretary; Miss E. H. Maynard, Corresponding Secretary; Mrs. W. N. Redfield, Treasurer; Mrs. N. B. Coffman, Treasurer of the United Offering, and Miss Myrtle Nosler, Secretary of the Junior Branch.

A resolution was adopted instructing the Corresponding Secretary to write to our U. S. Senators and Congressmen endorsing the "bill" which is shortly to be introduced to Congress for the medical and sanitary relief of the natives of Alaska, and, as Bishop Rowe requests, asking them to act favorably upon the same.

Mrs. Babcock, of Seattle, spoke briefly on the work of the Church Periodical Club.

Captain A. P. S. Hyde, of the U. S. A., then gave an interesting talk on religious work among enlisted men, particularly of the Chapel of the Good Shepherd at Fort Flagler.

Bishop Paddock closed the afternoon with an account of the peculiar conditions of the work in his field.

REPORT OF CORRESPONDING SECRETARY

During the past year, the work of the Olympia Branch of the Woman's Auxiliary has been along the same lines that have been followed for some years, and the object of its interest is still St. Stephen's Mission, Fort Yukon, Alaska, but the inspiring personal interest, apart from what we all feel for Bishop Rowe, is centered in Miss L. J. Woods, in our efforts to help her care for the children under her charge and of whom she is so fond. In August last a few of us were privileged to meet her again when she passed through Seattle on her return to Fort Yukon (after a year's sick leave), and hear something of her work, especially of her arrangements for the Christmas festival, which is as eagerly anticipated and enjoyed there as with us. A letter was received from her in April telling of a very trying winter, and mentioning some special needs, which have been provided for.

The Bishop Barker Memorial Scholarship for a girl in St. Mary's School, Shanghai, has been continued, but one for South Dakota, undertaken by the Seattle Branches, was not completed. Members of the various Parishes and Missions in that city have worked together, as usual, during Lent. Their all-day Mondays began in the most beautiful way, with the Holy Communion; and at noon the prayers for Missions were said.

The Tacoma Branch, comprising St. Luke's, St. Andrew's, St. Peter's and All Saints, Larchmont, met on the first Friday in each month, and on every Friday during Lent, when the day began with the Litany, and in the afternoon, after prayers for Missions a chapter was read from "The Conquest of the Continent." The Parishes of Trinity and Holy Communion each have independent branches, but all came together socially on two or three occasions, when the work was discussed and letters read.

Three newly organized branches are to be reported this year: Holy Communion, Tacoma; Trinity, Everett; and at Creosote, where there are 15 members full of the Auxiliary spirit.

In January the President authorized the sending of a copy of the Church Missionary Calendar to each of eight Missions. From Kent, Orillia and Aberdeen came back, not only thanks, but payment for the sample copy and orders for more. In Orillia, each of the six families connected with the Auxiliary has a Calendar. In this way a fuller knowledge of the Church's Missionary work is being spread about us, even without the "Spirit of Missions," which should be in every branch.

The Seattle boxes contain contributions from Everett, Creosote, Kent, Orillia, Dunlap and Montesano, and the Tacoma boxes include donations from Aberdeen, Hoquiam, Centralia and Chehalis. Some boxes of books are also being sent for the Reading Room opened by Dr. and Mrs. Burke.

The Secretary has written about 60 letters, 50 postals, sent out 60 notices of meetings, and reports and leaflets from Miss Emery.

CONSTITUTION

ARTICLE I.

The name of this Organization shall be "The Olympia Branch of the Woman's Auxiliary to the Board of Missions."

ARTICLE II.

The object of this Organization shall be to pray daily for Missions, and, by means of united and systematic effort, to diffuse missionary intelligence; to increase missionary activity among the women of this Diocese; to unite previously existing societies, and to encourage the formation of Branches where there are none.

ARTICLE III.

The Church itself is a Missionary Society, and every person by baptism becomes a member of this Organization; therefore, every baptized woman in this Diocese is a member of this Auxiliary.

ARTICLE IV.

The officers of this Organization shall be a President, three Vice Presidents, Recording Secretary, Corresponding Secretary, Treasurer, Secretary of the Junior Department, Secretary of the Babies Branch and Treasurer of the United Offering, who shall also constitute an Executive Committee. This Committee shall fill all vacancies that may occur during the year between the annual meetings.

ARTICLE V.

SECTION 1. The President, or in her absence, one of the Vice Presidents, shall preside over all meetings of this Organization and of the Executive Committee, and shall call meetings at such a time and place as in her judgment shall be necessary.

SEC. 2. The duty of the Recording Secretary shall be to keep a record of the proceedings of each meeting of the Auxiliary, and read the same at the following meeting, and to prepare an abstract of the minutes for the annual report.

SEC. 3. The Corresponding Secretary shall conduct the correspondence of the Auxiliary, send out notices, distribute information in regard to Missionary work, and prepare an annual report for circulation in the Diocese.

SEC. 4. The duty of the Treasurer shall be to receive all general and special funds, except as hereinafter provided; to disburse the former under the direction of the Executive Committee, and the latter as the donors may indicate; and to render an account of the same at the annual meeting.

SEC. 5. The Secretary of the Junior Department shall have a general superintendence of the work; shall conduct the correspondence of the Department; and shall endeavor to arouse an interest in the children's work for missions in places where there are no Branches. She shall make a report at the annual meeting.

SEC. 6. The Treasurer of the United Offering shall keep an account of the mite boxes in use in the various Branches; shall collect the contents by September 15; shall invest the same each year, and conduct all necessary correspondence. The total amount, principal and interest, shall be ready for presentation at the triennial meeting of the Auxiliary.

ARTICLE VI.

All Societies that desire it will be considered members of this Auxiliary, and will send their report of money collected and work done to the Secretary. An affiliation fee of one dollar annually shall be paid to the Central Fund. Delegates from all such Societies will be expected to attend the general meetings. The Secretaries of the Parochial Branches are required to correspond with the Diocesan officers, who alone correspond with the Secretaries of the Board of Missions, and transmit to them all moneys.

ARTICLE VII.

An annual meeting shall be held at the time of the Diocesan Convention and a semi-annual one at such time and place as shall be designated by the President, the Bishop approving.

ARTICLE VIII.

Regularly organized Branches are expected to pay annual dues of ten cents per member, which with the offering at the annual meeting, shall form a fund, out of which the Treasurer shall pay all Auxiliary expenses.

ARTICLE IX.

New Branches in missions may report as Auxiliary work, such Church furnishings and Sunday School supplies as they may provide for their own missions during the first two years of the Branch's organization.

ARTICLE X.

This Constitution may be altered or amended by a two-thirds vote at any annual or semi-annual meeting.

BY-LAWS

1. Officers shall be elected at the annual meeting. The President shall appoint a committee on nominations, and upon the coming in of their report, the meeting shall proceed to elect by ballot or viva voce. The choice of officers need not be confined to persons nominated by the committee.

2. Every local Branch shall forward to the Secretary, on or before the first of May of each year, a full report of all missionary work done during the year.

3. The order of business at the meeting of the Society shall be as follows:

1. Prayer.
2. Calling of the Roll.
3. Reading the Minutes.
4. Secretary's Report.
5. Treasurer's Report.
6. Report of Secretary of the Junior Department.
7. Report of Treasurer of United Offering.
8. Report of the Secretary of Babies Branch.
9. Miscellaneous Business.

4. These By-Laws may be amended by a majority vote at any general meeting.
