## PRESIDENT'S ADDRESS

For nine consecutive years it has been my honor and pleasure, as your President, to address this gathering, and you can scarcely wonder that I ask myself if there is anything I can say which I have not said before, any word of advice or note of encouragement which will not fall lifeless upon your ears because of its eternal sameness. Indeed, I can only hope that your consecration to the work is so great that your interest will not fail, even though you are forced to listen to vain repetitions.

Today closes the 21st year in the life of the Olympia Branch of the Woman's Auxiliary, and I would be tempted to use the usual metaphor and say that we have entered into man's estate, were we not living in such an age of rampant feminism that the words might have an unpleasant sound to the few masculine ears present. It has been twenty-one years of slow and gradual growth, and while we think of all the material good that has been accomplished, the spiritual advantage to our own souls must not be overlooked.

There was printed this year, for the first time, the yearly report of the Branch, copies of which were distributed generously. If our funds permit, we hope to issue again this year a like report, as we consider it an excellent means of giving publicity to our work and enlisting the interest of new workers, to say nothing of its historic value.

Next October will convene the great Triennial of the Auxiliary, to be held in New York at the time of the General Convention. Of all the privileges that can come to one, this seems the greatest of all, to attend the General Convention. There one can drink deep of the springs of inspiration, and meet face to face, not only those who labor in our large cities and small towns, but those who occupy positions upon the firing line, enduring the heat and burden of the day in far away lands, and those who labor faithfully in lonely places within our own borders. What rich memories can be gathered and stored away to brighten the days of discouragement that come to all!

It was decided in Cincinnati to limit the number of delegates to the Triennial to five, to be appointed or elected as each Branch decides. These five are the official representatives of the Diocesan Branch and are privileged to vote. The meetings, of course, are open to all. One of our duties today will be to elect these five delegates.

The thought of the Triennial brings with it the thought of the United Offering, with only four months left for the gathering and completion of the harvest. A glance at the Treasurer's report will assure us that we are going to break all records, and reach the thousand dollar mark which we

have set ourselves. Furthermore, we have made some headway in spreading the interest in this offering. Four new branches are contributing for the first time, and contributing generously, while no Branch has neglected the privilege of sharing in this Thank Offering that three years ago tasted this blessing. There is every reason for encouragement; a great deal more can be accomplished in four months.

These are days of great activity for women, with new avenues of usefulness stretching out on every side, each making its peculiar appeal. To the Christian woman, what work can be more ideal than that of our Woman's Auxiliary, employing all the gifts of her mind, her heart and her brain; giving her something to study about, something to work for, something to give to and something to pray for. You that are here appreciate this fully, but are you doing all that you can to impress upon the women of your parish a sense of their obligation, that they are by virtue of their baptism members of the Woman's Auxiliary, and that they must acknowledge this claim? It is being more and more recognized that Christianity is in its essence missionary, and the day has gone by when a Christian woman can express disbelief in missions without serious aspersions being cast upon her intelligence. Our Lord's last recorded commission to the Church was to go and preach the Gospel to every nation, and it is within the power of each woman to help in the fulfilment of this command. If she can not go herself, here is the Auxiliary, sending workers to the field and helping to keep them there. What reason can she give her great Commander for neglecting His orders?

Here, then, is work that each one of you can do, spreading the Auxiliary idea, with its call to serve God's children wherever found, with our prayers, our time and our talents; for thus only may we daily increase in the Holy Spirit more and more, until we come to the everlasting Kingdom.

## MINUTES

The 20th Semi-annual meeting of the Woman's Auxiliary of the Diocese of Olympia was held in Christ Church, Seattle, October 8, 1912. Bishop Keator preached the sermon and celebrated the Holy Eucharist, assisted by Rev. E. V. Shayler, of St. Mark's Church, Seattle. Luncheon was served by the ladies of Christ Church at Hyland Hall, the Church House for girls at the University.

The President called the meeting to order at two o'clock, opening the session with a hymn, the Auxiliary collects and the Creed. In the absence of the Secretary, Mrs. C. A. Pratt was appointed Secretary pro tem. Minutes of the last meeting were read and approved. Roll call showed 109 present, representing twelve parishes and missions.

The reports of the Corresponding Secretary, Treasurer, Treasurer of the United Offering and Secretary of the Junior Auxiliary were read and accepted.

The resignation of Mrs. A. J. Ikin, Second Vice President, was read and accepted with regret. Mrs. R. J. Arney, of Kent, was unanimously elected to fill the vacancy.

Letters were read from Bishop Rowe, Mrs. Burke and Miss Wood, acknowledging boxes sent to Alaska. After discussion, it was voted to continue the work for Fort Yukon (Alaska) another year.

A general discussion on Mission Study and program work followed.

Meeting adjourned.

## MINUTES

The 21st Annual Meeting of the Woman's Auxiliary of the Diocese of Olympia was held in Trinity Church, Tacoma, June 3, 1913. Rev. Sydney James, of All Saints Church, Seattle, preached the sermon. Bishop Keator was celebrant at the Holy Eucharist, assisted by Rev. C. Y. Grimes.

Luncheon was served in the Parish House by the ladies of Trinity Church. The President called the meeting to order at two o'clock, the Bishop of the Diocese leading in the usual prayers.

Minutes of the semi-annual meeting were read and approved. Roll call showed 134 present, representing eighteen parishes and missions. The President read her annual address, followed by the reports of the Corresponding Secretary, Treasurer, Treasurer of the United Offering and Secretary of the Junior Auxiliary.

While the Nominating Committee was out, Bishop Keator gave a short address, touching on the General Convention to be held in New York in October, the proposed House of Church Women, and matters of special interest in the Diocese.

Reports from Parochial Branches were read and placed on file. All reports showed increased interest and zeal. Boxes have been sent to Miss Wood, Fort Yukon, and Miss Wightman, Salchalet, Alaska; also, a room has been furnished for Bishop Rowe and the clergy at Salchalet. Mrs. Stewart spoke briefly of the Convention of Charities and Corrections to be held in Seattle in July.

After a rising vote of thanks to the ladies of Trinity for their hospitality, the meeting adjourned.

## JUNIOR AUXILIARY

On Saturday, May 3, 1913, the Junior Auxiliaries of the Diocese of Olympia held their first Annual Meeting in Christ Church, Seattle.

The meeting was opened with a short service by Rev. Willis N. Stone, followed by an address by Rev. T. R. Alleeson, of St. Mark's, Seattle.

After lunch and a walk through the University campus, the girls assembled for their business meeting. The eighty-three Juniors and Leaders who responded at roll call represented eight Parishes and Missions—Trinity, Everett; Trinity, Tacoma; and St. Paul's, St. Mark's, St. James, St. Andrew's, Epiphany and Christ, Seattle.

Favorable reports were read by the Secretaries and Treasurers of all the Branches showing that the Juniors, as a whole, had had a very successful year. They had sewed for the Alaska box, learned their Missionary Catechism, studied about our Church work in Japan and Alaska, prayed for the spread of Christ's Kingdom and given several helpful Missionary programs, to which parents and friends were invited.

The fourteen girls having perfect attendance during the winter have been given the little silver Junior pins.

We are sorry that so few of our Parishes have Junior Auxiliary Branches. The training our children receive at these meetings is given in no other department of our church work. A church that has no missionary spirit can never truly succeed and this missionary spirit must begin its growth in the heart of the child, if it is to reach its fullest power in the man.

To sow this missionary seed in the breast of every child in our Parish should be the aim of every Woman's Auxiliary. A seed that will grow into a mighty tree, yielding fruit long after we are gone.

This fall when the winter work is being planned in your Auxiliary, let the Junior work come before boxes or study. Find a leader among your members and then help her with your prayers and sympathy.

We must have a Junior Auxiliary in every Parish and Mission in the Diocese of Olympia.

## CONSTITUTION

## ARTICLE I.

The name of this Organization shall be "The Olympia Branch of the Woman's Auxiliary to the Board of Missions."

## ARTICLE II.

The object of this Organization shall be to pray daily for Missions, and, by means of united and systematic effort, to diffuse missionary intelligence; to increase missionary activity among the women of this Diocese; to unite previously existing societies, and to encourage the formation of Branches where there are none.

## ARTICLE III.

The Church itself is a Missionary Society, and every person by baptism becomes a member of this Organization; therefore, every baptized woman in this Diocese is a member of this Auxiliary.

## ARTICLE IV.

The officers of this Organization shall be a President, three Vice Presidents, Recording Secretary, Corresponding Secretary, Treasurer, Secretary of the Junior Department, Secretary of the Babies Branch and Treasurer of the United Offering, who shall also constitute an Executive Committee. This Committee shall fill all vacancies that may occur during the year between the annual meetings.

## ARTICLE V.

SECTION 1. The President, or in her absence, one of the Vice Presidents, shall preside over all meetings of this Organization and of the Executive Committee, and shall call meetings at such a time and place as in her judgment shall be necessary.

SEC. 2. The duty of the Recording Secretary shall be to keep a record of the proceedings of each meeting of the Auxiliary, and read the same at the following meeting, and to prepare an abstract of the minutes for the annual report.

SEC. 3. The Corresponding Secretary shall conduct the correspondence of the Auxiliary, send out notices, distribute information in regard to Missionary work, and prepare an annual report for circulation in the Diocese.

SEC. 4. The duty of the Treasurer shall be to receive all general and special funds, except as hereinafter provided; to disburse the former under the direction of the Executive Committee, and the latter as the donors may indicate; and to render an account of the same at the annual meeting.

SEC. 5. The Secretary of the Junior Department shall have a general superintendence of the work; shall conduct the correspondence of the Department; and shall endeavor to arouse an interest in the children's work for missions in places where there are no Branches. She shall make a report at the annual meeting.

SEC. 6. The Treasurer of the United Offering shall keep an account of the mite boxes in use in the various Branches; shall collect the contents by September 15; shall invest the same each year, and conduct all necessary correspondence. The total amount, principal and interest, shall be ready for presentation at the triennial meeting of the Auxiliary.

#### ARTICLE VI.

All Societies that desire it will be considered members of this Auxiliary, and will send their report of money collected and work done to the Secretary. An affiliation fee of one dollar annually shall be paid to the Central Fund. Delegates from all such Societies will be expected to attend the general meetings. The Secretaries of the Parochial Branches are required to correspond with the Diocesan officers, who alone correspond with the Secretaries of the Board of Missions, and transmit to them all monies.

#### ARTICLE VII.

An annual meeting shall be held at the time of the Diocesan Convention and a semi-annual one at such time and place as shall be designated by the President, the Bishop approving.

#### ARTICLE VIII.

Regularly organized Branches are expected to pay annual dues of ten cents per member, which, with the offering at the annual meeting, shall form a fund, out of which the Treasurer shall pay all Auxiliary expenses.

#### ARTICLE IX.

New Branches in missions may report as Auxiliary work, such Church furnishings and Sunday School supplies as they may provide for their own missions during the first two years of the Branch's organization.

#### ARTICLE X.

This Constitution may be altered or amended by a two-thirds vote at any annual or semi-annual meeting.

## BY-LAWS

1. Officers shall be elected at the annual meeting. The President shall appoint a committee on nominations, and upon the coming in of their report, the meeting shall proceed to elect by ballot or *viva voce*. The choice of officers need not be confined to persons nominated by the committee.
2. Every local Branch shall forward to the Secretary, on or before the first of May of each year, a full report of all missionary work done during the year.
3. The order of business at the meeting of the Society shall be as follows:
  1. Prayer.
  2. Calling of the Roll.
  3. Reading the Minutes.
  4. Secretary's Report.
  5. Treasurer's Report.
  6. Report of Secretary of the Junior Department.
  7. Report of Treasurer of United Offering.
  8. Report of the Secretary of Babies Branch.
  9. Miscellaneous Business.
4. These By-Laws may be amended by a majority vote at any general meeting.
