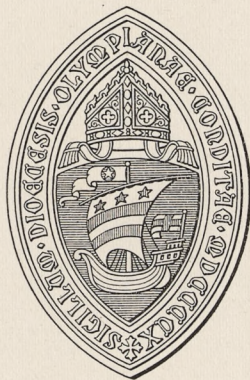

## PRESIDENT'S ADDRESS

*To the Woman's Auxiliary of the Diocese of Olympia, Greeting:*

Today brings to an end the twenty-second year of the work of our Diocesan branch of the Auxiliary, and marks as well the close of the tenth year I have been your executive. Naturally it is a time of retrospection for me—of looking back over the way we have come, of regret for the opportunities lost and privileges neglected, but, above all, of deep thankfulness that God's hand has been with us all the way, guiding us through our difficulties and leading us into larger fields of usefulness and progress.

My mind naturally turns to one who is not with us today, except in spirit, who was among the first to welcome me to this new field of service, and who through all the years has been a wise counselor and untiring helper. What the Auxiliary owes to Mrs. Cooper cannot be measured by words, and how much she is missed no one knows better than I. For many years she has served as our Vice President, and it gives me much satisfaction to take this opportunity of publicly expressing my appreciation.

It is a source of much gratification that we are able to report the formation of four new branches this year: Olympia, Bremerton, Chehalis and Epiphany, Seattle, all with their regularly elected officers. It is a joy to note such substantial evidences of advancement, and we give to these new branches a most hearty welcome.

Since our last meeting, it was the privilege of ten women from the Diocese of Olympia to be present at the Cathedral of St. John the Divine, in New York, on the morning of October 9th, where a great throng of devoted women had gathered from all over the country and from all lands, to join in the great Triennial service of prayer and thanksgiving, and to lay a gift upon the altar, the token of three years of thought and prayer and effort, of self-denial and thankfulness, of remembrance and hope. The offering made that morning of \$306,496.66 reached our highest expectations, but not the limit of our possibilities. Large as this sum seems, it would be even greater if it were more generally shared. There are still tens of thousands of our women who have scarcely heard of the United Offering, and through us they must be reached.

One of the features of the Triennial was the organization of Mission Study Classes which were continuous during the three weeks of the Convention. The Church Missions House of New York has recently added to its staff, Miss Emily C. Tillotson, of Ohio, who has particular charge of the Educational work of the Auxiliary. In a recent communication from her she suggests and urges that each Diocesan branch have its own Educational secretary, a woman who has leisure and is free to go through the Diocese for the purpose of training leaders and presenting the subject to the branches. If we can find just the right woman to take this office, we



have every reason to think that it will mark a new era in the usefulness of our Auxiliary.

One of the epoch-making addresses of the Triennial was that of Mrs. Ella P. Ely, who had just returned from a year's sojourn in China, where she had taught in St. Mary's Hall, Shanghai. She told us of the wonderful work being done by this school for girls, and also of the pitifully inadequate quarters which it occupies on the campus of St. John's University. Even this small space is begrudged it, as St. John's needs it for its own expansion. As a result of this address, sufficient money has already been given to buy a suitable plot of land, near enough to the University for collaboration, but far enough for independent growth. Efforts are still under way for securing funds to erect buildings. I speak at some length on this subject for a particular reason. For fourteen years this Branch has maintained what is known as the Bp. Barker Scholarship, the beneficiary of which is a girl in St. Mary's Hall, Shanghai. For some unknown reason it is becoming increasingly difficult to raise this small sum of \$50.00, and this year, strangely enough, the contributions have been particularly slow; this year, when the Church has been stirred to its depths by the appeal from China that we seize the vast opportunities that are opening up before us in that awakening land, and when all over our own land mission study classes have devoted themselves to the consideration of these problems! Do we realize that beyond the Pacific "a new day is dawning for a nation numbering four hundred million souls, where every one is hastening to adopt western customs, western ideas and western learning? Women, who have heretofore been strictly secluded, and have had no opportunity outside the home, are now to take a real part in the nation's life, and must therefore be thoroughly educated." We, as a Branch, have charged ourselves with the education of one of these girls, who will go forth, trained in heart as well as intellect, to spread the Church's influence among her people. At this most critical moment, with St. Mary's begging for more room, better equipment, more teachers in order that it may be able to care for the girls it is turning from its doors, why, I ask, has *our* enthusiasm waned? Why have *our* gifts come so reluctantly? This indifference of ours has placed upon us a stigma, which, let us hope and pray, will soon be removed forever.

In closing, I have but one word to say: Dear friends, ten years is a long time to have been your leader, and I cannot let the moment pass without expressing my appreciation of your loyal support, of your charity toward my many shortcomings, and for your prayers, without which nothing availeth. Thank you, many times, and God bless you, every one!

## MINUTES

The 21st Semi-annual meeting of the Woman's Auxiliary of the Diocese of Olympia was held in Trinity Parish Church, Seattle, Wednesday, September 23, 1913. Holy Communion was celebrated by the Bishop of the Diocese, assisted by Archdeacon Hilton, Rev. M. J. Bywater, and Rev. H. H. Gowen, D. D. The sermon was preached by the Rev. Dr. Gowen, from the text, Romans xvi:3, "Greet Priscilla." Offertory solo was rendered by Mrs. Keator.

A buffet luncheon was served at the close of the service, by the ladies of Trinity, and a social hour enjoyed.

The President called the meeting to order at two o'clock, and the Bishop led in the opening prayers.

Minutes of the annual meeting were read and approved. Roll call showed 102 present, from thirteen Parishes and Missions. The reports of the Treasurer, Treasurer of the United Offering, and Secretary of the Junior Department, were read and accepted.

The Corresponding Secretary was instructed to send letters of love and sympathy to Mrs. J. O. Cooper, our First Vice President, and to the family of Mrs. Dryden, of St. Paul's, Seattle.

The crowning feature of the meeting was the address by Bishop Rowe, who had just returned from Alaska. He gave a very interesting account of the Mission at Fort Yukon, from its beginning to the present time; spoke of the faithful work done by Mrs. White (formerly Miss Woods), many times risking her own life to save others; of his Indian congregation and Indian Minister; and of the new work at Tanana Crossing.

Addresses were also made by Bishop Keator, Archdeacon Hilton, and a short talk by Mrs. Eaton, one of the Diocesan officers of Quincy, Ill.

Meeting closed with hymn, "Blest be the Tie that Binds."

The 22nd Annual meeting of the Woman's Auxiliary of the Diocese of Olympia was held in St. Paul's Church, Seattle, May 27, 1914. Holy Communion was celebrated by the Bishop of the Diocese, assisted by Archdeacon Hilton, Rev. Sidney Morgan and Rev. A. P. S. Hyde. Sermon was preached by the Rev. Mr. Hyde, from the text, I Thess. v:21, "Prove all things, hold fast that which is good."

At the close of the service a bountiful luncheon was served by the ladies of St. Paul's and a social hour enjoyed.



The President called the meeting to order at two o'clock, and the Bishop led in the usual prayers.

The Roll Call showed 122 present, from seventeen Parishes and Missions.

The Bishop's address preceded the usual routine business. He explained particularly the difference between the House of Church Women and the Woman's Auxiliary, and spoke very touchingly of Bishop Scadding, of Oregon, whose death had just taken place.

Minutes of the semi-annual meeting were read and approved.

The reports of the Corresponding Secretary, Treasurer, Treasurer of the United Offering, and Secretary of the Junior Department were read and accepted.

The President read her annual address, and while the Nominating Committee was out, reports of the Parochial Branches were read and placed on file.

Four new Branches have been formed: St. Paul's, Bremerton; Epiphany, Chehalis; St. John's, Olympia; Epiphany, Seattle; and all reports show increased interest and zeal, more of the true missionary spirit and a greater interest in Mission study. Boxes have been sent to Fort Yukon, Alaska, and an Alms baison given to St. Paul's, Bremerton.

The Corresponding Secretary was instructed to send letters of sympathy and condolence to Bishop Rowe and Mrs. Scadding. Letters were read from Miss Jackson, at Fort Yukon.

The following officers were unanimously elected:

Mrs. Frederic W. Keator, President; Mrs. J. O. Cooper, First Vice President; Mrs. R. J. Arney, Second Vice President; Mrs. M. E. Somerville, Third Vice President; Mrs. F. D. Ellis, Treasurer; Mrs. G. H. Plummer, Recording Secretary; Miss Ellen H. Maynard, Corresponding Secretary; Mrs. N. B. Coffman, Treasurer of the United Offering; Deaconess Nosler, Secretary of the Junior Department.

The question of an Educational Secretary was discussed, and decided that one be appointed.

At the close of the business meeting Archdeacon Hilton gave a splendid address on the Missionary work of the Diocese, referring particularly to the Japanese and Italian Missions.

Meeting closed with prayers and benediction by Rev. Mr. Morgan.

Luncheon was served by St. Mark's Juniors, after which the girls had a happy hour inspecting their work and playing games on the lawn.

The business meeting opened at 1:30 with an address of welcome and prayer by Rev. E. V. Shaybe.

The roll call showed an attendance of 101 Juniors and Leaders. The reports read by the Juniors made us all realize that the girls had had a busy, profitable year.

Three new branches have been organized: St. Paul's, Bremerton; St. James, Kent and Trinity Branch, Tacoma.

Twenty girls from St. Mark's Settlement met with us. We hope they will all become active Juniors next year. Two of our old branches (St. Andrew's Mission and Trinity Church, Seattle) had no reports.

The enthusiastic day closed with a short musical program and helpful missionary address by Miss Sanders and Mrs. Kydd. I am sure that all who attended this meeting—Juniors, leaders and visitors went home with a determination to do more and ever more for the spread of Christ's Kingdom among men.



Twelve leaders were present at our annual board meeting.

The election of officers was followed by informal discussions of our discouragements and our hopes, our failures and our successes. Many helpful suggestions were made and I am sure every leader present received renewed strength and enthusiasm for the coming year.

O! that more women would hear God's call and take up this important work. A Junior Auxiliary should be as much a part of every parish as is the Sunday school. We have Junior Branches in nine Parishes and Missions, but what about the other ten where Woman's Auxiliary work is being done, and the twenty-eight where neither Juniors nor Seniors are at work? Are you all praying for leaders in your own Parish? Are you trying to find a leader? Are you *sure you* are not the one God is calling? We have the children, we have the interest of our clergy, but where are the LEADERS?

## CONSTITUTION

### ARTICLE I.

The name of this organization shall be "The Olympia Branch of the Woman's Auxiliary to the Board of Missions."

### ARTICLE II.

The object of this Organization shall be to pray daily for Missions, and by means of united and systematic effort, to diffuse missionary intelligence, to increase missionary activity among the women of this Diocese; to unite previously existing societies, and to encourage the formation of Branches where there are none.

### ARTICLE III.

The Church itself is a Missionary Society, and every person by baptism becomes a member of this Organization; therefore, every baptized woman in this Diocese is a member of this Auxiliary.

### ARTICLE IV.

The officers of this Organization shall be a President, three Vice Presidents, Recording Secretary, Corresponding Secretary, Treasurer, Secretary of the Junior Department, Secretary of the Babies Branch and Treasurer of the United Offering, who shall also constitute an Executive Committee. This Committee shall fill all vacancies that may occur during the year between the annual meetings.

### ARTICLE V.

SECTION 1. The President, or in her absence, one of the Vice Presidents, shall preside over all meetings of this Organization and of the Executive Committee, and shall call meetings at such a time and place as in her judgment shall be necessary.

SEC. 2. The duty of the Recording Secretary shall be to keep a record of the proceedings of each meeting of the Auxiliary, and read the same at the following meeting, and to prepare an abstract of the minutes for the annual report.

SEC. 3. The Corresponding Secretary shall conduct the correspondence of the Auxiliary, send out notices, distribute information in regard to Missionary work, and prepare an annual report for circulation in the Diocese.

SEC. 4. The duty of the Treasurer shall be to receive all general and special funds, except as hereinafter provided; to disburse the former under the direction of the Executive Committee, and the latter as the donors may indicate; and to render an account of the same at the annual meeting.



SEC. 5. The Secretary of the Junior Department shall have a general superintendence of the work; shall conduct the correspondence of the Department; and shall endeavor to arouse an interest in the children's work for missions in places where there are no Branches. She shall make a report at the annual meeting.

SEC. 6. The Treasurer of the United Offering shall keep an account of the mite boxes in use in the various Branches; shall collect the contents by September 15; shall invest the same each year, and conduct all necessary correspondence. The total amount, principal and interest, shall be ready for presentation at the triennial meeting of the Auxiliary.

#### ARTICLE VI.

All Societies that desire it will be considered members of this Auxiliary, and will send their report of money collected and work done to the Secretary. An affiliation fee of one dollar annually shall be paid to the Central Fund. Delegates from all such Societies will be expected to attend the general meetings. The Secretaries of the Parochial Branches are required to correspond with the Diocesan officers, who alone correspond with the Secretaries of the Board of Missions, and transmit to them all monies.

#### ARTICLE VII.

An annual meeting shall be held at the time of the Diocesan Convention and a semi-annual one at such time and place as shall be designated by the President, the Bishop approving.

#### ARTICLE VIII.

Regularly organized Branches are expected to pay annual dues of ten cents per member, which, with the offering at the annual meeting, shall form a fund, out of which the Treasurer shall pay all Auxiliary expenses.

#### ARTICLE IX.

New Branches in missions may report as Auxiliary work, such Church furnishings and Sunday School supplies as they may provide for their own missions during the first two years of the Branch's organization.

#### ARTICLE X.

This Constitution may be altered or amended by a two-thirds vote at any annual or semi-annual meeting.



## BY-LAWS

1. Officers shall be elected at the annual meeting. The President shall appoint a committee on nominations, and upon the coming in of their report, the meeting shall proceed to elect by ballot or viva voce. The choice of officers need not be confined to persons nominated by the committee.

2. Every local Branch shall forward to the Secretary, on or before the first of May of each year, a full report of all missionary work done during the year.

3. The order of business at the meeting of the Society shall be as follows:

1. Prayer.
2. Calling of the Roll.
3. Reading the Minutes.
4. Secretary's Report.
5. Treasurer's Report.
6. Report of Secretary of the Junior Department.
7. Report of Treasurer of United Offering.
8. Report of the Secretary of Babies Branch.
9. Miscellaneous Business.

4. These By-Laws may be amended by a majority vote at any general meeting.
