PRESIDENT'S ADDRESS

Greeting:

Since our last meeting, we have been called to mourn the loss of one of our charter members, Mrs. Thomas Prosch, whose sudden and tragic death is still fresh in our minds. Ever since the organization of our diocesan branch, Mrs. Prosch has been a familiar figure at these gatherings and we shall miss her sadly. We remember with what enthusiasm she took up the idea of the Jane Beaver Rectory Fund, and it was through her familiar knowledge of the early history of this state that we were inspired to give it this name, "Jane Beaver," in honor of the wife of the Rev. Mr. Beaver, who accompanied her husband when he came to Vancouver as a chaplain of the Hudson's Bay Company. Her home was the first rectory in the State of Washington, and it seemed very fitting to Mrs. Prosch that this Fund, intended for the building of rectories in our Diocese, should bear the name of this pioneer. Our tenderest love and sympathy have gone out to the bereaved daughters of this noble mother in their double affliction, and our prayers are offered in their behalf that they may be comforted.

"Thus, our Father, one by one
 Into Thy bright house we go,
With our work undone or done,
 With our footsteps swift or slow.
Dark the door that doth divide,—
 But, O God, the other side!"

After hearing the yearly reports, you will realize that our totals read less than they did last year. We know the reasons for this, reasons which will probably prevail for some time to come. Undoubtedly we have another year facing us which will require much fortitude and endless sacrifice on our part if we are to meet it in any degree consistent with our Christian calling. We are living today under the shadow of a great war cloud which has brought us added cares and responsibilities. With these new demands for our sympathy and help, we must not forget the importance of the work which as an organization we are pledged to do and for which we, and we only, are responsible. Let us make it a year of real, definite sacrifice, giving truly of ourselves by the giving up of some pleasure or luxury that its equivalent may go to the work of the Master. Such sacrifice will surely be blest of the Lord and blessings shall pour upon the gift and upon the giver.

It is a pleasure to report the formation of two new branches, one at St. Clement's, Seattle, and one at St. Andrew's, Aberdeen. We give them a most hearty welcome and wish them every success.

The increasing interest in mission study is one of the encouraging features of our work, a department which we wish to see grow and de-

velop. This work would be very much advanced if we could find some one to take the office of Educational Secretary. So far, it has been declined by everyone to whom it has been offered, and with truth it can be said that the office has gone begging. The importance of continuing and expanding this department can not be emphasized too strongly. By knowledge we get a vision and are transformed from artisans, who can only see the bit of detail upon which we are working, to artists who comprehend the whole and know the joy of helping to realize a great ideal. Will not some one grasp this opportunity and volunteer to lead us?

The 22nd Semi-annual Meeting of the Woman's Auxiliary of the Diocese of Olympia was held in Trinity Church, Tacoma, October 16, 1914. Holy Communion was celebrated by the Bishop of the Diocese, assisted by the Rev. C. Y. Grimes. The sermon was preached by Bishop Keator from the text, "Say among the heathen that the Lord reigneth." The offering at the morning service was \$13.65.

Luncheon was served at the close of the service by the ladies of Trinity Church, and a social hour enjoyed.

The President, Mrs. Keator, called the meeting to order at two o'clock and the Bishop led in the opening prayers..

Minutes of the annual meeting were read and approved.

Roll call showed 97 present, from sixteen parishes and missions.

Reports of the Treasurer and the Treasurer of the United Offering were read and approved.

The Corresponding Secretary read letters from Bishop Rowe and Mrs. Cooper; from Miss Emery, regarding work at Ft. Yukon; Miss Jackson, acknowledging box sent to Stevens Village.

Short addresses were made by Bishop Keator and Archdeacon Hilton.

The principal address of the meeting was made by Miss Grace Lindley, Associate Secretary, of New York. She spoke of the practical side of the Woman's Auxiliary; of Study Classes, especially Discussion method; and of the importance of the Junior Department.

Meeting was closed with the Benediction, by the Bishop of the Diocese.

MINUTES

The 23rd Annual Meeting of the Woman's Auxiliary of the Diocese of Olympia was held in St. Mark's Church, Seattle, May 20, 1915. Holy Communion was celebrated by the Bishop of the Diocese, assisted by Archdeacon Hilton, Rev. F. F. H. Greene and Rev. E. V. Shayler. The sermon, preached by the Rev. Mr. Greene, of Aberdeen, from the text, "The Master is here and calleth for thee," was of unusual interest and inspiration. The offering at the morning service was \$25.21.

A bountiful luncheon was served at the close of the service, by the ladies of St. Mark's, and a social hour enjoyed.

The President called the meeting to order at two o'clock and the Bishop led in the usual prayers.

Roll call showed 148 present, from twenty-one parishes and missions.

Minutes of the semi-annual meeting were read and approved, also the reports of the Corresponding Secretary, Treasurer, Treasurer of the United Offering, and Secretary of the Junior Department.

The President read her annual address, and reports of Parochial Branches were read and placed on file.

Two new Branches of the Woman's Auxiliary have been formed—St. Andrew's, Aberdeen, and St. Clement's, Seattle. Three new Branches of the Junior Auxiliary—St. Andrew's, Aberdeen; St. John's Mission, Centralia and St. Mark's Settlement, Seattle; one re-organized, Trinity, Seattle. Boxes have been sent to Ft. Yukon and a wider interest has been shown in Mission Study.

The Alms basin presented to St. James' Mission, Sedro-Woolley, was given as a memorial for Virginia MacCarver Prosch.

Letters of sympathy and condolence were sent the families of Mr. and Mrs. T. W. Prosch and Mrs. W. S. June.

Addresses were made by the Rev. Mr. Taylor, of Anacortes and Archdeacon Hilton, upon Missionary conditions in the Diocese, and especially the work at Anacortes, Mt. Vernon and the Whatcom Deanery.

The following officers were unanimously elected: Mrs. Frederic W. Keator, President; Mrs. T. W. Kydd, First Vice President; Mrs. B. F. Arnold, Second Vice President; Mrs. A. J. Iken, Third Vice President; Miss E. H. Maynard, Corresponding Secretary; Mrs. George H. Plummer, Recording Secretary; Mrs. F. D. Ellis, Treasurer; Mrs. N. B. Coffman, Treasurer United Offering; Deaconess Nosler, Secretary Junior Department; Mrs. J. W. MacLachlan, Educational Secretary.

Meeting closed with hymn, "Blest be the Tie that Binds."

During October, 1914, Miss Grace Lindley spent three days in our Diocese. Mere words cannot express what this visit meant to the Juniors and their Leaders. Between two and three hundred girls and young women were inspired by her helpful addresses, and twelve or more leaders met with Miss Lindley each day for a Leaders' Training Class. As a result of these classes we have held monthly Leaders' Meetings throughout the winter, and at our last meeting it was the unanimous vote to continue the class next year. If Miss Lindley could visit us every year, we would soon have thriving Junior Branches in every Parish and Mission in our Diocese.

The Third Annual Meeting of the Junior Auxiliary of the Diocese of Olympia was held at Trinity Church, Seattle, Saturday, May the second.

The day began with a service of admission and a helpful address by our Bishop. Thirty girls had passed their probation and were given their Junior pins. Each of these thirty girls had lived up to the following requirements:

1. Must be live, active members of their Branch.
2. Never absent without good excuse.
3. Learned Junior Collect.
4. Remembered their N. O. boxes regularly.
5. Written a paper on "History of the Junior Auxiliary.

After the service we were all ready for the delightful refreshments provided by the Juniors from Trinity, St. James' and St. Clement's Churches.

The business meeting opened at one. Eighty-seven responded to roll call.

The reports showed that most of the Branches had held weekly meetings, and that the time had been spent in study, prayer and sewing.

The following new Branches have been organized: One Branch, St. Andrew's, Aberdeen; one Branch, St. John's Church, Centralia; seconds I, III and a boy's Branch, Christ Church, Seattle; second III, Trinity Church, Seattle; seconds I and III, St. Mark's Church, Seattle; one Branch, St. Mark's Settlement, Seattle.

The following Branches have lapsed: St Paul's, Bremerton and Trinity, Tacoma.

The business meeting closed with the reading of the best papers from Sections II and III. Alice Hanson, Section II, Christ Church, Seattle, and Mary Burke, Section III, St. Mark's Church, Seattle, had this honor. Several other papers were exceptionally good.

The enthusiastic day closed with two plays:

"Mother Church and Her Juniors," by the Epiphany Juniors, and
"The Sunset Hour," by the St. Mark's Juniors.

CONSTITUTION

ARTICLE I.

The name of this organization shall be "The Olympia Branch of the Woman's Auxiliary to the Board of Missions."

ARTICLE II.

The object of this Organization shall be to pray daily for Missions, and by means of united and systematic effort, to diffuse missionary intelligence, to increase missionary activity among the women of this Diocese; to unite previously existing societies, and to encourage the formation of Branches where there are none.

ARTICLE III.

The Church itself is a Missionary Society, and every person by baptism becomes a member of this Organization; therefore, every baptized woman in this Diocese is a member of this Auxiliary.

ARTICLE IV.

The officers of this Organization shall be a President, three Vice Presidents, Recording Secretary, Corresponding Secretary, Treasurer, Secretary of the Junior Department, Secretary of the Babies Branch and Treasurer of the United Offering, who shall also constitute an Executive Committee. This Committee shall fill all vacancies that may occur during the year between the annual meetings.

ARTICLE V.

SECTION 1. The President, or in her absence, one of the Vice Presidents, shall preside over all meetings of this Organization and of the Executive Committee, and shall call meetings at such a time and place as in her judgment shall be necessary.

SEC. 2. The duty of the Recording Secretary shall be to keep a record of the proceedings of each meeting of the Auxiliary, and read the same at the following meeting, and to prepare an abstract of the minutes for the annual report.

SEC. 3. The Corresponding Secretary shall conduct the correspondence of the Auxiliary, send out notices, distribute information in regard to Missionary work, and prepare an annual report for circulation in the Diocese.

SEC. 4. The duty of the Treasurer shall be to receive all general and special funds, except as hereinafter provided; to disburse the former under the direction of the Executive Committee, and the latter as the donors may indicate; and to render an account of the same at the annual meeting.

SEC. 5. The Secretary of the Junior Department shall have a general superintendence of the work; shall conduct the correspondence of the Department; and shall endeavor to arouse an interest in the children's work for missions in places where there are no Branches. She shall make a report at the annual meeting.

SEC. 6. The Treasurer of the United Offering shall keep an account of the mite boxes in use in the various Branches; shall collect the contents by September 15; shall invest the same each year, and conduct all necessary correspondence. The total amount, principal and interest, shall be ready for presentation at the triennial meeting of the Auxiliary.

ARTICLE VI.

All Societies that desire it will be considered members of this Auxiliary, and will send their report of money collected and work done to the Secretary. An affiliation fee of one dollar annually shall be paid to the Central Fund. Delegates from all such Societies will be expected to attend the general meetings. The Secretaries of the Parochial Branches are required to correspond with the Diocesan officers, who alone correspond with the Secretaries of the Board of Missions, and transmit to them all monies.

ARTICLE VII.

An annual meeting shall be held at the time of the Diocesan Convention and a semi-annual one at such time and place as shall be designated by the President, the Bishop approving.

ARTICLE VIII.

Regularly organized Branches are expected to pay annual dues of ten cents per member, which, with the offering at the annual meeting, shall form a fund, out of which the Treasurer shall pay all Auxiliary expenses.

ARTICLE IX.

New Branches in missions may report as Auxiliary work, such Church furnishings and Sunday School supplies as they may provide for their own missions during the first two years of the Branch's organization.

ARTICLE X.

This Constitution may be altered or amended by a two-thirds vote at any annual or semi-annual meeting.

BY-LAWS

1. Officers shall be elected at the annual meeting. The President shall appoint a committee on nominations, and upon the coming in of their report, the meeting shall proceed to elect by ballot or *viva voce*. The choice of officers need not be confined to persons nominated by the committee.

2. Every local Branch shall forward to the Secretary, on or before the first of May of each year, a full report of all missionary work done during the year.

3. The order of business at the meeting of the Society shall be as follows:

1. Prayer.
2. Calling of the Roll.
3. Reading the Minutes.
4. Secretary's Report.
5. Treasurer's Report.
6. Report of Secretary of the Junior Department.
7. Report of Treasurer of United Offering.
8. Report of the Secretary of Babies Branch.
9. Miscellaneous Business.

4. These By-Laws may be amended by a majority vote at any general meeting.
