PRESIDENT'S ADDRESS

To the Woman's Auxiliary of the Diocese of Olympia, Greeting:

Instead of calling this the President's report, it should be called your report, since whatever has been accomplished this year, has been by and with your hearty cooperation and assistance. I have "leaned hard" on the older members of our organization, and never have they failed me or you.

The visit of Miss Grace Lindley, our General Secretary, to the Coast, meant much to us all, but to me she was a source of great strength and inspiration. She led a class at the Seabeck Conference of the Missionary Educational Movement, where we had a representative number from our Church, the Bishop preaching the Conference sermon, and celebrating the Holy Communion.

In September there was held a three days' Institute in St. Mark's Church, Seattle. It was led by Miss Tillotson, Educational Secretary of the Board of Missions, and Miss Allison, representing the Junior work. They brought us not only inspiration, but a bigger vision for service. Special emphasis was placed on the new Junior plan, the Advent Call and Mission Study.

The greatest piece of work for the year, and, in fact, the greatest ever undertaken by the Woman's Auxiliary, was the Advent Call. With the splendid leadership of Mrs. Sydney Morgan, the women responded loyally, and we are still reaping the benefits of our work, our Bible study and our prayers. Best of all, we became aware of the hidden power in every life, ready to respond to the call to something higher and better.

Following this came the Lenten call to service, which brought to us further Bible readings and the opportunity to pledge for service for our Community, our Country and our Church.

It is with much joy that I announce the organization of three Auxiliaries, at Vancouver, Wash., All Saints, Seattle, and at Bellingham. They are very much alive, sturdy Branches, and we are expecting great things of them. I am sure they will set our older Branches an example of progressive work.

Six visits were made during the year to Auxiliaries outside of Seattle. These have been valuable as a means of strengthening the ties that should exist between the Diocese and the Parish. The welcome everywhere has warmed my heart and has made me stronger for the work.

We are trying this year the experiment of having the Annual Meeting for two days. This is the plan that has been tried and found successful in other parts of the country. We hope you will see the wisdom of a longer time for the discussion of business, and most of all, for the time of quiet communion with God, that we may go away with his strength for the work of the year that is before us.

We have before us another call to service. Perhaps it is, as Miss Lindley says, because of our faithful work in the Advent Call. This time it is to cooperate with the men in the Nation-wide campaign. Again, Mrs. Sydney Morgan has consented to be our leader and I am sure that she will find an even more ready response from the faithful women of the Church.

"The Spirit of Service for Christ's sake is to be the dominating thought of the coming Triennial." Shall we not make it our thought for the year which we are now entering? If so, what can we not accomplish, with and for Him. Some one has said, "Christ wants the world, but he wants it thru us." So let us all labor more earnestly that the Kingdom of this World may indeed become the Kingdom of our Lord and His Christ.

MINUTES

The 27th Annual Meeting of the Woman's Auxiliary of the Diocese of Olympia was held at Kent, May 21 and 22, 1919.

Wednesday, May 21st, Holy Communion was celebrated by the Bishop of the Diocese, assisted by the Rev. Mr. Rolls, of Kent, Rev. Sydney Morgan, of St. Paul's, Seattle; Rev. Rodney Arney was also in the Chancel.

Bishop Keator delivered the sermon from the text, St. Matt. 28, 16 to 20.

Offering at morning service was \$26.50.

A cafeteria luncheon was served in the Parish house at 12:30, followed by a social hour.

Afternoon session convened at 2 o'clock, Rev. Mr. Rolls opening with prayers.

118 responded to roll call from twenty-one Parishes and Missions.

After a few words of welcome by our President, Mrs. Kydd, the convention divided into classes for an hour's instruction, Mrs. Kydd taking the class for Presidents; Miss E. H. Maynard the class for Secretaries; Mrs. F. D. Ellis the class for Treasurers; Mrs. N. B. Coffman the class on the United Offering; and Miss Lucy Gardner the Sunday School Junior plan.

At three o'clock the convention came together again to listen to an address by Mrs. Charles Pratt, of Tacoma, on Diocesan Missions. Mrs. Pratt took as her text, Bishop Burleson's book "Our Church and Our Country."

Mrs. Morgan, of St. Mark's, Seattle, had charge of the Literature table and Mrs. Burbach, of Kent, represented the Hospitality Committee.

After closing prayers, read by Rev. W. H. Bliss, of Trinity, Seattle, the meeting adjourned for the day.

Thursday, May 22nd, the meeting came to order at eleven o'clock, Archdeacon Hilton leading in the devotions, and Mrs. Kydd presiding.

Minutes of the last Annual meeting were read and accepted.

President called for reports from the Treasurer and Treasurer of the United Offering and Corresponding Secretary, which were read and accepted.

Report of the Committee on Constitution resulted in the following amendments to the Constitution:

Article V, Section 1, Paragraph 2. That the Vice Presidents shall be elected, one from each Deanery, and that the Vice Presidents shall endeavor to promote the foundation of Branches in their Deanery, and help and strengthen those already existing. They shall plan the Semi-annual meetings with the help of the President and the Bishop of the Diocese.

Article VII. There shall be an Annual meeting of the Society at such time and place as may be determined upon by the Society itself, and in absence of such determination by the Society, the President, upon consultation with the Bishop, shall appoint the time and place of the Annual meeting.

Article XI. The fiscal year of the Society shall be from May 1st to May 1st.

The following delegates were elected to the General Convention to be held in Detroit in October:

The President's address was full of encouragement and enthusiasm; three new Branches have been formed and increased activity and zeal in old ones.

Mrs. Shayler gave an account of the Seabeck Conference and Mrs. Sydney Morgan spoke of the Advent Call.

Morning session closed with prayers led by Rev. C. S. Morrison.

After luncheon and a short recess Archdeacon Hilton opened the afternoon session with a short address of welcome to the three new Branches, All Saints', Seattle; St. Paul's, Bellingham; and St. Luke's, Vancouver.

Reports from Diocesan Branches were read and placed on file.

Miss Gardner gave a brief outline of the new Junior plan.

A further amendment was made to the Constitution, Article IV, creating two new offices: Box Secretary and Educational Secretary.

Mrs. George Turrell's beautiful tribute to Miss Maynard for her many years of faithful service as both Recording and Corresponding Secretary, found an echo in the hearts of every one present, and a rising vote of appreciation was extended Miss Maynard.

Mrs. Gowen spoke of the women in the "Out of the Way" places.

The per capita tax was increased from ten to twenty-five cents.

Resolution was passed extending the sympathy of the Auxiliary to Rev. R. J. McGinnis, on the death of Mrs. McGinnis, President of the Holy Communion Branch, Tacoma.

Motion was made and carried that the Year Book should again be published, and Mrs. Keator appointed to take charge of same.

Offering at Thursday's session was \$14.70.

Eighty-two responded to roll call.

A rising vote of thanks was extended the ladies of Kent for their generous hospitality.

An invitation was extended by Trinity, Tacoma, for the next Annual meeting.

The Bishop closed the Convention with a "Quiet Hour" and Meditation on the Ascension of our Lord.

Meeting adjourned.

REPORT OF CORRESPONDING SECRETARY

During the past year the correspondence of the Woman's Auxiliary of the Diocese of Olympia has been rather heavy, as so many extra things have been done. First came the meeting of the Synod. Notices were sent out to all the officers of the Eighth Province, and then on account of the war, postals had to be sent telling them the meeting was postponed.

Then came the Advent Call with its wonderful message to all our women. Letters were written and literature sent out.

After which the follow-up work came—namely, the call to Service.

Besides all this, the regular correspondence was carried on.

We were very fortunate in having with us Mrs. Allison and Miss Tillotson from the Church Missions House, New York, to prepare us for the great work of the Advent Call. We also had a visit from Miss Grace Lindley, the General Secretary.

Three new Branches of the Auxiliary have been organized in our Diocese: Vancouver (St. Luke's); St. Paul's, Bellingham; All Saints, Seattle. St. John's has also taken on new life and increased its membership.

An effort has been made to increase the interest in Auxiliary work and there is no better way than each member reading and studying our handbook, consequently I have succeeded in distributing 65 of these handbooks among old members and new. United Offering boxes sent out to those members who did not have them were 50. 270 letters were written, 68 packages were sent out, 107 letters and 14 packages received.

CONSTITUTION

ARTICLE I.

The name of this Organization shall be "The Olympia Branch of the Woman's Auxiliary to the Board of Missions."

ARTICLE II.

The object of this Organization shall be to pray daily for Missions, and by means of united and systematic effort, to diffuse missionary intelligence, to increase missionary activity among the women of this Diocese; to unite previously existing societies, and to encourage the formation of Branches where there are none.

ARTICLE III.

The Church itself is a Missionary Society, and every person by baptism becomes a member of this Organization; therefore, every baptized woman in this Diocese is a member of this Auxiliary.

ARTICLE IV.

SECTION 1. The officers of this Organization shall be a President, three Vice Presidents, Recording Secretary, Corresponding Secretary, Educational Secretary, Box Secretary, Treasurer and Custodian of the United Offering, who shall also constitute an Executive Committee. This Committee shall fill all vacancies that may occur during the year between the annual meetings.

SEC. 2. The President of the Junior Department shall be ex-officio a member of the Executive Committee and shall make a report at the Annual Meeting of the work accomplished by her department.

ARTICLE V.

SECTION 1. The President, or in her absence, one of the Vice Presidents, shall preside over all meetings of this Organization and of the Executive Committee, and shall call meetings at such time and place as in her judgment shall be necessary.

SEC. 2. The Vice Presidents shall be elected one from each Deanery, and it shall be their duty to endeavor to promote the formation of Branches in their respective Deaneries, and to help and strengthen those already existing. They shall plan for semi-annual meetings with the help of the President and the Bishop of the Diocese.

SEC. 3. The duty of the Recording Secretary shall be to keep a record of the proceedings of each meeting of the Auxiliary, and read the same at the following meeting, and to prepare an abstract of the minutes for the annual report.

SEC. 4. The Corresponding Secretary shall conduct the correspondence of the Auxiliary, send out notices, distribute information in regard to Missionary work, and prepare an annual report for circulation in the Diocese.

SEC. 5. The duty of the Treasurer shall be to receive all general and special funds, except as hereinafter provided; to disburse the former under the direction of the Executive Committee, and the latter as the donors may indicate, and to render an account of the same at the annual meeting.

SEC. 6. The Treasurer of the United Offering shall keep an account of the mite boxes in use in the various Branches; shall collect the contents by September 15; shall invest the same each year, and conduct all necessary correspondence. The total amount, principal and interest, shall be ready for presentation at the triennial meeting of the Auxiliary.

ARTICLE VI.

All Societies that desire it will be considered members of this Auxiliary, and will send their report of money collected and work done to the Secretary. Delegates from all such Societies will be expected to attend the general meetings. The Secretaries of the Parochial Branches are required to correspond with the Diocesan officers, who alone correspond with the Secretaries of the Board of Missions, and transmit to them all monies.

ARTICLE VII.

There shall be an annual meeting of the Society at such a time and place as may be determined upon by the Society itself, and in absence of such determination by the Society, the President, upon consultation with the Bishop, shall appoint the time and place of the annual meeting.

ARTICLE VIII.

Regularly organized Branches are expected to pay annual dues of ten cents per member, which, with the offering at the annual meeting, shall form a fund, out of which the Treasurer shall pay all Auxiliary expenses.

ARTICLE IX.

New Branches in missions may report as Auxiliary work such Church furnishings and Sunday School supplies as they may provide for their own missions during the first two years of the Branch's organization.

ARTICLE X.

The fiscal year of the Society shall be from May 1st to May 1st.

ARTICLE XI.

This Constitution may be altered or amended by a two-thirds vote at any annual meeting.

BY-LAWS

1. Officers shall be elected at the annual meeting. The President shall appoint a committee on nominations, and upon the coming in of their report, the meeting shall proceed to elect by ballot or *viva voce*. The choice of officers need not be confined to persons nominated by the committee.
2. Every local Branch shall forward to the Secretary, on or before the first of May of each year, a full report of all missionary work done during the year.
3. The order of business at the meeting of the Society shall be as follows:
 1. Prayer.
 2. Calling of the Roll.
 3. Reading of the Minutes.
 4. Corresponding Secretary's Report.
 5. Treasurer's Report.
 6. Report of President of Junior Department.
 7. Report of Custodian United Offering.
 8. Address of President.
 9. Miscellaneous Business.
4. These By-Laws may be amended by a majority vote at any general meeting.
