PRESIDENT'S ANNUAL REPORT

To the WOMAN'S AUXILIARY OF THE DIOCESE OF OLYMPIA:

We come to our twenty-ninth annual meeting with praise on our lips and with a song of thanksgiving in our hearts, for the way in which we have been led since last we met together. Surely goodness and mercy has followed us all the days, and with joy we express our gratitude to the Bountiful Giver for His great goodness.

The meeting of the Provincial Synod and the organization of a Provincial Auxiliary, September 29-October 3, at Trinity Church, Seattle, was a great event in our history. A most successful meeting was held, from which we received a great deal of instruction and inspiration. Mrs. Louis Monteagle of San Francisco was elected President for three years, and I had the honor to be elected First Vice-President for the same time. The Provincial meeting will be held in Salt Lake City this year, September 7 to 10, and it is hoped that our Diocese may be well represented.

The greatest joy of the year's work to me has been visits made to the different parishes and the personal touch with the members of the Branches. Everywhere there has been the hearty co-operation of not only the women, but also of the Rectors. The meetings have been informal with not only business to be discussed, but there was also a luncheon, where we were able to know one another in a way which would have been otherwise impossible. These visits were made to Everett, Puyallup, Mt. Vernon, Tacoma, Bellingham, Olympia, Hoquiam and Aberdeen.

We welcome this year three new organizations: Olympia, Hoquiam and St. Barnabas Chapel of St. Marks Church, Seattle. Also a great revival of interest at Aberdeen, with the consequent addition of many new members. This growth, with the organization of Hoquiam, is entirely due to the efforts of one woman, Mrs. George Ware, of course, backed by her husband, the Dean of the southern part of the Diocese.

There were two Deanery meetings held, the success of which more than justifies the change in our Constitution. At the one held at Bellingham in November, there was an attendance of about sixty; at the one held at Aberdeen and Hoquiam there was an attendance of almost a hundred. These were entirely arranged by the Vice-President for the Deaneries, Mrs. Van Kirk for the Northern and Mrs. Ware for the Southern Deanery. The meeting of the Central Deanery, of which Mrs. Jacobs is Vice-President, was combined with the Provincial meeting in September. Surely much good must come from these meetings, for the strengthening of the women and the advancement of the Kingdom.

The year 1921 marks the Fiftieth Anniversary of the organization of the Woman's Auxiliary. During this year a thank offering will be given, to be known as the Emery Fund, in grateful appreciation of what these three sisters have meant to the Auxiliary. The income from this fund will be used for Missionaries home on furlough, for board, medical care, study or recreation. Many parishes have already reported their quota, and we hope

for a good offering from our Diocese. "On October 16 Corporate Communion will be held in every parish throughout the country, when members of the Woman's Auxiliary may dedicate themselves afresh to the service of the King."

RELIGIOUS EDUCATION

I had the pleasure and privilege of representing the National Student Council at the Seabeck Conference of the Y. W. C. A. We had a group of splendid young women to whom I had the opportunity of presenting the claims of the Church and the different phases of work which it offers.

In November I again represented the Council at a Student Rally and Banquet held at the University of Washington. At this time I presented the work of the Church in China, particularly St. Marks School at Shanghai. This meeting was also arranged by the Student Y. W. C. A. and was most successful.

I am glad to announce that the Rev. Mr. Oberholtzer has accepted the position of Director of Religious Education of the Diocese, and to assure him of our assistance and co-operation in this important phase of our work.

Four weeks from the day she presided at a session of the Annual Meeting the funeral of our First Vice-President, Mrs. C. A. Pratt, was held at Trinity Church, Tacoma. A woman of rare gifts and winning personality, all of which were consecrated to her Lord for His service, her loss to us is a great one. She has entered into the fuller life, truly her works do follow her, and the example of her life will be an inspiration to those of us who must go on with the task which she has laid down.

Another great loss to the Diocese was felt in the death of Miss Kinugasa, the faithful worker among the women and children of the Japanese Mission. She had organized a Woman's Auxiliary, which I attended, a short time before her death, which would have been a credit to any of our parishes. A patient sufferer for many years, she worked quietly, steadfastly and successfully in the place to which she was called. She has gone to her reward, to the rest that remaineth to the people of God, but her memory will be held sacred in the lives of those whom she has led into the light, and who will rise up to call her blessed.

I cannot close without a word of deep appreciation of the loyalty of my co-workers in the Diocese of Olympia. What has been done, has been done with and by them. "There remains yet very much land to be possessed." May we go forward in His strength, knowing that success will crown our efforts.

"Only be strong and of good courage, be not affrighted, neither be thou dismayed, for Jehovah thy God is with thee, whithersoever thou goest."

MINUTES

The Twenty-ninth Annual Meeting of the Woman's Auxiliary to the Presiding Bishop and Council, was held in Trinity Parish Church, Seattle, on May 26th and 27th, 1921.

Holy Communion was celebrated by the Right Reverend F. W. Keator, Bishop of the Diocese, assisted by Rev. W. H. Bliss and Rev. C. S. Mook. The sermon was preached by Bishop Keator, from the text "And they rest not day nor night, saying, Holy, Holy, Holy, Lord God Almighty, which was, and is, and is to come," Rev. IV, 8. He brought home in a forceful manner the lessons of the Trinity season to the women of the Auxiliary.

Luncheon was served at the Y. W. C. A.

The afternoon session was opened at 1:45 with prayer by the Rev. Cameron Morrison, Dean of the Northern Deanery, who spoke on the "Missionary Work of the Diocese." He stated that the greatest thing done in this Diocese by the nation-wide campaign was the raising of the stipends of the missionaries. Some notable advances have been made in the work done at Bremerton and East Seattle.

The Rev. John D. McLaughlin followed with an address on Religious Education. He called attention to a book on Organization of the Parish, by Dr. Goodwin, which should be in the hands of every leader in Woman's Auxiliary work.

Ninety-six responded to roll call, representing seventeen branches. The offering was \$18.81.

Mrs. G. G. Ware of Hoquiam, Vice-President of the Southern Deanery, spoke on "How to Increase Our Membership." The main thing is to be interested, and work to get others interested.

Mrs. Arnison, President of Epiphany, Seattle Branch, next gave her ideas on "How to Make Our Meetings Worth While." She said, "You cannot compel people to do Auxiliary work, but you *can* lead them." She suggested short, concise business meetings, active study classes and a social hour.

Here followed a short discussion and reports of methods used in different Branches.

Mrs. W. E. Lovejoy followed, speaking on "The Work of the Supply Department."

Mrs. McCollum of Trinity Parish next spoke on "The Church Service League as Adopted in Trinity Parish." Her idea is to "do what you can, with what you have, where you are."

After the benediction, pronounced by Rev. C. S. Mook, the meeting adjourned until Thursday morning at 10 o'clock.

THURSDAY, MAY 26TH

Meeting opened at 10:30 with prayers by the Rev. W. H. Bliss. Minutes of the last annual meeting read, and with one correction, approved.

The report of the Corresponding Secretary read and accepted (Appendix D).

The report of the Treasurer read and accepted.

The report of the Supply Secretary read and accepted.

The report of the United Thank Offering Treasurer read and accepted.

Fifty-seven members responded to roll call, representing fourteen branches. The offering was \$11.78.

The President next made her annual report, which, as usual, was full of the spirit of enthusiasm and encouragement.

After a short recess for luncheon the meeting was again called to order and opened with prayer.

Miss Amy Smith, Executive Secretary of the Northwest Field Committee of the Y. W. C. A., gave a short address on "Prayer," taking as her text Zachariah IV, 6, "Not by might, nor by power, but by My spirit, saith the Lord of Hosts."

The reports from the different Branches were next given. They practically all show an increase in work done and in money given.

Miss Gertrude Sanders, who was chairman of a committee appointed to draft resolutions of sympathy on the death of Miss Kinugasa, offered the following resolution, which was adopted:

BE IT RESOLVED, That we, members of the Woman's Auxiliary of the Diocese of Olympia express our deep appreciation of her life and faithful

work among her people, and wish to convey to her family our thankfulness of her life among us.

We recommend that these Resolutions be spread upon our Diocesan records and copies be sent to St. Peter's Mission, of this city, and to her family in Japan.

A communication from Miss Lindley was read, asking that there be a National Day of Intercession in the first week in Advent.

The question of having representatives from the Woman's Auxiliary elected to the departments of Religious Education and Social Service of the Diocesan Council was taken up, and after some discussion it was decided to have two members in each department, and Mrs. Kydd and Mrs. Culver of St. Mark's, Seattle, were elected to the department of Religious Education; Mrs. E. C. Ward and Mrs. Robt. Hall to the department of Social Service.

The report of the Committee on Constitution was read and accepted.

It was moved, seconded and carried that the Treasurer be instructed to pay \$5.00 annual dues to the Provincial Auxiliary.

CONSTITUTION

ARTICLE I.

The name of this Organization shall be "The Olympia Branch of the Woman's Auxiliary to the Presiding Bishop and Council."

ARTICLE II.

The object of this Organization shall be to pray daily for Missions, and by means of united and systematic effort, to diffuse missionary intelligence, to increase missionary activity among the women of this Diocese; to unite previously existing societies, and to encourage the formation of Branches where there are none.

ARTICLE III.

The Church itself is a Missionary Society, and every person by baptism becomes a member of this Organization; therefore, every baptised woman in this Diocese is a member of this Auxiliary.

ARTICLE IV.

The officers of this Organization shall be a President, three Vice-Presidents, Recording Secretary, Corresponding Secretary, Educational Secretary, Box Secretary, Treasurer and Custodian of the United Thank Offering, who shall also constitute an Executive Committee. This Committee shall fill all vacancies that may occur during the year between the annual meetings.

ARTICLE V.

SECTION 1. The President, or in her absence, one of the Vice-Presidents, shall preside over all meetings of this Organization and of the Executive Committee, and shall call meetings at such time and place as in her judgment shall be necessary.

SEC. 2. The First Vice-President shall be elected at large, whose duty it shall be to assist the President in the upbuilding of the Woman's Auxiliary throughout the Diocese.

The Second Vice-President shall be elected from the Southern Deanery, and the Third Vice-President from the Northern Deanery. It shall be their duty to have general oversight of the Auxiliary in their respective Deaneries; to promote the formation of new branches, and help and strengthen those already existing.

They shall plan for semi-annual meetings with the help of the President and the Bishop of the Diocese.

SEC. 3. The duty of the Recording Secretary shall be to keep a record of the proceedings of each meeting of the Auxiliary, and read the same at the following meeting, and to prepare an abstract of the minutes for the annual report.

SEC. 4. The Corresponding Secretary shall conduct the correspondence of the Auxiliary, send out notices, distribute information in regard to Missionary work, and prepare an annual report for circulation in the Diocese.

SEC. 5. The duty of the Treasurer shall be to receive all general and special funds, except as hereinafter provided; to disburse the former under the direction of the Executive Committee, and the latter as the donors may indicate, and to render an account of the same at the annual meeting.

SEC. 6. The Treasurer of the United Thank Offering shall keep an account of the mite boxes in use in the various Branches; shall collect the contents by September 15; shall invest the same each year, and conduct all necessary correspondence. The total amount, principal and interest, shall be ready for presentation at the triennial meeting of the Auxiliary.

ARTICLE VI.

All Societies that desire it will be considered members of this Auxiliary, and will send their report of money collected and work done to the Secretary. Delegates from all such Societies will be expected to attend the general meetings. The Secretaries of the Parochial Branches are required to correspond with the Diocesan officers, who alone correspond with the Secretaries of the Board of Missions, and transmit to them all monies.

ARTICLE VII.

There shall be an annual meeting of the Society at such time and place as may be determined upon by the Society itself, and in absence of such determination by the Society, the President, upon consultation with the Bishop, shall appoint the time and place of the annual meeting.

ARTICLE VIII.

Regularly organized Branches are expected to pay annual dues of 25 cents per member, which, with the offering at the annual meeting, shall form a fund, out of which the Treasurer shall pay all Auxiliary expenses.

ARTICLE IX.

New branches in missions may report as Auxiliary work such Church furnishings and Sunday School supplies as they may provide for their own missions during the first two years of the Branch's organization.

ARTICLE X.

The fiscal year of the Society shall be from May 1st to May 1st.

ARTICLE XI.

This Constitution may be altered or amended by a two-thirds vote at any annual meeting.

BY-LAWS

1. Officers shall be elected at the annual meeting. The President shall appoint a committee on nominations, and upon the coming in of their report, the meeting shall proceed to elect by ballot or viva voce. The choice of officers need not be confined to persons nominated by the committee.

2. Every local Branch shall forward to the Secretary, on or before the first of May of each year, a full report of all missionary work done during the year.

3. The order of business at the meeting of the Society shall be as follows:

1. Prayer.
2. Calling of the Roll.
3. Reading of the Minutes.
4. Corresponding Secretary's Report.
5. Treasurer's Report.
6. Report of President of Junior Department.
7. Report of Custodian United Thank Offering.
8. Address of President.
9. Miscellaneous Business.

4. These By-Laws may be amended by a majority vote at any general meeting.
