The Woman's Auxiliary was created by the Board of Missions during the session of the General Convention, October, 1871, in the City of Baltimore, and approved by the Board of Missions at the General Convention of 1880, to assist it in meeting its regular appropriations and to aid all missionary work of the church in any direction and to aid in any way that may be recommended by the Board or endorsed by the several Bishops.

The Junior Department was authorized by the General Board in 1889. The Quincy Branch of the Woman's Auxiliary was organized in 1887 at Rock Island by Miss Emery and Bishop Burgess.

Counsels to Parochial Offices.

Impress upon the women of your parish that they are, by virtue of their baptism, members of the Auxiliary. Urge them to recognize this claim by working along the appointed lines.

Miss Emery suggests the following order of business:

- 1—Prayer.
- 2—Roll call.
- 3—Reading of minutes.
- 4—Treasurer's report.
- 5—Report of committees.
- 6—Communications.
- 7—Unfinished business.
- 8—New business.
- 9—Prayer.
- 10—Adjournment.

Begin every meeting with prayer.

Every branch is expected to give to the Apportionment Fund, General Missions and to the United Offering. After this develop any general or diocesan work that has the approval of your Rector. *General Emery.*

The United Offering is the thank offering presented at every triennial session of the Woman's Auxiliary. It is made by all branches of the Auxiliary and given to the Board of Missions for Woman's work in the Domestic and Foreign fields, including the training, sending and support of women workers, also the care of such workers when sick and disabled; this to be interpreted to include Brazil, Haiti, Cuba, and Mexico. This is to be gathered by mite boxes. Send for them and for the leaflets *4 Q. Custodian* to the Treasurer of the Diocesan branch.

Semi-annual collections are desired for the United Offering in March and September, or it may be given in the form of a birthday offering. Each one should keep ready for reference a church almanac with

clergy list, the Cathedral Chimes, the last report of your Diocesan branch, Miss Emery's last report and the Spirit of Missions; and keep in supply copies of auxiliary prayers and leaflets from the Church Mission House and Mite Chests for the United Offering.

When a project is laid before your branch, do not fail to report its action after due deliberation. When you begin a box advise the recipient and the Diocesan secretary. When you ship it, advise again giving date and mode of shipment, notifying the Secretary of its money value, urge the acknowledgement of the same by the recipient.

If you cannot secure free shipment, always prepay charges and state this in your notification.

Remit money by express, postoffice order or bank drafts.

Please send the names and addresses of all parish officers to the Diocesan Secretary and notify her at once of any change of officers.

See that all notices of meetings sent out by the Diocesan Secretary are read by your Rector at the church services.

Lists for Missionary boxes should be filled by new articles of good quality, durable and tasteful. If all cannot be sent, report to the secretary.

If possible add some little gift not asked for in the list, also a box of candy, that there may be a little surprise for the missionary's family in unpacking the box.

The Bishop and Auxiliary officers recommend to your care Jubilee College, in addition to the above work.

Minutes.

The twenty-third annual meeting of the Quincy Branch of the Woman's Auxiliary to the Board of Missions, was held in the Parish Hall of Christ Church, Moline, on Tuesday, May 17th 1910.

Previous to this, the visitors had received invitations to a reception to be given by Rev. and Mrs. Musson on Monday evening to meet the Bishop, Deaconess Routledge, of the Philippines, the clergy Auxiliary members, etc. Many responded by coming the day before, and a very pleasant occasion was held. This also served as a dedication of the new Parish Hall.

On Tuesday morning Holy Communion was celebrated in the Church at 9 a. m. with Bishop Fawcett celebrant, followed by the business meeting at 10 a. m.

This was opened by a short prayer by Rev. Mussen with the creed, afterwards extending a hearty welcome to those present.

The President, Mrs. B. F. Diggs, having resigned in November, 1909, to go with her family to California, there was no annual address.

At Roll Call twelve branches of the W. A. responded and one Junior Auxiliary, the two delegates from each branch being quite generally represented and in some cases more. Of the officers there were present the Vice Presidents of Peoria and Rock Island Deanery, the Secretary, Treasurer and United Offering Custodian.

The minutes of the last meeting were voted to be omitted as the printed reports, although just finished, had been distributed.

The Secretary, Mrs. Zeller, then read her report.

Miss Emery had asked the Quincy Branch to assist four missions, to furnish a clerical suit and missionary box of new articles for Arthur Kenyon, of Stillwater, Okla., a catechist suit and complete new outfit for Wm. Walking Shield, Indian catechist, his wife and three children serving under Rev. J. P. Deloria, himself an Indian, at Wakpola, S. D. Help was asked for St. Mary's On the Mountain and for Mrs. Barbour's mission at Saluda, N. C.

By asking more than one branch to share these requests they were divided thus, the clerical suit was given by the Quincy Cathedral, Canton and Farmington contributing the other articles. For the Walk-

ing Shield family Carthage St. Johns and Grace Church Galesburg, St. Marys, Knoxville, and St. Pauls, Peoria, contributed. Thus a most valuable box was able to be sent.

St. Stephen's branch and its Juniors, Rock Island, and the Good Shepherd, of Quincy, sent valuable boxes to the missions of Rev. Deloria.

There are other favorite missions which come in for a share of attention as Jubilee, the Orphanage at Springfield, St. Andrews at the Switch and others. We have lost three branches during the year, Moline and St. Andrew's, Peoria Jrs. and Macomb.

The Walking Shield box was valued at \$75.75; Deloria mission box \$101.30; St. Mary's on the Mt., \$261.20. The value of boxes altogether is something near \$1000 and the money value \$300.

The last year's giving has been more systematic, realizing that the first duty is towards the Apportionment, General Missions and the United Offering, and we have not been carried away by specials or suggestions from others, thus forgetting our first obligations.

We lost Mrs. Purce in 1906, Mrs. Wilson in 1907, and Mrs. Diggs in 1909, whom we regret not to have with us to-day. She was a most capable officer and first urged the payment of the full amount of the Apportionment Fund, and last year the \$125 asked for by Miss Emery was forwarded, an honorary president was added to the official list, a printed programme introduced, and the United Offering Custodian was added after Mrs. Hopkins' inspiring address in Peoria. Carthage, Moline, the Junior Aux. of Moline and St. Paul's, Peoria, have been added during the past year.

Our most serious loss has been the passing away of Mrs. Rosetta Getchell, vice president of the Quincy Deanery, which came so suddenly that we were not prepared for it. She was rightly named by our Bishop, "Saint Rosetta." Her assistance to the Bishop and church in general was invaluable, and can never be replaced.

We are represented by 300 members, 250 of the W. A. and 50 Juniors. Two interesting Junior Auxiliaries have been formed in Rock Island, one for young children from 10 to 13 years and the other from 15 to 18 years. Twenty-two branches contributed, seventeen of the W. A. and five Juniors.

Altogether, Bishop Fawcett saw farther than we realized when the meetings were taken ~~out~~ ^{up} by the Synod and have since been held separately.

The Treasurer then read her report, always satisfactory, but of the

apportionment but \$67 of the \$125 had been collected. Before the close of the meeting, \$5 had been pledged each by St. Paul's, Peoria, Kewanee, Canton. Moline gave \$3 and other branches \$2 down to 50 cents, until the full amount was raised.

The United Offering Report was then read by Miss Sherwood and showed an increase in offerings by using the birthday ^{meetings} of collecting funds.

The Vice Presidents in giving reports, reiterated in part what had appeared in the Secretary's report.

Bishop Fawcett then asked to speak of a subject dear to his heart—Jubilee, paying a tribute at the same time to Mrs. Getchell who had really contributed the first money for the school in its advertising. She had also given \$1000 for a cottage, as had Mrs. Patterson and Dr. Leffingwell \$500. He spoke of Mr. Abbot's appointment and the bright prospects of the school, and then Mr. Abbot himself spoke of his great privilege to have charge of the cradle of the church in Illinois, giving a history of Bishop Chase and Jubilee.

The Bishop expressed a wish that the meetings hereafter be held outside of a church building.

A fine luncheon was served at 12:30 in the guild hall and at 2 p. m. Deaconess Routledge, of the Phillippines, gave a very interesting talk with stereopticon, upon this subject, bringing data and pictures down to the present. This was followed by the Bishop, who gave an illustrated talk on the Diocese of Quincy, giving views of the various churches, both in town and country, which in their pretty setting of trees and foliage, were scarcely recognized.

In the evening Rev. Percival, of Peorio, gave an inspiring talk on toe Laymens Forward Movement and the meeting was brought to a close.

Constitution.

ARTICLE I.

This Association shall be called the Quincy Branch of the Woman's Auxiliary to the Board of Missions.

ARTICLE II.

The objects of this Association shall be those of the General Auxiliary.

ARTICLE III.

All women of the Diocese desiring it, who offer prayer or gifts for Missions, shall be considered members of this Association.

ARTICLE IV.

The officers shall consist of an Honorary President, President, four Vice-Presidents (one from each Deanery), a Secretary and a Treasurer.

ARTICLE V.

The duty of the President shall be to preside at all meetings, to arrange for the organization of Parochial branches, and to have general charge of the work.

ARTICLE VI.

The duties of the Vice-Presidents shall be to choose one of their number to preside in the absence of the President, and to cooperate with her in the general supervision of the work of the Association in the Deaneries to which they belong.

ARTICLE VII.

The Secretary shall correspond with the General Secretary of the Auxiliary, and with the Vice-President of each Deanery concerning work of each Parish branch, and shall give notice of meetings and keep minutes of them.

ARTICLE VIII.

The duties of the Treasurer shall be to receive all Special and General Funds; to disburse the former as the donors indicate, and the latter under the direction of the Executive Committee, and to render an account of the same at the annual meeting.

ARTICLE IX.

The officers of the Diocesan Branch shall be a committee to use such means as lie in their power to increase Missionary knowledge and interest in the women of the diocese.

ARTICLE X.

There shall be one general meeting each year during the third week in May, when each Parish branch may be represented by two (2) delegates with power to vote. Special meetings may be called by the Officers.

ARTICLE XI.

The constitution may be altered at any general meeting by a majority vote, or at a special meeting, if notice has been given of the desired change.
