## MINUTES

---

The twenty-ninth annual meeting of the Auxiliary of the Diocese of Quincy was held in St. Paul's Church, Warsaw, May 9, 1916.

The service of the Holy Communion (fully choral) was celebrated at 7:00 a. m. by the Rev. George Long. This service was followed at 8:15 a. m. by breakfast served in the Parish Hall by the ladies of St. Paul's Church.

At 9:30 a. m. there was a quiet hour conducted by the Rev. Andrew Chapman of Grace Church, Galesburg. Following this hour a brief business meeting, preliminary to the afternoon business session, was called to order by the Bishop of the Diocese. Roll call was responded to by delegates from the following branches: Quincy, Cathedral; Bushnell, Canton, Carthage, Galesburg, Grace; Knoxville, Macomb, Moline, Monmouth, Peoria, St. Andrew's; Peoria, St. Paul's—Senior and St. Elizabeth branches; Peoria, St. Stephen's; Quincy, Good Shepherd; Rock Island and Warsaw. Junior delegates reported from Peoria, St. Paul's and St. Stephen's; Quincy, Good Shepherd; Rock Island and Warsaw.

The Secretary's report of money and boxes was read and accepted for publication in the annual report.

Miss Sherwood, the Treasurer, read her report showing the finances of the Auxiliary to be in somewhat better condition than usual. This report was also accepted for publication.

The report of the Educational Secretary, Sister Josephine, was read by Mrs. Zeller. The mission study classes have done splendid work under Sister Josephine's guidance and we are heavy losers by her removal from this Diocese. The report was accepted.

Mrs. G. H. Sherwood, president of the Junior Auxiliary, reported for her department, showing a good increase of work and interest among the Juniors.

The suggested form for the new constitution was submitted by the committee and was read by the Bishop for the consideration of the organization.

The business session then adjourned till 2:00 p. m.

At 11:00 a. m. special services were held with the sermon by the Rt. Rev. Daniel S. Tuttle, D. D., Presiding Bishop of the Church. It was a vigorous and inspiring address, and one to be remembered by those fortunate enough to be present.



At 12:30 luncheon was served. The visiting Bishops and Clergy were the guests of Dean Long at the Rectory. The delegates and other visitors were served in an historic brick school house a few blocks from St. Paul's church.

At 2:00 p. m. the business meeting was resumed with devotions conducted by Father Chapman of Galesburg. Bishop Fawcett spoke briefly of the value to him of the Woman's Auxiliary and of the meaning and use of the "Bishop's Purse." He then introduced Bishop Morrison, "our neighbor from Iowa," who gave an interesting talk about the conditions in his own diocese, showing them to be similar to our own in their measures of success and failure. He spoke of the lack of personal interest, with particular regard to the Sunday schools.

The suggested constitution was re-read, article by article, and so adopted. Afterward it was accepted as a whole. The by-laws were unanimously adopted. The principal changes in the constitution have to do with officers. The number of vice presidents is reduced to one; the recording secretary is eliminated; the position of educational secretary becomes an appointive office.

In the place of the usual address, the president, Mrs. Zeller, made an informal talk in which she thanked the officers for their co-operative work during the year, and mentioned the loss of Sister Josephine from the Diocese. The president hoped we might increase our payment to the Bishop's purse and our subscription to "Light." Several announcements were made from the chair, including the account of the complete record of the Woman's Auxiliary of the Diocese of Quincy since its beginning; the presence of two charter members of the Auxiliary, Miss Mary Marsh of Warsaw and Miss Mary Bestor of Peoria; the invitation of the Keokuk, Iowa, branch to hear Miss Lindley on May 26th, at Keokuk; the sale of Miss Emery's handbook at the close of the meeting.

Miss Douglas, special officer for "The Spirit of Missions," reported a fair degree of success with the subscriptions.

The election of officers was next in order. Of the four candidates for President, Mrs. G. H. Sherwood, Rock Island; Mrs. George Zeller, Peoria; Mrs. W. H. George, Peoria; Miss Mary Marsh, Warsaw, the ballot showed Mrs. Sherwood elected. However, as Mrs. Sherwood declined and Mrs. George



and Miss Marsh withdrew, the Secretary was instructed to cast the ballot for Mrs. Zeller who was declared elected.

Miss Alice Heading, Peoria; Miss Mary Marsh, Warsaw, and Mrs. J. A. Bunting, Quincy, were nominated for Vice President. Miss Marsh was elected.

Mrs. T. R. Stokes, Kewanee, the sole candidate for Secretary, was unanimously elected.

Miss Eliza S. Sherwood, Moline, was unanimously elected Treasurer.

Motion was made, seconded and carried to allow the Junior delegates to vote as members of the Auxiliary at the annual meeting.

The Rev. Dr. Davidson thanked the branches for their assistance with "Light," and asked that each branch appoint a news editor to report to him items of interest for publication. He hopes to make this paper a unifying medium for the Diocese.

The Rev. Andrew Chapman on behalf of the ladies of Grace Church, Galesburg, invited the Auxiliary to meet with them in 1917. This invitation was accepted by vote of the members present.

The Rev. George Long spoke briefly of the plan to have the Woman's Auxiliary meet with the Provincial Synod to take up the matter of missions, social service and education. He reported a plan to be presented to the next Provincial Synod of the Mid-West for the establishment of a House of Churchwomen to meet with and co-operate with the Provincial Synod.

The report of the United Offering was read, showing the total now to be \$1260.65. This is \$119.35 less than double the amount of the offering of \$690, presented by the Diocese of Quincy at the Triennial in 1913. It is our great hope to reach the \$1380 mark by the time of the Triennial in October.

The matter of delegates to the Triennial was brought up and motion made that they be appointed by the Bishop. [Note—The delegates appointed are: Mrs. George Zeller, Peoria; Mrs. G. H. Sherwood, Rock Island; Miss Abigail Davidson, Carthage; Miss Eliza Sherwood, Moline; Mrs. R. F. Newcomb, Quincy. Alternates, Mrs. L. E. Wilson, Peoria; Mrs. T. A. Brown, Quincy; Miss Alice Heading, Peoria; Miss Anne Hopkins, Griggsville; Mrs. Helen Bardens, Warsaw.]

A motion was made to send a note to Sister Josephine, thanking her for her good work and regretting her resignation.



A rising vote of thanks was given to the church people of Warsaw and the visiting Bishops who made the meeting so valuable to the Woman's Auxiliary.

At 4:30 the business session adjourned. The visitors were invited into the Parish Hall, where tea was served by the ladies of St. Paul's.

At 8:00 p. m. the meeting was opened by the Rev. Dr. Davidson, who introduced his brother, the Rev. P. G. Davidson, Rector of St. James', Greenville, Miss. He spoke of the work among the black people and cleared up several popular fallacies upon the subject.

Following this talk, and in the time allotted to Miss Lindley of the Church Missions House, who failed to arrive for the meeting, the Rev. George Long gave a synopsis of the pageant to be staged in St. Louis at the General Convention. It will be a gigantic spectacle, including about 2,500 people. Dean Long's outline of the performance created great interest and the desire of his audience to see the production.

A hymn and the benediction closed this service which marked the end of a very successful meeting of the Woman's Auxiliary.

## PRESIDENT'S ADDRESS

---

Greetings to our Bishop, guests, and the members of the Quincy Branch of the Woman's Auxiliary! Sincere congratulations on the work which has been accomplished this year. The workers have been faithful and devoted and there is cause for rejoicing because of an encouraging efficiency and growing sense of responsibility.

We have added three new branches during the year, those of Lewistown, Mendon and Bushnell, which came in at the last annual meeting, as well as the revival of St. Andrew's, Peoria.

Our membership remains about the same but branches have increased their gifts. All obligations have been met promptly and we have added to our yearly budget the "Milwaukee Plan."

In all of this work, the Young Women's Branch does its share and more, and is a splendid example for similar branches to follow when organizing.

The work of the Juniors shows constant growth under its leader. Never has there been so large a representation in attendance at an annual meeting.

The work of the Educational Secretary is now so well understood that it needs but little direction. It is with universal regret that we part with Sister Josephine, who goes to a larger field. For so long she has gone in and out among us, faithful and untiring. Her report will interest you. The new constitution which you asked for at last year's annual meeting is now presented for your consideration. As chairman of this committee Sister Josephine leaves this as part of her last work. It has been compiled from other branches, such as Southern Ohio, Chicago, and Miss Emery's new Handbook. The new constitution puts in printed form the manner in which we have been carrying on the work for some time which as it grows requires organized methods of procedure.

It was a pleasure to attend the sixth meeting of the Woman's Auxiliary in the Province of the Mid-West with Sister Josephine and Mrs. Sherwood. At the Cathedral in Chicago, the formal organization and constitution were drawn up. That is, a Woman's Auxiliary has been formed within the Fifth Province, holding its sessions in June at the same time as the Synod of the Province. This is composed of twelve dioceses and 500 branches.



To have a definite object in view, Mrs. F. M. Clanson of Milwaukee proposed at the Milwaukee meeting what is now called the "Milwaukee Plan." It was to form a central fund each year which shall be devoted to some poor mission, weak or forlorn cause in this Province, each diocese in its turn receiving the benefit. Four dioceses so far have received it, leaving eight others, one of which in time will be our own. \$1.00 is asked from each branch as dues. It is a Bishop's Purse on a larger scale. This year's meeting is postponed until the General Convention, notice of which will be given.

A committee of the Synod of the Province of the Mid-West was also appointed to consider the subject of the co-operation of women in the work of the Provincial Synod. They wish wide publicity given to this subject for expression of opinion, to learn what is best for the church. Recognizing the splendid work of women it desires to provide means by which the work of women should be organized within the Province, with a hearty co-operation between the Provincial Synod and women of the church. As a means of bringing this about it was suggested that certain representative women or bodies of women sit with the members of the Provincial Synod as a Provincial Board of Missions. This not seeming practicable for fear members of the Provincial Synod might think the plan not authorized under the Canons of the General Convention, it is preferred that the women of the church have an organization of their own, autonomous, but in full accord and co-operation with the Synod of the Province. California has had a House of Church Women for ten years, which we could follow, established to legislate for the conduct of woman's work in the church and to act in a consulting capacity. It is thought that the Woman's Auxiliary cannot fill this place; something with wider scope is needed to take up definite work on the lines of Church Extension, Religious Education, Social Service. It shall be the duty of the Board or House "to study all of the work done by the women of the Province in the extension of the work of the church within the Province and throughout the world; to take special note of all schools and institutions carried on by women for the benefit of women and children; to inquire into the constitution and working of all societies and organizations for the help of women or the promotion of their work in the church," etc. It shall consist of five delegates from each diocese. Delegates from seven dioceses shall be necessary for a quorum. It shall sit in consultative session with the Synod, when its report



and the report of its committee and joint committees are presented.

Our work should have been stimulated this year, because of the forthcoming Triennial. The Convention City is so near us this year that there should be a large attendance from this Diocesan Branch, for it is an inspiration to every church woman. Within easy reach we may hear all of the leaders of our great church and learn of its work at the head of which is Bishop Tuttle, who has honored us today with his presence. We may learn from Doctor Teusler himself, of the work and wonderful surgery he and his corps of assistants are doing at St. Luke's, Tokio. Dr. Teusler is of special interest to us, because we shall care for his Insurance Fund during his life time.

The Bishop's Purse we hope to make larger each year and then we must assist in the wider circulation of "Light," our Bishop's paper, by obtaining additional subscribers.

This meeting in Warsaw will be memorable for the presence of three Bishops and two of the founders of the Woman's Auxiliary movement in the Quincy Diocese. Miss Mary Bestor of Peoria was present at its organization in Rock Island in 1887, by Bishop Burgess and Miss Emery. Miss Marsh of Warsaw became its first secretary.

We have the written minutes of our organization from 1896 on, but Miss Marsh has re-written those previous to this, recalling the meetings and signing herself secretary. We are indeed fortunate to have the complete report. If these members would accept invitations to speak before various branches on the early days of the movement, it would be interesting and instructive.

We thank you for your faithful work and ready response and our Bishop for the wise counsel he has at all times offered as well as his confidence in us.

## REPORT OF THE EDUCATIONAL SECRETARY

From May 1, 1915, to May 1, 1916

The most notable thing in the mission study in the Diocese this past year has been the increased use of "The Spirit of Missions," in the Woman's Auxiliary and also in the Junior Department. Probably the excellent series on "How Our Church Came to Our Country," is responsible for this. The course is recommended to those who have not noted it. Among the branches using "The Spirit of Missions" either for a study class or for a reading circle are: The Cathedral, Quincy; Moline; Tiskilwa; Griggsville; Pittsfield; and the Juniors at Rock Island and at Moline. The Warsaw Juniors use the course in "The Missionary Magazine of the Young Churchman" and have also had lessons on China and Africa. At St. Paul's, Peoria, the Woman's Auxiliary has studied "Then and Now"; St. Elizabeth's branch has used the course on "The Conquest of the Continent"; and the Juniors are taking up the Missionary Bishops and their Districts. At St. Stephen's, Peoria, the Juniors have had their missionary game and there have been informal talks on various mission fields. Kewanee has had an interesting series of program meetings on the general mission field.

Our new branch at Bushnell has had no regular mission study, but had a very interesting Japanese Tea, at which the members and invited guests appeared in costume. There were also Japanese decorations, refreshments, and souvenirs, and our General Missionary, Dr. Davidson, gave an address on "Our Church in Japan." The same branch hopes to give a United Offering Tea in the near future.

Dr. Davidson also addressed the Woman's Auxiliary at St. Paul's, Peoria, on "City and Rural Missions" and Bishop Brooke was the speaker at the Missionary Tea in the same parish. Moline and Rock Island report interesting addresses by missionaries from the Mountaineers and from China.

With the Diocesan Presidents of the Woman's Auxiliary and the Junior Department, the Educational Secretary had the privilege of attending the meeting of the Woman's Auxiliary in the Province of the Midwest, at Chicago, last October, and of seeing "Children of Many Lands" given by the children of St. Paul's, Kenwood, and also "The Great Trail" given under the auspices of the General Board of Religious Education and the Junior Auxiliary of the



Diocese of Chicago, at Trinity Church.

At the meeting of the Diocesan Synod at St. Paul's, Peoria, last November, "The Little Pilgrims and the Book Beloved" was given, under the auspices of the Woman's Auxiliary of the parish and under the capable direction of our Diocesan Secretary, Mrs. L. E. Wilson, by the children of St. Paul's, assisted by Miss Elona Flessner of St. Elizabeth's branch as "Mother Church." This mystery play is a good illustration of the Prayer Book and of the fact that the Church can go only where she is taken by her children, and is a strong plea for faithfulness in work, prayer, and self-denial until the world is won for Christ.

In closing this report—as well as my career as your Educational Secretary—may I emphasize again the close relation between the study of missions, prayer for missions, and giving to missions, and say again that a little reflection will show that we do not pray intelligently or earnestly for that about which we know little or nothing, nor are we likely to give either ourselves or very liberally of our substance to something with which we are not familiar; and, finally quote from Miss Emery's Hand-book, recommending the general adoption of not only the Corporate Communion but also that "in each parochial branch some plan may be worked out, by which at every Communion Service in the parish Church two members, at least, shall attend, to present in behalf of all that Offering most precious in the Heavenly Father's sight! A praying Woman's Auxiliary such as this could not fail to help the Board of Missions in its highest purpose—to bring all men into that Church which is the Master's Body, the Body of Him that 'filleth all in all.'"

## CONSTITUTION

---

### ARTICLE I.—NAME.

The name of this Association shall be "The WOMAN'S AUXILIARY to the BOARD OF MISSIONS in the DIOCESE OF QUINCY.

### ARTICLE II.—OBJECT.

The object of this Association shall be: (a) To carry out in the Diocese of Quincy, by united and systematic effort, the three great aims of the Woman's Auxiliary, viz: Prayer for Missions, Study of Missions, and Systematic Giving to Missions; (b) to interest the women of the Diocese of Quincy in the missionary work conducted by the General and Diocesan Boards, and for the purpose of aiding said societies in carrying out the said missionary work.

### ARTICLE III.—MEMBERSHIP.

The Church itself is the Missionary Society. Every baptized person is a member of that Society. Any parish organization of women desiring to engage in the work of this Association may become a Branch and be entitled to representation upon payment of the annual dues as fixed in the by-laws.

### ARTICLE IV.—OFFICERS.

The officers shall be: The Bishop (ex-officio); a President, a Vice-President, a Secretary, and a Treasurer, who shall be elected at the Annual Meeting. These officers, with the President of the Junior Department, shall constitute the Executive Board of the Association.

The Secretary may choose an assistant, if she so desires.

Special officers may be appointed by the President, with the approval of the Bishop and a majority of the Executive Board.

#### Executive Board.

The Bishop (ex-officio), President, Vice-President, Secretary, Treasurer, President Junior Department, Special Officers, (when there are any), Educational Secretary.

### ARTICLE V.—DUTIES.

The Bishop is, ex-officio, head of this Association and all acts of the Ex-



ecutive Board and of the Association shall be subject to his approval.

The Executive Board shall—subject to the Association—direct the active work of the Association.

The duty of the President shall be to call meetings of the Association and of the Executive Board; to preside at the same; to arrange for the organization of new branches; to visit the same; and to have general charge of the work under the direction of the Bishop.

The duty of the Vice-President shall be to preside in the absence of the President; to co-operate with her in the general supervision of the work, and to take charge of any department of work to which she may be assigned by the Executive Board.

The duty of the Secretary shall be to send out notices of all meetings, to keep a record of the same, to prepare reports, and to conduct the necessary correspondence of the Auxiliary.

The duty of the Treasurer shall be to receive annual dues, as fixed by the By-laws; and any other moneys for the expenses of the Association; to pay all such bills as are endorsed by the President and the Secretary. She shall receive and forward all moneys given to redeem pledges made by the Diocesan Branch. She may receive other special and general funds and shall disburse the former as the donors indicate and the latter under the direction of the Executive Board. She shall receive reports from the parish branches of money given by them for missions, through the treasurers of their parishes or sent directly to the Church Missions House and to the treasurer of the Diocesan Board of Missions, which reports she shall incorporate in a supplement to the report of money received and disbursed by her, and present this joint report at the Annual Meeting, to be printed in the Annual Report after being duly audited and certified.

#### ARTICLE VI.—VACANCIES.

When a vacancy shall occur in the Executive Board by death or resignation, the said Board shall have power, with the advice and consent of the Bishop (previously obtained), to appoint an officer to fill the vacancy, the officer so appointed to serve until the next Annual Meeting.

#### ARTICLE VII.—MEETINGS.

There shall be an Annual Meeting of the Association for the transaction



of business.

Special Meetings may be called by the President, when recommended by the Executive Board.

The Executive Board shall meet when necessary and practicable.

#### ARTICLE VIII.—AMENDMENTS.

This Constitution may be altered or amended by a two-thirds vote at any Annual Meeting or at a Special Meeting, if notice has been given of the desired change.

---

#### BY-LAWS.

1. The Annual Meeting shall be held, if practicable, on the second Tuesday in May.
2. The Order of Business at the Annual Meeting shall be:
  - I. Offices of Devotion.
  - II. Roll Call (Officers, Branches, and Visitors.)
  - III. Reading of Minutes.
  - IV. Reports of Officers and Committees.
  - V. Election of Officers.
  - VI. Unfinished Business.
  - VII. Miscellaneous Business and Addresses.
3. The Annual Dues for each Branch of the Woman's Auxiliary in the Diocese of Quincy shall be two dollars (\$2.00).
4. Each Branch that has paid its Annual Dues shall be entitled to be represented by two delegates and to vote as a unit, at all meetings of this Association.
5. Any delegate may nominate. Election shall be by ballot.
6. These By-laws may be altered or amended by a majority vote at any Annual Meeting or at any special meeting, if notice has been given of the desired change.



## INSTRUCTIONS TO BRANCHES

---

The Woman's Auxiliary to the Board of Missions was established in 1871, with a Junior Department in 1899. The Quincy Branch of the Auxiliary was organized in 1887, at Rock Island, by Miss Emery and Bishop Burgess. Every woman in the Church is by virtue of her baptism a member of the Church's Missionary Society. She becomes an actual member of the Auxiliary by voluntarily sharing in its efforts—prayer for missions, study of missions, and gifts in money and work for missions.

1. Prayer for Missions. A special time for prayer for missions, suggested by the General Board and widely adopted throughout the Church, is the noonday hour, and at other times of devotion or together in their Corporate Communion, Auxiliary workers should make special petitions for the Spread of Christ's Kingdom.

2. Study of Missions. In order to have intelligent, earnest, and interested praying for and giving to missions, study is necessary. Books and leaflets on the work, including both foreign and domestic fields, can be secured from The Educational Department, Church Missions House, New York City. For advice concerning any particular course, consult your Diocesan Educational Secretary. The Spirit of Missions, the official missionary magazine, is indispensable to anyone wishing to keep informed about the forward work of the Church. Each parish branch should have copies of Miss Emery's "Hand-Book of the Woman's Auxiliary to the Board of Missions," for study, and of the Diocesan and General Reports, for information and reference.

3. Gifts in Money and Work for Missions. Besides the payment of dues, \$2, each branch of the Auxiliary in this Diocese is asked to give \$2 a year to the Bishop's Purse, and to contribute toward a sum of \$50 which the Auxiliary pledged at the convention in May, 1914, for the Foreign Missionary Insurance Fund. This fund supplies yearly a grant of \$50 to pay insurance dues for a missionary. The Diocesan Secretary will notify the branches of their share in the payment of this fund. There has also been added to our yearly pledge, a contribution to the Milwaukee Plan. See the President's report.

After these authorized calls are met the next most important money obli-



gation is that of aiding in paying the parish mission apportionment, if that be necessary. Miss Emery is urging that our money gifts to missions may be increased even at the expense of the box work.

Another and very important obligation which the Auxiliary has assumed is that called the United Offering. This is a personal thank offering collected by Auxiliary members in the little blue mite boxes or given as a birthday offering. This is taken up in March and September and the money forwarded to the Diocesan Custodian, who places it upon interest until the meeting of the next General Convention, when the entire amount is sent to be placed upon the altar, together with the offerings from other dioceses, at the triennial service of thanksgiving. October, 1913, in New York, a sum in excess of \$300,000, the United Offering made by the women of the Church for three years, was offered up on the great altar in the Cathedral of St. John the Divine. In this offering may also be included the Gift of Life, as suggested in the United Offering Resolution of 1916:

Resolved, That the United Offering of 1916 be given to the Board of Missions to be devoted entirely to the training, testing, sending and support of women for Mission Work at home and abroad, and to the care of such as are sick or disabled. Also that to our united gifts shall be added our united and earnest prayers that God will put into the hearts of many faithful women to give themselves to the work of the Master in the Mission field, or, if they cannot go themselves, to give of their substance gladly, as the Lord hath prospered them.

Appeals from Missionaries and Mission stations are sent to the Diocesan Secretary each fall by Miss Emery, and these are apportioned among the branches as carefully as possible. Branches are asked to rely on the Secretary for such work and not choose independent work.

Full instructions accompany the personal appeals. Such boxes should be filled with new articles of good quality, durable and tasteful. If all cannot be sent, report to the Secretary.

If possible, add some little gift not asked for in the list, also a box of candy that there may be a little surprise for the missionary's family in unpacking the box.

If any second-hand clothing is sent in boxes to mission stations it must

## REPORT OF THE JUNIOR AUXILIARY

---

St. ve. St. This year the Junior Auxiliary completes the tenth year of its existence. In the report of the Woman's Auxiliary of 1906 the President, Mrs. B. F. Diggs, urges that something be done toward forming a Junior organization, and three branches were begun, one in St. Stephen's, Peoria; one in Christ Church, Moline, and one at Grace Church, Osco. Their offerings that year amounted to \$47.50.

In 1909 Miss Lawton of Peoria was appointed as Junior Officer; she was succeeded by Sister Josephine in 1910. At the Annual Convention in Quincy in 1911, the Junior Auxiliary was set apart as a separate organization with Mrs. G. H. Sherwood as President.

The great need in every parish is leaders. The young people are willing and enthusiastic and waiting to be organized.

At the present time we have in the Diocese sixteen branches. We are sorry to bid good-bye to St. Catherine's, Tiskilwa, but after doing splendid work as a Junior Auxiliary they have been graduated into an older Guild doing parochial work. In our sixteen branches we have more than 200 members, 101 of whom are confirmed. In the table opposite, the work done by these branches will show for itself; but how far-reaching the influence of these girls and boys no one can estimate.

## CONSTITUTION

---

### ARTICLE I.—NAME.

The name of this Association shall be the Junior Department of the Woman's Auxiliary in the Diocese of Quincy.

### ARTICLE II.—OBJECT.

The object shall be to study, to pray for, and to give to Missions.

### ARTICLE III.—MEMBERSHIP.

The Church itself is the Missionary Society. Every baptized person is a member of that Society. Any organization of baptized children or young women desiring to engage in the work of the Association may become a Branch upon payment of \$1.00 to the Treasurer.

### ARTICLE IV.—OFFICERS.

The officers shall be a President and a Secretary-Treasurer, who shall be elected at the annual meeting or appointed by the Bishop.

The President shall have general supervision of the work, and present reports to the Woman's Auxiliary of the Diocese and the General Secretary.

The Secretary-Treasurer shall keep the records and accounts of the Association.

### ARTICLE V.—ANNUAL MEETING.

There shall be an annual business meeting, at which each Branch and each Diocesan officer of the Department shall have one vote.

The time and place of meeting shall be the same as that of the Woman's Auxiliary, unless a majority of the Branches shall be in favor of some other place and time.

### ARTICLE VI.—LEADERS.

Each Branch shall work under the direction of one or more Church women, who shall be known as Leaders.

The Leaders shall be appointed by the Rector (or Priest in charge) or by the President of the Junior Department.

### ARTICLE VII.

This Constitution shall go into effect upon its adoption by five Branches and its approval by the Bishop and by the Woman's Auxiliary of the Diocese of Quincy. It may be repealed, altered or amended by a two-thirds vote at any annual meeting or at a special meeting called for that purpose.
