The opening session consisted of Evening prayer, followed by a splendid address on Woman's Auxiliary work and aims by Mrs. E. J. Randall, of Chicago, Chairman of Church Extension in Province V. This was followed by a delightful social hour in the home of Mr. and Mrs. T. R. Stokes.

Following the Corporate Communion the business session opened at nine o'clock, Tuesday morning, in the Parish Hall with the president, Mrs. L. E. Wilson, in the chair. Roll call showed the following present: The Bishop, ten of the clergy, twenty-six delegates, fourteen visitors, also many from the local branch.

Motion to dispense with the reading of the minutes, seconded and carried.

Moved and seconded that the meeting depart from the regular order of business and invite Mrs. Mason of Highland Park to explain the two "Specials" for the coming three years. The amount the Auxiliary wishes to raise is \$75,000; \$10,000 being for a training school in Raleigh, N. C., for colored women, and \$65,000 for a training school in New York for white women. Mrs. Mason suggested \$500 as the amount they would like to receive from Quincy. It was moved and seconded that the Diocese of Quincy pledge \$500 and give as much additional as possible. Motion carried.

Mrs. Wilson, the president, then read her address.

The report of the Box Secretary was then read.

It was moved and seconded that these reports be accepted and printed in the Annual Report. Motion carried.

Treasurer's report was not received.

Report of Custodian of United Thank Offering was read.

Moved and seconded that the meeting elect the other three officers, namely: Box Secretary, Educational Secretary, United Thank Offering Custodian. Motion carried.

Moved and seconded that the three officers who held these positions this year be retained; viz., Mrs. Gray, Educational Secretary; Miss Hopkins, United Thank Offering Custodian, Mrs. Swift, Box Secretary. Motion carried.

The President then read extracts from circulars and letters which had come to her during the past year, emphasizing the World Conference on Faith and Order, and the use of leaflets and printed matter furnished by Church Missions House.

Moved and seconded that one woman from each parish be put on the mailing list of the World Conference on Faith and Order. Motion carried.

Intermission to await arrival of late delegates. During intermission, Bishop Fawcett called the delegates to order in the interest of the Church Service League.

Following this session the meeting was called to order for noonday prayer. Meeting adjourned for luncheon.

Afternoon session convened at 1:45 p. m. and was called to order by the President.

Archdeacon Swift extended an invitation to the Auxiliary to meet at Grace Church, Galesburg, in 1924. Moved and seconded that the invitation be accepted. Motion carried.

It was moved and seconded that the meeting be held on the second Tuesday in May, 1924. Motion carried. Emphasis was laid upon official notices of the meeting to be sent out by the Diocesan Secretary.

Nomination of delegates to the meeting of the House of Churchwomen at Toledo, October 15 and 16, 1923, was next in order. Upon motion a nominating committee was appointed by the chair.

The matter of sending a delegate to Racine Summer Conference was then taken up. Moved and seconded that Mrs. L. E. Wilson be appointed delegate to Racine Conference, with half her expenses paid by the Woman's Auxiliary, and that if it should prove impossible for her to go she be allowed to select some one to go in her place. Motion carried.

Moved and seconded that Mrs. F. C. St. Clair be selected as a second delegate to Racine Conference, her place also to be filled by appointment if an alternate should be necessary. Motion carried.

The nominating committee submitted the following names as Delegates and Alternates for meeting of the House of Churchwomen at Toledo:—

Secretary was instructed to write to Mrs. A. S. Ellis, Treasurer, a letter expressing the regret of the meeting at her inability to attend.

Secretary was instructed to write Mrs. E. J. Randall and Mrs. George Mason letters thanking them for their helpful addresses.

The chair extended a vote of thanks to Fr. Parmiter and the ladies of St. John's Parish, Kewanee, for their kind hospitality.

PRESIDENT'S REPORT

Bishop Fawcett, the Reverend Clergy, Members of the Woman's Auxiliary—

Friends All:—

This is the thirty-sixth annual meeting of the Woman's Auxiliary in the Diocese of Quincy. It is a pleasure and a privilege for us to be together here in Kewanee. Let us make it also a day of profit to the cause of the Auxiliary.

Before we proceed with our report, let us pause to pay tribute to our beloved leader, Bishop Tuttle, who has finished the course. The Auxiliary can never forget the wonderful support he gave us. We have been fortunate in this Diocese in having had him with us in some of our Diocesan gatherings and we remember his presence as a benediction.

So many months have elapsed and so many reports have been given about the General Convention that it seems almost like quoting history to mention it, yet we are proud to recall how many representatives our Diocese had at the Triennial. Certainly we can expect the impressions which they received there to bear fruit in the Diocesan work. At those sessions in Portland some important general resolutions were passed affecting the Auxiliary in every Diocese. These cover the subjects of prison reform, care of disabled veterans, proper laws for women and children, Christian inter-racial and international relations, limitation of armaments, and Christian unity. How we may enter into the carrying out of these resolutions we shall discuss under the head of New Business.

During the past year only a few visiting speakers from without the Diocese have been reported. St. Paul's Branch, Peoria, has had as speakers Mrs. Snowden of Milwaukee, Mrs. Tilton of Chicago, and Mrs. Biller from Church Missions House. Our Executive Secretary, Miss Lindley, enroute from Chicago to Kansas City, stopped in Peoria for an evening meeting and in Galesburg for a brief conference. May I urge upon all the branches the value of bringing in, now and then, workers from other fields. It arouses our enthusiasm, helps to create a healthy competition, and enlarges our vision by making us realize that we are part of a great whole. Often we feel that we of this Diocese are a very small part, but I cannot help deplore the attitude which complains that because we are few in numbers we should be excused from many responsibilities. Of course, our totals will not make large figures, but they can and should be proportionate to our membership. I feel very strongly that we should take our place in the big movements for which the National Auxiliary is sponsor. Our Lord, in His Ministry, did not scorn to work through small groups and I like to think His Work can still be done

in that way. Indeed large Dioceses may envy the personal friendships and personal consideration which are possible in the small group. Presumably we know that the three aims of the Woman's Auxiliary are prayer, study, and giving to Missions. Of these I am more and more convinced that prayer is the greatest; and who shall say that the prayers of the few shall not avail with those of the many?

It is gratifying to know that the Racine Summer Conference is resumed this year. Let me urge you as the Diocesan Auxiliary and as Parish Branches to encourage your people to attend this Conference and, if at all possible, assist some of your young people to go.

In closing, let me thank you for the support and response you have accorded your president during the past two years and may I bespeak for the new term your continued, earnest co-operation.

REPORT OF EDUCATIONAL SECRETARY

Early this fall a letter was sent by your Chairman to each branch of the Auxiliary in the Diocese, outlining the study set forth from Church Missions House to be taken up this year. This letter was also published in "LIGHT." A questionnaire was sent this Spring asking what had been accomplished this Winter, and the reports follow:

CANTON—Reports no special course other than the "Spirit of Missions."

MOLINE—Reports individuals study the "Spirit of Missions"; also a Lenten course with the children and occasional instruction.

PEORIA (St. Andrew's)—Has co-operated with St. Paul's in their Mission Study.

PEORIA: (St. Paul's, Senior, and St. Elizabeth's)—During Advent studied "Program Presented" and in Lent "Wanted Leaders." An original Missionary Pageant "The Christian God in China" was written and staged by the President of St. Elizabeth's. Mrs. Biller and Miss Lindley of Church Missions House, Mrs. Tilton of Chicago, Mrs. Snowden of Milwaukee, have been the outside speakers. Also, reports were given by delegates who attended the Convention in Portland and the House of Churchwomen in Chicago. The parish supplies the Public Library with "The Living Church" and the "Spirit of Missions."

PEORIA (St. Stephen's)—Has had no study classes, but each member has the "Spirit of Missions" and there are informal discussions at the meetings. Six members attended the Triennial at Portland and reports of the Convention were given by them during the Winter.

ROCK ISLAND—Has studied "Missions of Alaska" by Archdeacon Stuck.

MACOMB—Reports no study this year but hopes to take up some next year.

QUINCY (Good Shepherd)—Has studied the "Spirit of Missions."

MONMOUTH, BUSHNELL, PREEMPTION—Report no study.

CARTHAGE—Is reading "Program Presented" and they have "Wanted Leaders" to read. They also send a copy of "Spirit of Missions" and "Light" to the Public Library.

WARSAW—Reports that on account of sickness and death in the family of their President they have done no Mission study. They intend to study "The Southern Mountaineer" of Virginia and Kentucky.

KEWANEE—Has just finished a two and one half year study of the "Survey." Are now studying work among the foreign born with "Neighbors" and "Not Foreigners but Friends" as the guide. They also study the "Spirit of Missions."

GRIGGSVILLE—Has studied "Program Presented" and the "Spirit of Missions." During Lent Mrs. Lacey gave some interesting talks on Missions."

RUSHVILLE—Reports five interesting meetings taking up subject pertaining to our Domestic Missions and work of the U. T. O. Also the "Spirit of Missions." Deaconess Stern has addressed them.

OSCO—Reports that their Guild subscribes for a copy of the "Spirit of Missions" which is passed around among their members to read. It is impossible to meet for study as they live in the country.

TISKILWA—Has studied the "Spirit of Missions" and leaflets from Church Missions House.

MENDON—Has used "Spirit of Missions." Deaconess Stern addressed them.

Minutes of the Church Service League Meeting.

The third annual meeting of the C. S. L. of the Diocese of Quincy was held at St. John's, Kewanee, May 8, 1923. Bishop Fawcett presided, giving a brief resume of the organizing and work of the C. S. L. in this Diocese, and stated that while it was successful in some places it did not function here because of no present need and no financial ability to handle it.

The Rev. Campbell Gray presented the following resolution:

WHEREAS, the C. S. L. under present conditions in the Diocese of Quincy does not function as a Diocesan organization, therefore,

BE IT RESOLVED, that the Diocesan C. S. L. be held in abeyance until such time as the parishes and missions may be so organized along C. S. L. lines as to create a need for correlation; and also

BE IT FURTHER RESOLVED that the Woman's Auxiliary be requested to function in the matter of delegates to the House of Church Women and to the Conference at Racine.

The resolution was unanimously adopted.

Deaconess Josephine's report was read and placed on file. Bishop Fawcett appointed the following officers:

Deaconess Josephine—Executive Secretary of Little Helpers; The Rev. W. L. Essex—Executive Secretary of Church School Service League; Dr. F. G. Hall—Treasurer of Church School Service League.

The report of the Church School Service League as prepared by Deaconess Josephine was read and given to the Rev. W. L. Essex.

Motion was made by Mrs. Campbell Gray that a vote of thanks be extended to Deaconess Josephine for her untiring efforts in behalf of the Church Service League. Motion carried.

Meeting adjourned.

Report of the Executive Secretary of the C. S. S. L.

The Church School Service League of the Diocese of Quincy was represented in Portland by the Executive Secretary, Deaconess Josephine, and the Box Secretary, Miss Emma Stittg, at the Conference on the C. S. S. L. extending over a period of thirteen days.

Work was reported by 75 Dioceses, 9 of them retaining the Junior Auxiliary organization. As stated by the Chairman of the C. S. S. L. Commission, Miss Frances Withers, the C. S. S. L. at present functions in three spheres: 1. In the National administration of the Church by means of a Commission, which develops and recommends programs and methods. 2. In the Diocese, where there must be some kind of organization—Commission or Committee—that will put the C. S. S. L. into effect. 3. In the work of the Parish, where the C. S. S. L. may be a program, with or without organization.

Your secretary has been inclined to maintain that the only organization necessary was the Church School. Oseo demonstrates that some C. S. S. L. work can be done where there is not even a Church School.

One of the important days at the General Convention at Portland was Sunday, Sept. 10th, when the first Birthday Thank Offering of the boys and girls was presented. That was the time when Bishop Tuttle caught the attention of the children—big and little—by the words, which have recently been quoted in the Church press: "Johnnie and Susie eat their bread and drink their milk and grow to be strong men and women. Johnnie and Susie also receive their spiritual food from the Church and grow to be strong soldiers of Jesus Christ." Bishop Rowe has his new Pelican! \$8,126 was received. Of this amount your Executive Secretary brought \$79.39 from the Church Schools of this Diocese.

On recommendation of the Conference at Portland, the next B. T. O. will go to Liberia. Literature has been sent out to all points in the Diocese known to have a Church School and several requests for a supply of leaflets and envelopes have been received. The B. T. O. should be presented as a whole in each parish on Whitsunday and sent to Dr. F. G. Hall, acting Treasurer of the C. S. S. L., to be put at interest until the General Convention in New Orleans in 1925.

Copies of the Lenten Leaflets "A Call to Service" were also sent to our schools. The "Book of Programs for the C. S. S. L." is recommended for suggestions and information; also "Working together" if you have a G. F. S., Brotherhood of St. Andrew, or Boy Scout organization. Both can be had from the Church Book Store at the Church Missions House, at 30c and 5c respectively.

Your Secretary had an opportunity to present C. S. S. L. work as the Church School in action, at a conference on Religious Education at our Diocesan Synod last January.

The report of our faithful Box Secretary shows 14 boxes sent from 13 parishes in 1922, containing 1260 gifts valued at \$610.25; a gain over 1921 of 119 gifts and \$51.90 value. Miss Withers reports that about 38,000 children each received two gifts and 2500 men of the Seamen's Institute received Christmas cheer. A wonderful growth since the C. S. S. L. has charge of the Christmas boxes.

Again this year a C. S. S. L. Treasurer has left our Diocese. Happily Mr. Hall's father, Dr. F. G. Hall, kindly consented to take charge of the work.

We can now report five divisions of The Little Helpers: Rock Island, Kewanee, Warsaw, St. Paul's, Peoria and St. John's, Galesburg. The latter two are new this year. Sister Mary Angela hopes to report one at the Cathedral next year. To begin the work of the child's Christian training from the time of his baptism is surely a worthy objective.

"The program of the C. S. S. L. provides activity in Church life through prayer, study, work, gifts, and fellowship in the five fields of service: Parish, Community, Diocese, Nation and World."

CONSTITUTION

Article I—NAME

The name of this Association shall be "THE WOMAN'S AUXILIARY to the NATIONAL COUNCIL in the DIOCESE OF QUINCY."

Article II—OBJECT

The object of this Association shall be: (a) To carry out in the Diocese of Quincy, by united and systematic effort, the three great aims of the Woman's Auxiliary, viz: Prayer for Missions, Study of Missions, and Systematic Giving to Missions; (b) to interest the woman of the Diocese of Quincy in the missionary work conducted by the General and Diocesan Boards, and for the purpose of aiding said societies in carrying out the said missionary work.

Article III—MEMBERSHIP.

The Church itself is the Missionary Society. Every baptized person is a member of that Society. Any parish organization of women desiring to engage in the work of this Association may become a Branch and be entitled to representation upon payment of the annual dues as fixed in the by-laws.

Article IV—OFFICERS.

The officers shall be: The Bishop (ex-officio); a President, a Vice-President; a Secretary, and a Treasurer, who shall be elected at the Annual meeting. These officers, with the Diocesan Chairman of the Church Service League, shall constitute the Executive Board of the Association.

The Secretary may choose an assistant, if she so desires.

Special officers may be appointed by the President, with the approval of the Bishop and a majority of the Executive Board.

Article V—DUTIES

The Bishop is, ex-officio, head of this Association and all acts of the Executive Board and of the Association shall be subject to his approval.

The Executive Board shall—subject to the Association—direct the active work of the Association.

The duty of the President shall be to call meetings of the Association and of the Executive Board; to preside at the same; to arrange for the general charge of the work under the direction of the Bishop.

The duty of the Vice-President shall be to preside in the absence of the President; to co-operate with her in the general supervision of the work, and

to take charge of any department of the work to which she may be assigned by the Executive Board.

The duty of the Secretary shall be to send out notices of all meetings, to keep a record of the same, to prepare reports, and to conduct the necessary correspondence of the Auxiliary.

The duty of the Treasurer shall be to receive annual dues, as fixed by the By-laws; and any other moneys for the expenses of the Association; to pay all such bills as are endorsed by the President and Secretary. She shall receive and forward all moneys given to redeem pledges made by the Diocesan Branch. She may receive other special and general funds and shall disburse the former as the donors indicate and the latter under the direction of the Executive Board. She shall receive reports from parish branches of money given by them for missions, through the treasurers of their parishes or sent directly to the Church Missions House and to the treasurer of the Diocesan Board of Missions, which reports she shall incorporate in a supplement to the report of money received and disbursed by her, and present this joint report at the Annual Meeting, to be printed in the Annual Report after being duly audited and certified. ?

Article VI—VACANCIES.

When a vacancy shall occur in the Executive Board by death or resignation, the said Board shall have power, with the advice and consent of the Bishop (previously obtained), to appoint an officer to fill the vacancy, the officer so appointed to serve until the next Annual Meeting.

Article VII—MEETINGS.

There shall be an Annual Meeting of the Association for the transaction of business.

Special Meetings may be called by the President, when recommended by the Executive Board.

The Executive Board shall meet when necessary and practicable.

Article VIII—AMENDMENTS.

This Constitution may be altered or amended by a two-thirds vote at any Annual Meeting, or at a Special Meeting, if notice has been given of the desired change.

BY-LAWS.

1. The Annual Meeting shall be held, if practicable, on the second Tuesday in May.

2. The Order of Business at the Annual Meeting shall be:
 - I. Offices of Devotion.
 - II. Roll Call (Officers, Branches, and Visitors.)
 - III. Reading of Minutes.
 - IV. Reports of Officers and Committees.
 - V. Election of Officers.
 - VI. Unfinished Business.
 - VII. Miscellaneous Business and Addresses.
3. The annual dues from each branch of the Woman's Auxiliary in the Diocese of Quincy shall be the amount which has been elected by the branch according to the following scale: Class A, \$25.00; Class B, \$20.00; Class C, \$15.00; Class D, \$12.50; Class E, \$10.00; Class F, \$7.50; Class G, \$5.00; Class H, \$3.00.
4. Each Branch that has paid its Annual dues shall be entitled to be represented by two delegates and to vote as a unit, at all meeting of this Association.
5. Any delegate may nominate. Election shall be by ballot.
6. These By-laws may be altered or amended by a majority vote at any Annual Meeting or at any Special meeting, if notice has been given of the desired change.
