MINUTES

The thirty-eighth annual meeting of the Quincy Branch of the Woman's Auxiliary was held in St. Paul's Church, Peoria, May 5th, beginning at 7.30 o'clock with a celebration of the Holy Communion with Bishop Gray as celebrant.

At 8:30 o'clock breakfast was served in the Parish Hall.

The business session opened at 9:30 with prayer by Father Davis of St. Stephen's Church, Peoria. The President, Miss Mary March, of Warsaw, presided. Several of the Clergy were present, and roll call showed an attendance of 32 delegates, 7 alternates, and a number of visitors from the local and other branches.

Motion made and carried that reading of the minutes be dispensed with.

During the morning Mrs. Biller gave an address, explaining the various activities of church work for the Fifth Province, centered at Racine, Wisconsin. She urged a careful study of the gospels with the three thoughts in mind of Christ as a Critic, as a Companion, and as a Co-worker.

A rising vote of thanks was extended to Mrs. Biller.

The President's address followed.

The report of the Treasurer showed receipts for the year, including balance of \$256.10 from last year, \$596.98; expenditures, \$369.30; balance on hand, \$227.68. The balance was less this year than last, owing to the sending of three delegates to the meeting of the House of Churchwomen, which had not before been done. The report of the Box Secretary followed.

The United Thank Offering Custodian's report showed a total on hand of \$2056.58. This is \$445.69 less than the amount sent to the Portland Triennial. Miss Hopkins urged that this sum be made up before October.

The report of the Woman's Auxiliary Special showed that \$423.18 of the \$500 pledged by our Branch to the Bishop Tuttle Memorial Fund has been paid.

Reports were also received from the Educational Secretary and Chairman of the Church Periodical Club.

Motion made and carried that all reports be accepted and published in the Annual Report.

Miss Hedding, Mrs. Taft and Mrs. Grimmer were appointed to serve as a nominating committee.

Mrs. Campbell Gray reported the Summer Conference and the meeting of the House of Churchwomen held in Racine.

Deaconess Josephine explained the Carry-on-Fund.

Noonday prayer by Father Mayo. Luncheon at 12.30.

Meeting re-convened at 2 p. m.

The President spoke of the problem of a Field Worker for the Diocese. Mrs. Gray led a discussion on the question. Motion made and carried that this meeting vote in the negative.

Motion made and carried that the Carry-on-Fund be dropped and emphasis laid on U. T. O.

Motion made and carried that Treasurer be instructed to pay the \$10 due the House of Churchwomen.

Election of officers resulted in the following being chosen to serve during the coming year: President, Miss Mary Marsh, Warsaw; Vice-President, Mrs. J. C. McConnell, Quincy; Secretary, Mrs. J. F. Corbin, Galesburg; Treasurer, Mrs. J. Heber Smith, Osco.

The following delegates and alternates were chosen to represent the Diocese at the Triennial meeting in New Orleans in October:

Motion made and carried that the President of the Diocese be given \$125 to apply on her expenses to New Orleans.

PRESIDENT'S ADDRESS

Bishop Fawcett, Bishop Gray, The Rev. Clergy and Members of the Woman's Auxiliary, Greetings:—

Another year has gone by with its many responsibilities and encouragements and it is certainly an inspiration to be in such close touch with the Church Missions House and to receive the wonderfully inspiring messages that are sent out from there.

When elected to be your president and representative, I felt most keenly my inefficiency and ignorance of what was expected of me. Although I have attended the annual meetings quite regularly, yet the inner workings and the real duties of my office were unknown to me. Our former president, Mrs. Wilson, has helped me out on several occasions.

If we take the yearly happenings as they come, the first of importance was the Summer Conference at Racine. Much to my regret, I was unable to take advantage of this wonderful opportunity offered, but Mrs. Campbell Gray, our Educational Secretary, and Miss Stittig, Chairman of the Woman's Auxiliary "Special", were our official representatives, there being a number of others in attendance from the Quincy Diocese.

Then came the meeting of the House of Church Women, which instead of being held at Indianapolis as planned, was held at Racine, October 14, 15 and 16, at the same time as the Provincial Synod. The five delegates, elected at the annual meeting, were all able to be present, as were one alternate and four visitors, a total of ten women representing this diocese. We were very proud of our representation, as it was larger than that of any other diocese. Racine is certainly an ideal spot for such a gathering and I wish that many more women from this diocese might take advantage of the wonderful opportunities offered by the making of Racine a "National Center for Devotion and Conference". From April 14 to 17, inclusive, this year, there was held a Conference for parochial and diocesan officers, at which, as far as I know, there were no representatives from this diocese. I had hoped some one might attend and report some of the proceedings at this meeting,

In a letter from Miss Lindley, speaking of the Japanese Reconstruction Fund, she urged the Woman's Auxiliary to undertake the raising of funds for the rebuilding of St. Margaret's School, Tokio, and championed the Pennsylvania Plan viz: The Gold and Silver Offering, but it hardly seemed feasible in this diocese. However, we should find some plan for helping along the reconstruction of Japan and work upon it. Our efforts along financial lines the past year have centered more especially on our "Triennial Special" and our United Thank Offering. As you probably know, the building at Raleigh, North Carolina, which it was hoped might be fitted up and used for the training of Colored Workers, has been found most inadequate and consequently must be torn down and another building erected which instead of costing \$10,000.00, will cost at least \$30,000.00. We have something before us, if we reach our goal of 1922 and we should try to increase rather than diminish.

It has been the privilege of several of the branches to have with them as speaker, Miss Alice Wright of Nenana, Alaska. It is always an inspiration to hear missionaries from the Field and if more of us could come together in groups and secure a speaker, it would create an interest such as can hardly be gained otherwise.

A personal study of the Gospels as suggested by the Executive Board of the

Woman's Auxiliary and incorporated in a letter from your president to the several branches, will certainly bear fruit, provided the members all join in the study and try to interest other women to do the same.

A letter from Miss Lindley stresses Peace as one of the great aims of the Woman's Auxiliary and especially with "reference to good will between the Orient and the United States". It will have a prominent place for discussion at the Triennial in New Orleans. The need and opportunities for work among students in the colleges is being stressed and many more workers in the Mission Field are needed. If more of our young women could be brought to feel the urge to this noble calling it would certainly solve many problems for the present workers in the Field.

I wish to call your attention more especially to the Authorized Work, as it comes to us from the Church Missions House. Unless we carry out their orders, as specified, there is likely to be a lack in some Missions, while others have more than they are entitled to. They are very painstaking at Headquarters and apportion to each diocese as they consider them able to carry on and it is our duty to co-operate.

Thanks to our very able secretary and box secretary, the annual reports were gotten out in good season, that is, before our fall work began and were very neat in their make-up.

Our thanks are due to Peoria for their generous hospitality in allowing us to remain over an extra day in order to enjoy the Retreat which is to be conducted by Fr. Powell of Boston.

We have to think today of the approaching Triennial which opens on Tuesday, October 6th and must elect delegates and alternates to be our representatives at that great gathering of women. They ask especially that the representatives be active Church workers in their respective parishes or missions and that at least one of them be a young woman.

In closing let us hope that we may go forward as in the past, always remembering that we are a part of a great whole and are working for the coming of the Kingdom.

In this way I feel that a larger proportion of our women can know of plans for study. This year the book to be studied is "That Freedom", telling about Latin America, also "The Program of the Church". It is splendid the increased number of branches taking the course of study set forth. The Spirit of Missions should be read by every member of the Church for it is the news of the day, and is intensely interesting. There is no popular magazine to be obtained for \$1.00 a year, and yet this is the price of our Church magazine. I urge you to subscribe for it. May I thank you for allowing me the great privilege of being one of your delegates at the Racine Conference.

GALESBURG, (Grace)—Studied "My Father's Business", the discussion led by the Rector.

PEORIA, (St. Paul's)—Lectures on missionary topics on Fridays during Lent. Joined with St. Elizabeth's branch in the study of "China's Real Revolution". Bishop Partridge gave a talk on the Bible. Father Orum told of the work at St. Andrew's School, Sewanee. Miss Wright of Nenana, Alaska, gave accounts of work in Alaska. Members read "Spirit of Missions".

CONSTITUTION

Article I—NAME

The name of this Association shall be "THE WOMAN'S AUXILIARY to the NATIONAL COUNCIL in the DIOCESE OF QUINCY".

Article II—OBJECT

The object of this Association shall be: (a) To carry out in the Diocese of Quincy, by united and systematic effort, the three great aims of the Woman's Auxiliary, viz: Prayer for Missions, Study of Missions, and Systematic Giving to Missions; (b) to interest the women of the Diocese of Quincy in the missionary work conducted by the General and Diocesan Boards and for the purpose of aiding said societies in carrying out the said missionary work.

Article III—MEMBERSHIP

The Church itself is the Missionary Society. Every baptized person is a member of that Society. Any parish organization of women desiring to engage in the work of this Association may become a Branch and be entitled to representation upon payment of the annual dues as fixed in the by-laws.

Article IV—OFFICERS

The officers shall be: The Bishop (ex-officio); a President; a Vice-President; a Secretary and a Treasurer who shall be elected at the Annual meeting. These officers, with the Diocesan Chairman of the Church Service League, shall constitute the Executive Board of the Association.

The Secretary may choose an assistant, if she so desires.

Special officers may be appointed by the President, with the approval of the Bishop and a majority of the Executive Board.

Article V—DUTIES

The Bishop is, ex-officio, head of this Association and all acts of the Executive Board and of the Association shall be subject to his approval.

The Executive Board shall—subject to the Association—direct the active work of the Association.

The duty of the President shall be to call meetings of the Association and of the

Executive Board; to preside at the same; to arrange for the general charge of the work under the direction of the Bishop.

The duty of the Vice-President shall be to preside in the absence of the President; to co-operate with her in the general supervision of the work and to take charge of any department of the work to which she may be assigned by the Executive Board.

The duty of the Secretary shall be to send out notices of all meetings, to keep a record of the same to prepare reports, and to conduct the necessary correspondence of the Auxiliary.

The duty of the Treasurer shall be to receive annual dues, as fixed by the By-laws; and any other moneys for the expenses of the Association; to pay all such bills as are endorsed by the President and Secretary. She shall receive and forward all moneys given to redeem pledges made by the Diocesan Branch. She may receive other special and general funds and shall disburse the former as the donors indicate and the latter under the direction of the Executive Board. She shall receive reports from parish branches of money given by them for missions through the treasurers of their parishes or sent directly to the Church Missions House and to the treasurer of the Diocesan Board of Missions which report she shall incorporate in a supplement to the report of money received and disbursed by her and present this joint report at the Annual Meeting to be printed in the Annual Report after being duly audited and certified.

Article VI—VACANCIES

When a vacancy shall occur in the Executive Board by death or resignation the said Board shall have power, with the advice and consent of the Bishop (previously obtained), to appoint an officer to fill the vacancy, the officer so appointed to serve until the next Annual Meeting.

Article VII—MEETINGS

There shall be an Annual Meeting of the Association for the transaction of business.

Special Meetings may be called by the President, when recommended by the Executive Board.

The Executive Board shall meet when necessary and practicable.

Article VIII—AMENDMENTS

This Constitution may be altered or amended by a two-thirds vote at any Annual Meeting, or at a Special Meeting, if notice has been given of the desired change.

BY-LAWS

1. The Annual Meeting shall be held, if practicable, on the second Tuesday in May.
2. The Order of Business at the Annual Meeting shall be:
 - I. Offices of Devotion.
 - II. Roll Call (Officers, Branches, and Visitors).
 - III. Reading of Minutes
 - IV. Reports of Officers and Committees.
 - V. Election of Officers.
 - VI. Unfinished Business.
 - VII. Miscellaneous Business and Addresses.
3. The annual dues from each branch of the Woman's Auxiliary in the Diocese of Quincy shall be the amount which has been elected by the branch according to the following scale: Class A, \$25.00; Class B, \$20.00; Class C, \$15.00; Class D, \$12.50; Class E, \$10.00; Class F, \$7.50; Class G, \$5.00; Class H, \$3.00.
4. Each Branch that has paid its Annual dues shall be entitled to be represented by two delegates and to vote as a unit, at all meetings of this Association.
5. Any delegate may nominate. Election shall be by ballot.
6. These By-Laws may be altered or amended by a majority vote at any Annual Meeting or at any Special meeting if notice has been given of the desired change.
