MINUTES

The Woman's Auxiliary of the Diocese of Quincy held its 45th Annual Meeting at Christ Church, Moline, Illinois, on May 10th and 11th, 1932.

Guests were registered on their arrival Tuesday afternoon, and at 6:30 o'clock the Auxiliary joined the Synod at dinner at the LeClaire Hotel.

At 7:30 Wednesday morning there was a Corporate Celebration of the Holy Eucharist for both Synod and Auxiliary, with Bishop Fawcett as celebrant, after which breakfast was served by the women of Christ Church in the Parish Hall.

The Auxiliary meeting opened promptly at 9:30 o'clock Wednesday morning in the Parish Hall with the Bishop giving the opening prayers and a short talk. The Bishop read a letter from Miss Anna G. Stern of Nenana, Alaska, St. Mark's Mission, which is the diocesan object in the deficiency fund. Mrs. S. W. Mullinix, President of the local branch, welcomed the women.

Roll call by the Secretary showed 122 present, of which five were officers, 36 delegates and 81 visitors. The Treasurer's report showing \$303.41 balance was approved by the Auditor, accepted and placed on file.

Reports of the President, Recording Secretary, Box Secretary, United Thank Offering Custodian and Educational Secretary were read and accepted.

Miss Elona Flessner, Woman's Auxiliary correspondent of "Light" asked for suggestions regarding the "Candle Light of the Woman's Auxiliary Corner."

Following the United Thank Offering report it was agreed that the Offering should be sent to the Diocesan Custodian before October first in the fall and before April first in the spring.

There was a short discussion of Dr. McGregors' lecture on Adult Education and its relation to the educational work of the Woman's Auxiliary.

As our guest speaker, Mrs. Harry Longley, wife of the Bishop of Iowa, gave us a most interesting address on "The Evolution of the Woman's Auxiliary in its Relation to the National Church." Mrs. Longley's long experience as a leader of the Woman's Auxiliary in Iowa made her address especially acceptable to our delegates.

The report of the Nominating Committee was given by Mrs. A. A. Furst of Peoria, in the absence of the Chairman, Mrs. B. E. Diggs of Macomb. She reported the following slate: President, Mrs. A. F. Eichelsdoerfer; Vice-President, Miss Elona Flessner; Secretary, Mrs. J. T. Pickard; Treasurer, Mrs. R. C. Taft; Supply Secretary, Mrs. S. W. Mullinix; United Thank Offering Custodian, Mrs. A. R. Daniels.

Mrs. H. N. Heflin of Kewanee opened the afternoon meeting by reading several prayers. Mrs. Frank Warnhoff of Macomb sang for us. Mrs. W. G. Russell of Peoria told us of the work the Church Periodical Club was doing and Mrs. Sangren, Secretary of the Rock Island Church Periodical Club, read a letter from New York explaining how donors and recipients were selected and brought together.

Election followed; the slate as presented by the Nominating Committee was chosen by acclamation.

The following were chosen as delegates for the meeting of the Provincial Auxiliary to be held in Cleveland, Ohio, in October: Mrs. S. W. Mullinix, Moline; Mrs. A. R. Daniels, Peoria; Mrs. W. G. Russell, Peoria; Mrs. A. F. Eichelsdoerfer, Rock Island, and Mrs. H. N. Heflin, Kewanee. Alternates were: Mrs. J. T. Pickard, Kewanee; Mrs. Lillian L. Gardner, Quincy; Mrs. Chas. Fry, Rock Island; Miss Elona Flessner, Peoria; and Mrs. Harvey Sangren, of Rock Island.

Fifteen dollars was voted for Mrs. W. G. Russell for the work of the Church Periodical Club and the Officers' traveling fund was increased to Fifty dollars.

Prayers were asked for the Diocesan meetings of Cleveland, Western Michigan, Springfield and Marquette.

A vote of courtesy was given to the Moline branch for their generous hospitality and an invitation was accepted to meet with the Good Shepherd branch in Quincy next year.

REPORT OF THE SUPPLY SECRETARY—1931-1932

To the Officers and Members of the Woman's Auxiliary, Diocese of Quincy, I beg leave as Supply Secretary to submit the enclosed Annual Report, for the year 1931-1932.

Appeals were received for two Personal Boxes, one from Rev. J. B. Brown, Box 118, Washington, N. C., (Negro), the other from the Rev. Elias Wilson, Mitchel, Neb., the former in charge of St. Paul's-St. Jude's Mission, and the latter of the Holy Apostles Mission. Another came from St. Thomas Mission, Clarkton, Halifax Co., Va., with Mrs. Clark in charge, also a call came for a Christmas Box to be sent to Miss Delia Villanova, Box 68, Mayaguez, Porto Rico, which was taken care of by the Cathedral Branch.

Just recently an appeal came from an Orphanage Mission in Haiti, Sister Elizabeth Margaret, (St. Trinity or Maison des Enfants), which St. Paul's Church, Peoria, have accepted.

So far the value of the boxes reported are \$416.40. The appeals to the Branches to fill these assignments were splendidly responded to and I am very grateful indeed for their co-operation.

THE PRESIDENT'S REPORT

Today marks the close of my third year as your president,—to me a year of inspiration and opportunity and, I hope, of growth. Last May we were looking forward to Denver and the National Convention. Now we look back to it, marvelling that it could so far surpass our highest expectations. To say "Thank you," to the women of Quincy Diocese is a very mild way of expressing how much I appreciate the privilege of being one of your representatives there; also that it was your generosity that made it possible for me to go. To many of you I have tried to tell something of what it meant to us, who were the delegates, and I have attempted to place before you the ideals that were held up to us there; but you, who are fortunate enough to have experienced the exaltation of the morning of the great U. T. O. Corporate Communion, know that words are quite inadequate.

Quincy was represented by our five delegates, and three alternates, besides several visitors. Your president served on the "Despatch of Business Committee,"—a very prosaic committee that kept her out of her delegate's seat most of the time. However, Miss Flessner, Mrs. Daniels, Mrs. Mullinix and Miss Lawton were there to do the voting, and we often wished that every woman in the diocese could have been present, also, to share in the discussions, to enjoy the snappy reports, to appreciate with us that there is a remarkable combination of keen intellect and deep spiritual insight in the personnel of our National Board.

Some of us were again struck with that fact, when we attended the Conference at Brent House last month; and there, in the more intimate contact that such conferences allow, were privileged to exchange ideas with some of our outstanding provincial leaders, not to speak of Miss Elizabeth Matthews and Miss Grace Lindley. The diocese had five delegates at Brent House from Moline, Quincy, Kewanee, and Rock Island. One returns from such a conference with the feeling that the most we may do is only a tiny portion in the great work that lies to be done in the Kingdom.

This year I have had some pleasant times getting acquainted about the diocese,—Oscos, Geneseo, Macomb, Peoria, Preemption, Monmouth, Galesburg, Moline, Kewanee, and Henry were on the list, and the traveling allowance, voted last year, came in very handily.

The fall diocesan meeting in Galesburg, all too short for us who were fresh from Denver and full of it, still was so successful that Bishop Fawcett plans to make it an annual event. The purpose is to be inspirational, as opposed to the business-like spring meeting. Let's all plan to go to Peoria next fall, and have our usual good time together.

Henry reports a new branch this year, St. John's Guild-Auxiliary, and we are glad to welcome it into our diocesan family, and are happy to see the Henry delegates here.

The meeting of the Woman's Auxiliary of the Fifth Province is scheduled for October 18, in Cleveland, Ohio, and since this is the home field of our provincial president, Miss Matthews, we know it will be an extra fine session.

Today, in the Church, as well as in the world, we are facing a crisis. But the big deficit is surely going to be cleared away, and Whitsunday will see the Church again triumphant. Are we going to share in the triumph? Of course we are. We can each do a little, and many littles inevitably transform themselves into a Big.

As in the National, so in the Diocesan Church, we are privileged to have a large share. In my visits among you, I have been both amazed and delighted when I heard you discussing such things as a layette made, a cripple fitted with an appliance, clothes for a family of children; and when I exclaimed that you reported no social service work, you said, "Why, we have always done these things." No doubt we have always done a great many more things than we knew.

It would be wonderful to be able to say something like that about our publications. So far no evidences have come to light that we are over-modest in that. I am asking, however, that we try to stir up a little interest in our Church papers. If not individually at least, let us take one of our church weeklies as an organization, and pass it around. Certainly every Branch should take *The Spirit of Missions* for the files. And I do not see how you get along at all without *Light*, our diocesan bulletin, yet some parishes seem to do without even that.

It is inspiring to note the steady growth in the educational work you are undertaking. Very few there were of you who did not have Lenten studies, and many had a program of education and news throughout the year.

Are there younger women in your parish who are not working in any organization? You cannot afford to let such possibilities go unused. Plan to do one of two things. Have them organize a Woman's Auxiliary of their own, to meet perhaps, in the evening; or make your own meetings so worth while that you can't avoid drawing them in. Then, as soon as they are in, give them plenty to do. Younger women make peppy presidents, energetic committee chairmen, enthusiastic U. T. O. custodians. Moreover, unless we work in the young women, who will there be to carry on when we are gone?

In a word, let's not be satisfied to just go on as we are. Let us plan ahead, for we must go farther than "on," much farther, ere the kingdoms of this world shall become the Kingdom of our Lord, and of His Christ.

REVISED CONSTITUTION

ARTICLE I—NAME

The Name of this Association shall be "The WOMAN'S AUXILIARY to the NATIONAL COUNCIL in the DIOCESE OF QUINCY".

ARTICLE II—OBJECT

The object of this Association shall be: (a) To carry out in the Diocese of Quincy, by united and systematic effort, the aims of the Woman's Auxiliary to the National Council, through Prayer, Study, and Gifts; (b) to interest the women of the Diocese of Quincy in the work conducted by the National Council and by the Diocesan Board of Missions for the purpose of aiding said societies in carrying out said work.

ARTICLE III—MEMBERSHIP

The Church itself is the Missionary Society. Every baptized person is a member of that Society. Any parish organization of women desiring to engage in the work of this Association may become a Branch and be entitled to representation upon payment of annual dues as fixed in the By-Laws.

ARTICLE IV—OFFICERS

The officers shall be: The Bishop (ex-officio); a President, a Vice President, a Secretary, a Treasurer, a United Thank Offering Treasurer, a Supply Secretary, who shall be elected at an Annual Meeting and serve for one year. These officers shall constitute the Executive Board of the Association.

The Secretary may choose an assistant, if she so desires.

Chairmen may be appointed to take charge of special pieces of work.

ARTICLE V—DUTIES OF OFFICERS

The Bishop is, ex-officio, head of this Association and all acts of the Executive Board and of the Association shall be subject to his approval.

The Executive Board shall—subject to the Association—direct the active work of the Association.

The duty of the President shall be to call meetings of the Association and of the Executive Board; to preside at the same; to arrange for and have general charge of the work under the direction of the Bishop.

The duty of the Vice President shall be to preside in the absence of the President; to co-operate with in the general supervision of the work, and to take charge of any department of the work to which she may be assigned by the Executive Board.

The duty of the Secretary shall be to send out notices of all meetings to keep a record of the same; to notify officers and delegates of their election, and to furnish delegates with credentials; to prepare reports; and to conduct the necessary correspondence of the Auxiliary.

The duty of the Treasurer shall be to receive annual dues, as fixed by the By-laws, and any other moneys for the expenses of the Association; to pay all such bills as are endorsed by the President and Secretary. She shall receive and forward all moneys given to redeem pledges made by the Diocesan Branch. She may receive other special and general funds and shall disburse the former as the donors indicate and the latter under the direction of the Executive Board. She shall receive reports from Parish Branches of money given by them, through the treasurers of their parishes or sent directly to the Church Missions

House and to the Treasurer of the Diocesan Board of Missions, which reports she shall incorporate in a supplement to the report of money received and disbursed by her, and present this joint report at the Annual Meeting, to be printed in the Annual Report after being duly audited and certified.

The United Thank Offering Treasurer shall furnish United Thank Offering boxes and leaflets and in other ways call attention to the purposes of the United Thank Offering. She shall keep a list of contributors; make semi-annual collections and put these amounts at interest. Each year she shall report the progress of the offering; and she shall make it ready, with accumulated interest, for presentation at the Triennial Service of the Woman's Auxiliary.

The Supply Secretary shall have charge of all box work, receiving allotments from the Woman's Auxiliary Supply Secretary at the Church Missions House and re-allotting same. She shall make a report at the Diocesan Annual Meeting and shall send a report to the National Headquarters.

ARTICLE VI—VACANCIES

When a vacancy shall occur in the Executive Board by death or resignation, the said Board shall have power, with the advice and consent of the Bishop (previously obtained), to appoint an officer to fill the vacancy, the officer so appointed to serve until the next Annual Meeting.

ARTICLE VII—MEETING

There shall be an Annual Meeting of the Association for the transaction of business.

When practicable a Conference for inspiration and consideration of national and diocesan plans shall be held at a place and time to be determined by the Bishop and the President.

Special Meetings may be called by the President, when recommended by the Executive Board.

The Executive Board shall meet when necessary and practicable.

ARTICLE VIII—AMENDMENT

This Constitution may be altered or amended by a two-thirds vote at any Annual Meeting, or at a Special Meeting, if notice has been given of the desired change.

BY-LAWS

1. The Annual Meeting:

The Annual Meeting shall be held, if practicable, on the second Tuesday in May.

2. Annual Dues:

The annual dues from each Branch of the Woman's Auxiliary in the Diocese of Quincy shall be the amount which has been elected by the Branch, according to the following scales: Class A, \$25.00; Class B, \$20.00; Class C, \$15.00; Class D, \$12.50; Class E, \$10.00; Class F, \$7.50; Class G, \$5.00; Class H, \$3.00.

3. Representation:

(a) Each Branch that has paid its annual dues shall be entitled to two delegates and two alternates, who must be active members of the Woman's Auxiliary in their own parish or mission.

(b) Names of delegates and alternates must be in the hands of a Committee on Credentials and Registration, consisting of the President and Secretary of the Branch where the meeting will be held, ten days before the meeting.

(c) Members of the Executive Board and Chairman of Committees not elected delegates may have the privilege of the floor, but no vote.

4. Order of Business:

- (a) Offices of Devotion.
- (b) Roll Call (Officers, Branches, Visitors).
- (c) Reading of Minutes.
- (d) Reports of Officers and Committees.
- (e) Election.
- (f) Unfinished Business.
- (g) Miscellaneous Business and Addresses.

5. Quorum:

One-third of the Branches shall constitute a quorum at the Annual Meeting.

6. Election:

Any delegate may nominate. Election shall be by ballot, unless the same be dispensed with by a unanimous vote.

7. Parliamentary Rules:

(a) All resolutions except those concerning routine matters must be presented in writing signed by the proposer and with the name of her Branch.

(b) A majority vote of the delegates present shall be necessary to a decision on all questions, provided that on the request of any three Branches the vote shall be taken by Branches, each Branch having one vote.

(c) "Robert's Rules of Order Revised" shall be the authority in all questions of parliamentary law not covered by these By-laws.

8. Amendment:

These By-laws may be altered or amended by a majority vote at any Annual Meeting or at any Special Meeting, if notice has been given of the desired change.
