THE RHODE ISLAND BRANCH

WITH the cordial approval of the Bishop of this diocese, a society has been formed which hopes to include all the parishes in the diocese, and asks the co-operation of all the clergy. It does not propose to change the work of any parish, but by united and sympathetic action to increase the interest in, and render more effective the missionary work of the Church. It is hoped by this union that the smaller parishes that are able to do but little may unite with the larger, or with each other, in working; also, that the larger parishes may learn the needs of the smaller and assist them if desired.

At a meeting called by the Bishop, February 8, 1878, the following Constitution was adopted, and the officers appointed.

CONSTITUTION.

I. This organization shall be called the "Rhode Island Branch of the Woman's Auxiliary to the Board of Missions.

II. Its object is to unite all the parishes in this diocese in the six branches of mission work, viz.: Domestic, Diocesan, Foreign, Freedmen, Indian, Mexican.

III. The officers of this society shall be a President, one or more Vice-Presidents, a Secretary, a Treasurer; also an Executive Committee of six ladies, who shall attend to the several branches of missionary work. This Board shall fill all vacancies that may occur in the offices between the annual meetings.

IV. This society shall hold an annual meeting in Providence in October, for the purpose of electing officers for the ensuing year, hearing the reports of the parish secretaries, electing delegates to the general meeting of the Woman's Auxiliary, and transacting all other business.

V. This society shall also hold meetings at stated intervals in the different parishes for mutual intercourse and information. Each parish shall send delegates to the annual meeting, also a written report to the Secretary, of the work done during the year.

VI. It shall be the duty of the President to preside at the annual meeting, and to have a general knowledge of the work that is in progress. The Vice-President shall preside in her absence.

VII. It shall be the duty of the Secretary to conduct the correspondence of the society, send notices of the meetings and keep a record of them, keep an account of the work done by the women of the diocese, as reported by the parish secretaries, and report this annually to the secretary of the "Woman's Auxiliary," in New York.

VIII. The Treasurer shall receive and disburse all money sent to her for any branch of missionary work and for the expenses of the society, and shall present a report at the annual meeting.

IX. Seven persons shall constitute a quorum at the annual meeting, and five at a board meeting.

X. This Constitution may be altered or amended at any annual meeting by a two-thirds vote of the persons present.

SECRETARY'S REPORT.

The adjourned Annual Meeting was held November 5th, in St. Stephen's Church, Tuesday, beginning with the celebration of the Holy Communion, the celebrant being the Rt. Rev. Dr. Walker, Bishop of North Dakota, assisted by the Rt. Rev. Dr. Howe, of Central Pennsylvania, the Rev. Dr. Fiske, rector, and Rev. E. P. Bartow, assistant priest of St. Stephen's.

After this service, the meeting was called to order by the President, Mrs. William Ames. The roll of parishes was called and over three hundred delegates, representing 31 parishes, responded.

The Nominating Committee presented the names of the old Board, with the addition of Mrs. Charles H. Babcock as a vice-president, and Miss. N. A. Greene as secretary of the Mexican department.

The reports of the Secretary and the minutes of the last annual meeting were read and accepted.

Bishop Clarke welcomed the Auxiliary and introduced Bishop Walker, who spoke briefly upon his work. The Rt. Rev. Dr. Howe spoke very encouraging words to the women of the Auxiliary. He was followed by the Rev. W. B. Gordon, who asked assistance in maintaining a teacher in his work in Mexico. The Bishop offered to assume half of the amount required if the Auxiliary would assure the other half. After the offertory the meeting adjourned until 2 P. M.

In the afternoon the first speaker was the Rt. Rev. Dr.

Kendricks, who gave an interesting account of his new work. Short addresses were made by the Rev. S. H. Webb, the Rev. Dr. Richards, and Rev. Mr. Orpen of Crompton. The president read extracts from several letters from missionaries, and after prayers the meeting adjourned to 7.30 P. M.

The speakers of the evening were Rt. Rev. Dr. William, D. Walker, Bishop of North Dakota, Rt. Rev. Dr. Kendricks of New Mexico and Arizona, and the Rev. W. B. Gordon, of the mission in Mexico. The offerings amounted to \$174.00. Bishop Clarke returned thanks to the speakers and said the Woman's Auxiliary had never held a more inspiring and instructive meeting than this.

After prayers and the benediction by the Bishop, the meeting closed.

A Quarterly meeting was held in Christ Church, Providence, February 27. There were 400 delegates present, representing 22 parishes. Bishop Dudley, of Kentucky, Miss Margaretta Scott of Beulah, Africa, and several clergymen of this diocese addressed the meeting. The second Quarterly meeting was held in Christ Church, Lonsdale, May 23d. There were 240 delegates, representing 32 parishes. Miss Sybil Carter of New York, Rev. Paulus Moort of Africa, the Rev. H. Hines of Concord, New Hampshire, the Rev. Dr. Jaegar, and the Rev. Frederick Bassett, were the speakers at this meeting. The Monthly meetings have been well attended. They are held in Room 6, Wayland Building, every third Friday in the month, from 11 A. M. to 12 noon.

Meeting with such a generous response to all our work we have felt warranted in assuming even more than ever before; our pledges now amount to \$2,270, and from them our influence will be felt in many remote parts of the world. Let us labor, heart and soul, that our blessed Lord may say of us, "in as much as ye have done it unto the least of these my brethren, ye have done it unto me." Value of work for the year:

FOREIGN MISSIONS.

If, when the opportunity for giving is limitless, we can call a year successful in which limited pledges are fulfilled; this last has been a successful year. We have not only fulfilled every pledge—with the exception of one which is only temporarily delayed—but we have had a surplus to bestow upon an object dear to many earnest workers in Japan, viz.: The piano for St. Margaret's School, in Tokio.

It is interesting and encouraging to note the increase in our pledges during the last seven years. In 1882-3 the total pledge was \$350.00; this year it is \$615.00, nearly double. In every year since 1883, there has been more money given than pledged, but the excess this year is by far the largest. A large part of this sum was given especially for the work of Miss Margaretta Scott, the building at Beulah, a school for native girls in Liberia.

There is never a lack of ways in which to dispose of any sum above the amount we pledge ourselves to give. We have been able to give a third of the cost of the piano for St. Margaret's, and Rhode Island seems to have contributed more than any other Auxiliary to this object. Mrs. White (*nee* Miss Riddick) complains that the great interest professed by those whom she addressed upon this subject manifested itself in gifts of ten-cent pieces! And now, within a few days, we learn that Miss Bull, whose salary of less than \$600 is shrunken to still less, owing to the depreciation of United States Money, has pledged one-third of her pittance for the support of a needed teacher in the school in Osaka, and helps to support little orphaned children besides. There is truly no limit to the good we can do, even in this one way of putting more money into the hands of our representatives in the mission field, to be used for the needs which they know so much better than we can.

This year our work in Africa has been brought home to us by the Rev. Paulus Moort, and our interest has been quickened and our information increased by this visit of Miss Margaretta Scott.

The letters from the foreign field have been very few, but we hope for more news this year and that we may be able to keep all the parishes informed of the work by sending the letters through the diocese.

Grateful letters assured us that our efforts had been appreciated; and this girl will not have the mortification of appearing among her schoolmates ill-clad.

Now we wish to urge upon the parishes the necessity of sending immediately anything intended for Christmas. Do not let our missionaries and their families go shivering half the winter for the lack of a little energy on our part. We are gaining each year in the amount of our contributions—let us gain also in promptness.

FREEDMEN'S MISSION.

The pledge for the Colored Commission is the same, \$250. But the \$200 sent for several years to Mrs. Brent now goes to the Rev. J. W. Perry, Tarboro, N. C., for the support of a teacher in his school, Mrs. Brent having given up her official connection with the Gordonsville work. Mr. Perry writes very encouragingly about the school. There are ninety-two pupils and the industrial department is doing a good work among the girls.

The money for the Colored Commission is sent to the Rev. William C. Gray, Nashville, Tennessee, toward the support of one of his clergymen. Mr. Gray says in one of his letters: "I can give you a good report. I am sure God is smiling on our efforts in behalf of the colored people, and you are helping a prosperous and growing work.

DIOCESAN REPORT.

In reviewing our last year's report it can scarcely be said with truth that the Auxiliary neglects its home work while ministering with zeal and generosity to missions outside the diocese.

We trust this year will make an equally good showing.

Also we feel encouraged to believe that the influence of the Auxiliary is permeating the diocese in a quiet way, and accomplishing in a degree, at least, the original object in its organization, that is to disseminate information in regard to the missions of the church, and to stir up and unite all hearts and hands in setting forward the Lord's work both at home and abroad.

An appeal has recently been made to the Auxiliary by ladies of Drownville, R. I., asking information as to our objects and methods of work. In response a committee of the Board paid a visit to Drownville and held a conference with the ladies who became deeply interested in the cause as presented, and while the extent and needs of the mission fields of the church were opened as a revelation to them, they manifested an eager desire to be pressed into the service, and to do something toward sustaining and helping onward the work. They hope at no distant day to have a chapel of their own around which they may rally and grow strong numerically and spiritually.

By patience and persevering effort a still further reduction has been made in the mortgage on St. George's Rectory, Central Falls, which now stands at \$4100—\$231 having been raised the past year by the Auxiliary. The canceling of this mortgage should really be a matter of diocesan concern. The parish being entirely exempt from any responsibility in its contraction, yet hampered and almost annihilated by the burden of it for some sixteen years, fully capable of self-support if this

burden were lifted, it is to be regretted that churchmen of the diocese should not come forward and, either by single or united effort, remove by one stroke this unfortunate encumbrance. The Rectory has been put in complete order without and within, at the expense of the missionary in charge; the church itself has been kalso-mined and recarpeted, and the finances and working elements of the parish are in a healthy condition. Cannot someone be found to come to the rescue?

The penny-a-week collections while falling a little behind those of last year, yet compare favorably with the average returns. This year twenty-six parishes contributed \$237.07. The amount from each parish, as, also, the several sums contributed toward the mortgage on St. George's Rectory, and such other cash receipts as belong to the diocesan work, will be found in the general treasurer's report.

We have been able to furnish, this year, from the penny-a-week fund a new supply of Prayer Books and Hymnals for the Church of the Ascension, Wakefield, and St. Thomas, Greenville, \$50 for repairs on the latter, and \$60 toward the debt of \$150 on its Rectory; \$25 toward a carpet for Christ Church, South Providence; \$50 toward carpeting the chancel at St. George's, Central Falls, and \$19 towards its mortgage; \$50 to the Mission of the Advent, Pawtucket, and \$30 toward the new church at Wanskuck.

At the close of July we had but 43 cents left in the treasury of this fund, but by the middle of the present month, October, it had grown to \$41.47, showing, once more, what the steady accretion of small sums will amount to, and this, also, at a season when church work and workers are mostly quiescent.

Let no one feel that because it may not be convenient to contribute the 52 cents for the year, to this fund, all at one time, therefore she will give nothing. Ten cents, five cents, or even a penny, covers a corresponding number of weeks, and perhaps at the end of that time she can give again, if not, "she hath done what she could," and doubtless will be commended of the Lord, even as Mary of old.

The St. Elizabeth Home and the Orphanage have been

remembered by several parishes, in the diocese, outside of cash contributions, as follows:

SEVENTEENTH ANNUAL REPORT

OF THE

Indian Aid Society of Rhode Island.

For twenty-five weeks of the past year the Indian Aid Society has met at the Auxiliary rooms to sew for the Indians. The average attendance has been six members per week. Eighty-three articles—some of clothing, some of bedding, have been cut—and three boxes sent to missionaries.

The first went to Rev. Edward Ashley, Fort Bennett, South Dakota ; value, including freight and other charges, \$90.29.

The second was sent to Rev. George B. Morgan, of White Earth, Minn. ; total value, \$48.66.

The last went to Rev. C. S. Cook, Pine Ridge Agency, South Dakota ; total value, \$84.57.

The box for Mr. Morgan was opened somewhere *en route*, and goods to the value of nineteen or twenty dollars taken out. We applied for redress to the Railroad Company at each end of the line, but with no favorable result.

For seventeen years we have sent out these boxes, and this is our first misfortune of the kind. May it be the last.

A clerical suit was sent by express from New York to Rev. Mr. Morgan, which reached him safely and pleased him much ; value, \$23.70.

We have received in money \$594.52. As will be seen

by the Treasurer's report \$586.52 have been paid out, leaving in the treasury \$8.00.

We feel it our first duty always, to appropriate \$250.00 towards the salary of Mrs. Johnstone, teacher in St. Paul's school, South Dakota.

After that sum was made up this year, \$233 were sent to the Treasurer of the Board of Missions for Indian work.

Finished work was sent to us from several parishes in town and from some out of town. St. Faith's Guild of St. Stephen's parish dressed twelve dolls. The children in our Indian schools look forward to the Christmas tree with all the excitement and enthusiasm that our white children do, and we are glad to stow away in our boxes the things which will make the little ones happy.

Our work is mostly of the plainest and most prosaic kind; but in May, at the end of the season we meet in the same room and have a very cosy tea, before we separate and go our different ways for the summer. A very pleasant thing it is to look forward to during the year.

One who has been on our Board of Managers for sixteen years has within a few weeks been added to our fast-growing store in Paradise. For many years she was one of our most active workers, but her last few years were years of suffering borne with Christian faith and courage. Her interest in our work never failed, and she continued to manifest it as long as she lived by her liberal giving. We shall miss her ready sympathy and her cheerful face.

And, now for what is before us this year, let us bring to it all the resolution and all the perseverance that we need. And seeing how much more hopeful is the prospect for the Indian race, as time goes on, let us "thank God and take Courage."

CONSTITUTION.

I. THIS Association shall be called THE INDIAN AID SOCIETY OF RHODE ISLAND.

II. Its object will be to aid in missionary work among the Indian tribes throughout our land, especially those within the jurisdiction of Niobrara.

III. The Association shall consist of all persons who shall contribute to the treasurer thereof, annually, at least the sum of one dollar. Any one may be constituted a life member by the payment at one time of the sum of one hundred dollars.

IV. The officers of this Association shall be a President, two Vice-Presidents, Secretary, Assistant Secretary and Treasurer. There shall be, moreover, a Board of Managers, consisting of the above-named officers, and of two ladies from each parish represented in the Association, whose duties it shall be to regulate its affairs, and, under the supervision of their rectors, to further the work of the Association in the parishes to which they respectively belong. The methods by which the ends of this organization can be promoted are, the raising of money for the support of missionaries and teachers, for the education of those who may be preparing for the work, and for other benevolent purposes connected with the mission; the making, collecting, and transfer of clothing, and other material aid, and the publication of papers and pamphlets that may serve to stir up a public interest in the welfare of the Indians.

V. It shall be the duty of the President to preside at the business meetings of the Association and the Board of Managers, and to call special meetings of the same when occasion shall arise.

VI. It shall be the duty of the Secretary to conduct the correspondence of the Association and to obtain and communicate to the Association any fresh information from Indian Missions; to keep minutes of the proceedings of the Association and of the Board of Managers; to send

out notices of the stated and special meetings of the same, and to prepare an annual report.

VII. It shall be the duty of the Assistant Secretary to act and vote in the absence of the Secretary.

VIII. It shall be the duty of the Treasurer to receive and to keep account of all moneys and materials contributed for the work of the Association, and to pay all drafts upon the funds.

IX. The Constitution shall not be altered, except at the annual meeting of the Association, or at a special meeting called for that purpose by the President,—notice of the proposed change having been given at a stated meeting of the Board of Managers.

BY-LAWS.

I. There will be an annual meeting of the Association on the first Thursday in October in each year, at such hour and place as the Secretary, with the advice of the President, shall indicate.

II. The election of officers and of the Board of Managers shall take place at such meeting, and they shall continue in office for one year, or until their successors shall be appointed.

III. In the case of the vacancy in any office by the death or removal of the incumbent, the same shall be filled at a stated meeting by the board of managers; and any one so elected shall continue in office until the next annual meeting of the Association.

IV. The stated meetings of the Board of Managers shall be on the first Thursday of each month.

V. At the meeting of the Board of Managers, six members, representing not less than three parishes, shall constitute a quorum for the transaction of business.

VI. In raising funds for carrying on its operations, this society shall not resort to the questionable expedients of fairs, bazaars, tea-parties, dramatic entertainments, or any forms of lottery.
