THE PRESIDENT'S ADDRESS

Again we come together at the end of one more year of service to take a backward glance at what we have accomplished, and at the beginning of another year to look forward with new aspirations and new hopes. We find much to be thankful for in the year just past,—in the unflinching loyalty with which you have faced great difficulties and in your willingness to undertake new ventures, but more than all in a new attitude throughout the Diocese that can hardly be defined and certainly cannot be measured, but which is very surely the work of the Holy Spirit among us. Our Quiet Day together, our Day of Prayer, the instruction we have received from Canon Bell and other teachers, and the loyal co-operation of our rectors have all been contributing factors. There is surely a deeper spiritual meaning in our work, and a more intelligent understanding of the simple methods by which the Auxiliary carries out its program. But divine discontent must always mark progress toward our high goal, and using the experiences of the past year wisely, we may pause to ask ourselves the searching question, if we be His disciples, where have we failed and how may we do better? That is a question that can only be truly answered by each individual member of the Auxiliary, and by each parish branch, and the answer must be used not in any way for discouragement but for future guidance. In the light of that question, may I set forth certain specific points that seem of paramount value in our growth, both spiritual and material, and which were brought out in many conferences at our Triennial meeting. I need hardly say that they may serve for endless discussion and meditation and prayer.

The one of fundamental importance is the revitalizing of our personal lives, and the integrity of our motives as members of the Woman's Auxiliary. Are we so convinced of our Lord's Incarnation and of His continual presence among us that we are impelled by the joy of that knowledge to join in proclaiming Him throughout the world as its only Saviour and King? If our motive be less than this, let us pray for the renewing of a right spirit among us. It is this same joy that we need to infuse into all our work for Him, that it may irradiate the common tasks done in His name, and make of our daily life a joyful adventure for God.

The question of interesting the uninterested woman is one deserving our deepest consideration and prayers. Where have we failed if our group is not being constantly enlarged? How can we break through the crust of apathy and indifference that threatens so much of our Church life to-day? How may we commend the work of building Christ's Kingdom on earth so that it may appeal to empty hands and hearts? The splendid response of young women in our Diocese to the ideals of the Auxiliary is a source of justifiable pride, but are we enlisting them in sufficient numbers? How we need their dauntless courage, their capacity for large thinking and their ruthless sincerity!

The intimate connection between the work done on our mission fields and the peace of the world and understanding among nations, cannot be too strongly emphasized. When Christian ideals prevail in international councils, and self-interest is merged in co-operation for universal welfare, war can be no longer a factor in the history of the world. If this seems a far cry into the future, the seeds of such a harvest are sown in Christian teaching. The giving of our minds to our Lord in more intelligent study of the work that is being done in His Name will lend wings to our imaginations and transform our parochialism into citizenship of the world. We

greatly need a closer touch with the splendid work that we are helping to support, and the suggestion is made that every Churchwoman cultivate the habit of reading news of the mission field as she now reads her newspaper. It is a habit that cannot fail to grow by what it feeds on, and the results would be out of all proportion to the effort made.

For the attainment of these ends to which I have asked your attention,—a new joy born of a life in our Lord and Saviour, a winning of new workers for Him, a more enlightened view of our fields of work and of the intimate relation between the Christian attitude toward life and the solution of world problems,—for their attainment we must dare to claim the power that is ours if we fulfill our Lord's conditions. "Ye shall receive power" are words which ring down the centuries to the very core of our weakness, our hesitations and our doubts. Our tasks are great, for they are the needs of the whole world, but we are not working alone. So let us, with faith in His promises, go forward joyfully and trustfully to meet our tasks in the year 1935.

**ANNUAL REPORT
OF THE RECORDING SECRETARY
FOR THE YEAR 1934**

The annual meeting of the Rhode Island Branch of the Woman's Auxiliary was held on January 26th in Grace Church, Providence. The speakers were the Rev. Barrett P. Tyler, D.D. and the Rev. Bernard Iddings Bell, D.D. Dr. Tyler spoke of his work among the Arapaho Indians. He emphasized the danger of tearing down the old Indian religion and spoke of the necessity of grafting on to the trunk of the Indian belief our Christian conception of God. Dr. Bell made a strong plea for religious education. He urged us to stimulate our religious thought by reading and said that missionary enterprise depends upon keeping our minds alert and clear. 344 responded to the roll call.

On March 16th a meeting was held in the Parish House of the Cathedral of St. John for U.T.O. custodians and others. Miss Cotherin gave a most inspirational talk. On March 20th the board of the Woman's Auxiliary spent a delightful afternoon as the guests of St. Barnabas Branch in Apponaug. On March 22 a Quiet Day conducted by Bishop Bennett was observed at the Cathedral of St. John. A great number of the women of our church gladly availed themselves of this privilege. In May the Auxiliary sent on \$55.00 which had been collected for the Provincial project of helping the educational work in the rural districts of New England.

The Spring Quarterly meeting was held at Christ Church, Westerly, on May 4. Bishop Perry greeted us at the morning session. The speakers were Dr. Wood, Executive Secretary of the Department of Missions of

the National Council, and Bishop Bennett. Dr Wood described the wonderful work done in some of our mission stations abroad. Bishop Bennett said that the mission of the church was the great factor by which we may express the divine compulsion to bring the love of God into every soul. 237 responded to the roll call.

Your Auxiliary gave three scholarships to the Wellesley Conference.

The high light in our church year was, of course, the Triennial meeting in Atlantic City in October. Rhode Island was officially represented by Mrs. Binney, Mrs. Merriman, Mrs. Thornley, Mrs. Wray and Mrs. Meader with Miss Downing as alternate, and I am sure all the delegates enjoyed to the utmost this great honor and privilege and returned home full of inspiration and enthusiasm.

On November 9th came our Fall Quarterly meeting at Trinity Church, Pawtucket. The speakers were Miss Elise Dexter and the Rev. Walworth Tyng of China. Miss Dexter spoke of the General Convention at Atlantic City and Dr. Tyng spoke of the evils existing in China and of the need for Christian missionaries in this great nation where the people are hungry for Christ and where after 4000 years of pagan rule there are now Christian men at the head of the government. 296 responded to the roll call.

On November 12th a day of prayer was observed by the church women all over the world. The prayer leaflets for the different parishes were supplied by the Educational Secretary of our auxiliary.

The women of our diocese have had a rare privilege and opportunity in the course of four lectures which were given during October and November by Dr. Bernard Iddings Bell on the Development of Religion. These lectures have been an exceptional mental as well as spiritual stimulus. Our Auxiliary is deeply indebted to Dr. Bell.

On November 16th a sale of articles from the mission field was held by the Auxiliary at St. Stephen's Parish House. Articles came from Porto Rico, China, the Philippines, the Negro and Indian Missions and from the Southern mountains. Receipts from the sale were \$307.50. This money is always sent back to the mission fields from which the articles come.

It is with deep regret that I report the resignation of Miss Julia Downing our Assistant Educational Secretary who has served faithfully in this capacity since 1922. We shall miss her.

After six years of service as our Provincial Representative on the Executive Board, Miss Marguerite Ogden's place was filled last October by Miss Mary Louise Pardee. Your diocesan board sent a resolution of thanks and appreciation to Miss Ogden for her interesting work in the service of Province I, during the past six years.

Board meetings have been held every month during the year with the exception of July, August and October.

Three new branches have been formed in our diocese this year. I think we all feel a very special joy that one of these is a branch at St. Elizabeth Home.

Church people feel a close bond no matter in what corner of the earth. Last spring the Rhode Island branch of the Woman's Auxiliary sent greetings to the synod held in Wuhu, China.

May we feel more and more this universality of our common Christian faith and once again this new year affirm our loyalty to the Mission of the Church.

THE UNITED THANK OFFERING

Balance, January 1, 1934—\$5,258.99.

Between that date and October 8th we added by contributions and interest on account, \$4,404.44. On October 11th at our Triennial Service in Atlantic City, as your representative I presented the sum of \$9,663.43 as the Thank Offering of the Women of the Church in Rhode Island.

Since October, I have received \$15.05, which is the balance January 1, 1935.

The total amount of the Offering made by the women of the whole Church at the Triennial Service was \$789,561.13. Because this sum was so much less than we had previously given, it was voted that no part of it should be used during this Triennium for building purposes, but that it should be used for the salaries, pensions and training of U.T.O. workers.

We did not pass a detailed resolution to govern the use of the Offering of 1937, but we did resolve:—"That in these next three years the United Thank Offering be held before the women of the Church with more zeal than ever before as an ideal expression of their personal devotion and gratitude to the living Christ, and as a means of forwarding the missionary work of the Church through well equipped women."

We further resolved to study the United Thank Offering and its possible use during the next three years. It is my hope that we may start such study here in this diocese now. I want a group of women in each parish to act as a United Thank Offering Committee with the Parish Custodian. The aim of such a committee would be to spread information and make sure that every

woman in her parish knows what the United Thank Offering really is.

Just after an Offering has been presented there is apt to be a "let down," and our Blue Boxes are neglected for a time. Let those of us who have done this begin now to remember our every day blessings and as we drop our coins into the box let us think of what the letters U. T. O. may stand for. *Us, Thee, Others: Unto The Outermost.* Thus may our U.T.O. be truly a United Thank Offering, given by Us to Thee, oh Lord, for Others, and may it reach even unto the Outermost.

It has been a year of progress in many directions.

The work of the Supply Department in the last year has been most satisfactory, as far as the making and buying of the new garments; but we are sadly lacking in second-hand clothing, money for parcel post, and dispensary supplies, which are just as necessary as the new work. The large number of rummage sales in the churches has considerably reduced the amount of second-hand usually sent to our Missions. I feel very strongly that every department of the R. I. Woman's Auxiliary should be self-supporting. A deficit could be easily avoided if every woman would be willing to give her Treasurer 5 cents a month to cover the cost of parcel post and dispensary supplies for the work of the Supply Department.

In closing I want to thank each and every member of those Auxiliaries who have done their full share of work, and co-operated with me in every way possible to make this report such a splendid one. It is a great satisfaction and inspiration to work with such a splendid body of women.

Indian Department

Interest in the Indian Department was stimulated at our annual meeting in January at Grace Church when the Rev. Barrett Tyler told of the Arapahoes at St. Michael's Mission, Ethete, Wyoming. Newport County chose this as the object of its Lenten Offering.

I had the pleasure of speaking at 8 parish branches during the year.

The Lantern Studio, Wayland Square, took the Indian laces and linens for sale, when the Junior League shop closed. We are grateful to Miss Fidler for her co-operation. From the Mission sale, I sent out \$50.00 to Oneida with 6 orders. This is a most helpful part of our work, for the Indians want to earn their living, yet they seem to appreciate more our friendliness in liking their work than the money we send.

We were interested in the Wheeler-Howard bill of reorganization for Indian administration, and sent a petition signed by the Executive Board, objecting to the backward policies of the bill. The bill was amended, taking out the worst features, and we can feel sure that our church missions have helped and do co-operate with the government for the better education of the Indians to fit them to be self-supporting.

Mrs. Webster, an Oneida, in charge of the linen and lace work, has been appointed post-mistress at Oneida, Wisconsin, passing the civil examination 100%—over five white people.

If I am not asked to come to tell you about these loyal Americans, I am going to write and invite myself, for I want you all to share in the fellowship they have for us and to know how much they need our friendship.

Diocesan Department

In reviewing the year of 1934, we find among the Auxiliaries an increasing interest in the work of our Diocesan missions and institutions. On every side we have met with generous co-operation in gifts of money and supplies, and we are grateful to all who have contributed in any way to the success of the year's work.

The response to the "Penny-a-Week" or Diocesan Mission Fund has been especially encouraging, and because of this we have been able to give our missionaries greater financial aid than ever before.

Late in the winter of 1933 an effort was made to supply the boys at St. Andrew's School with heavy winter sweaters. This task has now been accomplished and seventy-two sweaters have been supplied. We have helped where we could in the other institutions, and we are pleased to record a new branch of the Auxiliary at St. Elizabeth Home.

The Guild of Compassion, under the able direction of Miss Eunice Dexter, has continued faithfully its work of assisting Father Vivian in his visitations at the State Institutions, and deserves the prayerful support of every woman in the Auxiliary in its most important task of bringing cheer, comfort and a spirit of friendliness to those less fortunate than ourselves.

In the summer of 1933 the Diocese purchased a piece of property in the village of Arcadia to be used as a mission, and the women of the Auxiliary undertook the raising of funds necessary to remodel a portion of the building as a chapel, to be known as the Chapel of the Transfiguration. In February the Diocese was saddened by the news of the sudden death of the Reverend George

N. Holcomb, our missionary in the rural field, and as Mr. Holcomb had felt for some time that Arcadia should become the center of missionary activity in that area, and as the work there was very near to his heart, it was thought fitting that we should give the new chapel in his memory. Immediate response to an appeal for money came from many parishes, and work on the building was started during the past summer. Although not completed the Chapel is being used, and we look forward with confidence to its ultimate consecration to the Glory of God, and in loving memory of a life given in devoted service to our Lord, and to his Church.

ANNUAL REPORT OF THE JUNIOR AUXILIARIES

Having been re-elected chairman of the Central Committee of the Junior Auxiliaries, I have this second opportunity of reporting their activities over a year's time. Were I permitted to go into the parish activities of the eight Junior branches, I could relate a much wider scope of work in which they participate. Their obligations to their individual parishes often equal their duties to the Woman's Auxiliary proper, but these added opportunities to assist the home church have been cheerfully undertaken along with the routine Auxiliary work of sending out prayer leaflets three times a year to the shut-in intercessors, assisting at the yearly Mission Sale, fulfilling their quotas of Supply Dept. work, knitting, and visiting the "shut-ins" and the sick.

In April, the Junior Auxiliaries as a unit held a bridge and dance to raise money for supplies for Mahan School dispensary in Yangchow, China. The results of this endeavor were two-fold,—bringing the Juniors into close affiliation, and accomplishing the special object for which it was undertaken, as excerpts of a letter from Mrs. Ancell, head of the dispensary, testify:—

"The check for \$50 gold was received at our Mission. This morning the money has been turned over to me, and amounts to \$142 Mexican. This sum will be a splendid help in my work and enable me to get some much needed supplies, and also help take care of some of the sick, who need to be sent to hospital for special examinations, for which they are unable to pay. I am so grateful to the Juniors of the Rhode Island Woman's Auxiliary for their efforts, and feel sure could they know how each dollar will bring relief they would be glad for this effort on their part."

This fall a letter of greeting was sent to a newly formed Junior Auxiliary in Bishop Mosher's Cathedral in Manila, Philippine Islands, and we are awaiting a reply and exchange of ideas from this interesting branch far across the seas.

Again this Thanksgiving the Juniors furnished heap-
ing baskets of supplies to thirty families in rural Rhode
Island. Upon the occasion of delivering them, several
of our members had the opportunity of seeing Holcomb
House, and were rewarded for their work and greatly
inspired by this visit to the diocesan mission field and by
Father Wright's fine letter, which said, in part, "If the
work, time and trouble that the members of the Junior
Auxiliaries took to provide dinners for the needy in the
rural missions can be offset by the real happiness and
satisfaction and gratitude which those dinners produced,
you may rest assured it was worth while. Mrs. Wright
and I drove 125 miles distributing the packages you left
with us, and I have never had a happier drive. It was
splendid of you not only to give so much, but to do it so
carefully that we were saved all the time and trouble of
selecting and packing."

There is still plenty of work for the Juniors to do this
winter and spring, and it is our desire to spread our labors
so that all departments of the Woman's Auxiliary may
benefit by our good works. This hope could be even more
certain of fulfillment were the present eight branches to
be supplemented by new groups from parishes which
evidently have not yet considered the advantages of a
Junior Auxiliary as a constant help in the present, and
as a training ground for future church workers and
Woman's Auxiliary members.

D. 1927, the following amendment (x) to the Articles of Association was duly adopted by the affirmative vote of a majority of its members, viz:—

“VOTED, That the Articles of Association of this corporation be amended by changing the name from Rhode Island Branch of the Woman's Auxiliary to the Board of Missions, to, Rhode Island Branch of the Woman's Auxiliary to the National Council.”

**The Rhode Island Branch
of the
Woman's Auxiliary to the Board of Missions**

With the cordial approval of the Bishop of the Diocese, a society has been formed which hopes to include all parishes in the diocese, and asks the co-operation of all the clergy. It does not propose to change the work of any parish, but by united and sympathetic action to increase the interest in, and render more effective, the missionary work of the Church. It is hoped by this union that the smaller parishes that are able to do but little may unite with the larger, or with each other, in working; also that the larger parishes may learn of the needs of the smaller and assist them if desired.

At a meeting called by the Bishop, February 8, 1878, a Constitution was adopted, and the officers appointed.

Constitution

as amended to January 1st, 1931

I. This organization shall be called the "Rhode Island Branch of the Woman's Auxiliary to the National Council."

II. Its object is to unite all the parishes in the diocese in the different branches of mission work, viz: Foreign, Domestic, Indian, Colored, Diocesan, and United Thank Offering.

III. Any woman who is a member of a parochial branch of the Woman's Auxiliary shall be a member of this organization.

IV. The officers of this organization shall be a President, a First Vice-President, a Second Vice-President, and such other Vice-Presidents, in order, as shall be elected at the Annual Meeting; a Recording Secretary, a Corresponding Secretary, a Treasurer, an Assistant

Treasurer, an Educational Secretary, one or more Assistant Education Secretaries, a Treasurer of the United Thank Offering, a Supply Secretary and one or more Assistant Supply Secretaries, a Committee on Missions, and all such Honorary Officers as may be elected at the Annual Meeting. The Executive Board shall fill all vacancies which may occur between Annual Meetings.

V. The business of the organization shall be transacted by an Executive Board consisting of the officers of the organization.

VI. This society shall hold an annual meeting in January for the purpose of electing officers for the ensuing year, hearing the reports, and transacting all other business. Meetings shall be held at stated intervals in different parishes. Special meetings may be called by the President, or upon the request of three members.

VII. It shall be the duty of the President to preside at all meetings, and to have general knowledge of the work that is in progress. A Vice-President shall preside in her absence.

VIII. It shall be the duty of the Recording Secretary to keep a record of all meetings, and an account of the work done by the women of the diocese, as reported by the department secretaries, and to report this annually to the secretary of the "Woman's Auxiliary" in New York.

IX. It shall be the duty of the Corresponding Secretary to conduct all the correspondence of the Society, and to send notices of all meetings.

X. The Treasurer shall receive and disburse all moneys sent to her for any branch of missionary work, and for the expenses of the Society, and shall present a report at the annual meeting.

XI. Fifteen persons shall constitute a quorum at the annual meeting, and five at any board meeting.

XII. This Constitution may be altered or amended at any annual meeting by a two-third vote of the members present; due notice having been given all parish branches.
