## WOMAN'S AUXILIARY RECOGNIZED

The relationship of the Woman's Auxiliary to the Board of Missions to the Presiding Bishop and Council had been referred for consideration to the committee on organization and by-laws, and their report was adopted by the Presiding Bishop and Council as follows:

"Whereas, the Presiding Bishop and Council recognizes the splendid and necessary work which the Woman's Auxiliary to the Board of Missions has carried on for so many years, and desiring to conserve in every way this devoted service, therefore be it

"Resolved: That the Presiding Bishop and Council hereby constitutes the Woman's Auxiliary an auxiliary to the Presiding Bishop and Council, it being understood that further action in the matter may be taken if and when there should come into existence in the Church a federation of women's societies which can be made auxiliary to the Presiding Bishop and Council."

**REMINDERS FOR PARISH OFFICERS.**

1. Any work that aids the Board of Missions to meet its obligations is legitimate work for the Auxiliary. When in doubt about it, write to the Diocesan Secretary.

2. The Woman's Auxiliary's share in the Diocesan apportionment is \$1,700.

3. Delegates to annual convention should be elected in April.

4. All money, except for the United Offering, must be sent to the Diocesan Treasurer, Mrs. Thos. Hazelhurst, 4 Council St., Charleston, otherwise the Branch sending it will not receive credit therefor in the Treasurer's report.

5. The United Offering should be collected in September, 1919, and sent immediately to the United Offering Custodian, Miss Virginia T. Singleton, Columbia, in order that she may present it at the Triennial Convention in Detroit, October 7th. The offering of April, 1920 should be collected and carried to



the Convention by the delegate in an envelope provided for that purpose, giving name of branch, name of branch Custodian, amount of September offering, and amount enclosed. Should there be no delegate, the offering should be sent direct to Miss Singleton.

The entire offering will be presented on the alms basin at the United Offering Service at the Convention in May.

6. Annual dues should be paid in November.

7. The books of the Diocesan Treasurer close December 31st. All money must reach the Treasurer before this date or it cannot be included in reports for the current year.

## Report of Thirty-Fourth Annual Convention

---

The Thirty-fourth Annual Convention of the South Carolina Branch of the Woman's Auxiliary to the Board of Missions was held in Sumter, S. C., May 21st, 22nd, and 23rd, 1919.

The opening service was held in the Church of the Holy Comforter, on Wednesday morning, May 21st, at 10:30, the Right Rev. Wm. A. Guerry, D. D., Bishop of the Diocese, Rev. A. R. Mitchell, Treasurer of the Diocesan Board of Missions, and the Rev. J. Bentham Walker, Rector of the local church, officiating.

The Bishop made a most interesting address in which he urged the women of the Church to realize a deeper sense of their responsibilities in the work of the Church both at home and abroad. He warmly thanked the women of the Auxiliary for their growing interest in the work among the colored people, and hoped that all would remember the offering to be given for this work on Septuagesima Sunday. Following the Bishop's address, the Rev. J. Bentham Walker presented two candidates for confirmation to the Bishop. The United Offering from all the Branches was then made, and the sacrament of the Holy Communion was received.

The Holy Communion was celebrated every morning, the business of the Convention was suspended every day at noon for prayers for Missions and for our Missionaries. Each session of the Convention opened and closed with appropriate Hymns and Prayers.

The speakers and guests of the Convention were the Rev. Louis G. Wood, Field Secretary of the Board of Missions, Deaconess Henrietta R. Goodwin, Student Secretary of the Missions House, Miss Eliza H. McCullough, former Missionary to Porto Rico, Rev. A. R. Mitchell, Treasurer of Diocesan Board of Missions and the Rev. A. E. Penick, Minister in charge of Trinity Church, Columbia.

A Missionary service was held on Wednesday evening. The Rev. A. R. Mitchell delivered a most inspiring sermon on "The



Christian's Duty Toward Missions" after which the Rev. A. E. Penick made an address on "The American Church Institute for Negroes" and our responsibility to the colored people. The Bishop also spoke on this subject and highly commended Arch Deacon Baskerville on his work among the people of his own race. The offering at this service was devoted to the American Church Institute for Negroes, and amounted to \$50.00.

On Thursday evening the Sumter branch gave a most delightful reception to the delegates and visitors, at the beautiful residence of Mr. and Mrs. Upshur.

A Missionary Exposition held on Thursday night in the Sunday School rooms of the Presbyterian Church, through the courtesy of the minister, the Rev. Mr. Marion, was of great inspirational and educational value.

The Exposition was formally opened at 8:30 with the singing of a Hymn and invocation pronounced by Rev. J. Bentham Walker. Mrs. Cornell, General Chairman, invited the delegates and their friends to visit the many Mission Fields of the Church's work, represented by booths containing curios, costumes and products, loaned by the Exchange Department of the Missions House, attractively arranged to represent the fields in different sections of the world. Flags, charts and banners, calling attention to the general needs and opportunities before the Church today, were displayed. During the evening the Rev. T. P. Noe and the Rev. A. W. Taylor presented the needs and opportunities in the mill villages of Graniteville and Columbia, Miss Eliza McCullough gave a description of the work in Porto Rico, Mrs. Marsh, a portrayal of life in the Phillipine Islands, and Dr. Lucy Bragg Anthony (colored) made a splendid talk on the Church's opportunity among the negroes in our midst. Sincere thanks are tendered these speakers for their most interesting talks.

The first business session of the Convention was called to order by Mrs. W. P. Cornell, President, on Wednesday at 11:30 A. M., all the sessions and services being held in the Church. The President expressed gratification at such a large and representative gathering of Church women, the Roll Call showing in attendance the Bishop of the Diocese and eight of the Clergy, 95 representatives from Chapters A, 16 from Chapters B and 25 Juniors, making a total of 145.



The Rev. J. Bentham Walker, Rector of the Church of the Holy Comforter, addressed the Convention and welcomed it to Sumter and to his Parish. Mrs. John Sumter, in the name of the Sumter branch, extended a most cordial welcome also, to which the President responded.

The Annual Message from Miss Grace Lindley, General Secretary was read, after which a resolution was passed that greetings from the Diocesan Branch be sent to the staff at the Missions House, accompanied by the hearty endorsement of the South Carolina Auxiliary of the Nation Wide Campaign to be waged in the Fall by the Board of Missions.

The President made a most inspiring address which was received by a rising vote of appreciation.

Reports for the year 1918 were made by the three Vice-Presidents. The Secretary reported having prepared the Annual Report for publication; 250 copies had been printed and distributed to all general and Diocesan officers, Parish Branch Presidents and others and that 73 letters and postals had been written during the year.

Reports were made by, Box Secretary, Treasurer, Secretary of the Junior Department and Secretary of "The Diocese". The reports of the Secretary of "The Spirit of Missions", the Chairman of Publicity Committee, and of the United Offering Custodian were read, these officers being unable to be present. A report was read from Miss Laura Bragg and Miss Susie Fitzsimmons, auditors, stating that the books of the Treasurer and of the United Offering Custodian had been audited and found correct.

On Wednesday afternoon, Deaconess Henrietta R. Goodwin made an address on "Present Opportunities in the Mission Field". She also spoke of the opportunities to do real missionary work in our Sunday Schools by bringing in the children, stating that in the last year, 50,000 children had been lost out of our Sunday Schools. The Deaconess urged, wherever possible, the adoption of the New Junior Plan in the Sunday Schools.

At the Thursday morning session, Mrs. D. D. Taber, Educational Secretary and Chairman of War Work of the Women's Auxiliary in this Diocese, made a report; an Educational Symposium was held, and many matters of vital interest to



branches were brought out. Mrs. Taber most strongly urged each branch to appoint an Educational Secretary and to make a more general use of the Educational Department in connection with their Box work. Importance of Summer Church conferences was stressed and the branches were urged to send delegates to these conferences. A resolution was adopted that the Diocesan Branch send a delegate to the Church Conference at Sewanee for training. The value of program meetings was stressed. The branches were urged to call on the Foreign and Domestic Missions Committees for information on the various Mission Fields for use in program meetings. Miss Ellen F. Hayne, Chairman of the Foreign Missions Committee, read a most interesting paper on what could be accomplished by the Branches in the next two years, if they would only grasp the many golden opportunities at their very doors.

Articles II, IV, V, VI and VIII of the Constitution and Articles II and III of the By-laws were amended as shown on page 58.

The Junior session was held on Thursday afternoon, Mrs. J. S. Myers, Secretary of the Junior Department, presiding. The President stated that Mrs. C. T. Lundgren, former Secretary of this Department, had resigned this office on account of removal to Liverpool, England, and that Mrs. Myers had been appointed by the Executive Board to fill the unexpired term.

This session was well attended. The Junior delegates submitted reports of the work of their various branches, which were most interesting and encouraging. The Little Helpers of the Holy Communion Church, Charleston, reported placing a cot in the City Hospital as a memorial to one of their little members who had been called to his Heavenly home.

At the Friday morning session, the Rev. Louis G. Wood, Field Secretary of the Board of Missions, spoke on the Nation Wide Campaign which will be conducted by the Board of Missions in the fall. Mr. Wood highly commended the women of the South Carolina Branch of the Auxiliary for the work accomplished by the Branch and stated that he expected them to put forth their very best efforts, when called on to assist in this Campaign, just as they had done in the Advent Call. Deaconess Goodwin also spoke on the Nation Wide Campaign and urged all the women



to grasp the opportunity for service thus presented. In this connection the President announced that the Bishop had appointed her Chairman of the Women's Division in this Diocese and she pledged the support of the Auxiliary 100%.

Mrs. T. H. Fisher presented the following resolution which was adopted:

"That a Committee be appointed by the President to confer with Miss Lindley, the General Secretary, and with our Bishop, to consider the possible co-ordination of the various departments of women's work in the Diocese, this report to be made to the Executive Board, and the Board given power to act."

Mrs. H. G. Osteen offered the following resolution which was unanimously passed:

"That this Convention place itself on record as recognizing the existence of a great social scourge in the presence of venereal diseases in the cities of this State, and the obligation which this imposes upon all good citizens, especially the members of the Christian Churches, to support the efforts of Federal and Civic authorities in combatting this evil which is the most serious menace to society today."

The Secretary presented a resolution which had been passed by the Executive Board and recommended to the Convention for its endorsement:

"That Our Own Missionary Fund be placed in the control of the Executive Board, same to be used at the discretion of the Board for such volunteers of this Diocese as have been accepted by the Board of Missions and are being trained by said body."

This was endorsed by the Convention.

A message of gratitude and love to the women of the Auxiliary, and to the Juniors, whose pledge is supporting a little girl in the Valle Crucis School, was read from Miss Horner, Principle of this School.

The Treasurer requested the delegates to place the following items on their Pledge Slips, to which the branches are asked to make pledges:

To apply on the Apportionment—St. Mary's School, Shanghai; St. John's School, Cape Mt., Liberia; "Work in Porto Rico" to be changed to "McCullough Fund". On Specials—Summer Volunteer Work; Christ School, Anvik, Alaska; Uta Saito's Work in Japan; Alice Gregg's Work in China; Rev. Hoke Ramsauer's Work in Liberia.

A resolution was offered and passed:

That "Mission Study Institute Fund" be changed to "Diocesan Educational Fund" in order that it might be used for Institute and Educational Work.



A resolution was passed that:

"Bishop Colmore's Work in Porto Rico" be put on the Pledge Slips as a Special and that the delegates make a plea to their branches for support of this work.

The Treasurer suggested a division or apportionment of the Diocesan Apportionment among the several branches, which apportionment was, in most instances, accepted by the delegates present.

Voluntary pledges were made from the floor for the work of Alice Gregg in China amounting to \$65.00 and to the American Church Institute for Negroes amounting to \$70.00.

The President made a plea for the Summer Volunteer Work and requested that any offerings for this work be sent to the Treasurer as soon as possible in order that the work could be carried on as usual this summer. Miss Elizabeth Waddell, a Summer Volunteer, also made plea for support of this work.

A report from Mrs. Heyward, Diocesan Correspondent for the Church Periodical Club, was read. A resolution of appreciation of Mrs. Heyward's work was unanimously passed. The announcement was made that Mrs. Heyward had resigned as Diocesan Correspondent of the Church Periodical Club and Mrs. I. G. Ball 13 New Street, Charleston, had been appointed Correspondent by the Bishop.

The proposed General Constitution for the Woman's Auxiliary, Prayer for the Woman's Auxiliary and for the United Offering to be brought before the Triennial Convention in Detroit for adoption were endorsed.

The appointed delegates to the Triennial Convention are the President, Educational Secretary, United Offering Custodian, and Secretary of Junior Department. The elected delegate at large is Mrs. T. M. McCarré, Charleston. Alternates, Mrs. F. N. Challen, Greenville, Mrs. W. S. Manning, Spartanburg, Mrs. Alexander Long, Rock Hill, Miss Katie Lee, Charleston and Mrs. F. P. Henderson, Aiken.

Mrs. S. R. Guignard, Vice President of the Charleston Convocation, extended to the Auxiliary an invitation from the Church in Charleston to hold the next annual meeting in that City, which was accepted with thanks.



The Chairman of the Courtesy Committee, in the name of the Diocesan Branch of the Auxiliary, most heartily thanked the Rector and congregation of the Church of the Holy Comforter, and the people of Sumter, for their unbounded hospitality, the Rev. Mr. Marion for the use of the Sunday School Room of the Presbyterian Church for the Missionary Exposition, the Bishop and other speakers for the inspiration of their addresses, and Mr. and Mrs. Upshur for their most gracious hospitality in receiving the delegates and visitors in their beautiful home.

## Reports of Officers for 1918

*Annual Message from the General Secretary.*

My dear Mrs. Cornell:—

This annual letter is for the purpose of bringing before you a very important matter—the Nation Wide Campaign. You have, of course, already heard and read about this. “It is a campaign inaugurated by the Board of Missions at its meeting in February to bring the compelling facts of the Church’s needs at home and abroad to the attention of every member of the Church. It is, therefore, primarily a campaign of education. A survey will be made of all our work at home and abroad, including all missionary work now under the care of each diocese. Committees will be formed in each diocese to co-operate with the Bishop and a Central Committee, and a combined budget will be made up covering the needs of the Board and the federal agencies. In preparation for this great endeavour educational work will be carried on throughout the whole Church culminating in a week of intensive education which will be conducted in the autumn when meetings will be held all over the United States ending in an Every Member Canvass of each parish. Dr. Robert W. Patton is the national director.

That the Woman’s Auxiliary will have its part in this campaign goes without saying. The Auxiliary is to be congratulated that after the Advent Call this new and bigger work has come to us. Perhaps it is given to us because we tried to be faithful in that service. And now as to what we are to do. I have ventured to tell the Executive Committee in your name that the Auxiliary’s share in the plan will be to see that every woman in the Church understands the enterprise and is prepared to take her part in carrying it out. We shall work as we did in the Advent Call, reaching and enlisting other Church societies for women. Each diocesan branch of the Auxiliary should at once, with the approval of the Bishop, appoint a leader or committee to have general charge of this work. This leader and as many of the committee as possible should go to one of the summer con-



ferences where we plan to have training classes on the campaign. From now till autumn we should all spread information. In the autumn, training classes should be held and the women prepared as they were for the Advent Call and from now until the campaign we can make spiritual preparation through special services and by the formation of prayer groups. All this is very much like the Advent Call preparation and it may be asked why it is suggested that we should work on these lines when this is to be an effort by men and women. This is suggested because we believe that in the Woman's Auxiliary we have too good and powerful an *organization* not to use that organization for the furtherance of this campaign and that we can get to work more quickly and do our share more thoroughly if we have these committees throughout the Woman's Auxiliary. For instance, we can reach meetings of women in parishes at hours when the men cannot and we can perhaps do more thorough training through classes than they will have time for, so it has seemed best to the Executive Committee to suggest our working on these lines with the understanding that, of course, the campaign itself will be a united one carried out by men and women working together. It is also desirable that the leader or chairman of the committee appointed by the Auxiliary shall be a member of the diocesan committee. In this way all plans will be centralized and duplication of work, such as speakers' visits, etc., will be avoided.

So let us begin our work for the Nation Wide Campaign. If it is "one of the biggest and most courageous steps forward ever taken" by the Church in America it is undoubtedly the biggest opportunity ever given the Auxiliary to the Board of Missions and I know we will accept that opportunity and give our services so truly and faithfully that the results will be, as they were in the Advent Call, beyond our most daring dreams.

### ADDRESS OF PRESIDENT.

Fourteen months ago you women of the Auxiliary in South Carolina elected me your President.

These have been fourteen months of hard work, and yet they have been months of great joy and privilege.

There have been several changes in the Executive Board this year. Our Educational Secretary, Miss Ford, was obliged to resign her office shortly after she was elected. With regret we accepted her resignation and appointed Mrs. Taber to fill the office thus left vacant. Mrs. Taber having been Vice-President of the Columbia Convocation, left another vacancy on the Executive Board. We were fortunate in securing Mrs. T. H. Fisher to assume this office, and we feel that the South Carolina branch is a distinct gainer by this addition to her executive force. Our Junior Secretary was obliged to leave the Diocese and is now making her home in Liverpool, England. It was with deep regret that we gave up Mrs. Lundgren, but God was again good to us in that He enabled our Assistant Junior Secretary of the Charleston Convocation, Mrs. J. S. Myers, to fill Mrs. Lundgren's unexpired term.

This year we are losing two of our most valued and most beloved officers, Mrs. Gaillard, the Vice-President of the Greenville Convocation, and Miss Heyward, our Treasurer. We will miss them sorely, but we know we may depend upon their continued interest and support.

What are some of the encouraging features of the past administration? I note first our financial report. I do not choose this first because it is of primary importance. Far from it; but because I do believe that our money gifts are an indication of the purpose that lives in our inner lives. Our apportionment of \$1700. was fully met, in spite of the fact that when your Treasurer and I went over the books the latter part of December we were some \$500.00 short on this account. Why were we short when the year was about to close? For two reasons—one the fault of your Executive officers who had not discovered that this fund was some \$150.00 under-pledged—the other, because many of the Parish branches failed to send in their pledges until



after January 1st. How then did we meet our apportionment, and so save the honor of our branch? By the loyalty and generosity of branches and individual members of the Auxiliary.

Each of you must see to it that this does not happen again and that pledges are paid before January 1st, 1920. Our total gifts on the apportionment for 1918 amounted to \$1,747.53. Our gifts to specials, which include the Advent Call fund were \$1,712.49 and our Contingent Fund amounted to \$459.05. Our United Offering is \$1,170.42, making a total for 3 years \$5,139.59

You will recall that I have continually urged you to remember the obligations which I feel should rest with peculiar significance upon the Church in our Diocese. These obligations of which I speak are our responsibility to support and extend the Church's work among the mountain and mill people, and among the negroes of our own and other Southern States. We must not send the gospel abroad and forget those who stand at our doors and knock. "This ought ye to have done and not left the other undone". I feel encouraged by your response to this ideal, although, I warn you, I am yet far from satisfied. In 1918 \$634.20 in cash was given to our Mountain work. Of this \$413.13 was given to the Valle Crucis Emergency Fund.

The Valle Crucis Industrial School is still in need of funds. It costs \$10,000.00 a year to maintain the school, and of this amount Bishop Horner is only reasonably assured of \$7,000.00. This leaves an annual deficit of \$3,000.00 which must be raised through some source, if the school is to continue its work. It seemed wise to seek this amount from the Church at large, and so, the Valle Crucis Emergency Committee of the Carolinas was organized last fall, and the plan to raise \$5,000.00 this first year and \$3,000.00 annually hereafter, until such time as this amount is given from other sources. The funds of this Committee do not go through our Treasury, nor is the Auxiliary responsible in any way for the same; yet as this fund has been largely raised through or by our women, it seems entirely proper that some report should be given to this Convention. From January 1st, 1919 to the present date, some \$2,000.00 has been received on account of this Fund. Of this amount, some 600.00 has been given in South Carolina or through her Committee.



We gave \$118.00 to the Mill work in the past year, and although we have lost Deaconess Sands from our midst, we will long remember her consecrated work.

About 25 study classes have considered the Negro problem as they studied "Our Church and our Country". Several of these classes have added an extra session to consider the Church's responsibility to those black children of God, while Trinity Church, Columbia, and four other branches had classes of six weeks intensive study on this field of opportunity. Charleston and Aiken have studied the Church's work in Liberia; and already there is a growing interest in the work "over there" because the Rev. Wm. Hoke Ramsaur of our sister State, North Carolina, has given his life during the past year to this difficult and lonely field. Mr. Ramsaur cannot be claimed as a volunteer from South Carolina, but he belongs to us nevertheless, because of his many personal friends in Charleston and elsewhere in the Diocese, and because he is a cousin of our Bishop's wife. Bishop Lloyd is anxious that the Church support the Liberian work, and I hope that the Auxiliary of South Carolina will accept its responsibility for this backward race in a complete way; that is, that we will pray for, study of, and give to the Church's work among the negroes in South Carolina, in America, through the American Church Institute for Negroes and in our two Negro republics, Haiti and Liberia. In 1918 only \$17.00 was given to the work among the Negroes. This year we have already given and pledged \$135.80.

The Domestic and Foreign Missions Committee will have reached the apex of its year's work when it presents to you tomorrow night the Missionary Exposition.

There is a note of disappointment in my report when I speak of our Junior Department. Owing to circumstances beyond the control of the Junior Secretary, this important work has not grown as I feel sure you would like to see it grow. Each one of us must rally to the assistance of our incoming Junior Secretary, of whom we expect great things. She can do but little alone. She needs you to help her! Our boys and girls are the future church. They will carry the Cross "over the top" when we have fallen on the field. We may make good in them, if we will, the



lives of opportunity that we ourselves have wasted or destroyed.

The United Offering and the Offering of Life express the highest and most complete service that we women can give. How we should strive, we that remain at home, to make an adequate thank offering for all our blessings, and how thankful we should be that there are those amongst us who, in answer to the cry of "Who will go for me", gladly cry out, "Here am I, send me".

I am so grateful for the Advent Call and for our gifts of life and substance! But women, "forgetting those things which are behind, and reaching forth unto those things which are before" we must *press on*.

Listen to the words of our Presiding Bishop: "Gather to the colors of the Nation-wide Campaign. Summon the men. Call the women. Forget not the children. Discipline the recruits. Furnish the munitions and supplies. Speak to the American Churchmen that they go forward". What does this call to arms mean to you and me? Very briefly, it means that the Army of the American Church is called into active service for the King! That between now and the 1st of December, every man, woman and child is to be enlisted in the fighting force of the Church.

The Son of God goes forth to war!

The American Church goes with Him!

## REPORT OF THE VICE-PRESIDENT OF COLUMBIA CONVOCATION.

I shall preface my report by saying that I have only served since June 1918, filling out the unexpired term of Mrs. Taber, who resigned to become the Educational Secretary. This, however, does not account for the incompleteness of the Branch Reports. Influenza crippled all work, but it positively paralyzed



the Auxiliary work in some localities—no meetings being held for months. Then war work monopolized the attention of a large per cent of former earnest workers.

The Fall Convocational meeting which was planned in conjunction with the clergy, was interrupted by the quarantine then so general. However, by extra exertion, our able President and Educational Secretary carried out the program for the Advent Call, and as that was the prime object of the Convocation, the loss was made up in this way. Notices of the various institutes for the training of messengers for the Advent Call were sent to each Branch President.

Letters were sent to the various branches with suggestions for simple program meetings.

It is with real pleasure that I report the organization of three new Chapters in this Convocation, viz., Chapters A. Trinity Chapel, Columbia, Chapter B. St. Thaddeus, Aiken, and Chapter C. Grace Church, Camden.

One of the Branches—Trinity Church, Columbia,—broadened its work a little by organizing a Committee whose object is to further the Negro work of the Diocese. The plans are not perfected, but they look to the organizing of similar committees in all the branches of the Woman's Auxiliary of this Diocese to assist the Bishop in his work among the negroes of South Carolina.

Another progressive step taken by this branch was the co-ordination with the Auxiliary, of a group of youthful war-time "Busy Knitters" whose hands were left idle by the signing of the Armistice. They are called "the Home Service Department of the Woman's Auxiliary". The plan is feasible for utilizing other groups of erst-while war workers, and I hope it will be adopted by other branches.

It is my sad duty to report that the Columbia Convocation has sustained a telling loss in the death of one of our leading workers, and we join with Cheraw in lamenting the death of Mrs. H. P. Duvall, the United Offering Custodian of St. David's Branch.

The following report, as I said, is incomplete, but it shows that



some of our Branches have kept the faith during the past hard year.

## REPORT OF THE EDUCATIONAL SECRETARY.

Upon the resignation of the Educational Secretary, Miss Marianna Ford, I was appointed by the Diocesan Board to fill her unexpired term. It was through the generosity of the women of the Auxiliary that I was sent to the Conference of Church Workers at Cambridge, Mass., last June. If I have been able to further this important branch of Church work in even a small way, it is due to the helpful instruction and inspiration which I gained at Cambridge.

Convocations and Institutes were later held in Charleston, Aiken, Columbia, Rock Hill and Spartanburg, but as the Advent Call was the greatest spiritual effort the Auxiliary had ever attempted, it necessarily overshadowed the Educational work last Fall.

The following books were recommended for study this year. "Our Church and our country" by Bishop Burleson; "The Call of a World Task" by Lovell Murray; and "The Negro Life in the South" by Dr. Weatherford, and a great many of the books have been sold.

It is my earnest wish that all branches will have Educational Program Meetings, the material for which can be furnished by the two important missions committees, (Foreign and Domestic), who have papers prepared on their respective fields.

Let me urge upon you that every Branch send a delegate to one of the Church Conferences, which are in reality Training Schools and are held every summer at, Sewanee, Tenn., Wesley College, and Blue Ridge, North Carolina.

There have been held in the Diocese this past year 23 Mission Study Classes.

The reports of the number of Program Meetings were so inaccurate that I cannot give the number held the past year.

## REPORT ON ADVENT CALL.

The Advent Call to Prayer was such a big undertaking it would have been appalling if we had not from the outset realized its potent possibilities. It was a concerted effort to help the women realize the spiritual power latent in them, in order that they in turn might assist other women to appreciate the far reaching power this Call meant to the nation and to the world.

That the Advent Call reached almost every parish and mission in the Diocese was due to the indefatigable efforts of the several Chairmen. It was a great distress to the Executive Board that our Bishop was not with us to lead and inspire us in this great work, but we felt strengthened by his blessing in our undertaking; and we knew his prayers were for us that God's Holy Spirit would guide and succor His messengers, as they went from house to house asking the women to put *first things* first.

And what about the women whose homes they visited, how did they receive the Message? Many were glad to discuss the things of the Kingdom, and most of them appreciated our coming, and others did not hesitate to tell us they esteemed it a privilege to be thus visited.

The intercessors—those who were praying continuously in the Churches while the messengers were making their visits, holding up the hands of God's messengers, as it were,—have realized as never before the potent power of prayer.

It was an opportunity for the shut-ins of our Church to become active sharers in the work of the Church.

One great victory gained by the Advent Call is that we overcame our timidity and natural disinclination and accomplished the hardest because the most fundamental work the Auxiliary had ever before undertaken.

The Advent Call has shown the strength of the Auxiliary—its ability to do big things, to assume leadership in a big movement, and enlist the cooperation of all other organizations in the Church.

This is but a brief summary of the Call; but I wish to thank the President, in the name of the Executive Board, for the helpful and inspiring classes she held for the Training of Messengers. Also our hearty appreciation and thanks are given to the Clergy



for their interest and co-operation. In many instances, it was only through their efforts that messengers were able to reach outlying districts.

**REPORT OF THE UNITED OFFERING CUSTODIAN AND  
OF THE CHAIRMAN OF THE COMMITTEE ON THE  
OFFERING OF LIFE.**

The year of 1918 was unlike any previous year in the history of the Auxiliary, due to two causes.

First—The condition of the country at war and the fearful epidemic of Influenza.

Second—Owing to the change in the fiscal year, 1917 being only an eight months year only one United Offering was presented at the Convention in January 1918. Consequently, the two Offerings for 1918 (April and October) were sent direct to me and not reported until now. The books of the Custodian closed on January 1st. and any Offerings sent in after that date will not be credited on 1918, but on 1919 report.

The Charleston Convocation leads, not only in amount, but also, in that every branch, except one, sent in two offerings.

The Offering from the Junior Department is depressing. Only 37 of the 79 sections sent in Offerings, and only 12 of these sent two during the year.

The Junior Custodian, Mrs. Kennedy, assisted wonderfully and we regret that she is unable to serve another year. Mrs. Mixson, Mrs. Heinitsh and Miss Sylvia Allen, Convocational assistants, have aided nobly, endeavoring to arouse interest in the United Offering in small places where there are no branches.

Programs for United Offering meetings were sent out and were used by many of the branches. Made a talk to the Juniors at the Greenville Convocational meeting. Wrote a paper on the Offering of Life which Miss Allen read for me at the Charleston Convocational meeting.



Our Summer Volunteers numbered only two. Miss Elizabeth Waddell of Cheraw again served at St. Mary's Mission, assisting Dr. Hilton with class work and visiting. She accepted no financial aid from the Auxiliary. Miss Freda Klintworth, a graduate of Coker College, served at Dante, Va., most acceptably as requests for her services again this summer testify. Miss Klintworth's expenses were \$62.05 and were paid from the Summer Volunteer Fund. The branches that had pledged to this Fund sent in their offerings so slowly that the Treasurer was forced to borrow for a time; but we hope that pledges for this work this summer will be sent to the Treasurer early so as to cause no embarrassment to our Volunteers.

The latest news from our own Missionaries is as follows:

Miss Sarah C. Thurston is still in Cuba, C. and 11th St., Havanna. Miss Eliza H. McCullough, after many years service in Porto Rico, has returned to this Diocese and is now head of the Educational Department at our Church Home Orphanage. Rev. H. H. Lumpkin who has been for nearly five years Missionary Priest in Alaska will return to the Diocese this summer. Miss Alice H. Gregg has the oversight of three kindergartens in Anking, China, and she is filled with enthusiasm and love for her work. She asks assistance for the salaries of two splendid young Chinese women teachers in these kindergartens. Miss Uta Saito, our first Missionary to Japan, has been transferred from St. Agnes School, Kyoto, to a school in Tokyo. Mrs. Eloise Dublin Travers graduates in June from White Haven Sanatorium, Penn., as a Tuberculosis nurse, and hopes to be able to assist her husband in his work among the Italians near Philadelphia.

The Offering of Life has been very gratifying. In July, Miss Marie J. Ravenel of Charleston offered her life for the Church's work at home or abroad. She was accepted by the Board of Missions and entered the Philadelphia Training School last October for a two years course. Miss Lucille Moore has also offered herself for the Church's work and her application is now before the Board. If accepted, she will enter St. Faith's School, N. Y., for two years preparation. A third young woman has volunteered but cannot begin the necessary training for some time and wishes her name withheld.



We feel very humble and most deeply grateful that our prayers for volunteers have been so wonderfully answered in the offering of life of these splendid young women. How happy we shall be when the South Carolina Auxiliary, having a representative in every field can echo the words of the Junior Auxiliary, "Around the world a circle wide we make, Formed of love for Jesus' sake."

## CONSTITUTION OF THE SOUTH CAROLINA BRANCH OF THE WOMAN'S AUXILIARY TO THE BOARD OF MISSIONS

As amended in Convention, May, 1919.

---

### ARTICLE I.—NAME.

The name of this Association shall be The South Carolina Branch of the Woman's Auxiliary to the Board of Missions.

### ARTICLE II.—OBJECT.

The object of this Association shall be to carry out within the Diocese of South Carolina the three great aims of the Woman's Auxiliary: Prayer Study and Gifts for the Church's Missions.

### ARTICLE III.—MEMBERSHIP.

Section 1. The Bishop and Clergy of the Diocese are ex-officio members.

Sec. 2. The Association shall be composed of those women, young people and children who, being by Baptism members of the Missionary Society—the Church—are actively engaged in any department of auxiliary work.

Sec. 3. Women, young people, and children, who are not yet baptized, may be admitted to associate membership and shall be known as "Auxiliary Co-workers."

### ARTICLE IV.—OFFICERS AND EXECUTIVE BOARD.

Sec. 1. The officers of the Association shall be the Bishop, a President, three Vice-Presidents (one in each Convocation), Secretary, Box Secretary, Treasurer, Educational Secretary, United Offering Custodian, and Secretary of the Junior Department.

Sec. 2. The Vice-President of the Convocation in which the Annual Convention is to be held shall rank as first Vice-President, which office she assumes at the close of the previous Convention. She shall perform the duties of the President in the absence of the same.

Sec. 3. These Officers shall constitute the Executive Board, and five of them shall constitute a quorum.

### ARTICLE V.—ELECTION OF OFFICERS.

Section 1. All officers shall be elected at the annual Convention.

Sec. 2. No officer shall serve longer than three years consecutively in one office, except the Educational Secretary and the Secretary of the Junior Department.

Sec. 3. Candidates shall be nominated by informal ballot, the two receiving the largest number of votes for an office, being considered candidates therefor. A formal ballot shall then be cast.



## ARTICLE VI.—REPRESENTATIVE BODY.

Section 1. Each Parish and Mission Branch, with its Junior Department, shall be entitled to four votes, provided it sends four delegates; two votes to be cast by the Woman's Auxiliary and two by the Junior Department. If there are two sections in either the Woman's Auxiliary or the Junior Department and each sends a delegate to the Convention, one vote shall be cast by each section.

Sec. 2. Members of the Executive Board and Appointive Officers shall be entitled to vote. Visiting members of the Auxiliary shall be granted a voice, but not a vote.

## ARTICLE VII.—FISCAL YEAR.

The fiscal year of the South Carolina Branch shall be from January first to January first.

## ARTICLE VIII.—MEETINGS.

Section 1. The Diocesan Branch shall hold an Annual Convention in the month of May, alternately in each Convocation.

Sec. 2. Meetings of the Executive Board shall be held on the second Wednesday before Ash Wednesday, and immediately after the Annual Convention.

Sec. 3. Convocational Meetings shall be held once a year, preferably in the fall.

## ARTICLE IX.—AMENDMENTS.

This Constitution may be amended at any Annual Convention of the Diocesan Branch by vote of the majority, due notice of the proposed amendment having been previously given to every Branch.

## By-Laws

As amended in Convention, May, 1919.

## ARTICLE I.—DUES.

All members of the Woman's Auxiliary shall pay an annual fee of 25 cents, and the Juniors an annual fee of 10 cents. This amount shall be paid in November and shall constitute a contingent fund, to be used at the discretion of the Board.

## ARTICLE II.—DUTIES OF OFFICERS.

Section 1. The President shall preside at all annual and executive meetings, and shall have the general supervision of the work throughout the Diocese. She may call executive meetings at her discretion and shall call the same at the desire of a majority of the Board. She shall have power, after conferring with the Board, to appoint committees and fill vacancies occurring during term of office.



Sec. 2. The Vice-Presidents shall arrange for and preside over Convocational Meetings; shall endeavor to establish a branch of the Auxiliary in every parish and mission, and shall have the general supervision of the work throughout their several Convocations; shall send out report blanks and notices of Annual Convention; shall collect and tabulate annually the report of all the branches in their Convocations, and after giving summary of the same at the pre-lenten meeting of the Executive Board, shall pass reports on to the Treasurer and the Secretary for publication in the Annual Report. The Vice-Presidents shall also present a detailed report of the year's work at the Annual Convention.

Sec. 3. The Secretary shall keep the minutes of all Diocesan and executive meetings; conduct all necessary correspondence, and with the assistance of the Treasurer and Vice-Presidents shall prepare and edit the annual report.

Sec. 4. The Box Secretary shall receive and distribute all information relative to missionary boxes, and shall make a report at the Annual Convention.

Sec. 5. The Treasurer shall receive ALL the money contributions, except the United Offering from the Parish Branches and forward them to their various destinations. She shall keep an accurate account of same and, closing her books on December 31st, make an annual report of all the receipts and disbursements.

Sec. 6. The Educational Secretary shall guide the educational work of the Diocesan Branch. She shall be the Chairman of a Diocesan Educational Committee which shall be composed of the Secretary of the Junior Department, three Convocational Assistants in the Woman's Auxiliary and three in the Junior Department, and the general and specific chairman of the Foreign and Domestic Missions Committees of the Diocesan Branch. This Committee shall endeavor to plan and execute the systematic and thorough Missionary education of the Women and Juniors of the Diocese. The Educational Secretary shall give the power to call a general meeting of her Committee when it shall be deemed advisable.

Sec. 7. The United Offering Custodian shall have charge of all offerings for that fund, and shall endeavor, with Convocational Assistants and an assistant in the Junior Department, to promote interest in the same throughout the Diocese. She shall be Chairman of a Committee on the Offering of Life, of which the other members shall be the President, Junior United Offering Custodian, the Educational Secretary and the Secretary of the Junior Department. It is recommended that the Parish United Offering meetings shall be held in October and April.

Sec. 8. The Secretary of the Junior Department shall guide the work of the Juniors. She shall have three Convocational Assistants and a United Offering Assistant; these officers to be appointed by the Secretary of the Junior Department and their appointment confirmed by the Executive Board. (It is understood that these officers, with the exception of the Secretary of the Junior Department, are not officers of the Executive Board.)

Sec. 9. The Executive Board shall have power to adopt By-laws and shall exercise all the powers of the Association not otherwise herein expressly provided for.

### ARTICLE III.—COMMITTEES.

Section 1. A Secretary of the "Spirit of Missions" shall be appointed by the President. Said Secretary shall endeavor to increase the circulation of the "Spirit of Missions", and promote intelligent interest in, and study of, said magazine.



Sec. 2. A Secretary of "The Diocese," the official organ of the Church in South Carolina, shall be appointed by the President. Said Secretary shall endeavor to increase the circulation of "The Diocese", and promote intelligent interest in the same.

Sec. 3. A Publicity Chairman shall be appointed by the President.

Sec. 4. An auditing committee shall be appointed by the Board at the pre-lenten meeting to examine and report on the books of the Treasurer and the United Offering Custodian.

#### ARTICLES IV.—DELEGATES TO THE TRI-ENNIAL.

Each Diocesan Branch is entitled to five delegates to the Triennial. These shall be the President, the Educational Secretary, the United Offering Custodian, the Junior Secretary and one elected from the Auxiliary at large. The Convention shall also elect five alternates.
