## PRESIDENT'S ADDRESS

"It is a great pleasure for me to meet the members of the Woman's Auxiliary of the district of southern Florida, and while I may not be able to fill the place of your former president, I shall endeavor to carry on the work so ably begun by her, and to make some recommendations for the future.

"I welcome you all to this meeting and hope it will be of benefit and a source of inspiration for the coming year. We are to hear the work done during the past year, to be warmed and strengthened by the same purpose and working for the same end, to consider some problems and if possible to find their solution, and we hope augment our faith, intensify our hope, deepen our love in and for Christ and our church. With this feeling I welcome you most heartily.

"Since arriving in this District, I have visited several Parishes and Missions, and have spoken at St. Petersburg, Tampa, Sanford, Winter Park, New Smyrna, Daytona, and Ft. Pierce. It is my purpose to visit as many of our organizations as possible during the coming year, and to become acquainted with our church women.

"Last month I sent a circular letter to seventy auxiliaries and guilds asking their co-operation in raising the necessary amount each year for our expense fund, formerly called the "Contingent Fund." Each organization should desire to contribute to this fund, for it is a part of missionary work, and as you know this is a missionary district and receives much support from the General Board of Missions. I have not heard from all, but hope to hear from additional ones to-day.

"Our United Offering should need no explanation; but perhaps it would be well to recall its idea and object. It is a thank offering from the women of the church. Mark you not Auxiliary women alone, but all church women, for the support of women workers in the church. This offering has come to be the great outward sign of the unity of the Woman's Auxiliary. Every church woman should esteem it a privilege to give to it, to have a part in it, no matter how small. Do not let inability to make large contributions prevent your contributing at all.

"There are two points I wish to urge you to-day. The yearly contribution to the expense fund, and the United Offering.

"No one who attends an annual meeting can leave it without

some enthusiasm of fellowship. Can we not carry that enthusiasm to the women at home by taking notes of everything interesting and reporting it to them. May you each go back with a deeper sense of responsibility and a longing to do more. Now what are we to do this coming year?

"One thing seems imperative. To maintain the former custom of making pledges to raise three hundred dollars at Easter which meets our apportionment and our clergy insurance fund. Will not some of the auxiliaries who have forgotten to help in this formerly do so this coming Easter?

"I end by quoting words from the Ontario churchman, which have also been used by the Diocesan presidents of Minnesota and Iowa: 'There is in your church a young lady who will join the auxiliary or church if you ask her; a woman who will send her children to Sunday School if you ask her: a woman waiting to join; and still another, tender in sorrow, who will make a special offering if you ask her; a man who will become an honorary helper if you ask him; there is a man and a woman who will subscribe for a church paper if you ask them, also for missionary papers for the children; another who will ask a friend to subscribe for them also if you ask him; a woman who will pray for mission work if you ask her; perhaps there is another who will give herself to the work if you ask her. The Master is waiting for you and you and you to do His work."

## REPORT OF ANNUAL MEETING

On Monday morning, January 11th, 1915, representatives of the Woman's Auxiliaries and a few of the Guilds of Southern Florida convened at ten o'clock in the Methodist Church, North, Miami, for the Annual Meeting of the Woman's Auxiliary, the President Mrs. Cameron Mann presiding.

The meeting was opened with prayers and recital of the Creed, followed by Roll-call of the Auxiliaries and Guilds.

After the reading of the Minutes of the last Annual meeting, the President's address was heard followed by the reports of the Secretary, Treasurer, United Offering Treasurer, Educational Secretary, Palm Branch Committee, Junior Auxiliary Secretary, Junior Treasurer, President Little Helpers and Secretary Church Periodical Club.

Motion made by Tampa, seconded by West Palm Beach that the offering taken at the service of Aux. Corporate Communion be given to the United Offering Fund. Carried.

The obligation of the Southern Florida Auxiliary to maintain the Insurance on the lives of two Missionaries, one in China and one in the Philippines, was explained.

Pledges for the Easter Fund were then taken and the matter of a Scholarship for the daughter of a Clergyman in the Cathedral School at Orlando, was suggested by the President as a future work which was very suitable for this organization. The President stated that it was probable that after this year the responsibility for the Palm Branch having been removed from the Auxiliary and the Current Expense fund being provided for by assessment, the efforts of the members could be directed towards this Scholarship. This idea met with instant approval and enthusiasm and voluntary pledges were promptly made by Mrs. Goode, Mrs. Bocker, Mrs. Alleman and Mrs. Fuller to provide a nucleus for this Fund.

The report of the Cathedral School was given by Mrs. R. P. Cobb with earnest thanks for the interest shown in the scholarship matter.

The revised Constitution was then read and adopted as a whole, followed by the adoption of revised Bylaws.

The noon hour having arrived prayers were offered by Bishop Cameron Mann after which he announced the new list of Officers for the coming year.

A strong appeal was made by the President for supplies for the Church Home and Hospital, and the Auxiliaries away from Orlando were urged to send bedding, towels and jellies as well as money.

A vote of thanks was given to the ladies of Miami for their beautiful hospitality and many courtesies to the visiting delegates and the Secretary was instructed to send a letter of thanks to the Pastor of the M. E. Church, Dr. Merrill, for his courtesy in allowing us the use of a room in his church for this meeting.

## REPORT OF THE SECRETARY

The quarterly meetings (and one called meeting) of the executive committee have been held regularly throughout the past year and fully attended by all members.

The president, Deaconess Parkhill, having resigned the office in November, Mrs. Mann was appointed by the bishop as her successor.

The resignation of Mrs. L. W. Weddell from the work of the Church Periodical club of the district was accepted with regret by the bishop in December.

The district of southern Florida was represented in New Orleans at the department meeting by the president, Mrs. Mann.

The total receipts of the district for the year show a small deficit as compared to the last annual report, while the Juniors show a small gain.

Advent boxes were sent by almost all the branches, most of them given to the missions of Waynesville, N. C.

The district is supposed to have twenty-three branches, but seventeen of which have reported to the president or secretary, twelve of which report a total membership of 217.

285 pieces of mail have been issued, at a cost of \$6.17 for postage and printing.

Blank forms for reports of the local secretaries have been issued, which if used would be of great assistance in preparing district reports for the annual meeting and the Woman's Auxiliary to General Board of Missions.

This report is not what it should be, as it has been impossible to hear from many places in time to incorporate. In nearly all the Parishes and Missions, I am assured that the Educational Work will be taken up during the Lenten Season.

A few of the clergy have been helpful in their co-operation, especially Dean Remsen, who devoted the Sunday evenings during Advent to Missionary lectures, with Lantern slides, and who expects to carry on the same work during Lent.

In October, 1914, a committee met with Mrs. Mann to discuss the work for the season. A committee of two were appointed to arrange a program for the purpose of helping to get the work started. This program has been submitted to every Branch of the Woman's Auxiliary, and where there was no Branch to Guilds.

The plan is working well in St. Luke's Cathedral.

It has been impossible to get a correct report of the number of Missionary Calendars for 1915, disposed of.

There has been more general interest manifested in the work this fall.

Your Educational Secretary is not satisfied with the results and earnestly prays, with God's help, that efforts which are made in the future, may be productive of better results

## REPORT OF THE JUNIOR AUXILIARY

The Branches of the Junior Auxiliary, as a whole, have been doing splendid work and the interest shown by the members and leaders has been and is most encouraging. During the past year the Juniors have largely been interested in providing for a poor family of seven, a mother and six children living in La Grange, Georgia. Boxes were sent once a month which contained clothing and, occasionally, books and toys. Money also was sent monthly to the amount of five dollars. Several weeks ago, five of the six children were adopted by different people and as no further aid was needed by the mother the Juniors have undertaken to provide scholarships for mountain children in a Mission School in the mountains of North Carolina. These scholarships are valued at five dollars and provide books and schooling for one year; besides giving these scholarships the Juniors are providing clothing for their scholarship children.

Quite a number of boxes have been sent during the year although the leaders made no report of all boxes sent. As yet, only two Branches have reported their annual Advent boxes and these were sent to Morgantown, North Carolina.

The Secretary has carried on a continued correspondence with the Junior leaders and has sent out leaflets and Prayers cards besides giving information of literature that is interesting reading for the Junior Meetings.

Although the number of Junior Branches has not increased the eight have kept together nicely and the interest they are showing in the work for the new year is most promising.

# CONSTITUTION OF THE SOUTHERN FLORIDA BRANCH OF WOMAN'S AUXILIARY.

## Article I. NAME.

The name of this Association shall be "The Southern Florida Branch of the Woman's Auxiliary to the Board of Missions."

## Article II. OBJECTS.

The objects of this Association are

First.—By means of Prayer and Offerings to spread Christ's Kingdom in the world.

Second.—To diffuse Missionary Intelligence.

Third.—By united and systematic effort to increase Missionary Activity among the women of the District, and to encourage the formation of Local Auxiliaries where none exist.

## Article III. MEMBERSHIP.

All baptized women in the District of Southern Florida are eligible for membership in this Association.

## Article IV. OFFICERS.

There shall be a President, Vice President, Secretary, Treasurer United Offering Treasurer and such other officers as may at any time be required.

## Article V. JUNIOR DEPARTMENT.

There shall be a Junior Department of this Association for the younger women and children of the District, working under its own Constitution and electing its own officers.

## Article VI. LOCAL AUXILIARIES.

Local Auxiliaries may be organized in all Parishes and Missions of this District by the consent of the Rector or Missionary, and of the District President.

## Article VII. ANNUAL MEETING.

There shall be an annual meeting of Delegates from the Local Auxiliaries at the time of the Annual District Convocation.

## Article VIII. ELECTION OF OFFICERS.

The election of officers at the annual meeting shall be by ballot.

## Article IX. AMENDMENT.

This Constitution may be amended at any annual meeting by a two-thirds vote of the Delegates present, and upon the approval of the Bishop.

## BY-LAWS

### 1. QUORUM.

Three of the District Officers shall form a quorum for transacting business at committee meetings.

Delegates from five Local Auxiliaries shall form a quorum in annual meetings.

### 2. EXPENSES.

The current expenses of this Association shall be paid from the General Expense Fund.

### 3. MEETINGS.

All meetings shall be opened with prayer.

### 4. DUTIES OF OFFICERS.

The duty of the President shall be to preside at all meetings, to arrange for the organization of Local Auxiliaries, and to have general charge and care of the work, throughout the District.

The duty of the Vice President shall be to preside in the absence of the President, and to have special care and charge of the subscription lists of the SPIRIT OF MISSIONS and THE PALM BRANCH.

The duty of the Secretary shall be to

1. Issue notices of meetings;
2. Keep the minutes of the Association;
3. Prepare and edit the annual report and perform such other functions as may be assigned her by this Association.

The duty of the Treasurer shall be to receive and under the direction of the President to disburse all moneys, and to render an account of the same at each annual meeting.

The duty of the United Offering Treasurer shall be to distribute Blue and Birthday Boxes to local United Offering Officers, receive annually all moneys from the same, prepare an annual report and present the total amount at each Triennial meeting at the time of General Convention.
