PRESIDENT'S ADDRESS

My Dear Friends and Co-Workers:—

I bid you a cordial welcome to this annual meeting of the Woman's Auxiliary in Southern Florida.

The past year has shown a decided increase in interest and giving—and, after hearing the different reports, I am sure you will approve the change in methods of work.

And here I wish to say that I am most grateful for the hearty support of all the officers. They have most willingly and effectively carried out the new scheme.

It is not my purpose to tell of the progress made under the different officers, and the work accomplished by them. Their reports speak for themselves. Much has been done. Still much more remains to be done. I will offer just a few words on the subjects, Mission Study and Prayer.

There is no better means for promoting interest in Church work than a missionary program, or Mission Study Class. The Educational Secretary will gladly give information regarding such work; and I do hope more of our members will follow the course suggested by her. We have in Southern Florida a real Mission Study leader, Mrs. McKay, of Daytona, and I much regret that more Auxiliaries and Guilds have not availed themselves of her leadership. Missionary program on study work results in increased knowledge, and is of great value in parochial life.

The General Auxiliary has instituted a Pilgrimage of Prayer. It began with the first Sunday in Advent, December third, 1916. Each week is assigned to the Auxiliary in one or more Dioceses. On the closing Sunday of the year, Sunday next before Advent, November twenty-fifth, all Auxiliary women of the Church are asked to make their communion together and offer the intercessions of the Pilgrimage of Prayer.

With the first week in Advent the Pilgrimage began in Maine and New Hampshire. The second week was for Vermont and Western Massachusetts; the third week for Massachusetts; the fourth for Rhode Island and Connecticut; and so it goes on, until throughout the Christian year prayers will have been made in every part of the Church. The date for Florida and Southern Florida is Easter Day, April 8th, and the week following. I urge that all women in our Missionary District observe Easter Day with special supplication in their Pilgrimage of Prayer.

In conclusion I ask that we all exert ourselves to double our membership, increase our interest and to keep in mind the three-fold purpose of the Auxiliary, study, gifts and prayer.

May each one of us return home with a deeper sense of responsibility, and a determination to increase the work done for the Master.

REPORT OF VICE-PRESIDENT

The following is the report of my work as agent for the Spirit of Missions and Palm Branch in the District of Southern Florida:

During the past year I have written to every vice-president of Auxiliary Branches and where there were none to vice-presidents of Guilds' and sent out the leaflets, explaining the work. Not hearing fully I sent out cards in mid-summer. In most instances the replies have been kind and courteous, with promises of co-operation, but few have sent me answers upon which to form a tabulated report.

During the year I have received sixteen answers. The following having sent satisfactory reports:

MINUTES OF THE TWENTY-FOURTH ANNUAL MEETING

The twenty-fourth annual meeting of the Southern Florida Branch of the Woman's Auxiliary opened at St. Andrews' Church, Tampa, January 29th, at 9 a. m., with the usual Corporate Communion Service, which was celebrated by Bishop Mann, assisted by the Rev. Mr. Williams. Bishop Mann made a brief address thanking the Auxiliary for their able assistance during the year and also expressing regret that Mrs. Mann could not be present. After the service the women passed to the transept of the church, where Bishop Mann stated that the president had made the request, owing to her enforced absence and that of the vice-president, that the meeting should appoint Miss Mary Rand chairman for the day and Mrs. J. J. Bridges, secretary, of the meeting. These motions were made and carried. Bishop Mann then withdrew and the meeting was called to order by Miss Rand and opened with prayers.

The roll call by the secretary showed an attendance of 6 officers and 39 delegates from 28 organizations, either Auxiliaries or Guilds.

It was moved that the minutes of the last annual meeting be omitted as they had already been printed in the report. The motion was carried.

The president's address was listened to with interest, especially the plan for the Pilgrimage of Prayer and the plea for more earnest work in the individual organizations and was received with a rising vote of thanks.

The report of the Vice-President was read and accepted.

The report of the Secretary was read and received by the meeting.

The report of the Treasurer was read and accepted. It was shown that the total receipts for the year was \$1,816.28; expenses, \$1,019.30; balance on hand, \$823.49. Mrs. Moore stated that the amount was just \$2.00 less than last year. The Treasurer also made the request that all moneys be handed in before January 1st, as she was obliged to have her books balanced at that time, so that all funds received after that would have to be held until the next year. She stated that she has received some money at today's meeting, but that it could not be counted in at this time.

The roll call for convocation gifts was then made and the Treasurer reported the amount as \$403.75, given from twenty societies, either Guilds or Auxiliaries.

Many of the organizations in answering the roll call made the explanation that their societies had not understood about the change in the time of the gift from Easter to Convocation and questioned whether notice had been sent them. Miss Sawyer then made the statement that the circulars explaining this had been sent out about December 1st. Most of the societies not contributing expressed re-

gret and also their intention of doing so at the next Convocation.

The report of the United Offering Treasurer which closed the Monday after Easter had been reported in the Palm Branch and was as follows: \$906.48, it being the three-year gift sent to St. Louis. She made an interesting statement saying that there were 4,828 communicants in this Diocese probably one-third of whom were women. If each of these women gave one cent a week for three years we should have the sum of \$2,500.00 for our United Offering and made an earnest plea for every one to do her part.

The chair then announced the following committee for the disbursement of the fund: Mrs. O. B. Eaton, Lakeland, chairman; Mrs. G. A. Ottman, Ocala; Mrs. J. H. Pratt, Tampa; Mrs. H. Cary-Elwes, Melbourne; Mrs. H. B. Adams, Winter Park.

She also made the following suggestions for pledges which had been sent by the President:

The chair then asked what was the desire of the meeting in regard to the election of officers, stating that by the Constitution the election must be by ballot. A motion was made and carried that a nominating committee be appointed by the chair. The following committee was then appointed:

The noonday hour having arrived prayers were said by Bishop Mann.

Mrs. Sperry then arose and after a few appreciative words of Deaconess Parkhill and her work made the following resolution:

I move to amend Act 4 of the Constitution so as to provide for the office of Honorary Vice-president, this office to be created especially for Deaconess Harriet Randolph Parkhill in recognition of her devoted work in this auxiliary. This motion was seconded by Miss Cary-Elwes and unanimously carried.

Mrs. Shaw then made a motion to send a telegram to Deaconess

Parkhill telling her of this motion and also a telegram of sympathy to Mrs. Mann. Mrs. Emerson amended this motion to include the regret of the Auxiliary at Mrs. Mann's enforced absence. This motion was seconded and carried. The chair then appointed Mrs. Sperry and Mrs. Shaw a committee of two to prepare the telegrams.

The report of the Educational Secretary was then made and accepted by the meeting. Mrs. Bliss made a plea for more interest in her work and in the formation of Mission Study Classes.

The report of the Treasurer of Junior Auxiliary was then read by Miss Cary-Elwes, there being no Secretary's report.

The report of the Little Helpers was read by the Secretary and accepted by the Auxiliary.

An interesting report of the work of the Church Periodical Club was then made by the correspondent, Mrs. Thompson, which was received by the meeting.

On motion the meeting was then adjourned for luncheon, which was served at the Y. W. C. A.

The second session convened at 1:45 p. m. The minutes of the morning session were read and approved.

The order of the day was taken up at unfinished business.

Mrs. Bull read a very interesting report of the meeting of the Women's Auxiliary at the triennial convention, which was received by a vote of thanks from the Auxiliary.

The committee on telegrams then reported the sending of the messages to Mrs. Mann and Deaconess Parkhill.

A letter from Mrs. Loring Clark was then read asking for an additional sum of \$5.00 to defray the expenses of the Provincial Delegate to the meeting in New York. A motion was then made and carried that the Treasurer be instructed to send this amount.

A letter from Miss Julia Emery to Mrs. Mann was read apprising her of her resignation and asking for continued support for her successor, Miss Lindley.

A letter from Mrs. Pancoast in regard to the completion of the fund for St. Luke's Hospital, Tokio, was read and also one from Mrs. Pettigrew in regard to St. Agnes' School, Kioto.

The chair then invited any visitors to the convention to say a few words in regard to the work of their respective Auxiliaries. The following responded very interestingly: Mrs. Emerson, Diocesan Officer of Diocese of Michigan; Mrs. Burnside, of South Dakota, and Mrs. Burley, of New Hampshire, both United Offering Treasurers, and Miss Knapp of the Diocese of Albany, N. Y.

Mrs. Bliss also made a brief, earnest plea for interest and co-operation in her program work, making the statement that "Education means bringing out the noblest side of man."

The Secretary requested that a list of the officers of each organization be handed to her by the delegates before leaving.

There being no other business to come before the convention, on motion of Mrs. Bliss, the meeting adjourned.

REPORT OF EDUCATIONAL SECRETARY

Madame President:—

I herewith submit my report as Education Secretary for the year from January, 1916, to January, 1917:

Twice during the year I have met with the Sunday School Teachers, of St. Luke's Cathedral, in the interest of instituting Mission Study in the Sunday School. So far, it does not seem possible to combine the two. All of the teachers and superintendent are interested in this work, and take their part in the Mission Study of the Woman's Auxiliary.

A missionary program, prepared by a committee, has been sent as a suggestion to every branch of the Woman's Auxiliary, and to the Guilds, where there is not a branch of the Auxiliary. We have taken a step forward this year by incorporating in the program, a real Mission Study on prayer to be held during Lent, and we earnestly hope a class of earnest women may be organized to carry out this part of the program. With the program your Secretary has sent a personal letter to each President or Secretary, pleading for co-operation and I am so happy to report that the enthusiasm in this year's course of study has been most gratifying.

The chain of Study Classes, Reading Circles and Program Meetings is increasing and we hope and pray that in another year not one link in the chain may be missing, for the aim of your Secretary, with God's guidance, and the help of all the members, is to link up the varied interest of the several parishes and missions, to the one great motive, Missionary Education.

May every leader in every parish and mission pray and work for the spread of the knowledge of His Kingdom.

JUNIOR AUXILIARY PRESIDENT'S ADDRESS

Last year I asked the Juniors to concentrate their efforts and all work for the same objects and this has been done wherever the work has gone on and I thank you for your loyal answer to my desires in this respect and ask you to continue.

Five of our seven branches have worked hard and kept up the standard, but two have not been heard from since the beginning of the year. All sent their gifts to the Expense Fund. Three sent gifts to the endowment of the bed in "The Eliabeth Bunn Memorial Hospital, Wuchang, China. Two scholarships and two boxes were sent to the Morgantown Mission Schools and a large Christmas box was sent to Rutherfordtown, N. C., to which three branches contributed. This year I ask you for further support along the same lines, for while changes in our methods are to be tried, still the objects we work for will be the same and we must try more and more to work in a band if we are to accomplish things that are worth while.

At General Convention in St. Louis a new idea was suggested, which came to me with great force as being the right way to work. This will have to be worked out and we must rather feel our way and not try to force things and have a good understanding ourselves before we try to show others. For this reason I have simply sent a sort of sketch of the lines laid out to each existing branch and to one other mission, where the Rector has asked for information. I am waiting for fuller details, which I will send on to the branches when I have secured them and gone over them to see how they fit our needs. You see we are asked to work with the Sunday Schools and it seems to me that if this is done we shall have an opening for a splendid opportunity. I am asking you all to try the new plans carefully and faithfully. Do not try to force it on the Sunday School in your parish, but ask the superintendent and teachers to meet with you and discuss ways and means and try to get them interested and show them how it will help the life of the Sunday School. Of course there are many details that will have to be adjusted and we will have to move slowly. I think the success hinges to a great extent on the teachers having a Mission Study Class, and at this time preparing material to be given in the Sunday School. This should enable us to reach more children than the Junior Auxiliary can possibly do. And now I thank you all for your co-operation in the past year, and hope with God's help, we may go on to larger and more helpful things in 1917.

MINUTES OF ANNUAL MEETING OF JUNIOR AUXILIARY

Miss Marion Cary-Elwes presided and opened the meeting with prayer and collect. She made an address on the aim and object of the Junior Auxiliary, ending with a brief mention of her trip to the Convocation in St. Louis.

There was no Secretary's report. The Treasurer reported \$47.16 left in the treasury.

After discussion on distribution of this money a motion was made and carried that \$25.00 should go to the endowment of St. Luke's Hospital, Orlando, and \$22.76 to St. Agnes' School, Kyoto.

Miss Cary-Elwes then spoke of the work of the Juniors in Orlando. Pledges were asked for the maintenance of a bed in Elizabeth Bunn Memorial Hospital, China, \$35.00 being the amount to be raised.

The President mentioned the Christmas Box that the Orlando Branch sent to Rutherfordtown, N. C.

The question of the distribution of the systematic dues was raised and Miss Cary-Elwes said it should be left with the different branches as to how it should be disbursed.

Miss Cary-Elwes then gave some ideas for work during Lent.

The delegate from Leesburg was asked for a report, but had none.

There being no further business, the meeting adjourned.

REPORT OF DAUGHTERS OF THE KING

A report having been asked from the Daughters of the King, a brief outline is here given; the chief purpose an dwork of this order being not that which may be recorded in word and figures, but the quiet, individual effort of its members to reach and help other women by prayer and by personal influence.

As our Hand Book expresses it: "The sole object of this order shall be the extension of Christ's Kingdom—especially among women—and the strengthening of the Church's spiritual life."

The two-fold rule of prayer and service, corresponds to that of the Brotherhood of St. Andrew.

In Southern Florida we now have but nine (9) chapters of the Daughters and three chapters of the Junior Daughters.

The diocesan organisation is called the Local Assembly, and meets annually, usually in the early part of May, the date being determined by the Bishop.

The present officers are: Miss Corinne Robinson, Orlando, president; Miss Louise Hindry, of West Palm Beach, vice-president; Miss Lizzie Gardiner, of Daytona, secretary, and Miss Cornelia Pickett, of Tampa, treasurer.

The care of the altar, of vestments, etc., usually is put in charge of the Daughters, who are also to be their Rector's assistants on whom he can depend for any service they may render. They are to call upon strangers, the sick, the afflicted; to bring others for Baptism and Confirmation, with also the earnest effort week by week to bring women to the services of the Church.

The last week of the Epiphany season each year is observed as "Self Denial Week" by the Daughters throughout the United States, the members making then a special offering through self denial for the support of a member of this order as a missionary in China. The missionary now being provided for in this way is Miss Emily L. Ridgeley, of Tchang, China, who made a welcome visit to Southern Florida a year ago, when in this country on furlough.

CONSTITUTION OF THE SOUTHERN FLORIDA BRANCH OF WOMAN'S AUXILIARY

Article I. NAME.

The name of this Association shall be "The Southern Florida Branch of the Woman's Auxiliary to the Board of Missions."

Article II. OBJECTS.

The objects of this Association are

First.—By means of Prayer and Offerings to spread Christ's Kingdom in the world.

Second.—To diffuse Missionary Intelligence.

Third.—By united and systematic effort to increase Missionary Activity among the women of the District, and to encourage the formation of Local Auxiliaries where none exist.

Article II. MEMBERSHIP.

All baptized women in the District of Southern Florida are eligible for membership in this Association.

Article IV. OFFICERS.

There shall be a President, Vice President, Secretary, Treasurer, United Offering Treasurer and such other officers as may at any time be required.

Article V.

There shall be a Junior Department of this Association for the younger women and children of the District, working under its own Constitution and electing its own officers.

Article VI. LOCAL AUXILIARIES.

Local Auxiliaries may be organized in all Parishes and Missions of this District by the consent of the Rector or Missionary, and of the District President.

Article VII. ANNUAL MEETING.

There shall be an annual meeting of Delegates from the Local Auxiliaries at the time of the Annual District Convention.

Article VIII. ELECTION OF OFFICERS.

The election of officers at the annual meeting shall be by ballot.

Article IX. AMENDMENT.

This Constitution may be amended at any annual meeting by a two-third vote of the Delegates present, and upon the approval of the Bishop.

BY-LAWS

1. QUORUM.

Three of the District Officers shall form a quorum for transacting business at committee meetings.

Delegates from five Local Auxiliaries shall form a quorum in annual meetings.

2. EXPENSES.

The current expenses of this Association shall be paid from the General Expense Fund.

3. MEETINGS.

All meetings shall be opened with prayer.

4. DUTIES OF OFFICERS.

The duty of the President shall be to preside at all meetings, to arrange for the organization of Local Auxiliaries, and to have general charge and care of the work, throughout the District.

The duty of the Vice President shall be to preside in the absence of the President, and to have special care and charge of the subscription list of the SPIRIT OF MISSIONS and THE PALM BRANCH.

The Duty of the Secretary shall be to

1. Issue notices of meetings;
2. Keep the minutes of the Association;
3. Prepare and edit the annual report and perform such other functions as may be assigned her by this Association.

The duty of the Treasurer shall be to receive and under the direction of the President to disburse all moneys, and to render an account of the same at each annual meeting.

The duty of the United Offering Treasurer shall be to distribute Blue and Birthday Boxes to local United Offering Officers, receive annually all moneys from the same, prepare an annual report and present the total amount at each Triennial meeting at the time of General Convocation.
